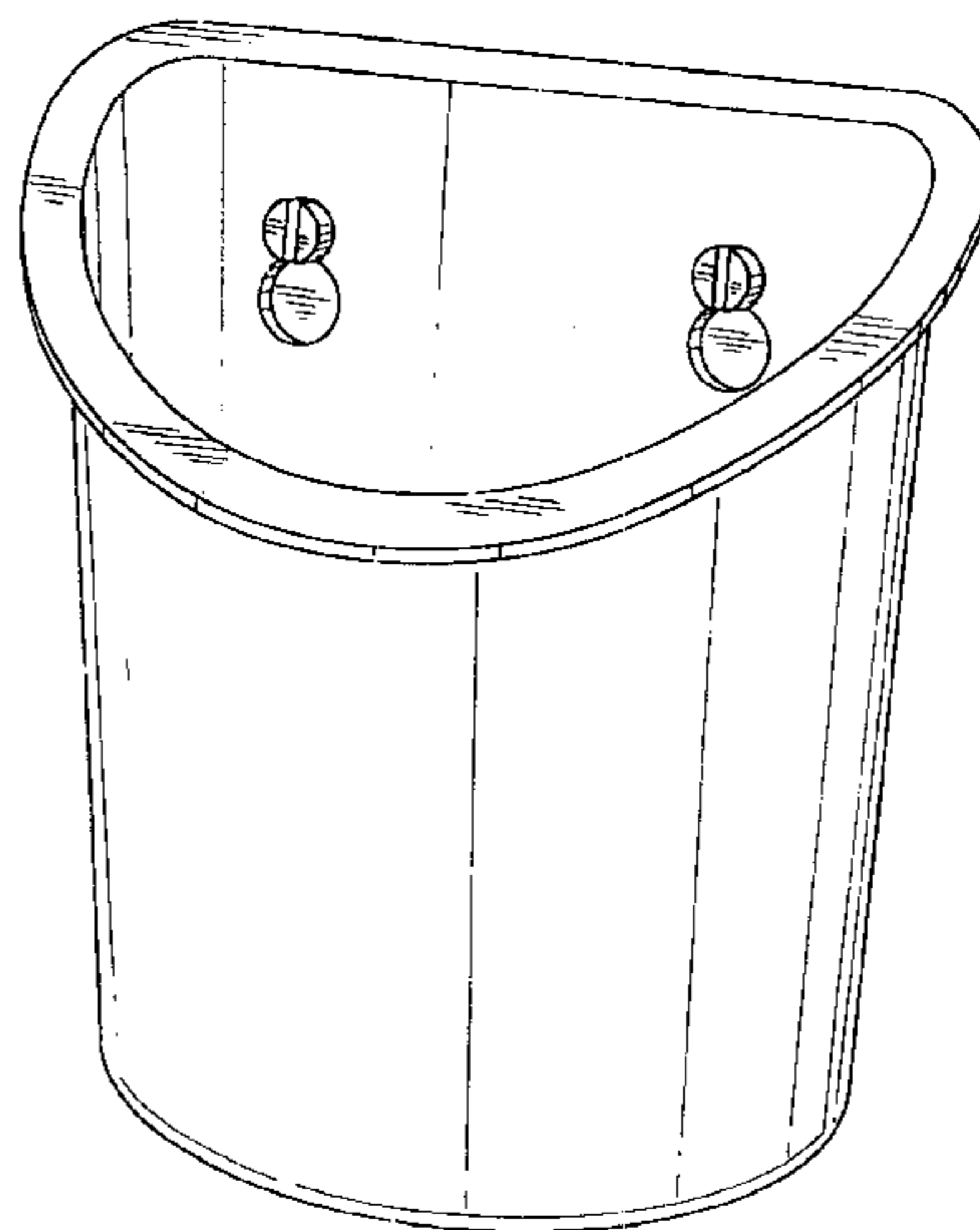
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front prospective view of a pencil cup showing my new design;

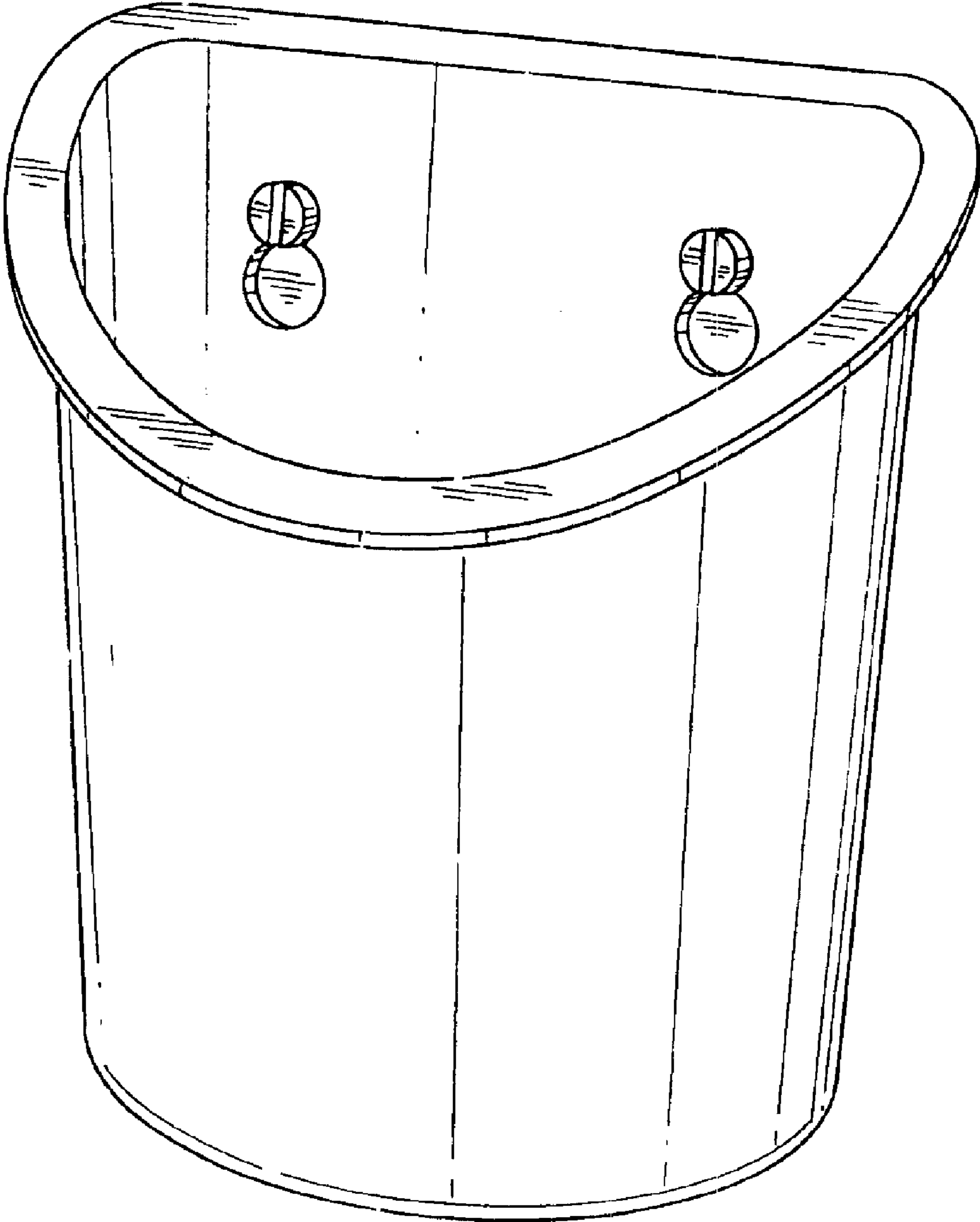

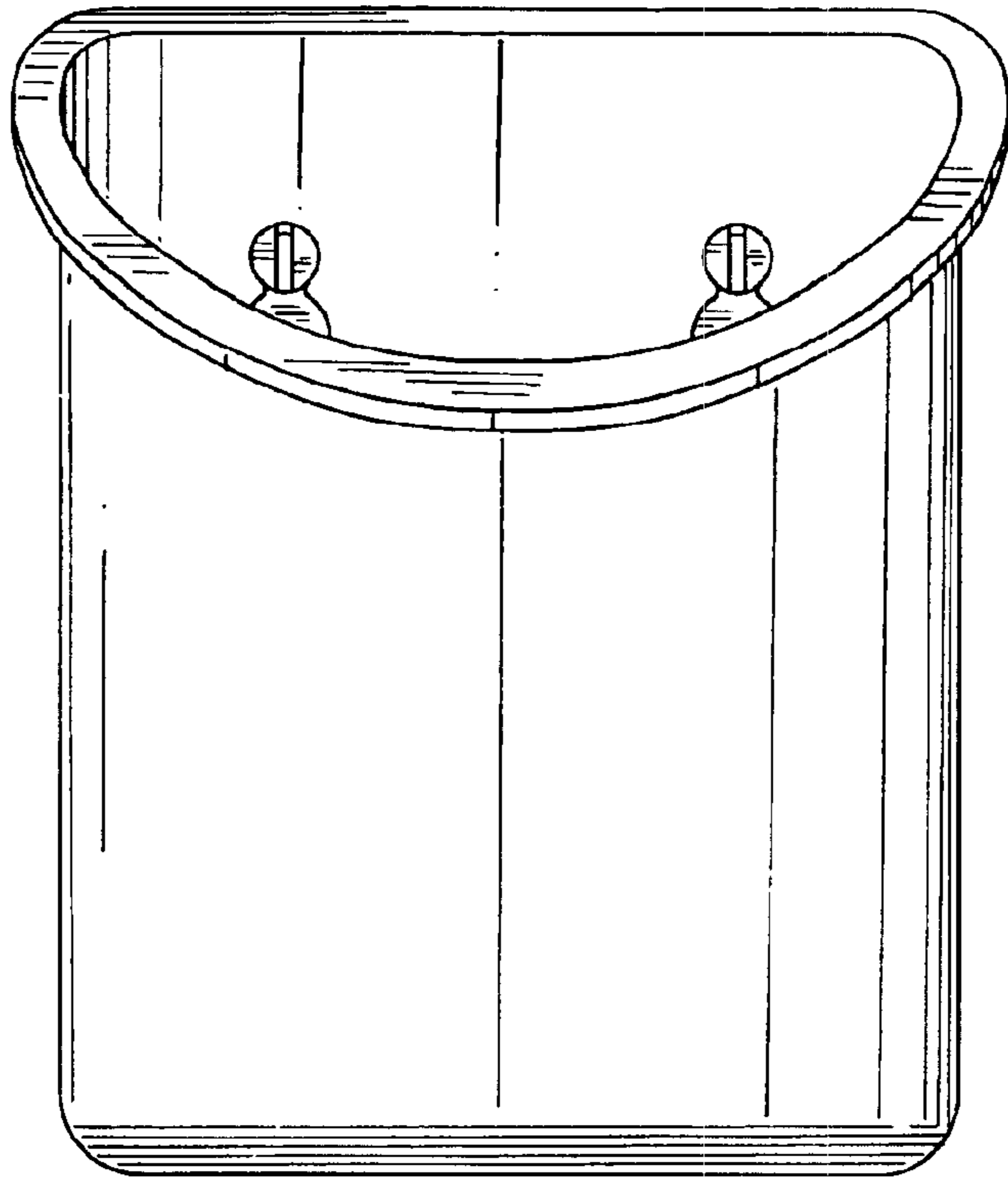

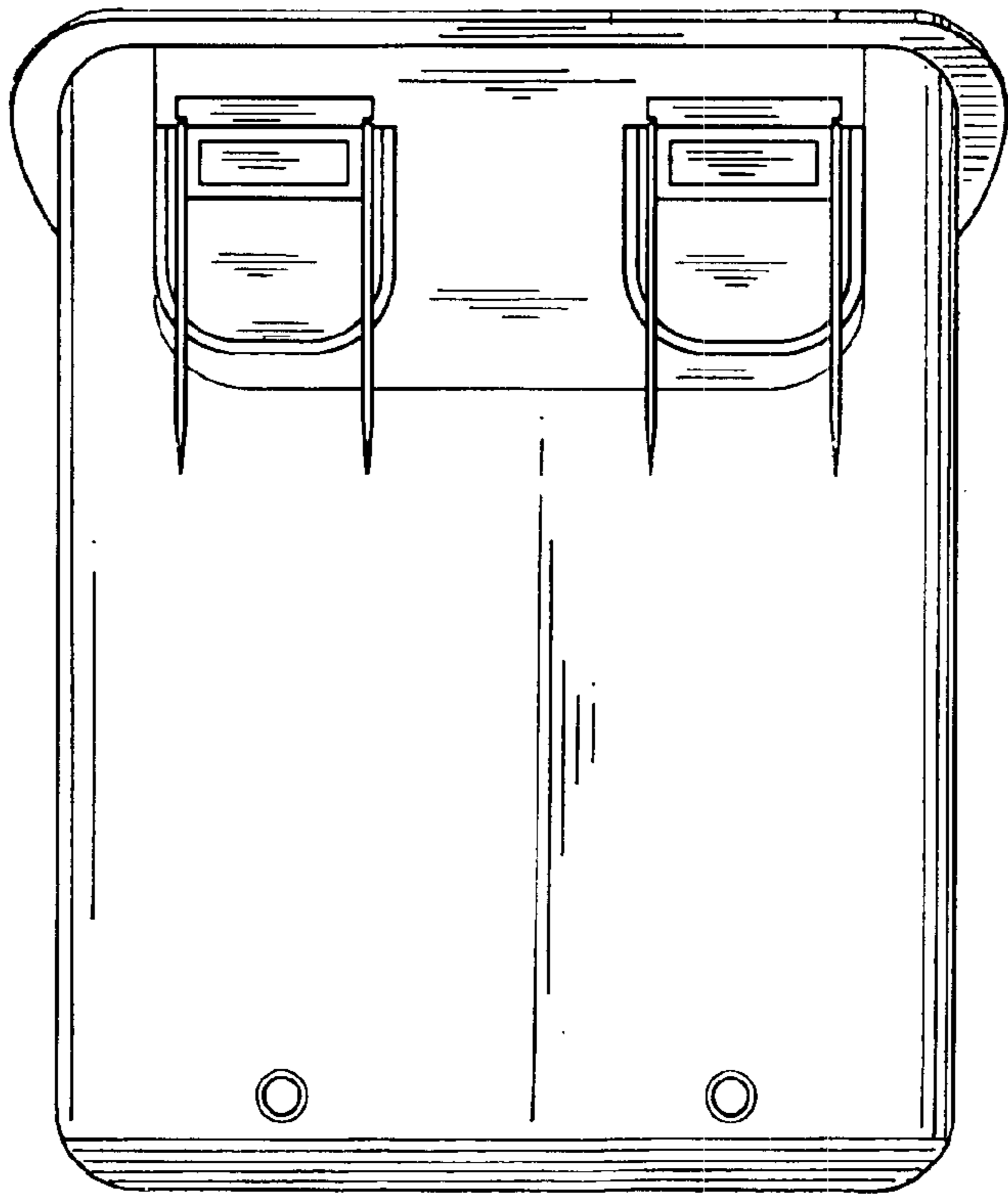

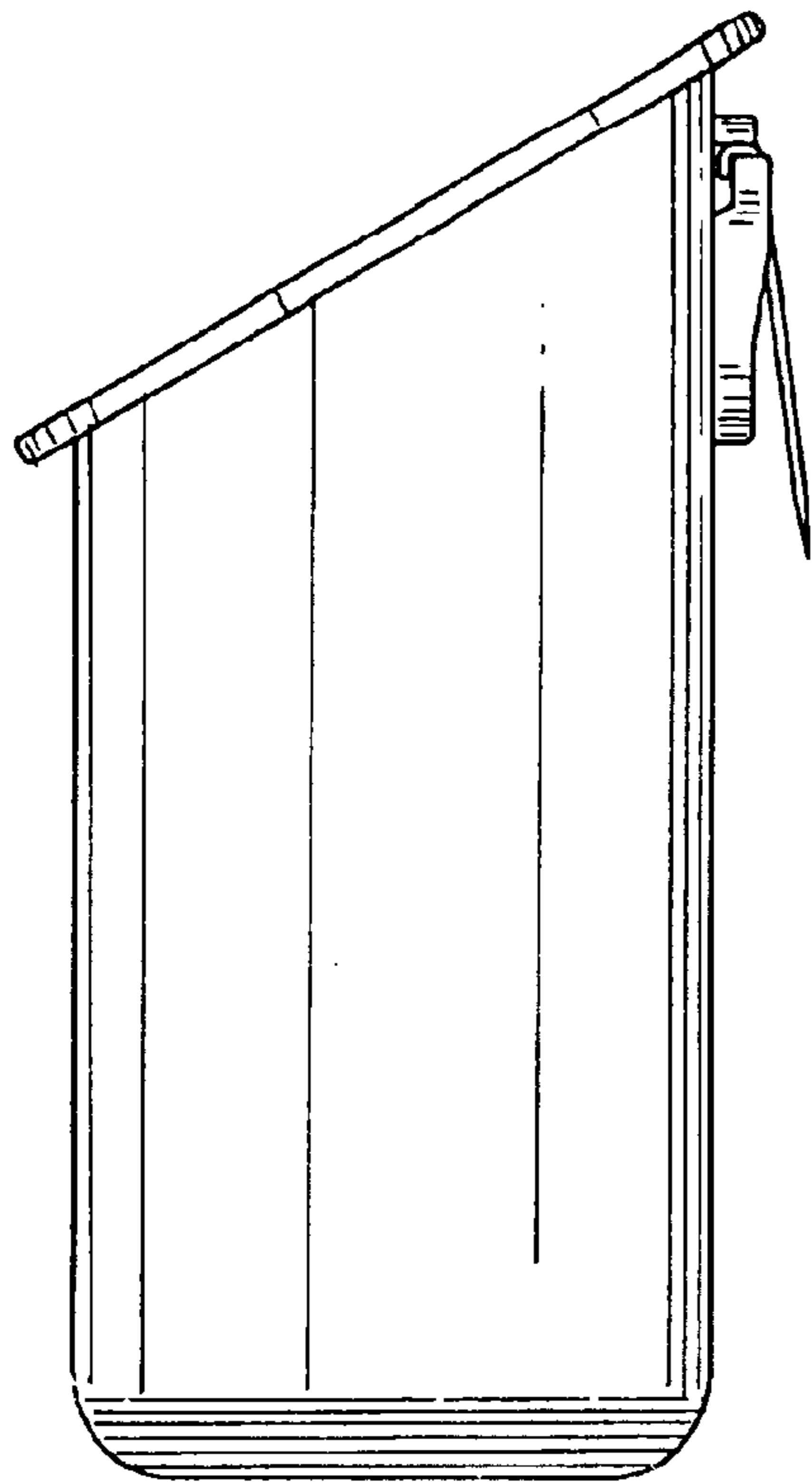

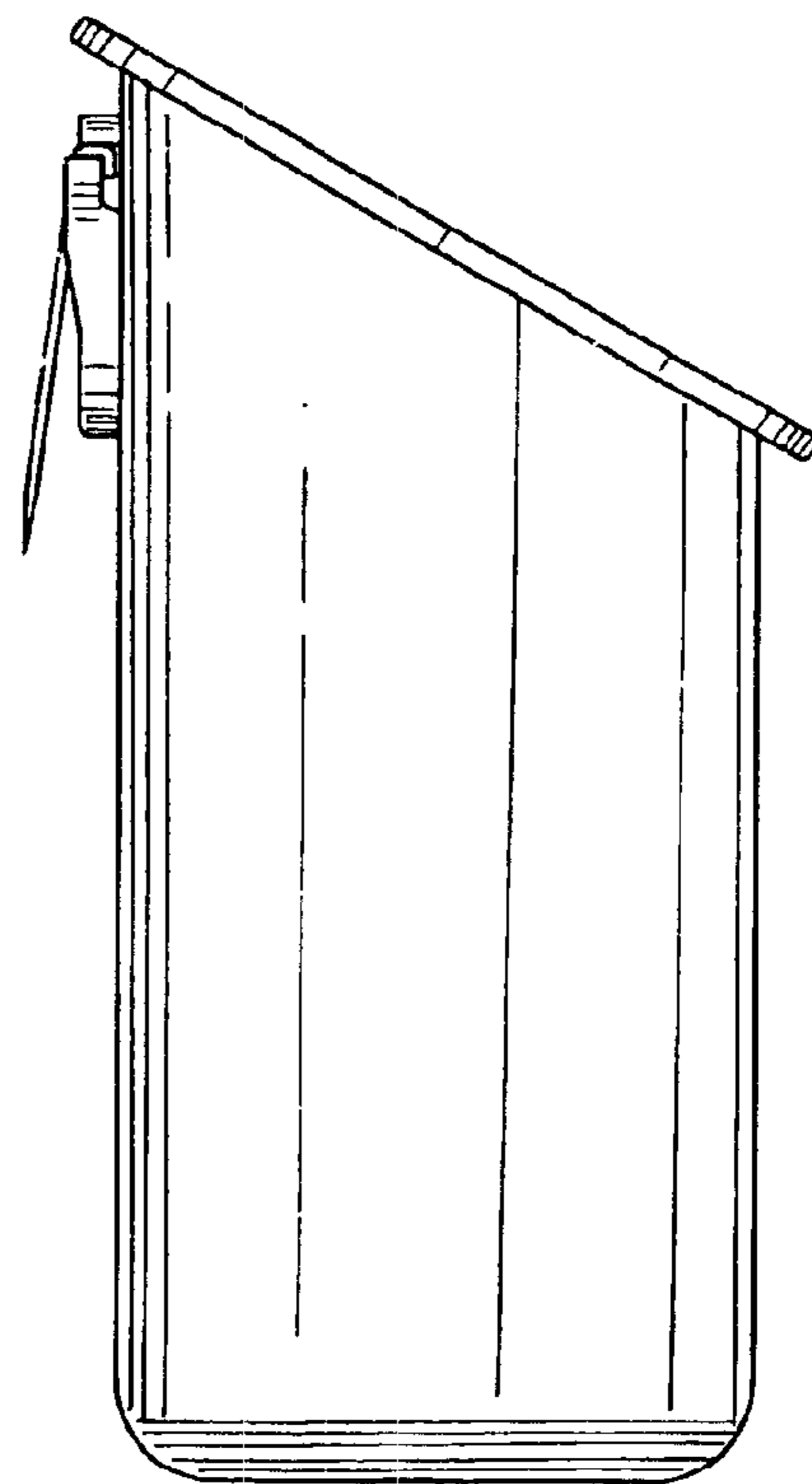

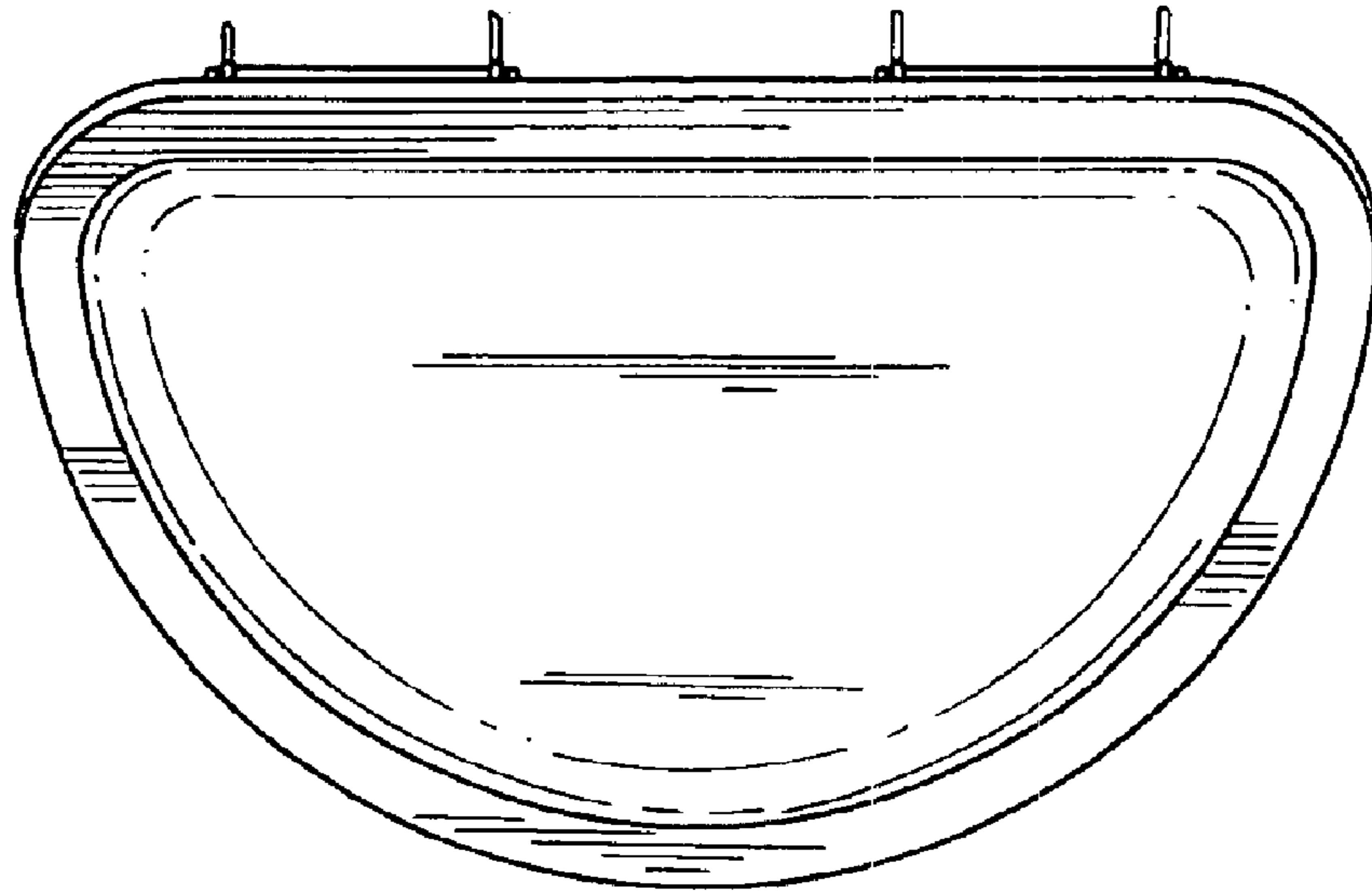

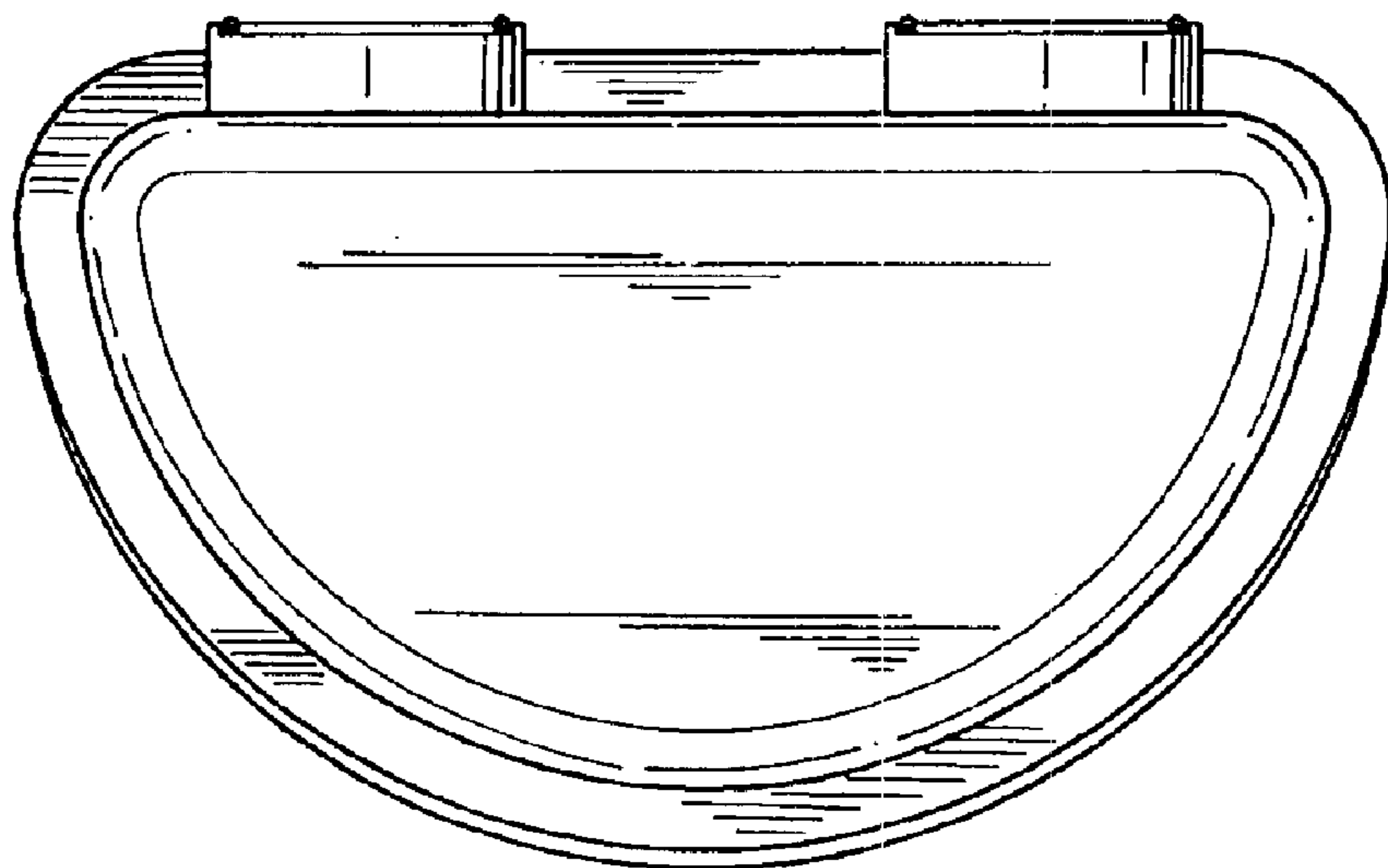

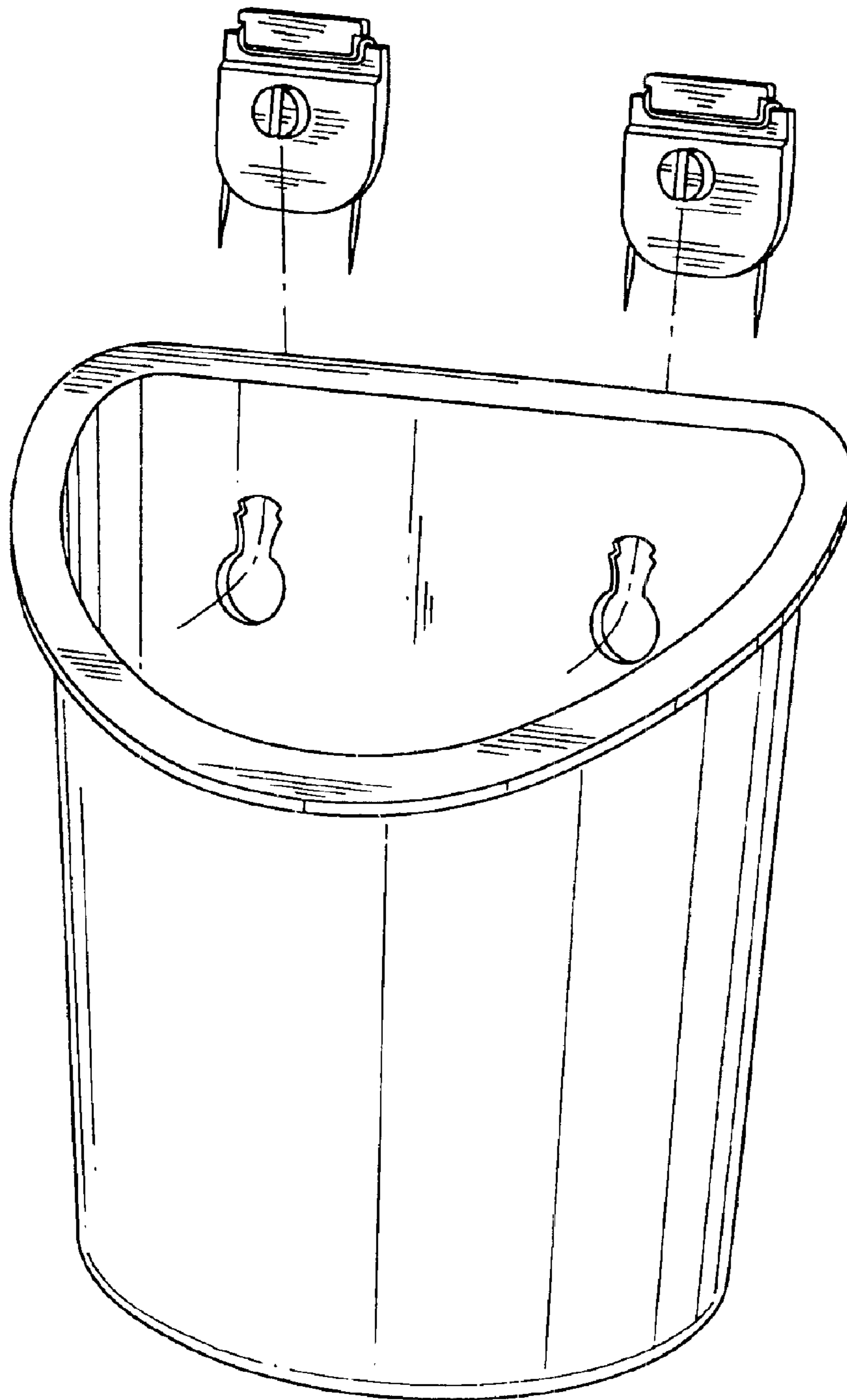
