(57) **CLAIM**

The ornamental design for a “signage display,” as shown and described.

DESCRIPTION

FIG. 1 is a left side perspective view taken from the front, left side, and above, showing our new design;
 FIG. 2 is a front elevational view thereof, the rear elevational view being a mirror image thereof;
 FIG. 3 is a left side elevational view thereof, the right side elevational view being a mirror image thereof;
 FIG. 4 is a top view thereof;
 FIG. 5 is a left perspective view taken from the front, left side, and above, of another embodiment thereof;
 FIG. 6 is a front elevational view thereof, the rear elevational view being a mirror image thereof;
 FIG. 7 is a left side elevational view thereof, the right side elevational view being a mirror image thereof; and,
 FIG. 8 is a top plan view thereof.

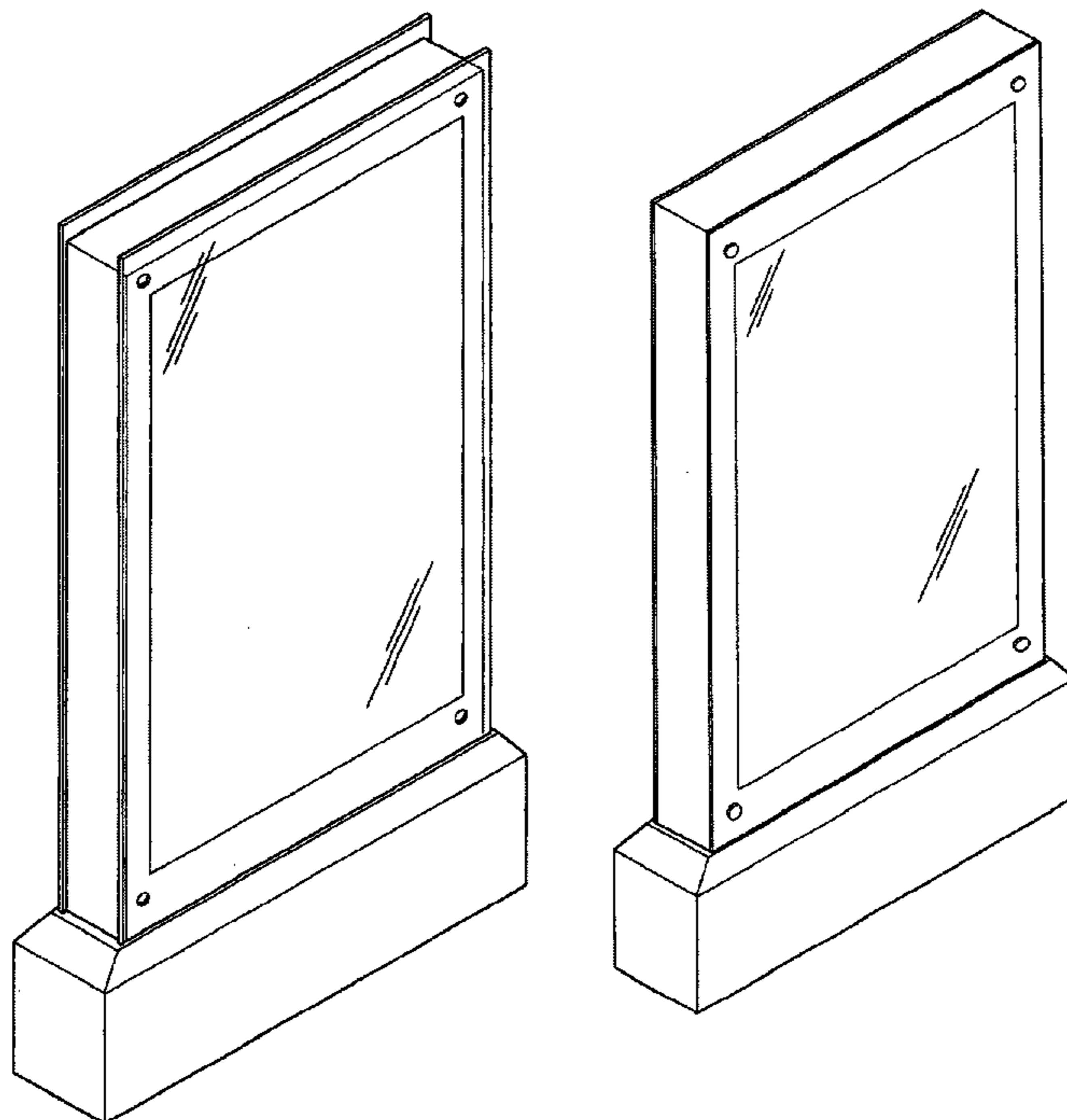

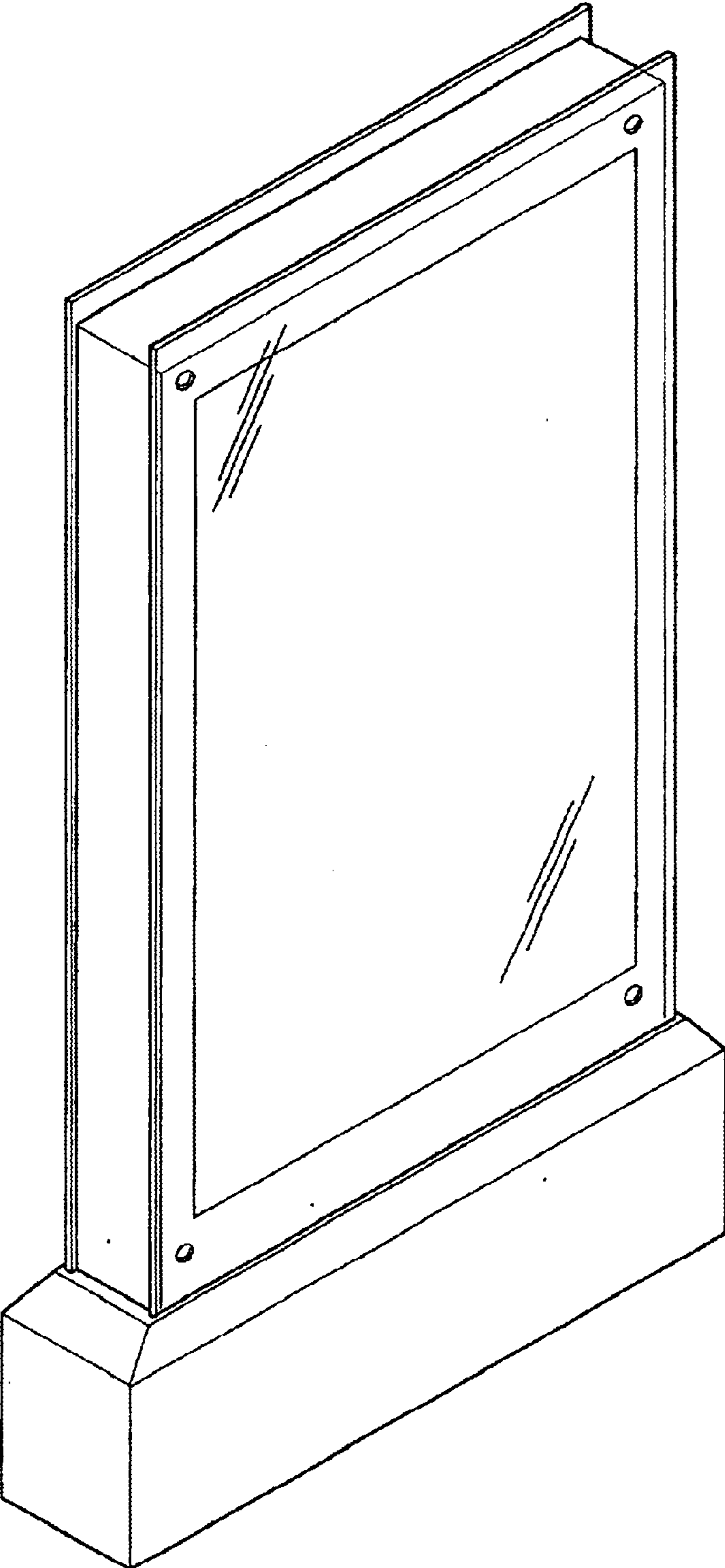

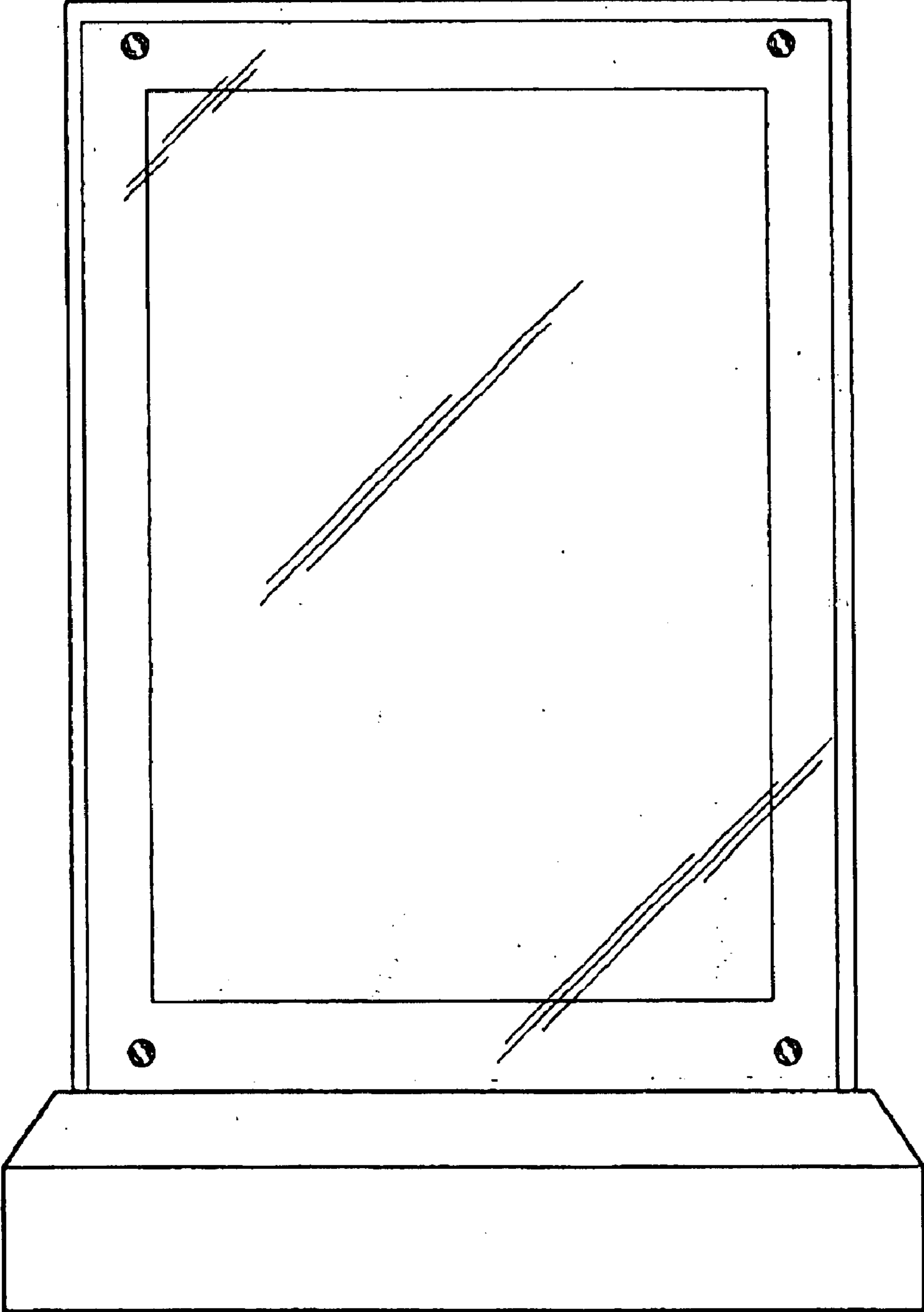

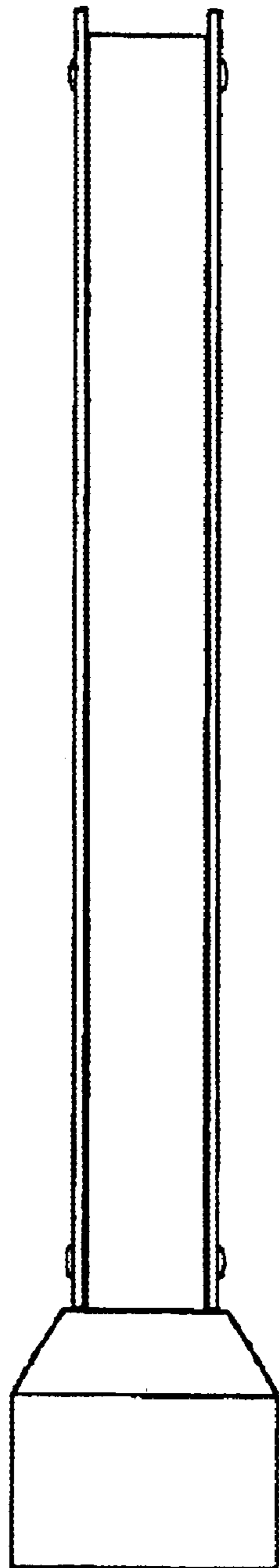

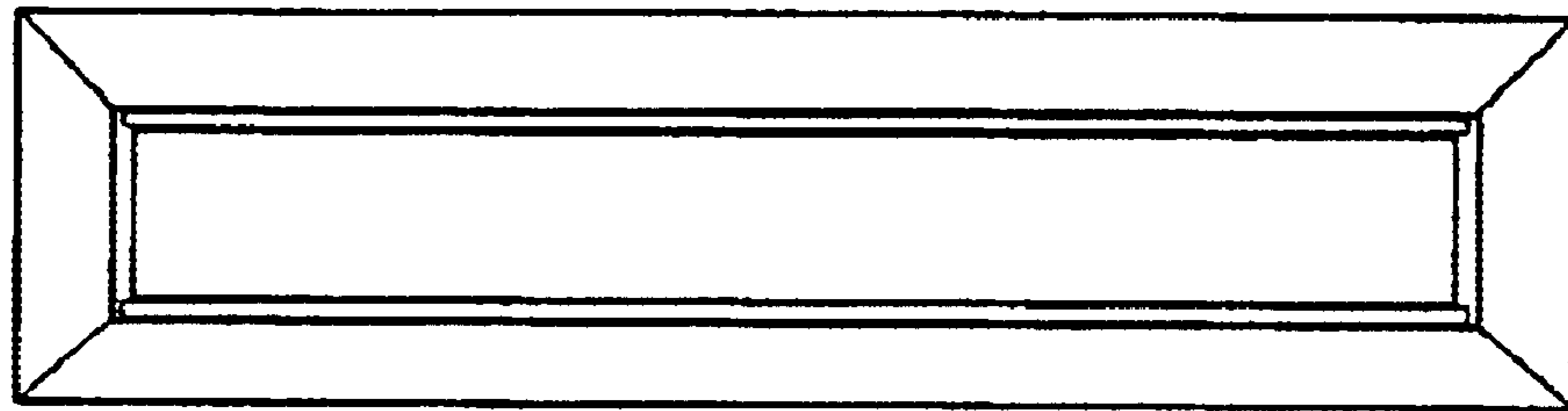

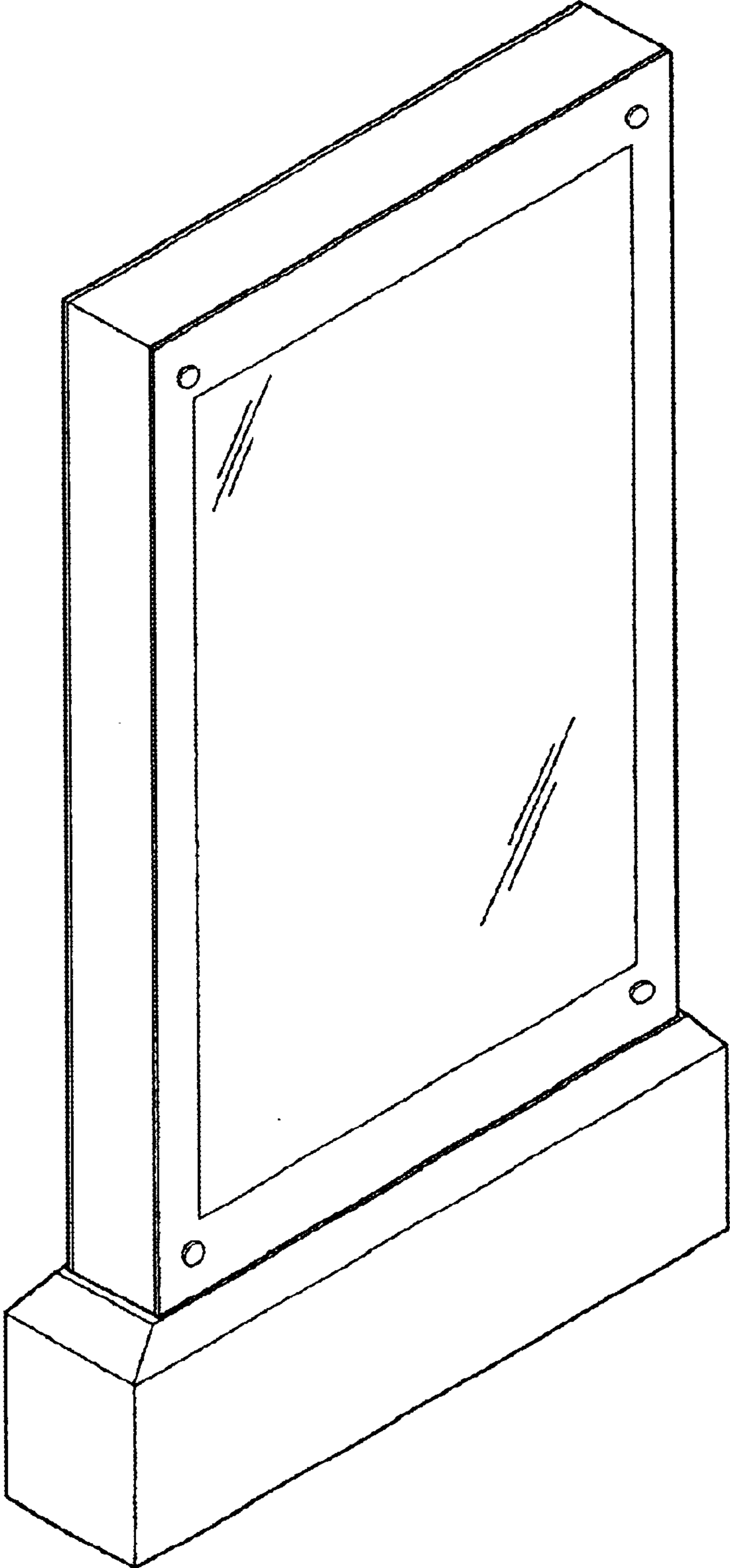

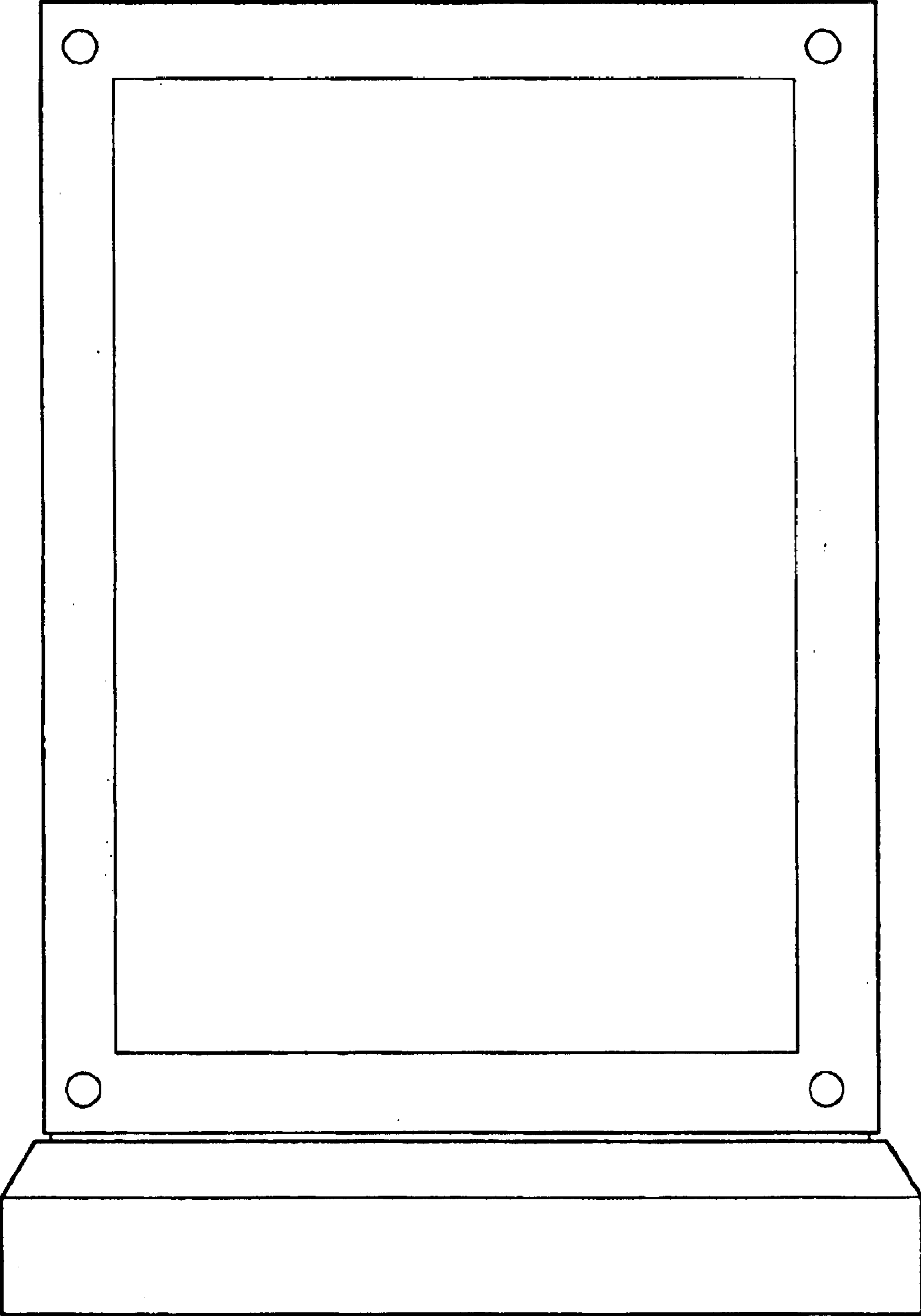

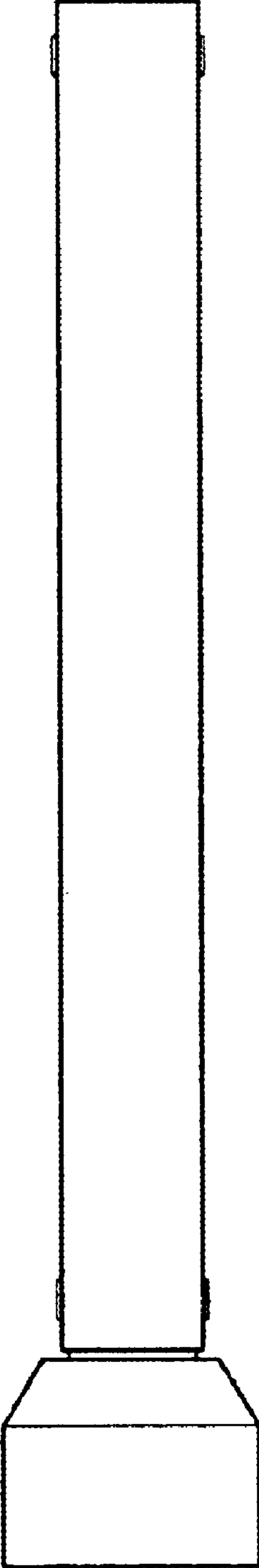
