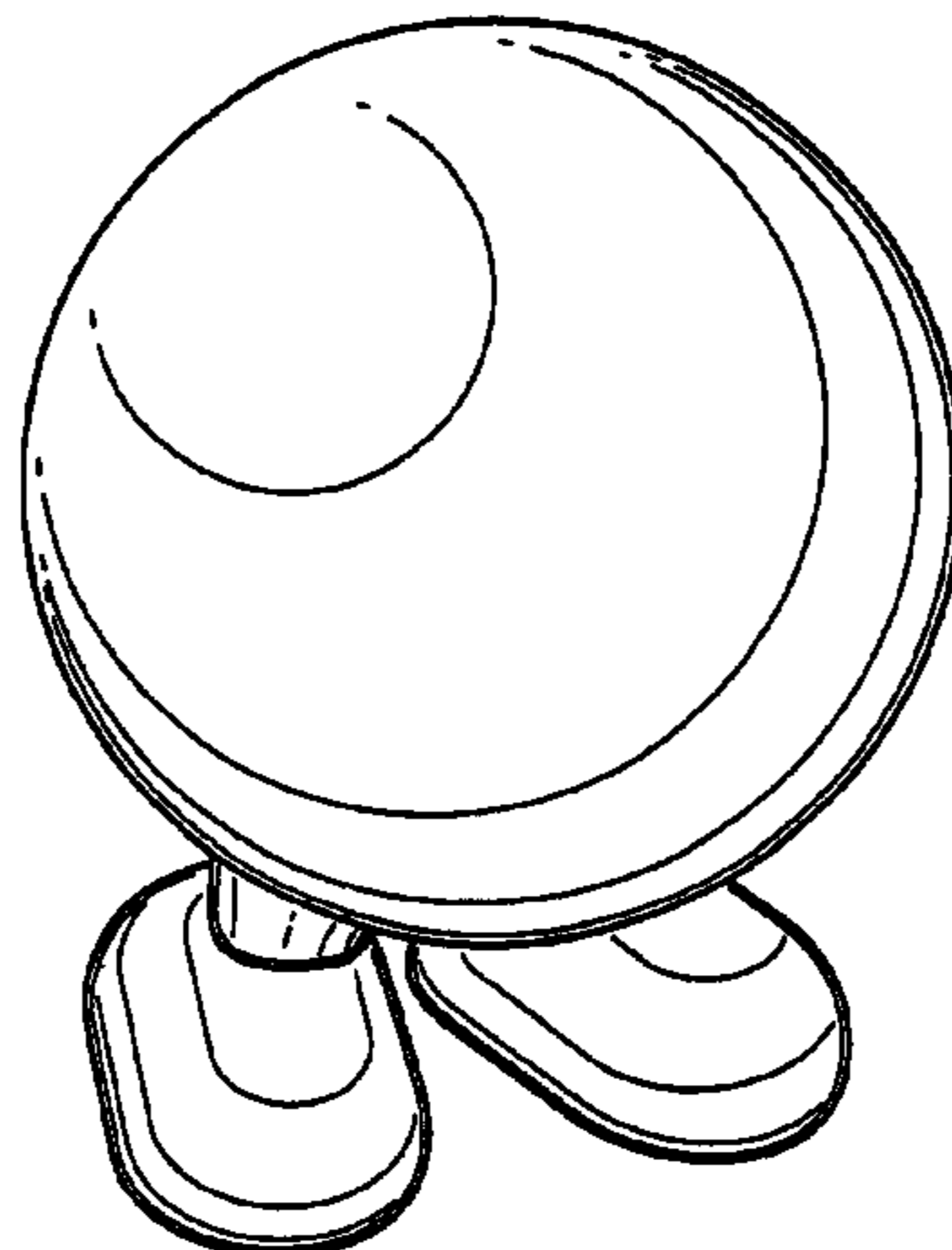
(57) **CLAIM**

The ornamental design for angel toy, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an angel toy showing our new design;
FIG. 2 is a front elevation thereof;
FIG. 3 is a rear elevation thereof;
FIG. 4 is a left side elevation thereof;
FIG. 5 is a right side elevation thereof;
FIG. 6 is a top view thereof; and,
FIG. 7 is a bottom view thereof, the portion in dotted lines representing no part of the claimed invention.
The broken lines shown in FIGS. 2, 3, 4, 5 and 7 are for illustrative purposes only and do not form part of the claimed design.

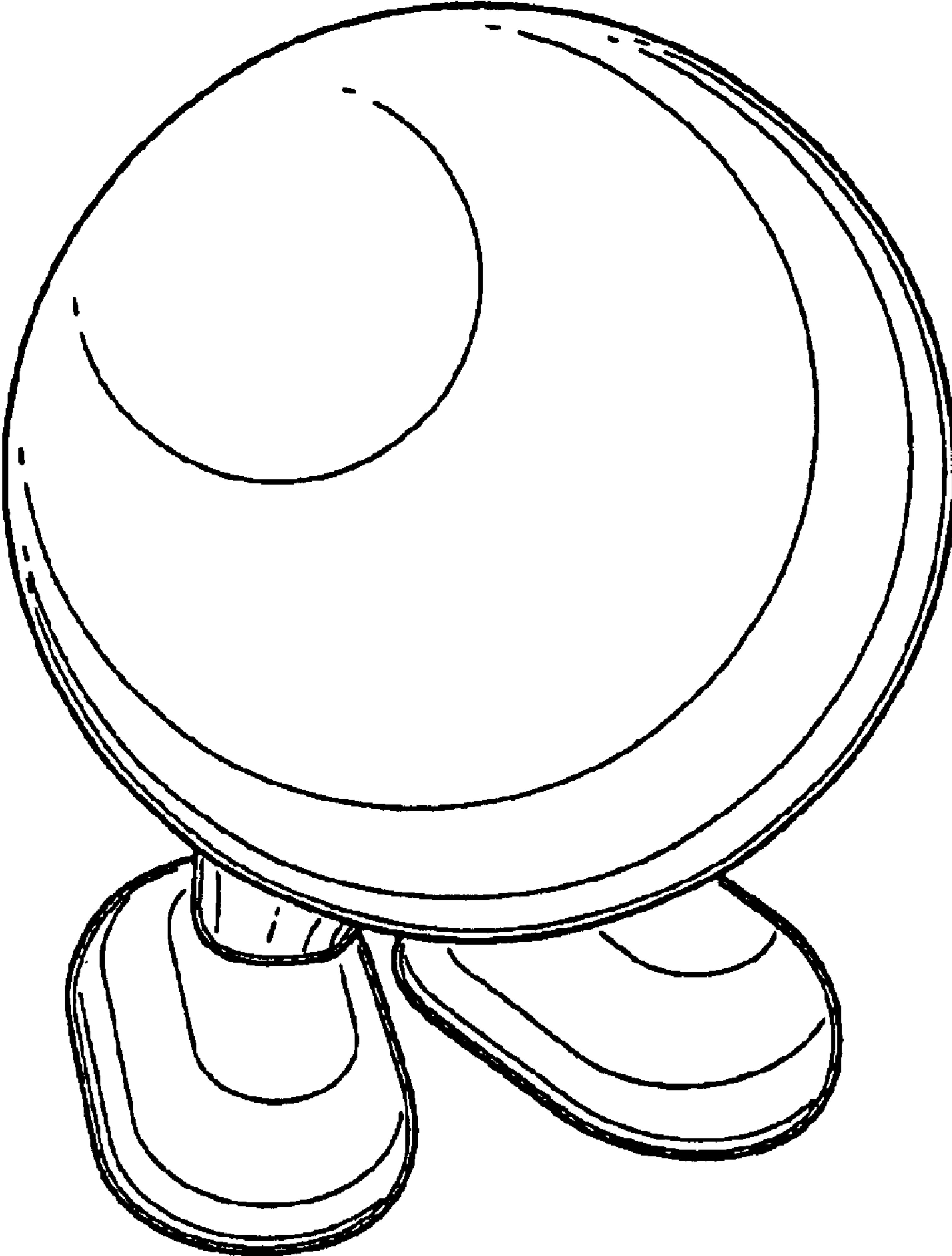

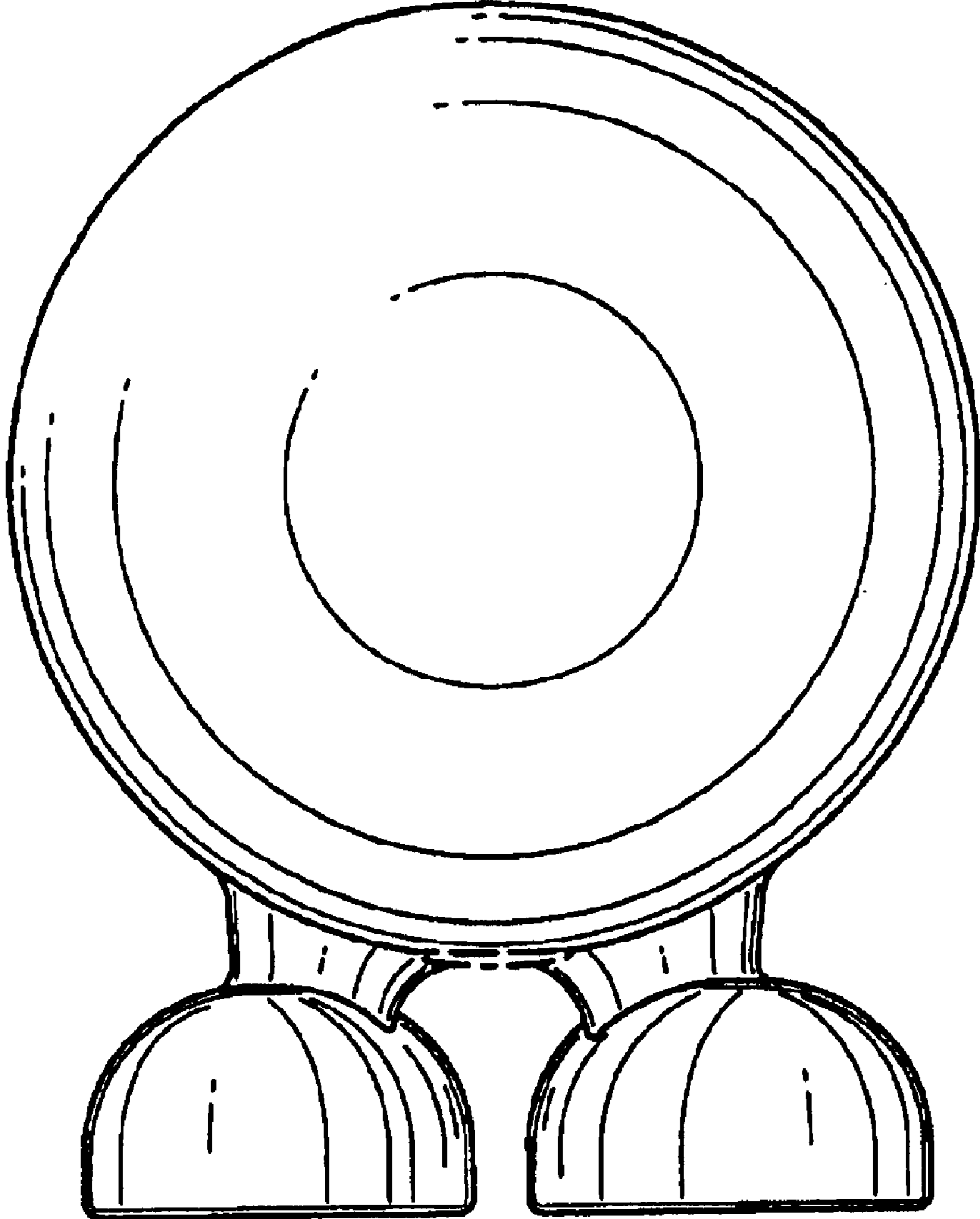

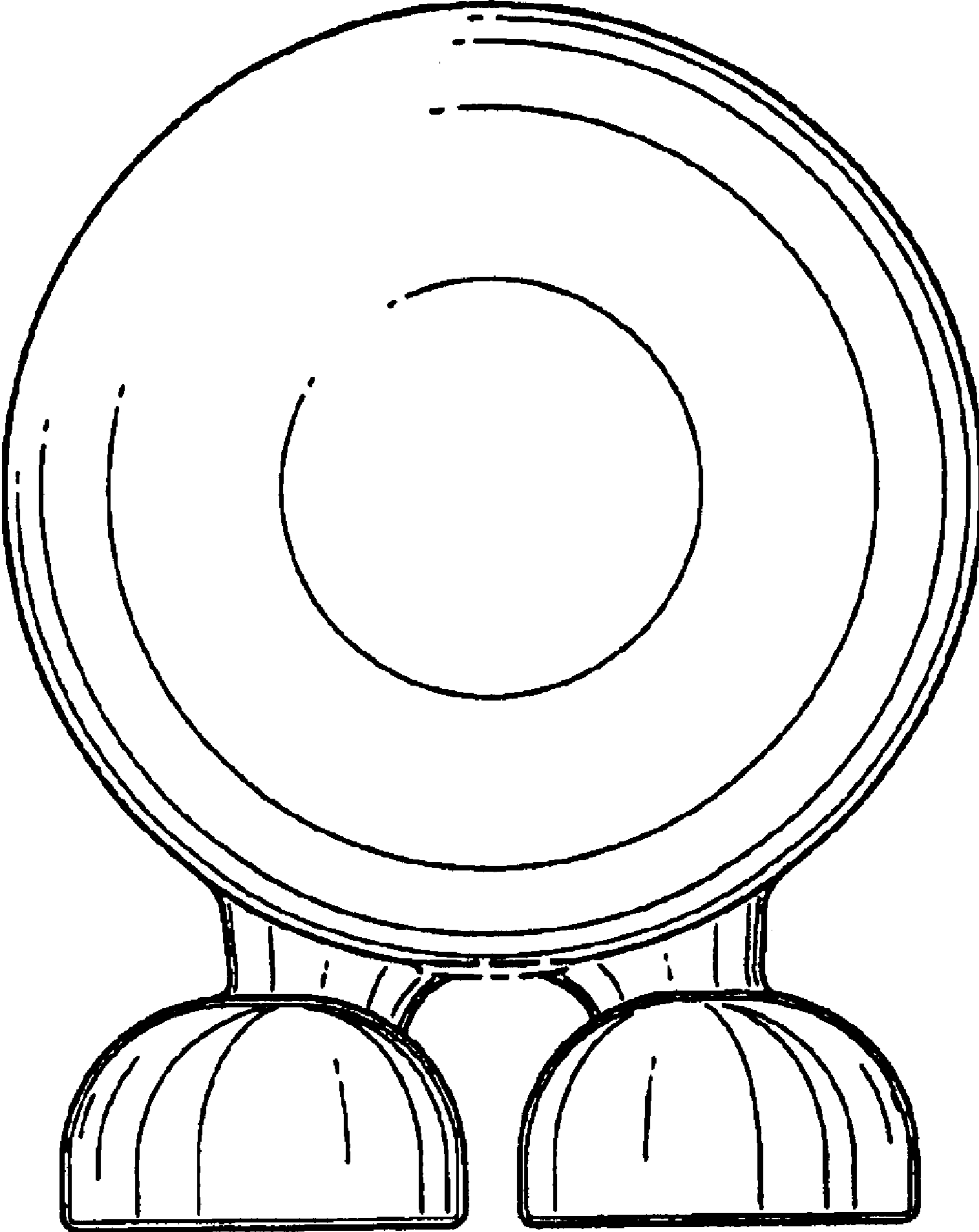

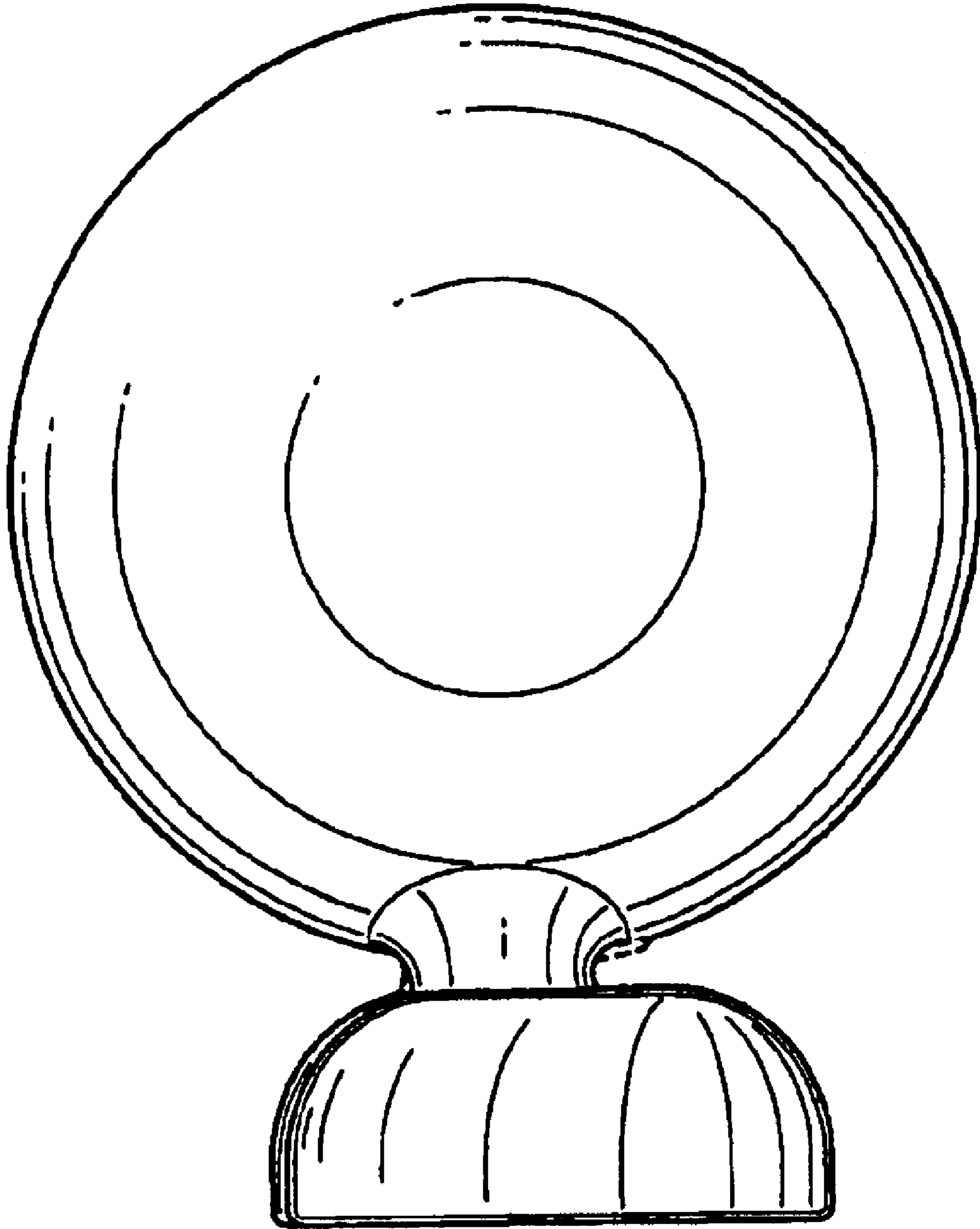

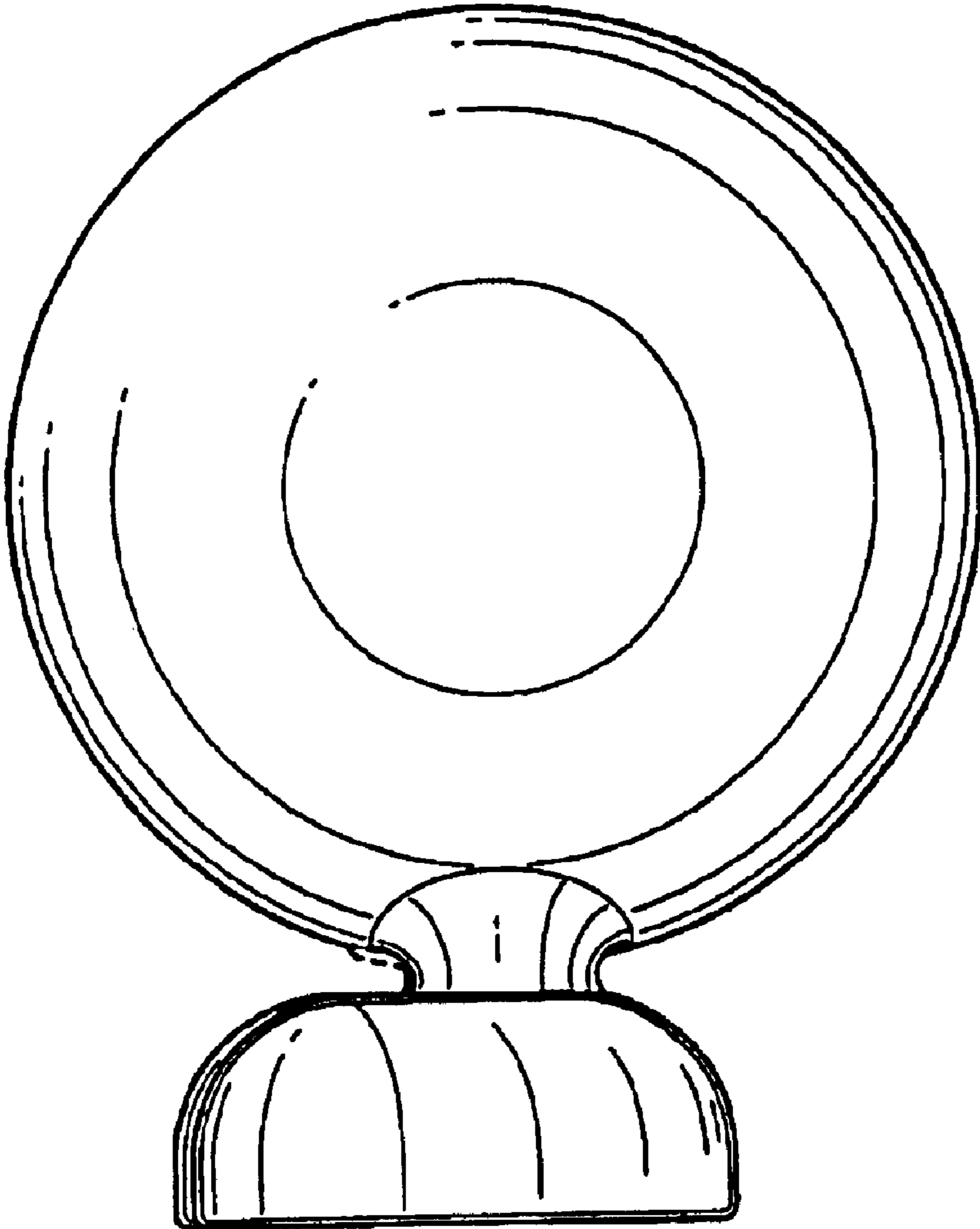

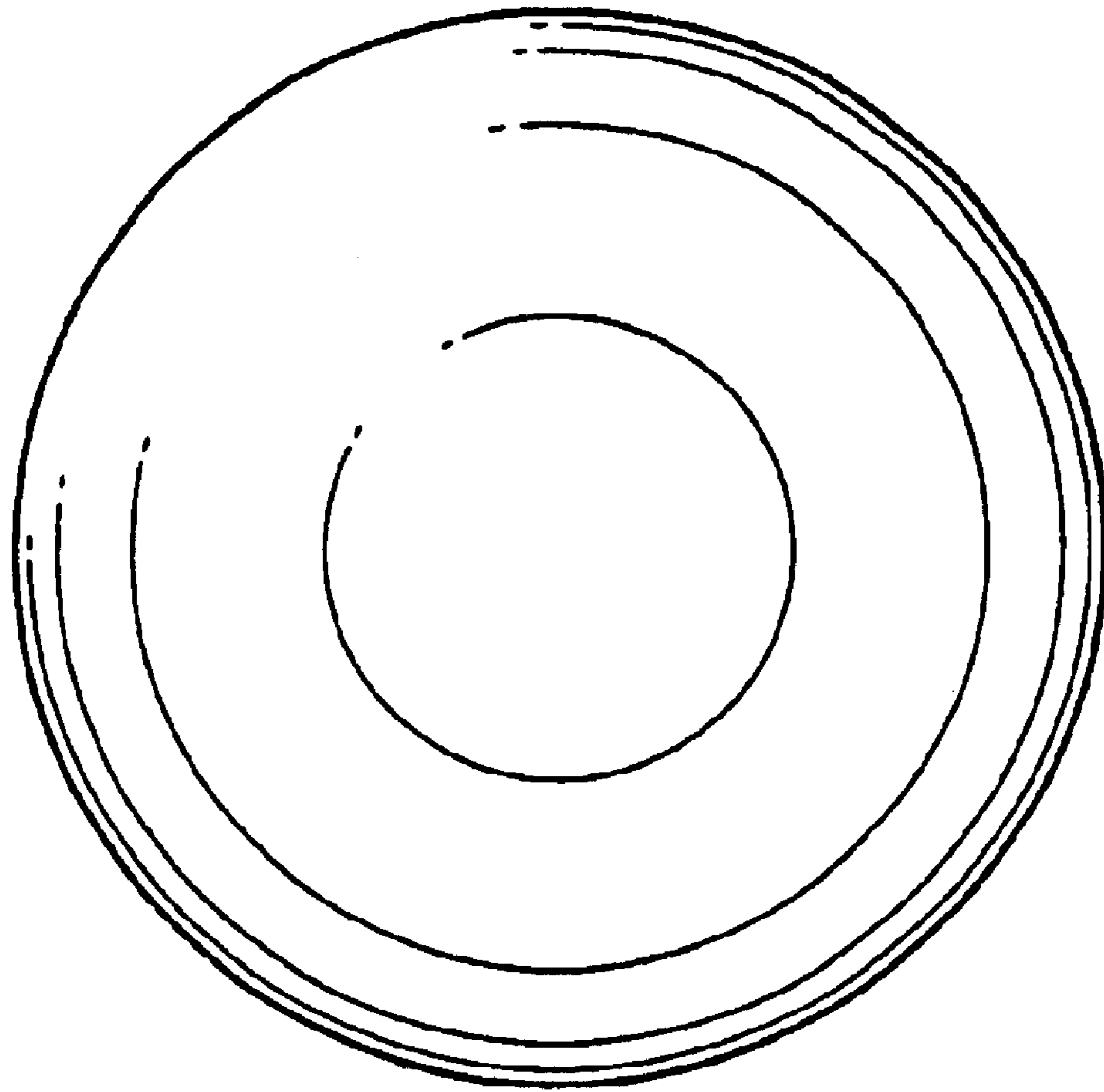

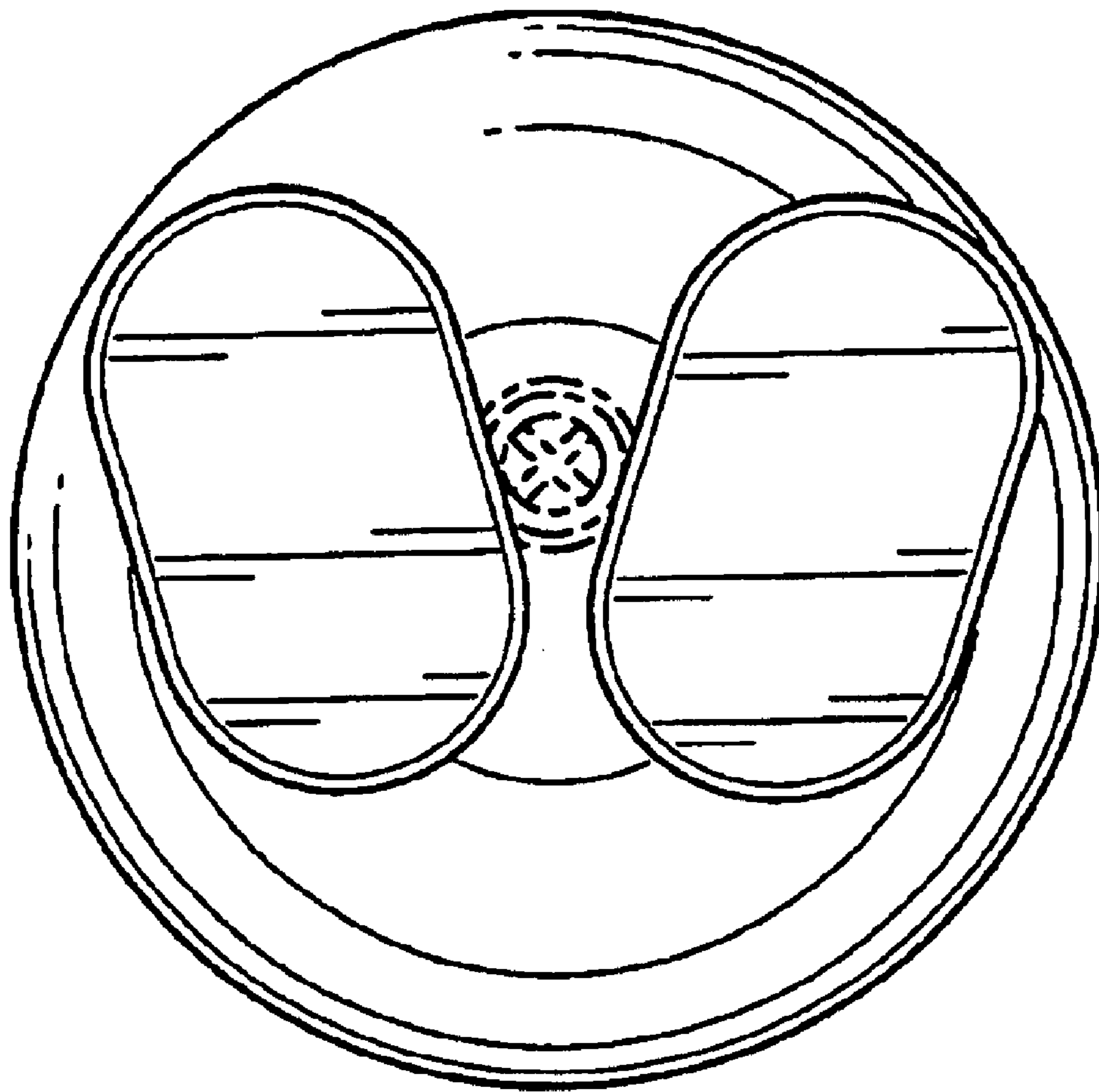
