The ornamental design for a cigarette lighter, as shown and described.

**DESCRIPTION**

FIG. 20 is a right side elevational view;

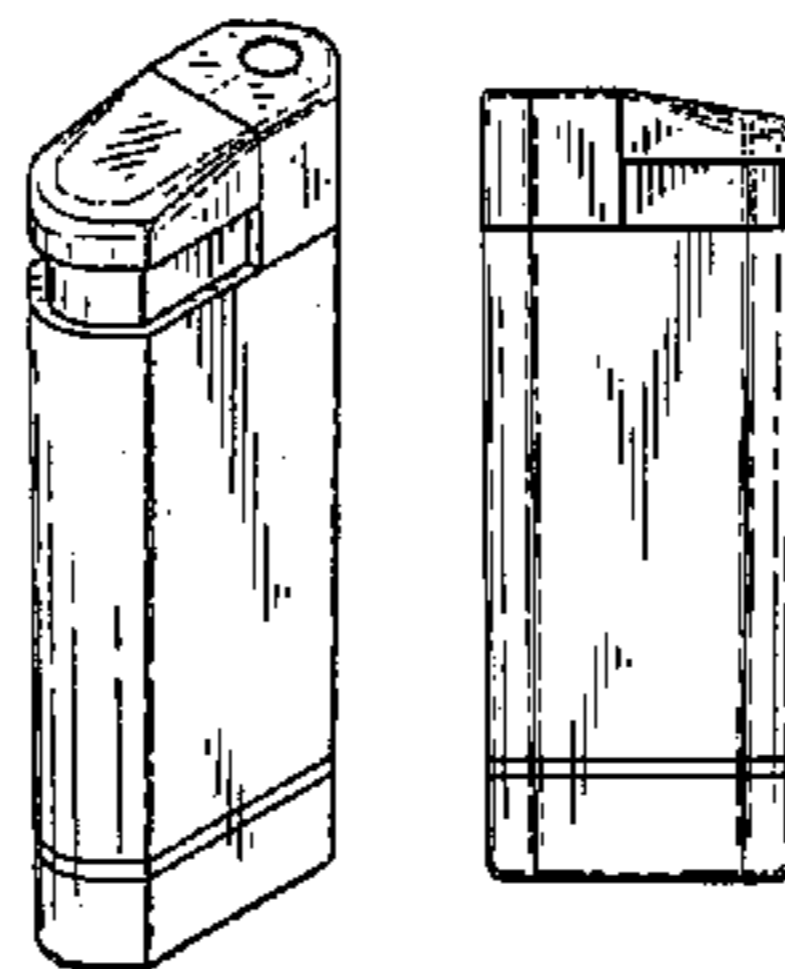
FIG. 21 is a front elevational view, the rear elevational view being a mirror image thereof;

FIG. 22 is a left side elevational view;

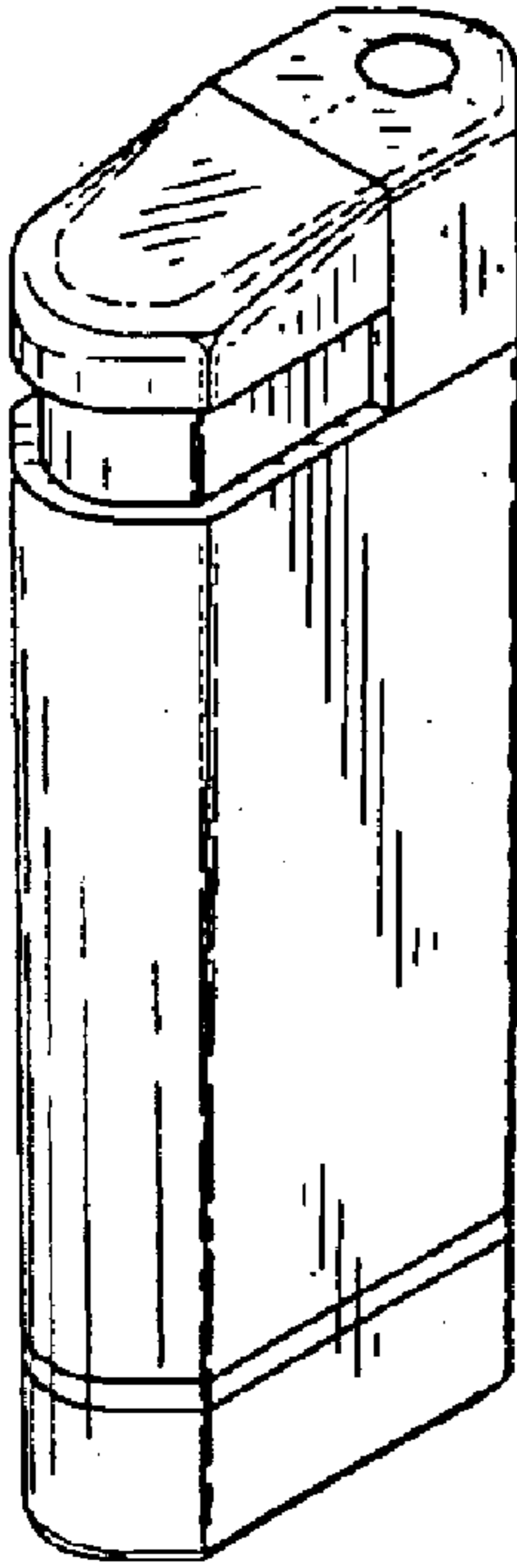
FIG. 23 is a top plan view; and,

FIG. 24 is a bottom plan view.

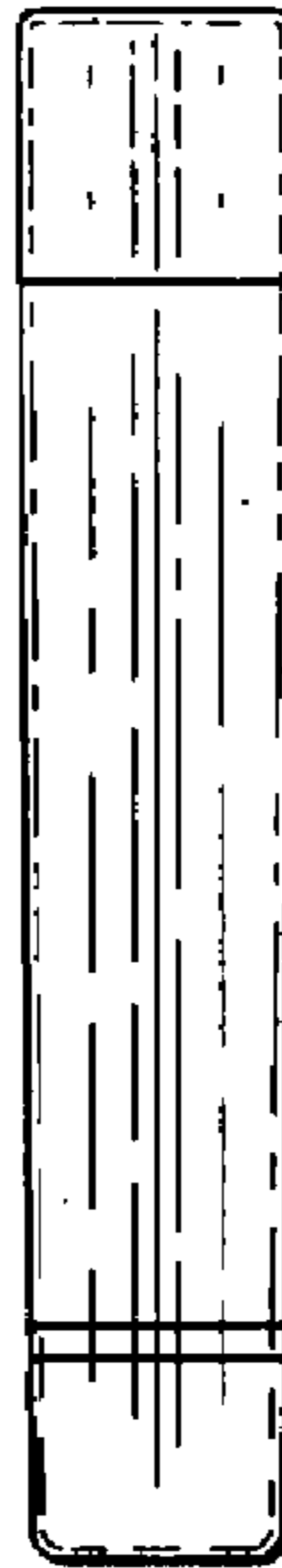

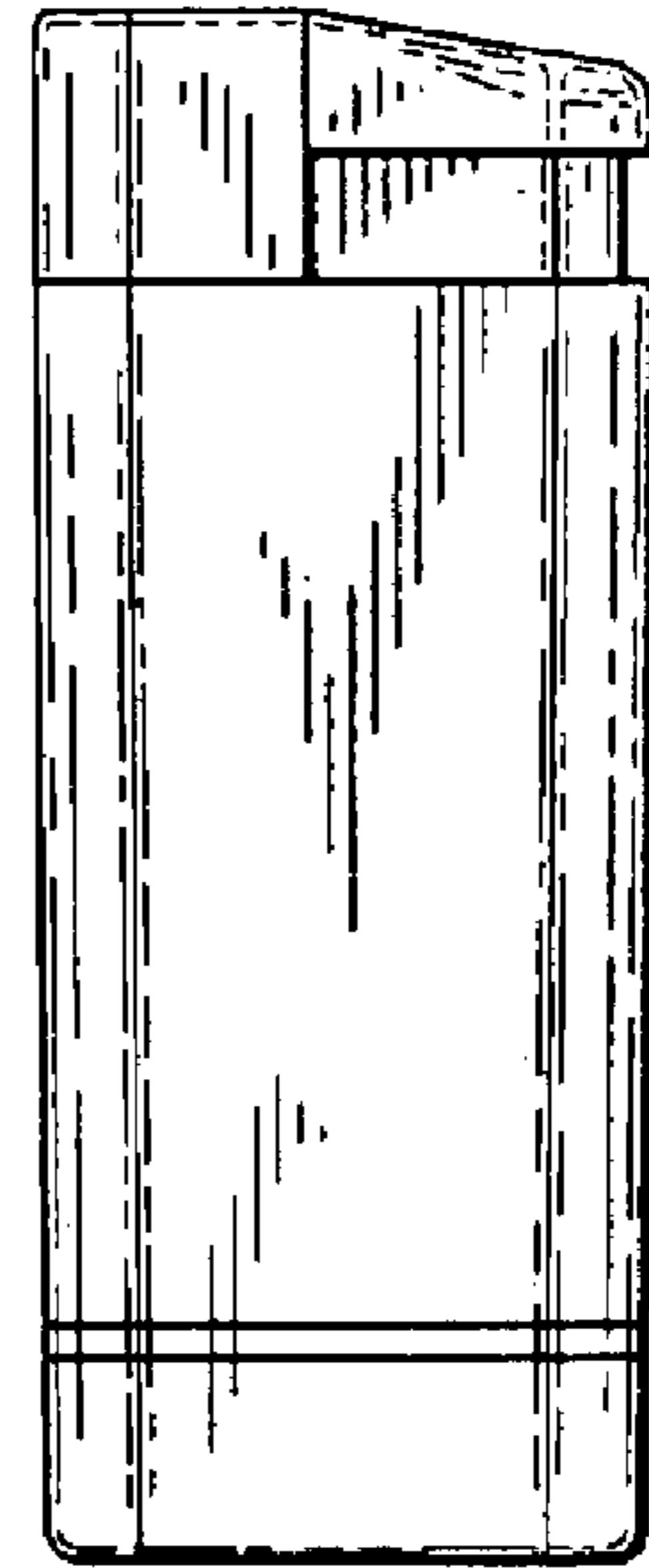

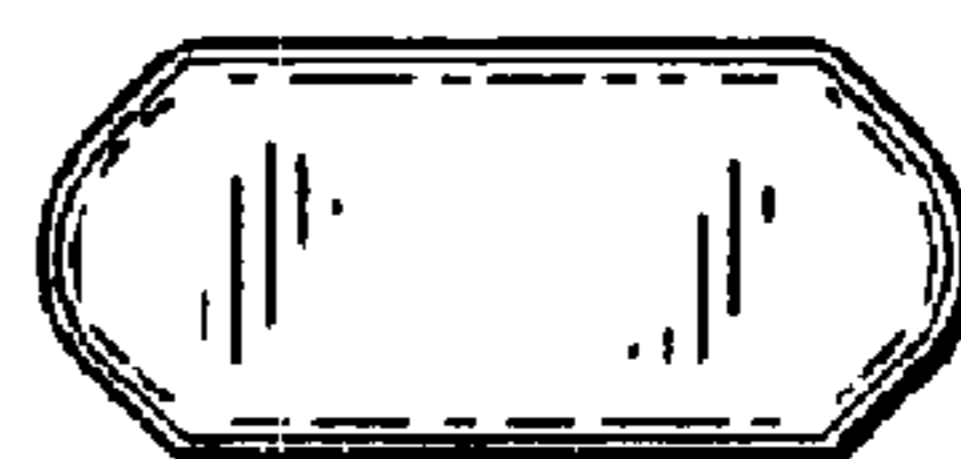

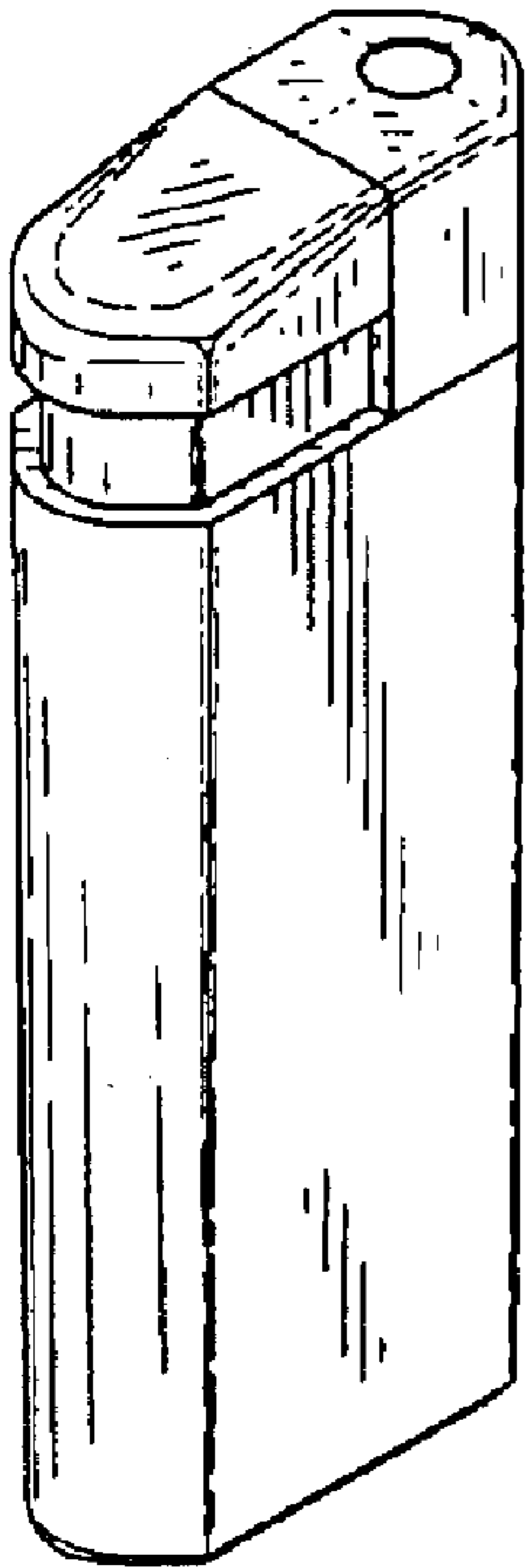

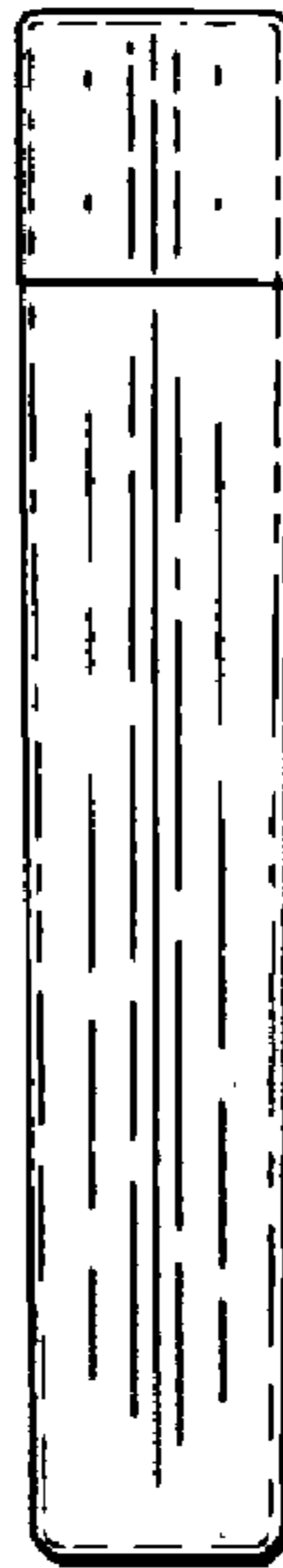

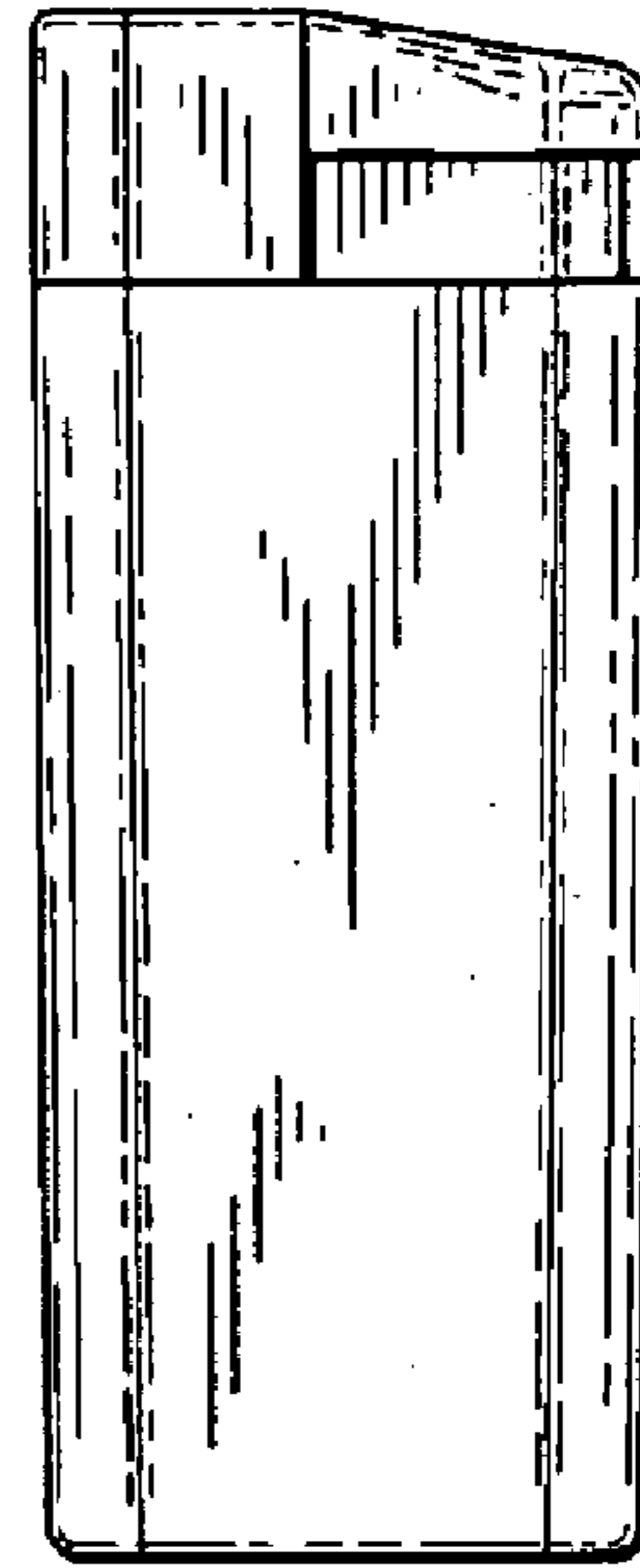

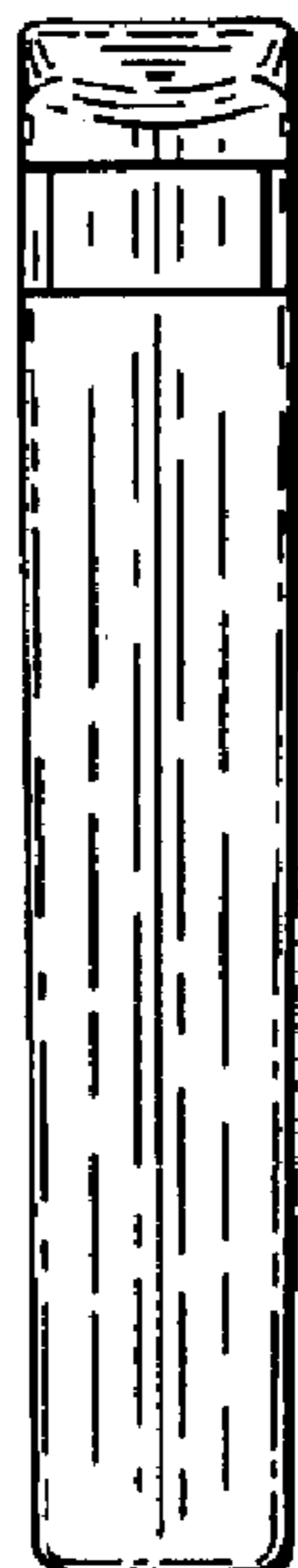

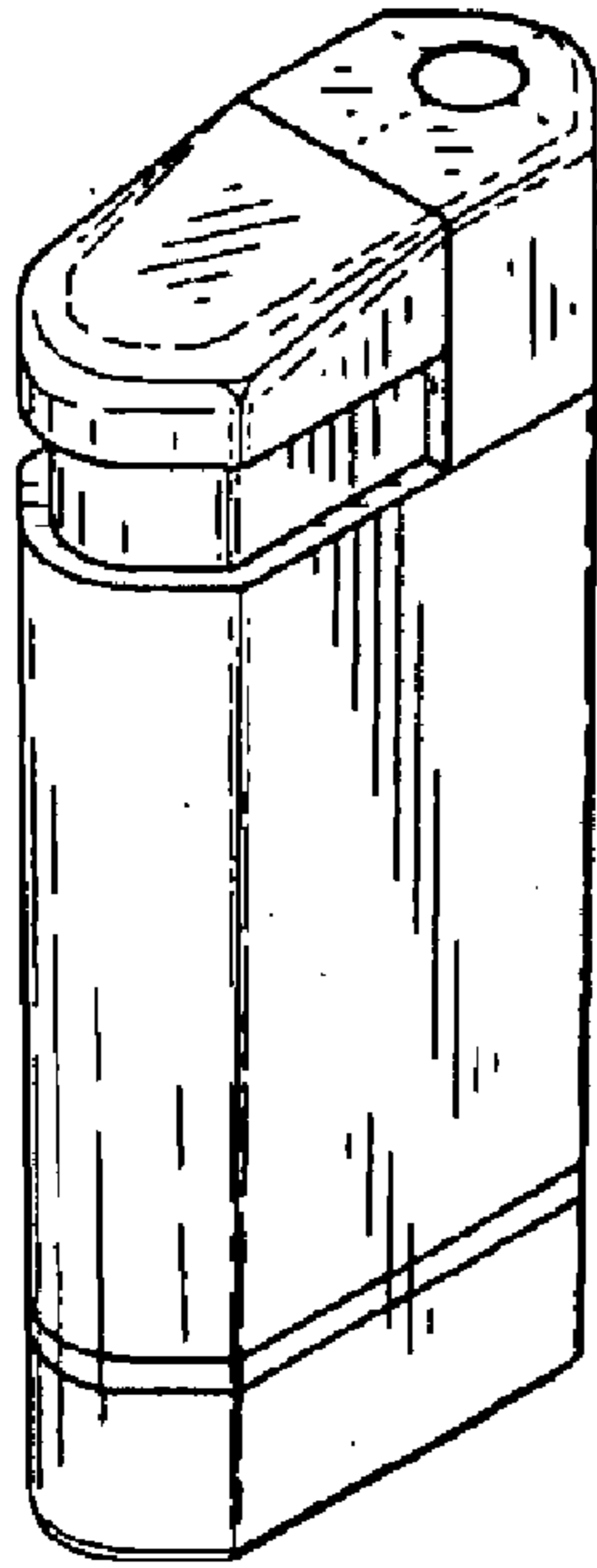

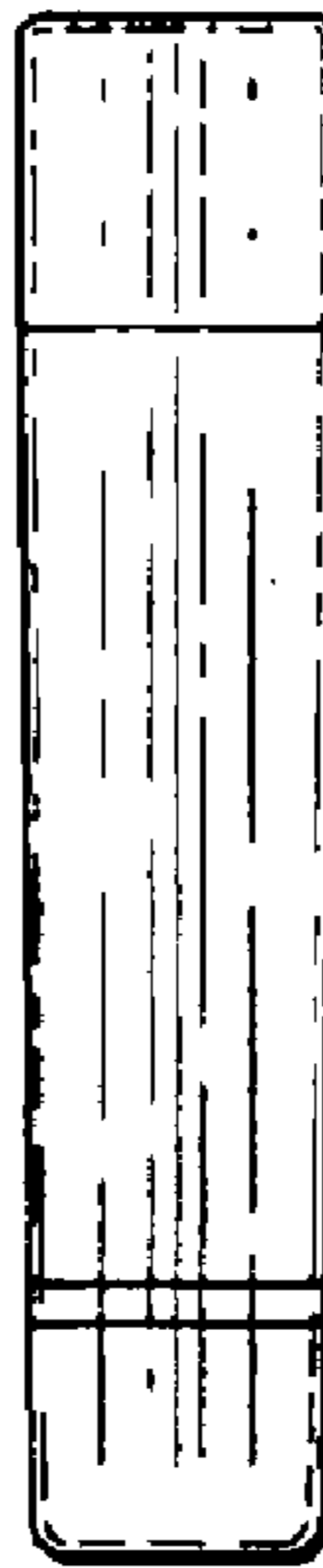

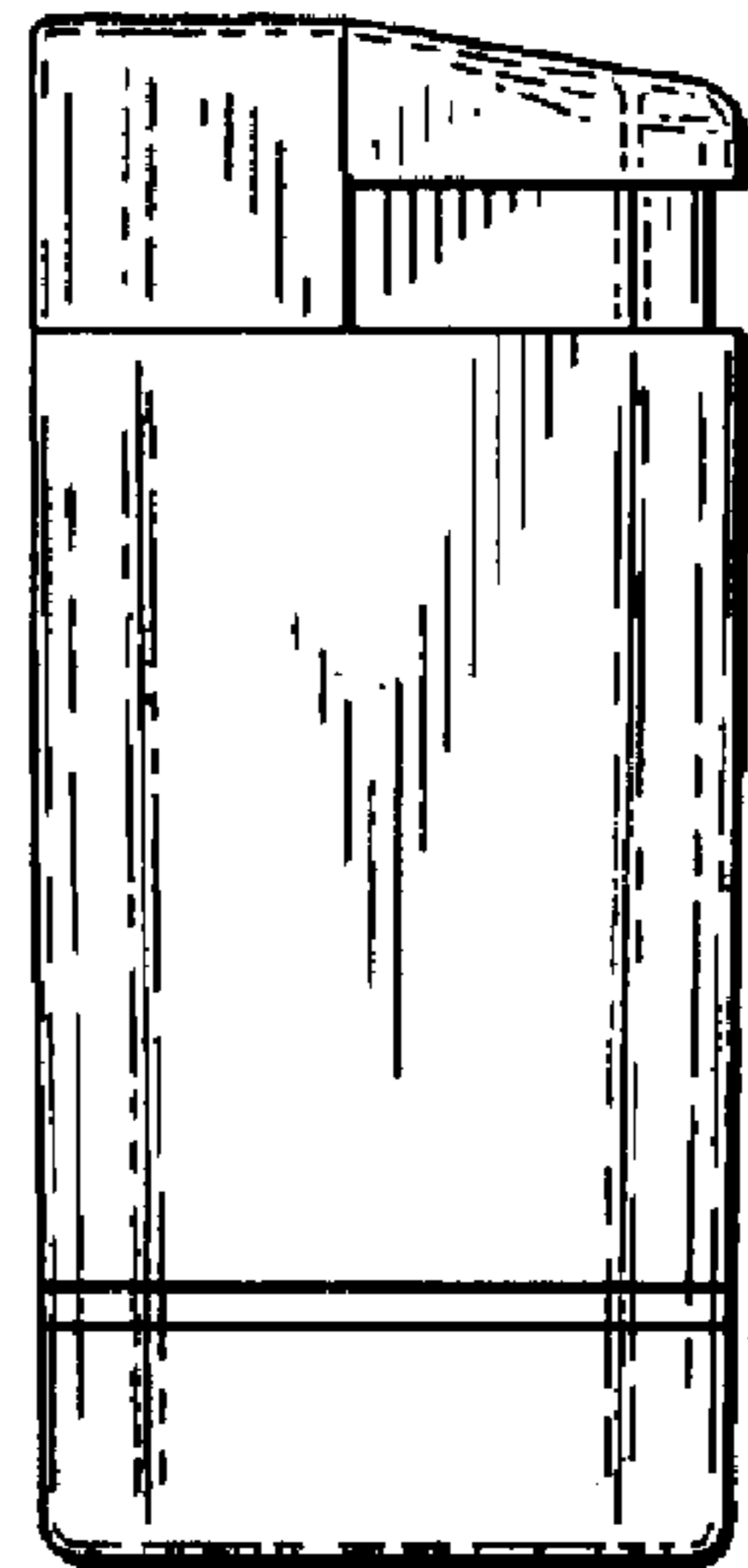

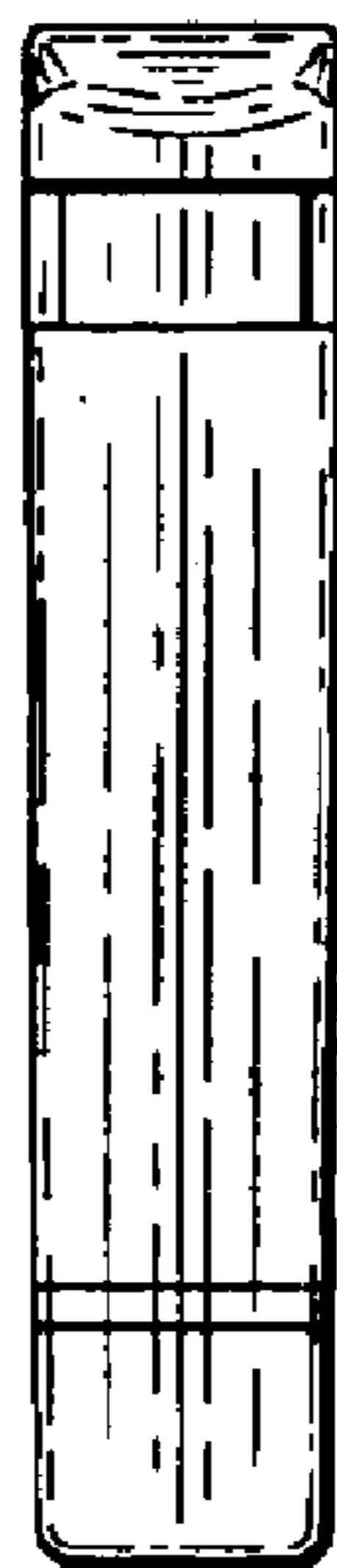

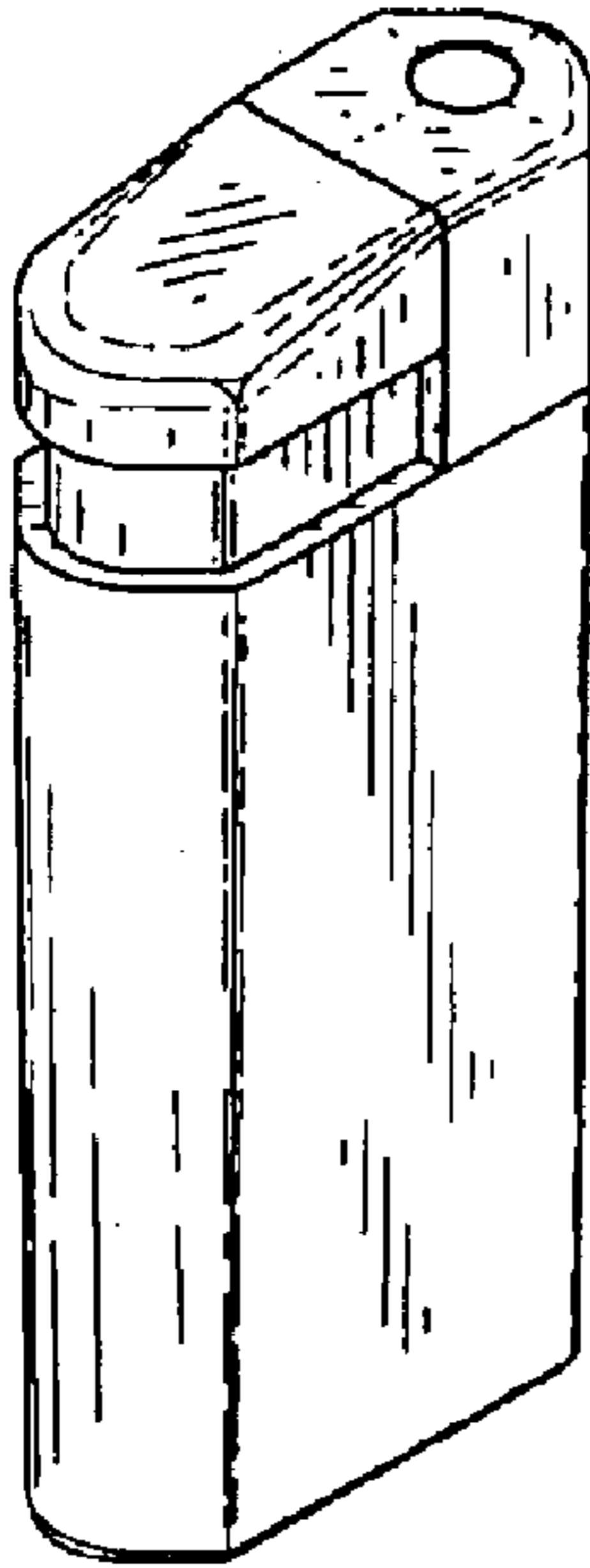

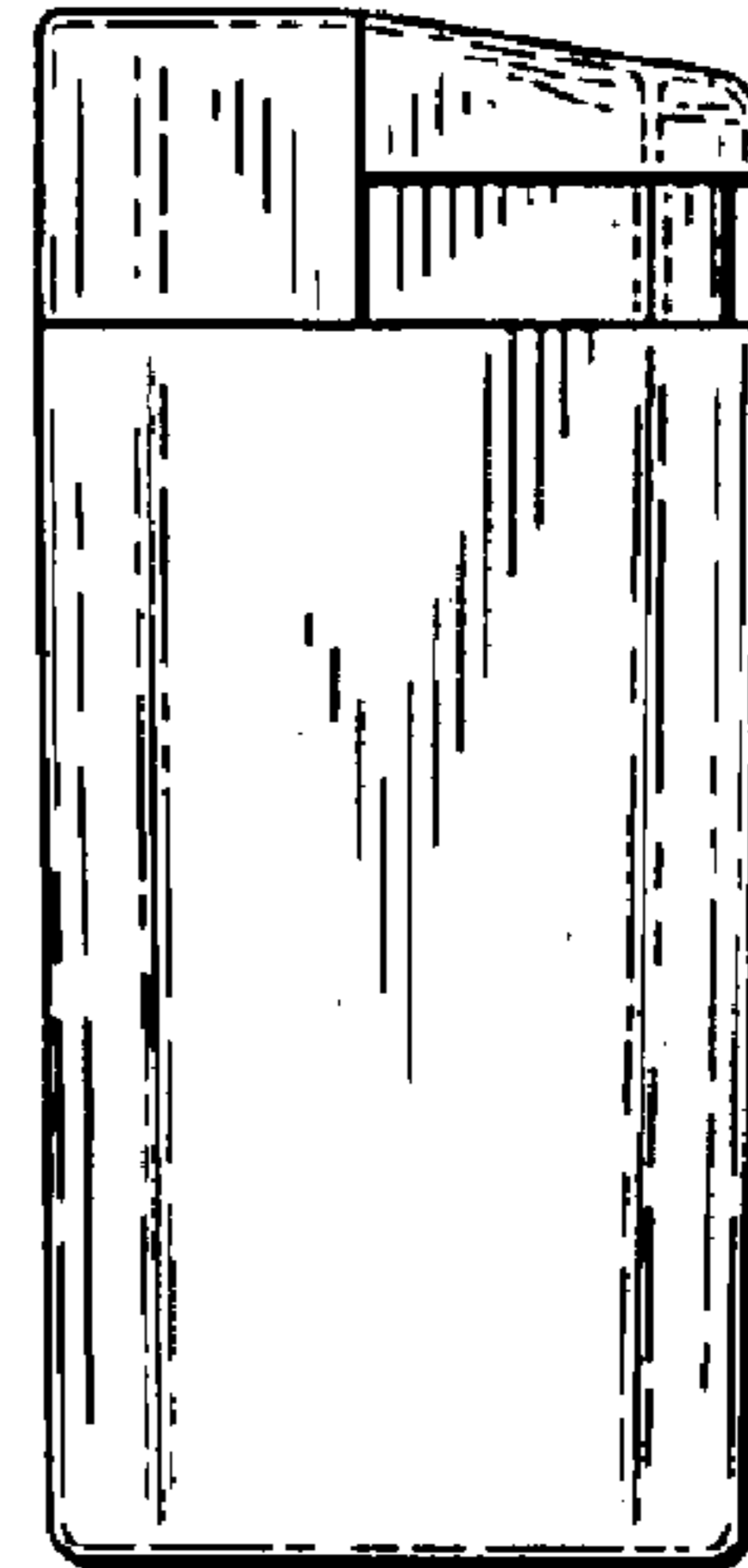

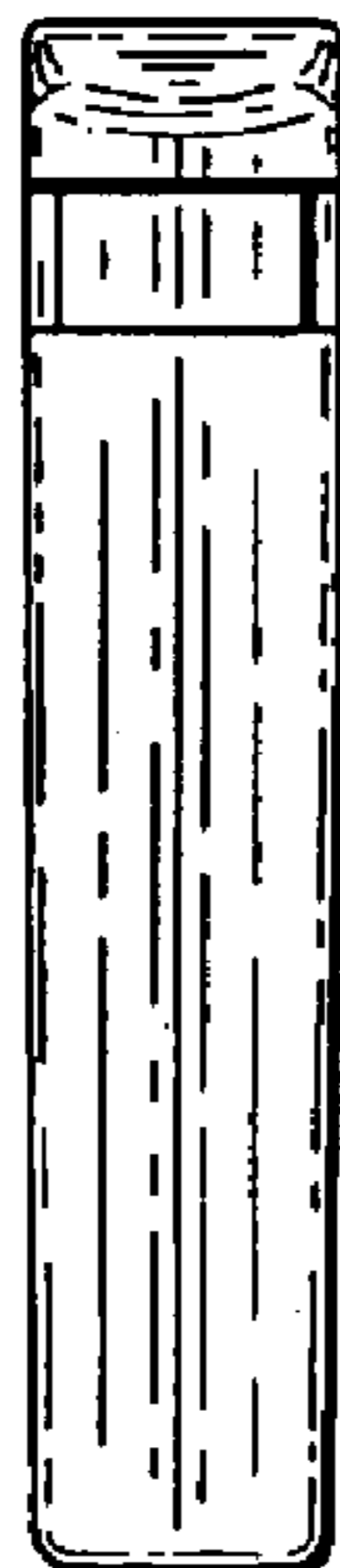
