(57) **CLAIM**

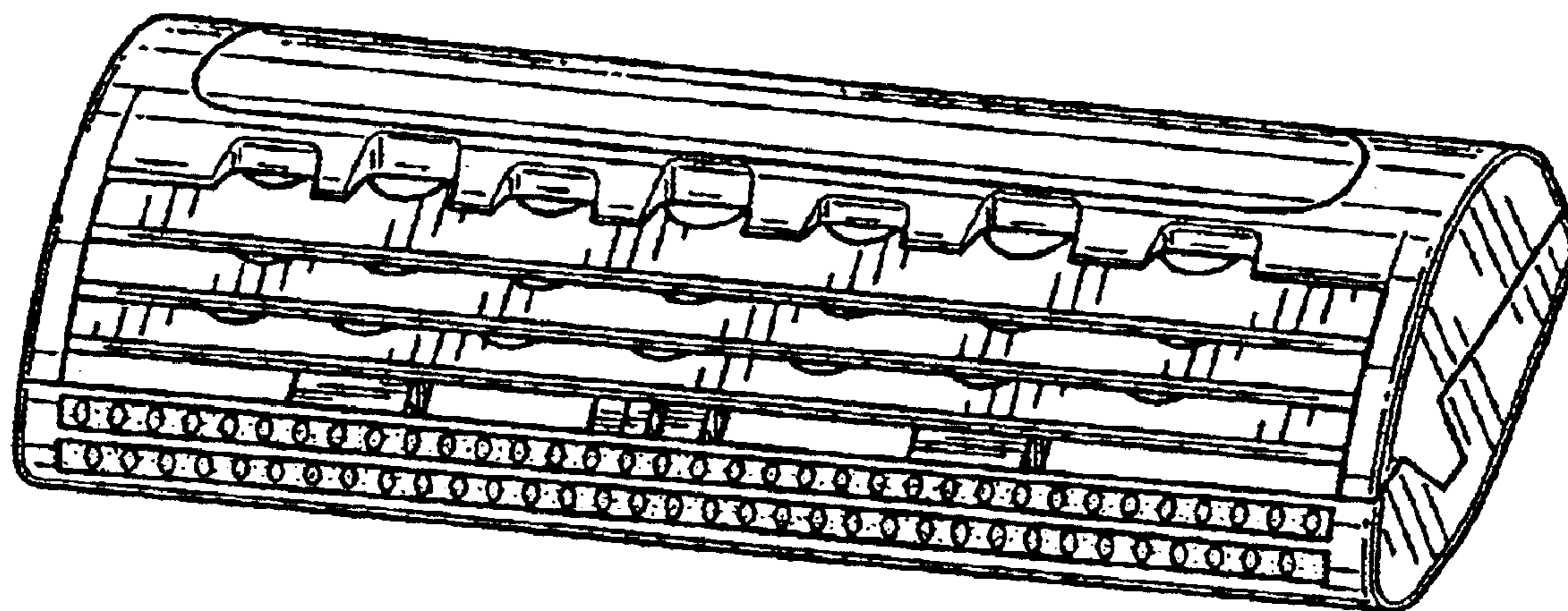
The ornamental design for a razor cartridge having a dual purpose soap bar, as shown and described in the drawings.

DESCRIPTION

FIG. 1 is a front perspective view of a razor cartridge having a dual purpose soap bar showing the new design;
 FIG. 2 is a top view of the razor cartridge having a dual purpose soap bar;
 FIG. 3 is a bottom view of the razor cartridge having a dual purpose soap bar;
 FIG. 4 is an upended left side view of the razor cartridge having a dual purpose soap bar;
 FIG. 5 is a back view of the razor cartridge having a dual purpose soap bar; and,
 FIG. 6 is a front view of the razor cartridge having a dual purpose soap bar.

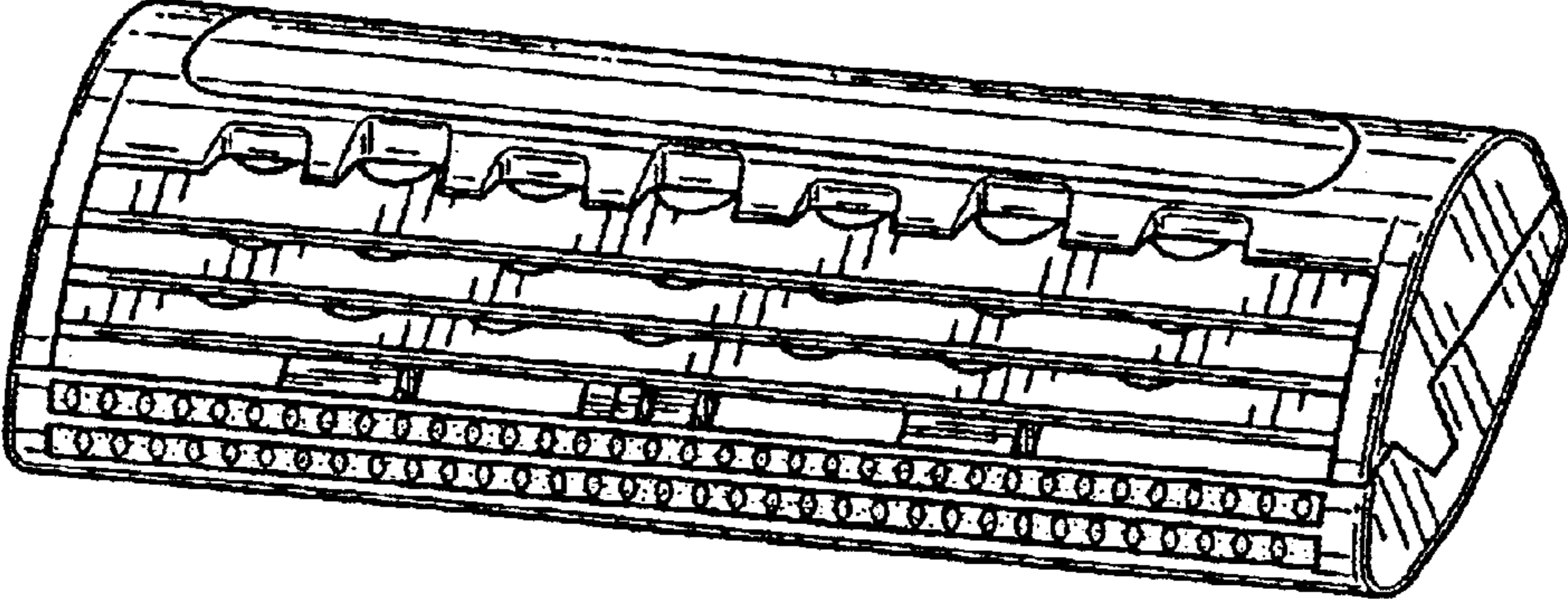

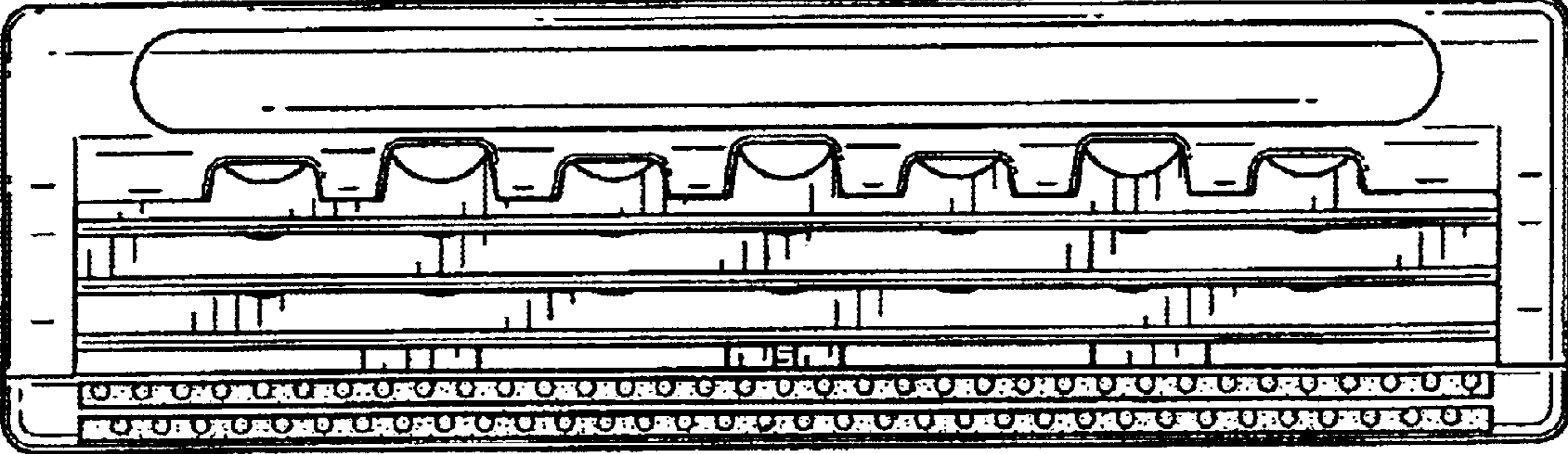

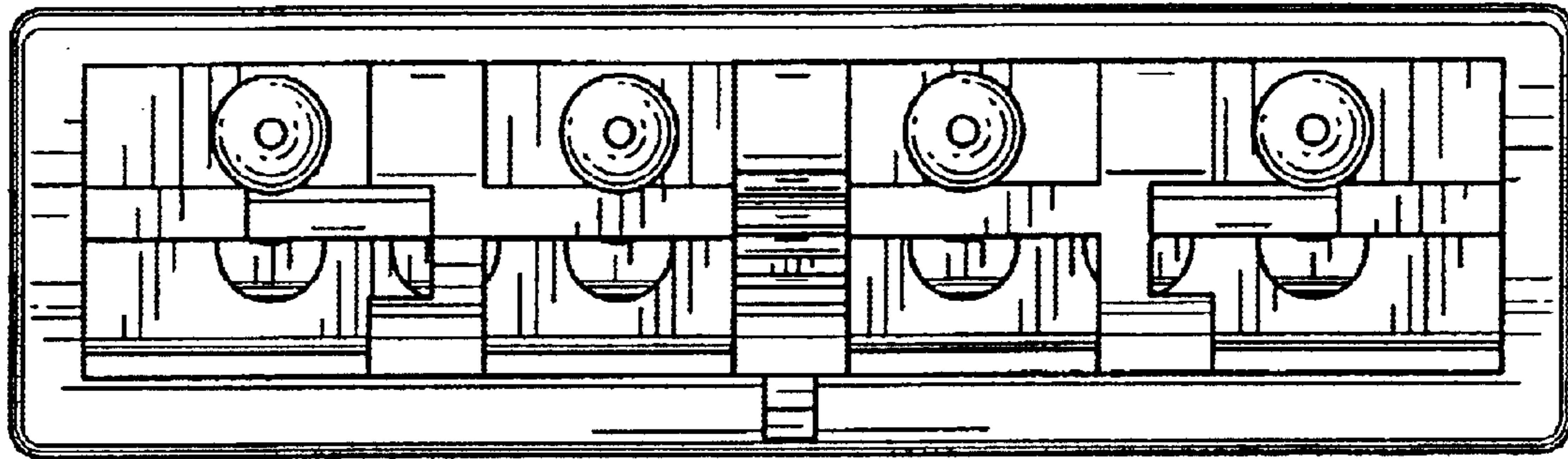

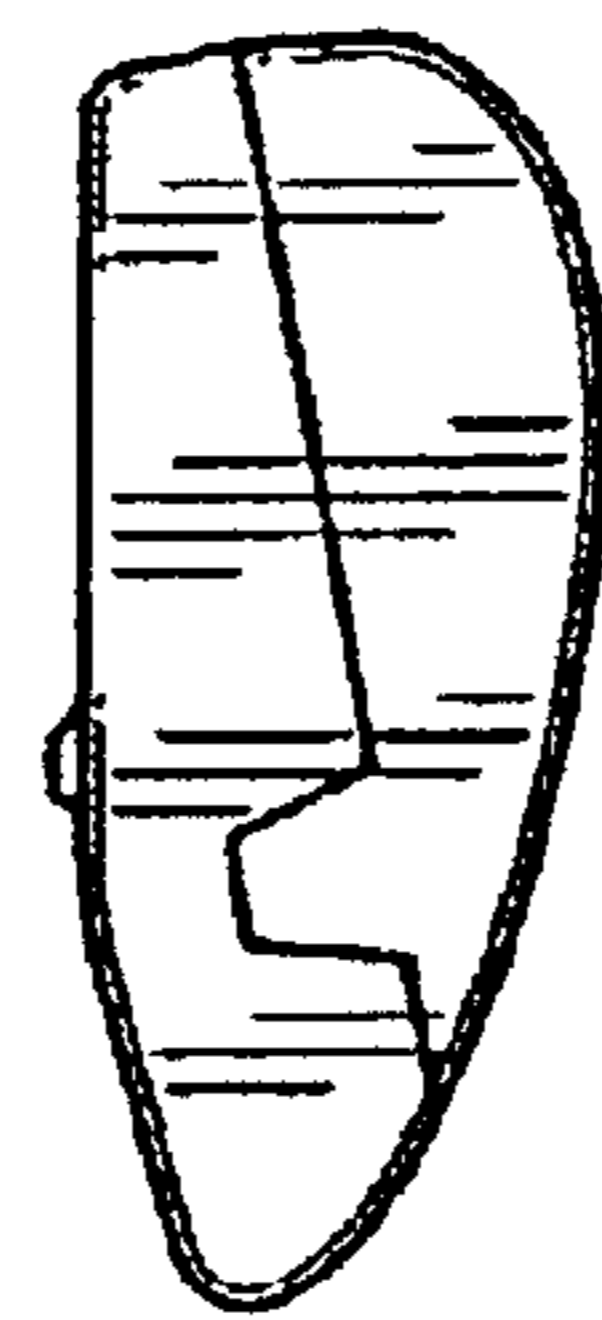

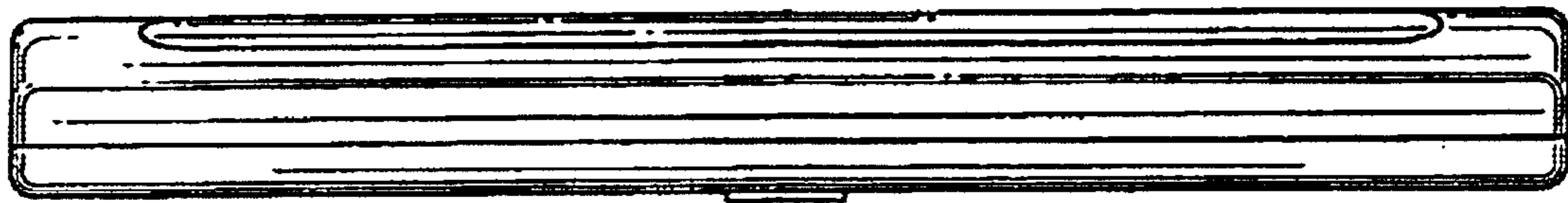

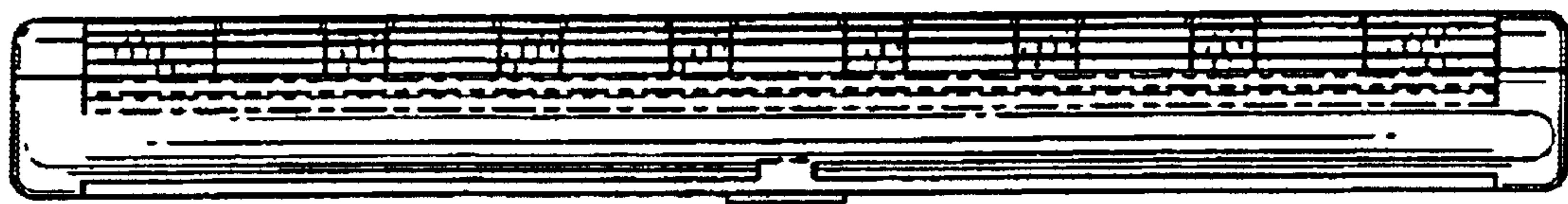
