(57) **CLAIM**

The ornamental design for a hair trimmer stand/storage case,
as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of one embodiment of a hair trimmer stand of the present invention, in a storage case configuration, with a cover over a base;

FIG. 2 is a front view of the hair trimmer stand of FIG. 1;
FIG. 3 is a right side view of the hair trimmer stand of FIG. 1;

FIG. 4 is a left side view of the hair trimmer stand of FIG. 1;

FIG. 5 is a rear view of the hair trimmer stand of FIG. 1;

FIG. 6 is a top view of the hair trimmer stand of FIG. 1;

FIG. 7 is a bottom view of the hair trimmer stand of FIG. 1;
FIG. 8 is a perspective view of the hair trimmer stand of FIG. 1 in a hair trimmer stand configuration, with the cover beneath the base;

FIG. 9 is a front view of the hair trimmer stand of FIG. 8;
FIG. 10 is a right side view of the hair trimmer stand of FIG. 8;

FIG. 11 is a left side view of the hair trimmer stand of FIG. 8;

FIG. 12 is a rear view of the hair trimmer stand of FIG. 8;
FIG. 13 is a top view of the hair trimmer stand of FIG. 8; and

FIG. 14 is a bottom view of the hair trimmer stand of FIG. 8.

FIG. 15 is a perspective view of another embodiment of a hair trimmer stand of the present invention, in a storage case configuration, with a cover over a base;

FIG. 18 is a left side view of the hair trimmer stand of FIG. 15;

FIG. 21 is a bottom view of the hair trimmer stand of FIG. 15;

FIG. 22 is a perspective view of the hair trimmer stand of FIG. 15 in a hair trimmer stand configuration, with the cover beneath the base;

FIG. 24 is a right side view of the hair trimmer stand of FIG. 22;

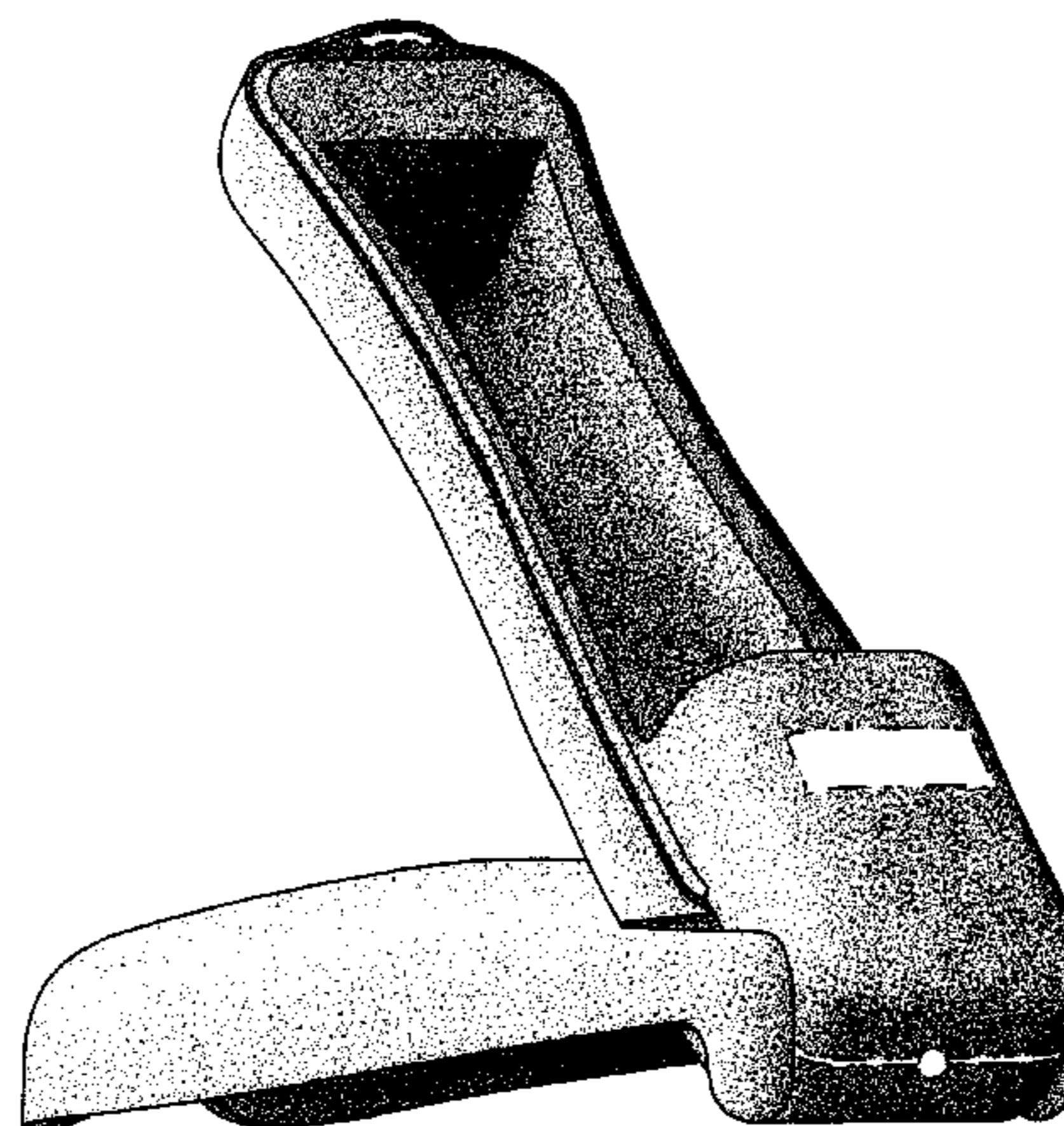
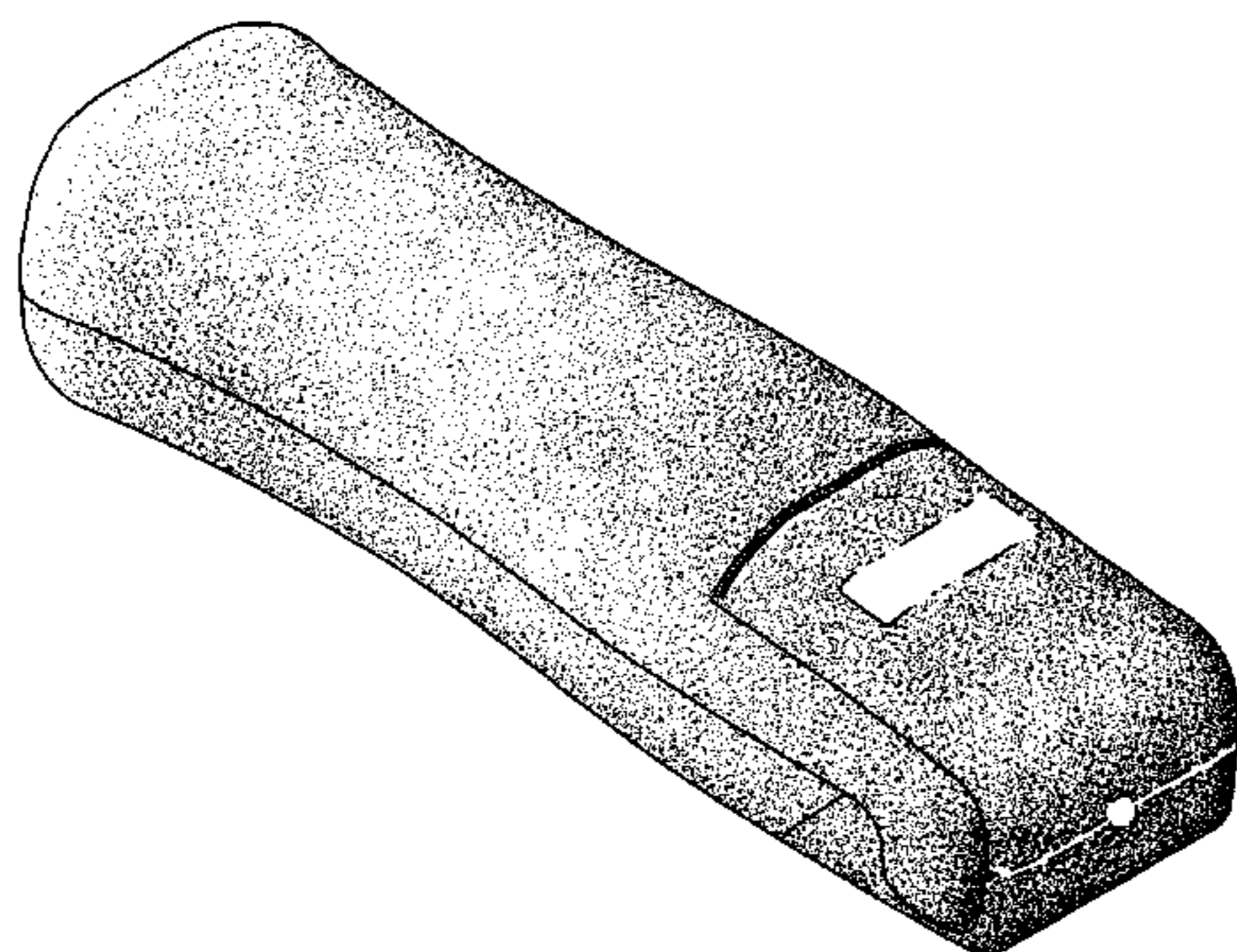
FIG. 25 is a left side view of the hair trimmer stand of FIG. 22;

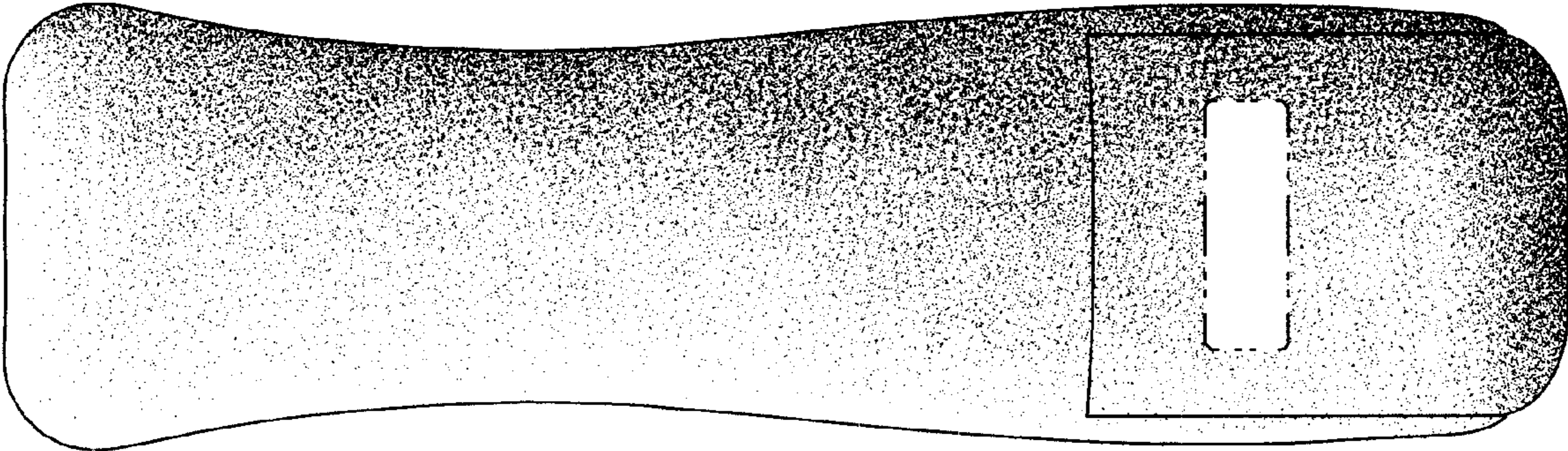

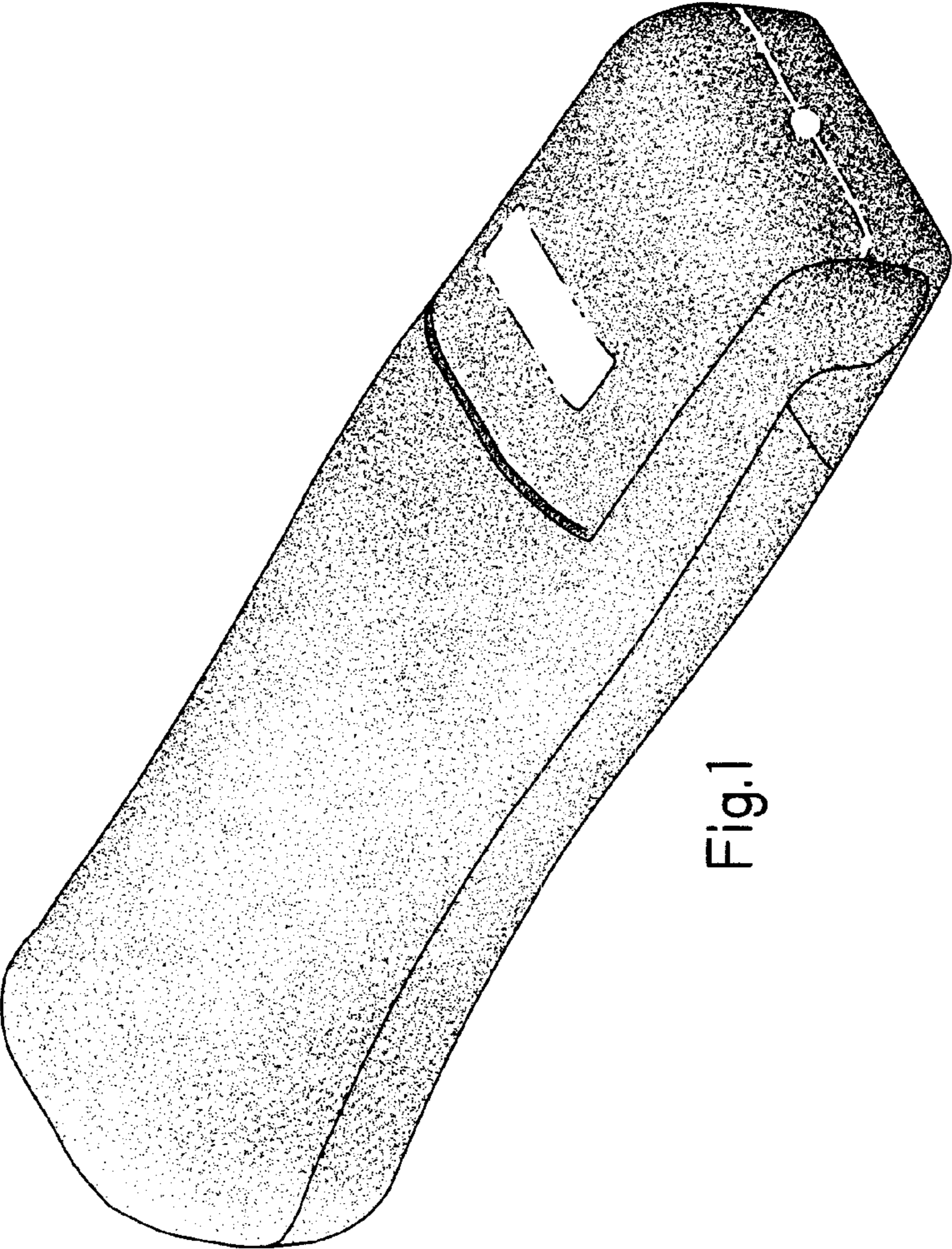

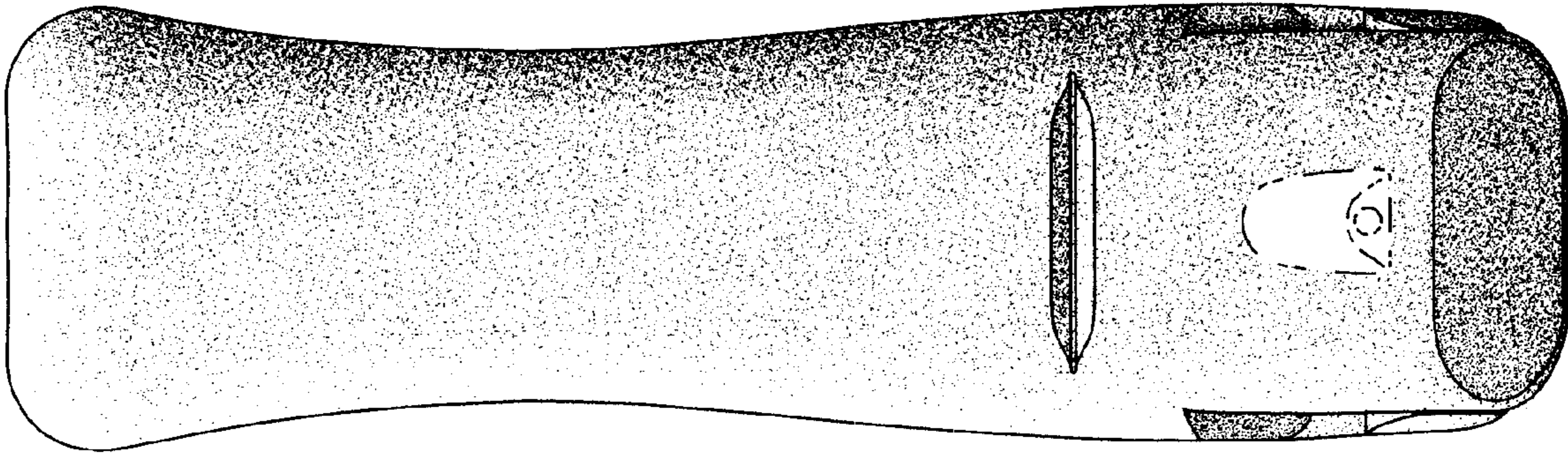

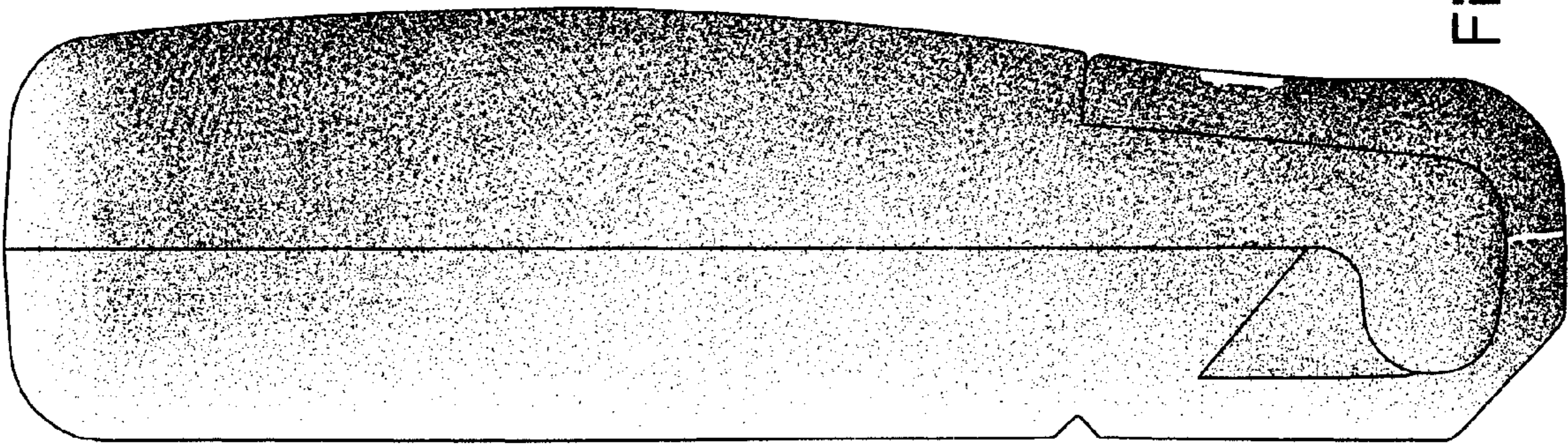

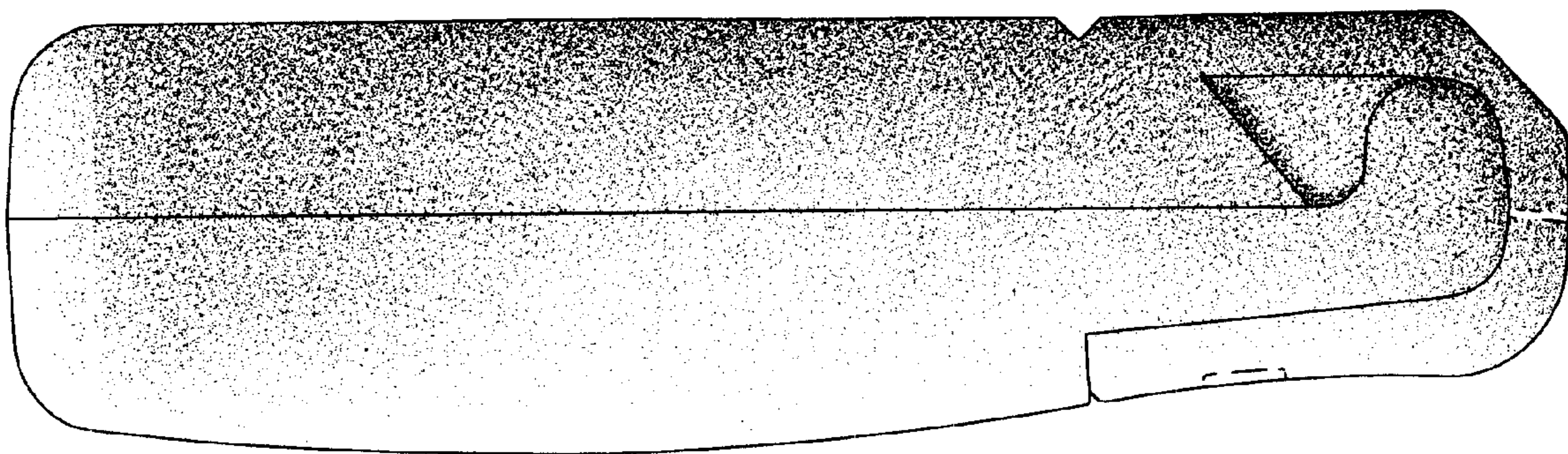

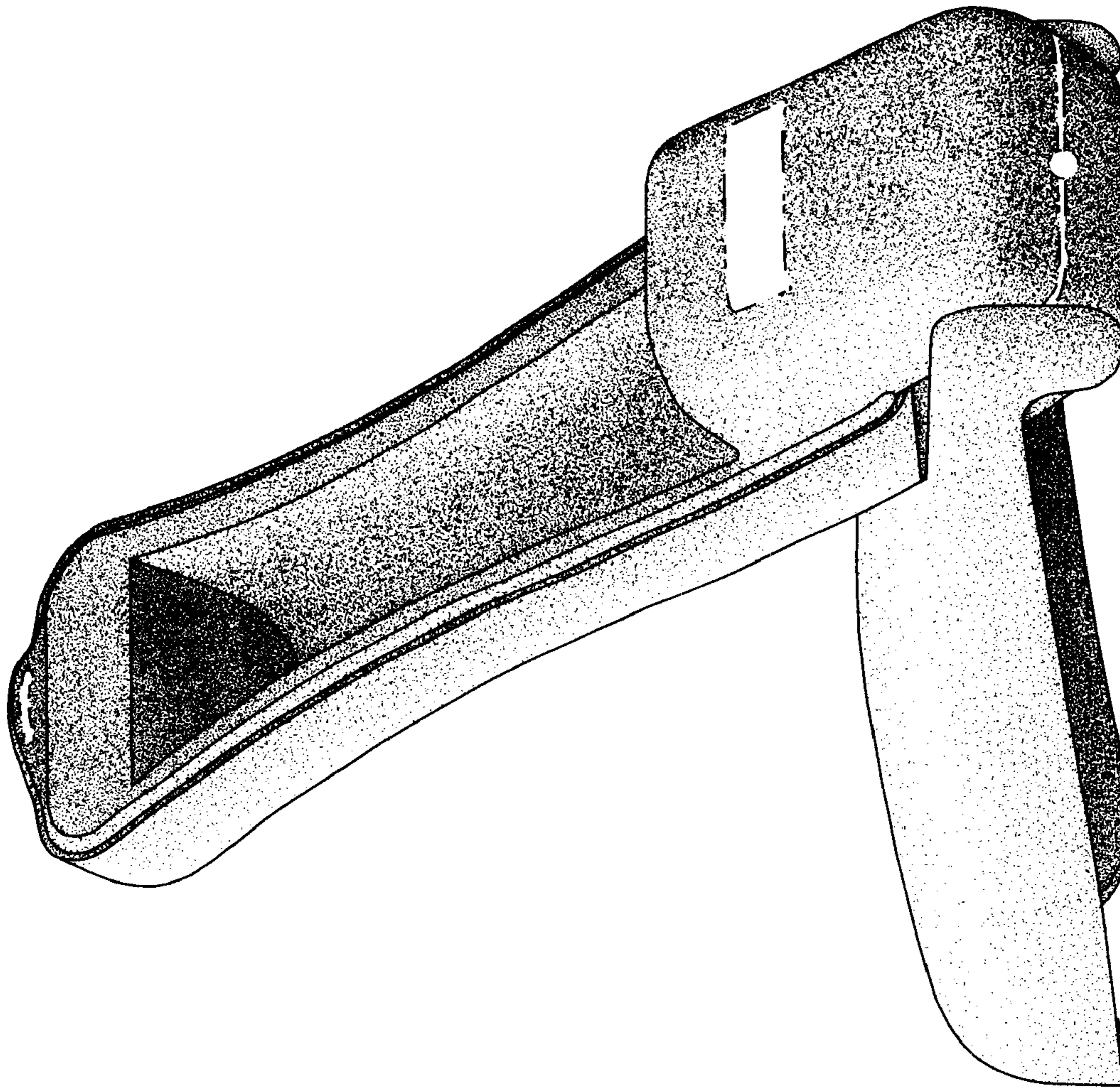

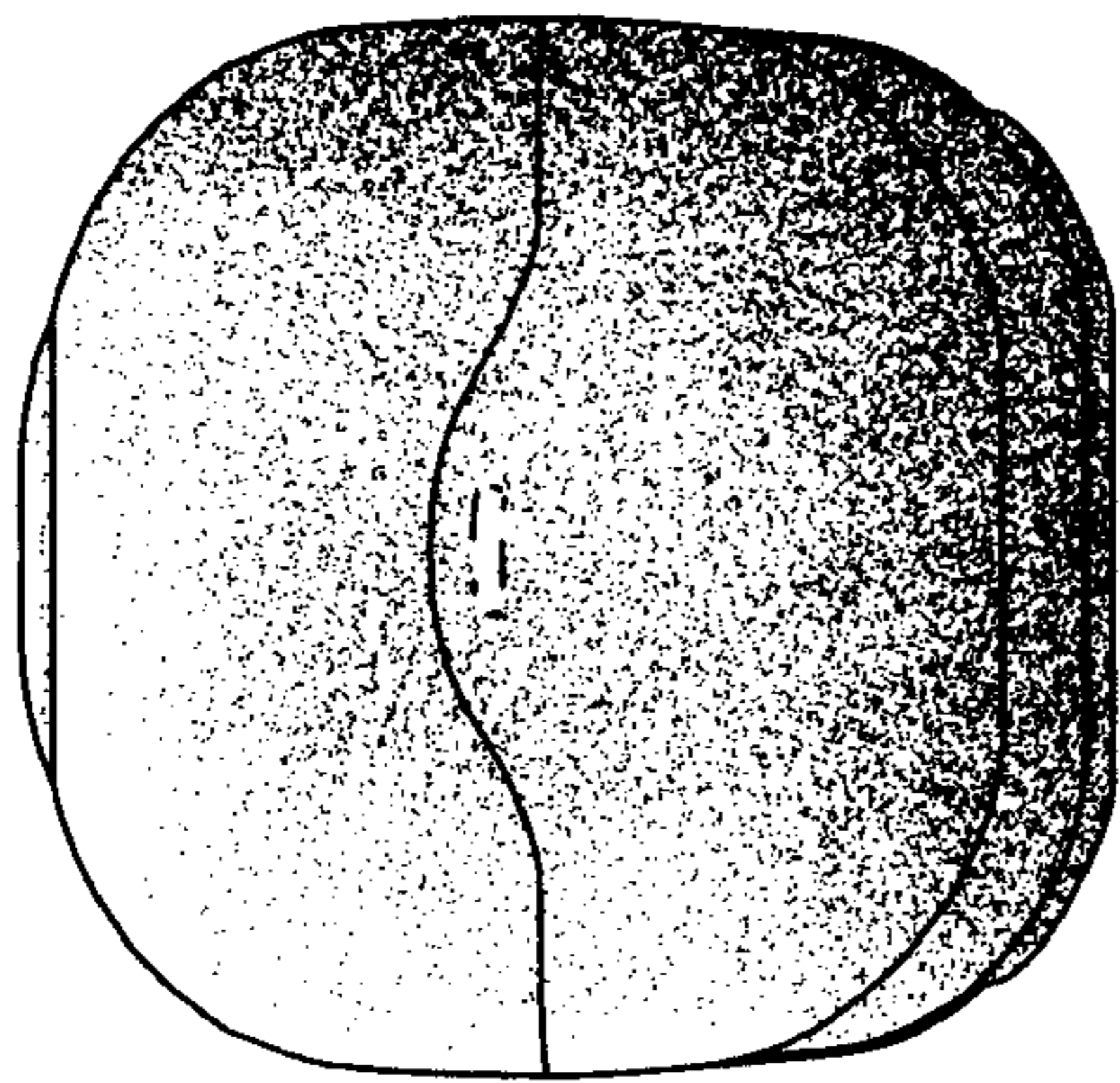

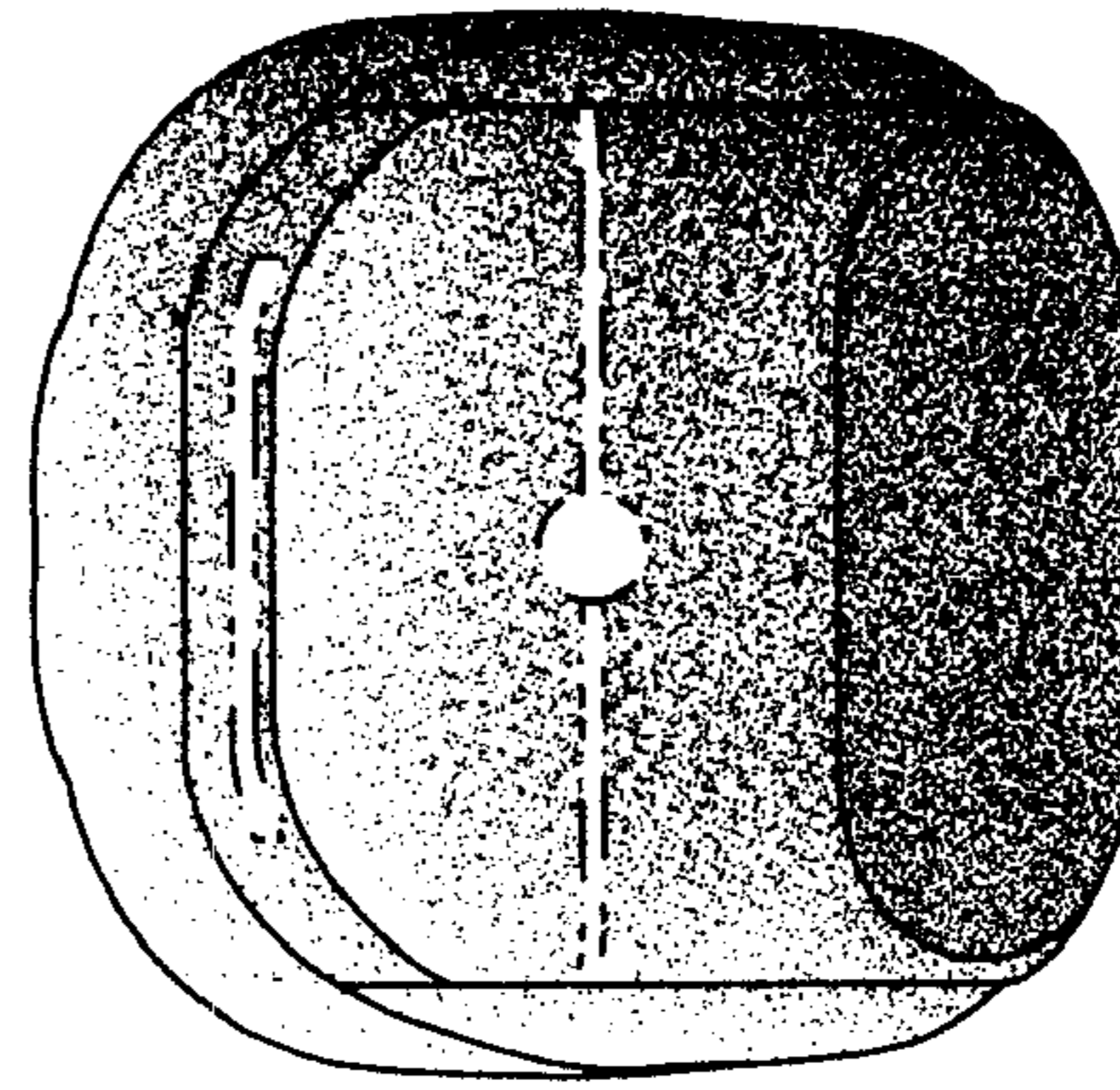

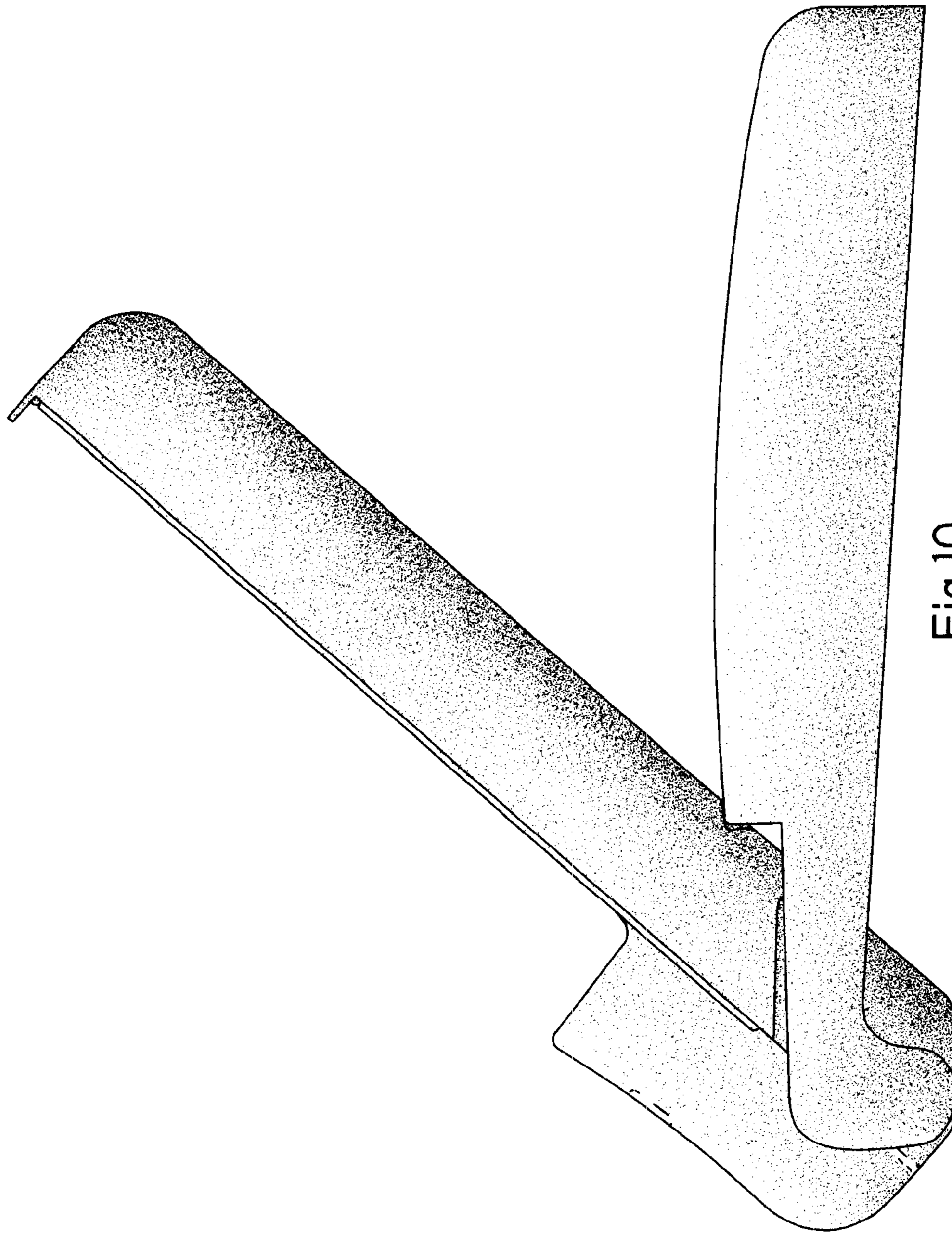

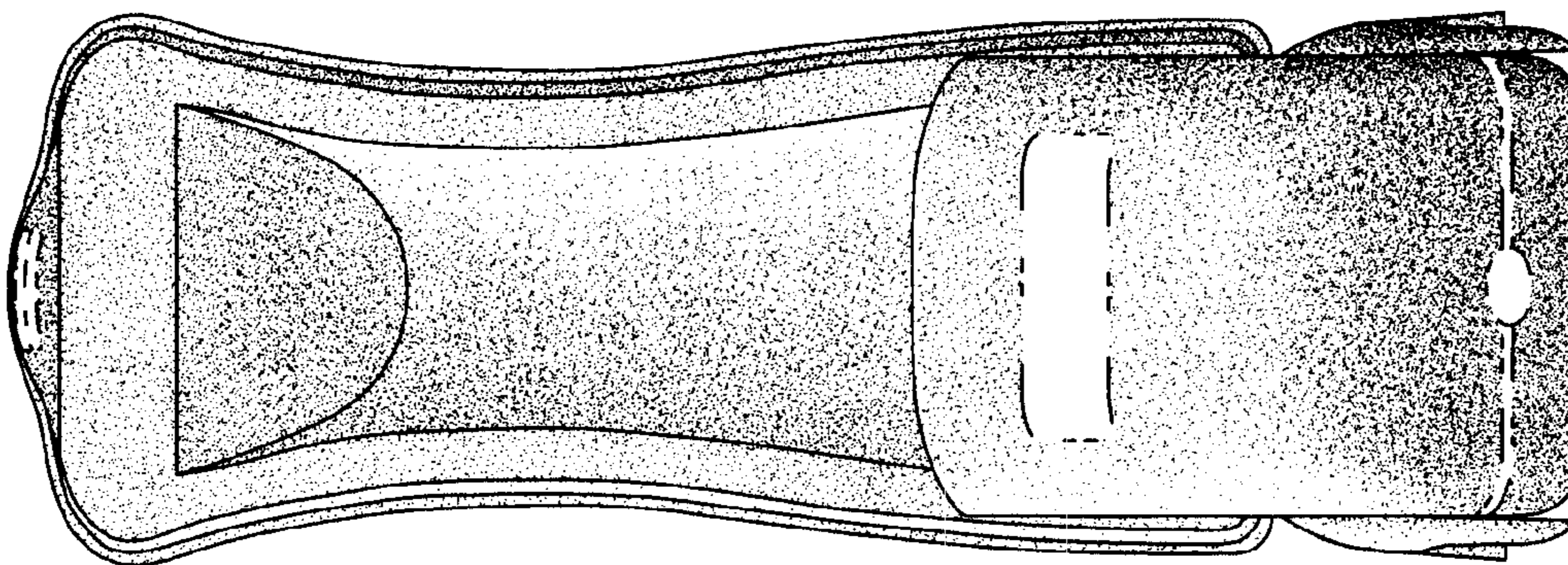

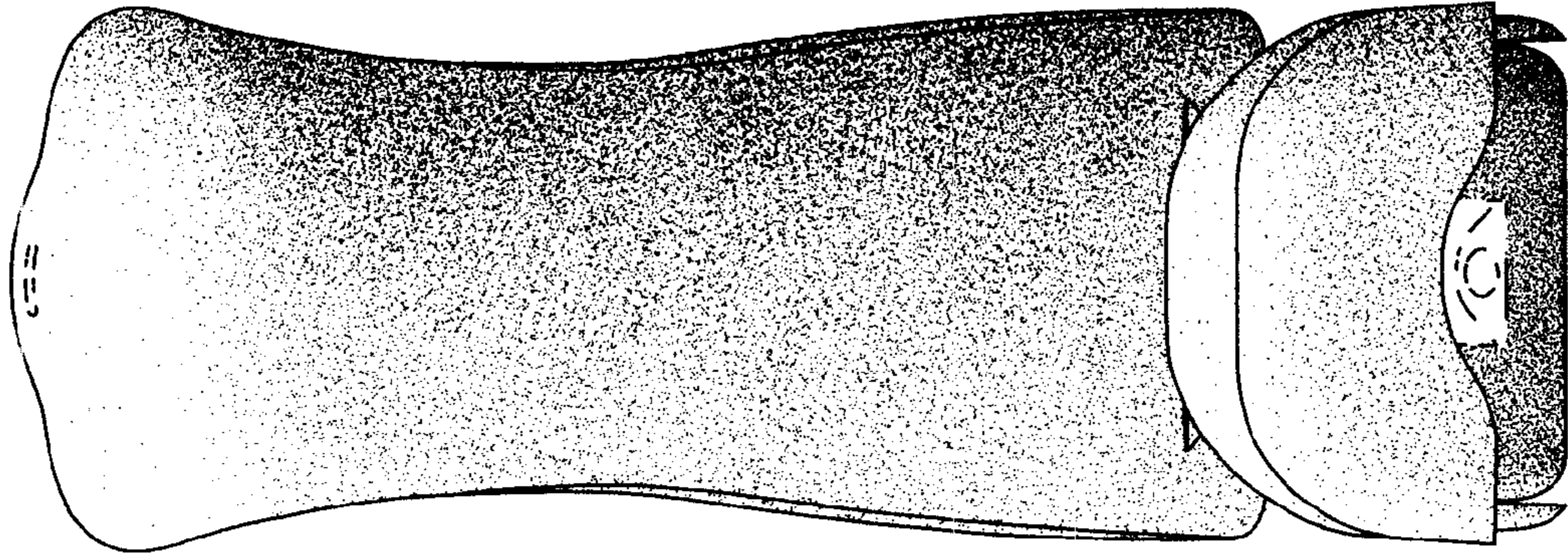

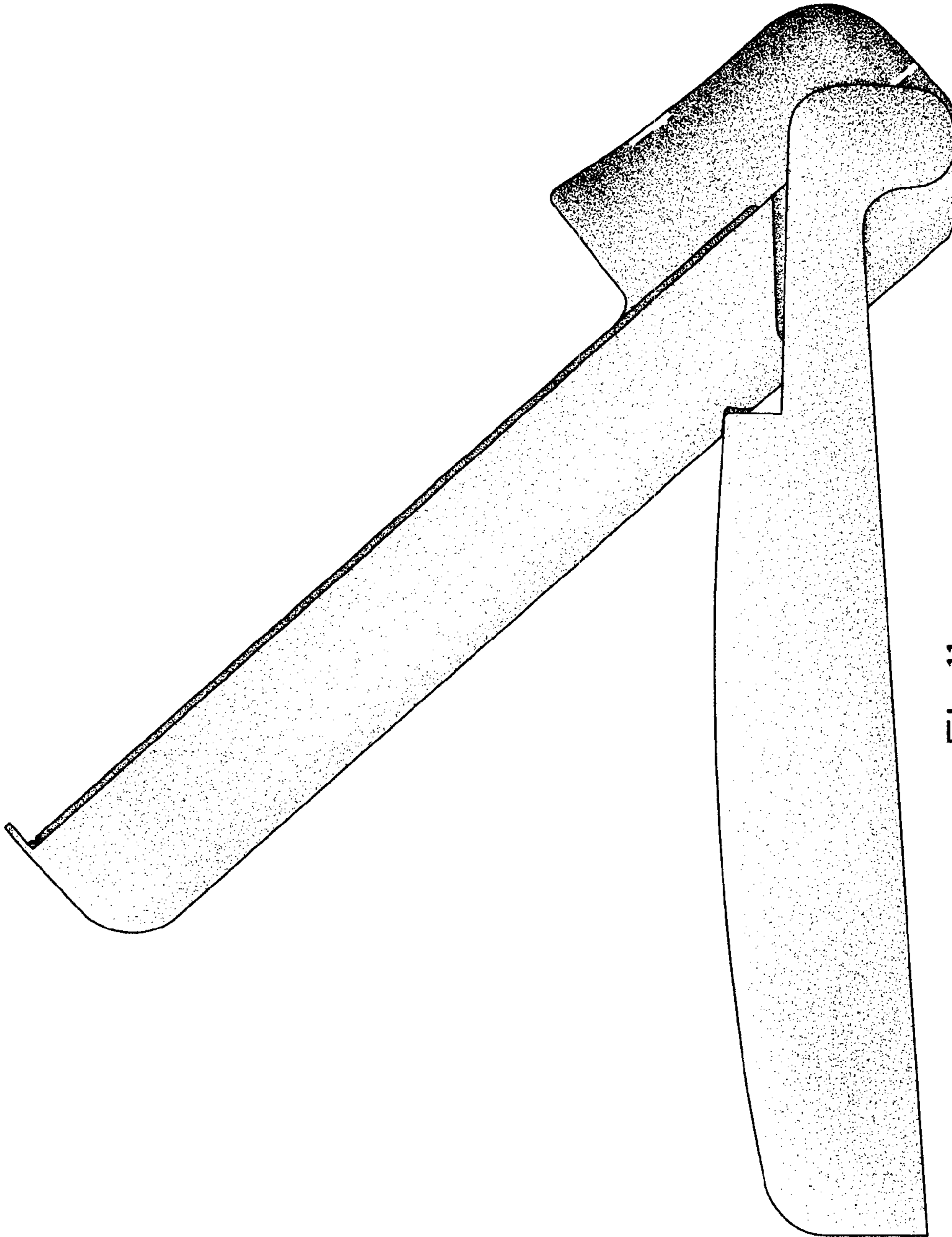

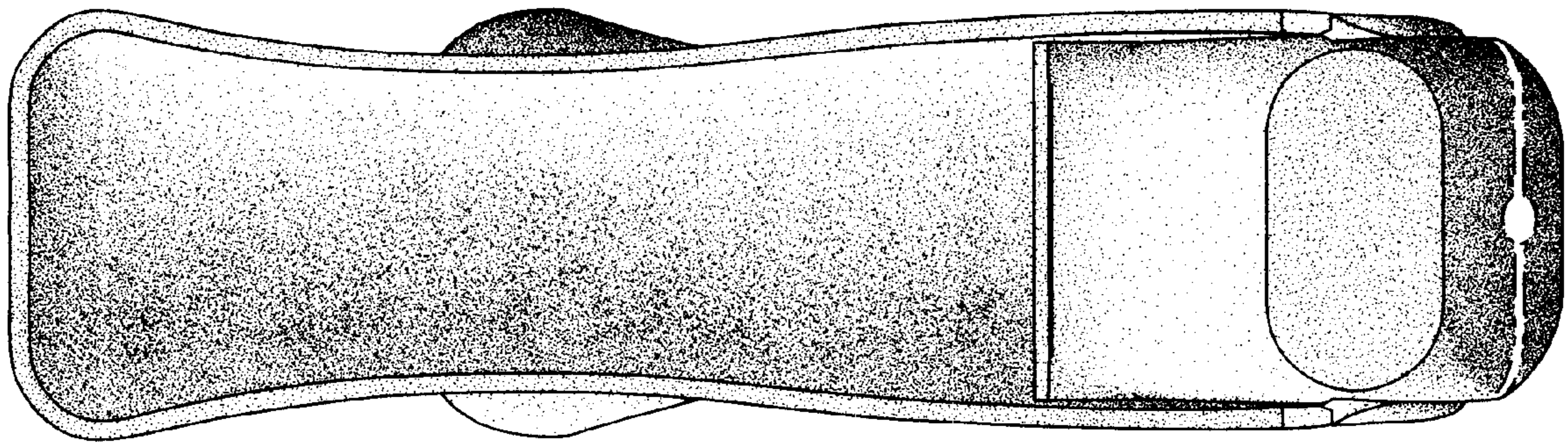

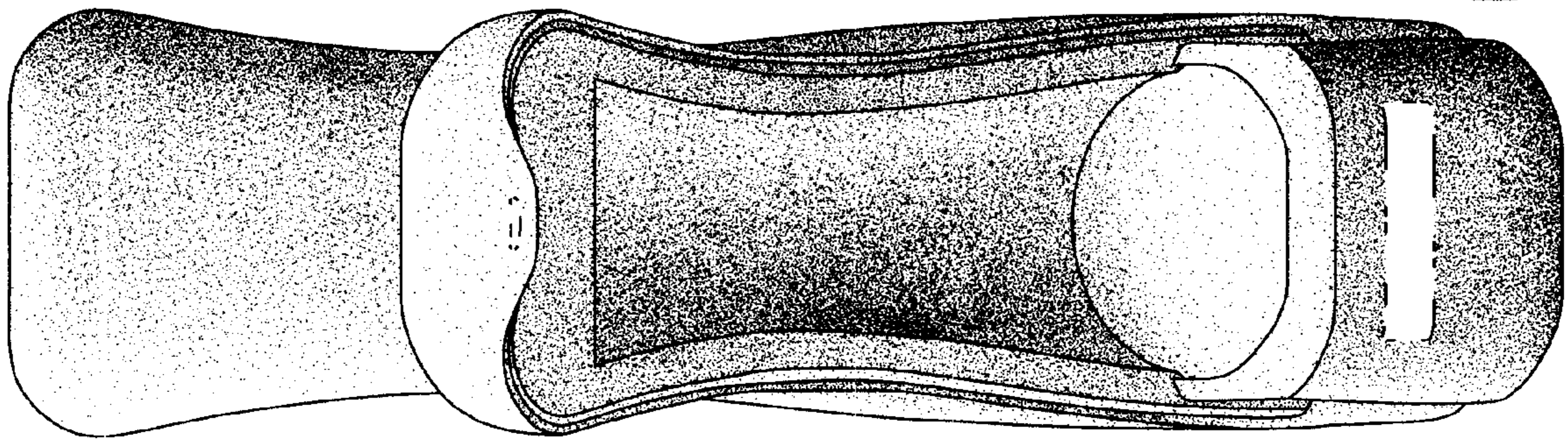

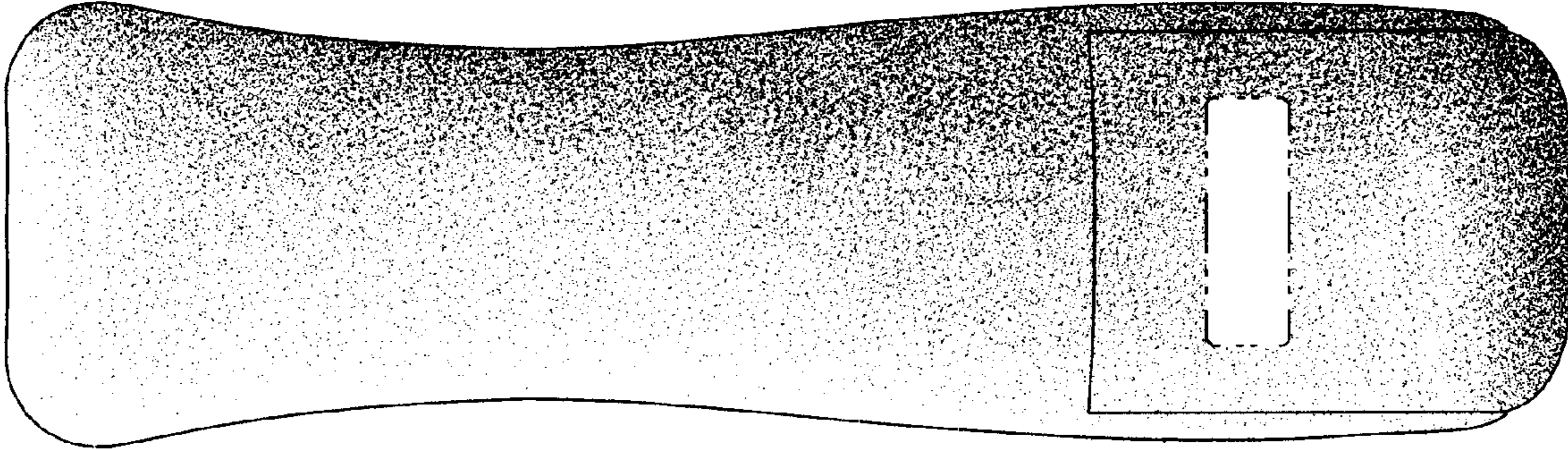

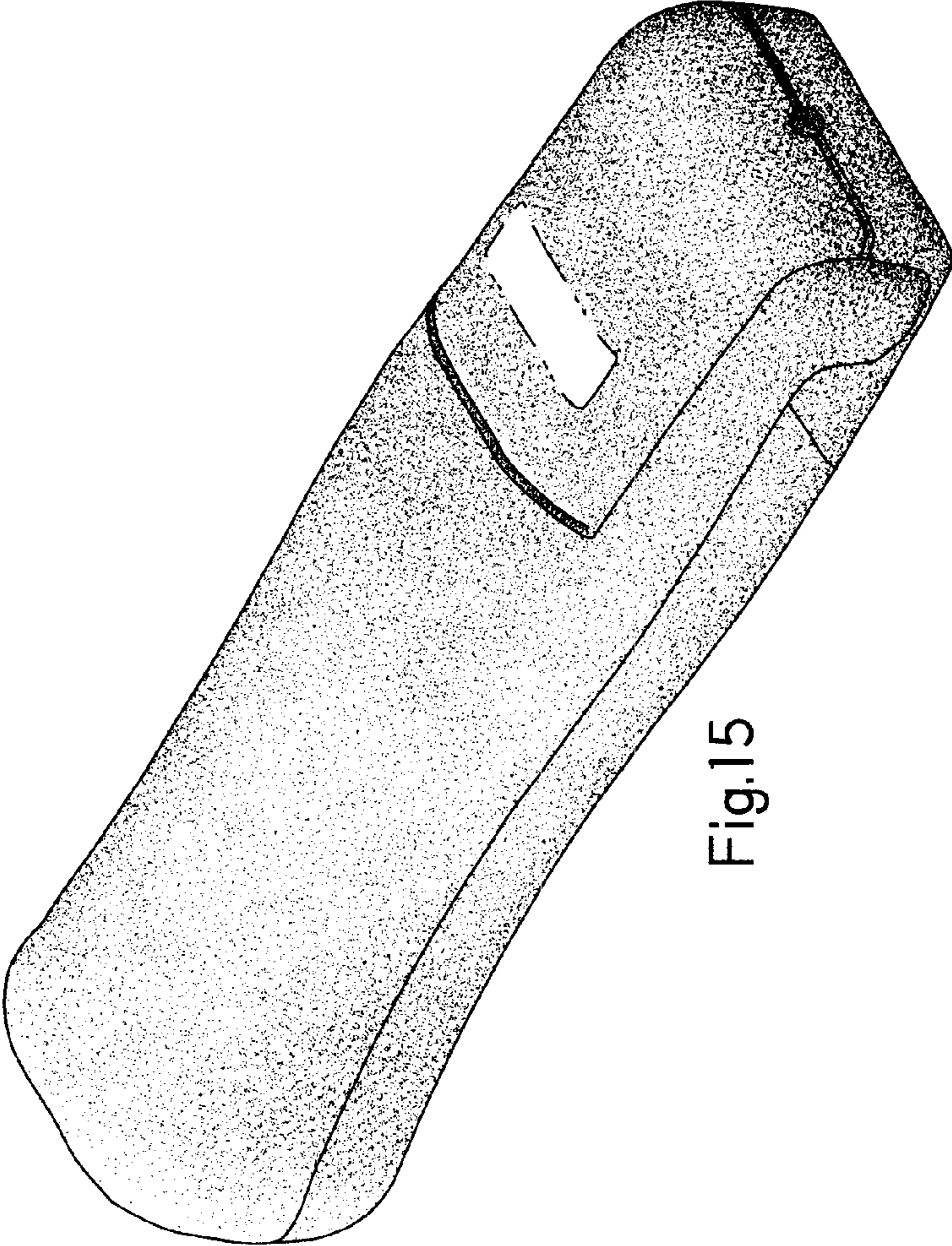

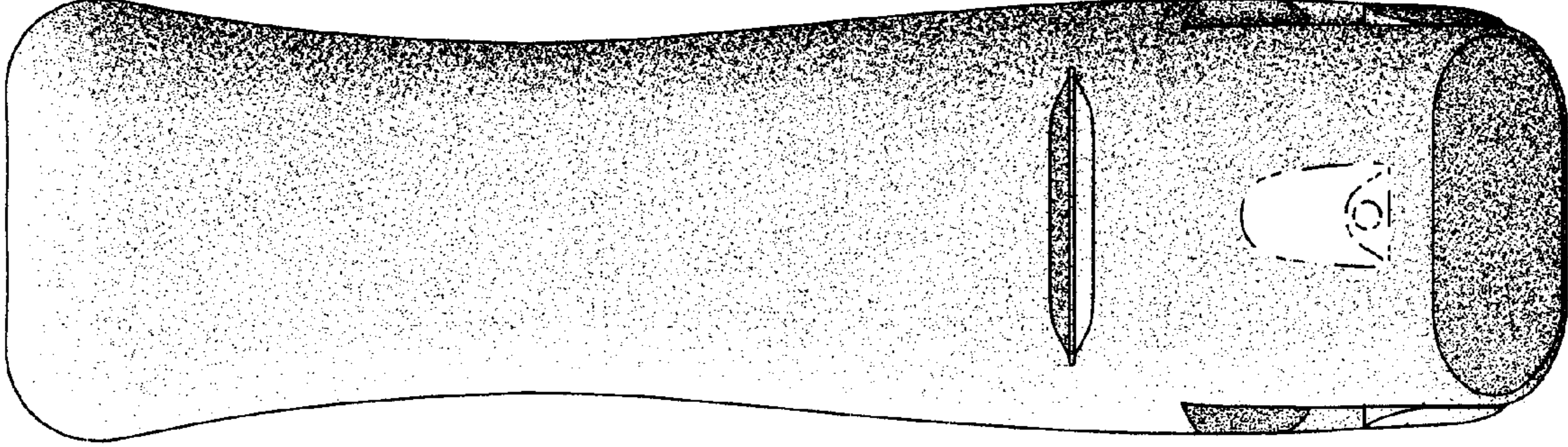

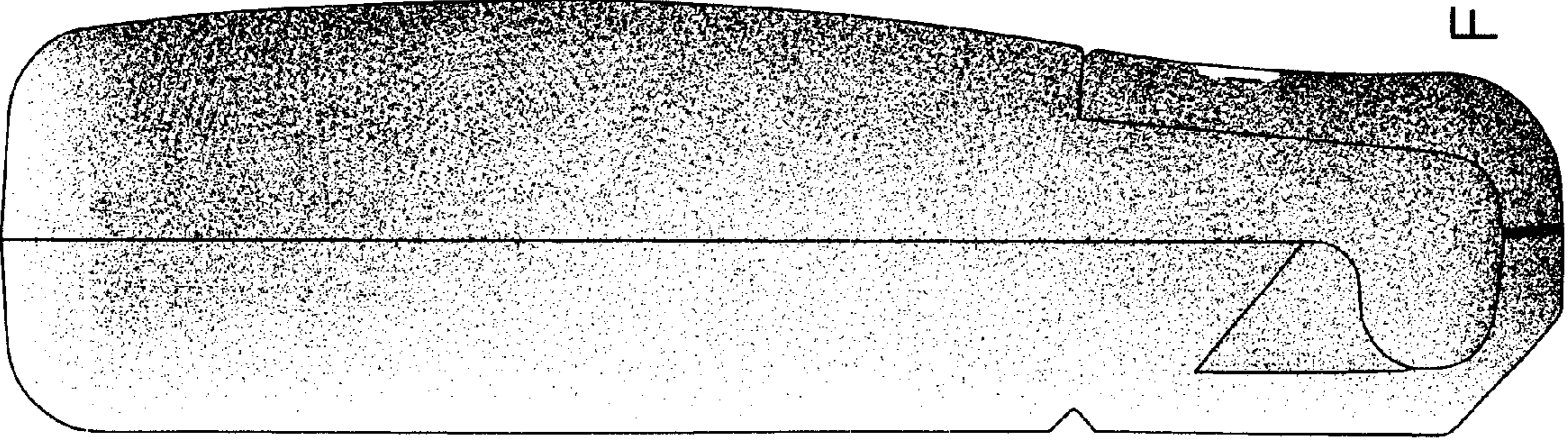

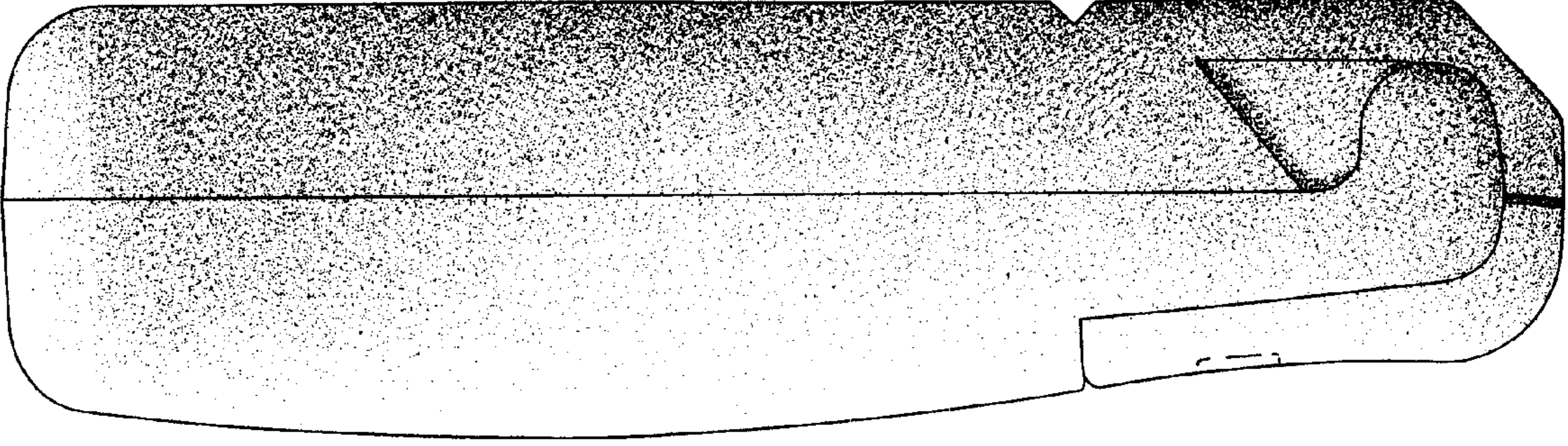

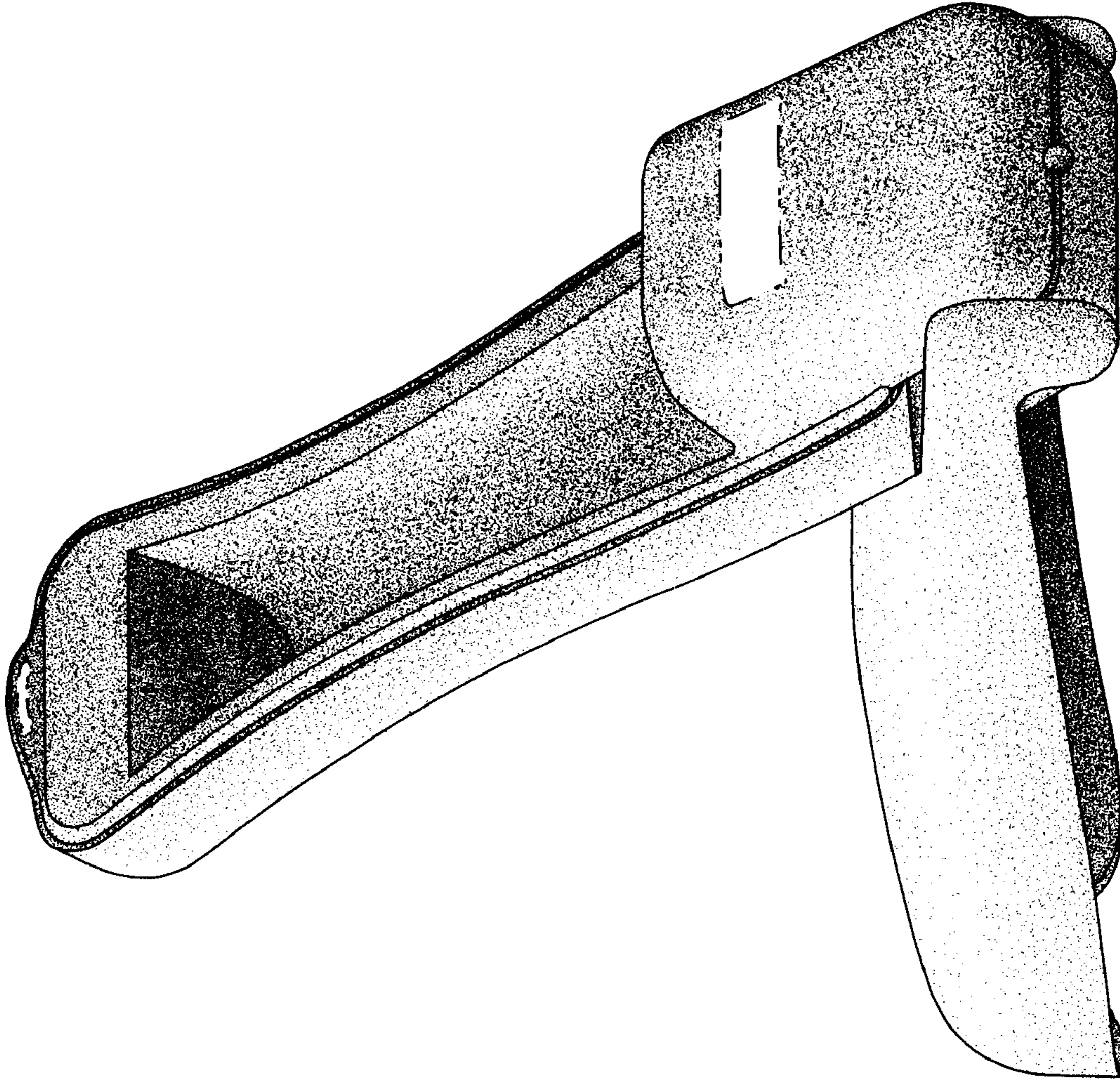

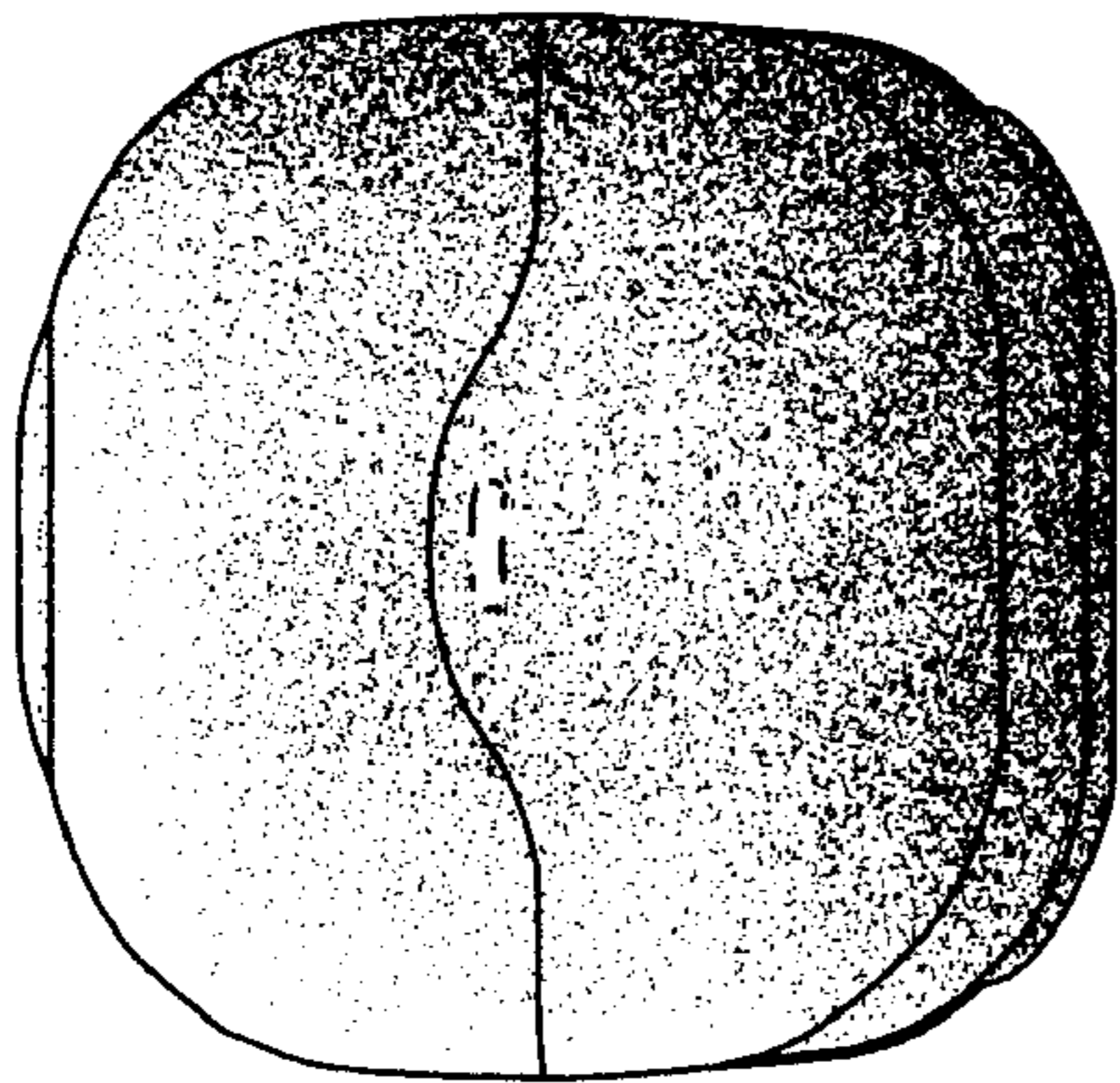

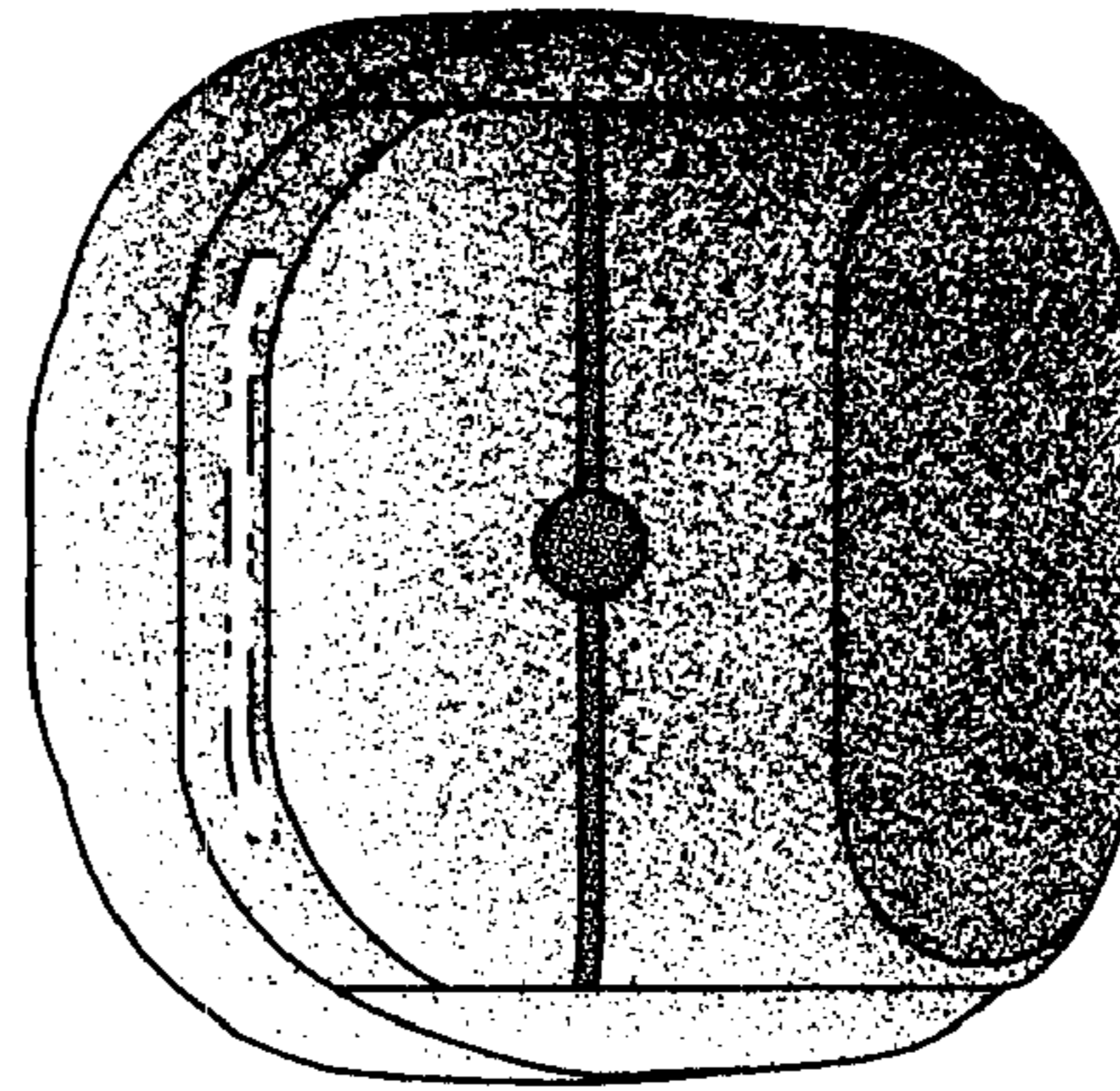

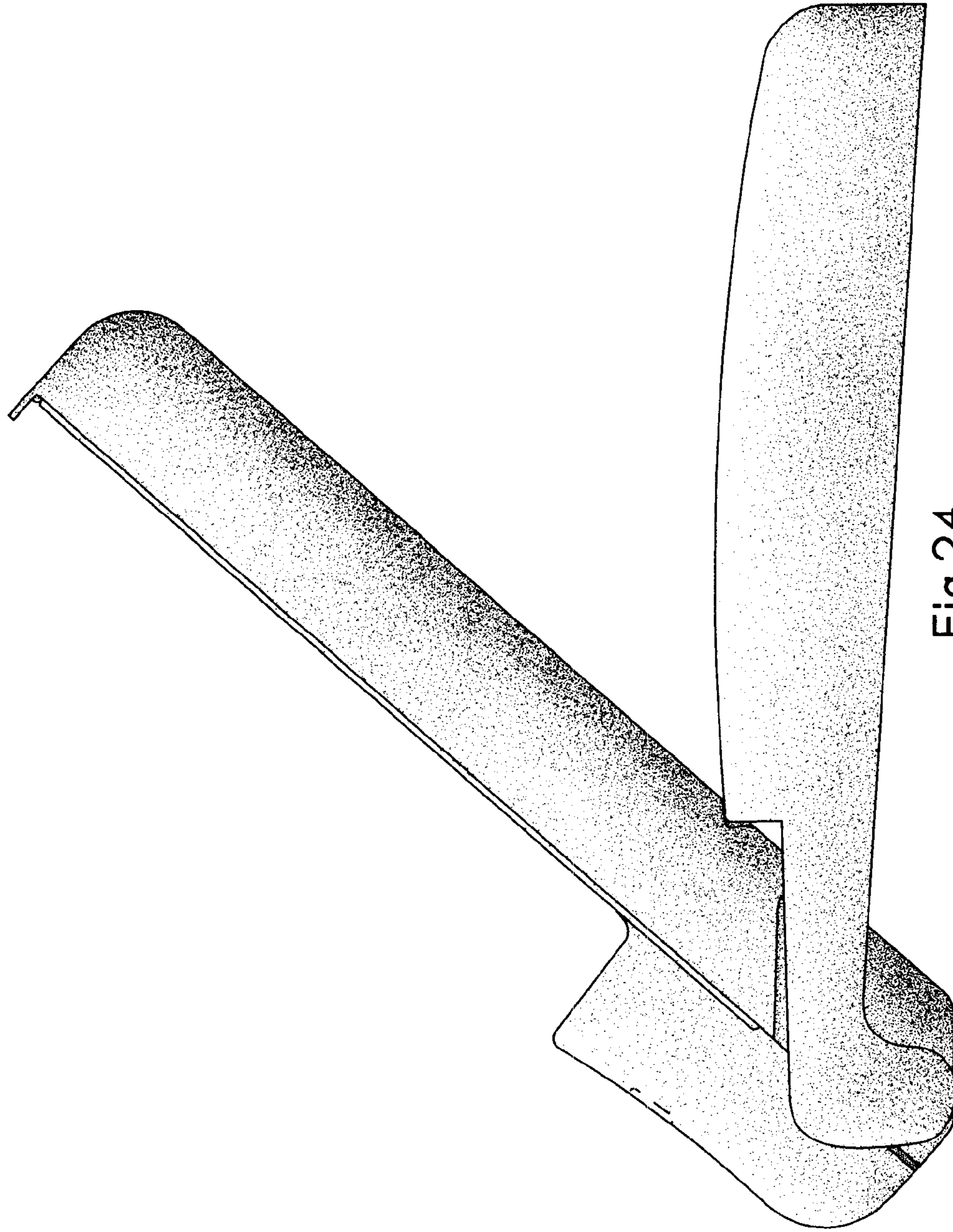

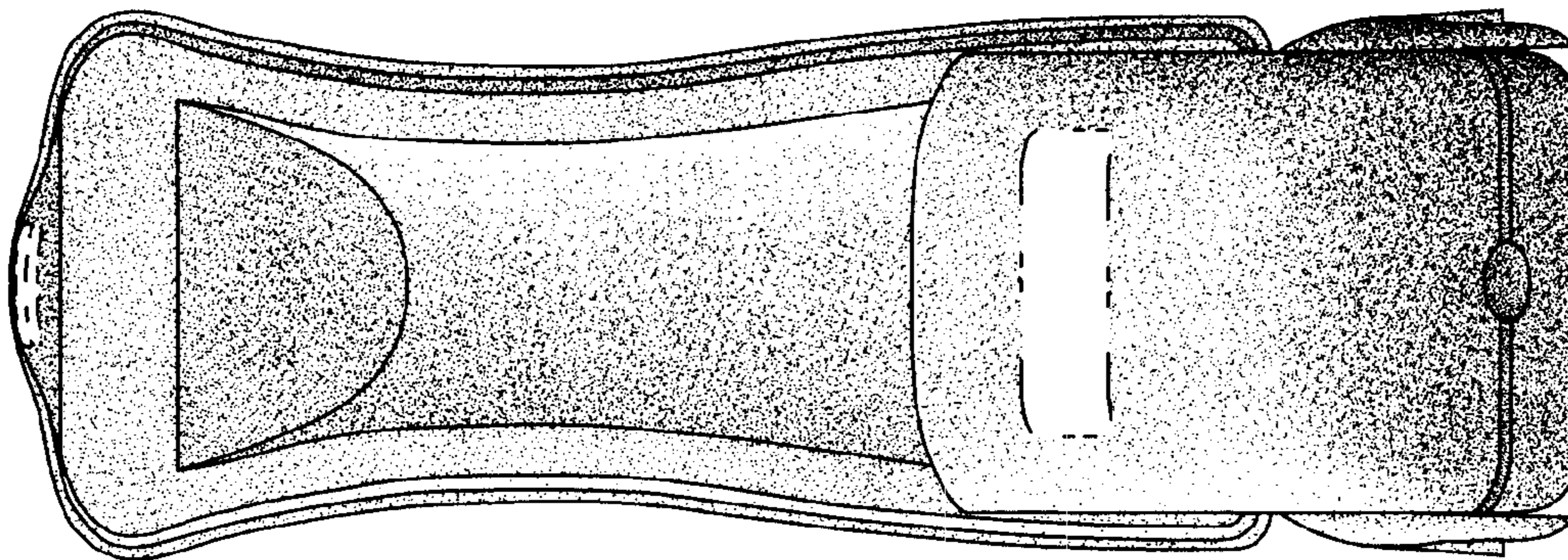

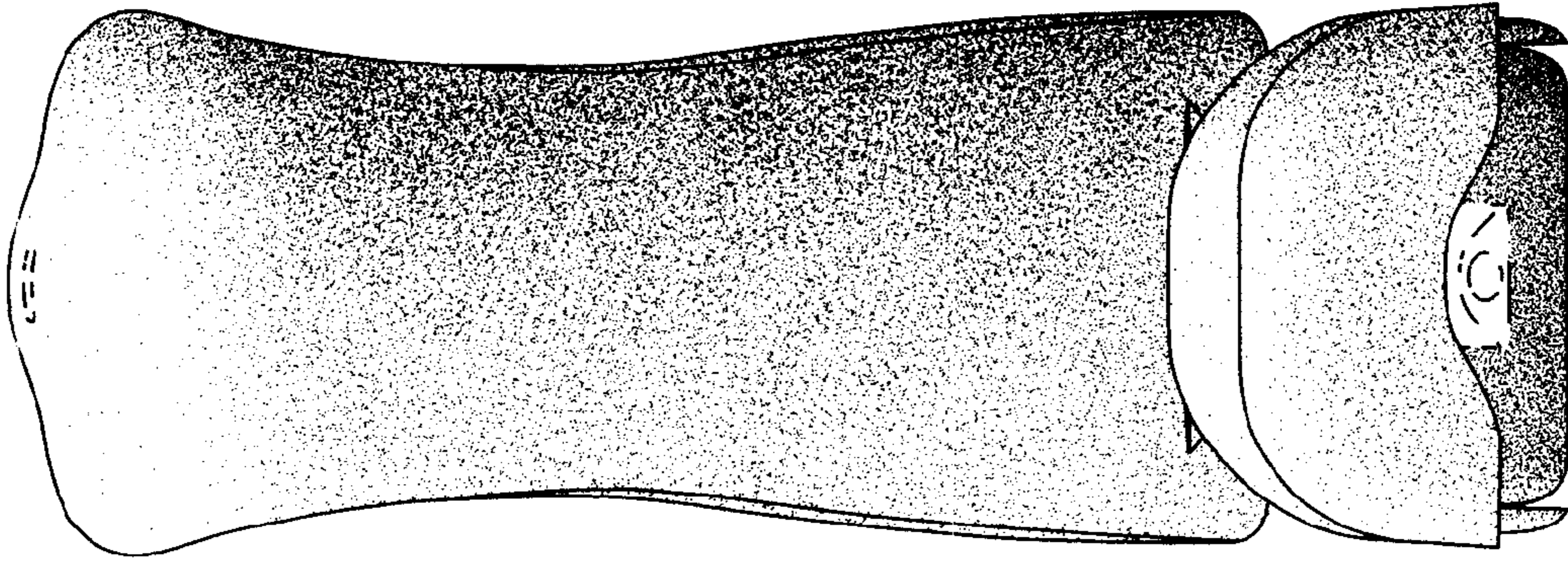

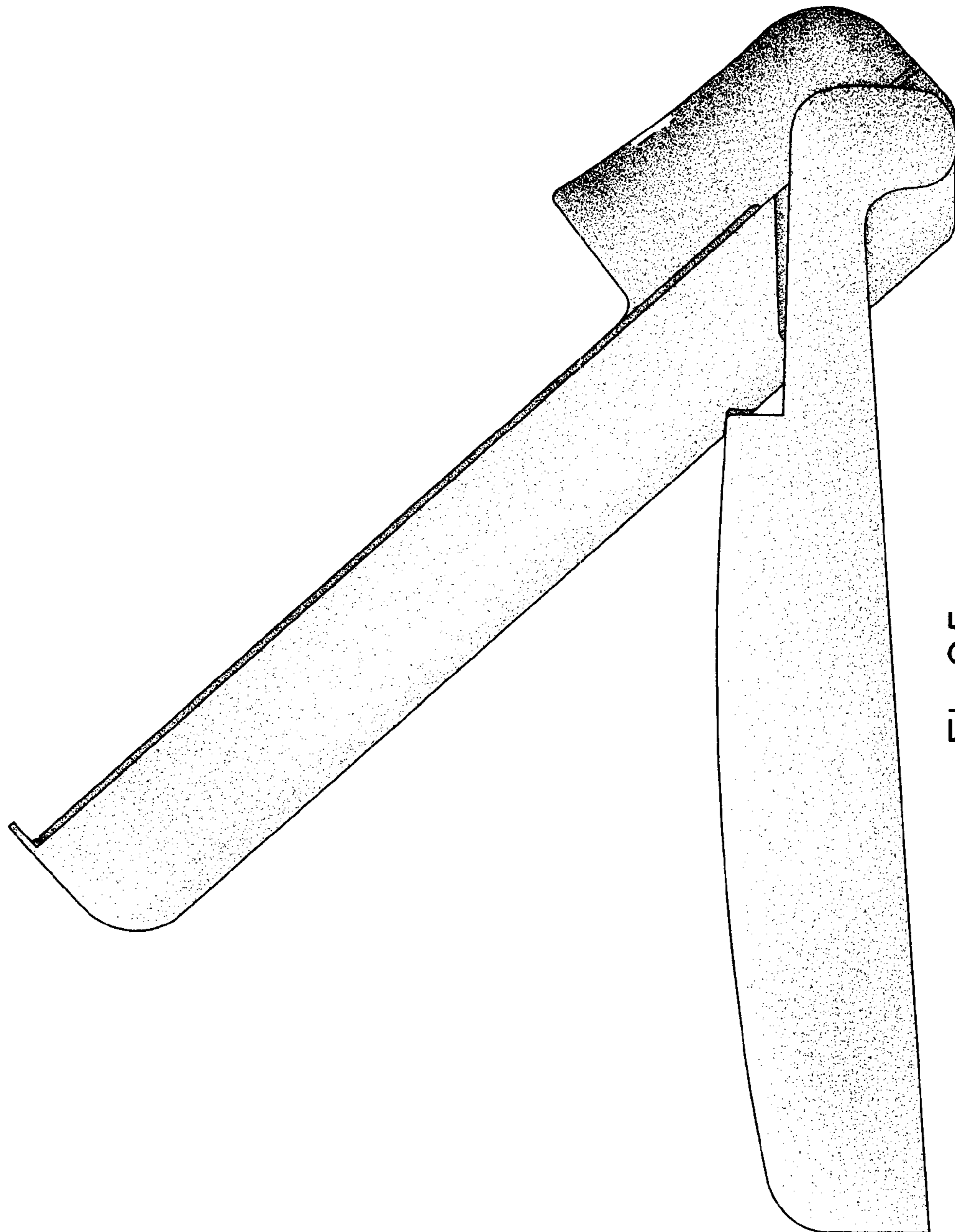

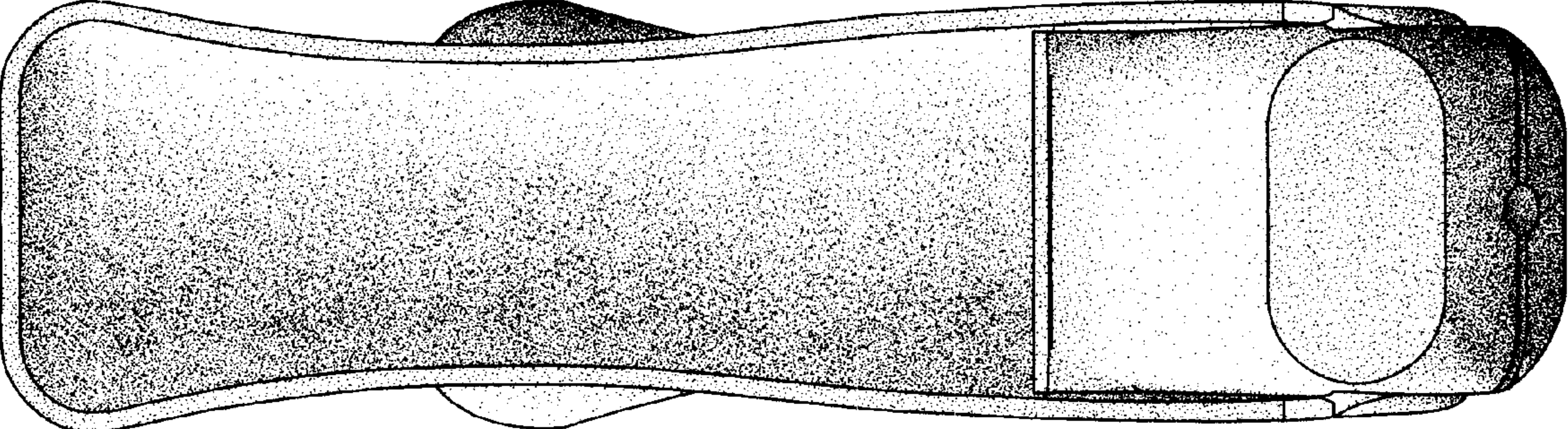

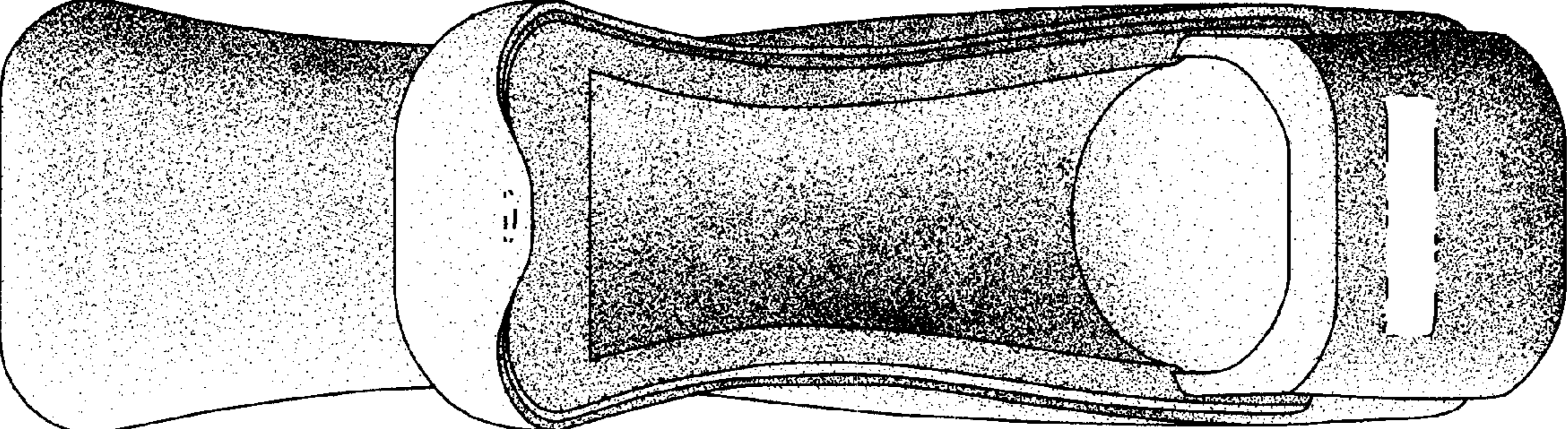
