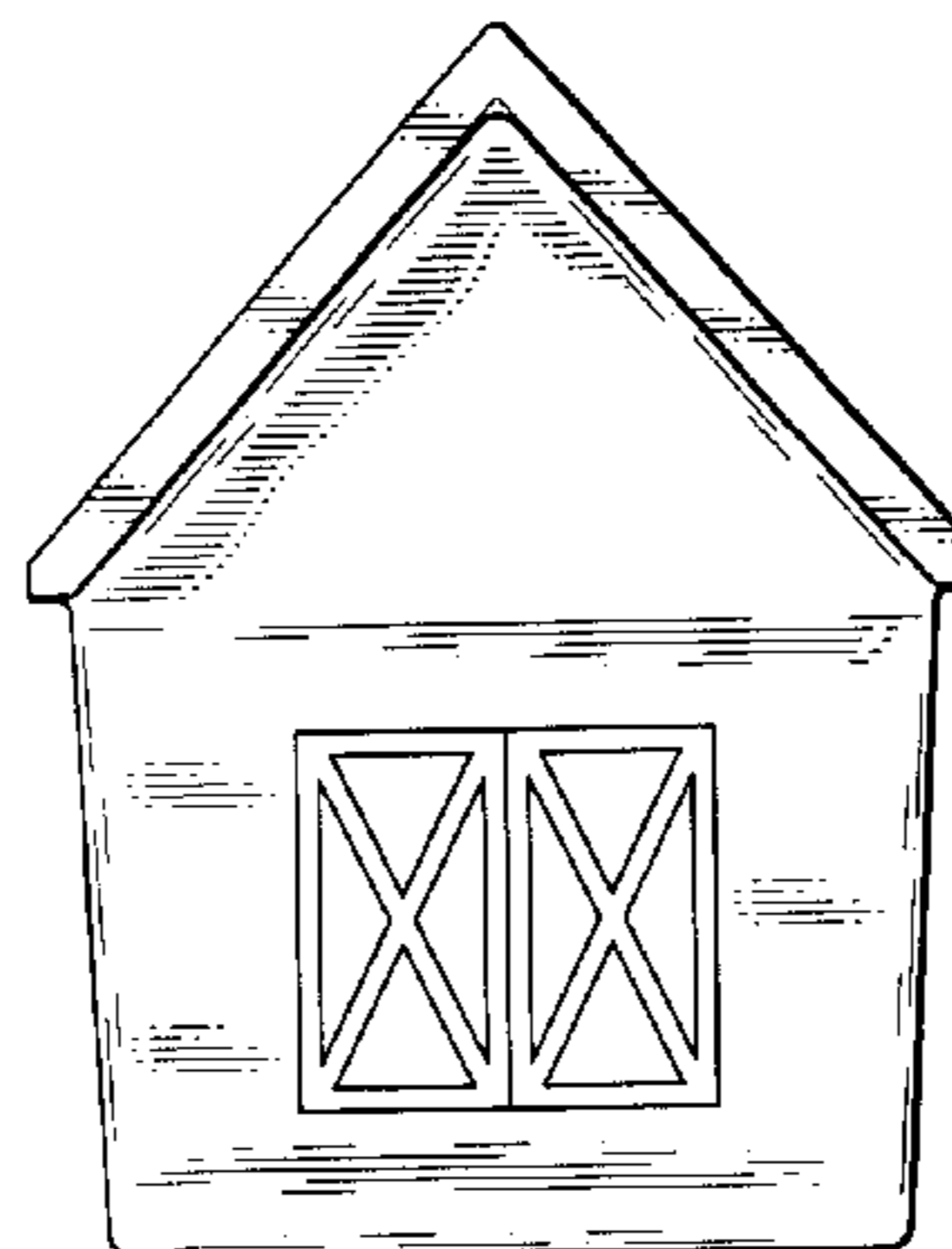
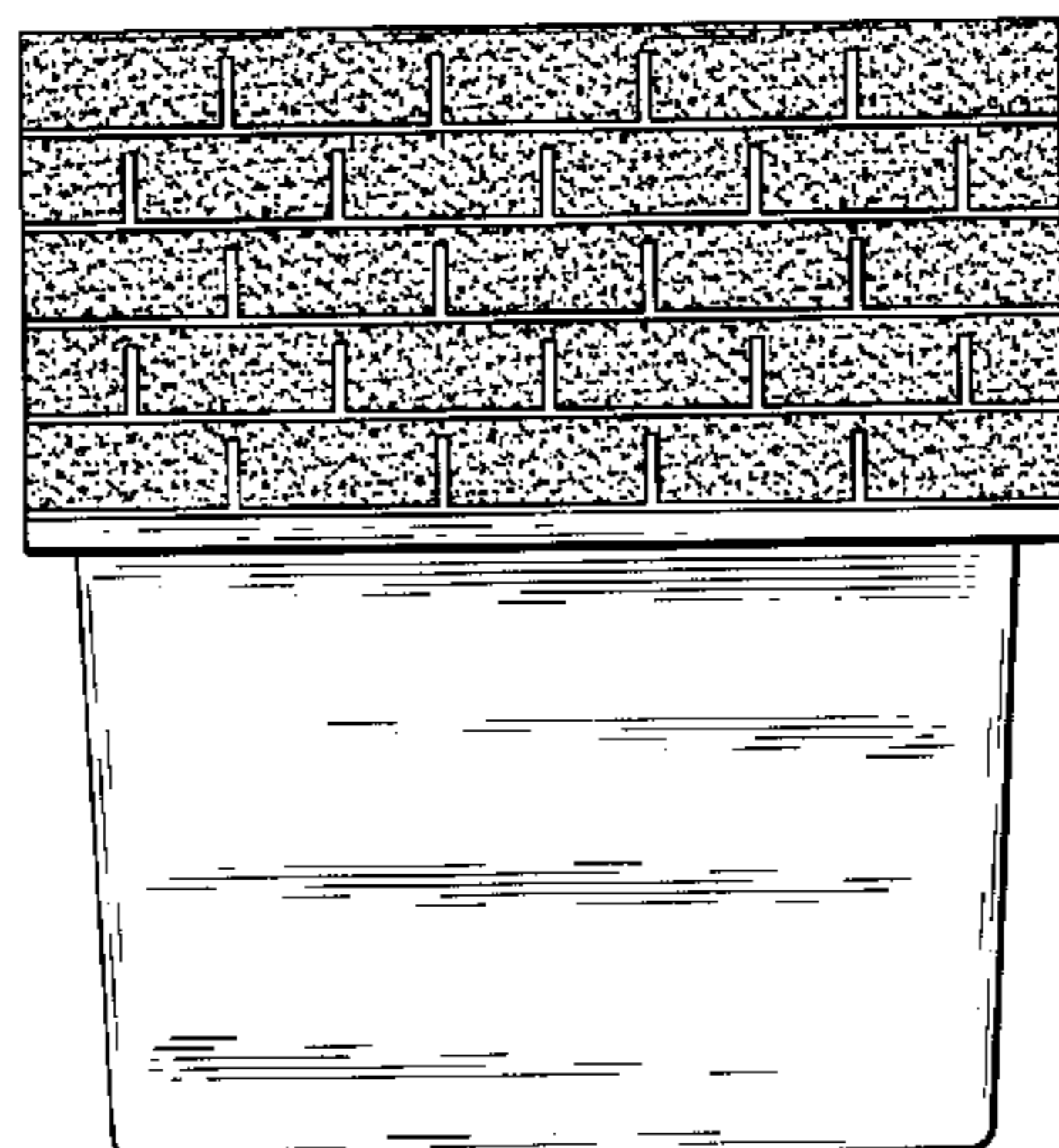
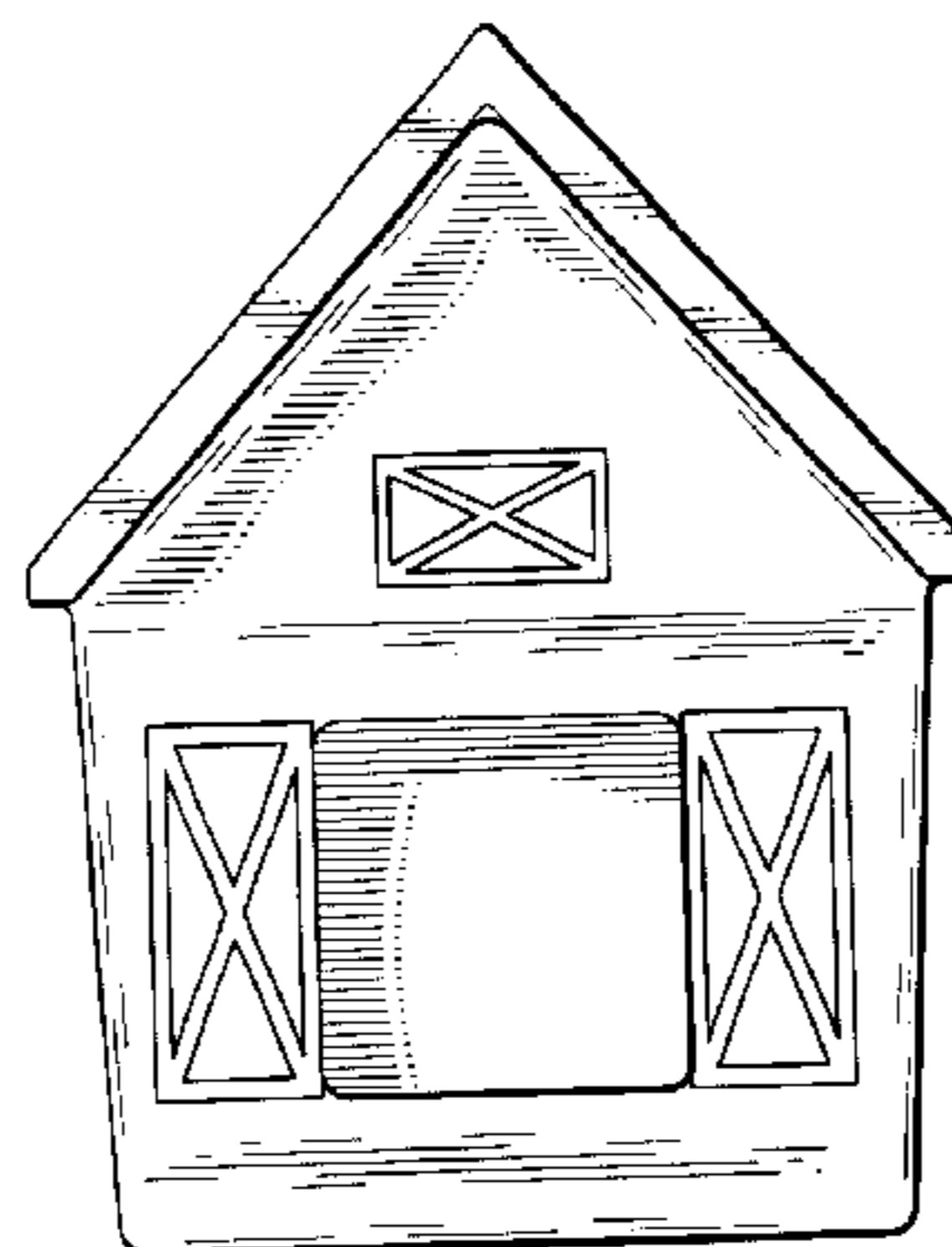
(57) **CLAIM**

The ornamental design for a farm shaped litter box with
removable peak roof, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a farm shaped litter box with
removable peak roof;
FIG. 2 is a top plan view thereof;
FIG. 3 is a bottom plan view thereof;
FIG. 4 is a front view of the removed roof;
FIG. 5 is a bottom perspective inside view of the removed
roof;
FIG. 6 is a bottom plan view of FIG. 5;
FIG. 7 is the top plan view with the roof removed;
FIG. 8 is a left side elevational view of FIG. 1, the right side
is identical; and,
FIG. 9 is a rear view of FIG. 1 design.

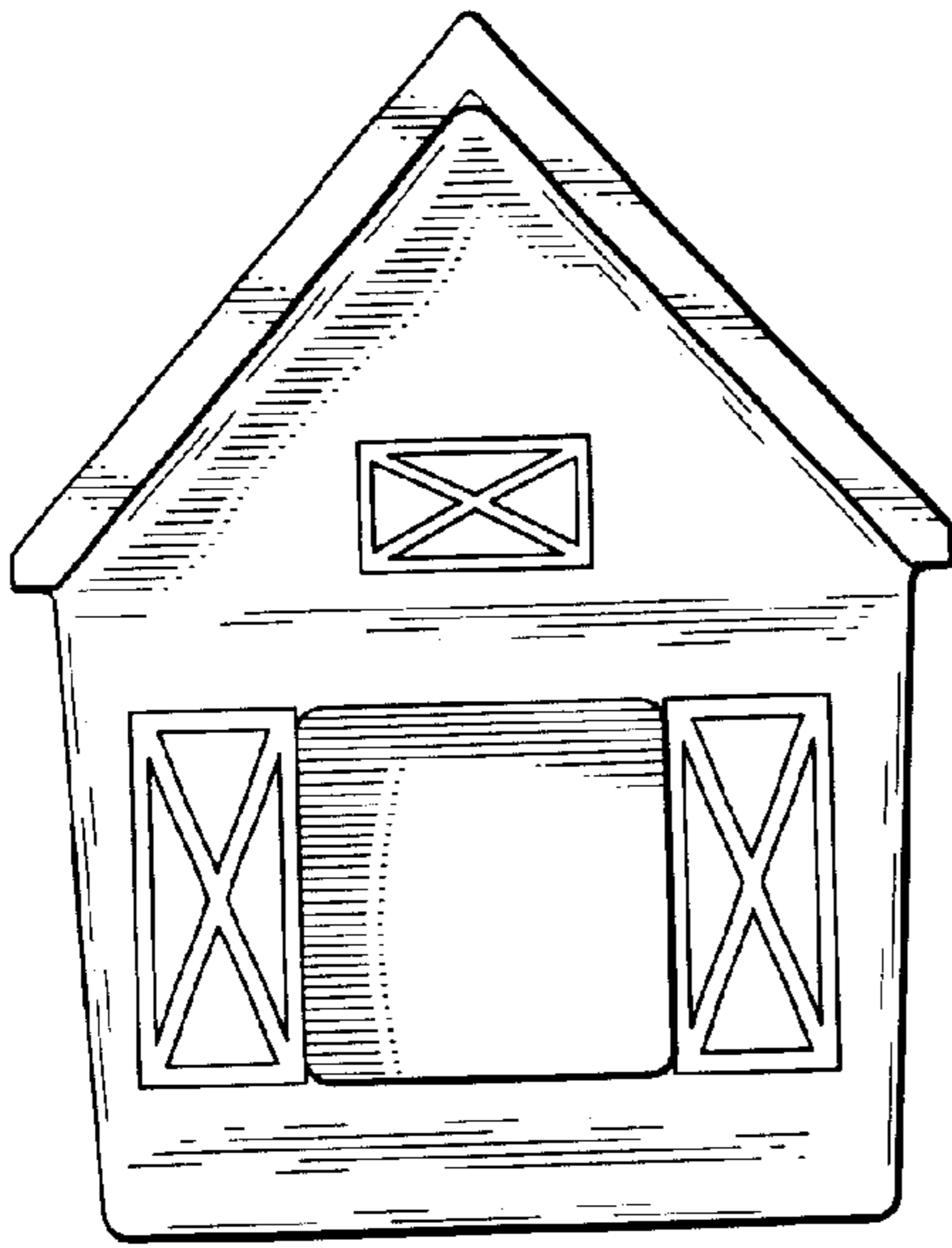

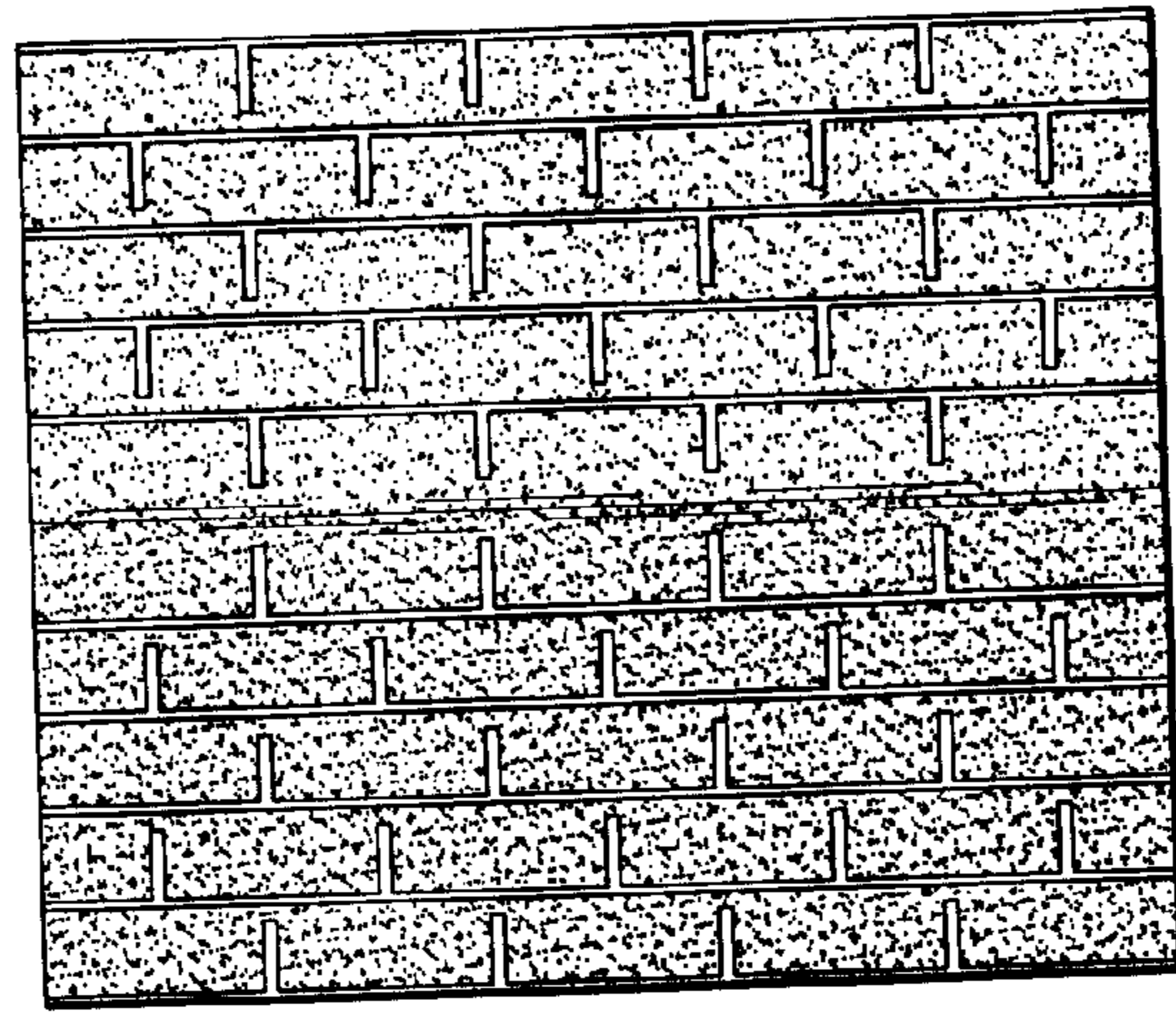

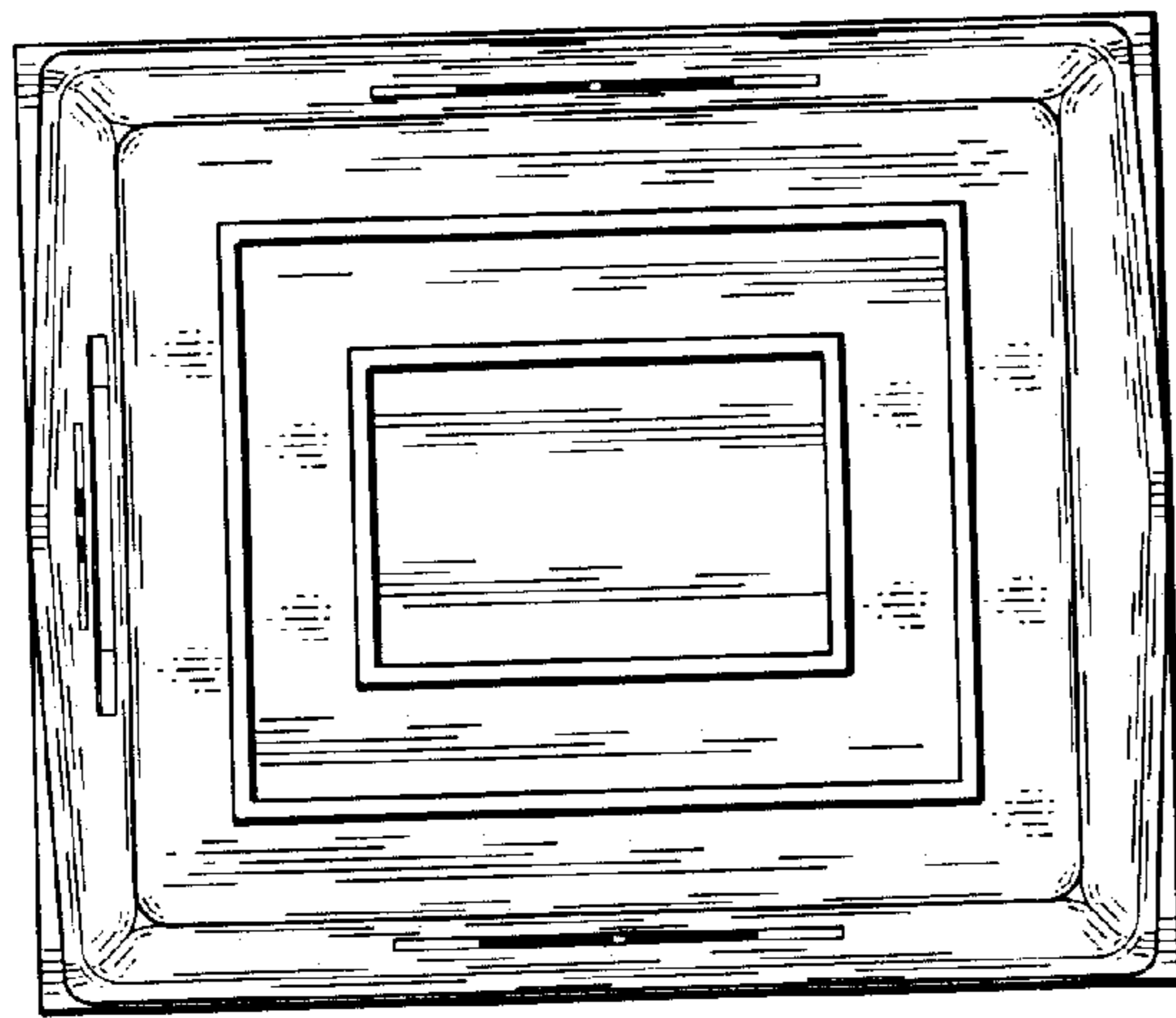

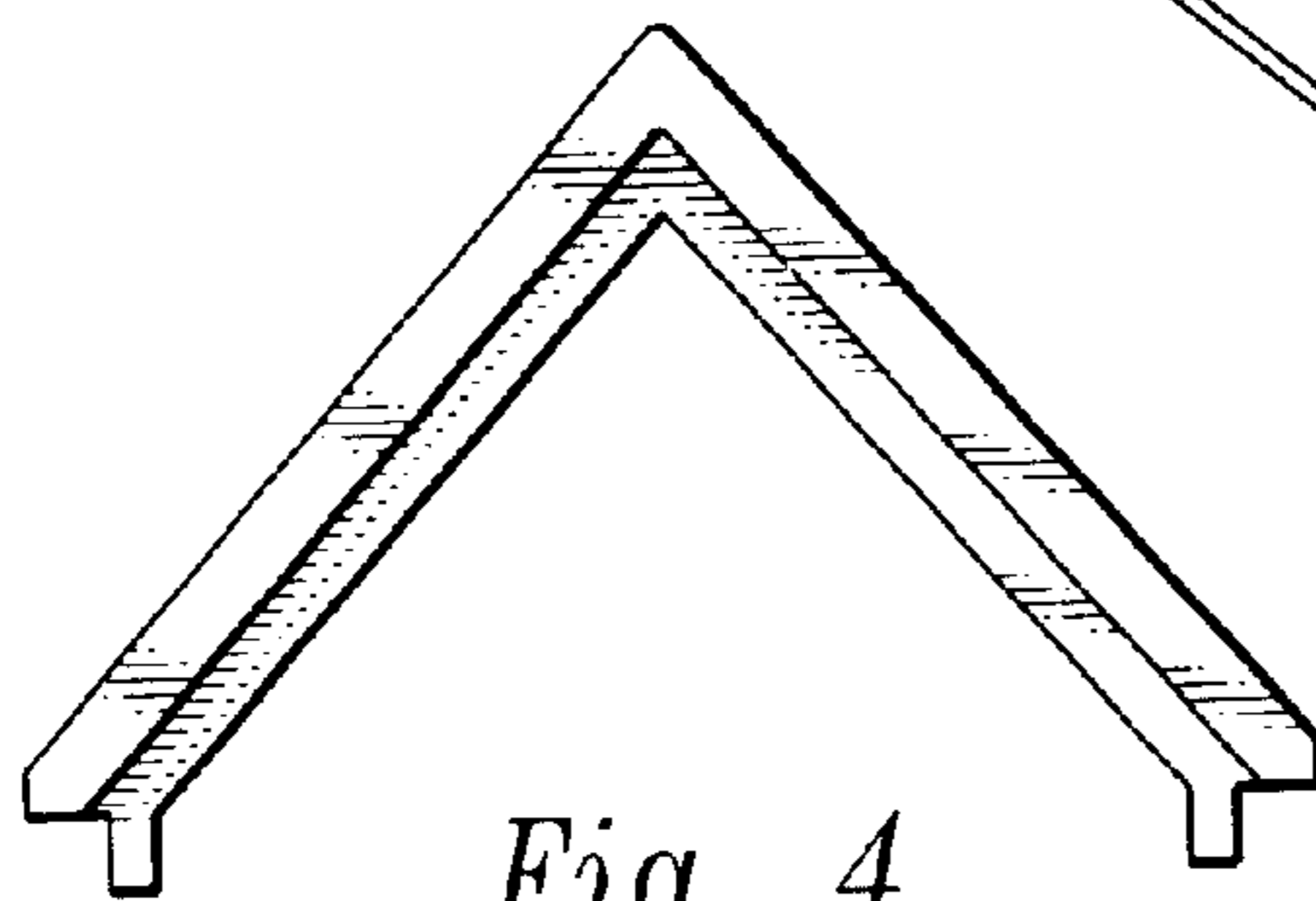

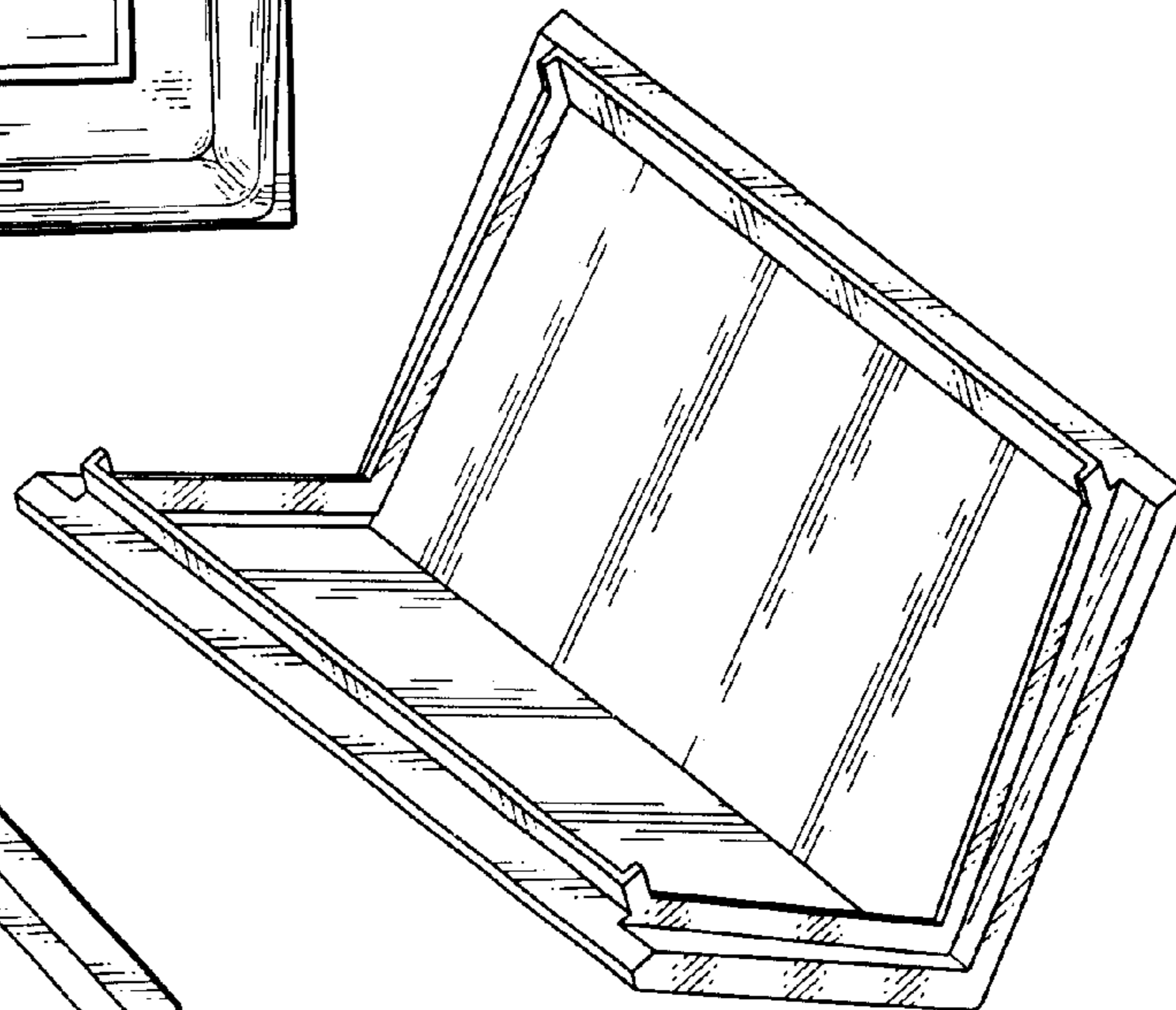

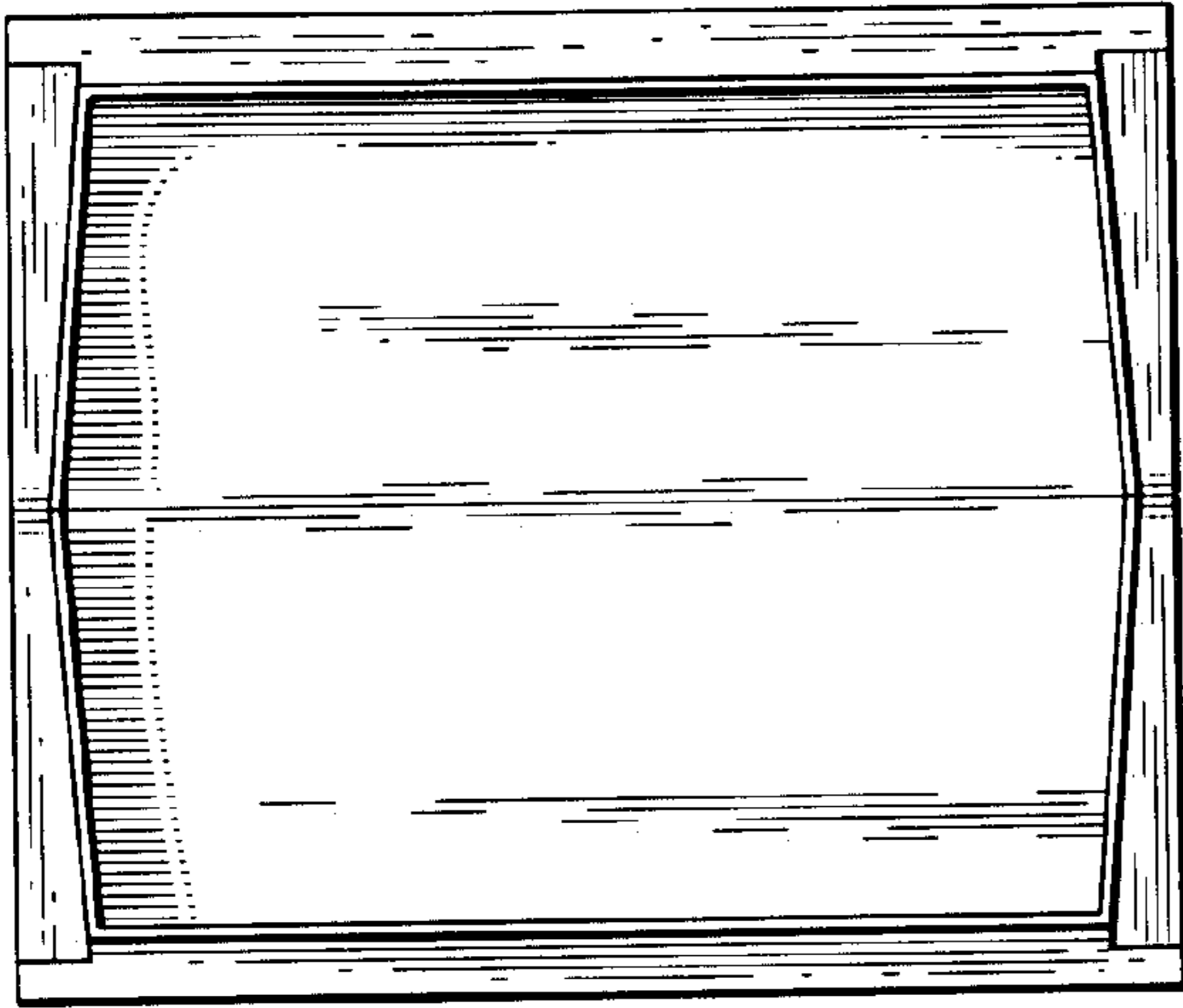

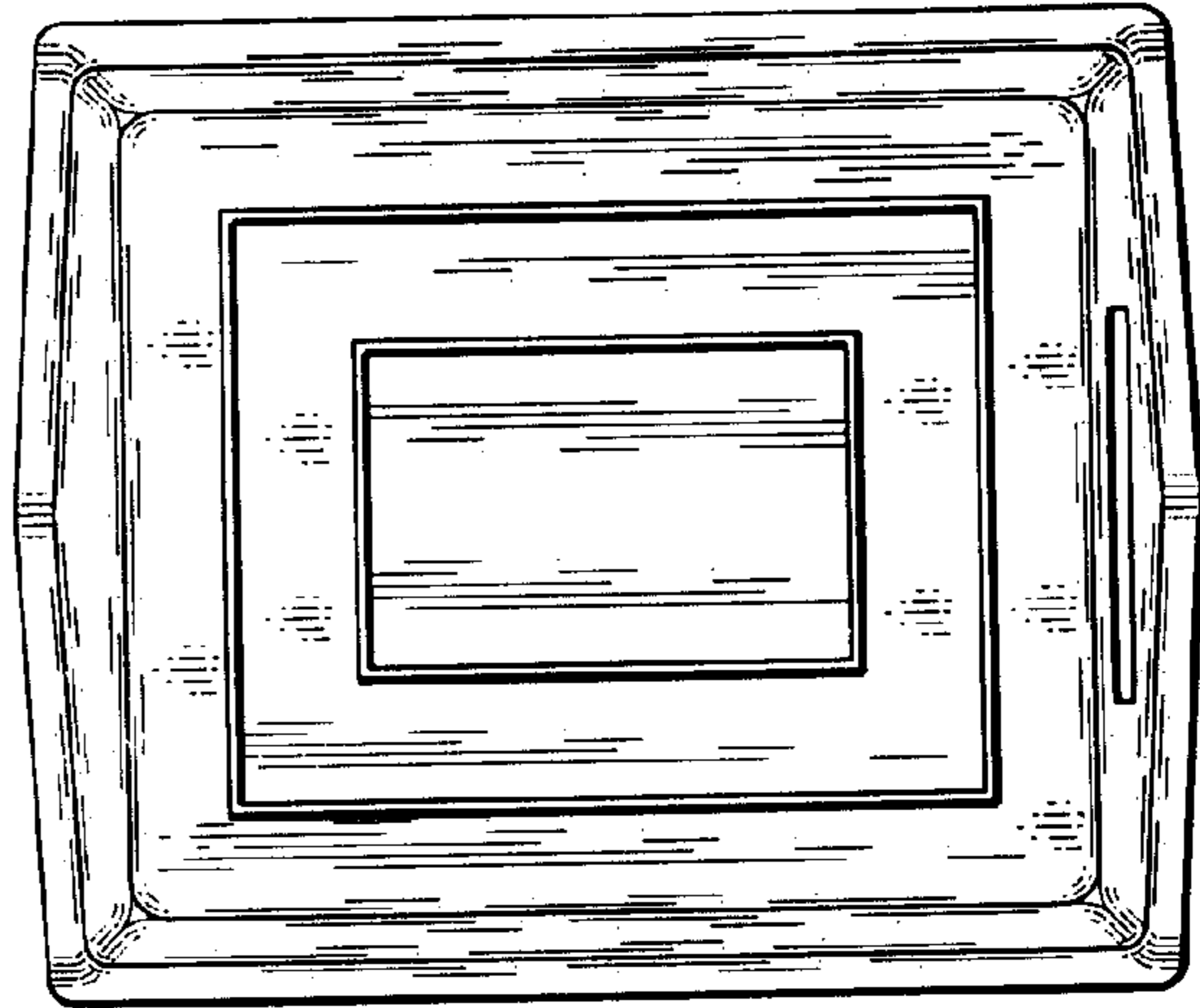

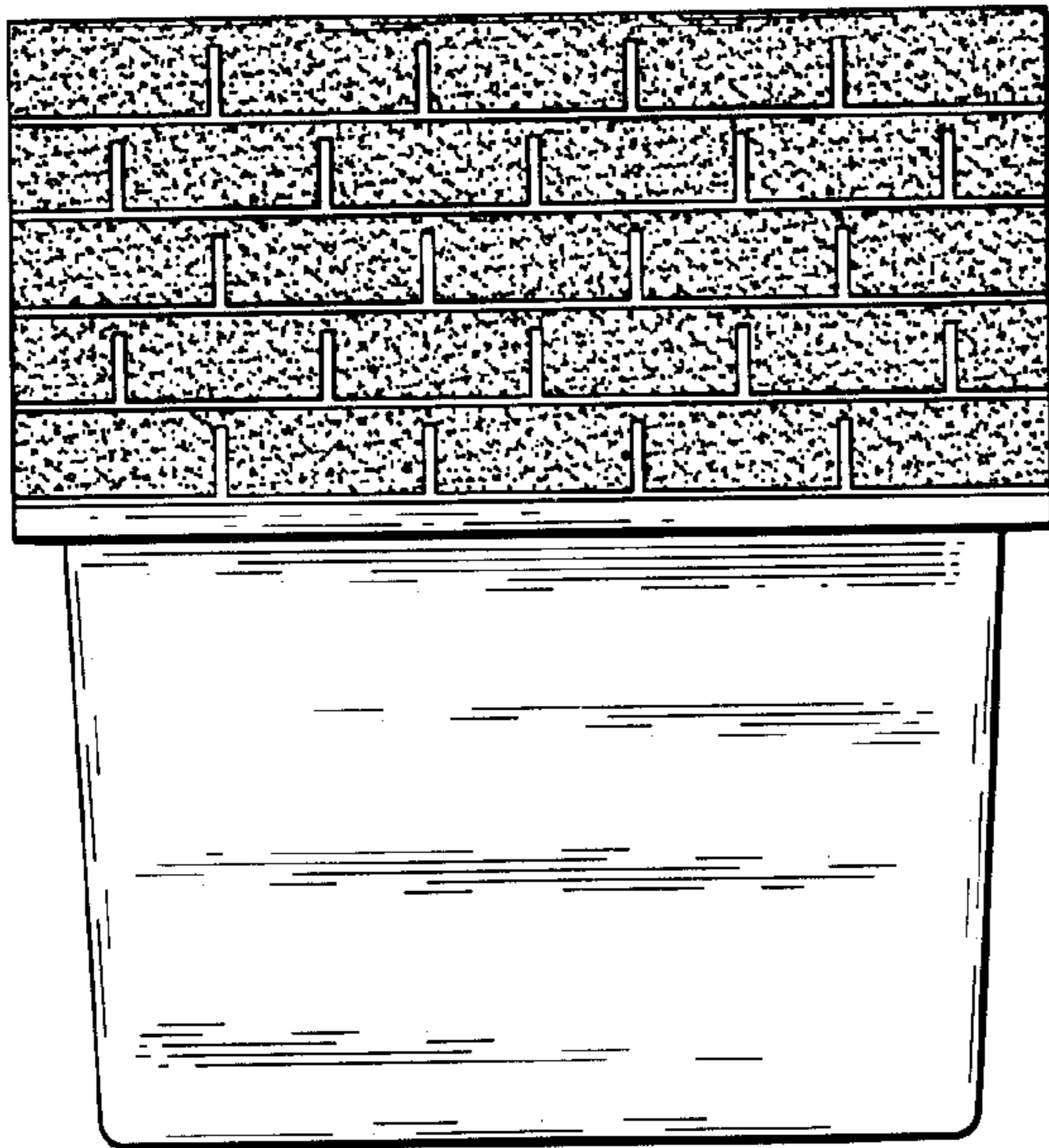

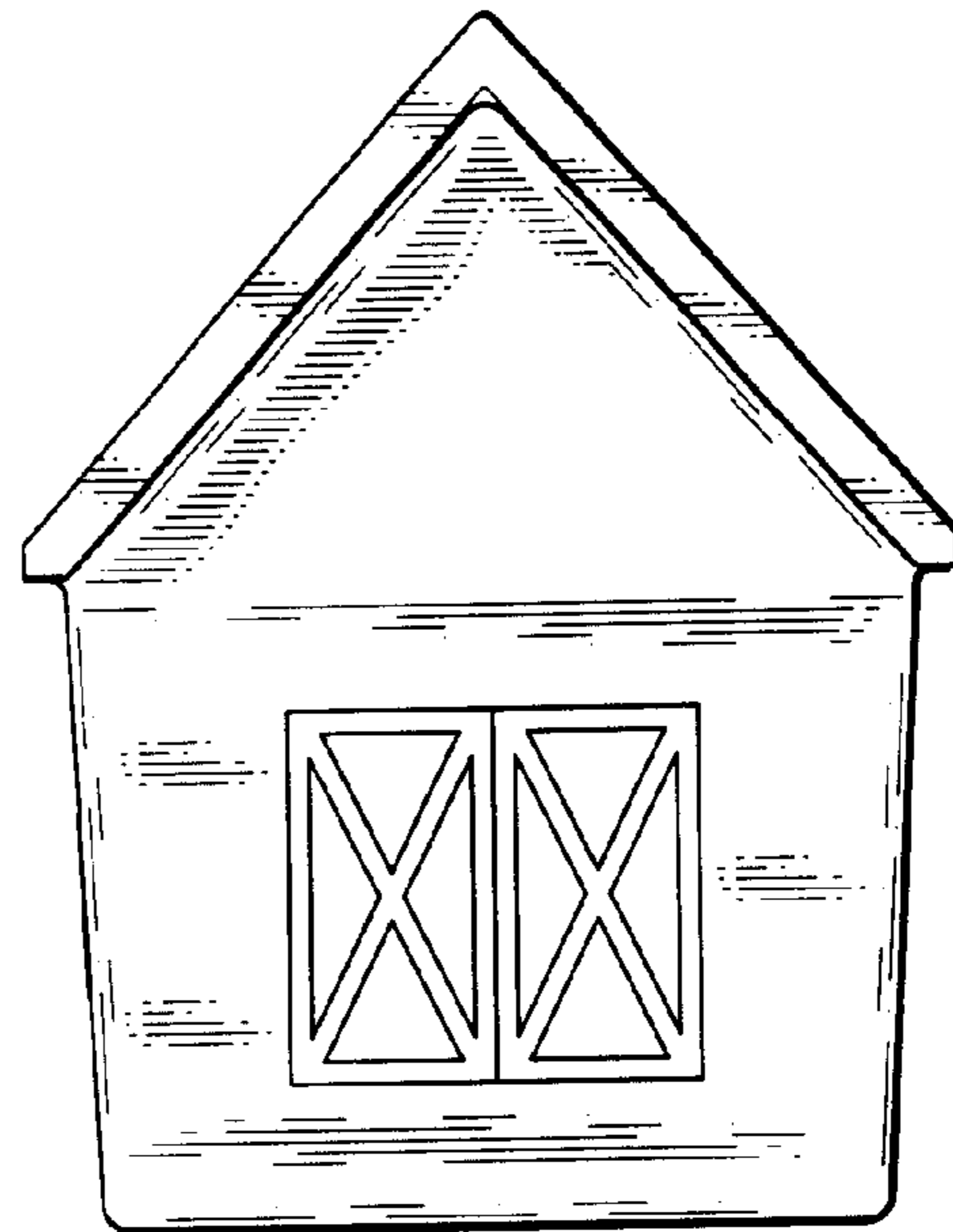
