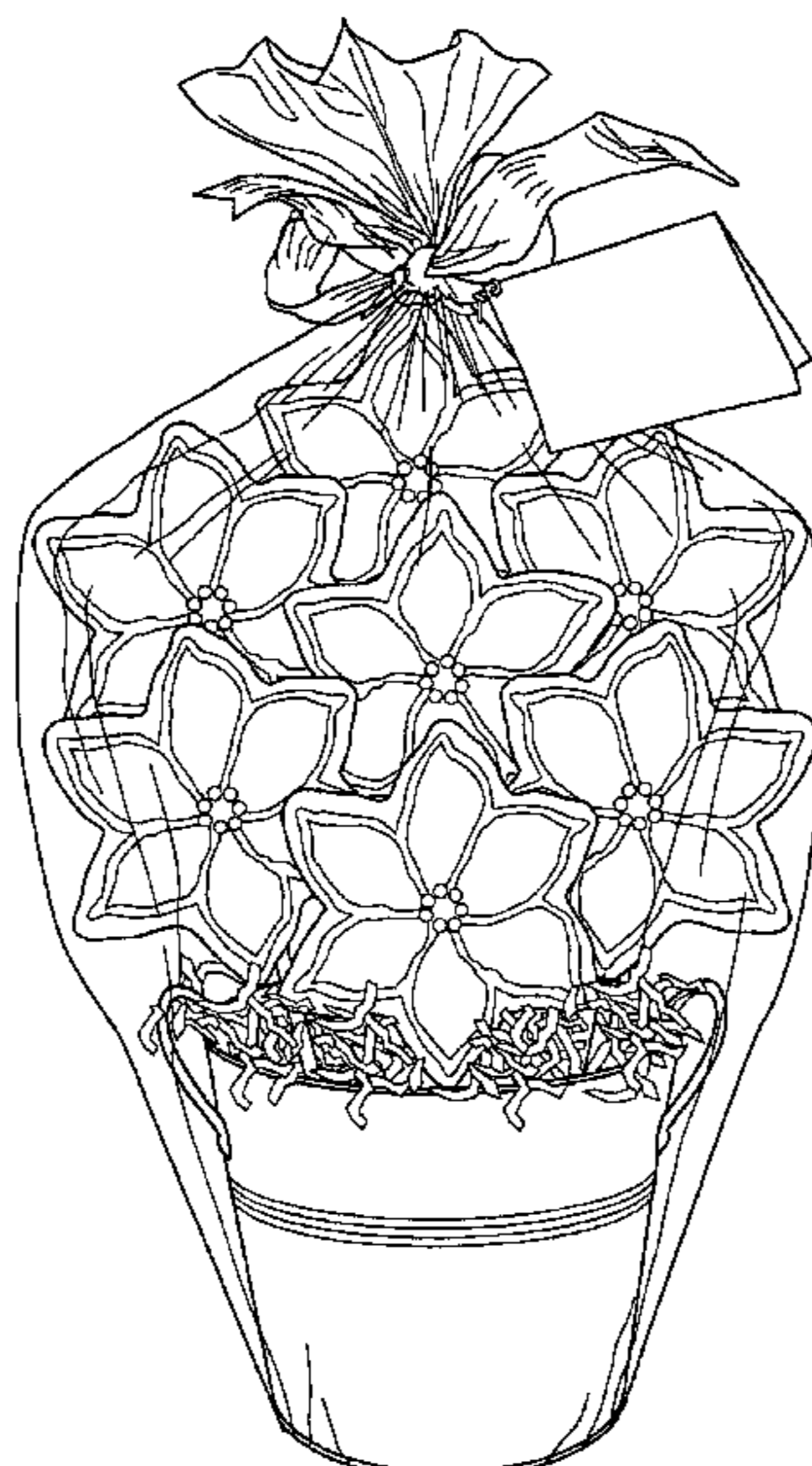
(57) **CLAIM**

The ornamental design for a combined cookie bouquet and inedible holder therefor, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a combined cookie bouquet and inedible holder therefor, showing my new design;
FIG. 2 is a front perspective view thereof, shown without the transparent wrapping, bow and card for clarity of disclosure;
FIG. 3 is a rear perspective view of FIG. 1;
FIG. 4 is a rear perspective view of FIG. 2;
FIG. 5 is a left side perspective view of FIG. 1;
FIG. 6 is a left side perspective view of FIG. 2;
FIG. 7 is a bottom perspective view of FIG. 1;
FIG. 8 is a bottom perspective view of FIG. 2; and,
FIG. 9 is a top perspective view of FIG. 2.

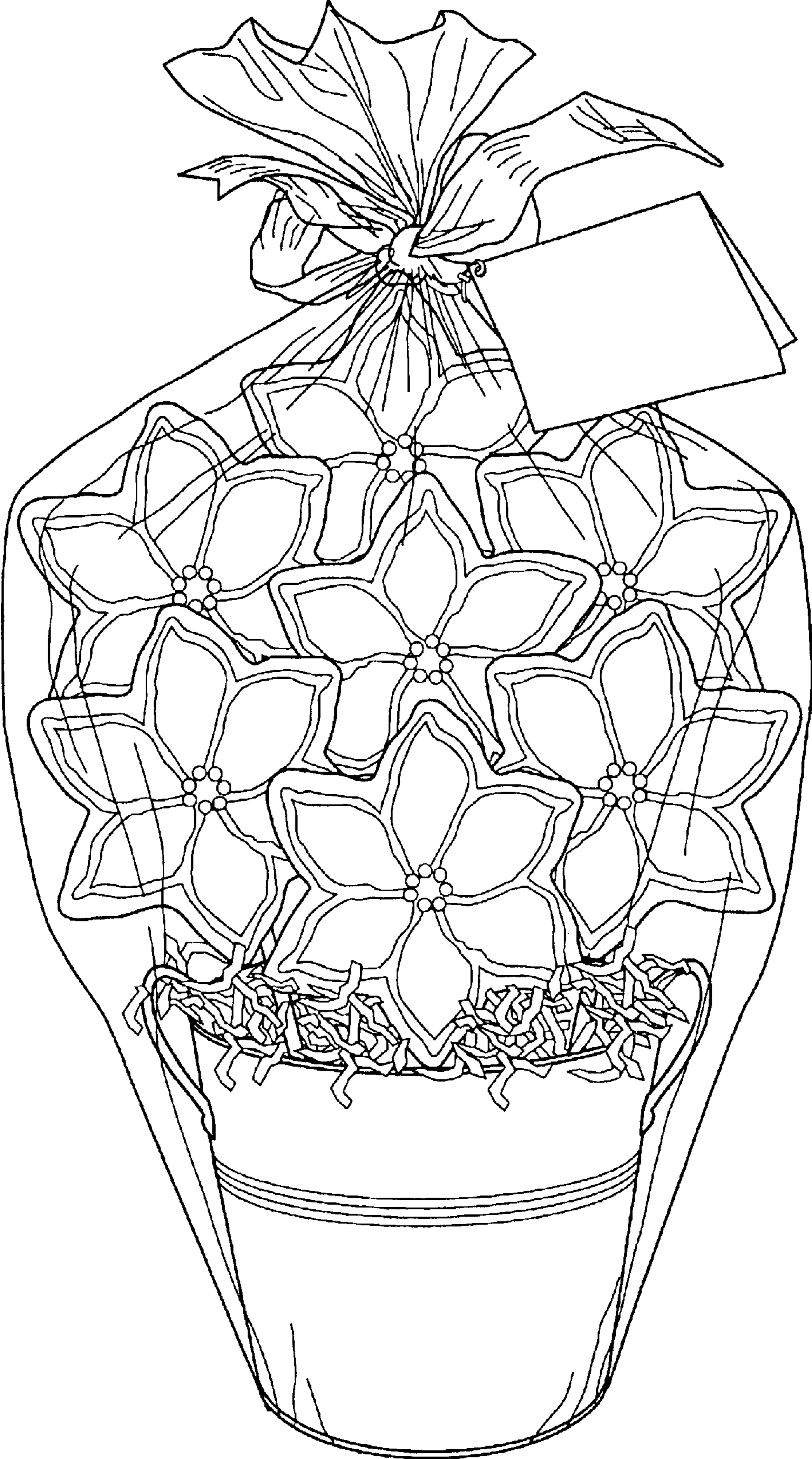

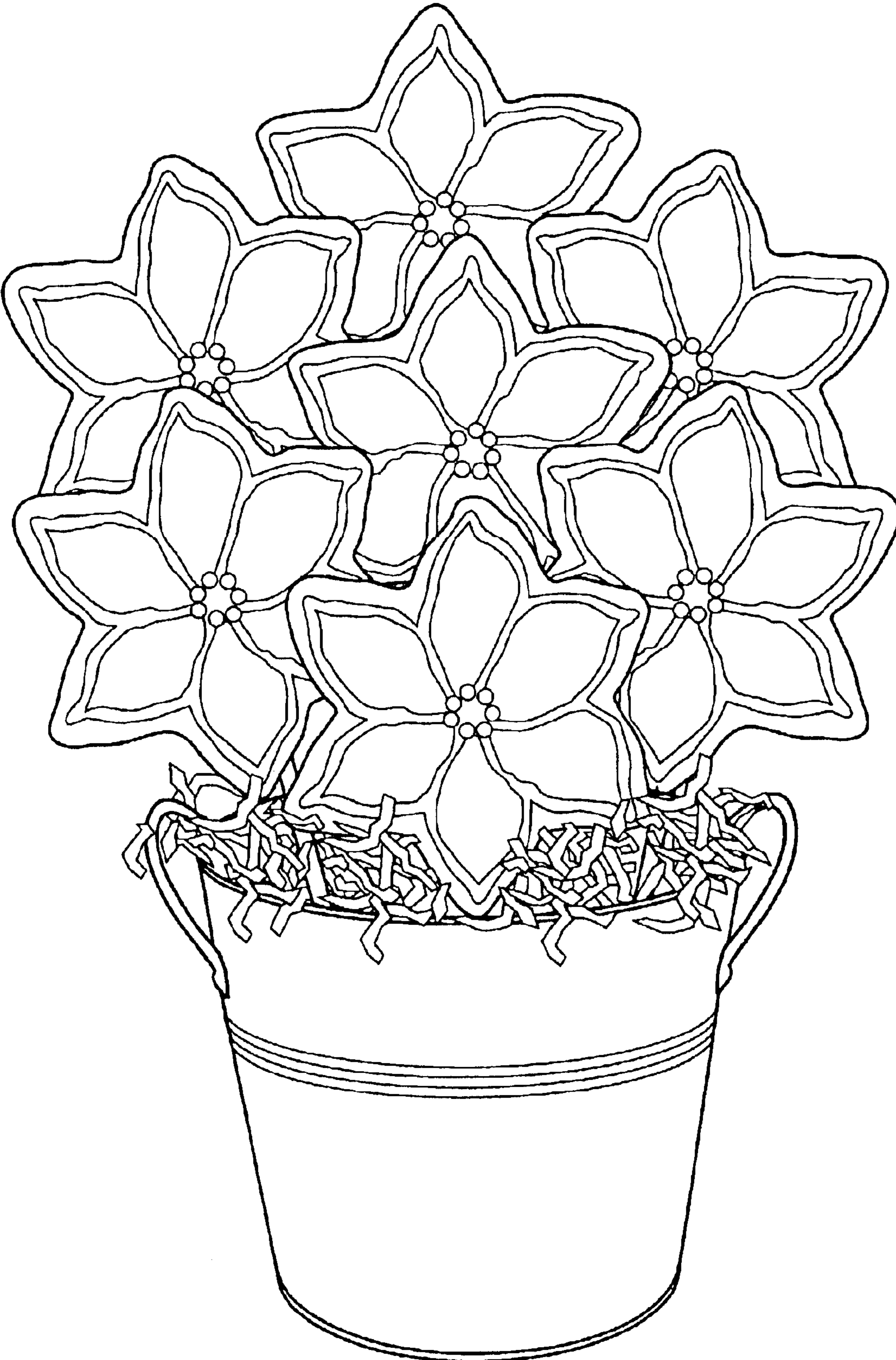

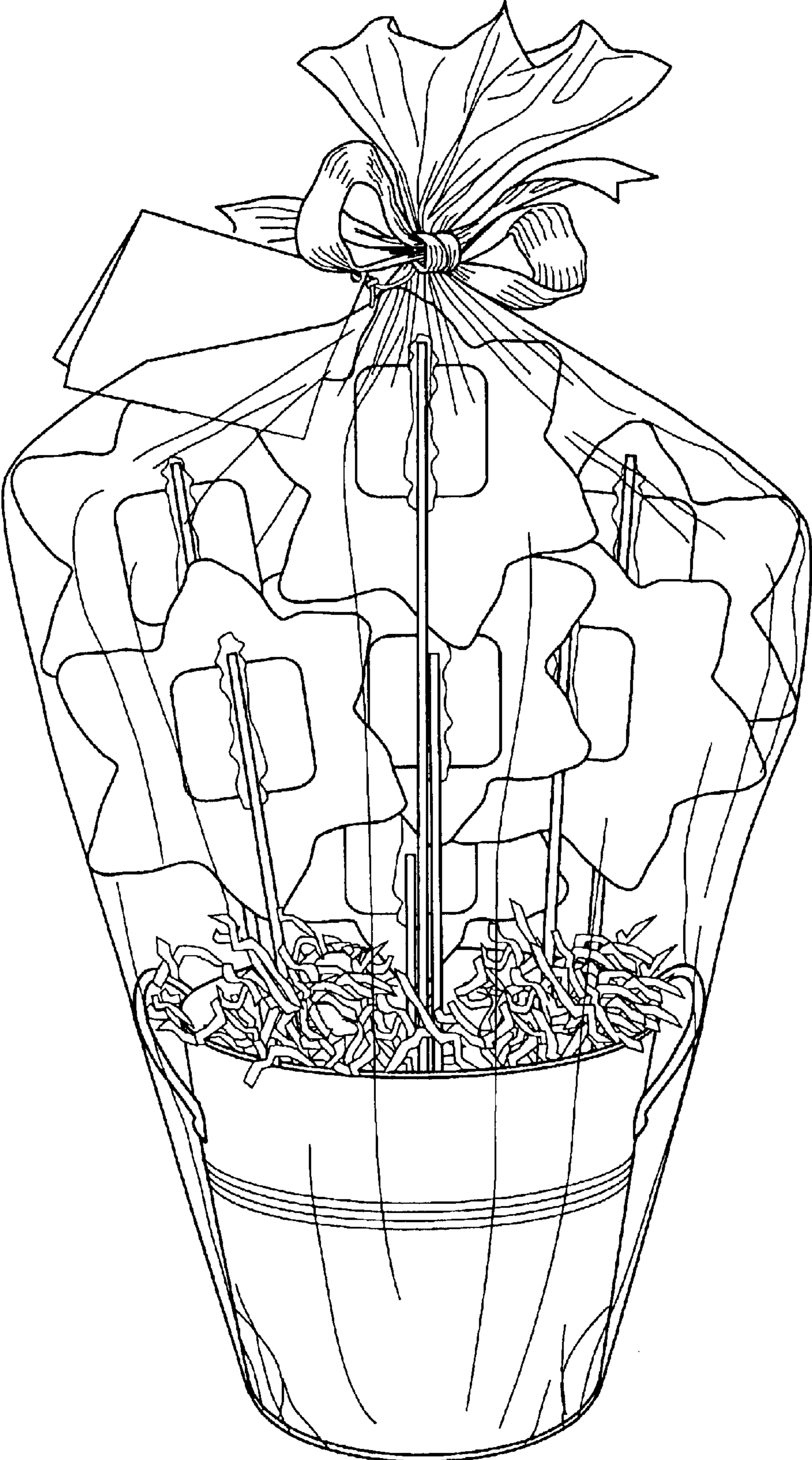

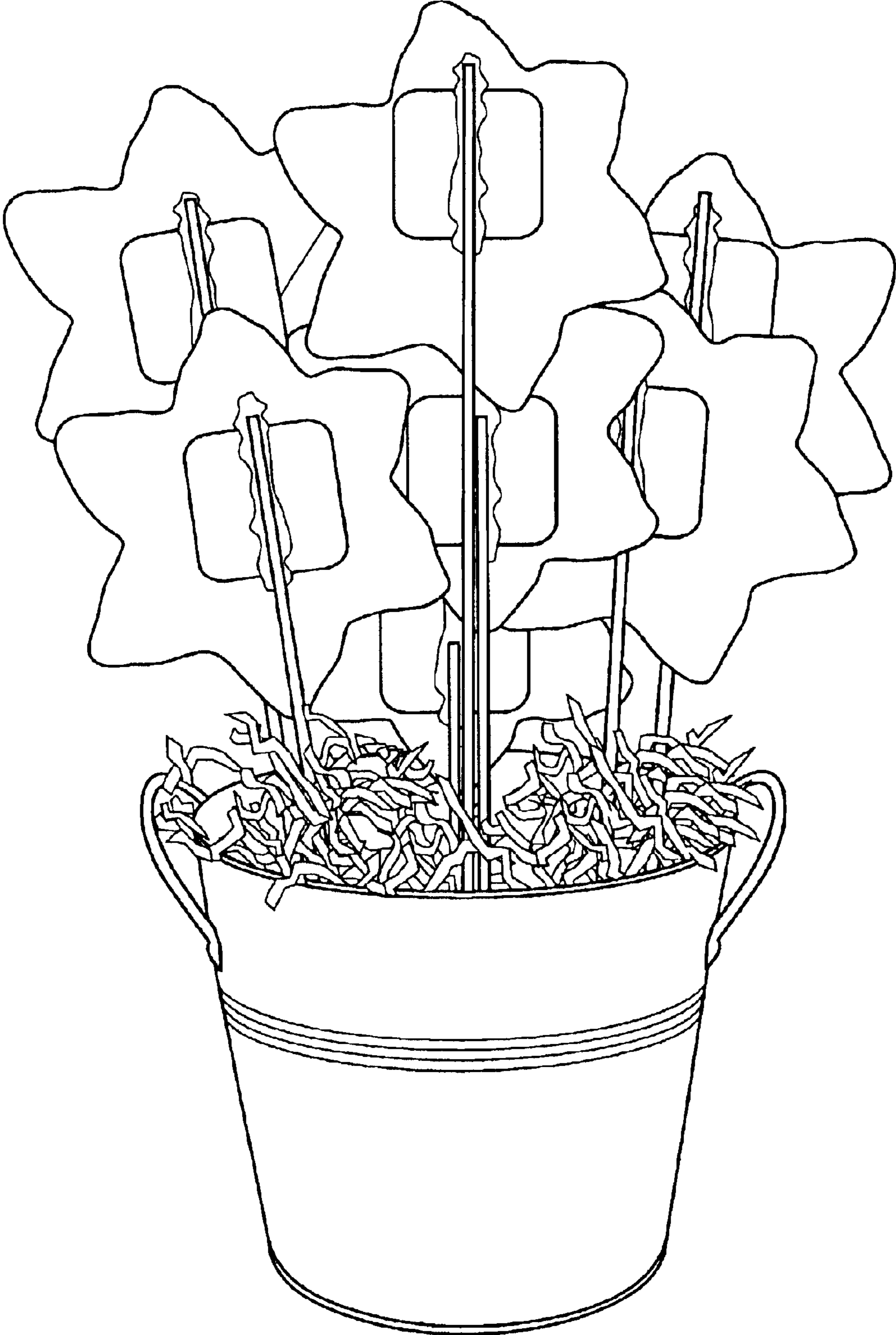

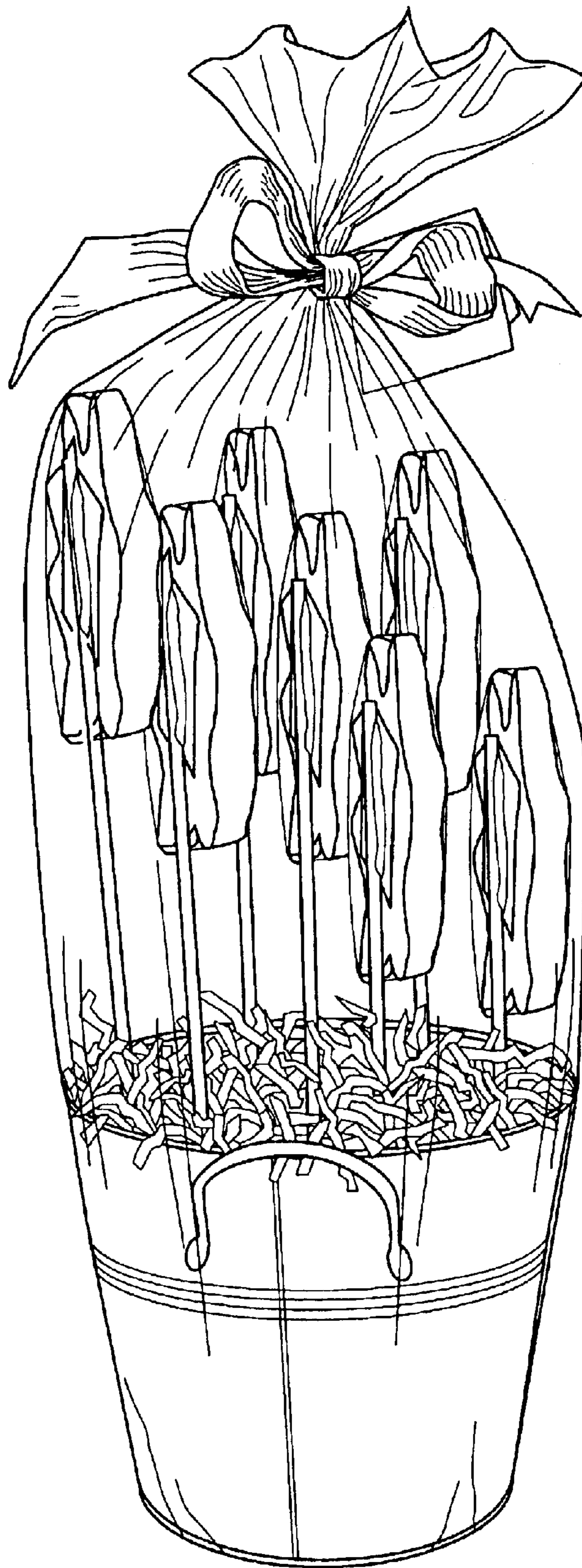

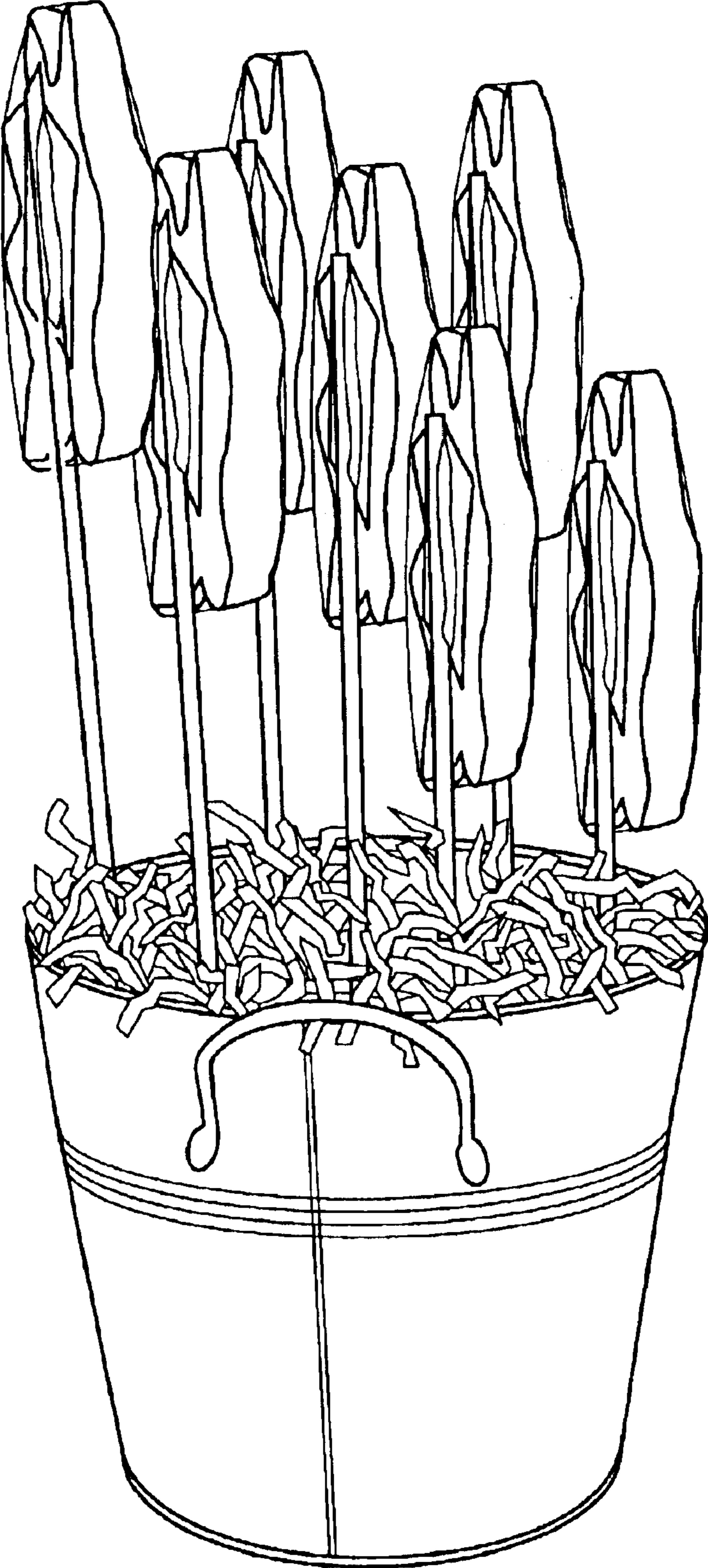

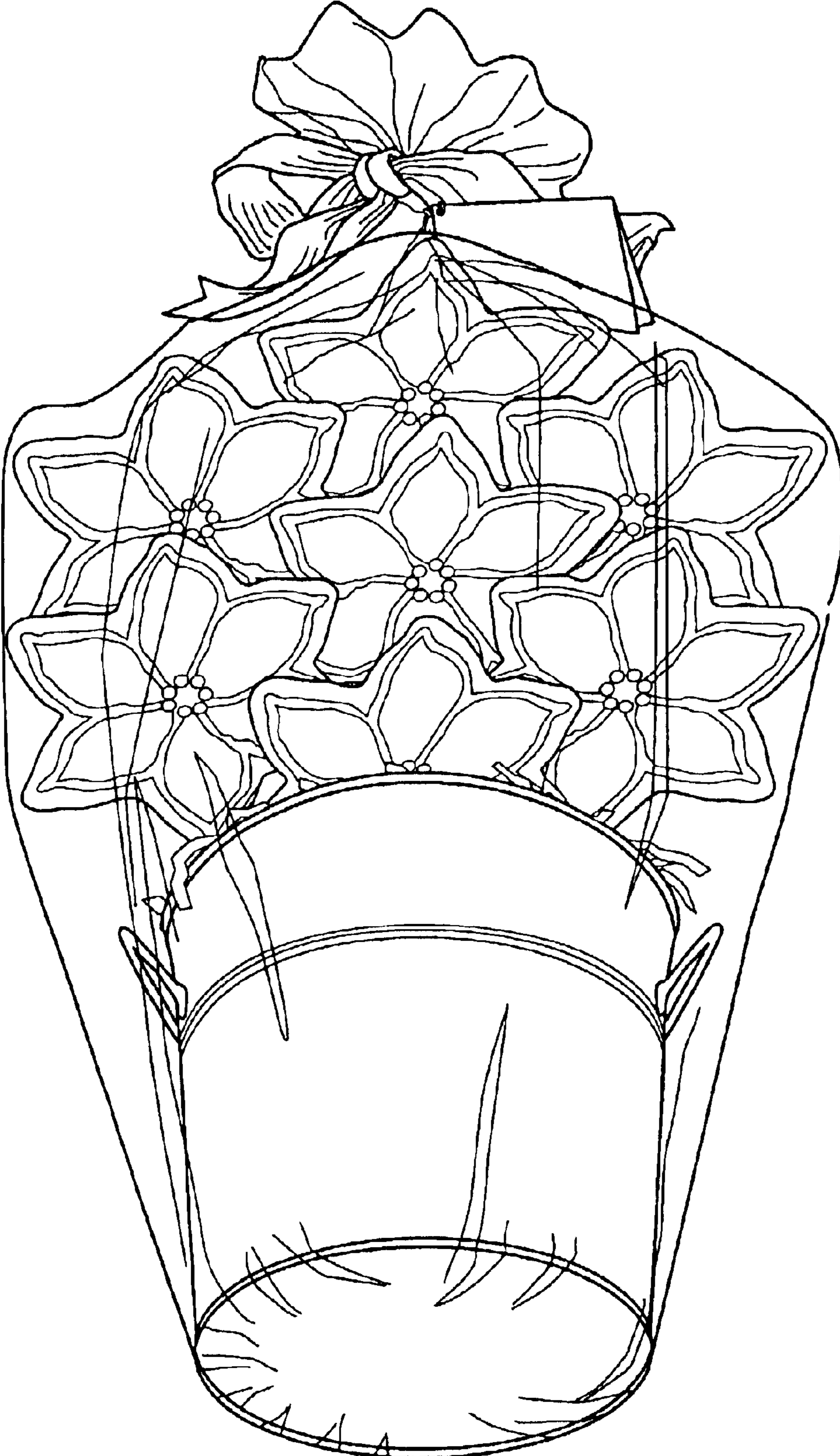

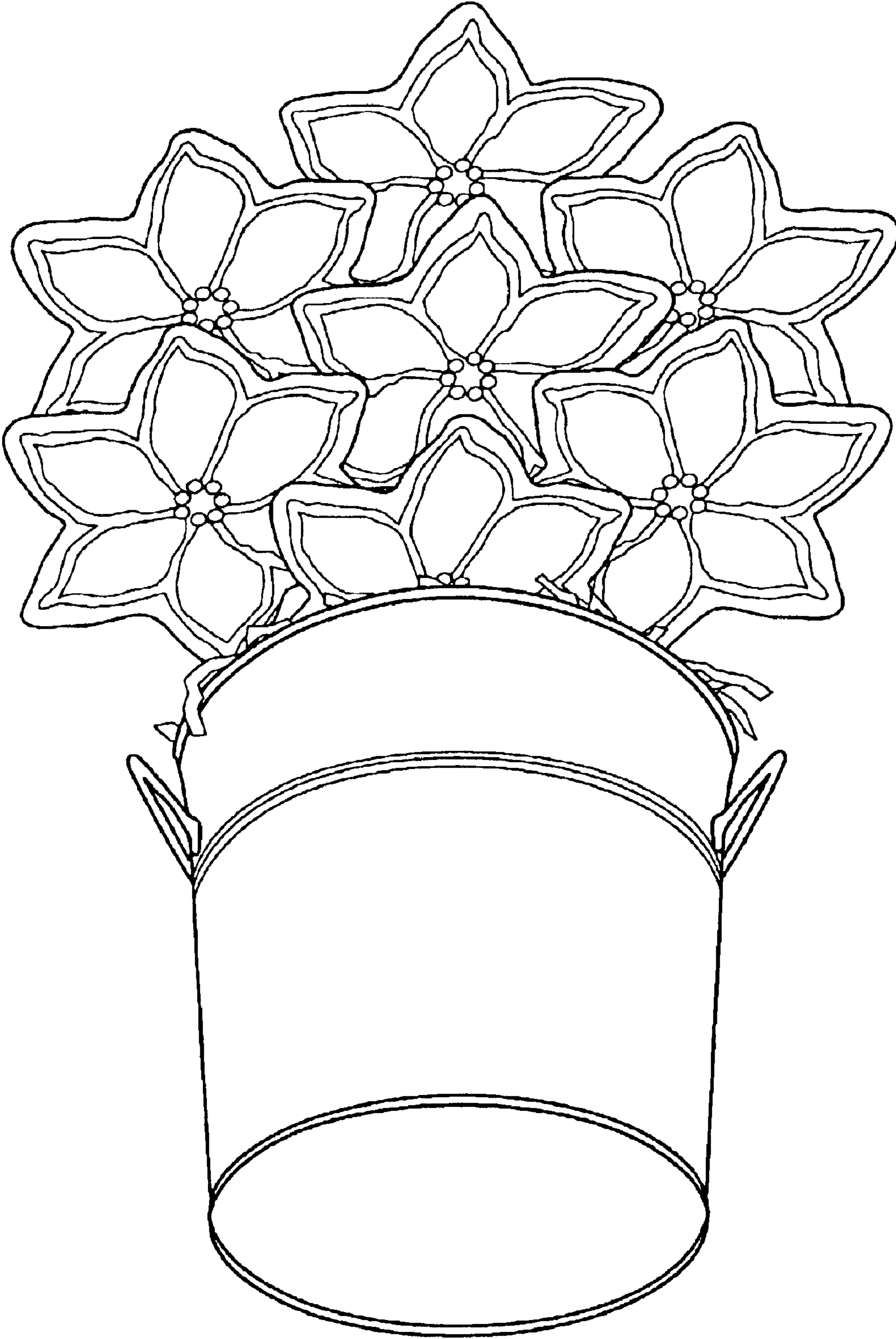

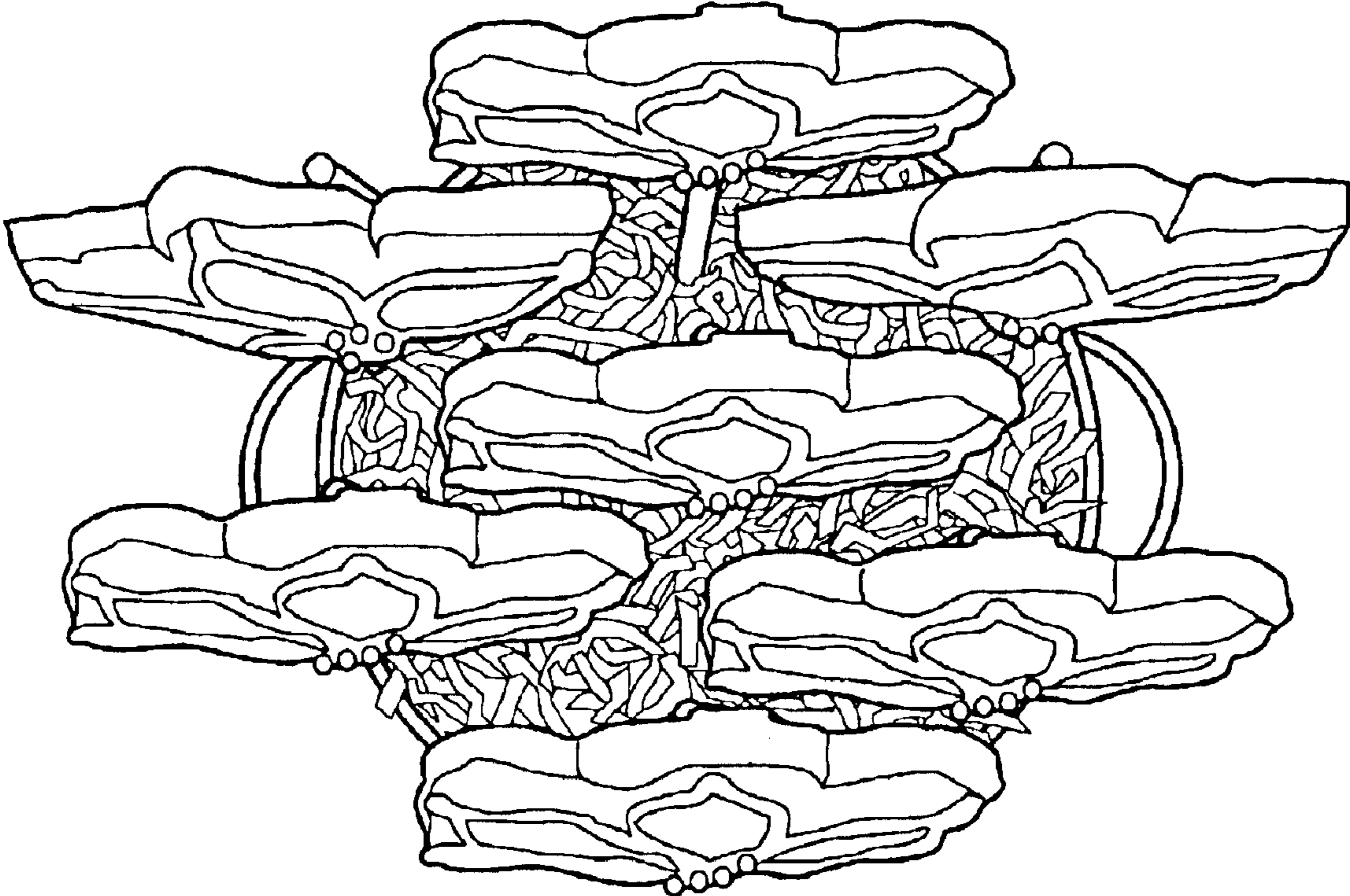
