FIG. 8 is a cross-sectional view taken along line 8—8 of FIG. 1; and,

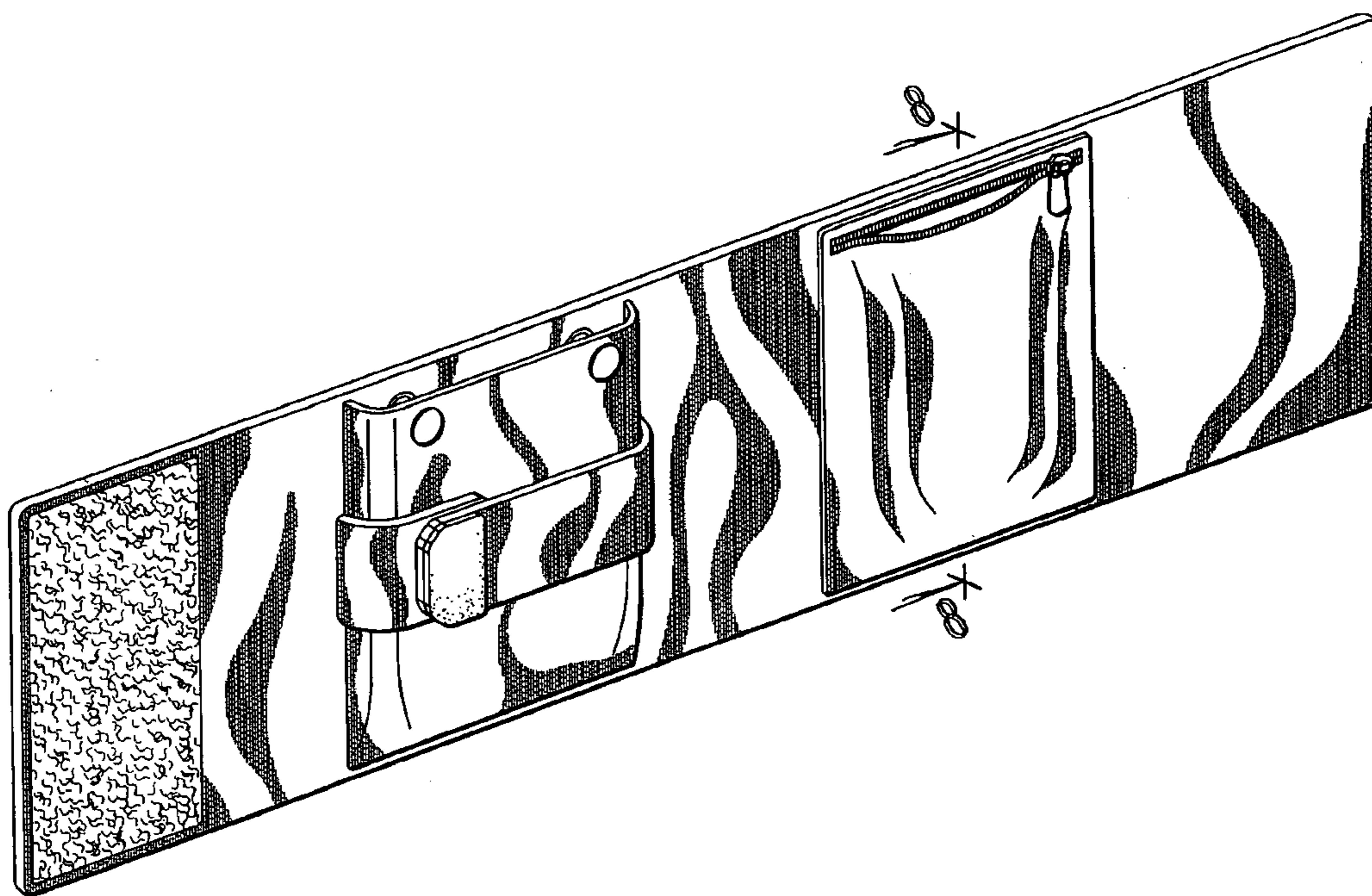

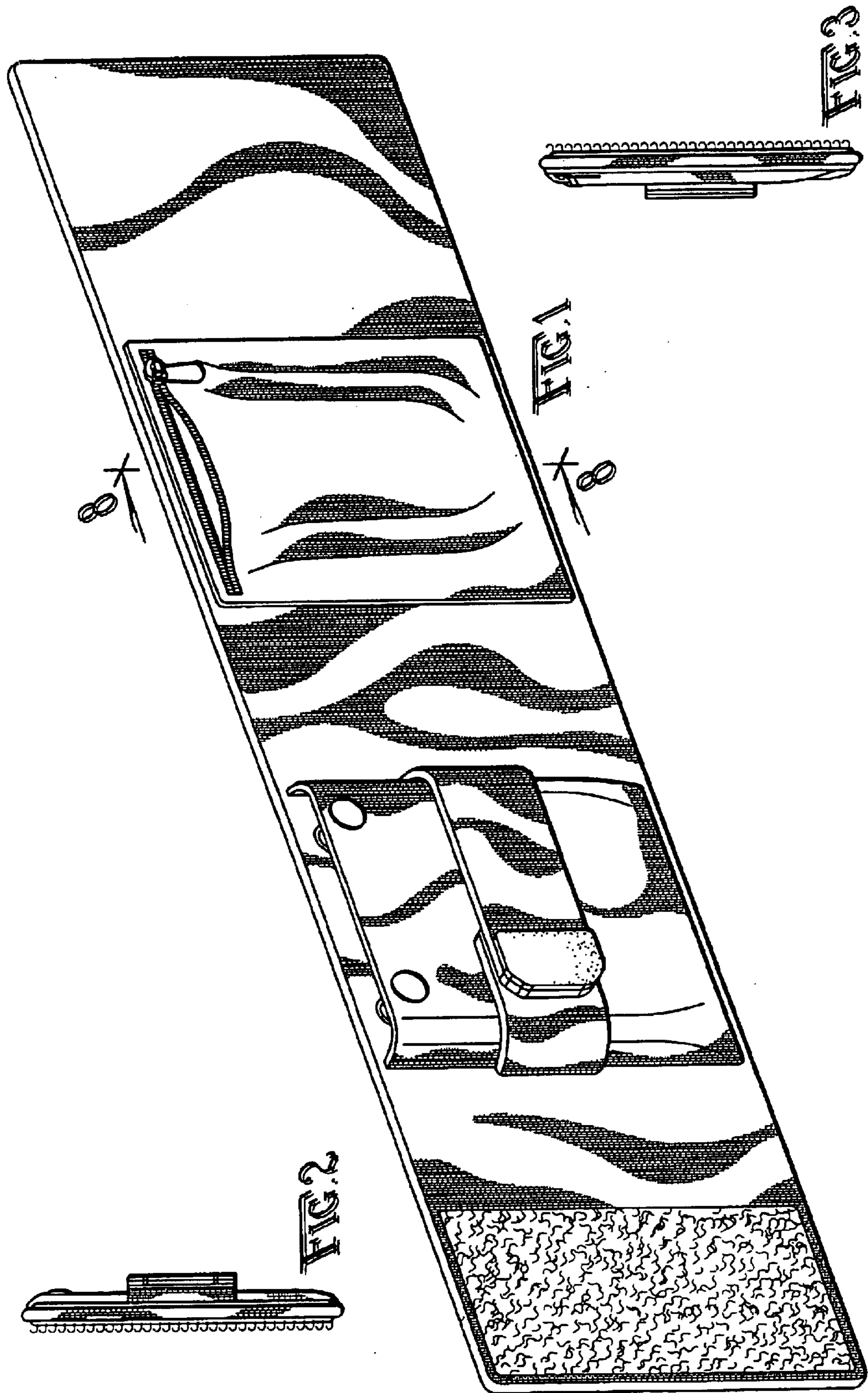

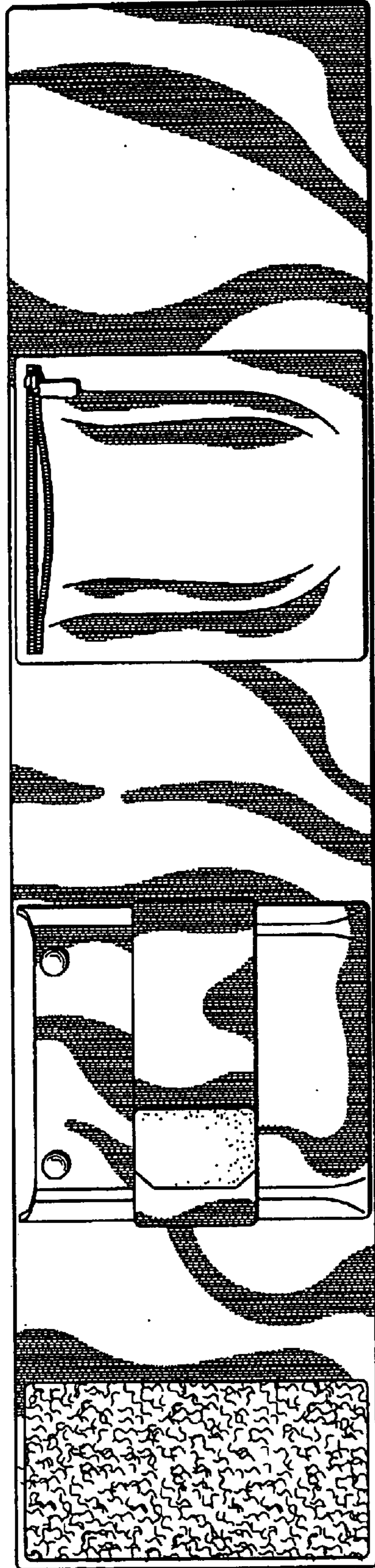

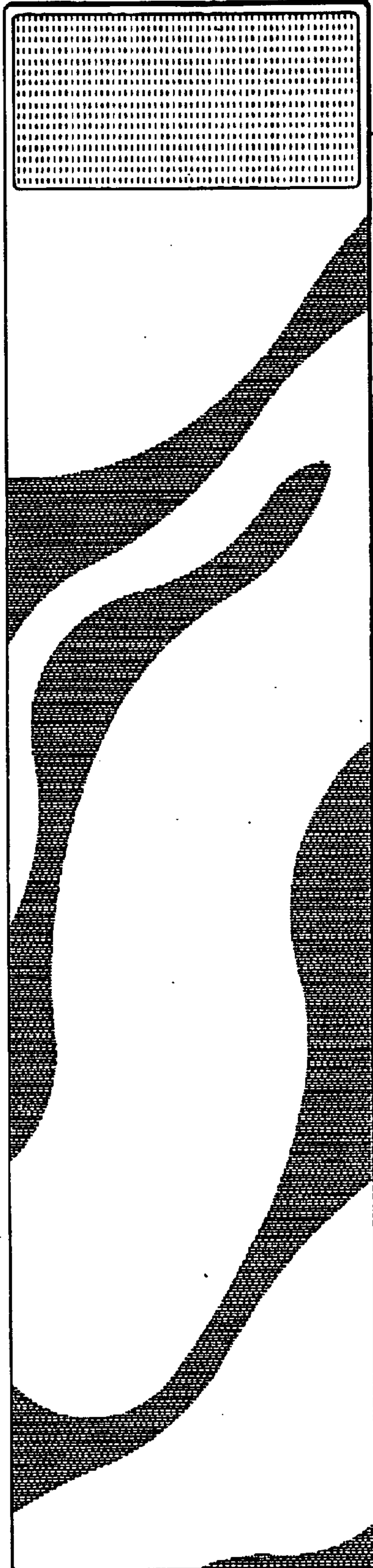

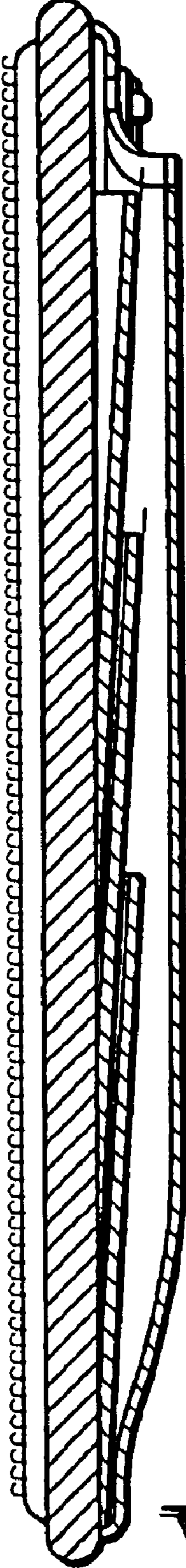
