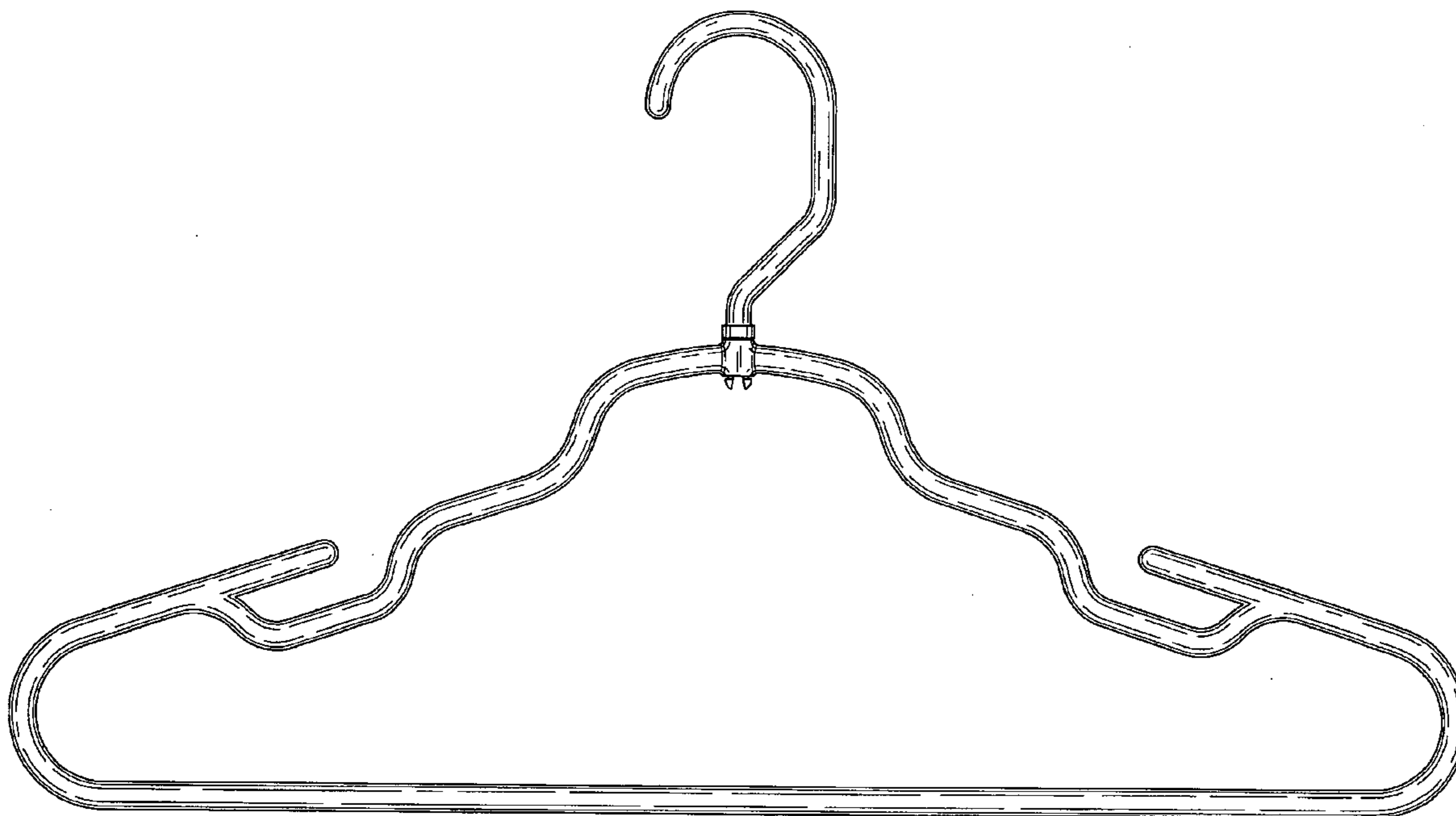
(57) **CLAIM**

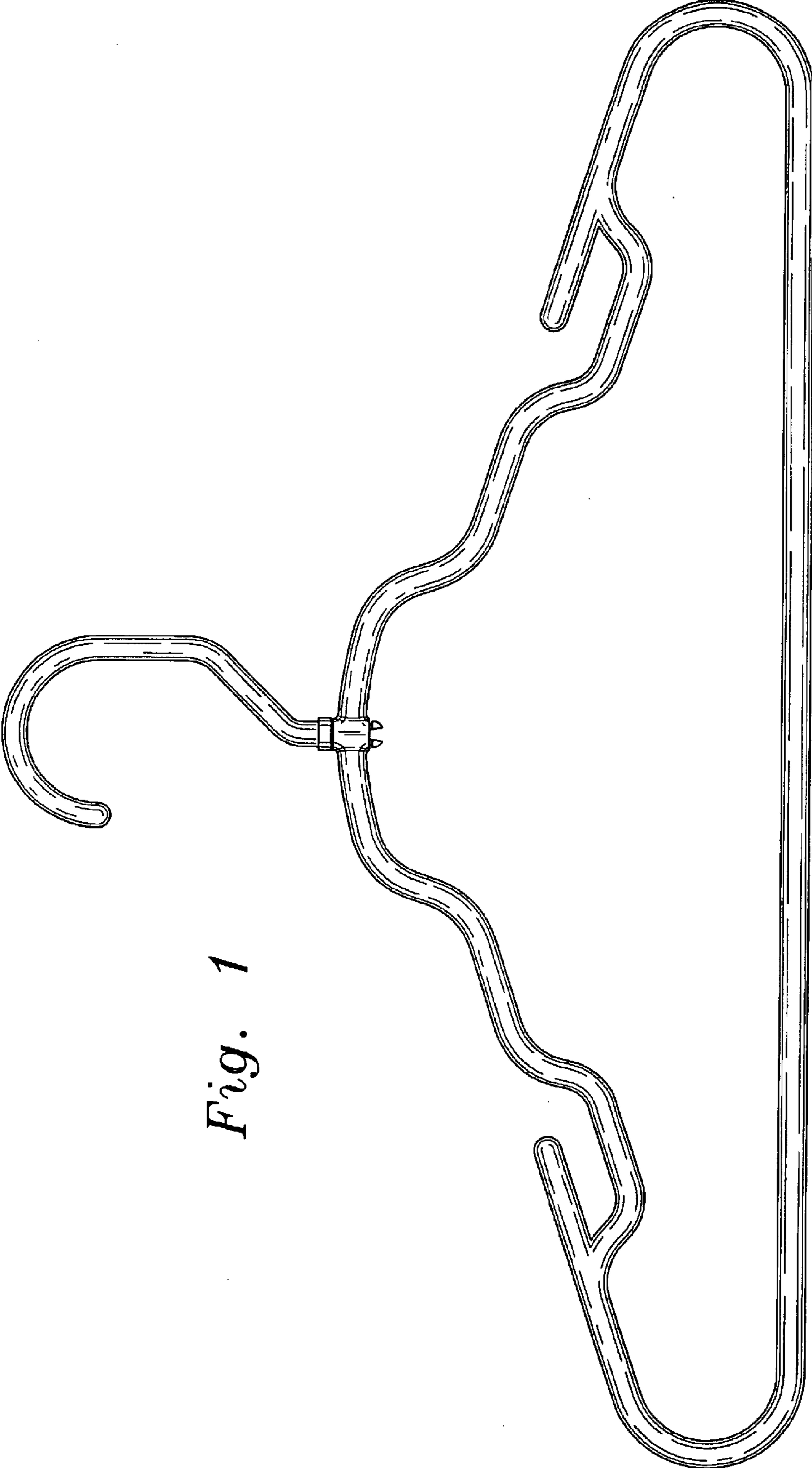
The ornamental design for a notched hanger with swivel hook, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a notched hanger with swivel hook, showing my new invention;  
FIG. 2 is a right side elevation view thereof, with the swivel hook rotated approximately 45 degree;  
FIG. 3 is a left side elevation view thereof, with the swivel hook rotated approximately 45 degree;  
FIG. 4 is a top plan view thereof, with the swivel hook rotated approximately 45 degree; and,  
FIG. 5 is a bottom plan view thereof, with the swivel hook rotated approximately 45 degree.

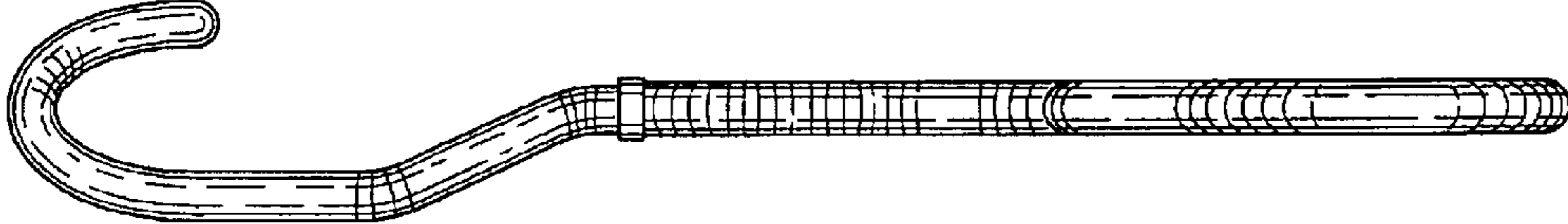

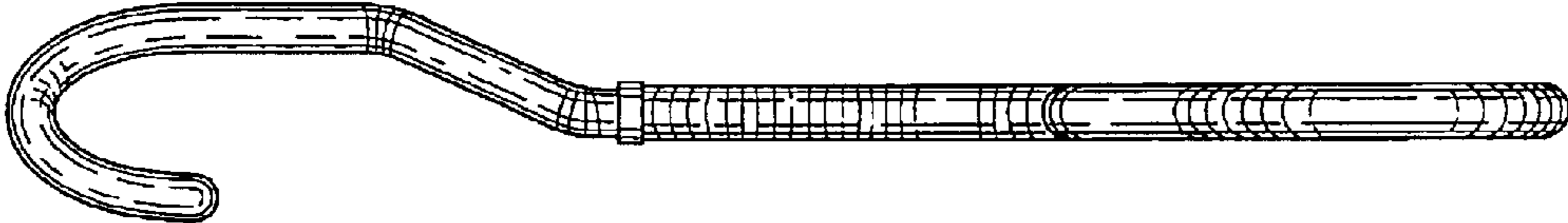

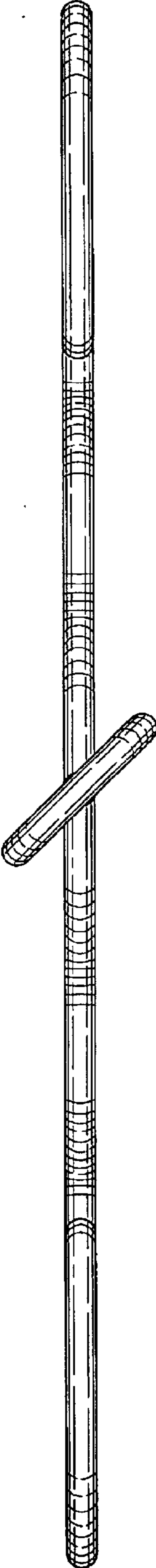
