DESCRIPTION

FIG. 9 is a front elevational view thereof;

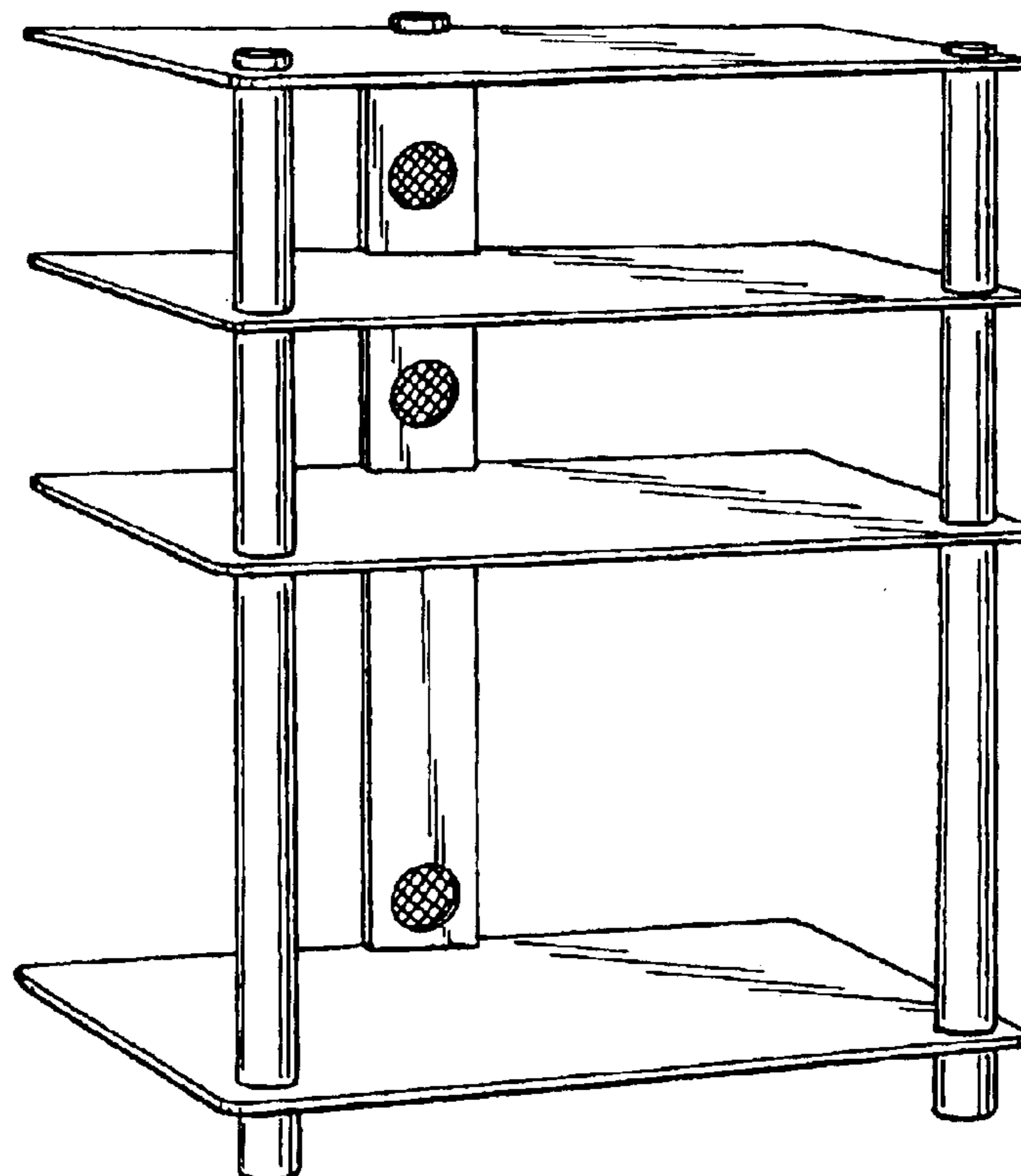
FIG. 10 is a right side elevational view thereof;

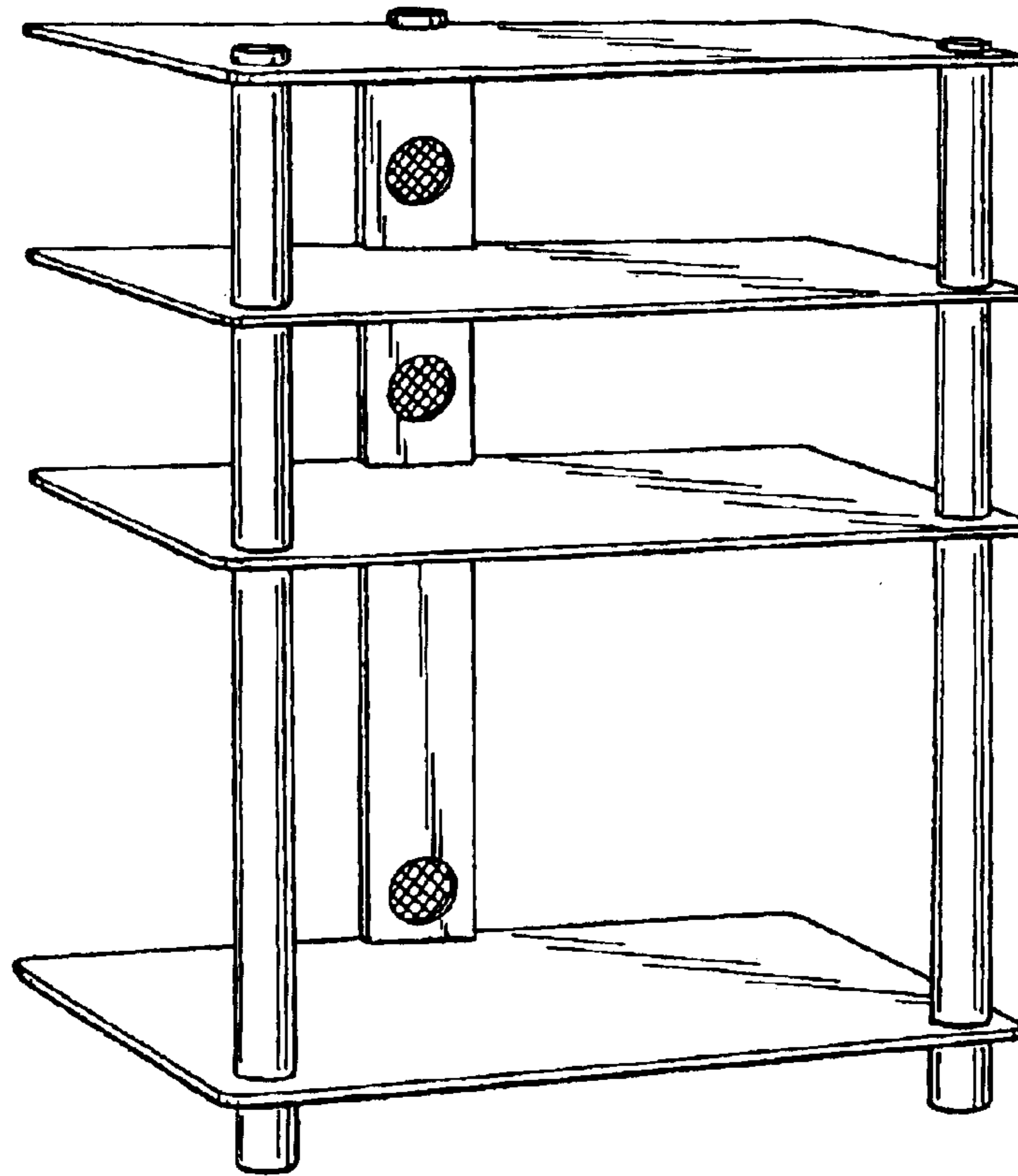

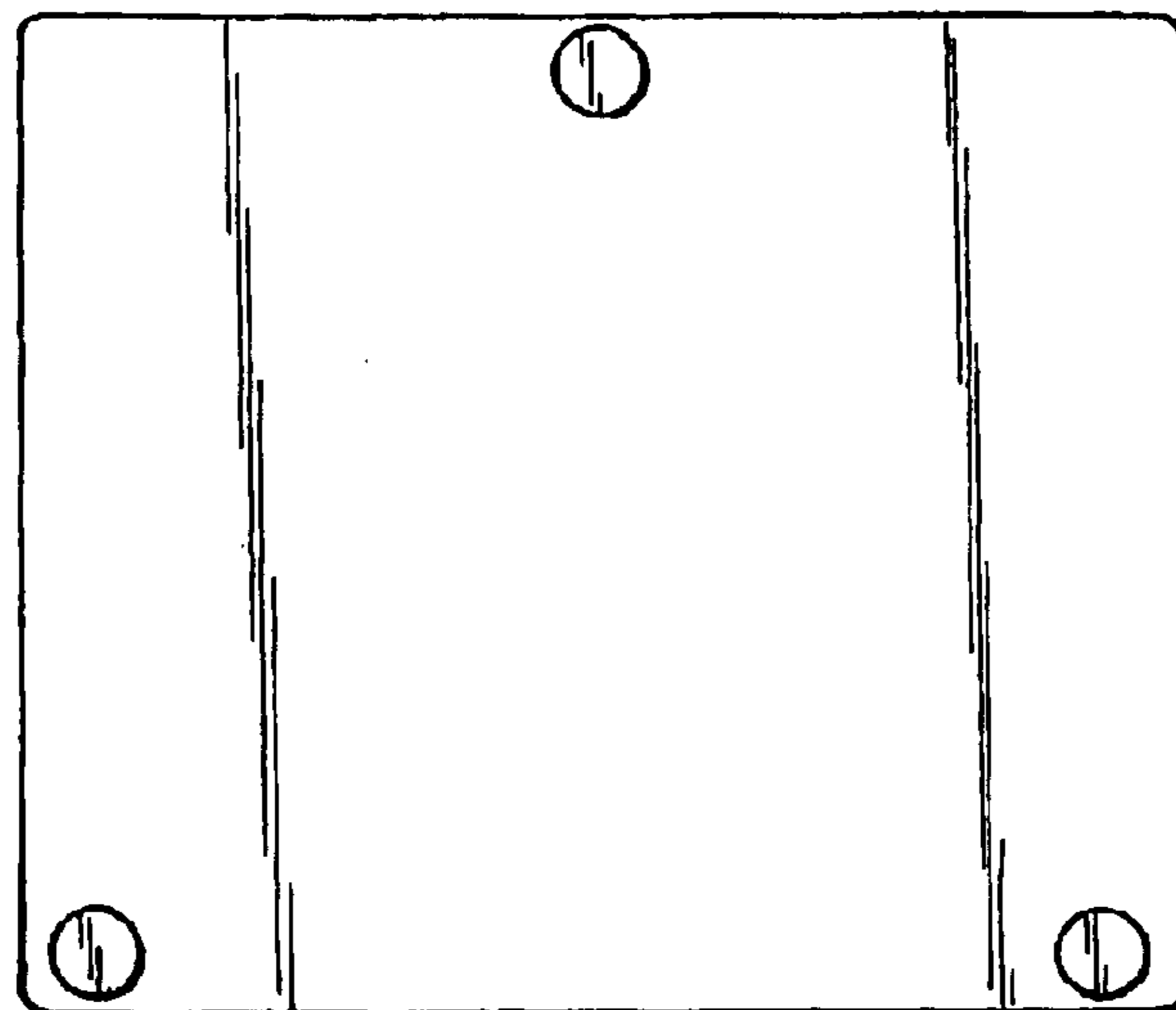

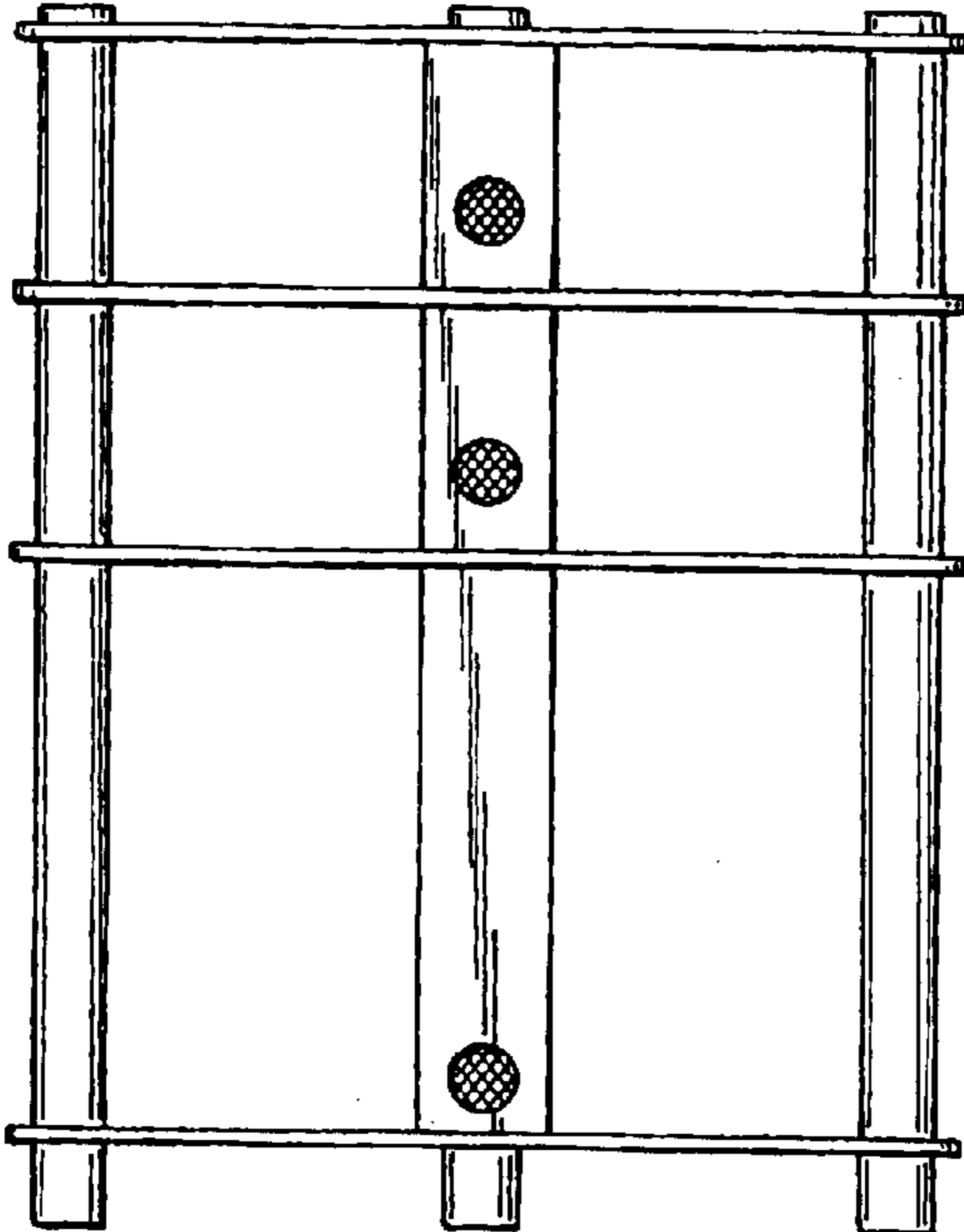

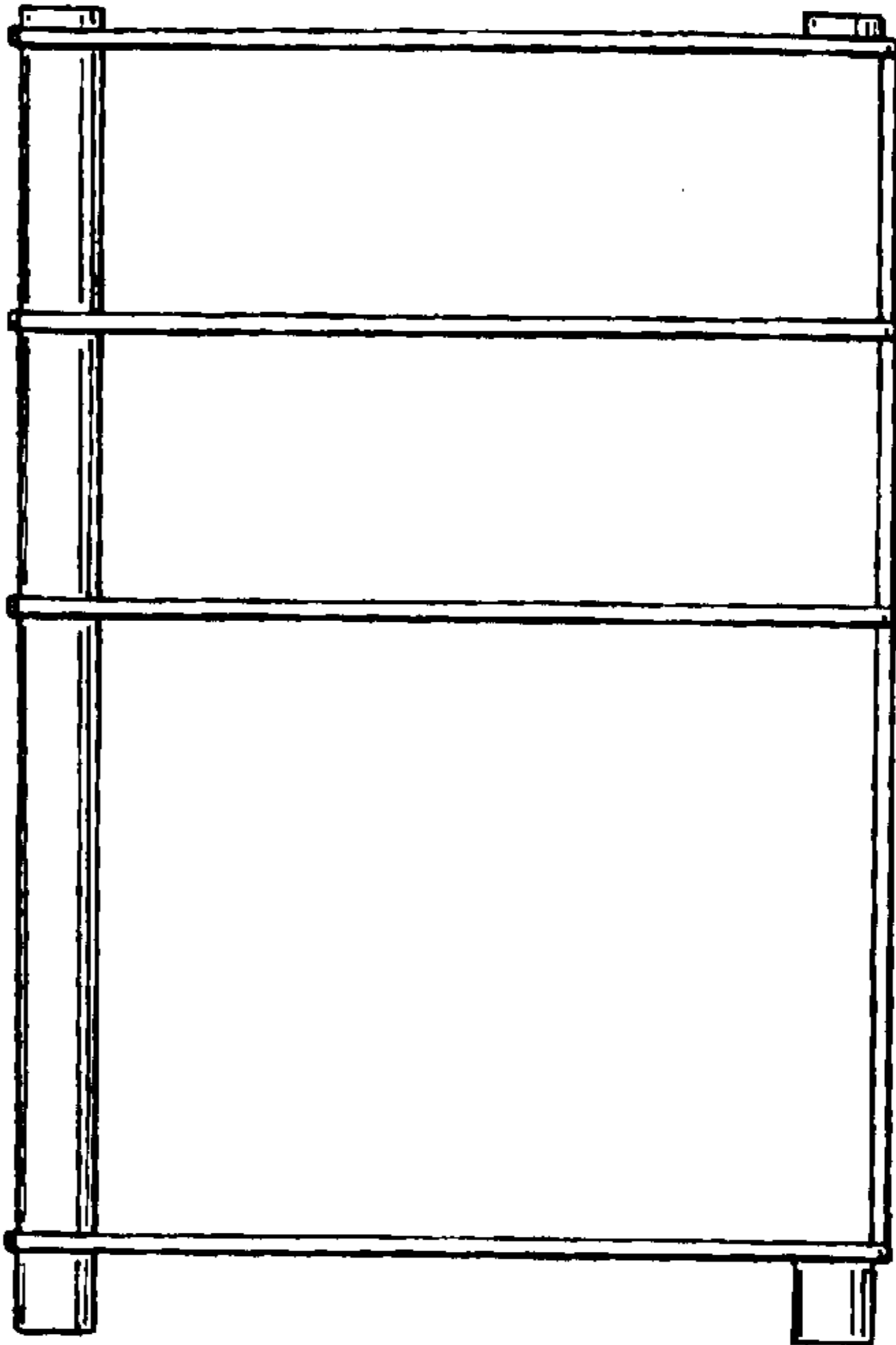

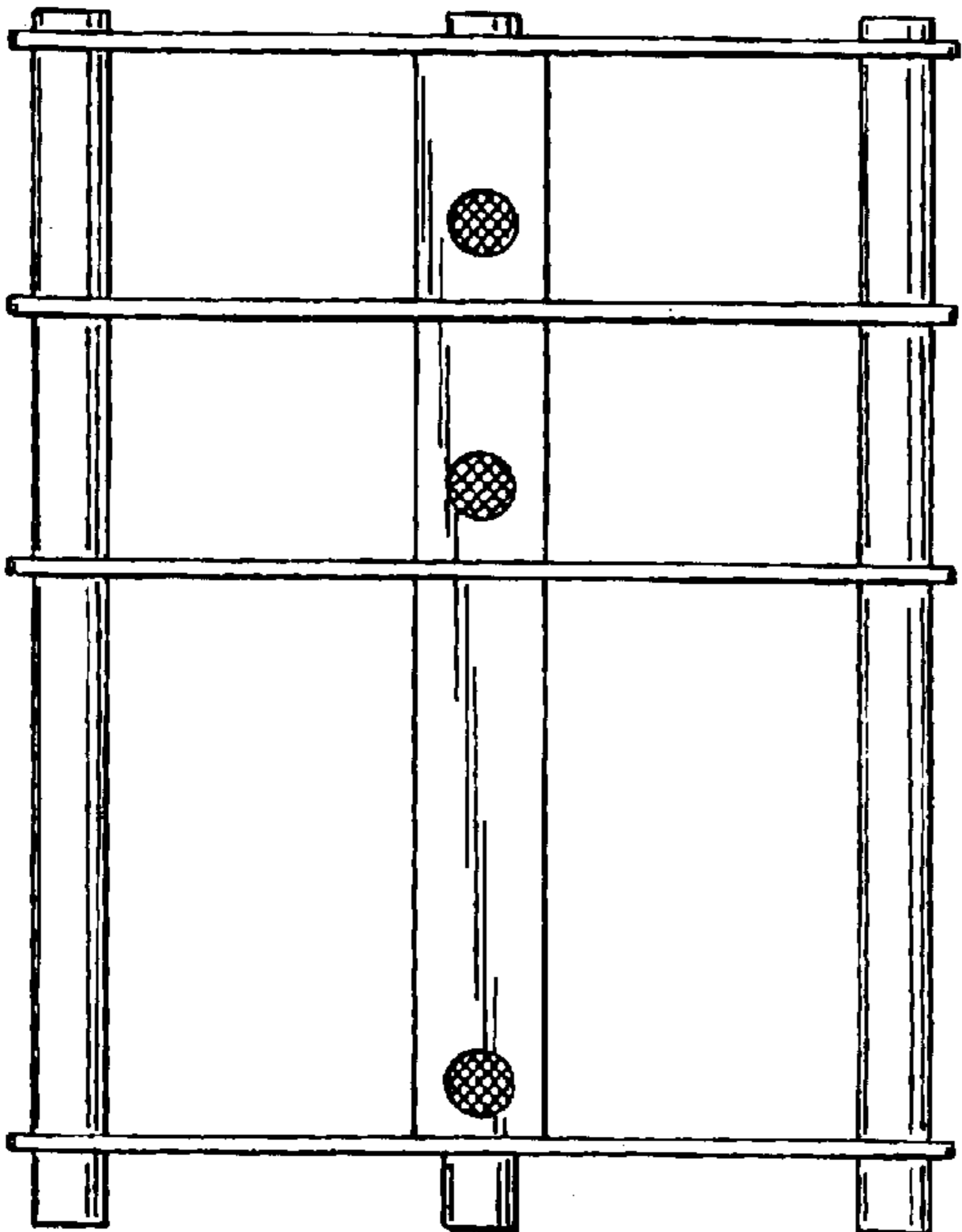

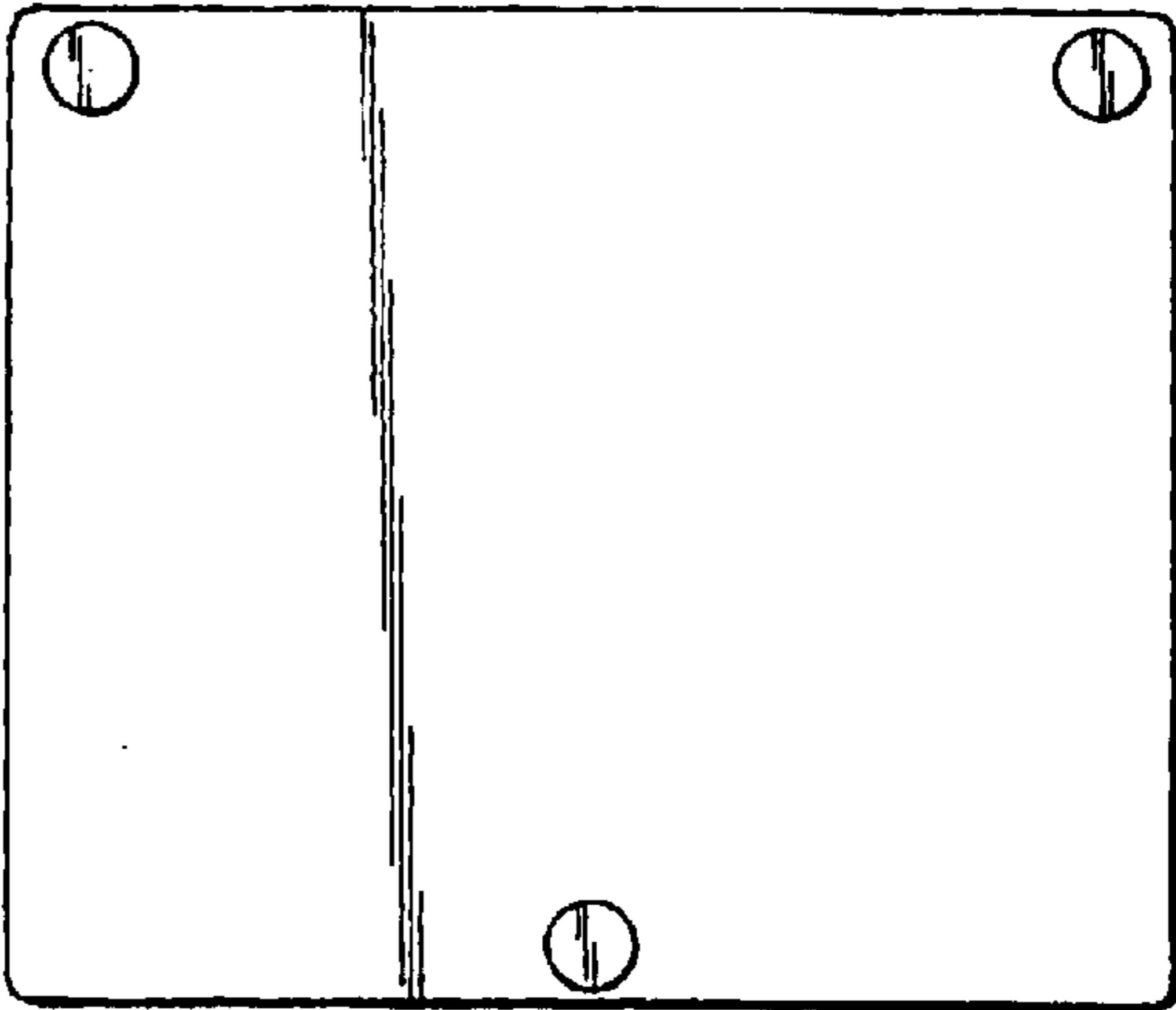

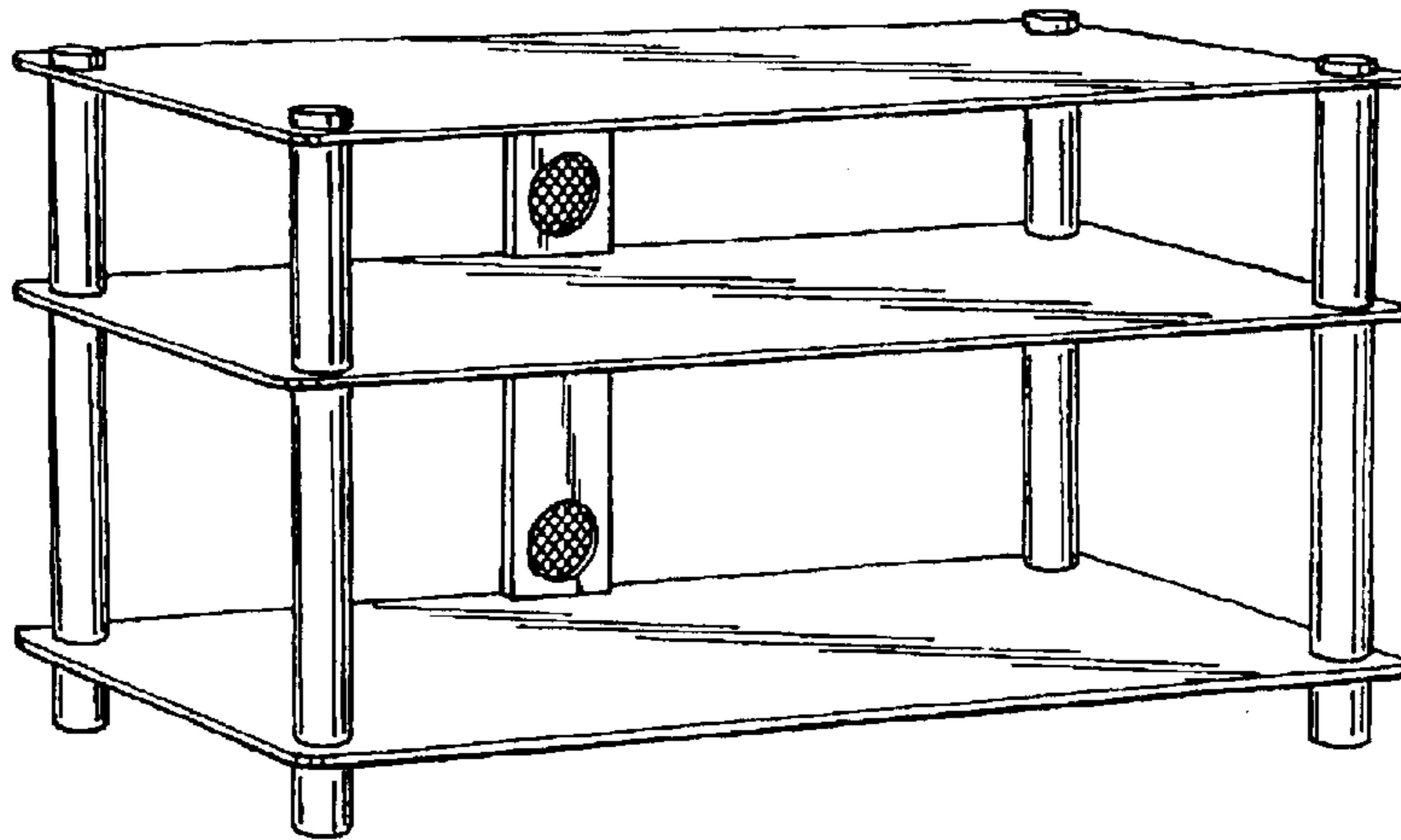

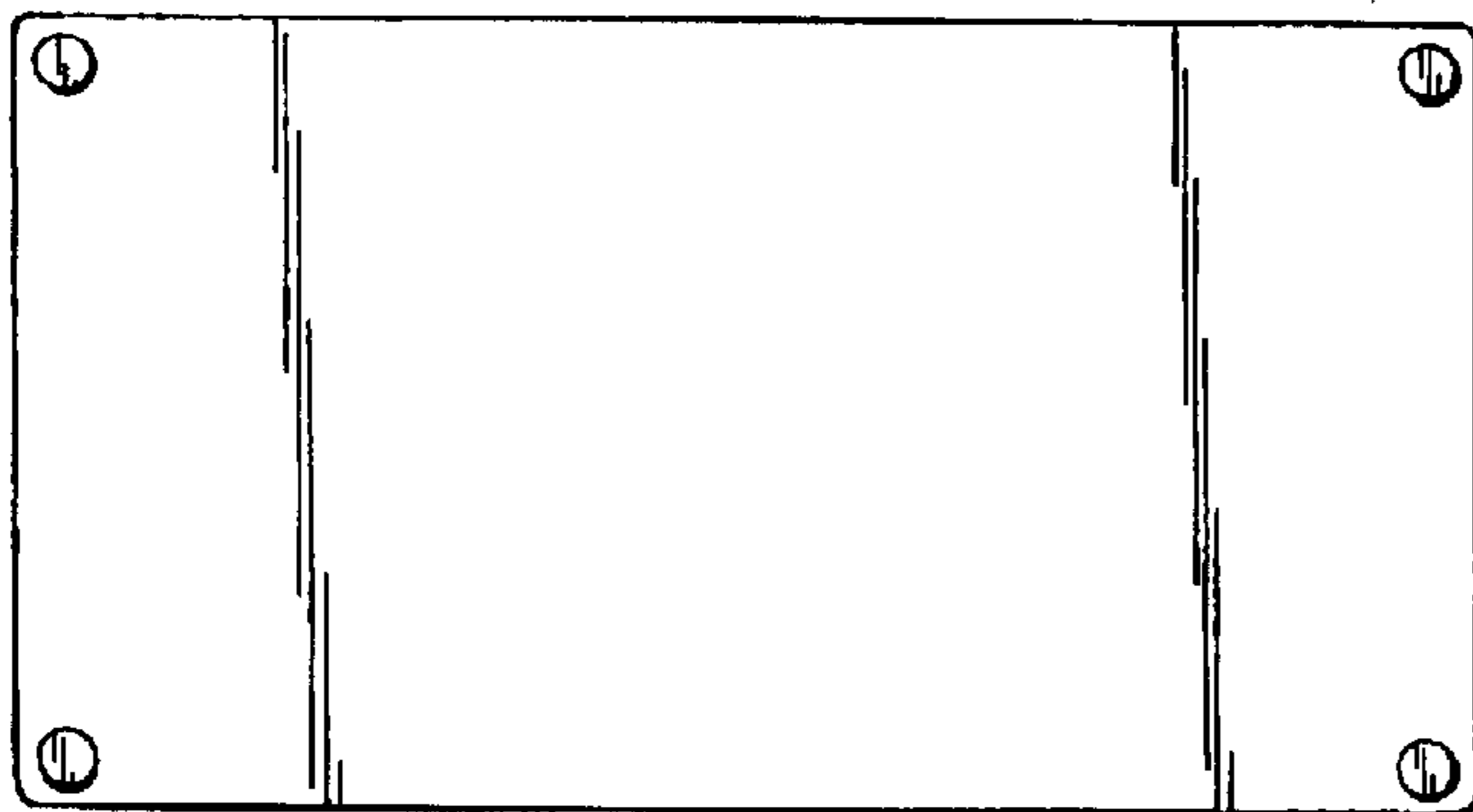

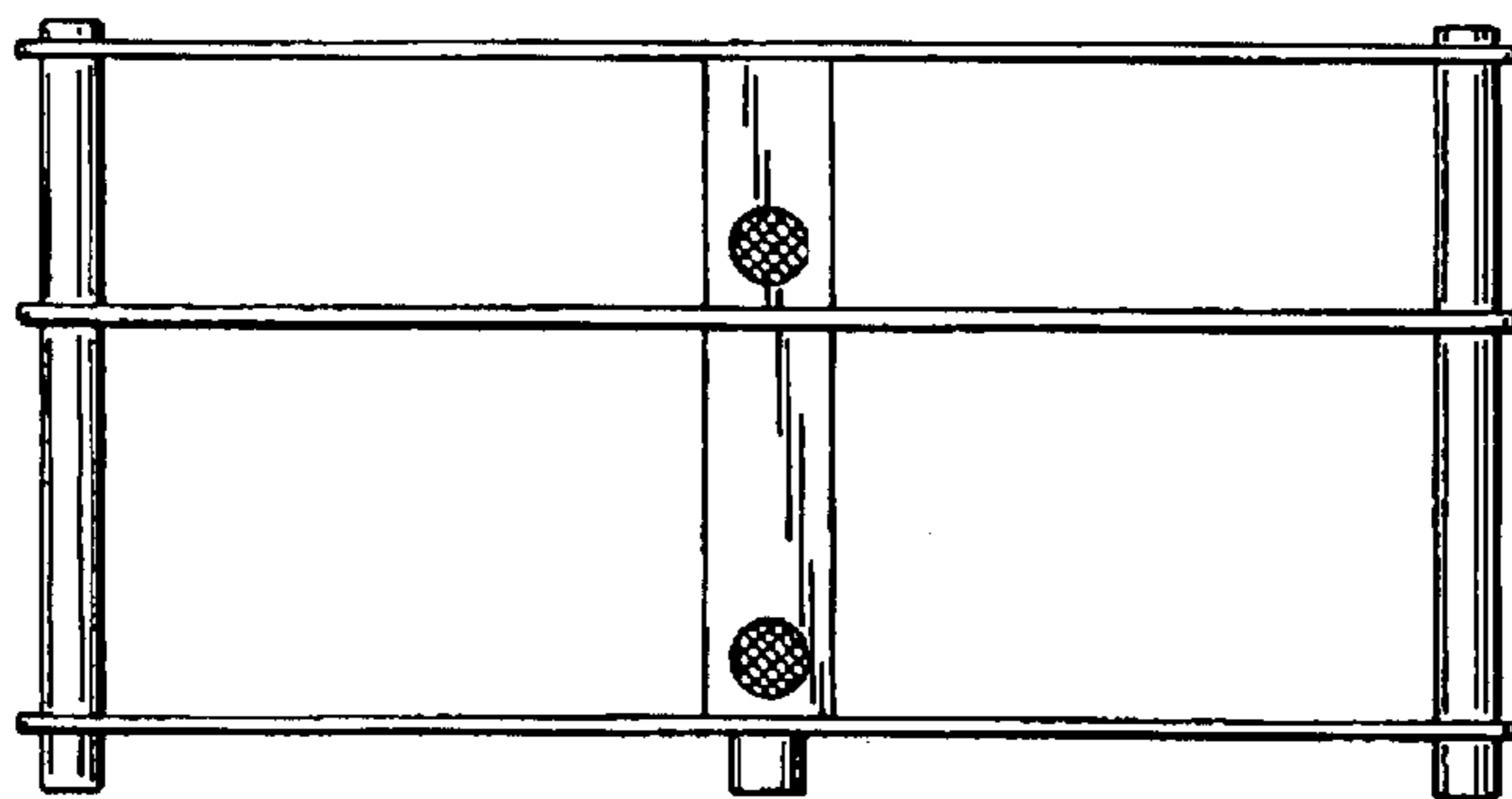

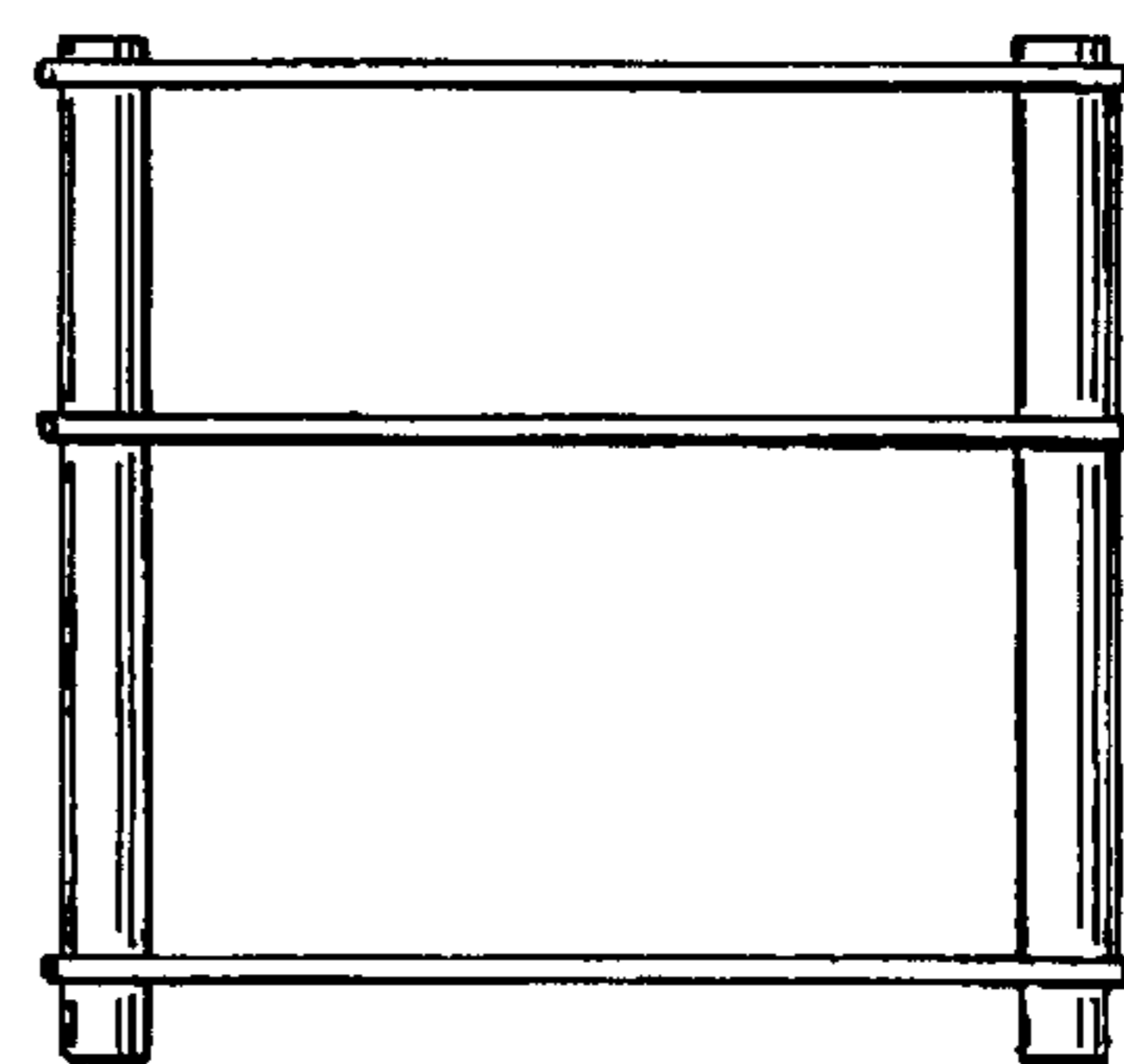

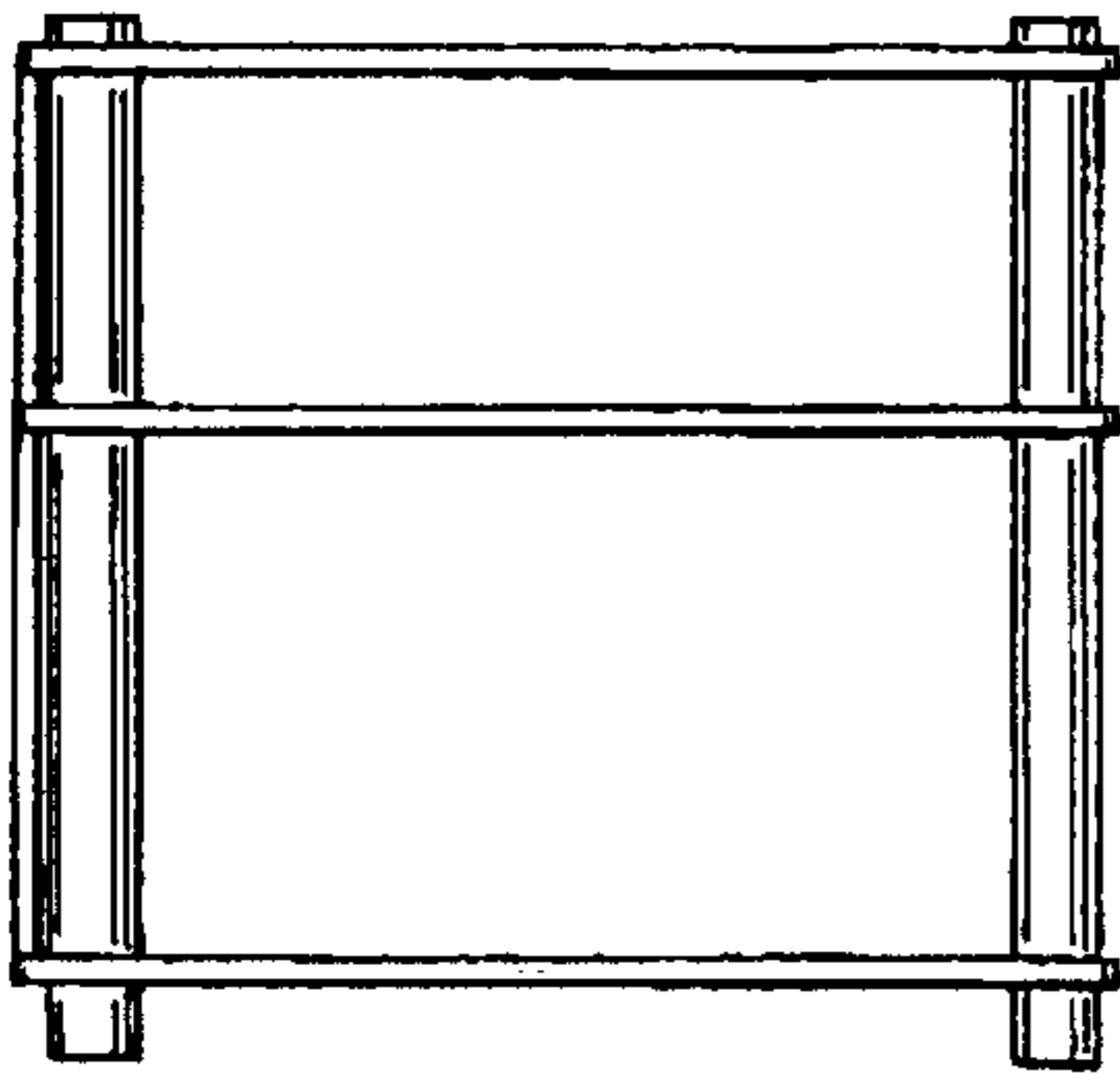

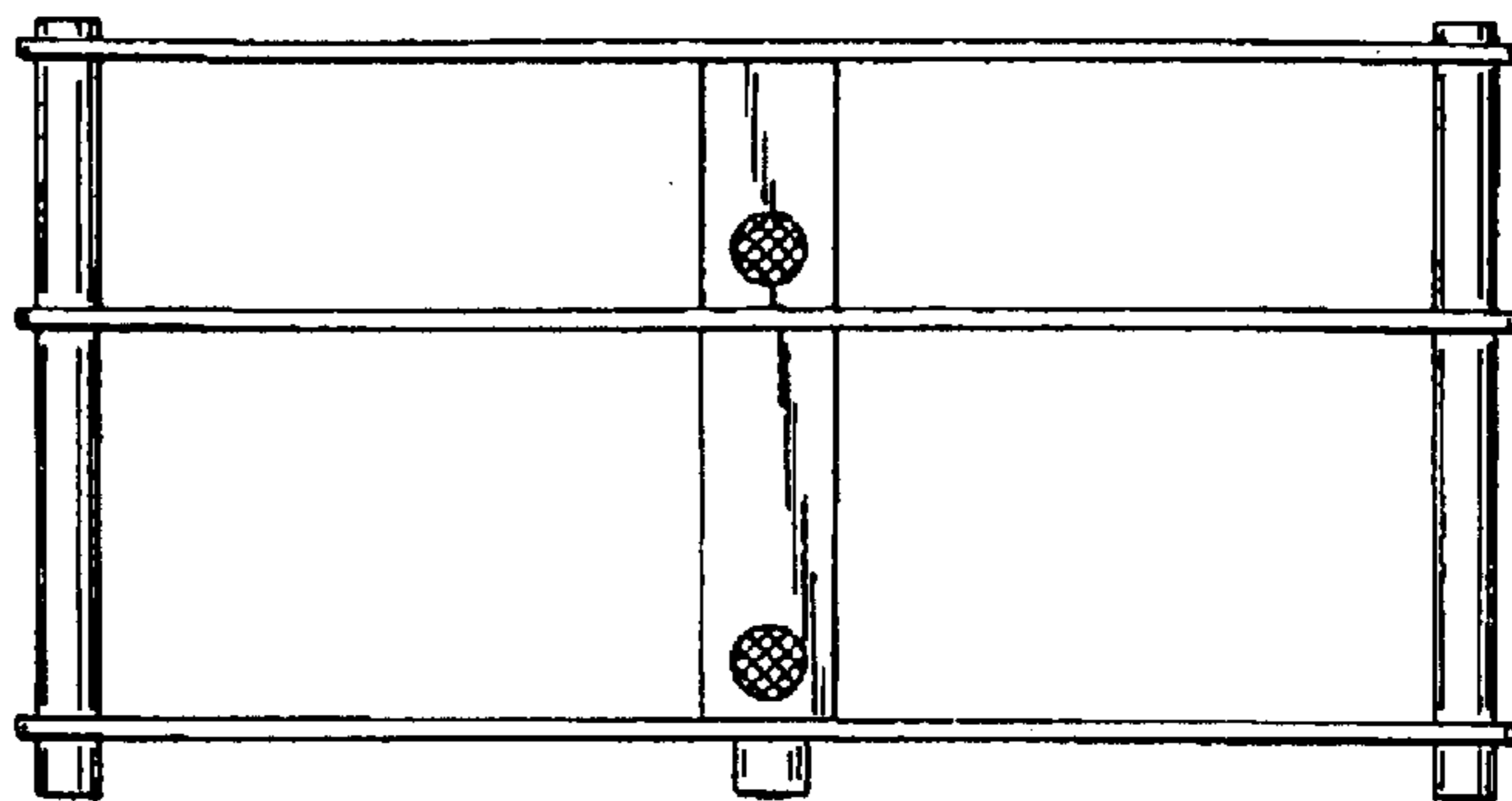

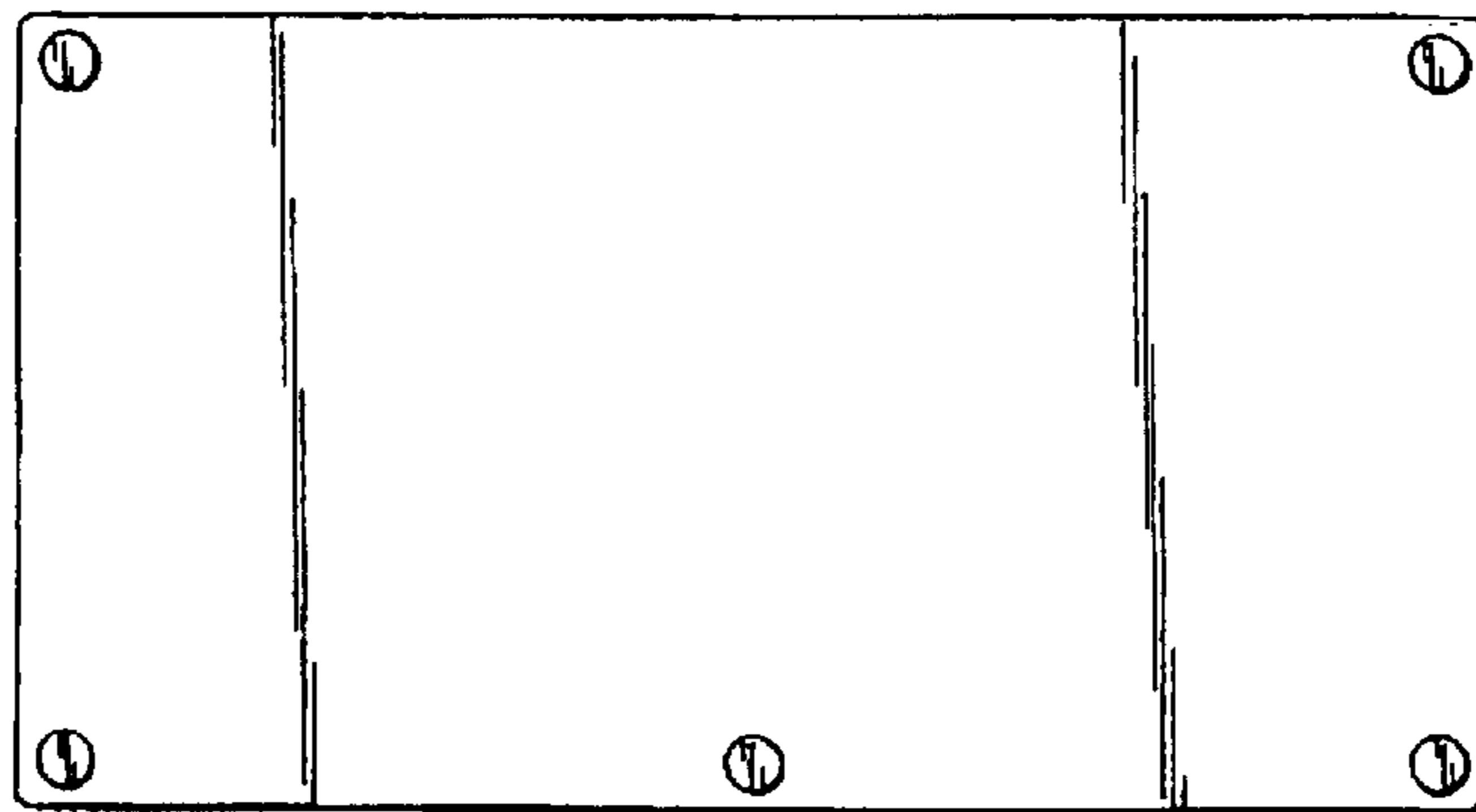
