(57) **CLAIM**

The ornamental design for storage container for recorded media, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the storage container for recorded media showing our new design, the storage container being in a closed configuration.

FIG. 2 is a perspective view of the storage container for recorded media showing our new design, the storage container being in an open configuration.

FIG. 3 is a front elevation view of FIG. 2.

FIG. 4 is a left side elevation view of FIG. 3.

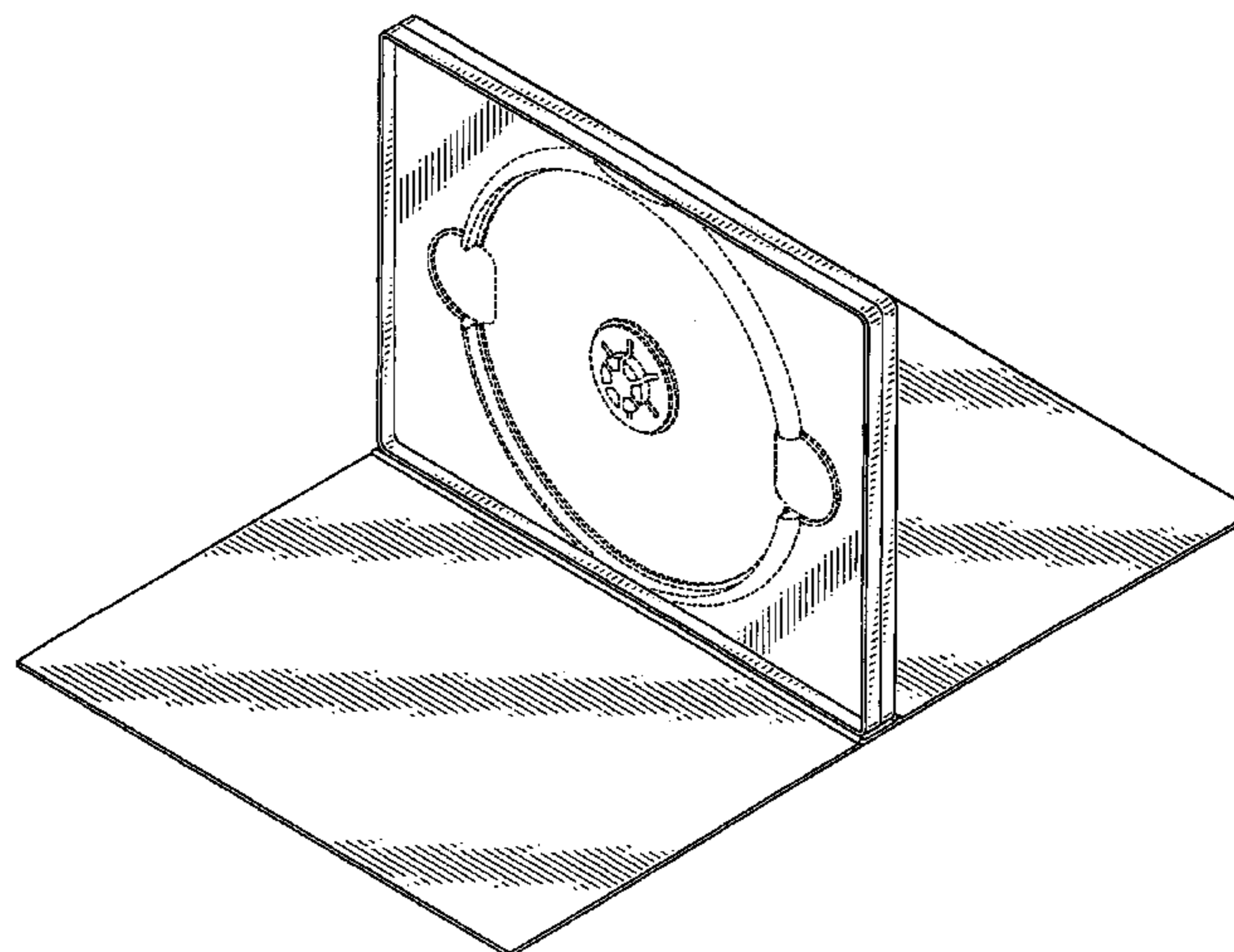
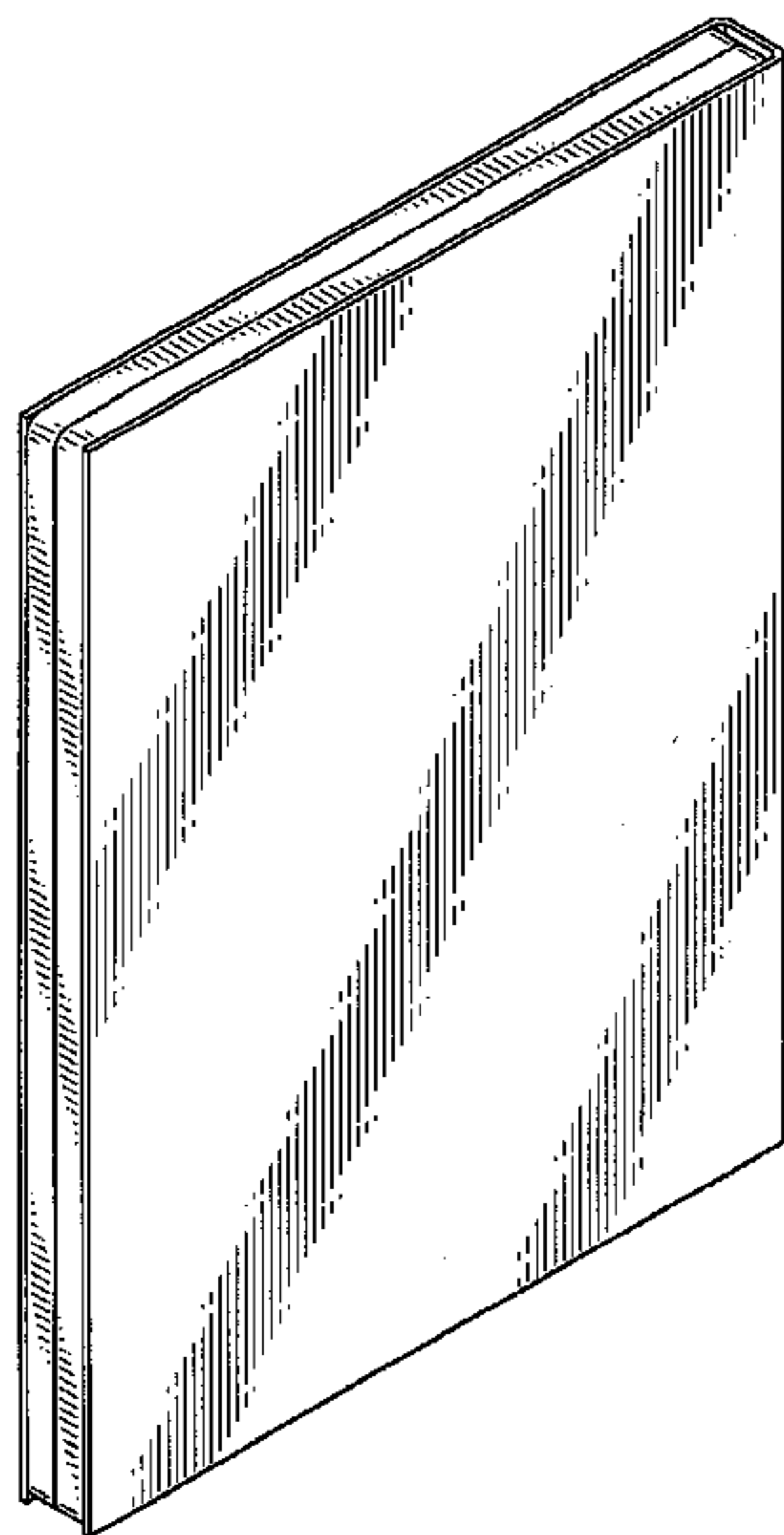
FIG. 5 is a top plan view of FIG. 3; and,

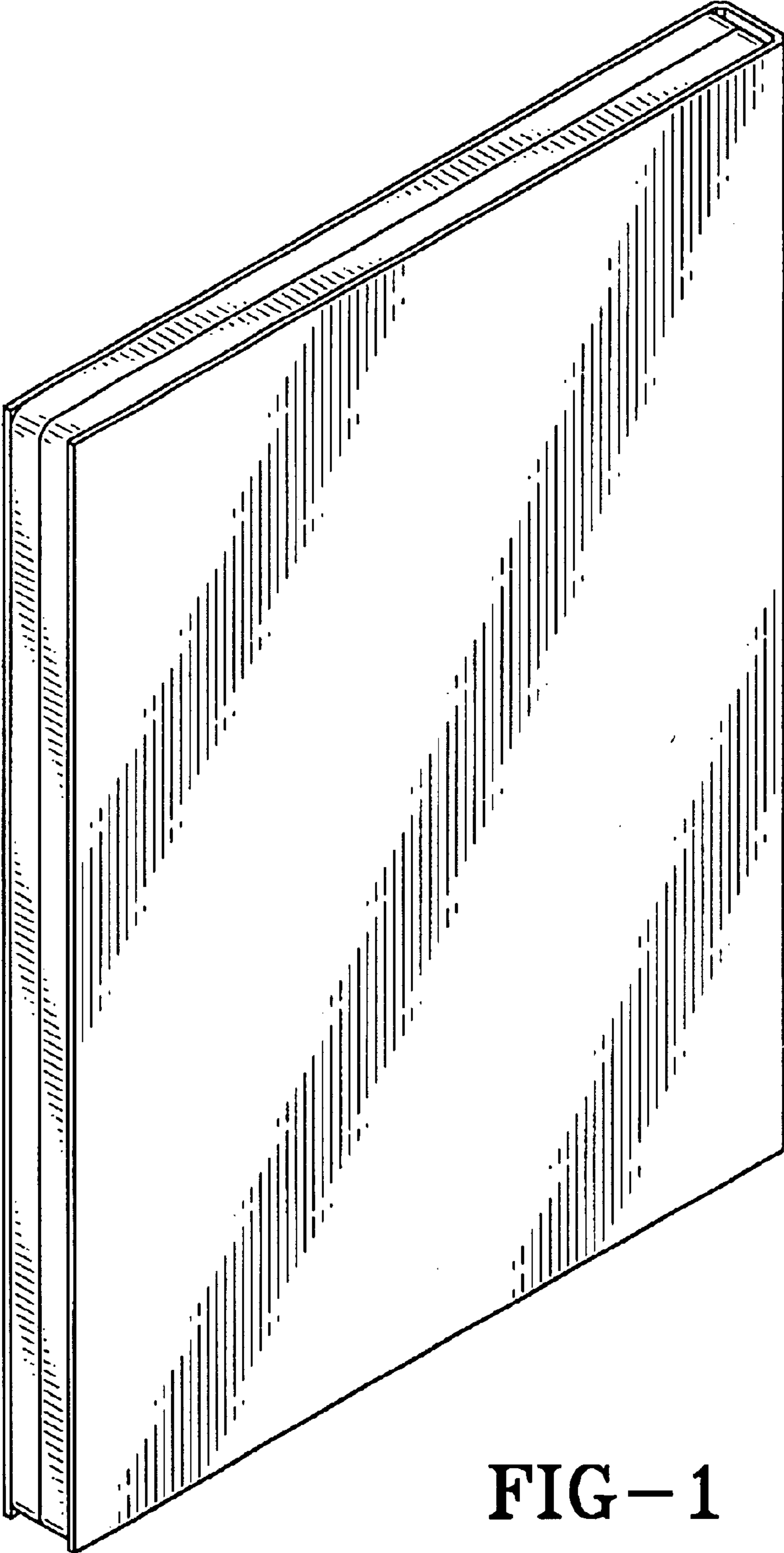

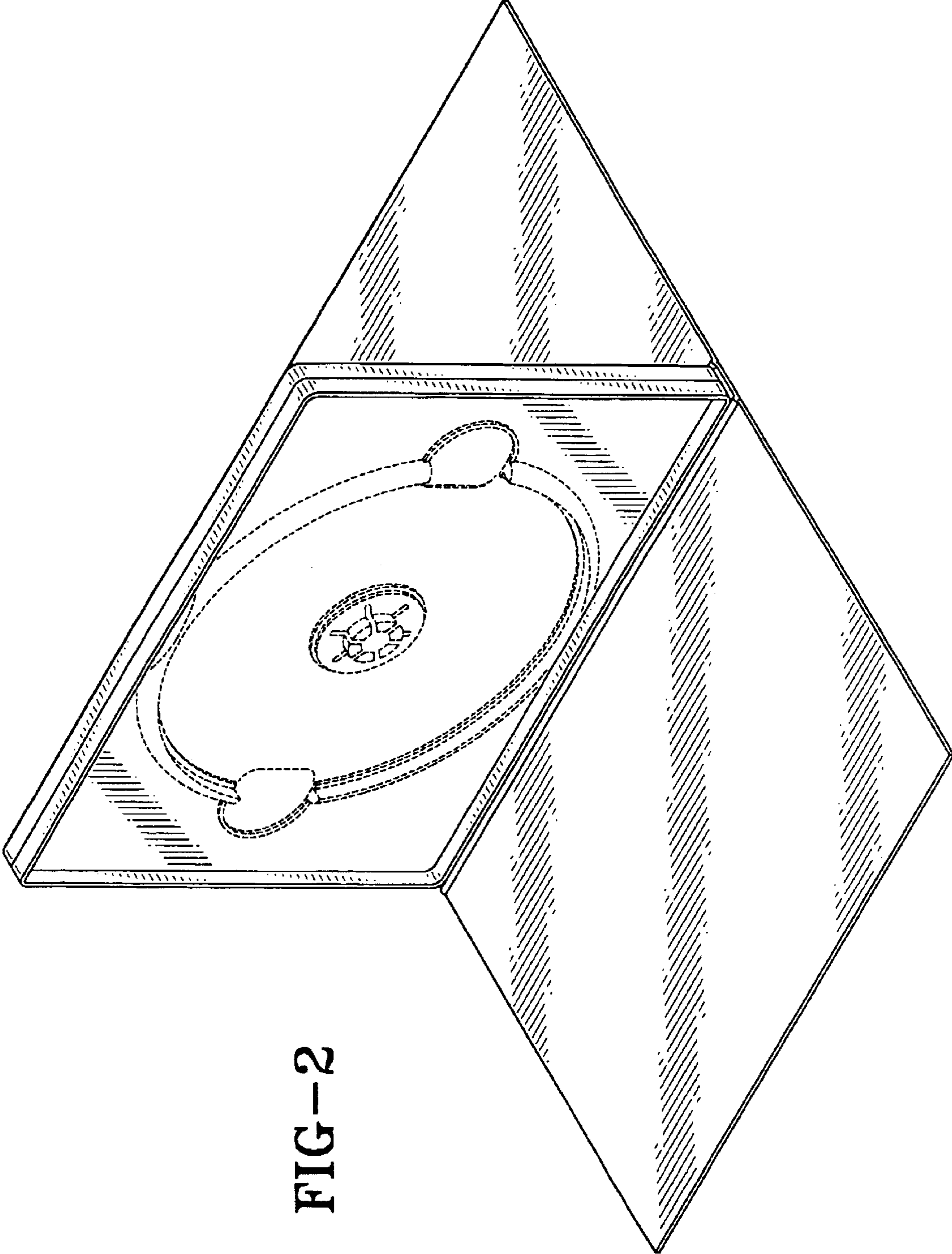

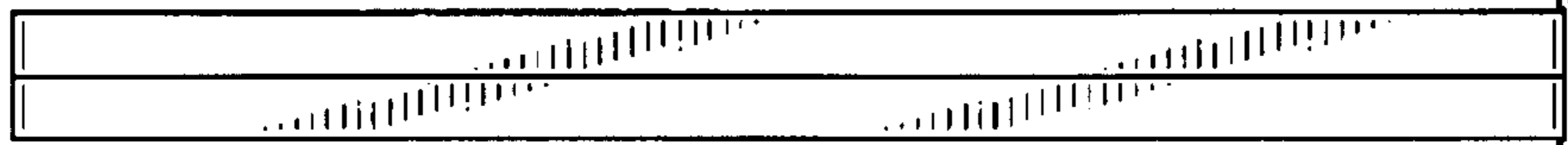

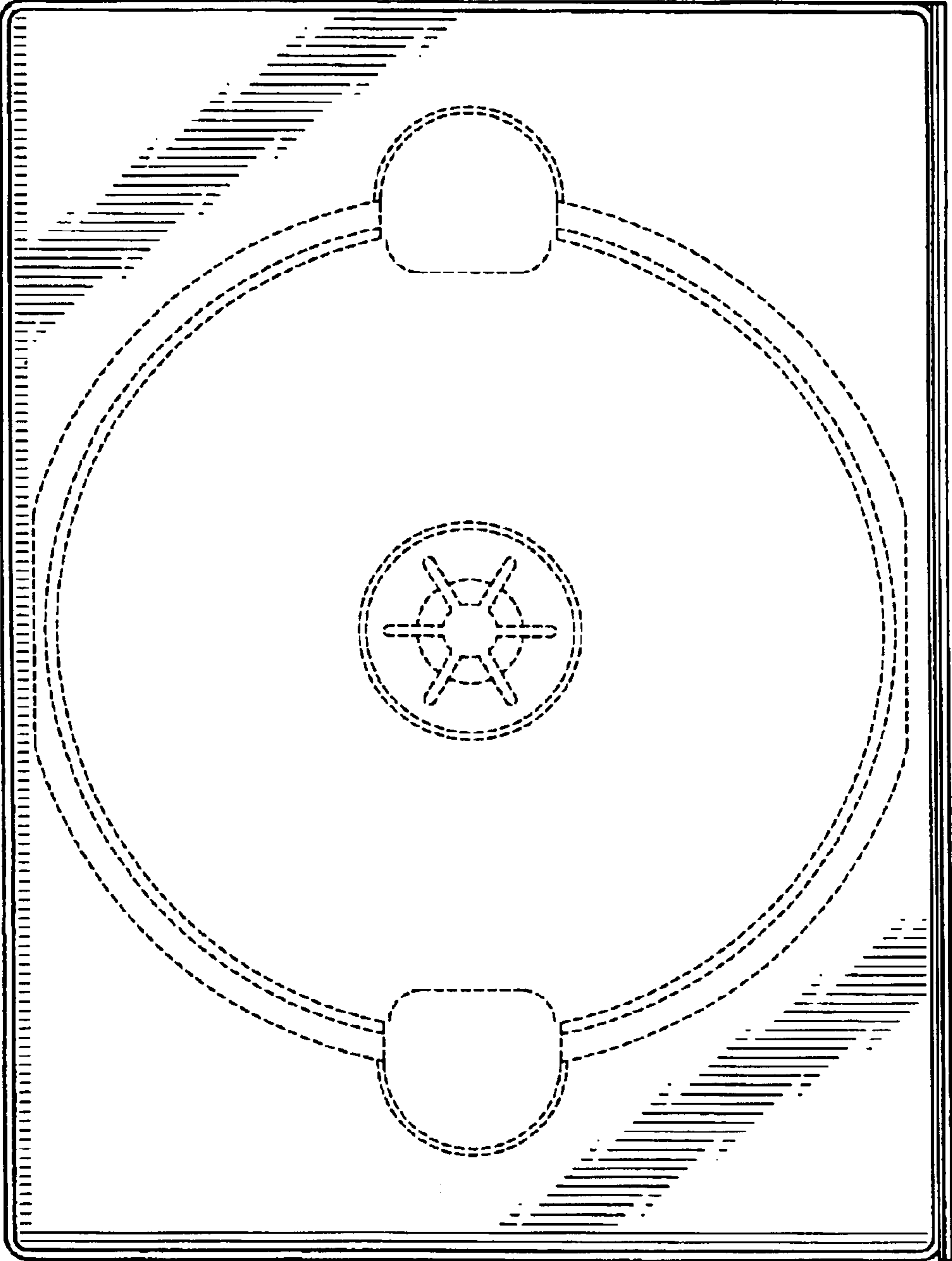

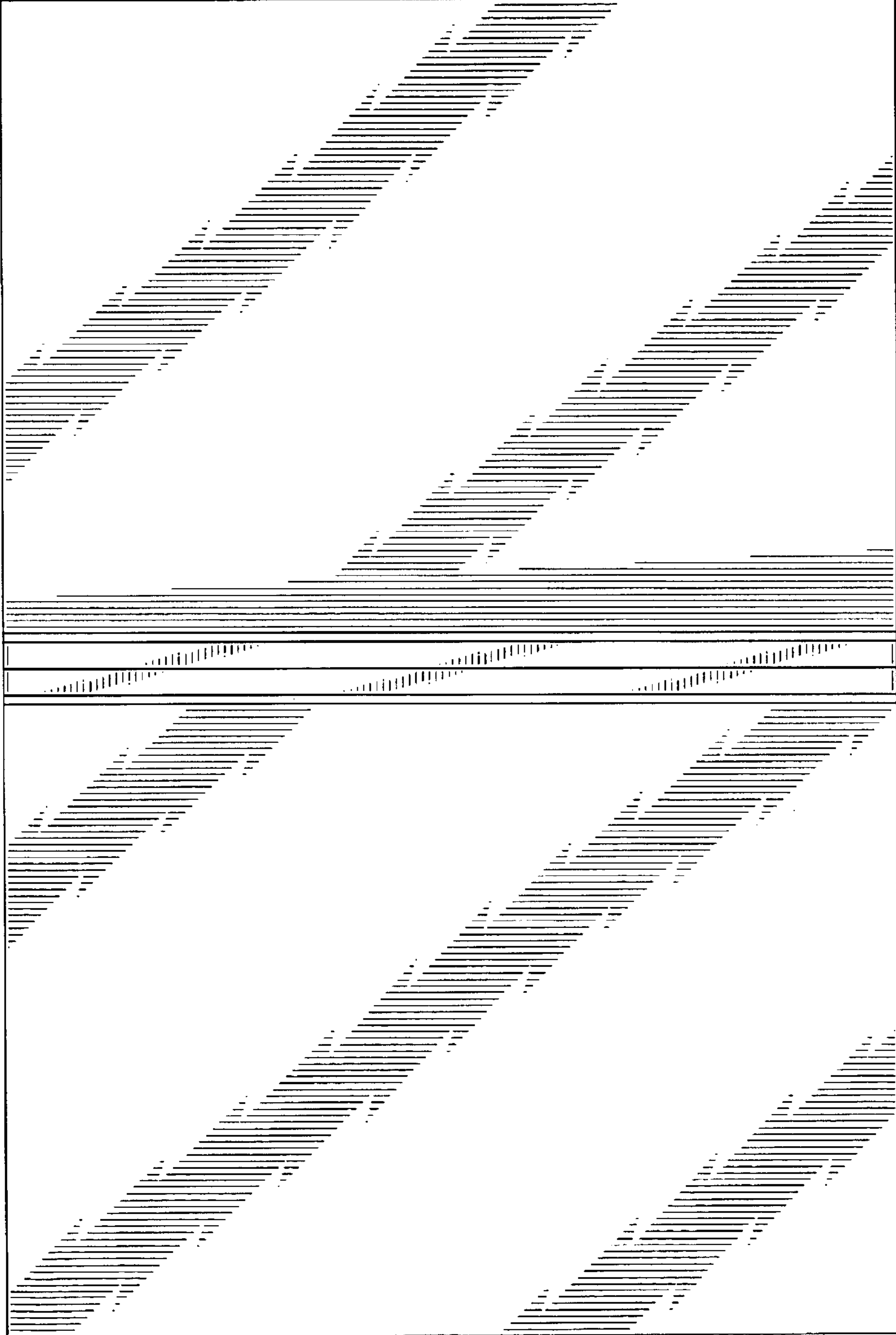

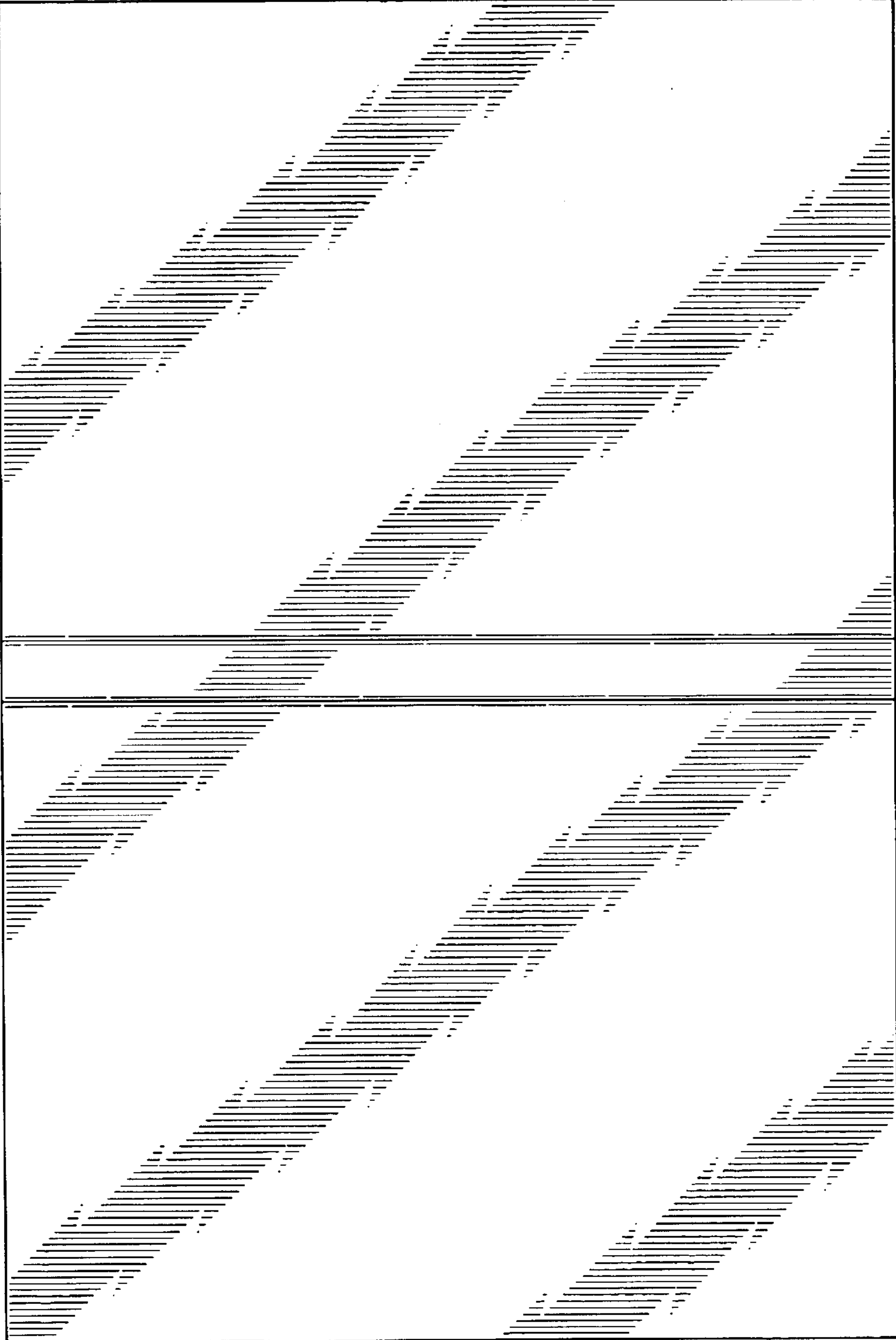
