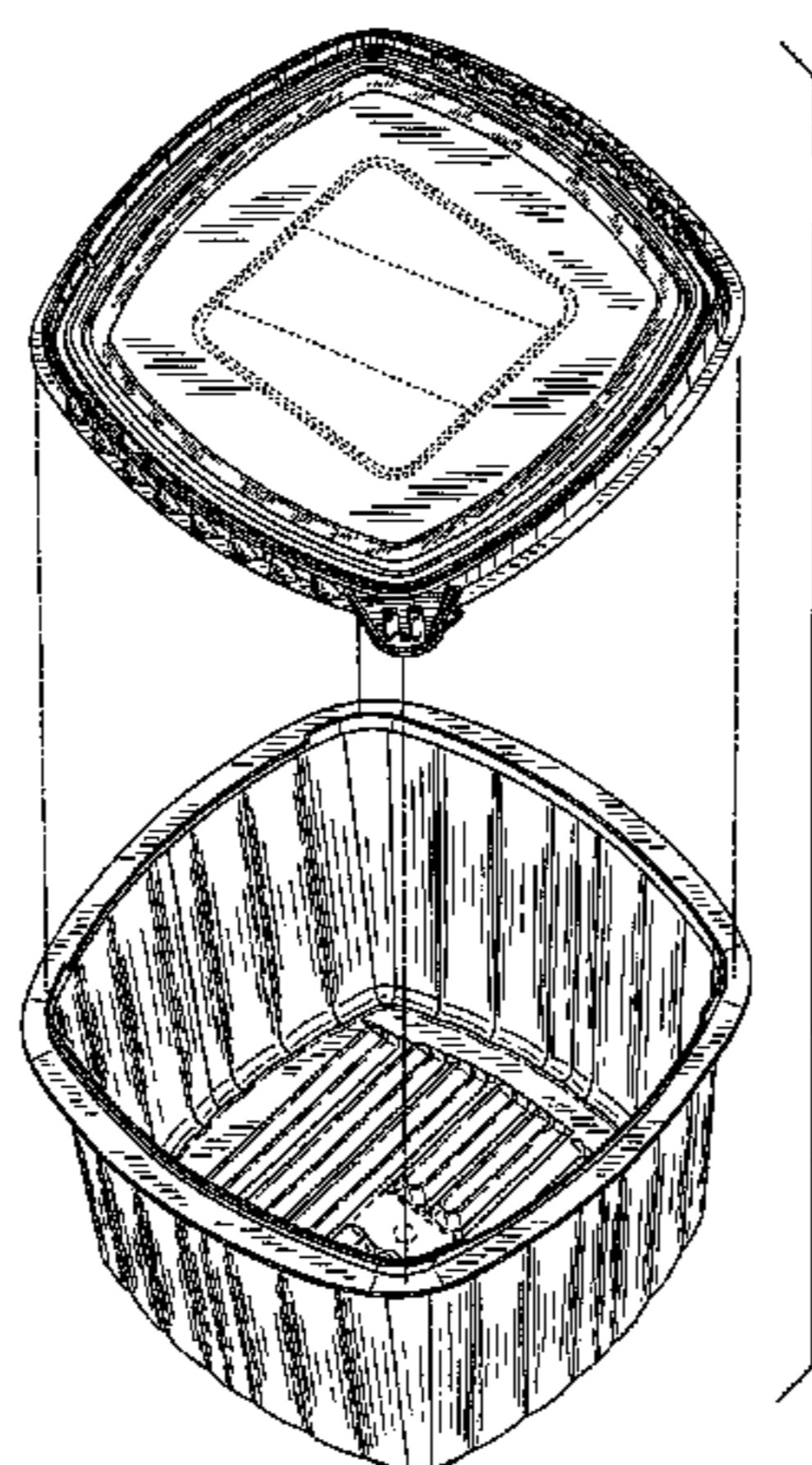

FIG. 6 is an exploded, perspective view of the container with a selectively vented lid, showing the lid spaced from the container.

Rear and left-side views of the container have been omitted, as these views are merely duplicative of the other views and are not necessary for a complete understanding of the design.

The portions of the drawing figures shown in broken lines form no part of the claim. Moreover, no claim is made to the color, clarity, or surface finish of the container.

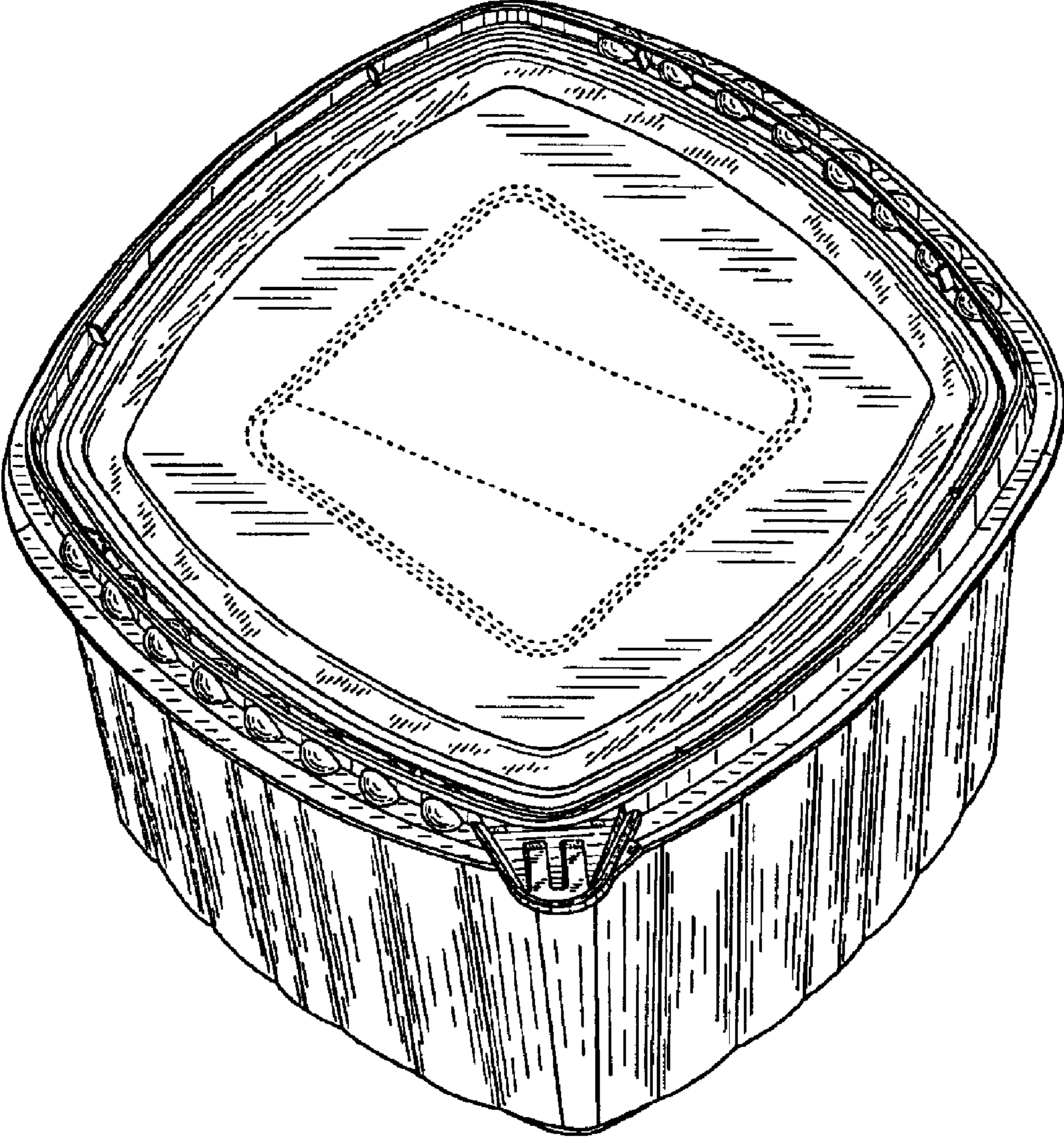

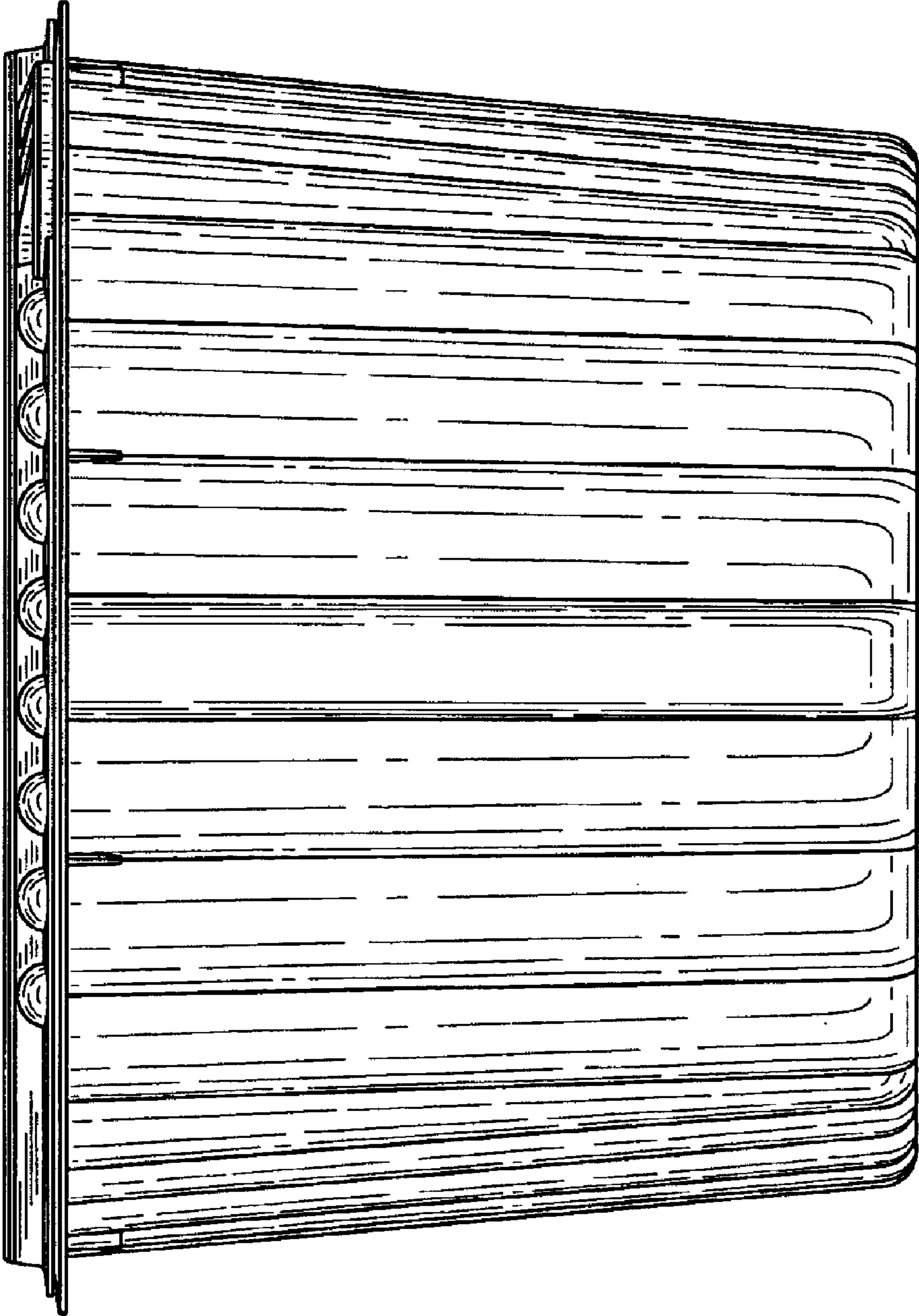

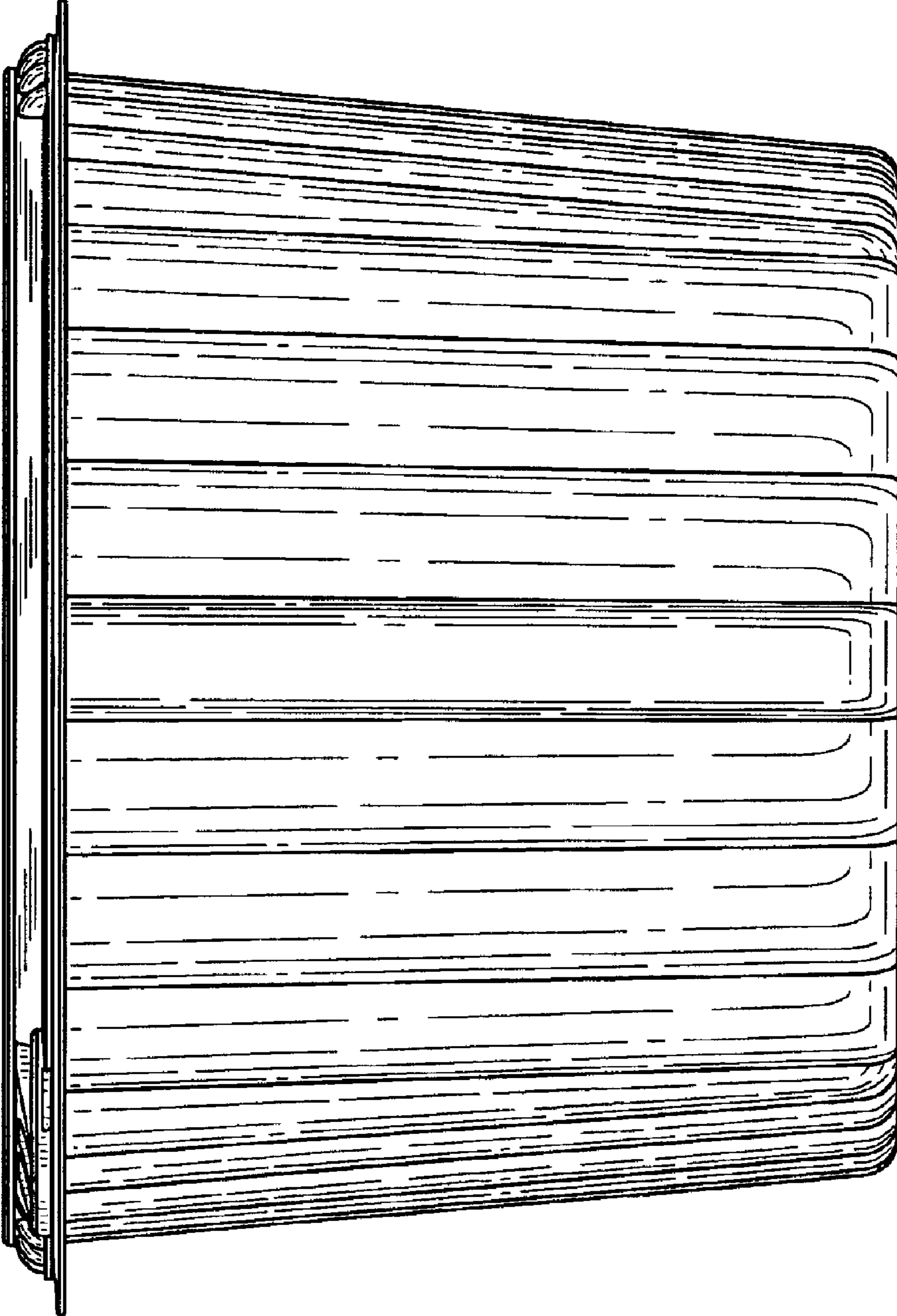

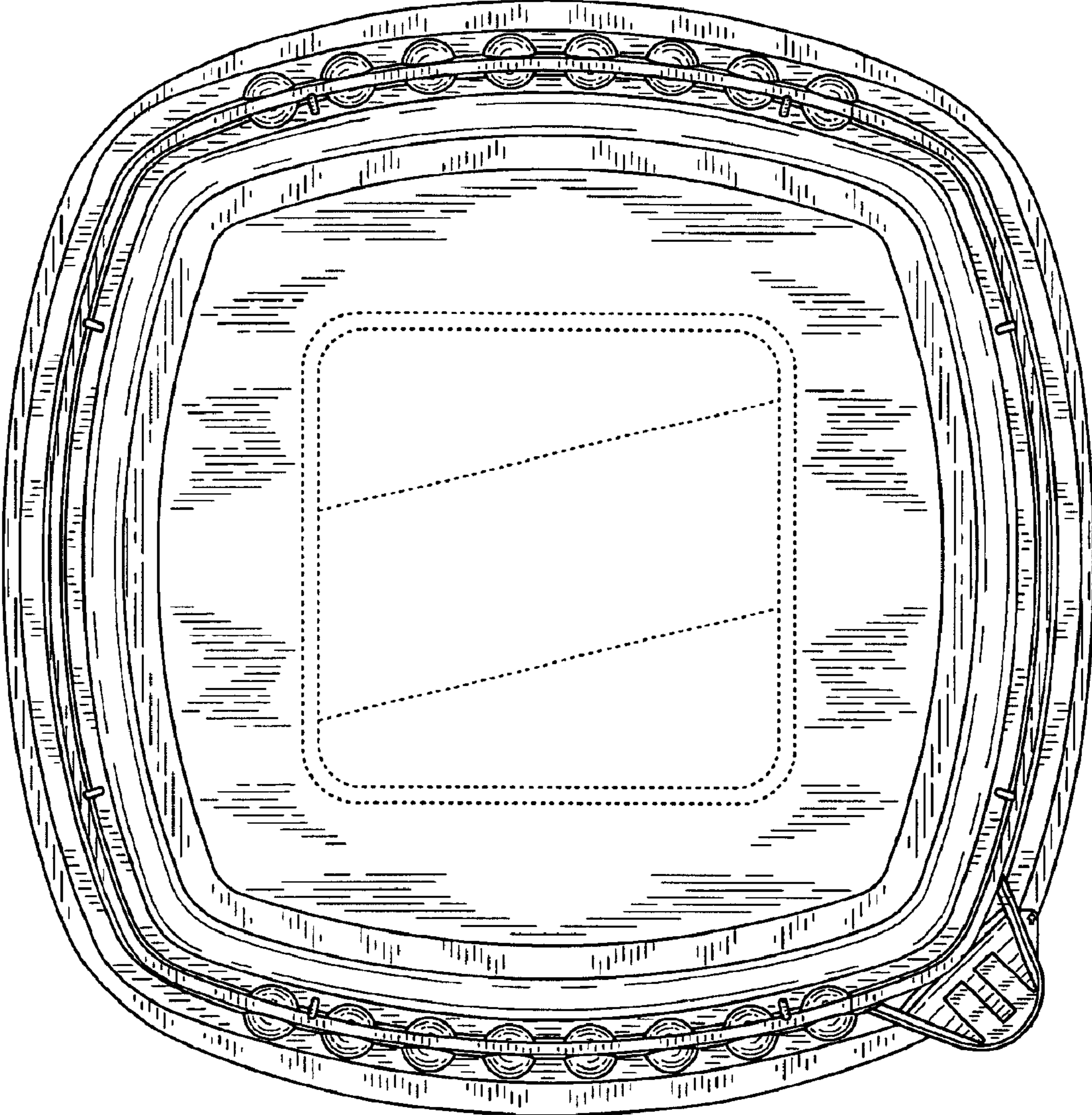

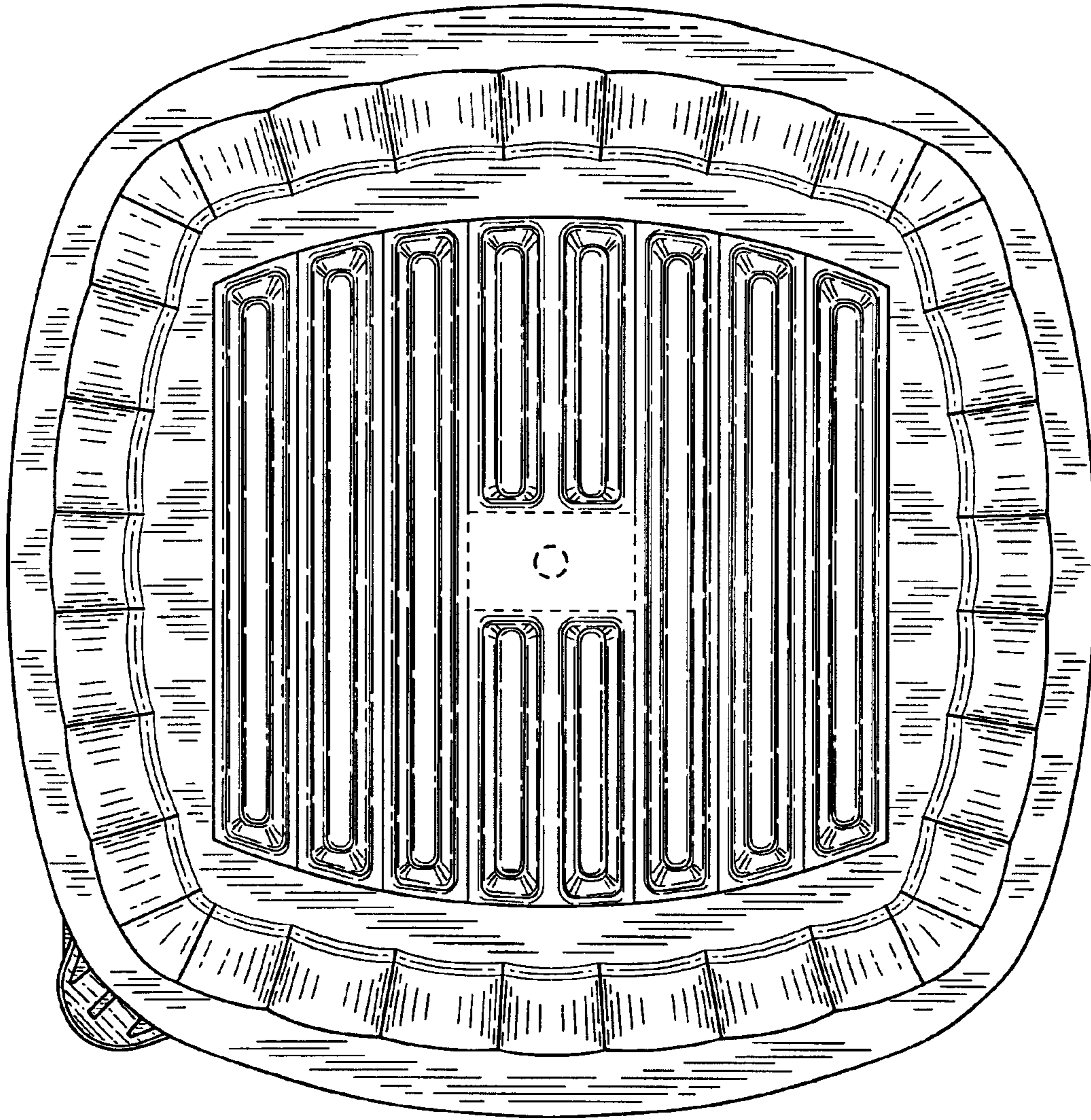

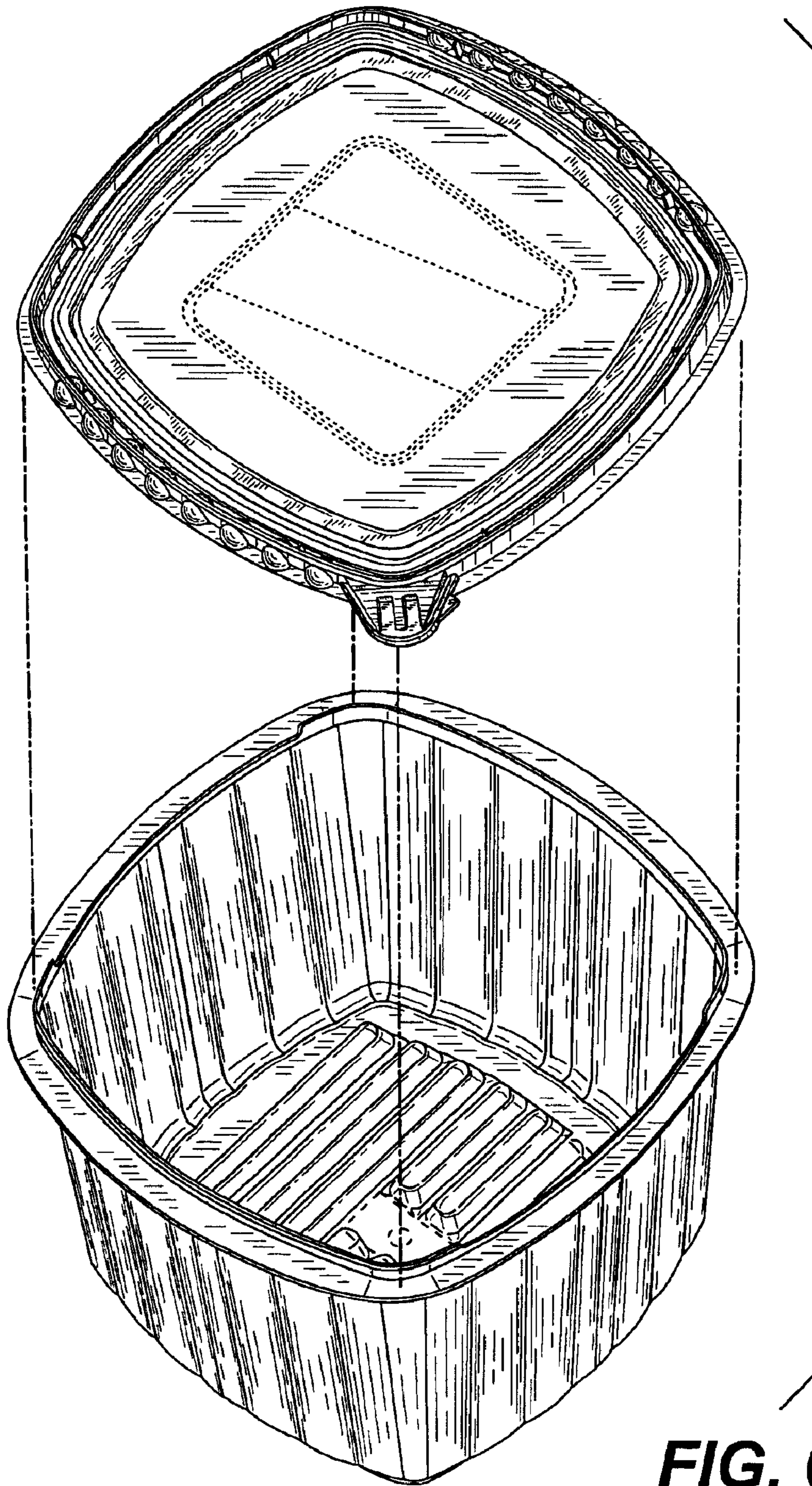
