FIG. 1 is a front view of a periphery of cap for a tubular dispenser according to the present invention;

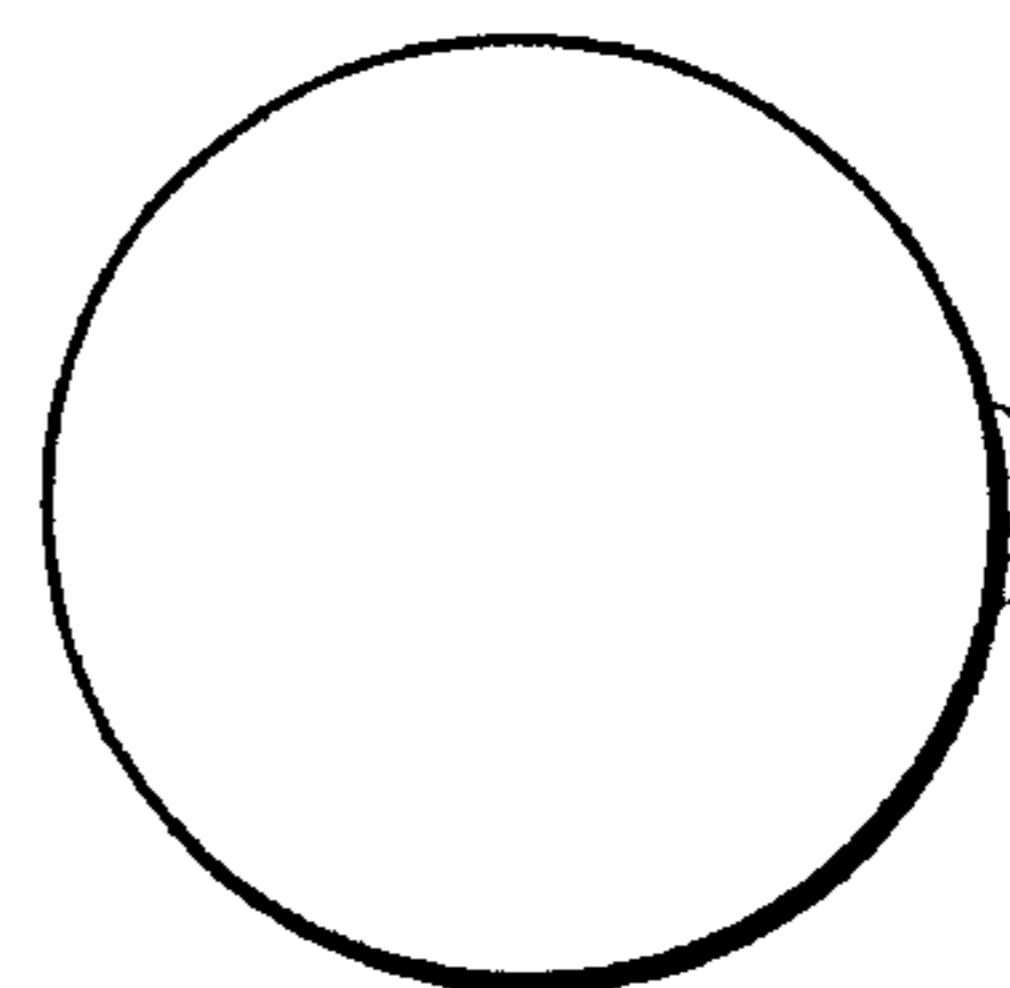
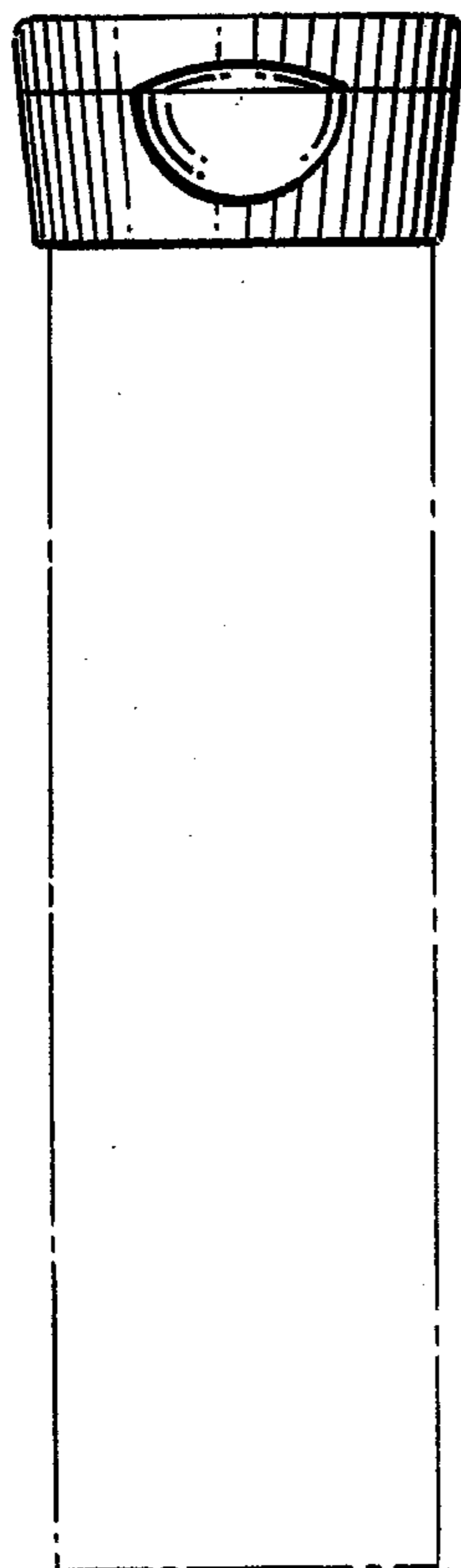
FIG. 2 is a side view of the cap of FIG. 1;

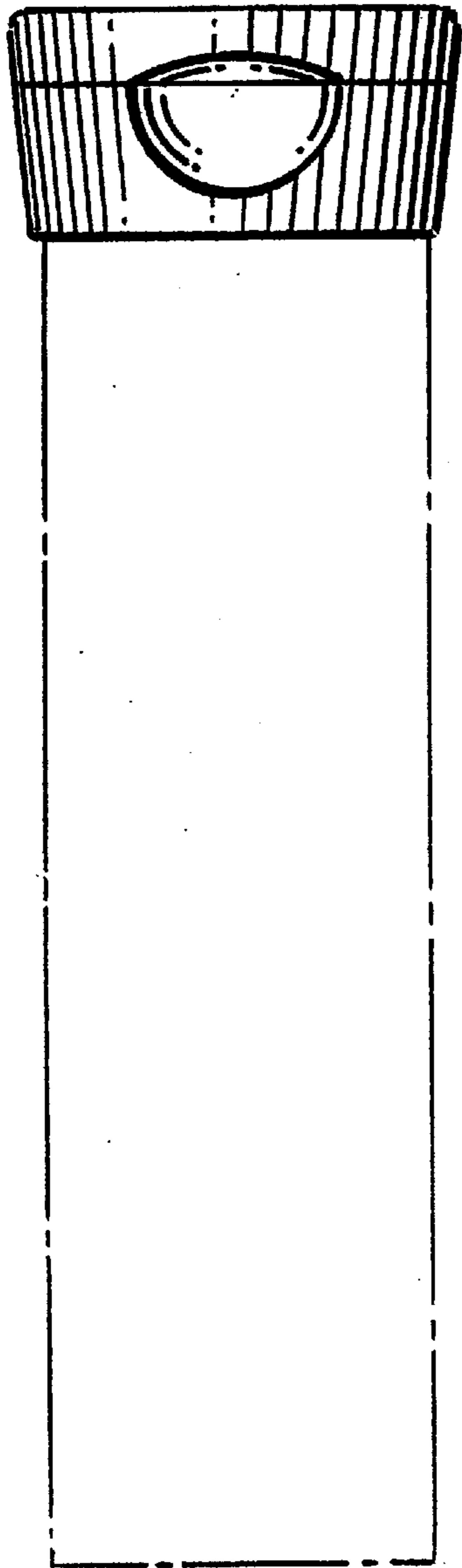

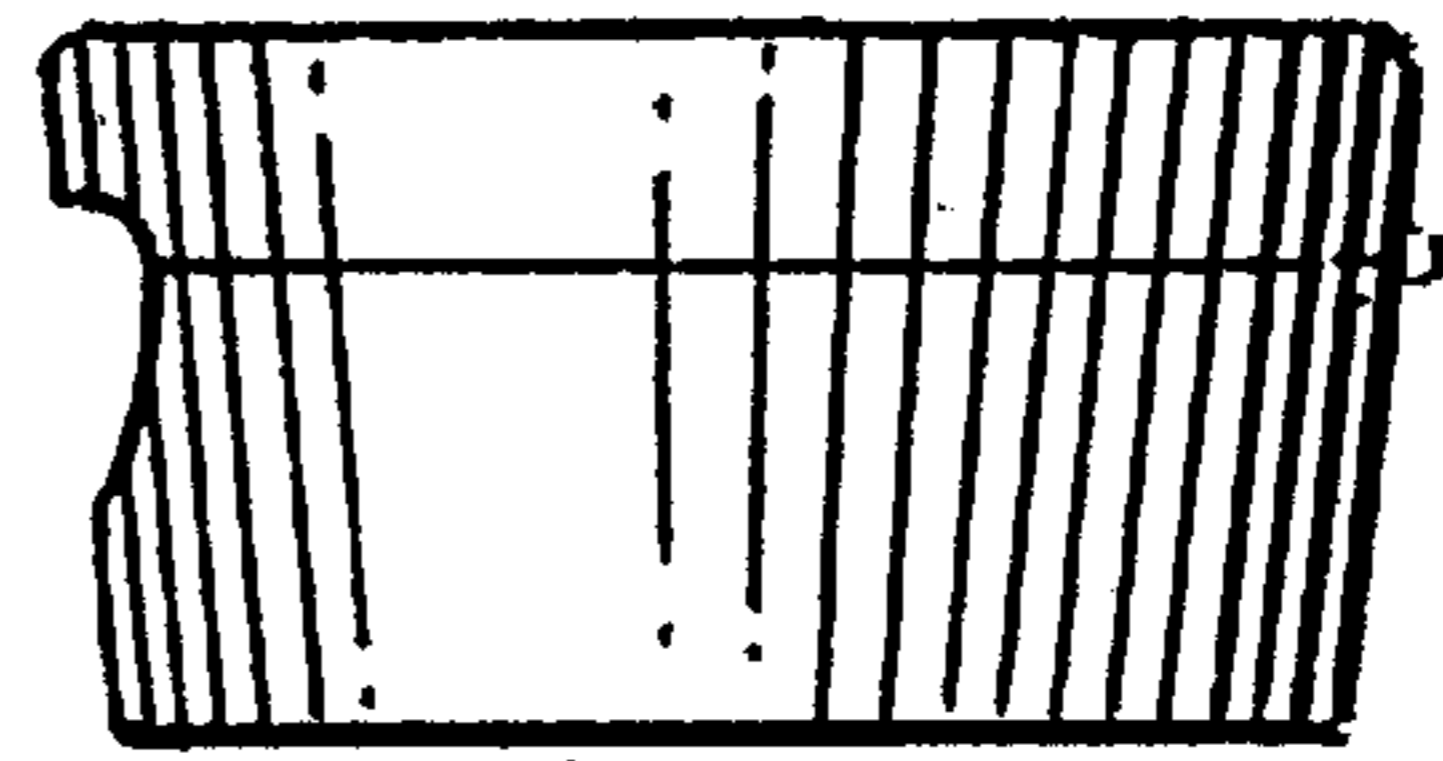

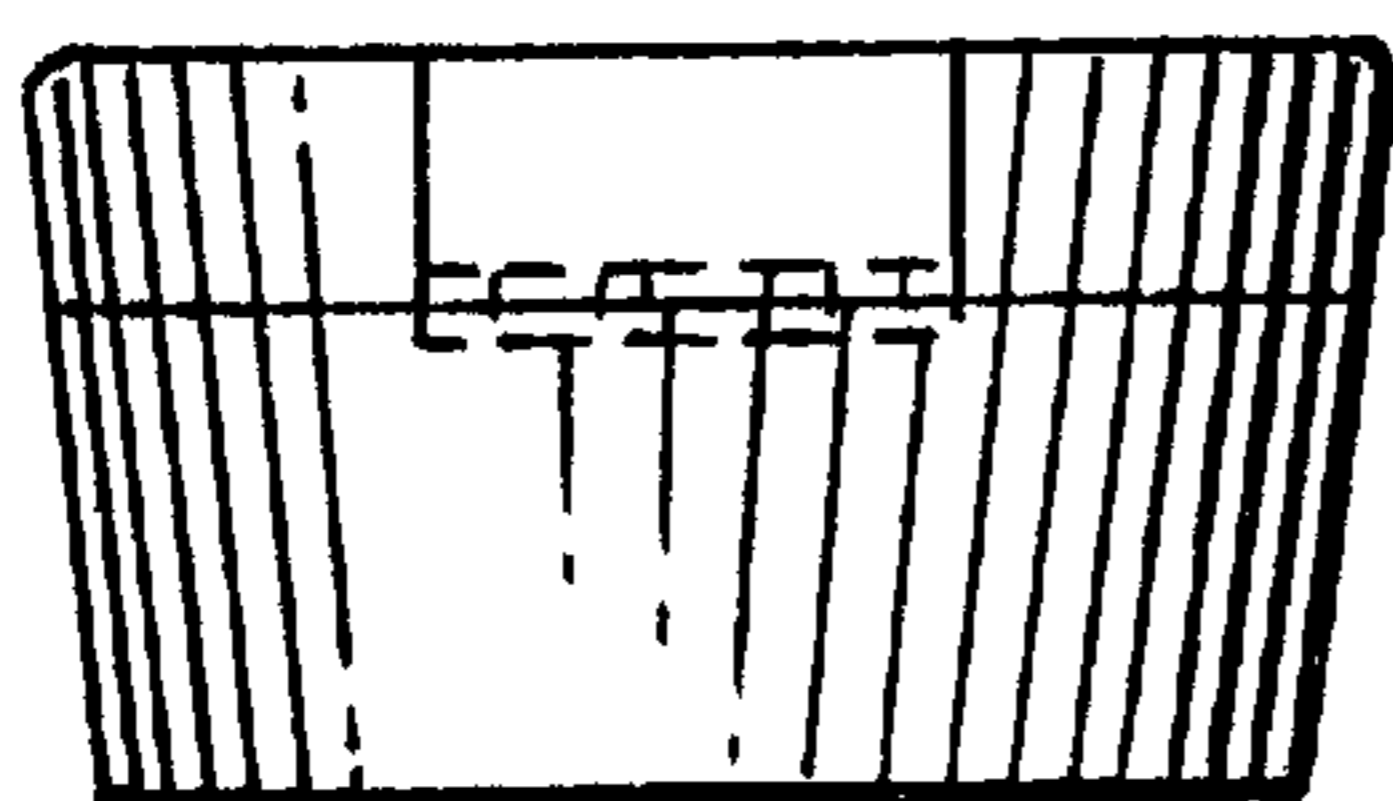
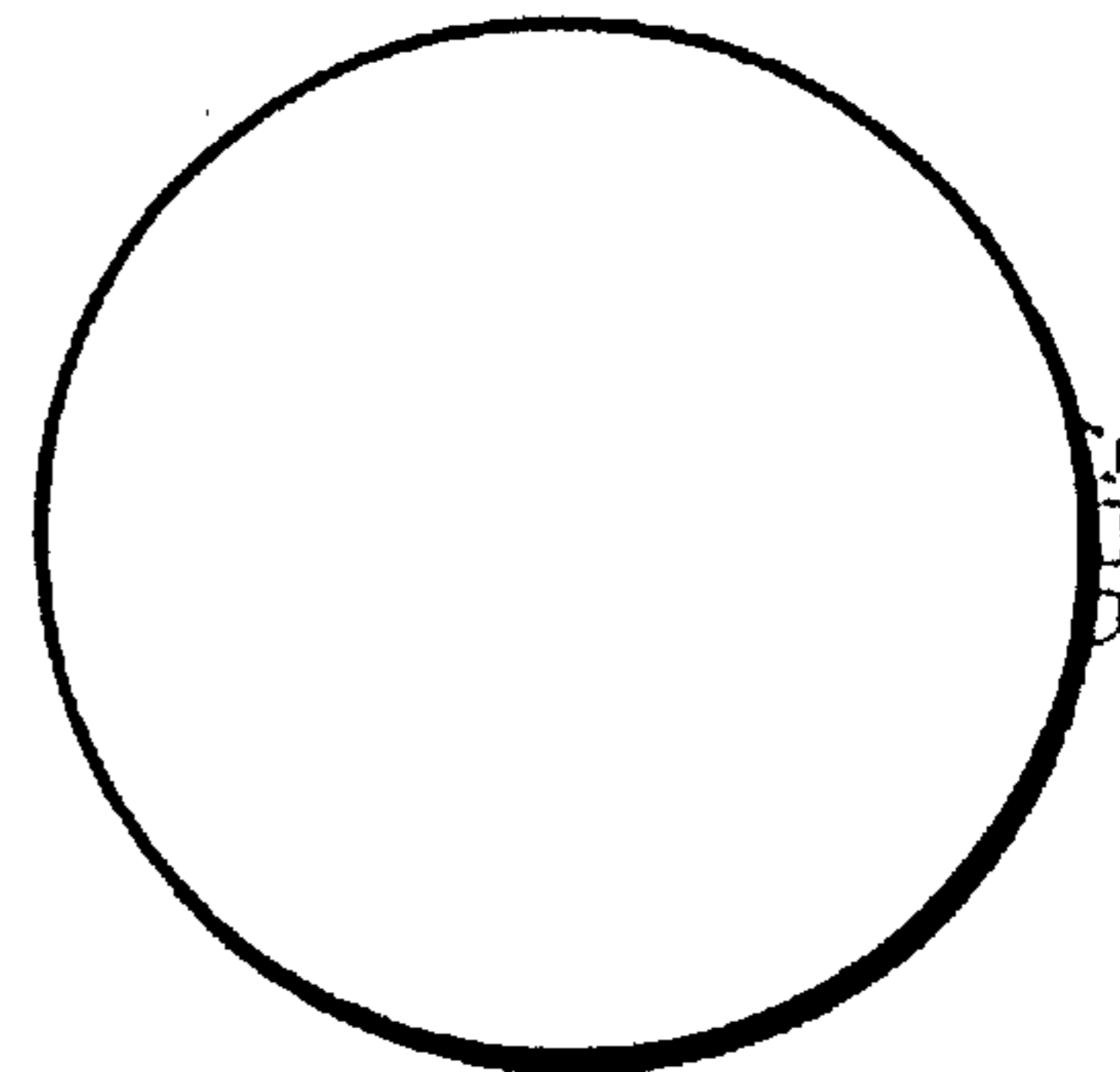
