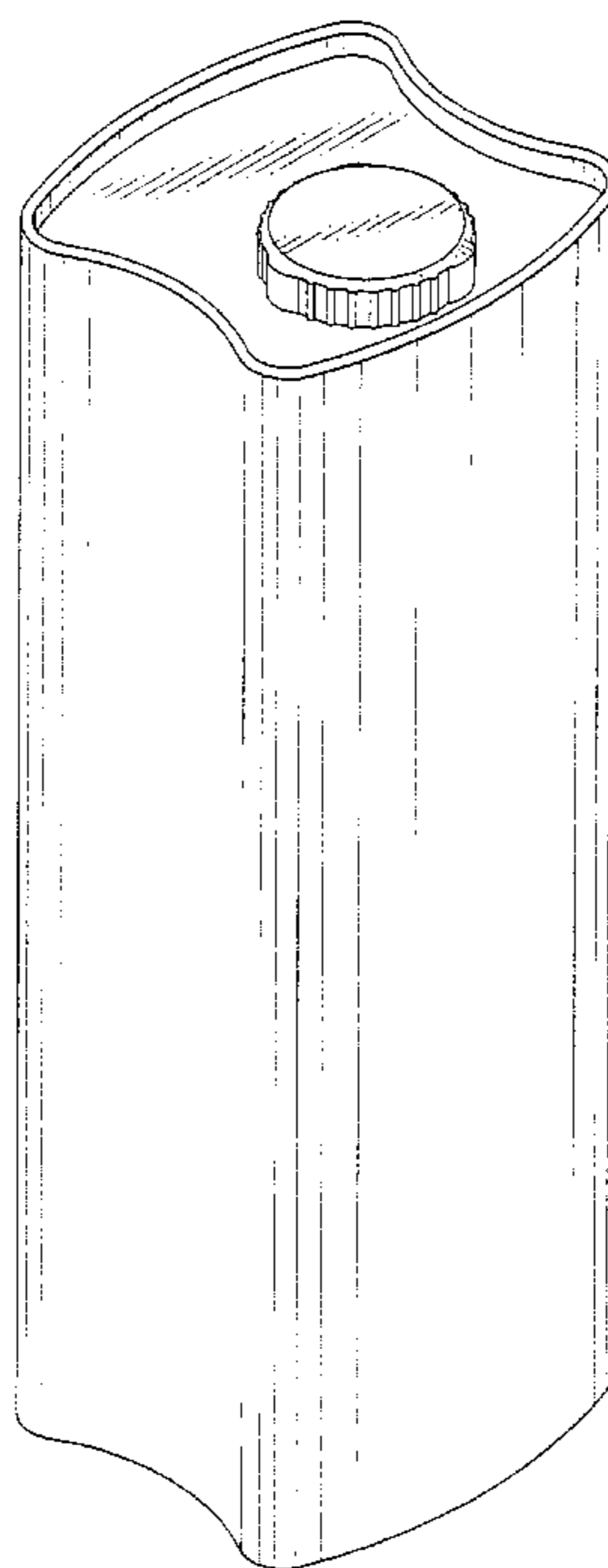

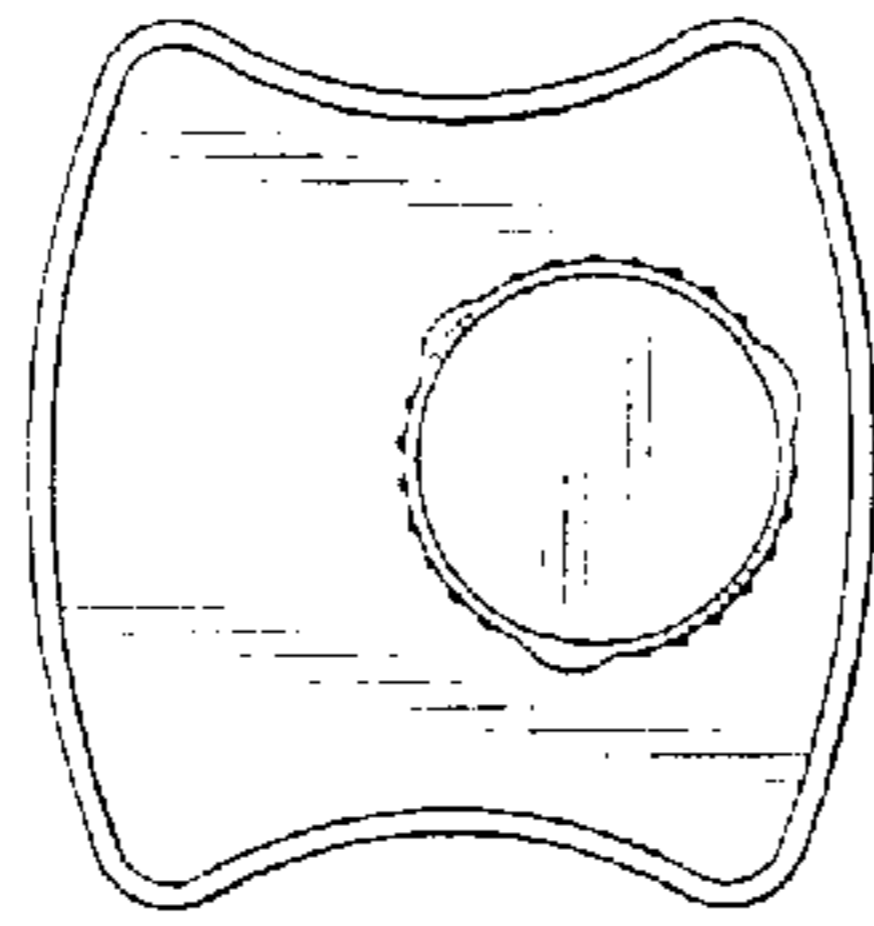
The ornamental design for a beverage package, as shown

**DESCRIPTION**

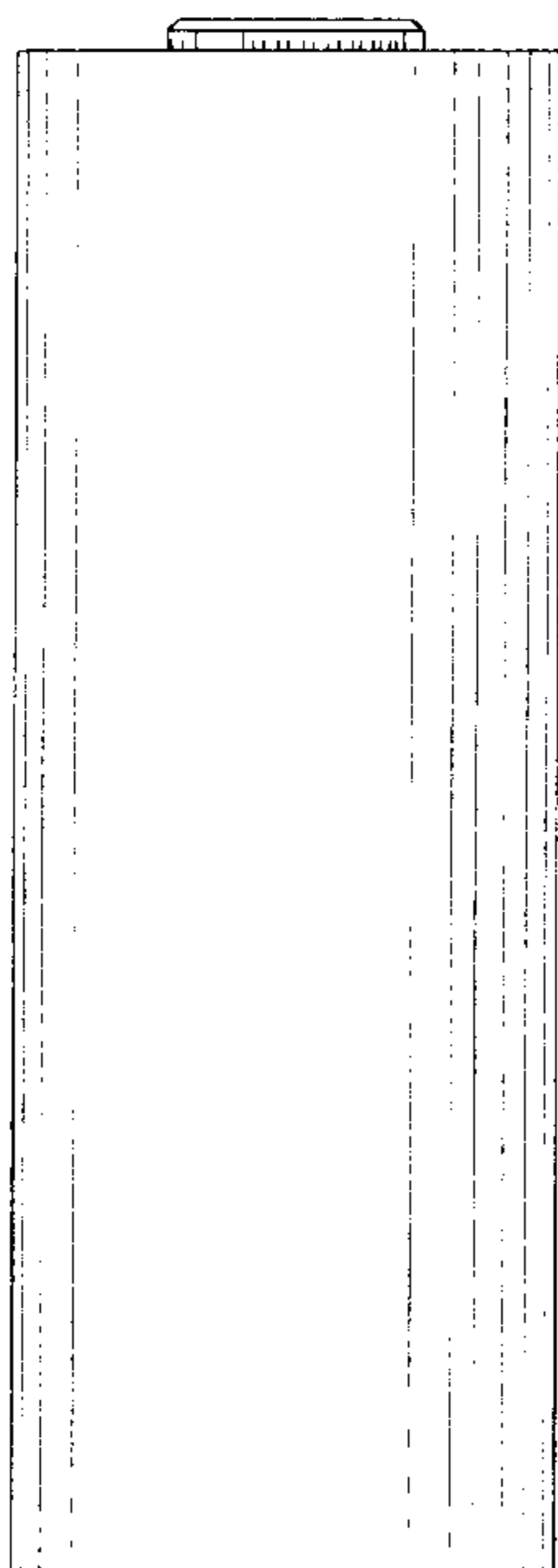
FIG. 1 is a top view of a beverage package in accordance

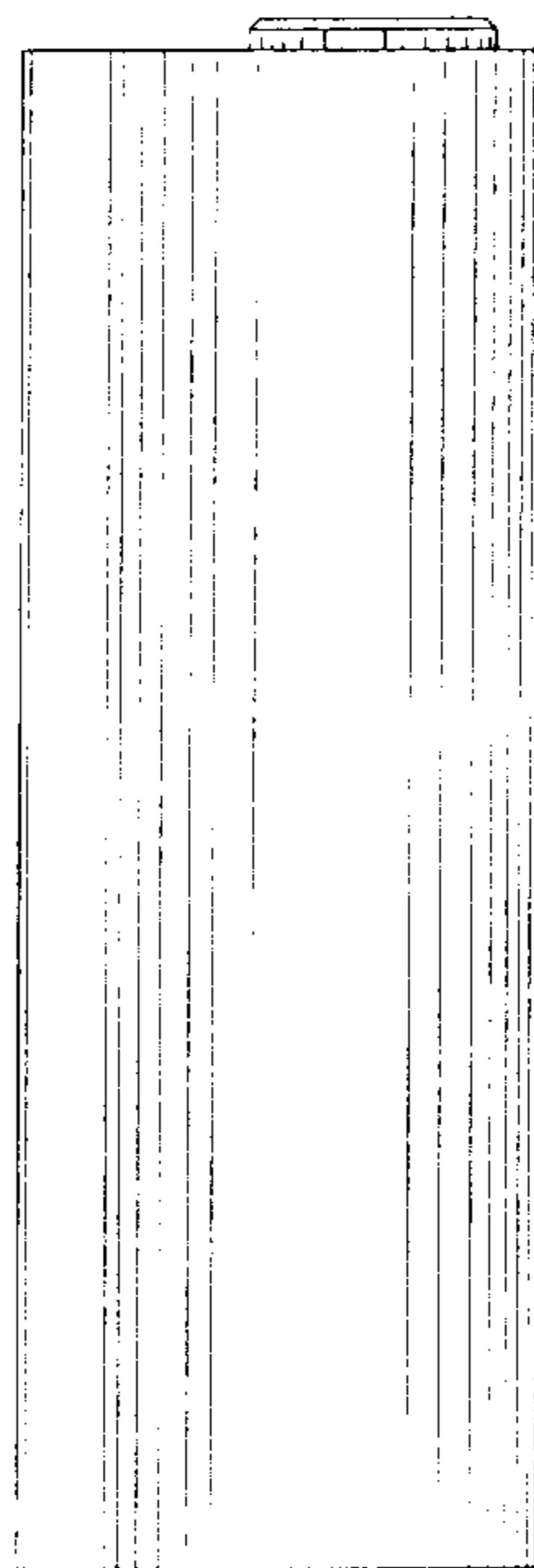




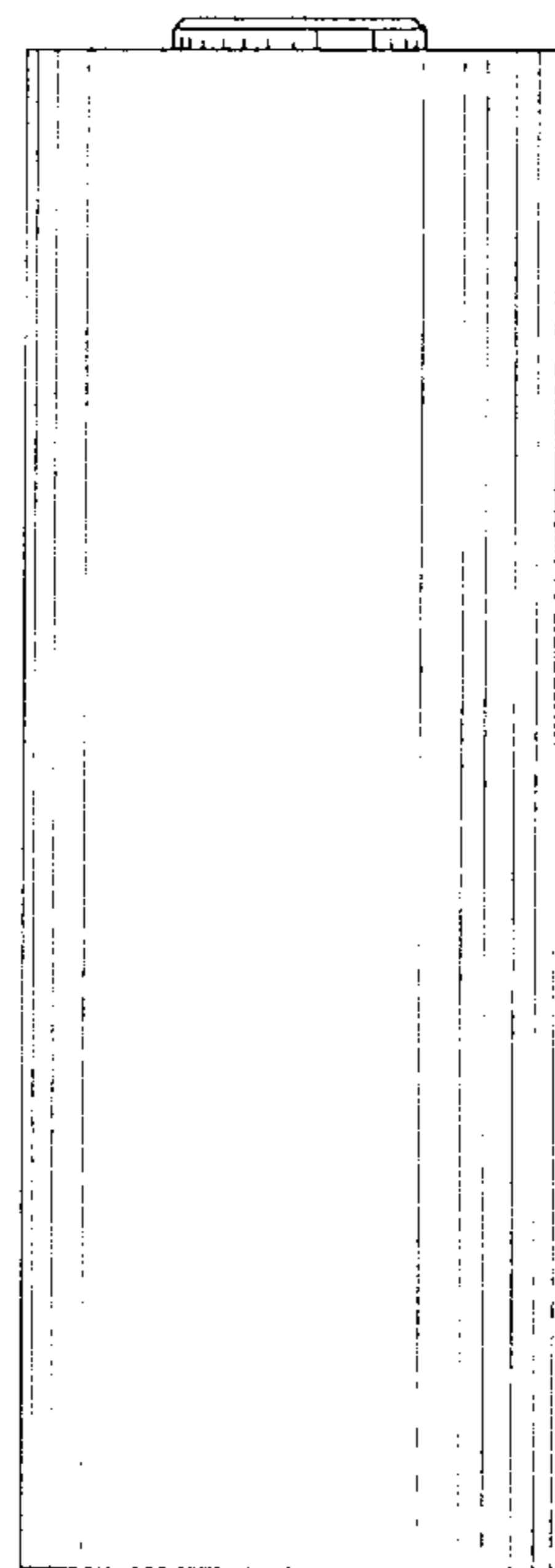

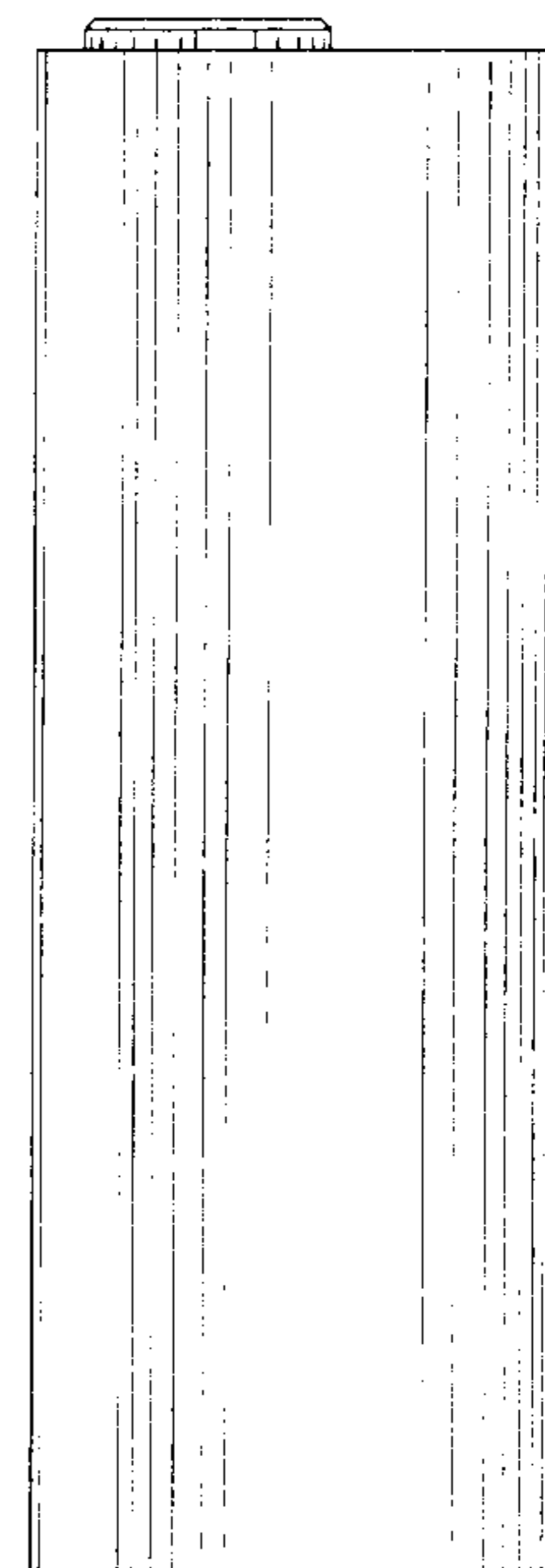

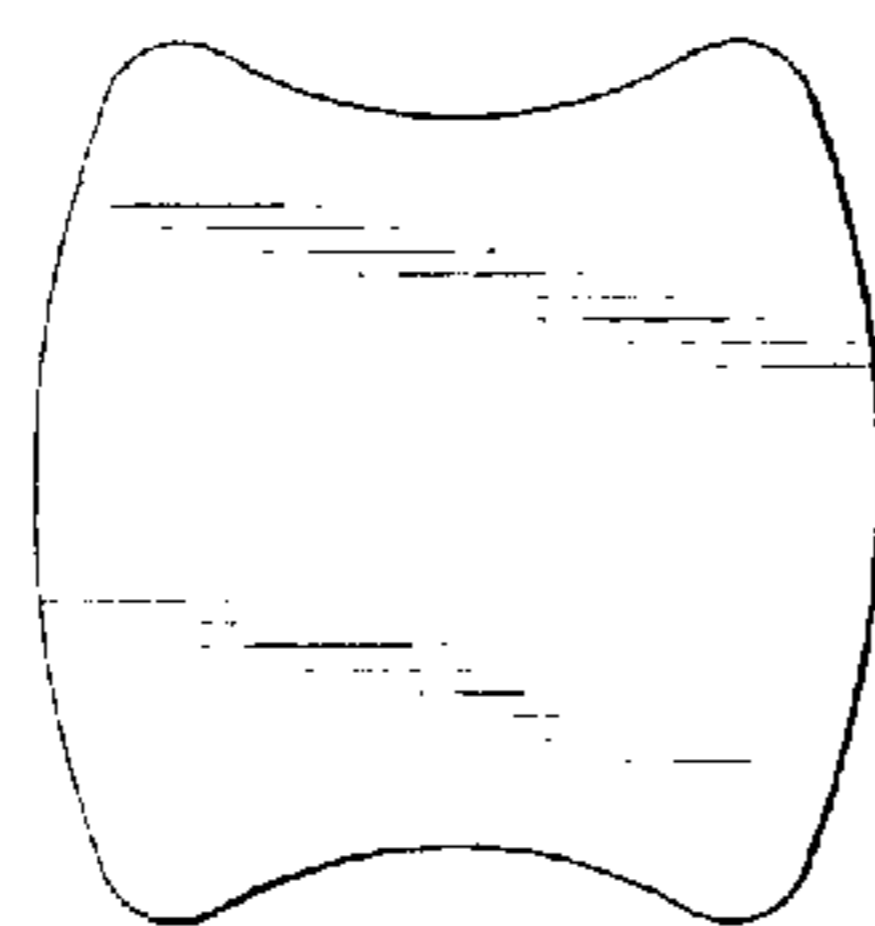

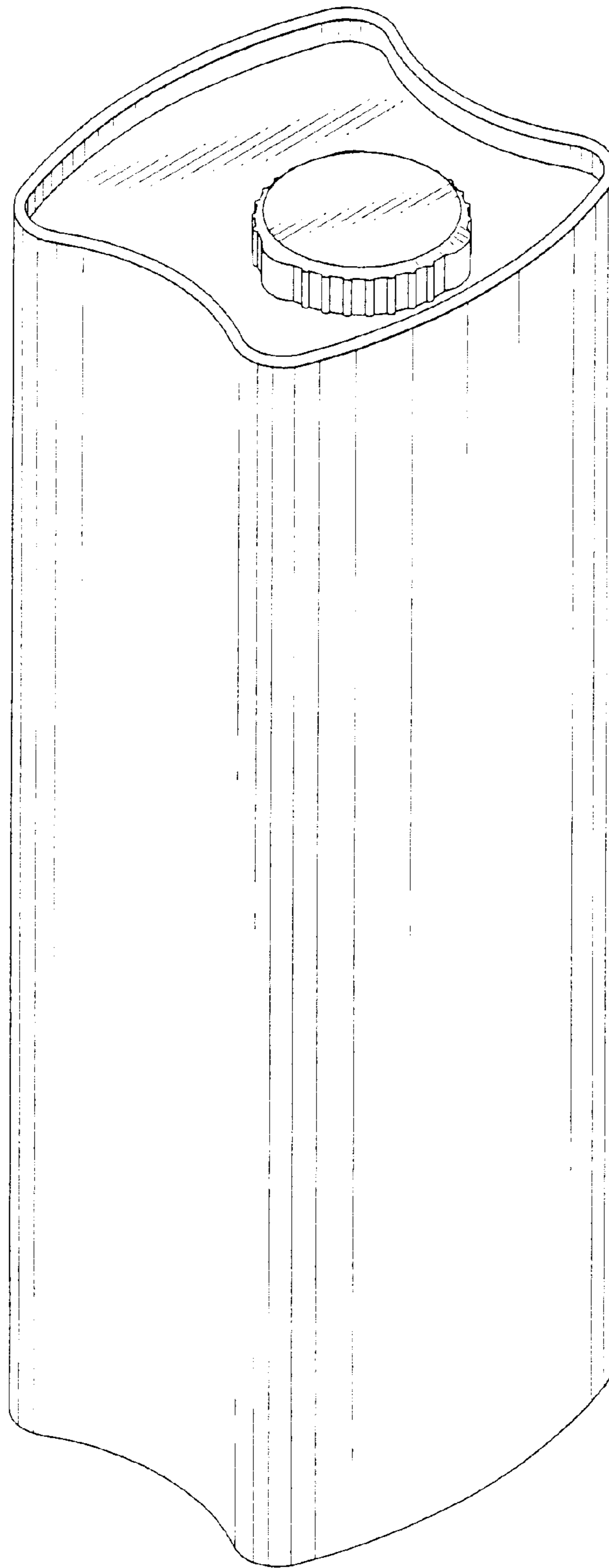
