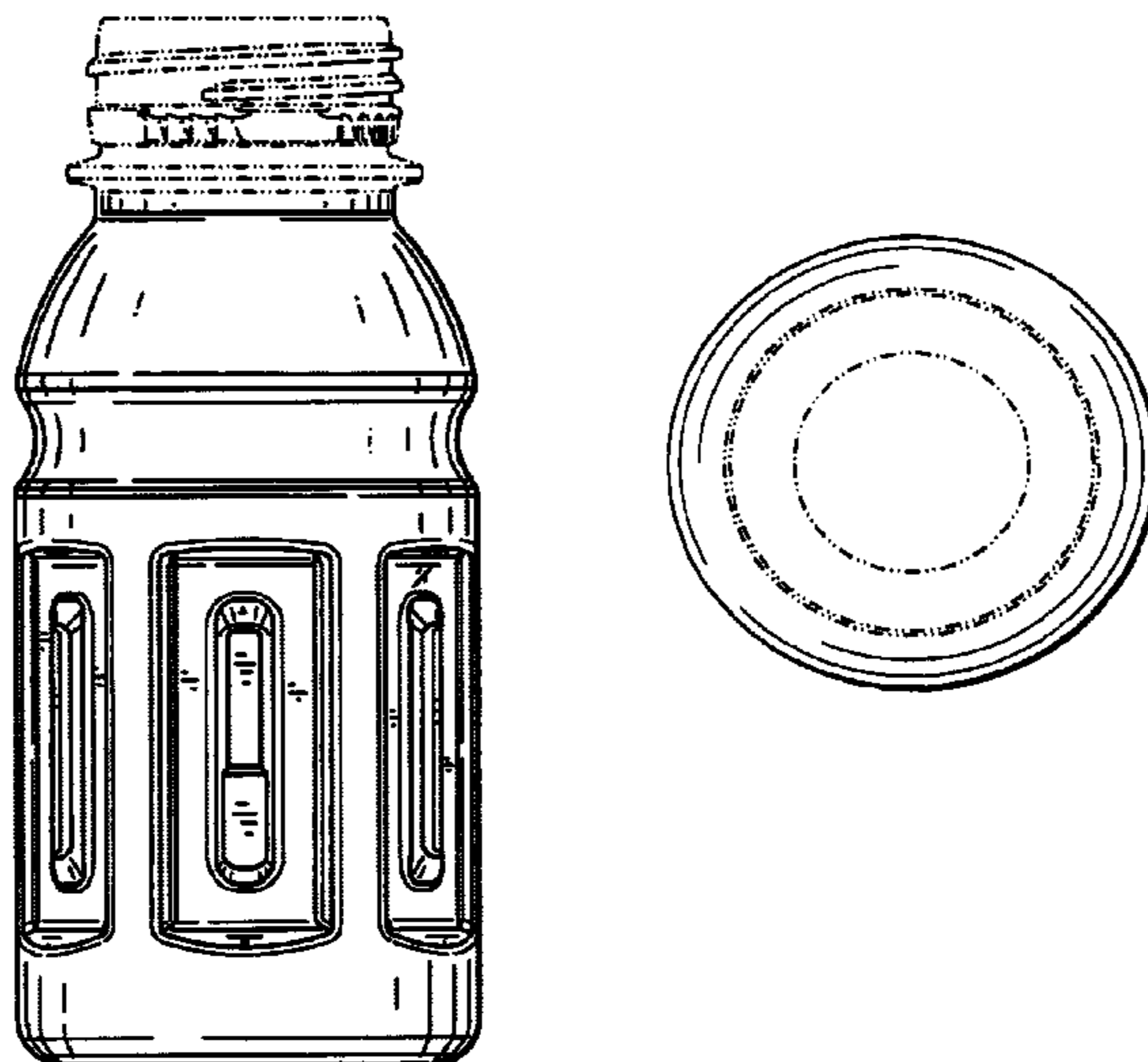
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front elevational view of a container, showing our new design in solid lines;
FIG. 2 is a right side elevational view of the container of FIG. 1;
FIG. 3 is a rear elevational view of the container of FIG. 1;
FIG. 4 is a top view of the container of FIG. 1;
FIG. 5 is a bottom view of the container of FIG. 1; and,
FIG. 6 is a perspective view of the container of FIG. 1.

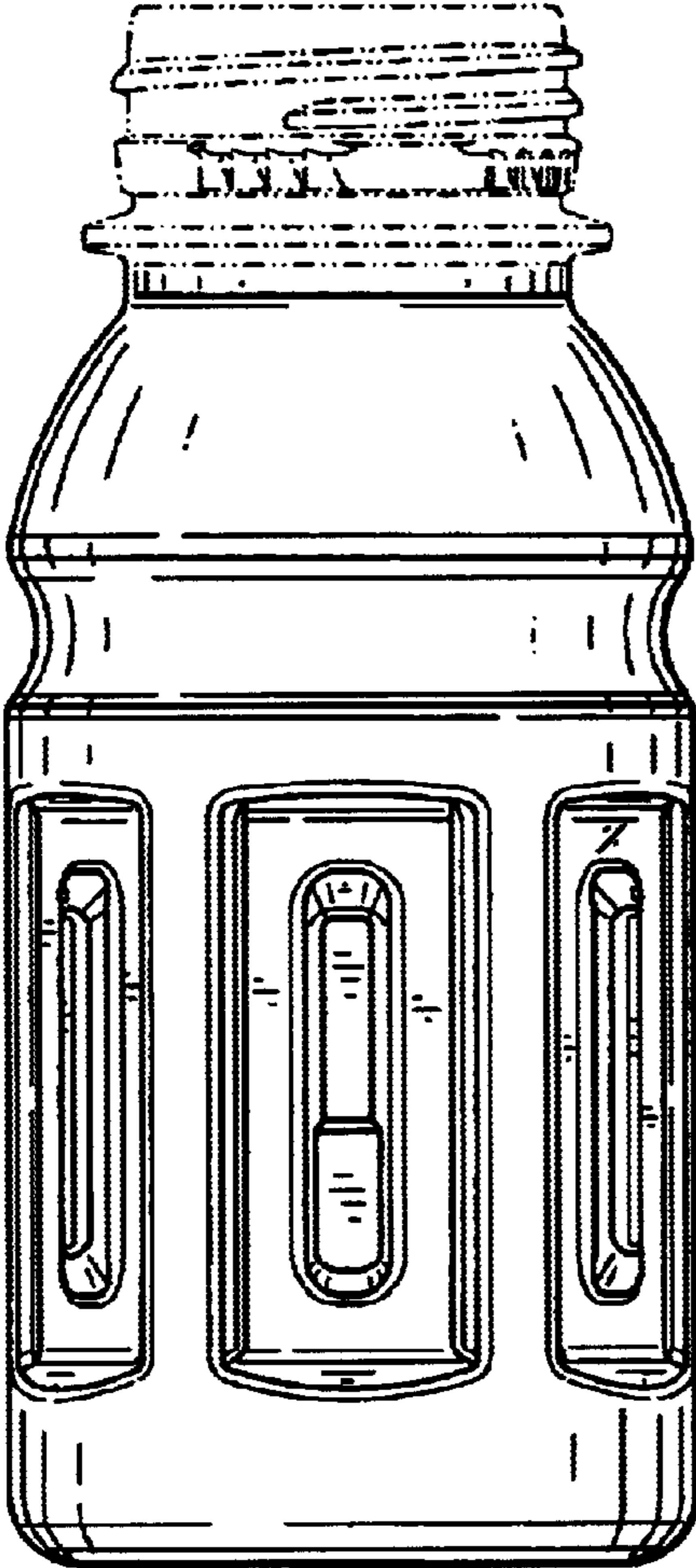

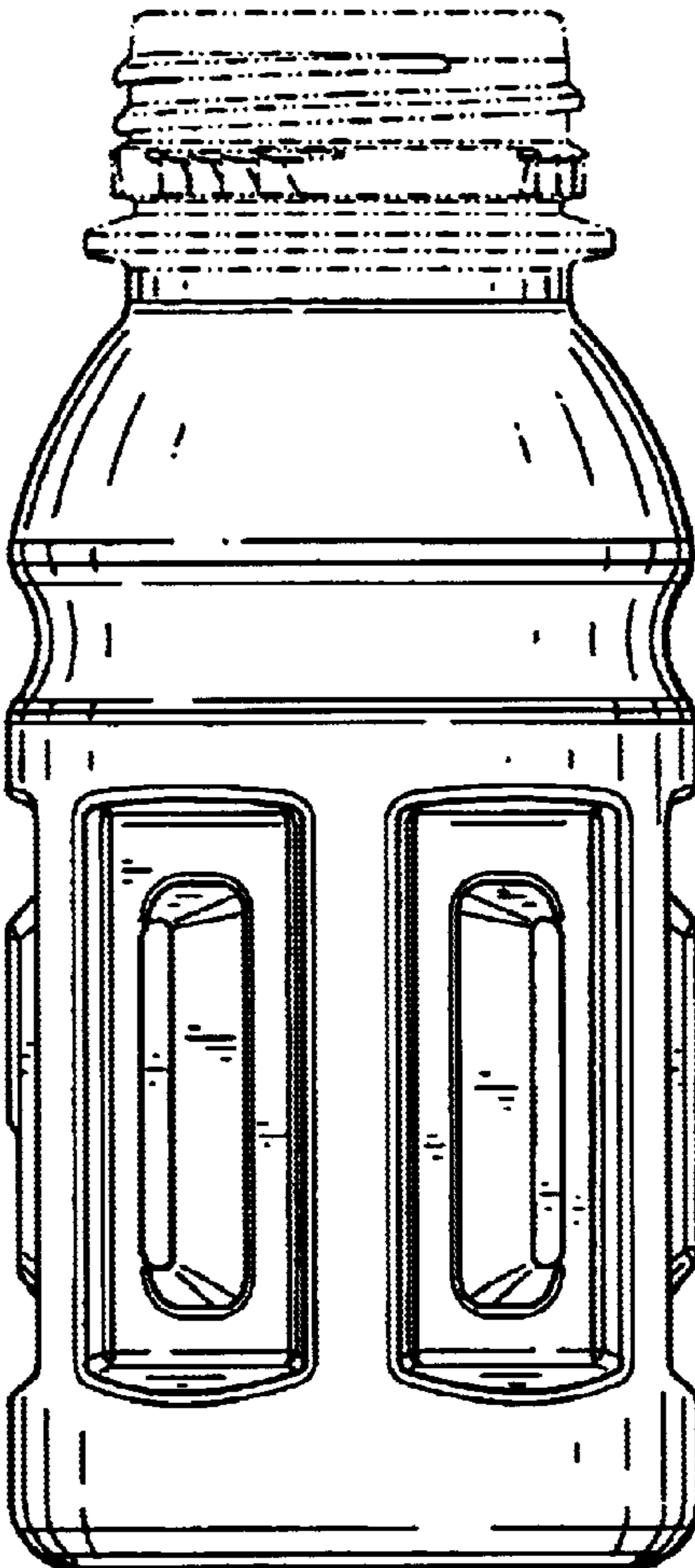

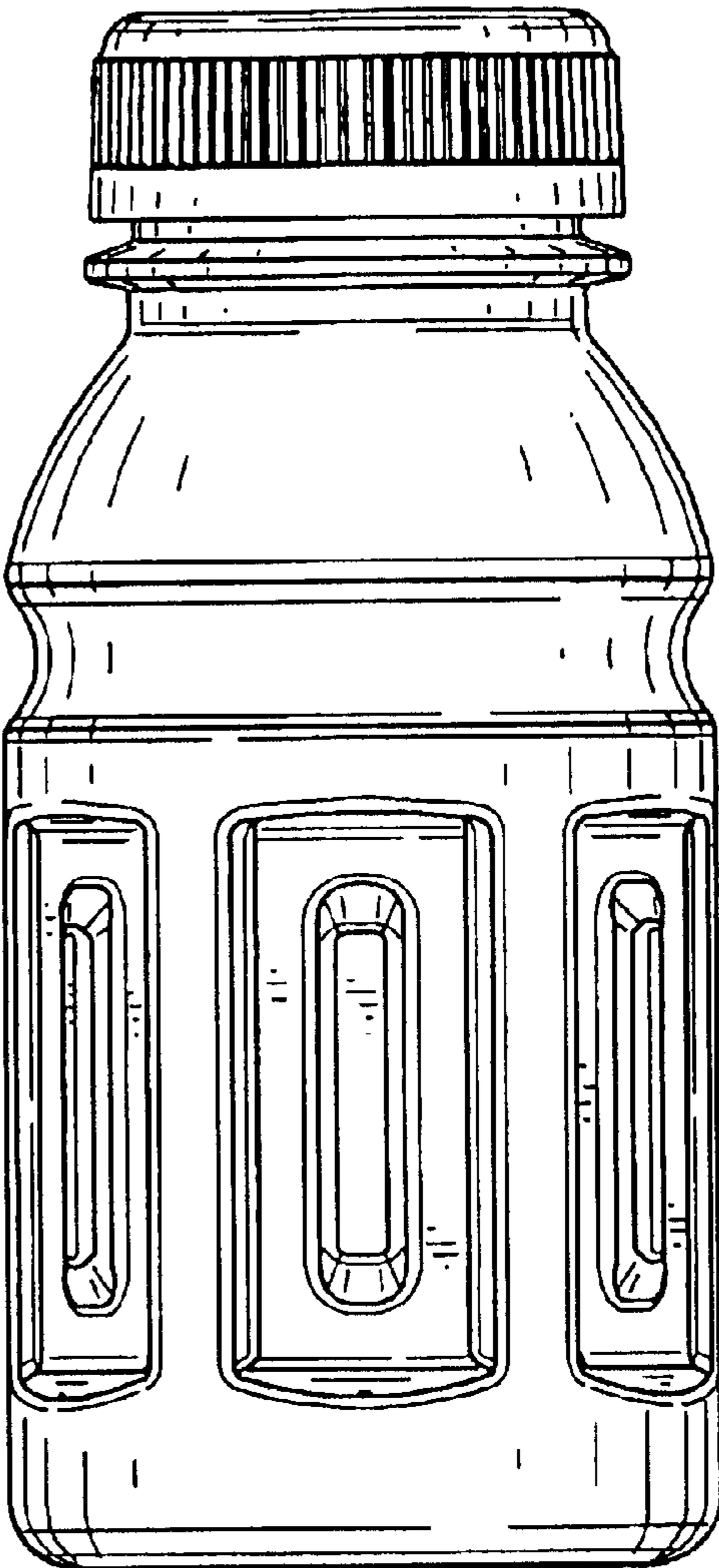

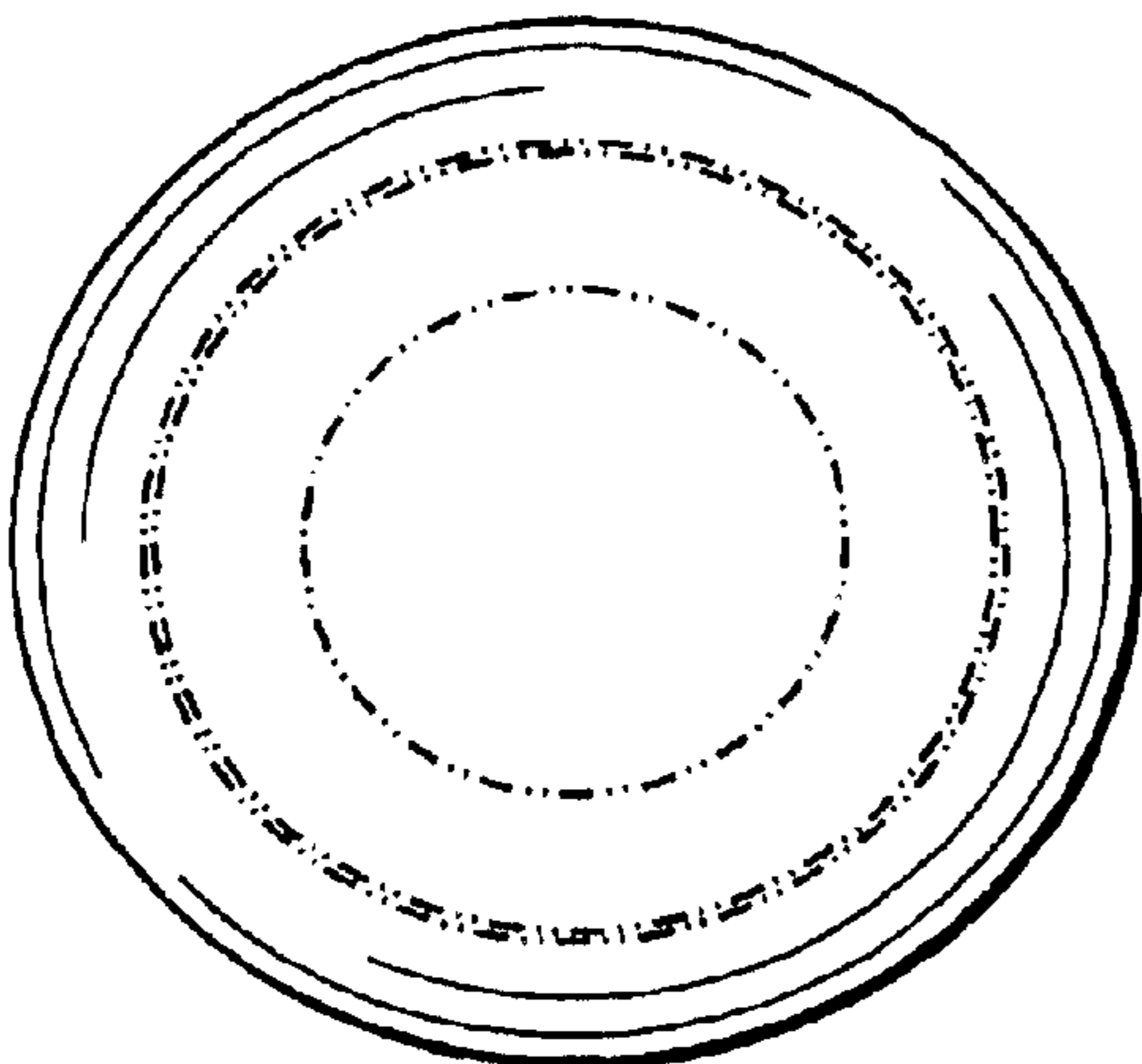

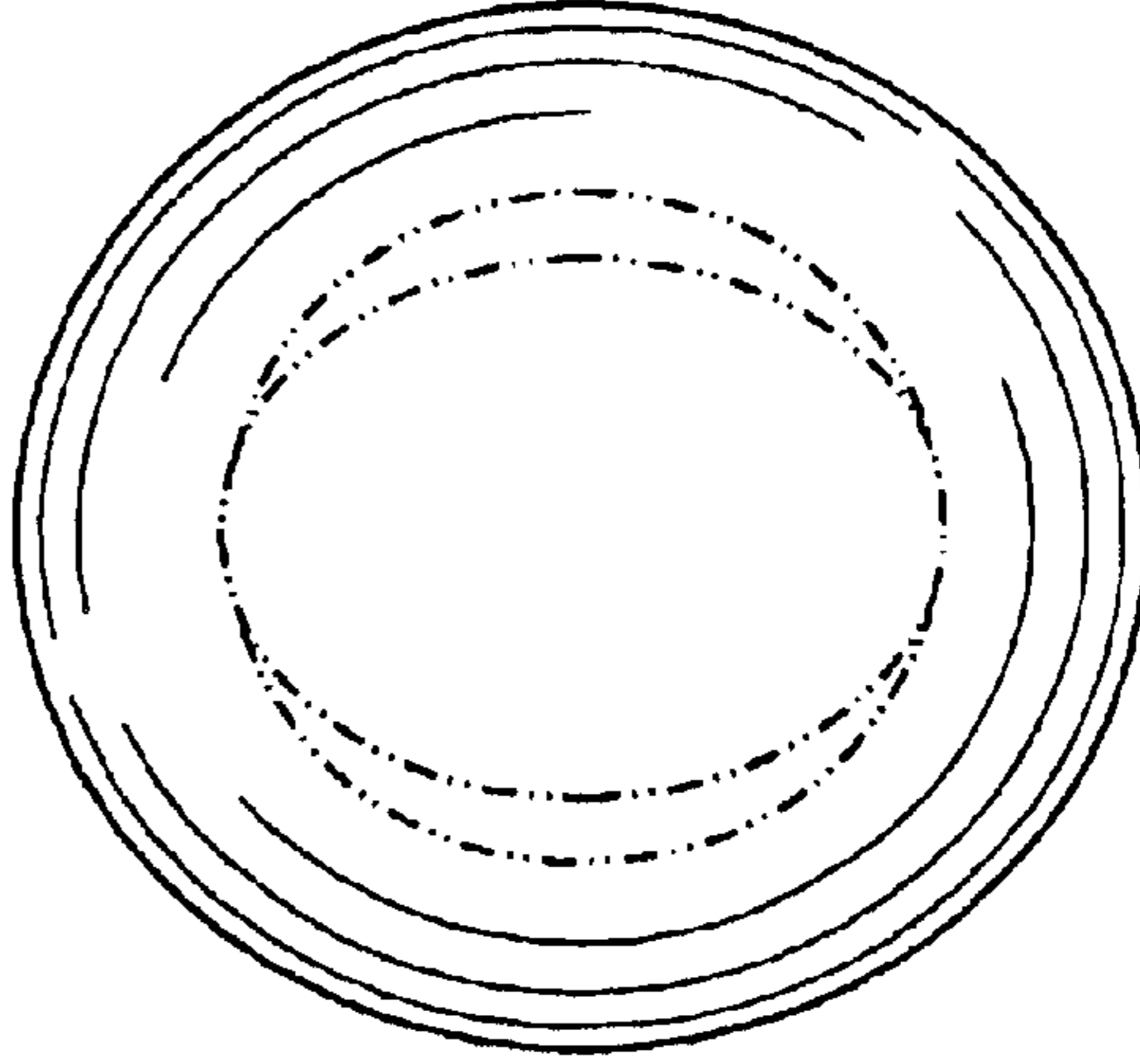

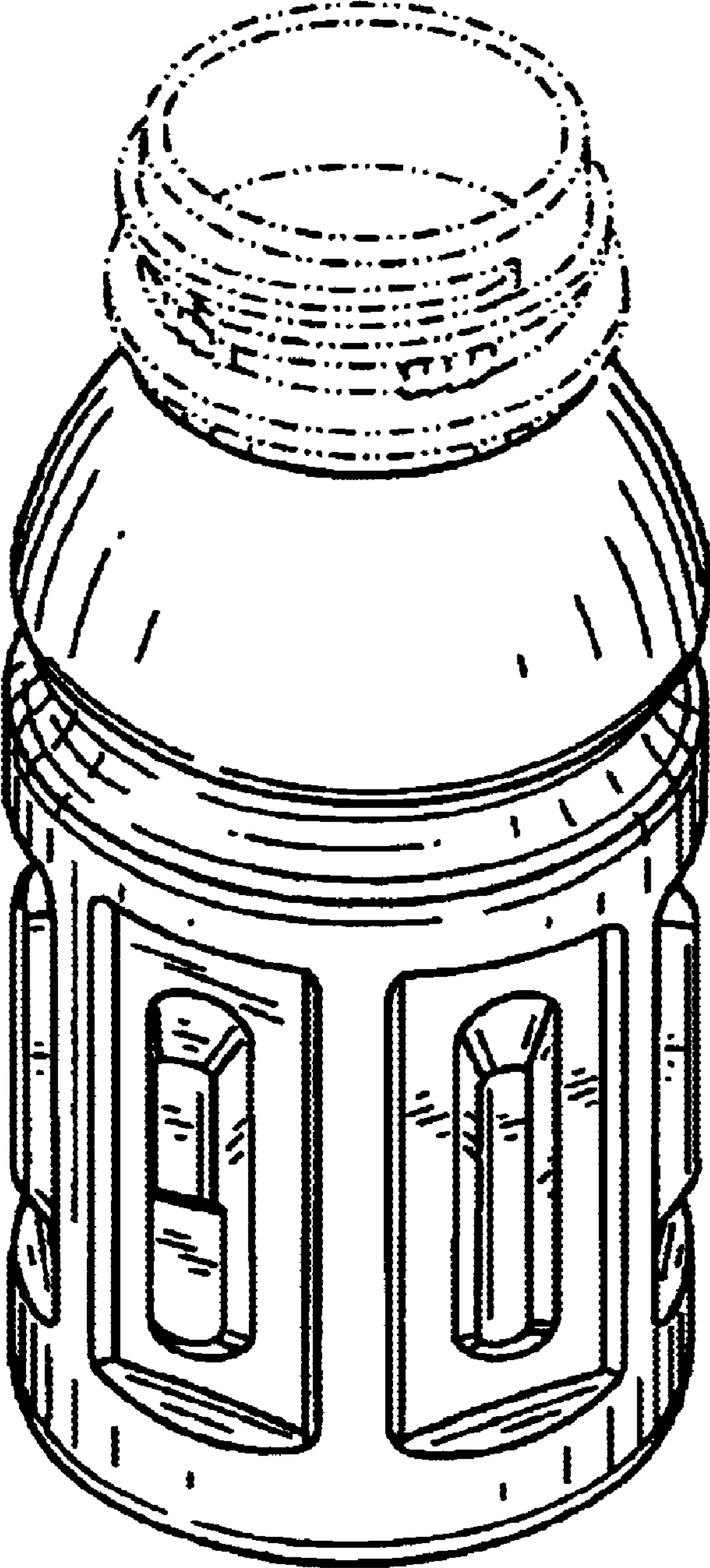
