The ornamental design for a cellular phone, as shown.

DESCRIPTION

FIG. 1 is a perspective view of a cellular phone having the present design;
FIG. 2 is a view of the front thereof;
FIG. 3 is a view of the rear thereof;
FIG. 4 is a view of the left side thereof;
FIG. 5 is a view of the right side thereof;
FIG. 6 is a view of the top thereof; and,
FIG. 7 is a view of the bottom thereof.

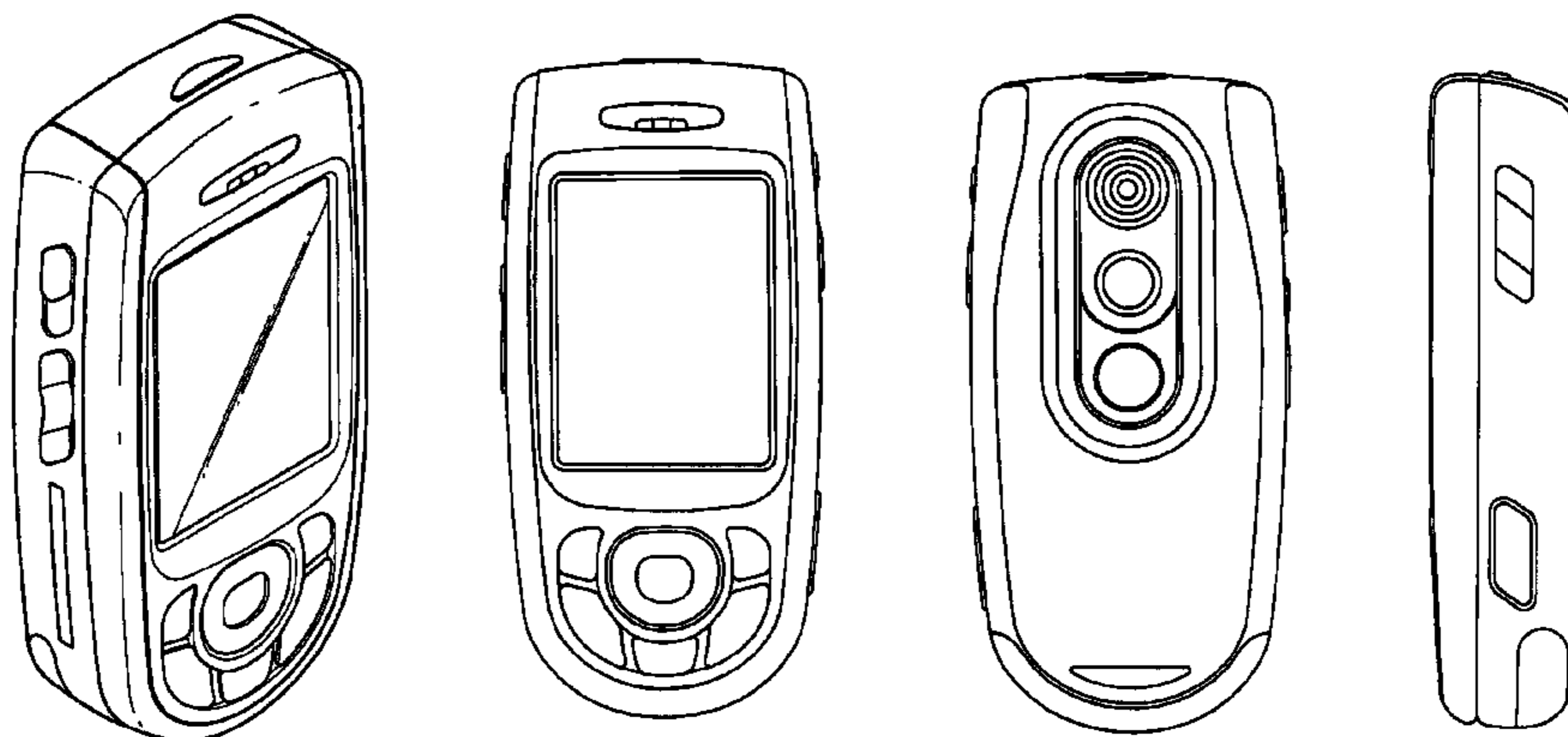

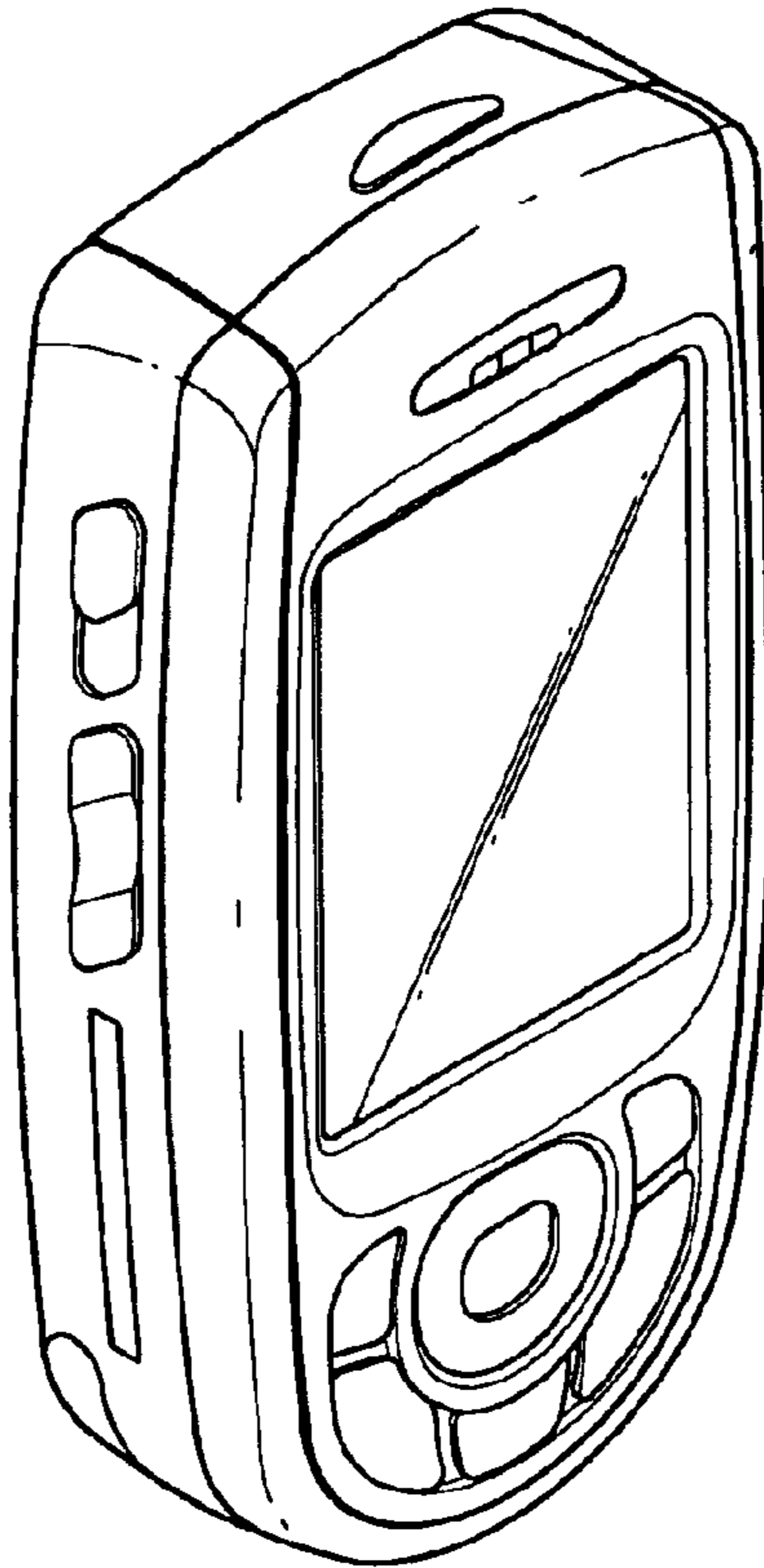

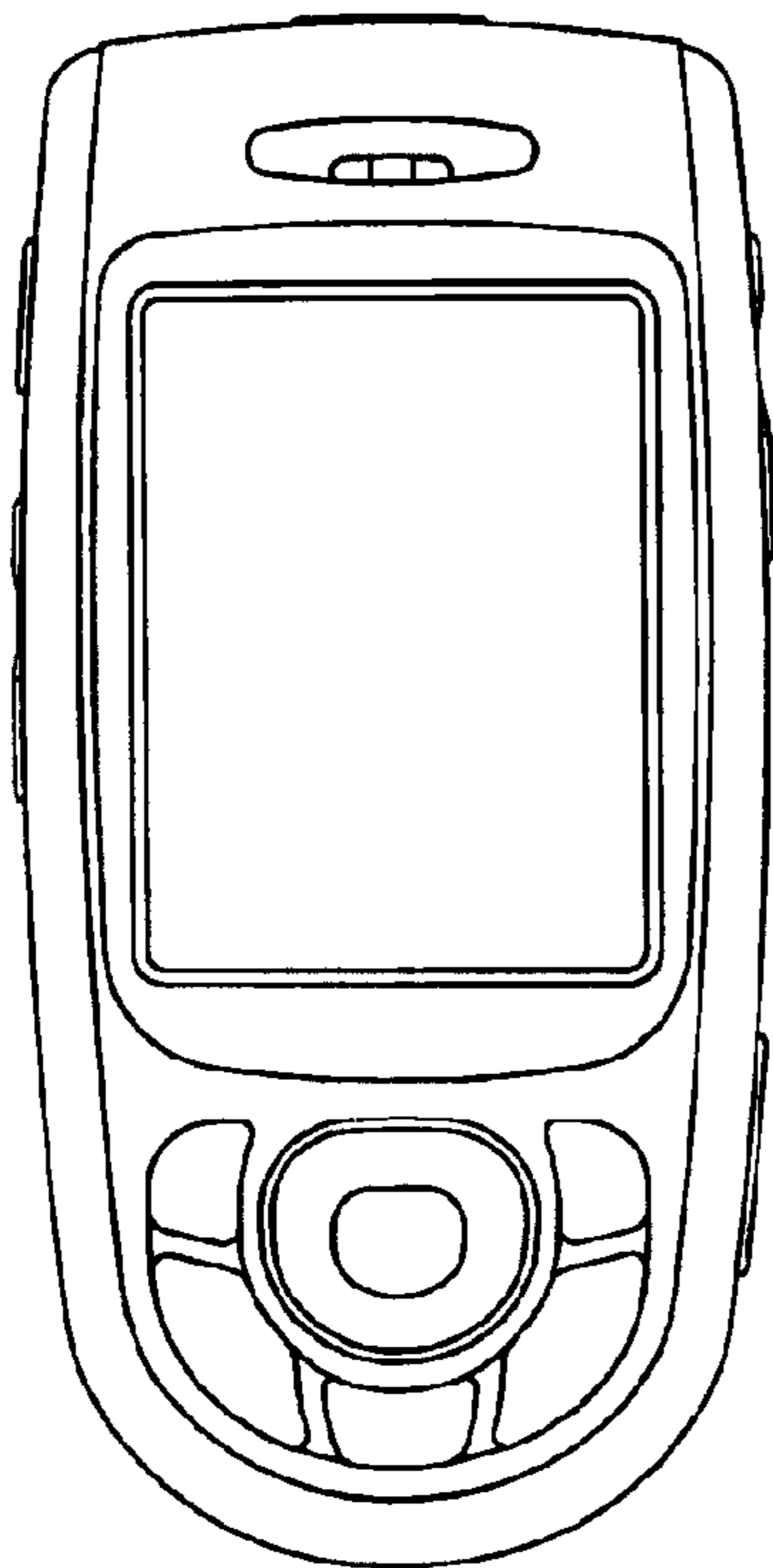

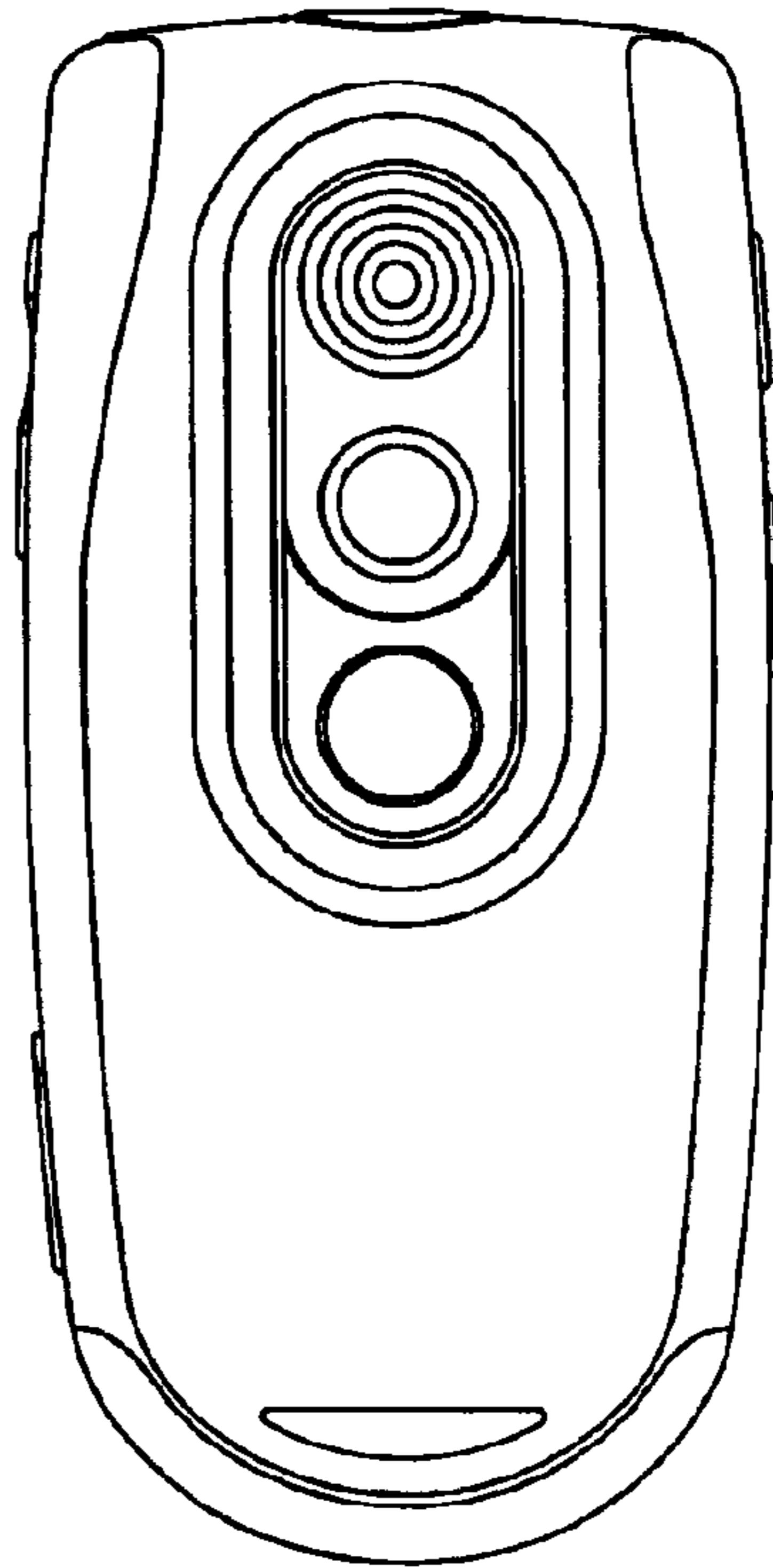

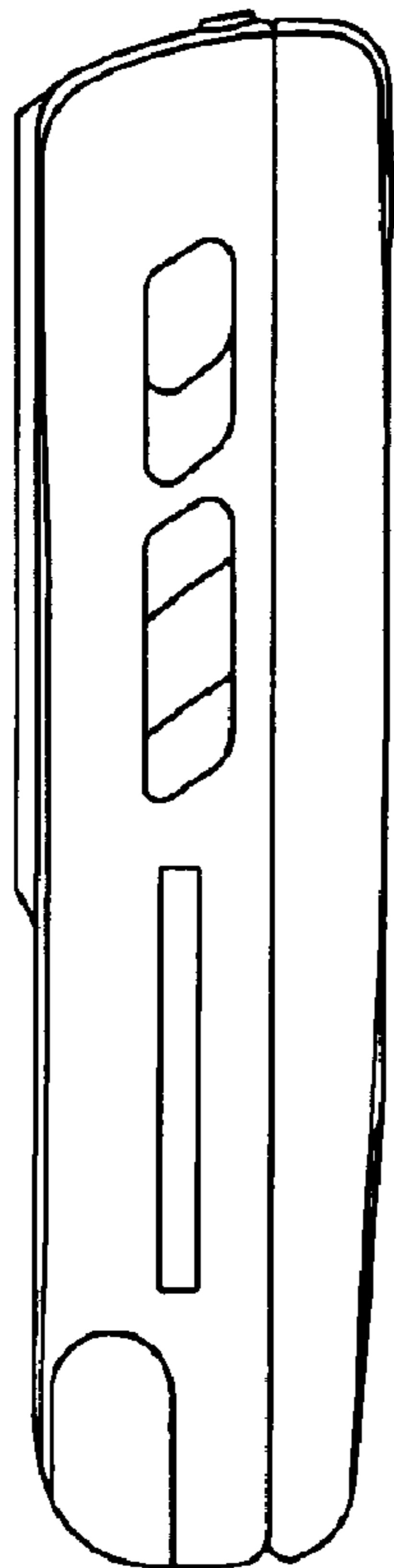

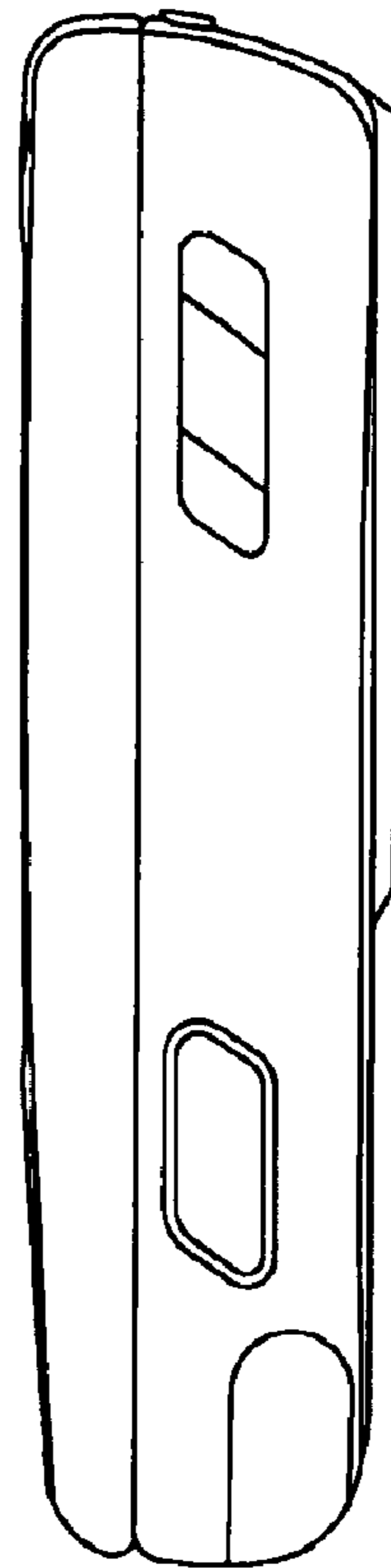

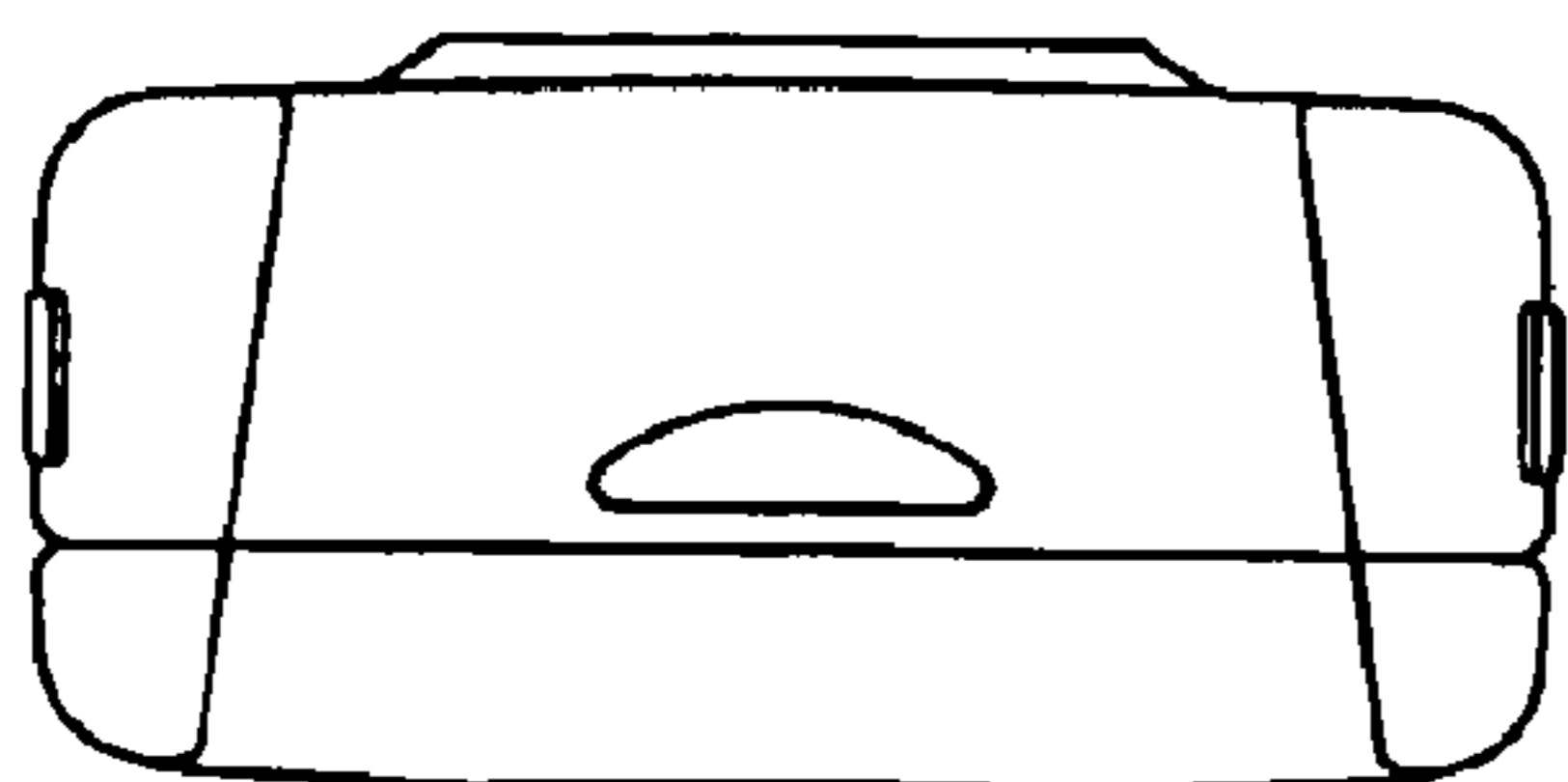
