**DESCRIPTION**

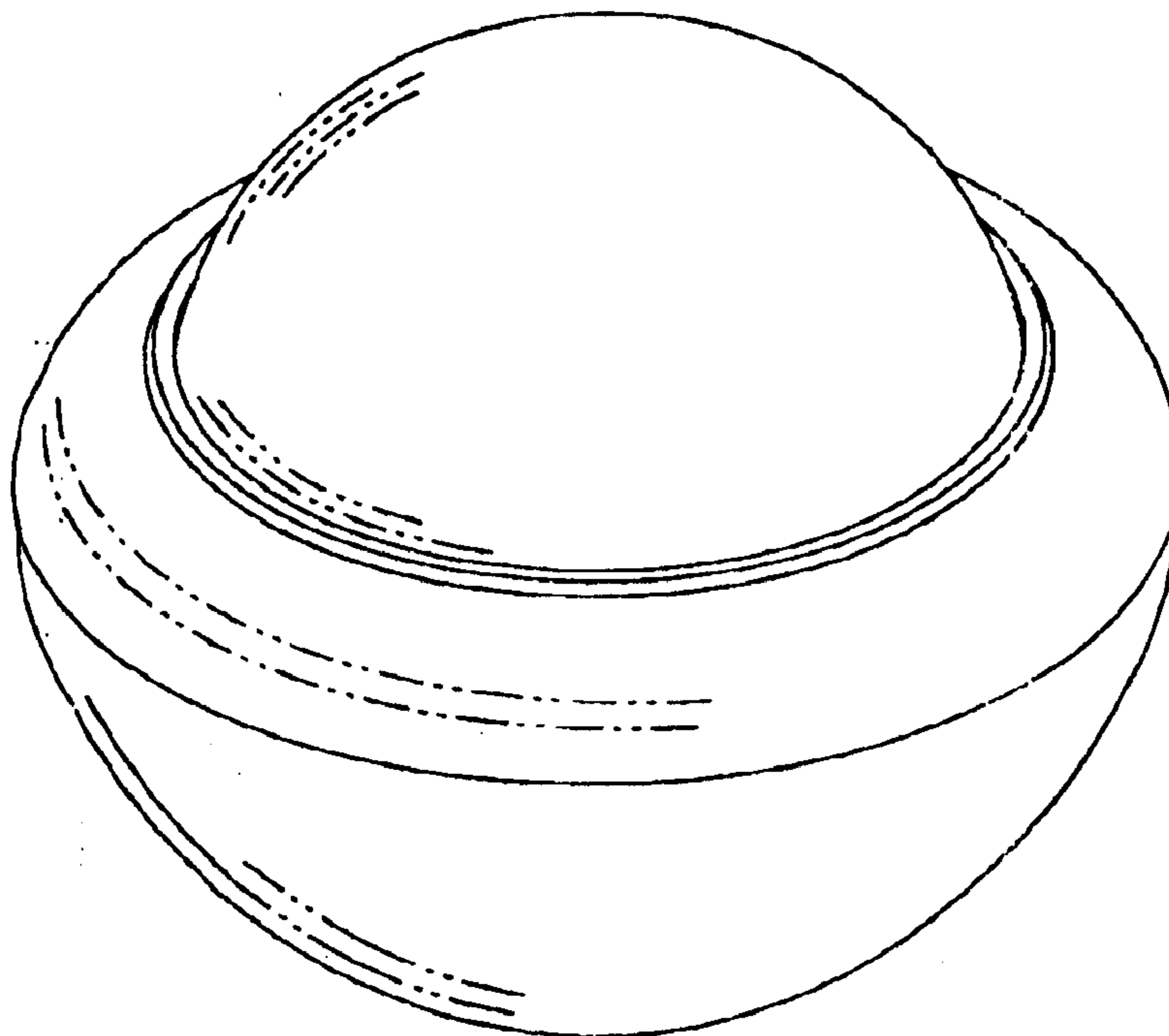
FIG. 1 is a perspective view of a massage implement, showing my new design;

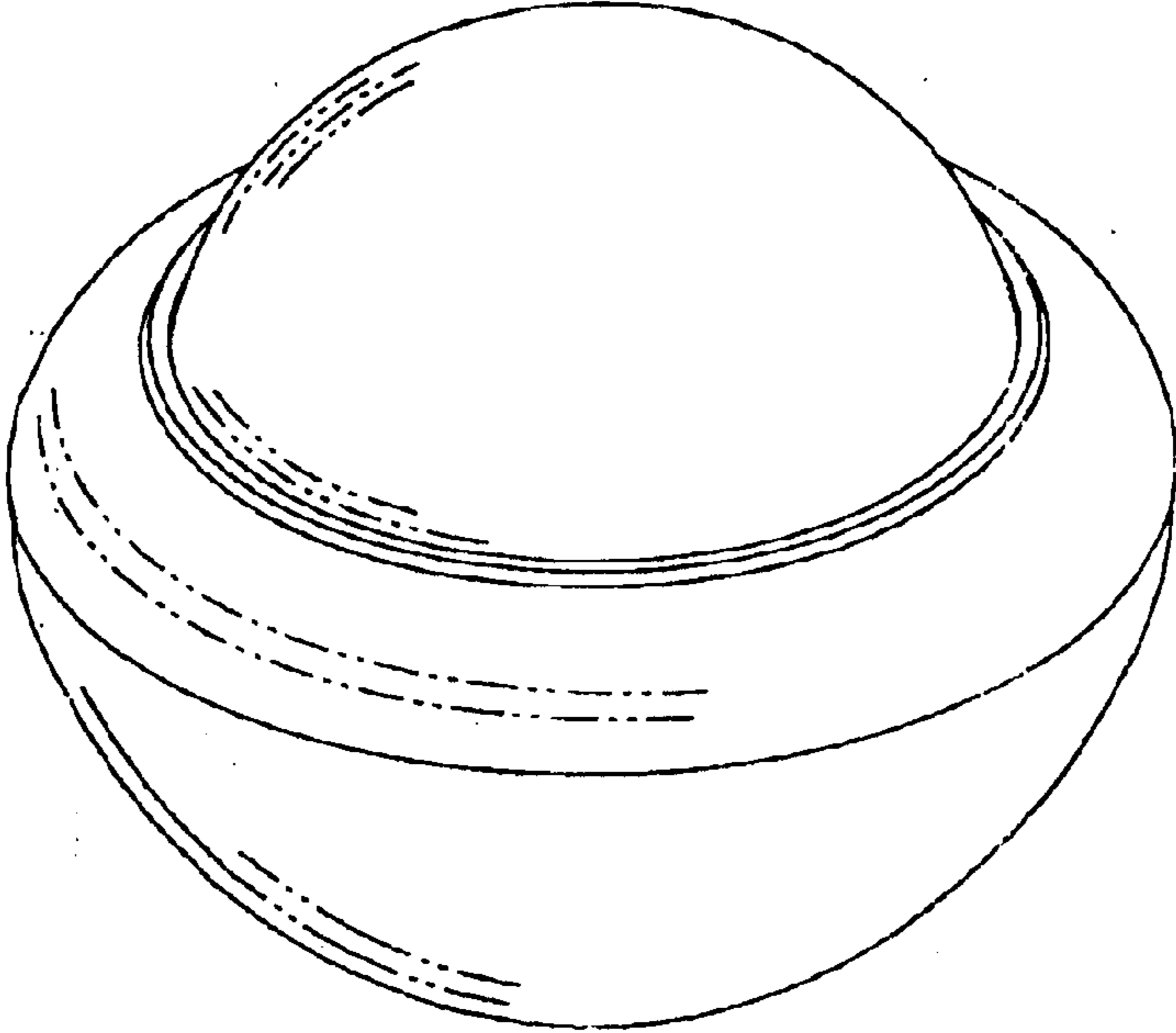

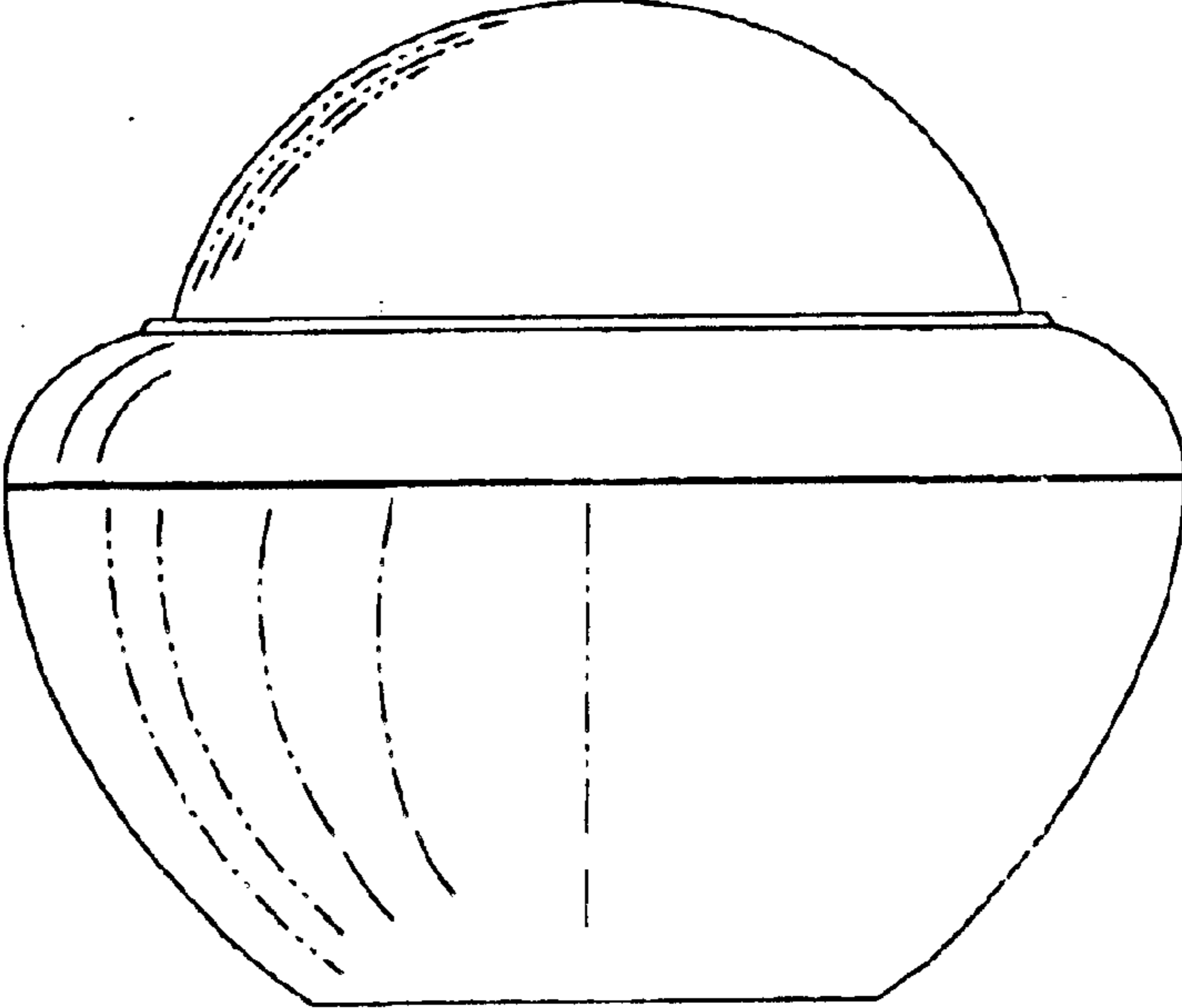

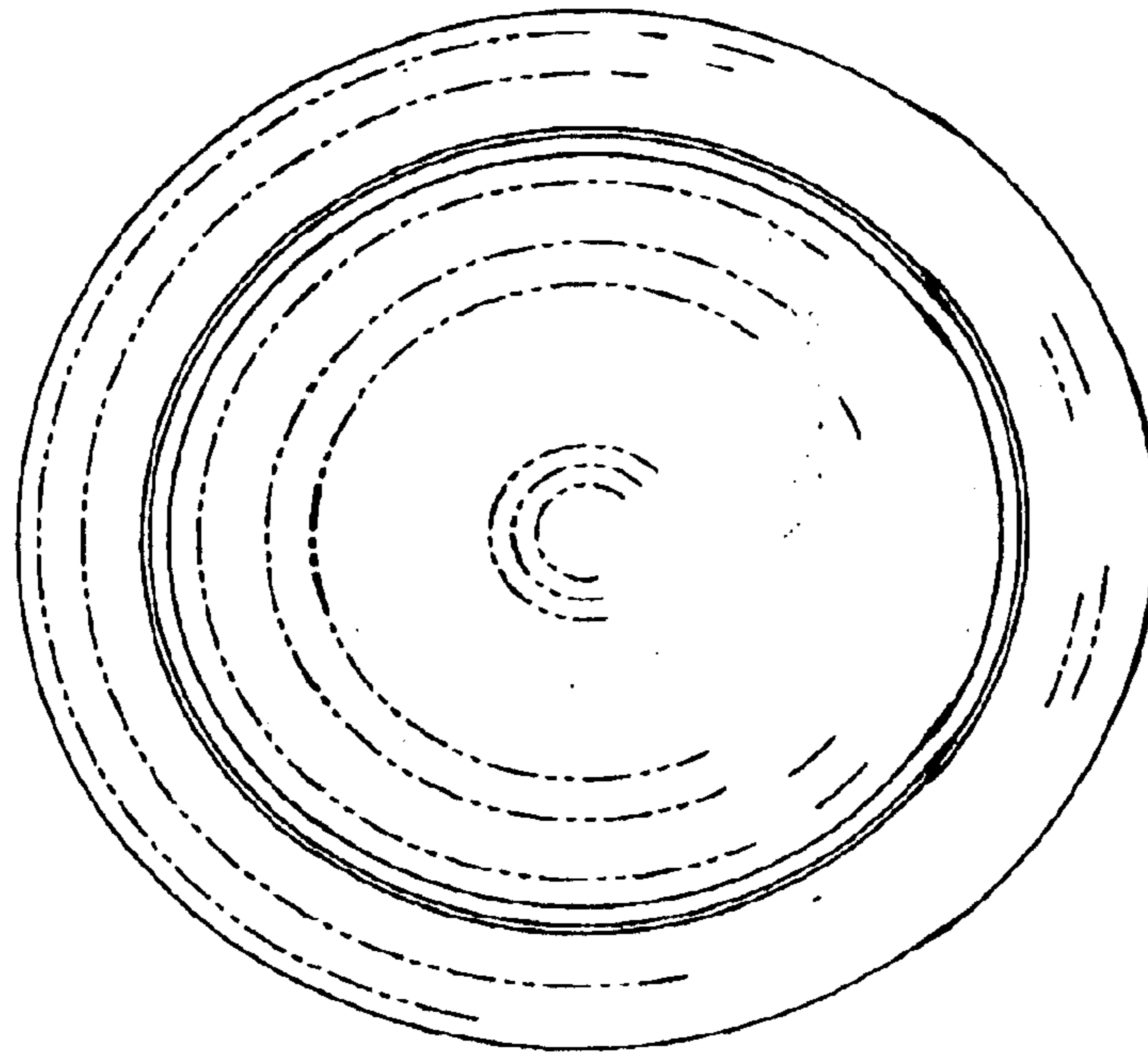

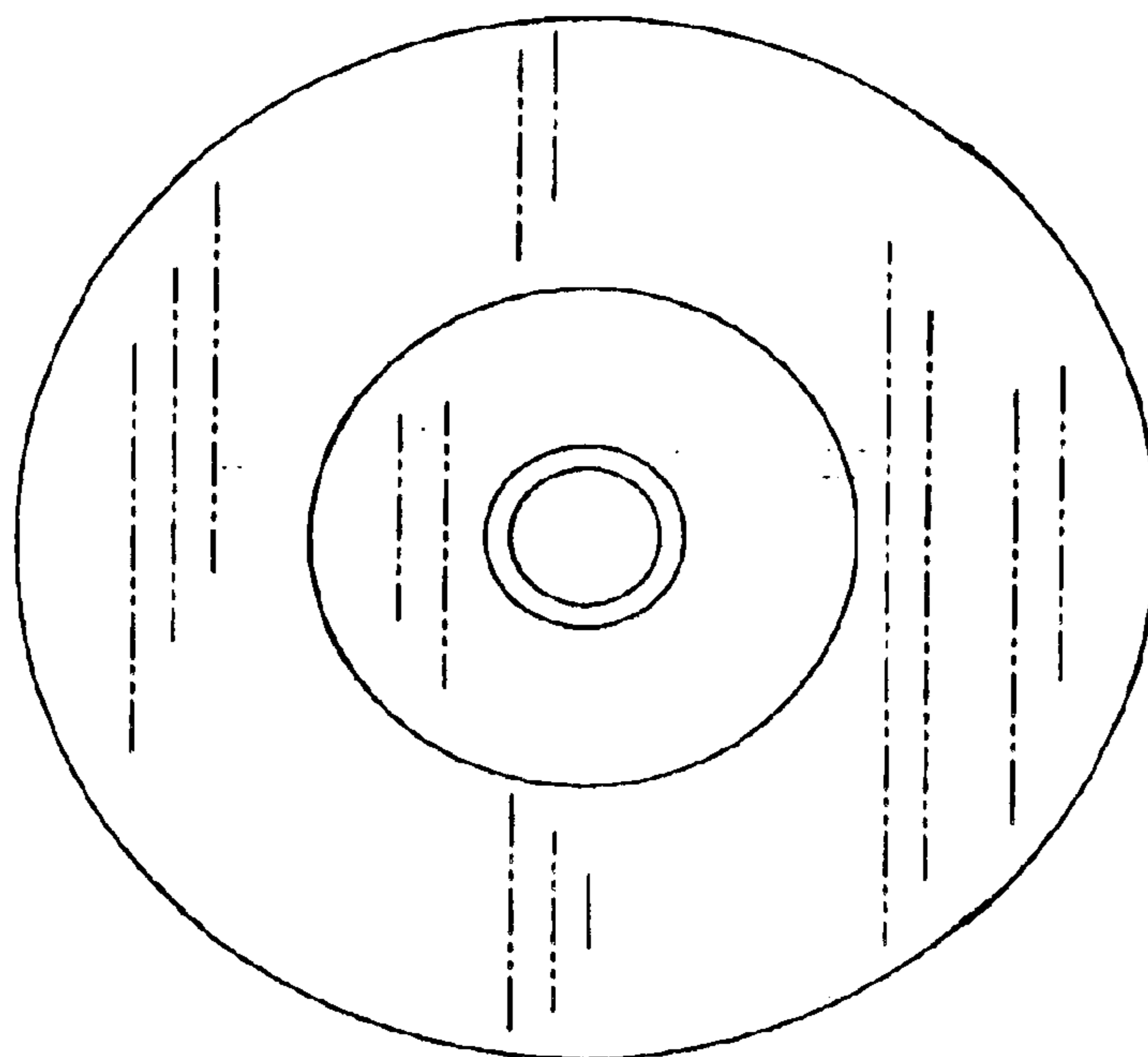
