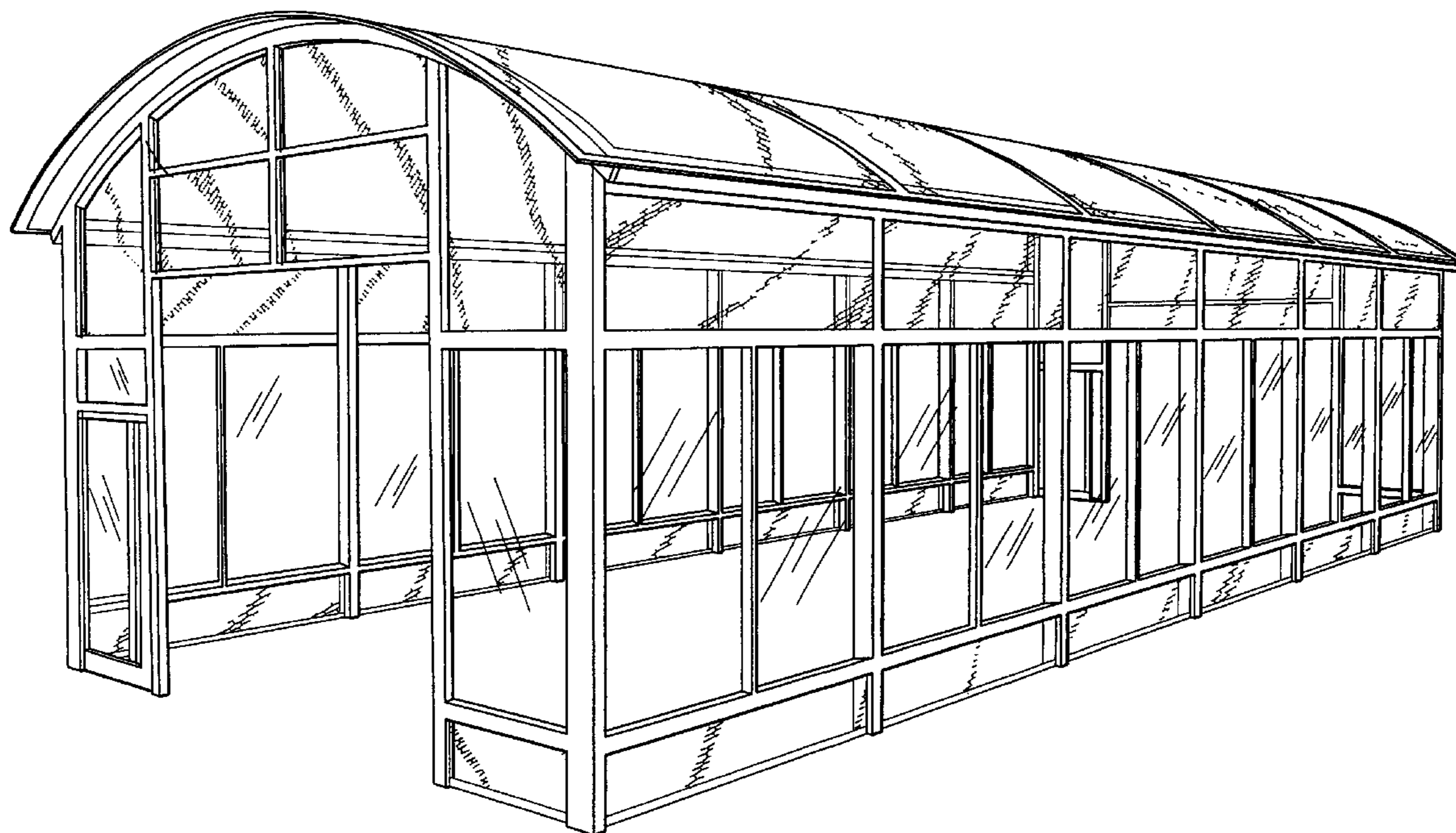
(57) **CLAIM**

We claim the ornamental design for a building structure for a carwash, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a building structure for a carwash showing our new design; FIG. 2 is a right side elevational view, the left side elevational view being a mirror image thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a rear elevational view thereof; and, FIG. 5 is a top plan view thereof.

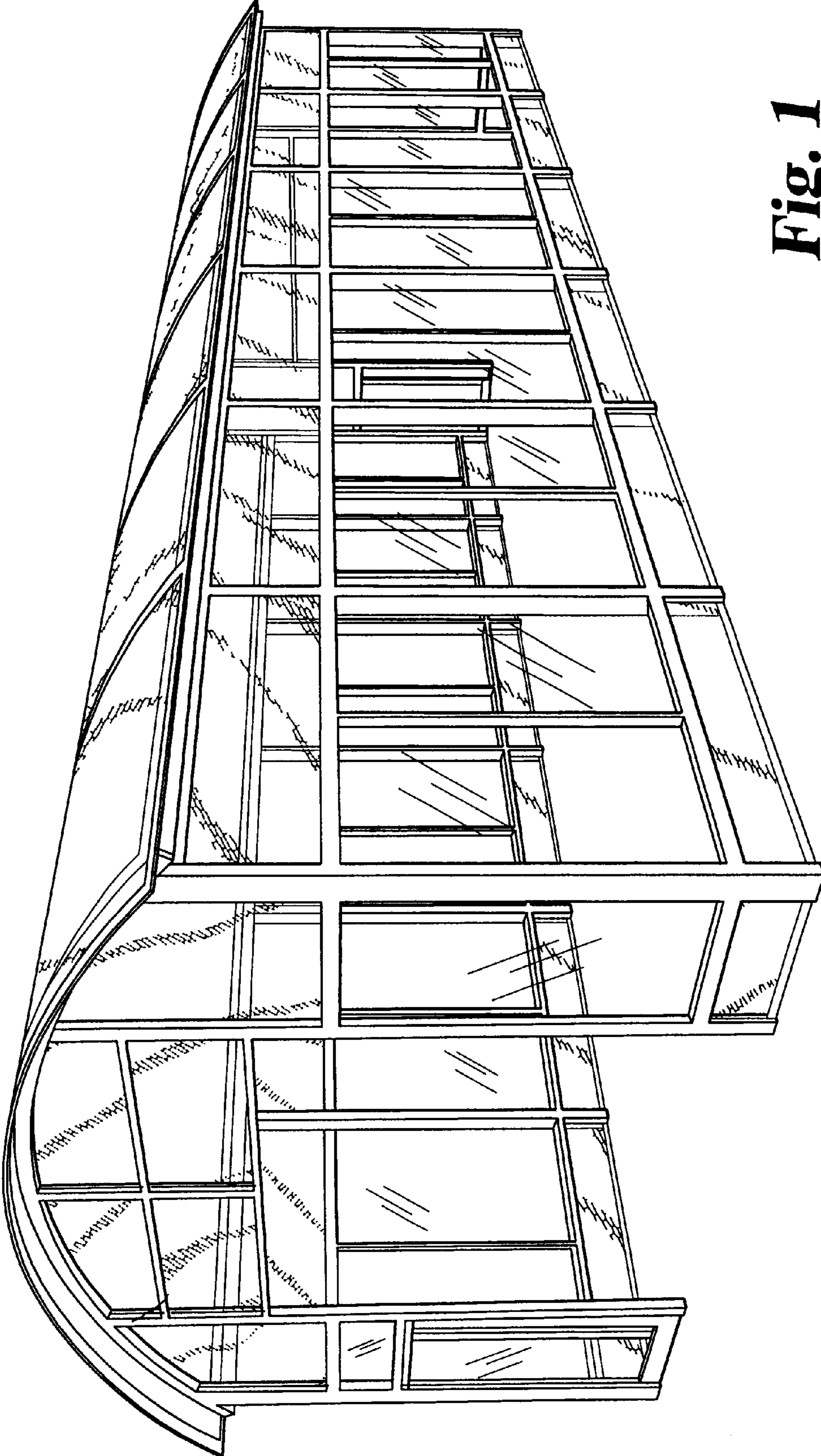

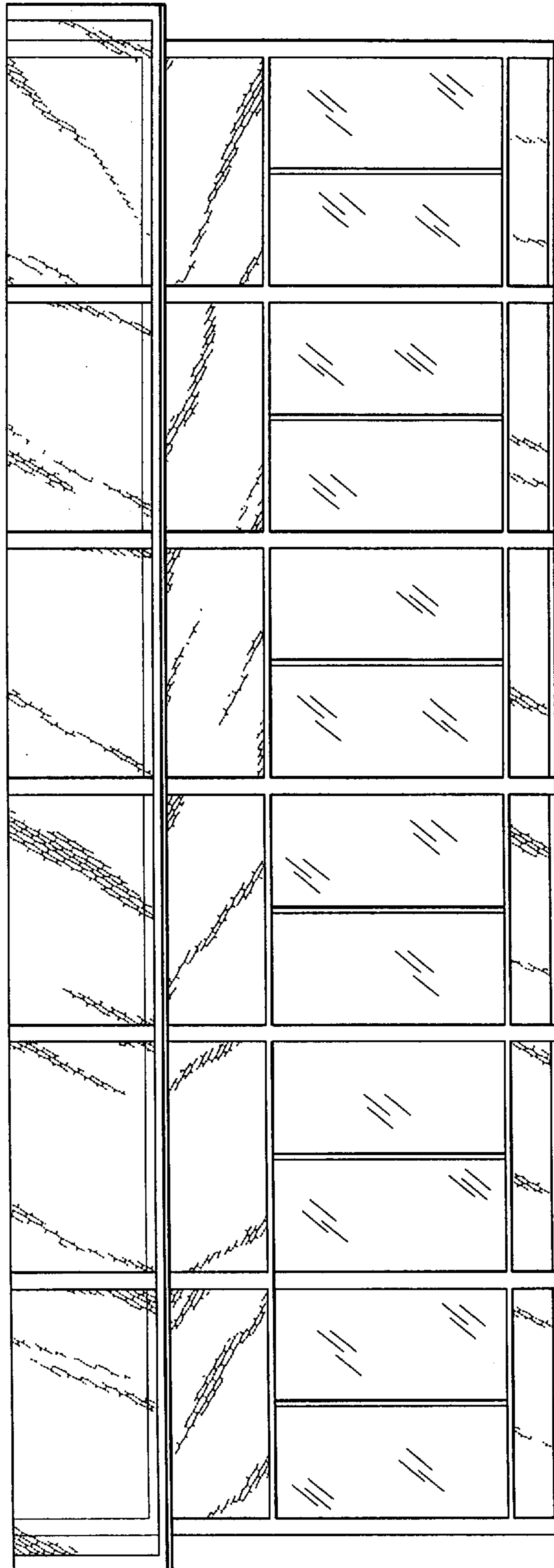

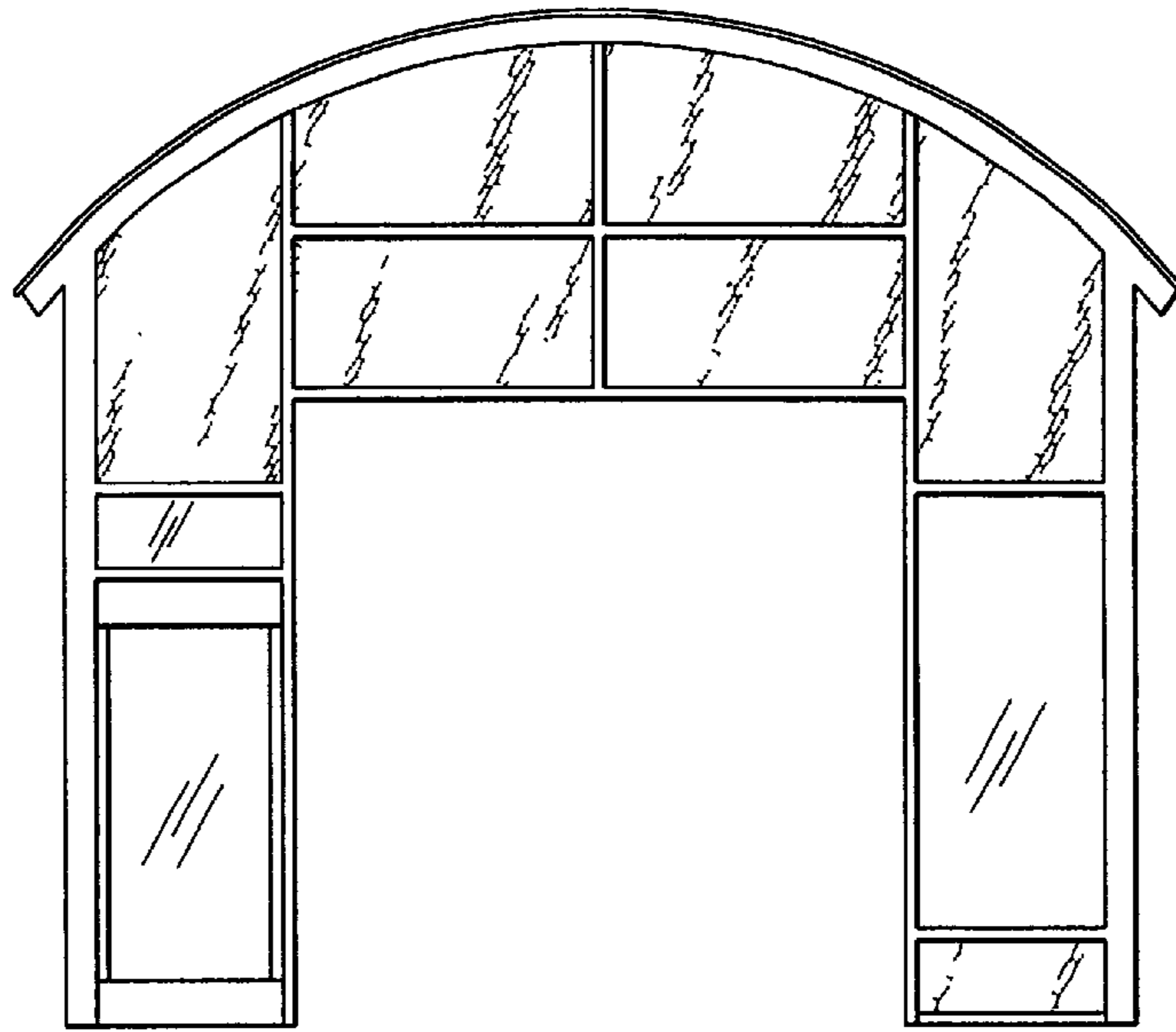

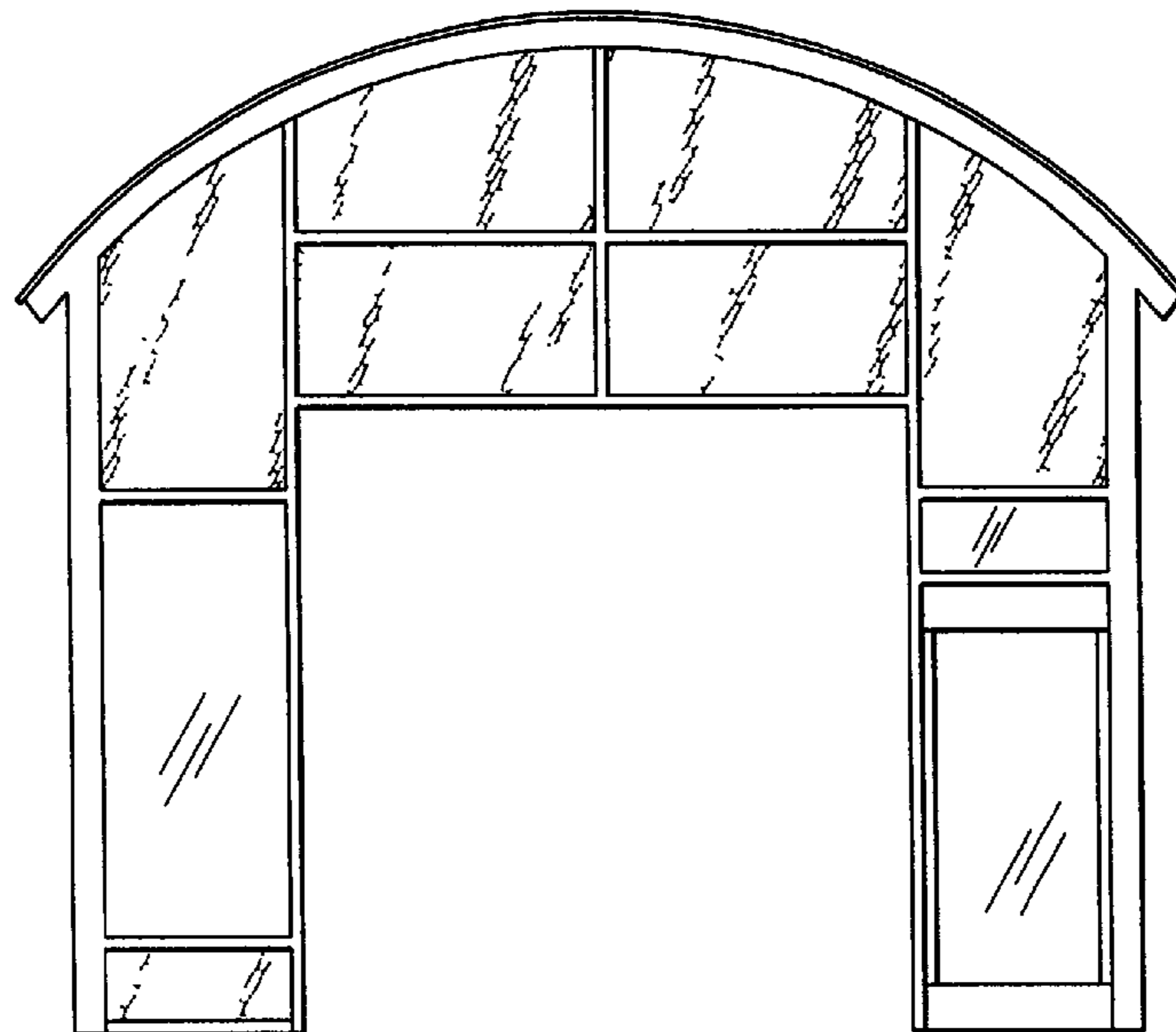

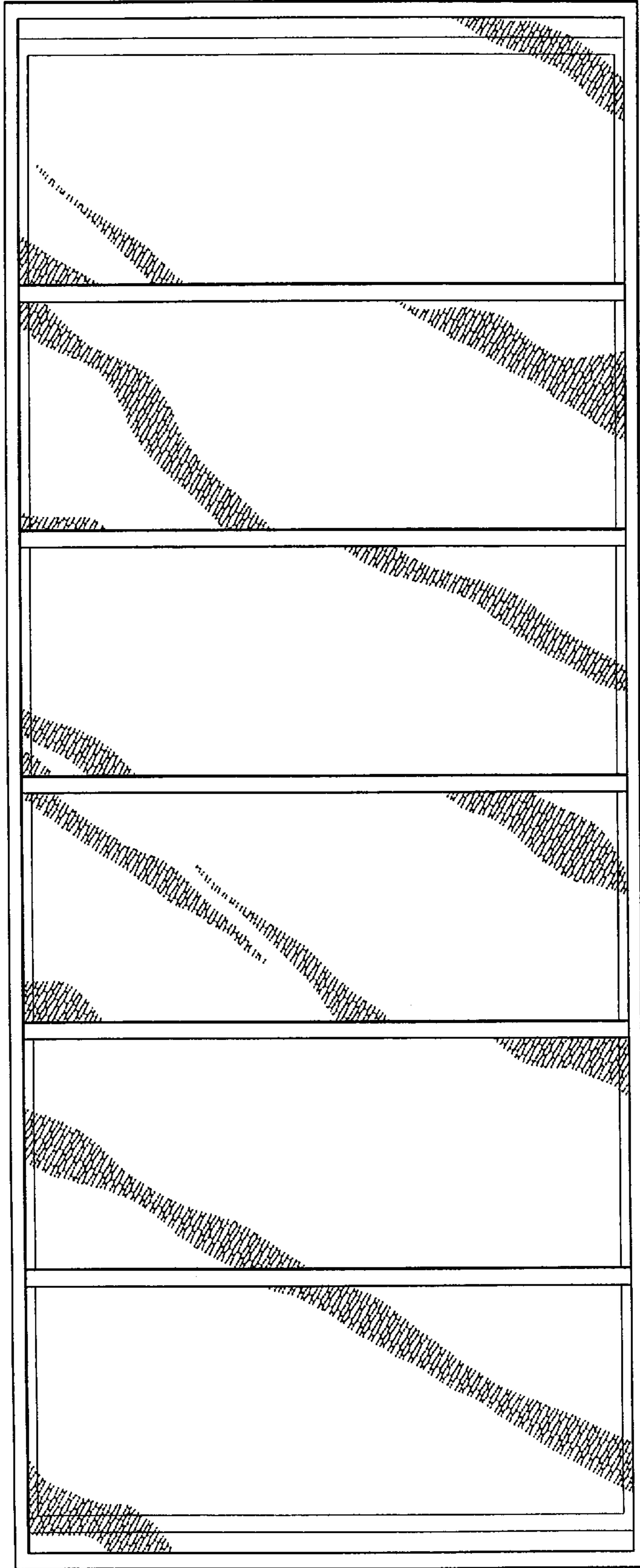
