FIG. 9 is a side view of an embodiment of the minidisc and accessory holder showing my new design;

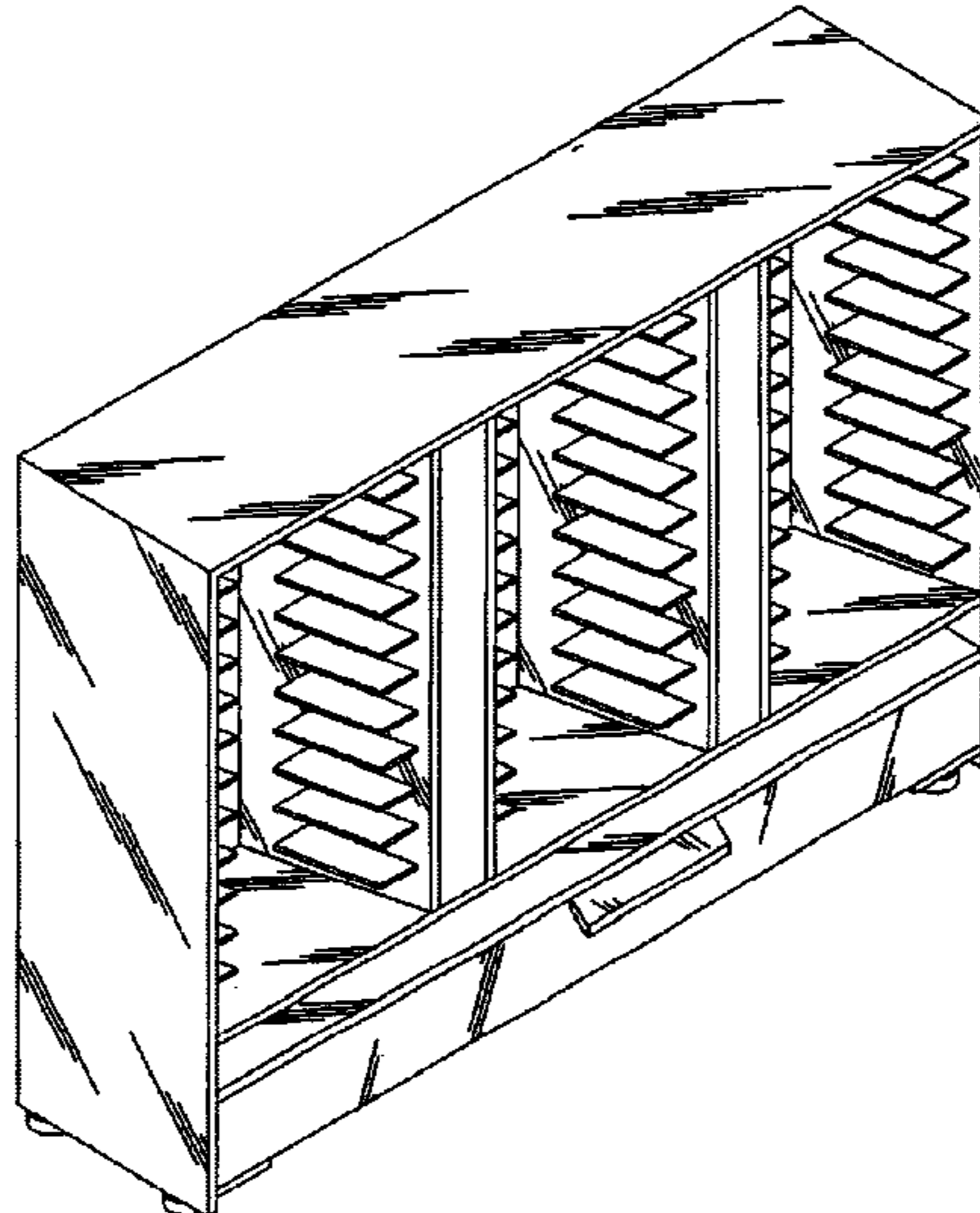
FIG. 10 is another side view of an embodiment of the minidisc and accessory holder showing my new design;

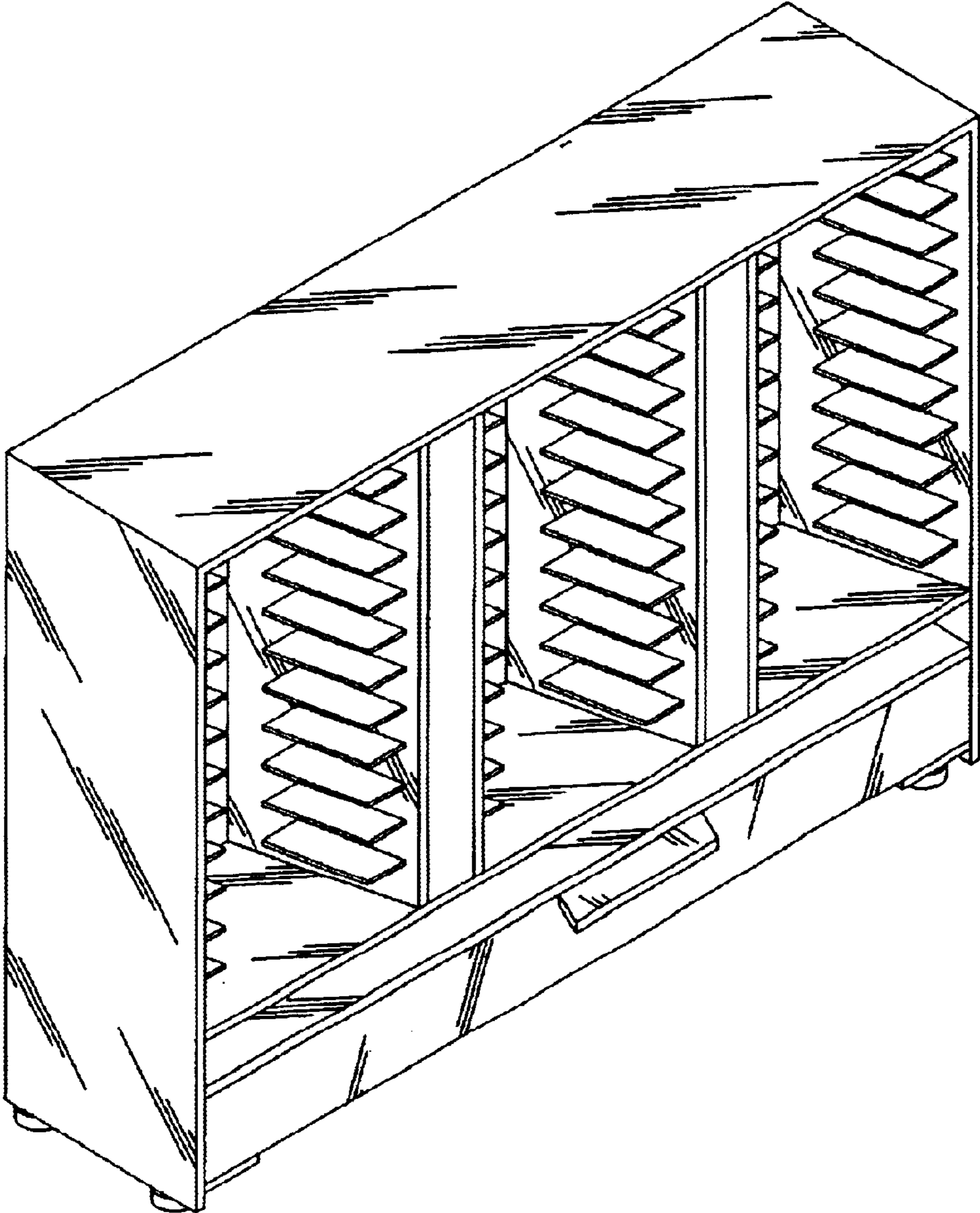

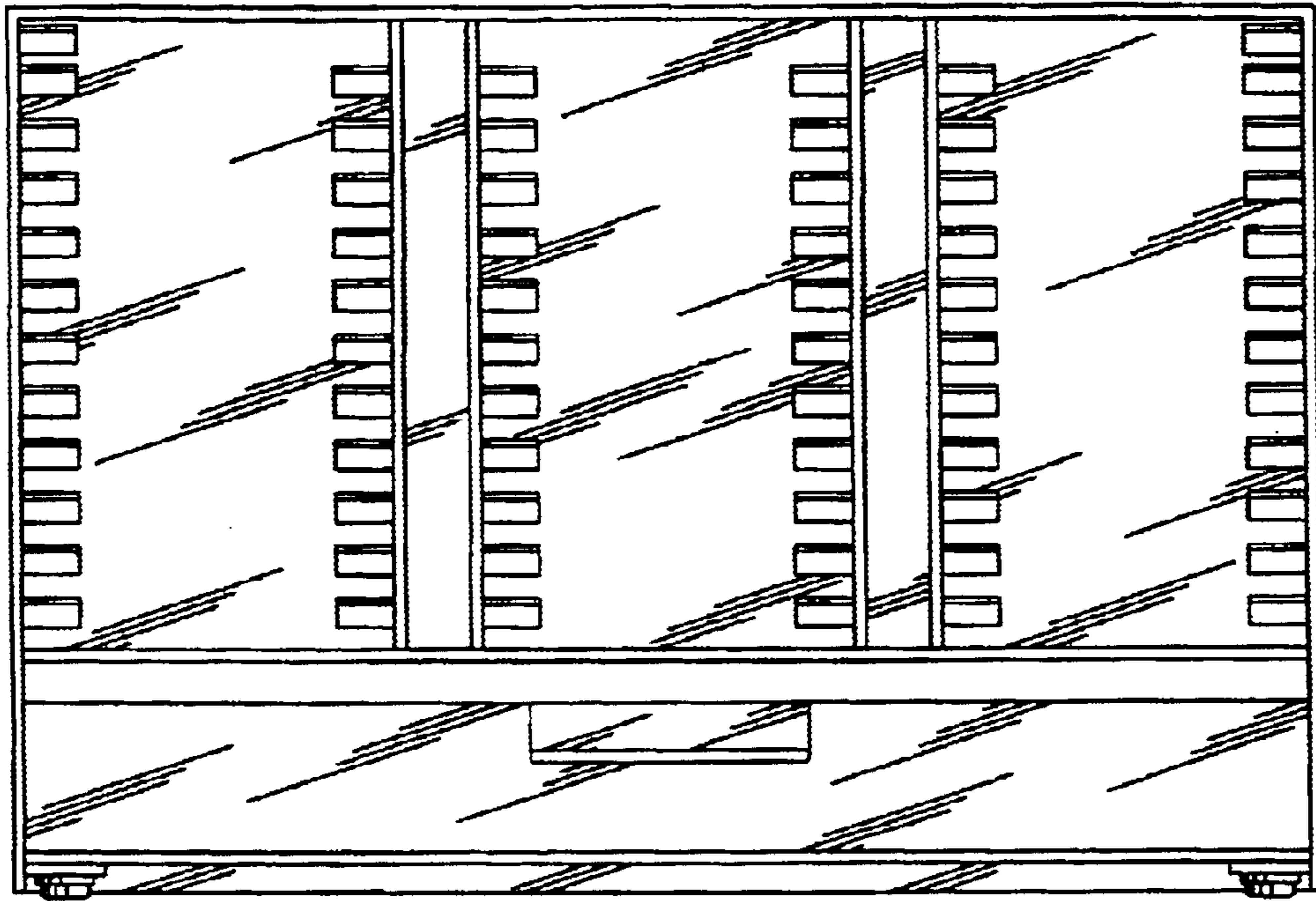

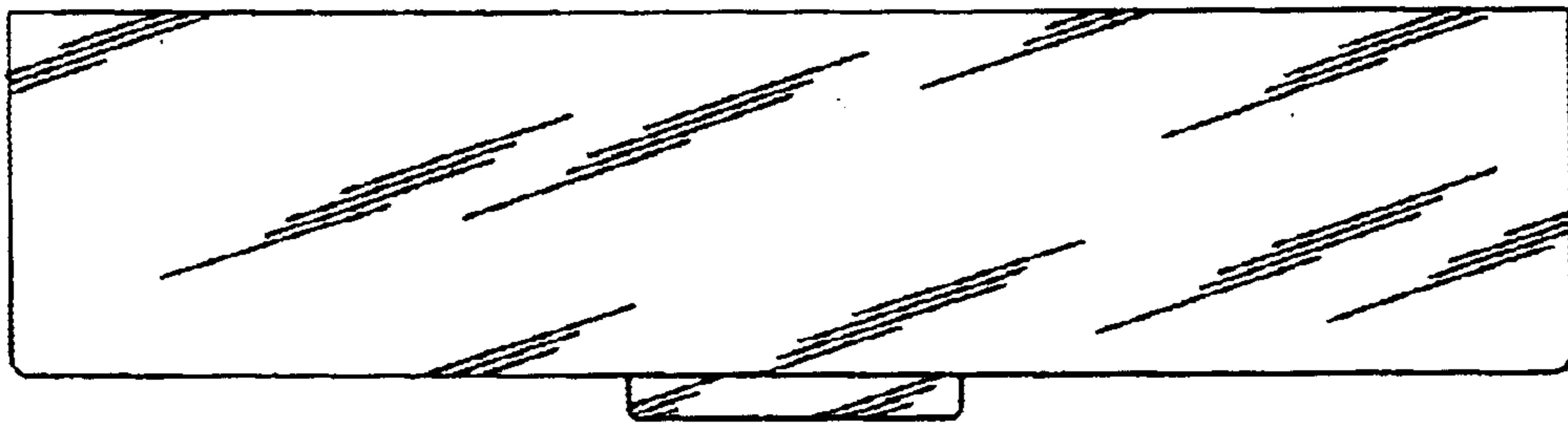

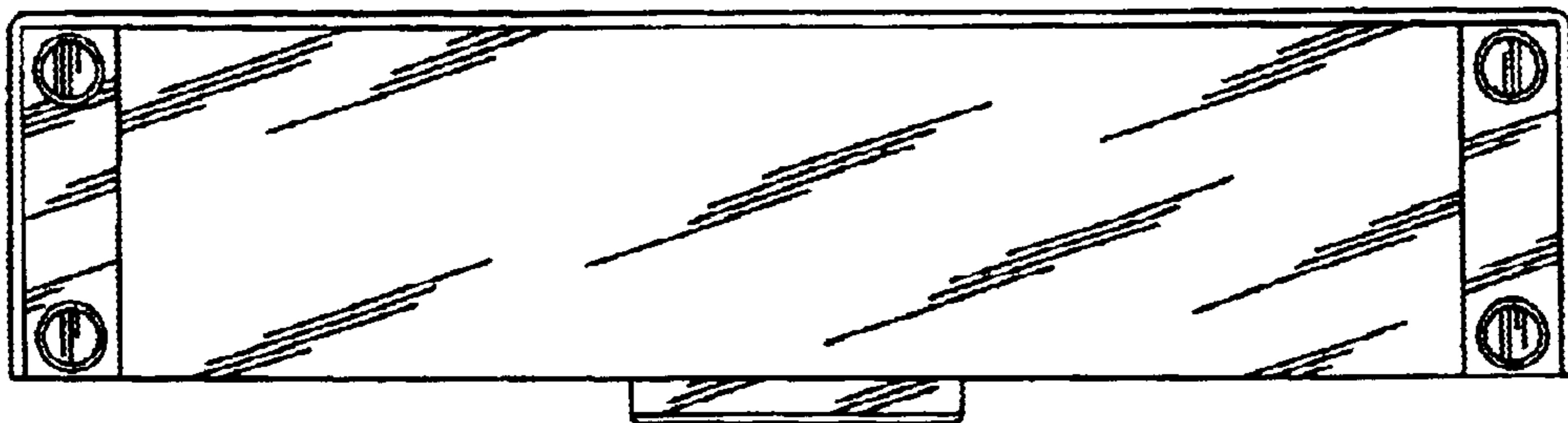

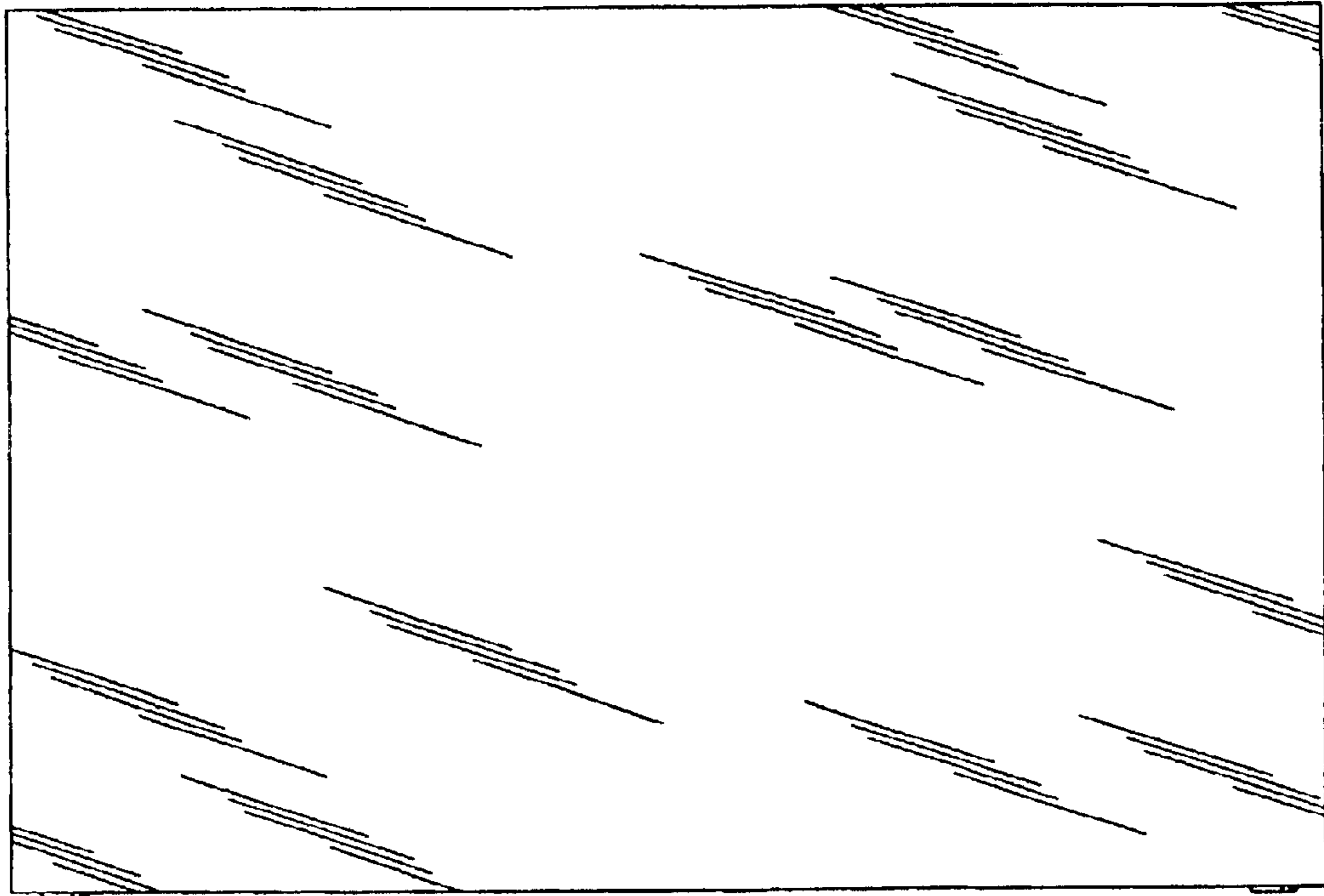

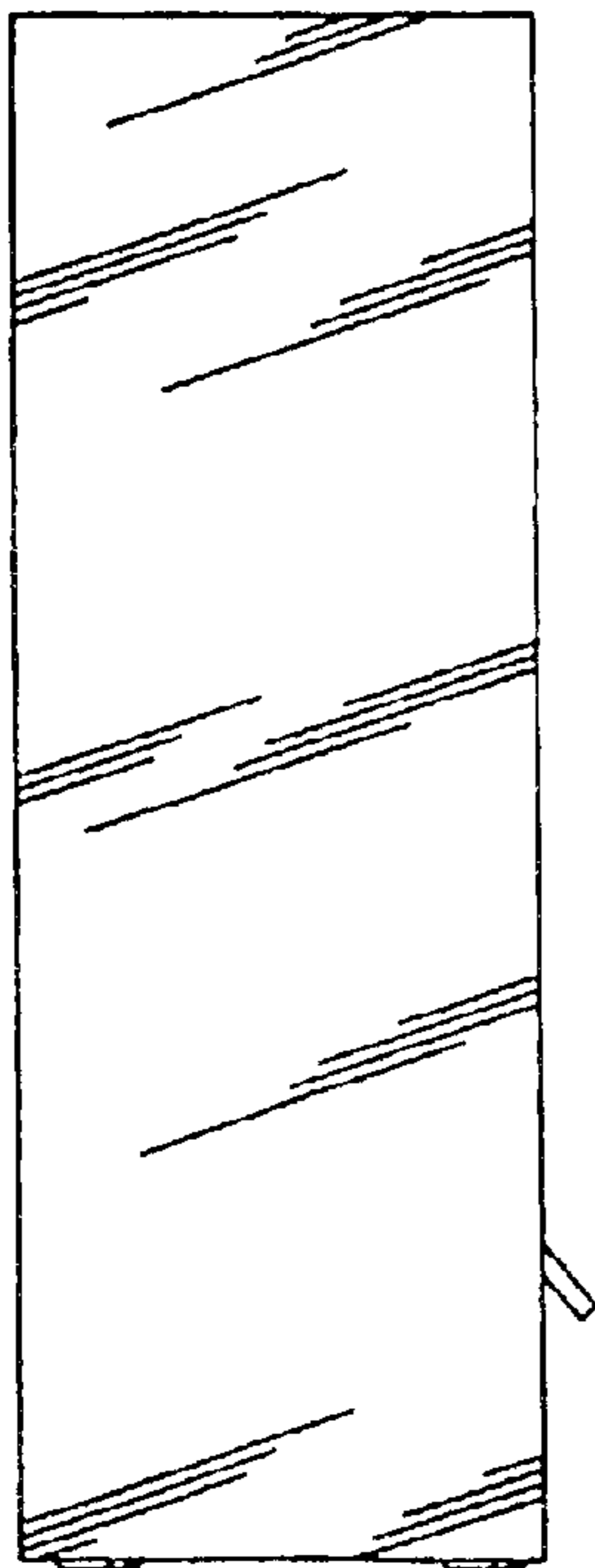

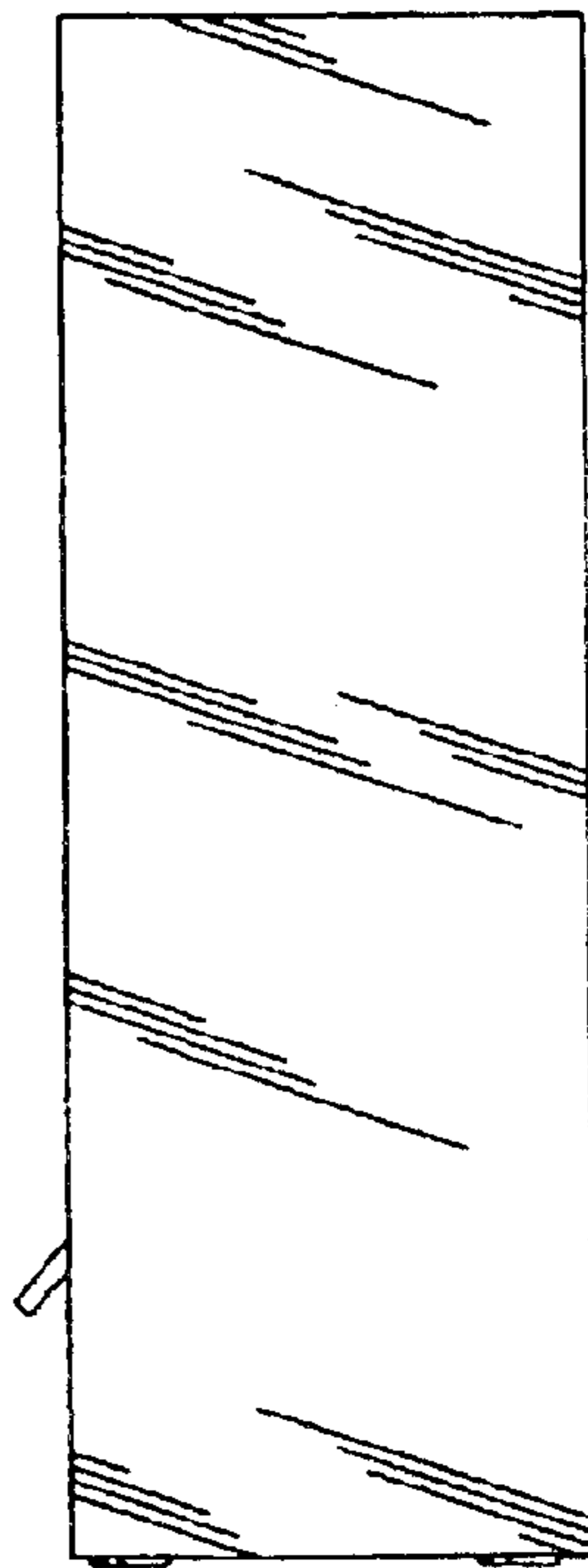

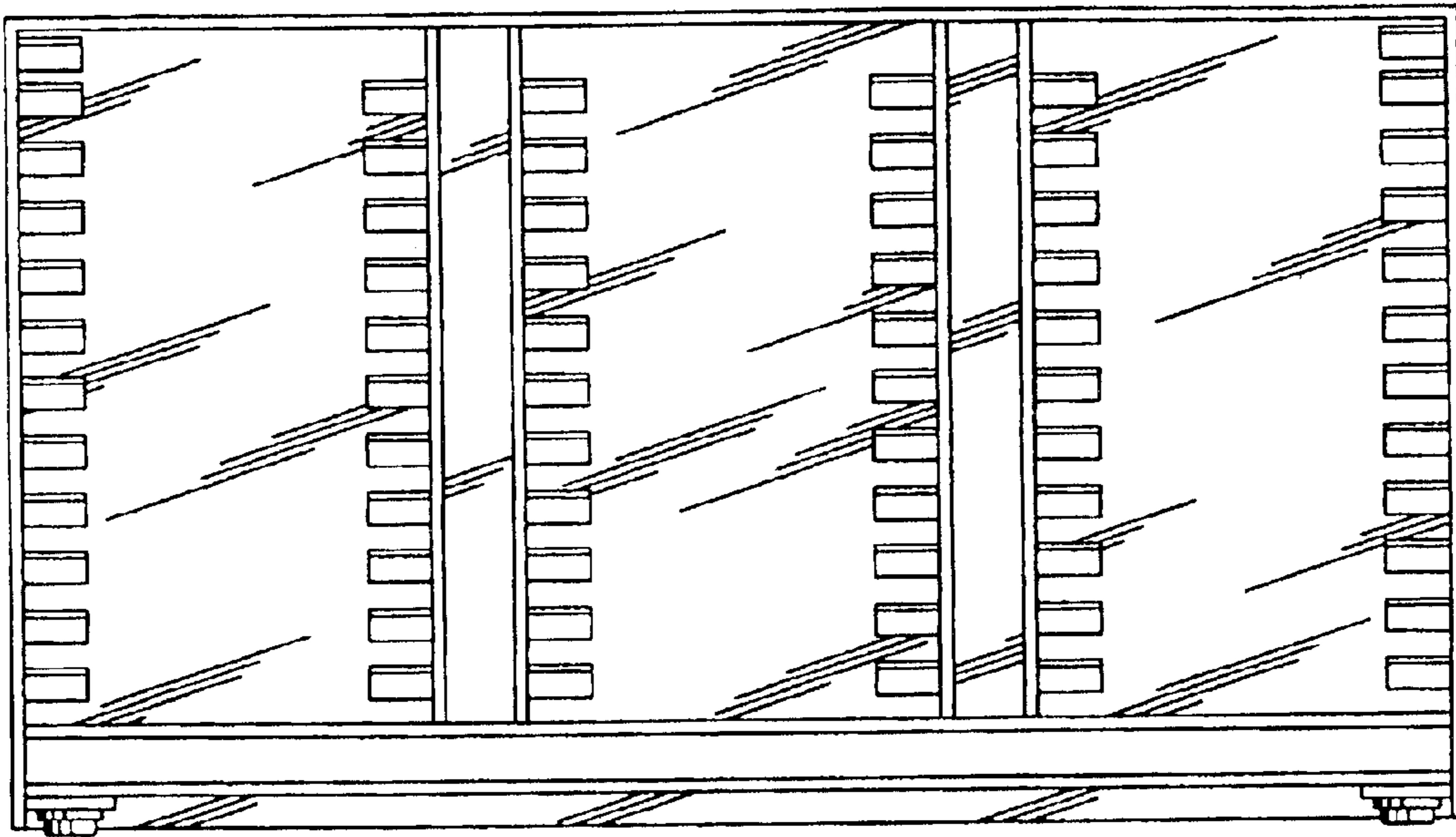

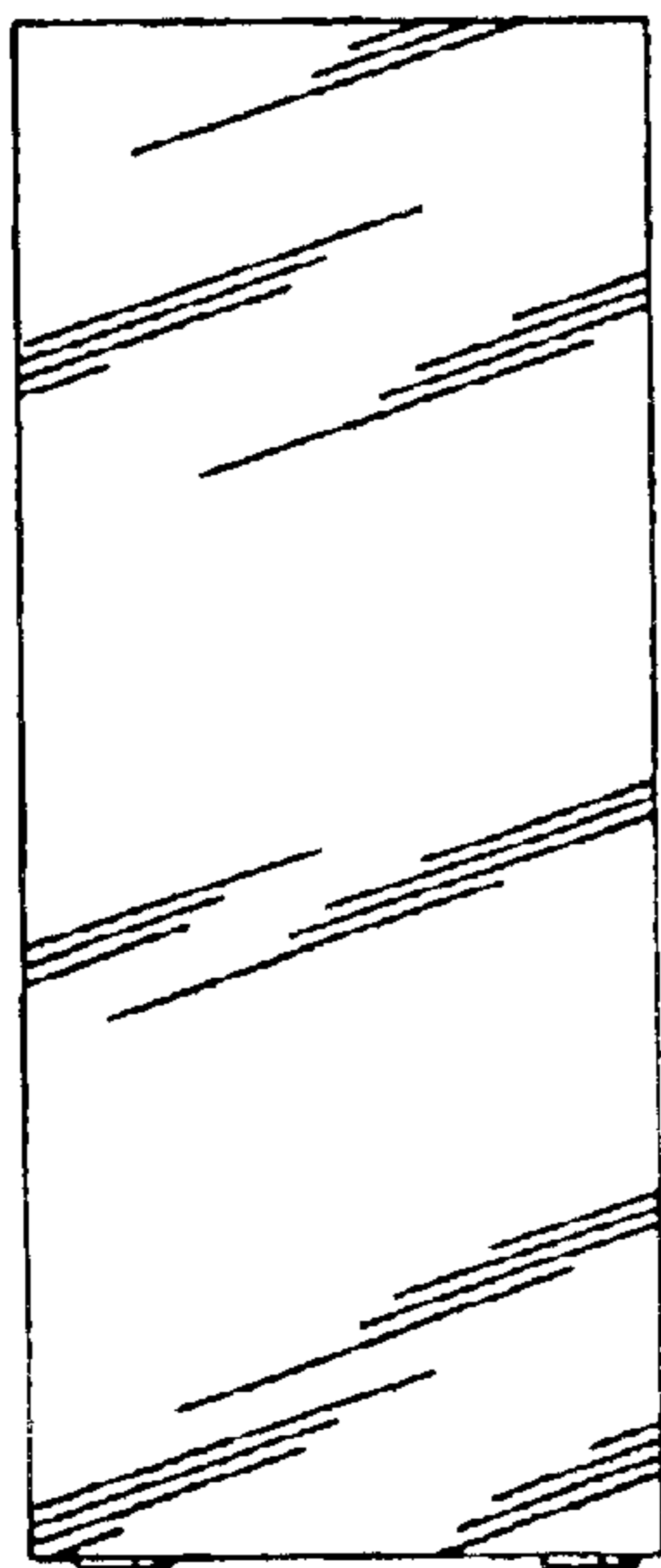

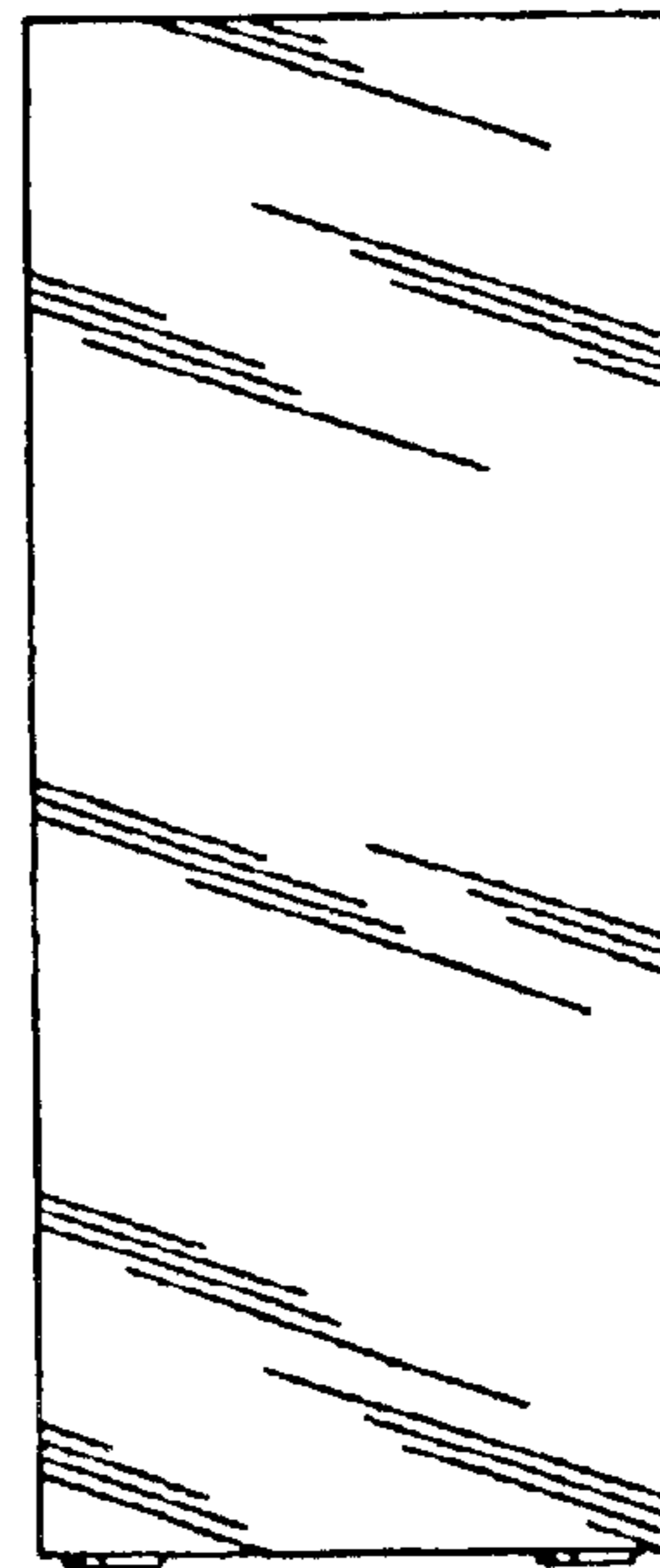

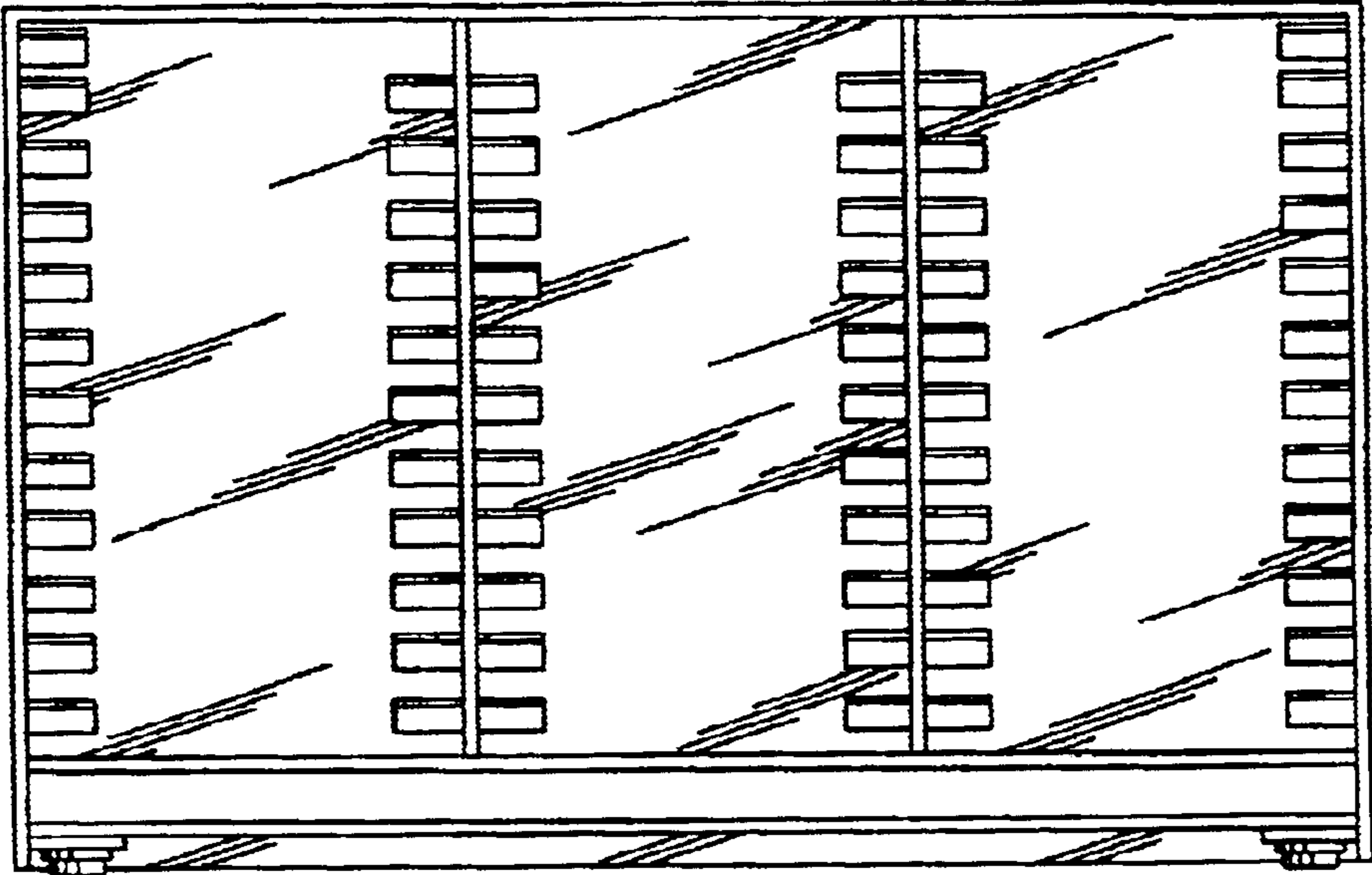

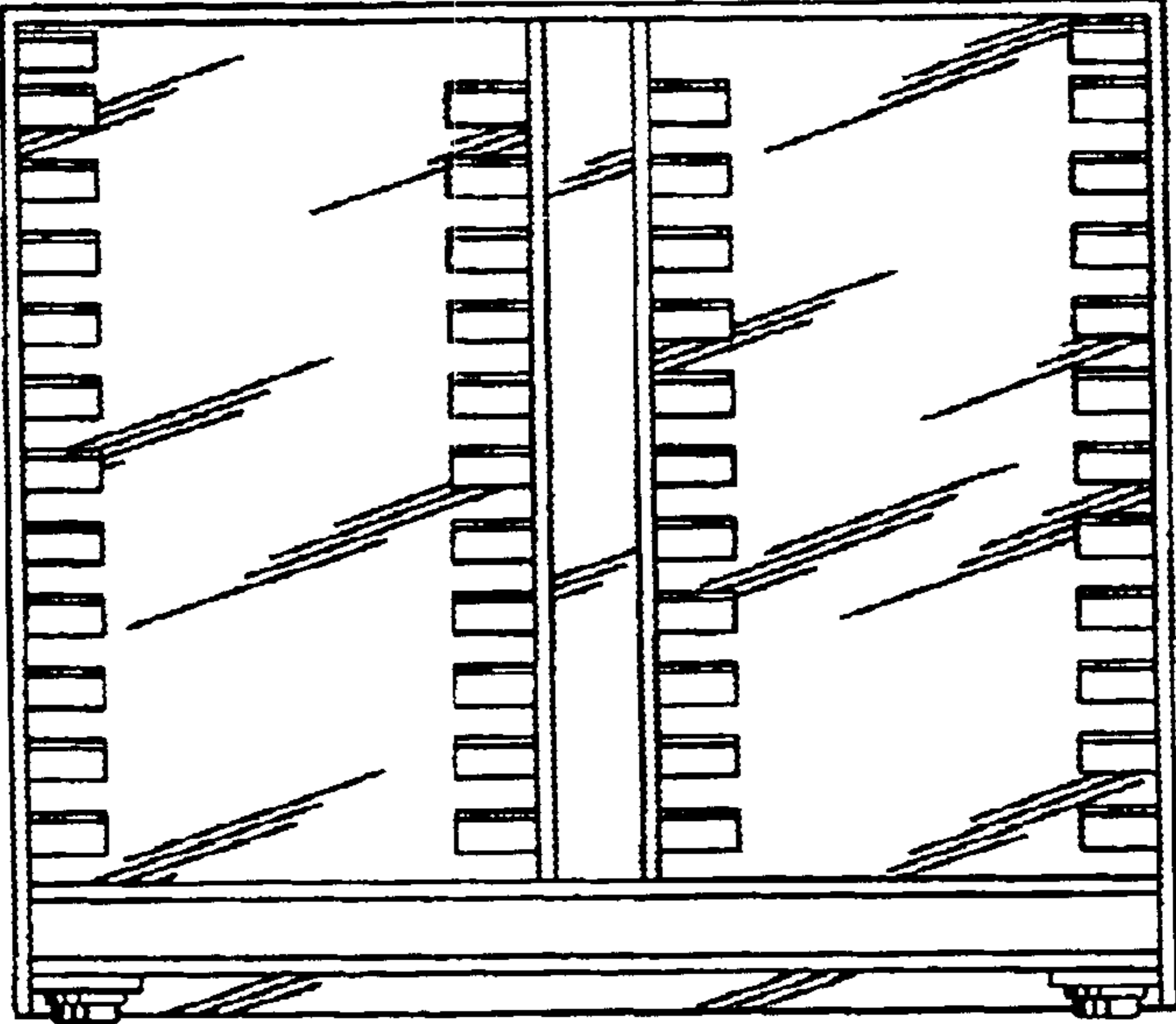

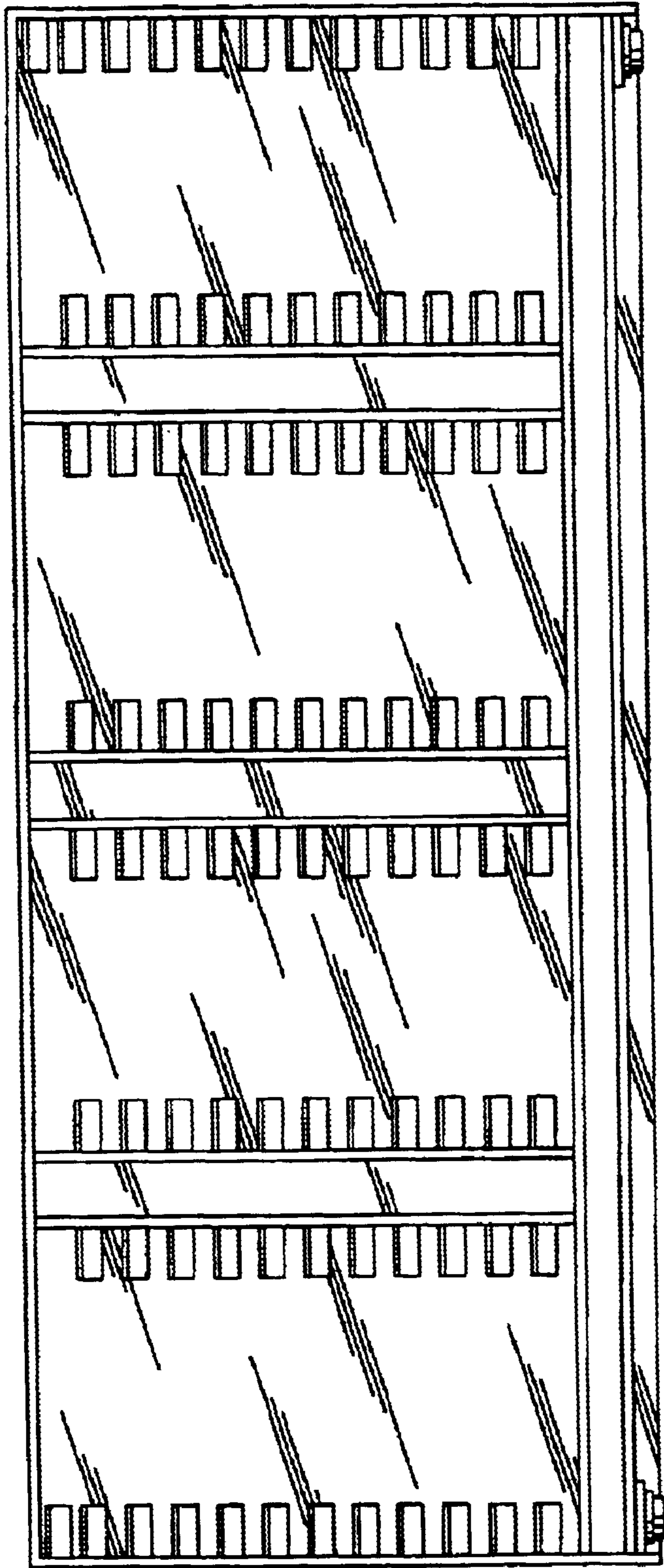
