FIG. 10 is a elevational view showing a further application of the present design, where those environmental features illustrated in dashed lines are not claimed in the present design;

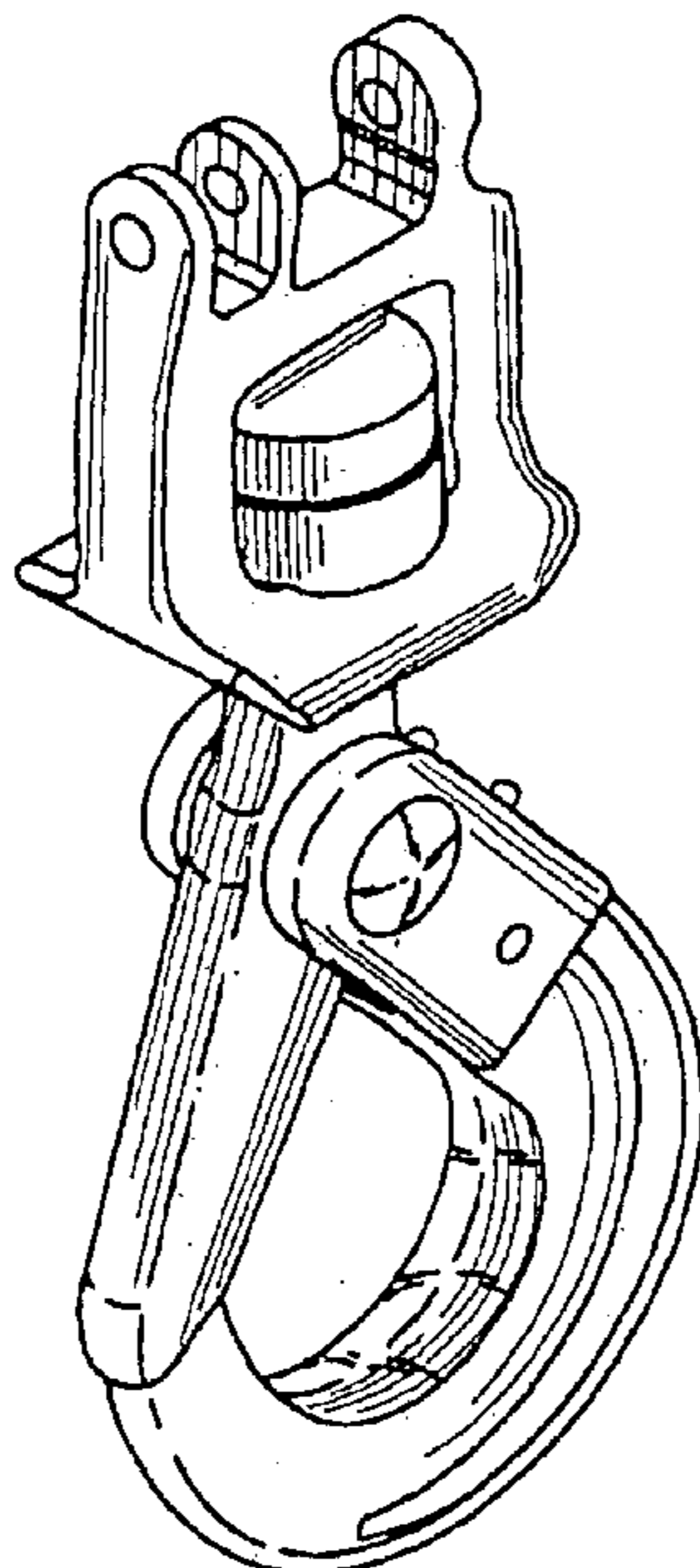
FIG. 11 is a elevational view showing yet another application of the present design, where those environmental features illustrated in dashed lines are not claimed in the present design; and,

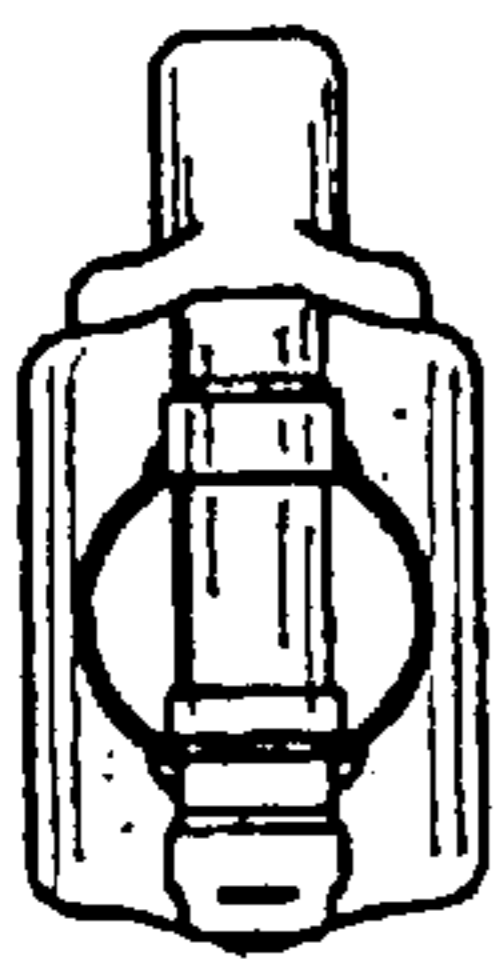

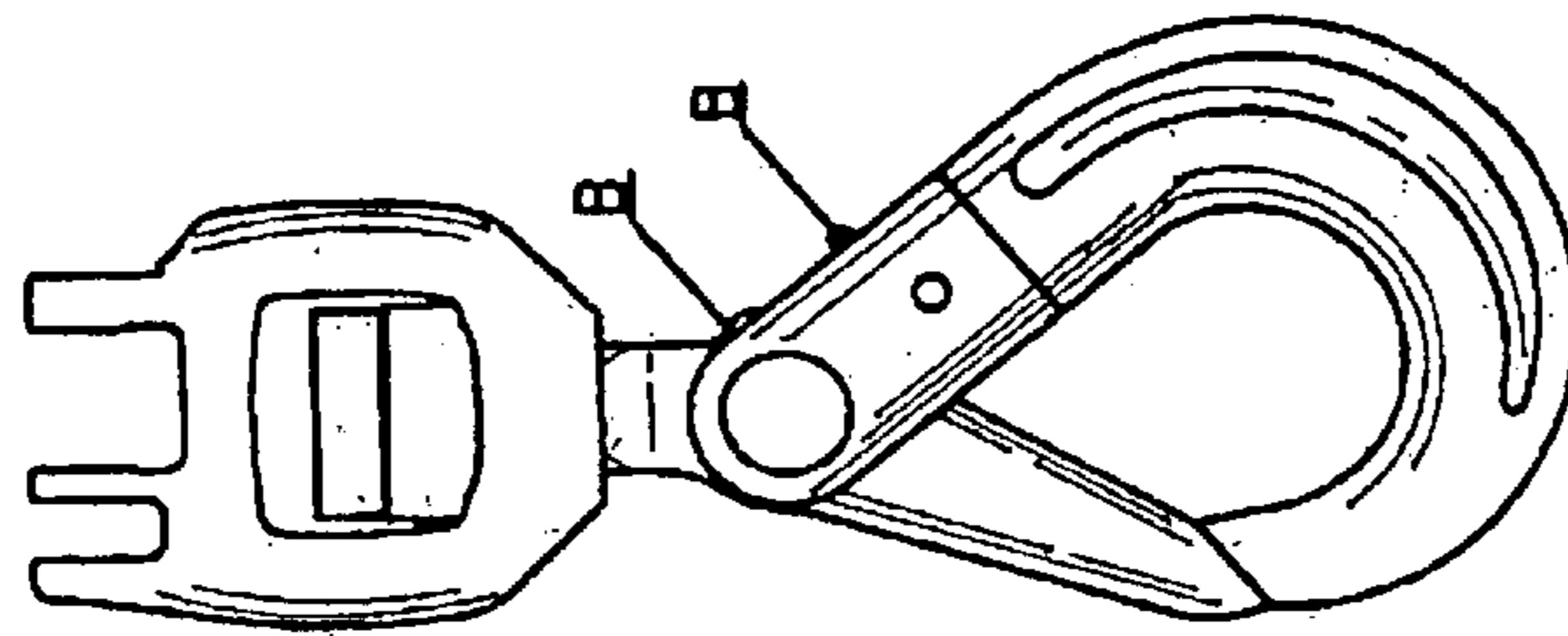

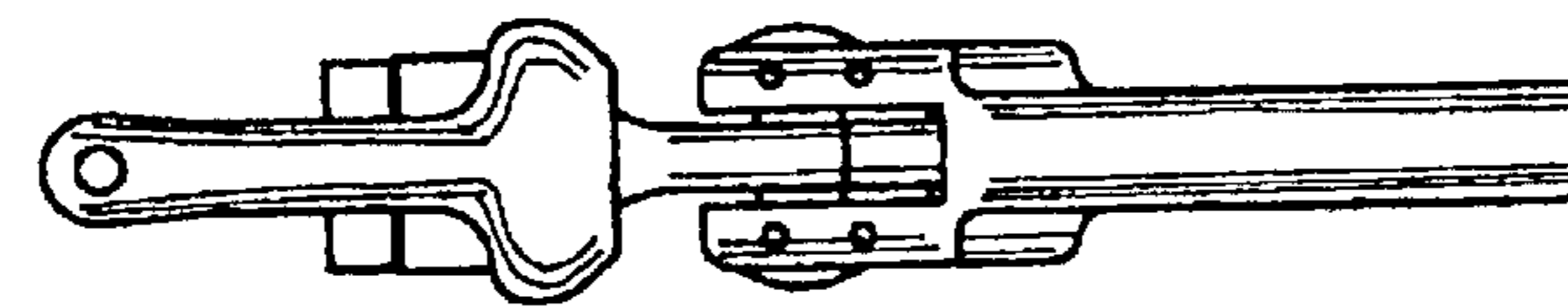

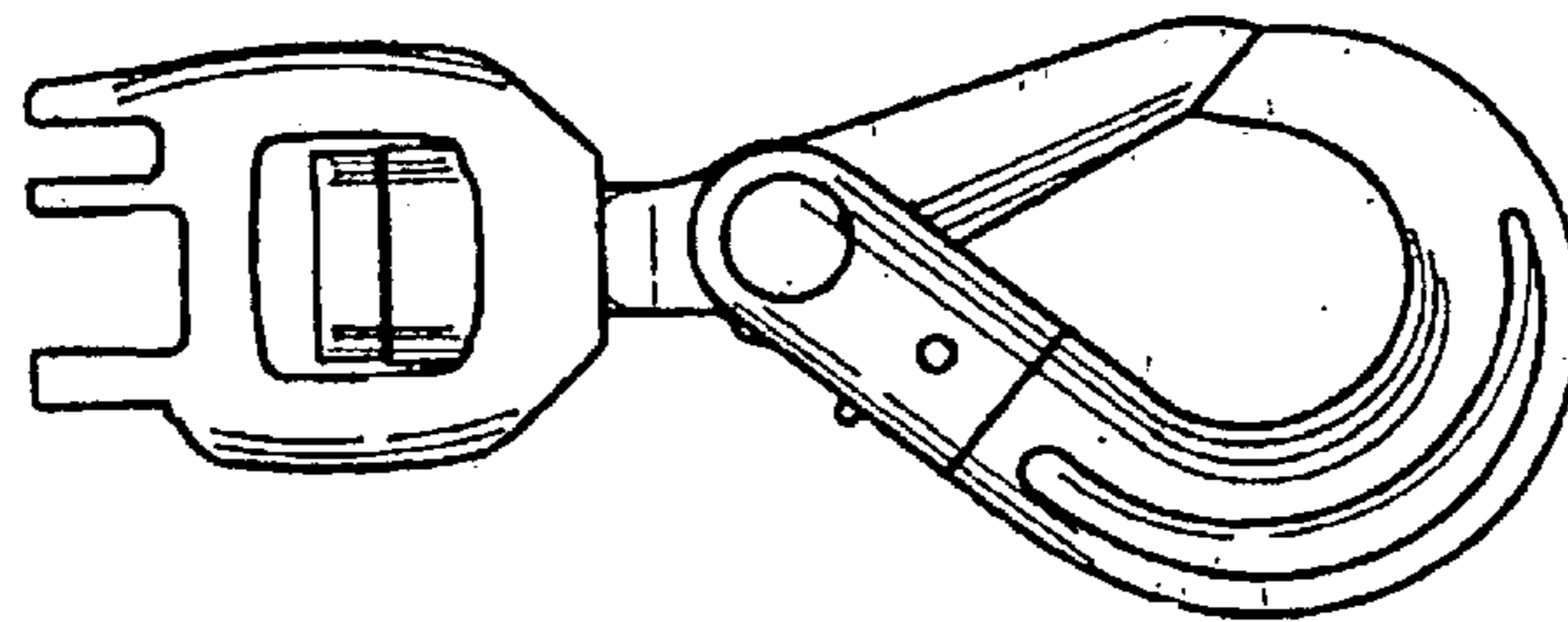

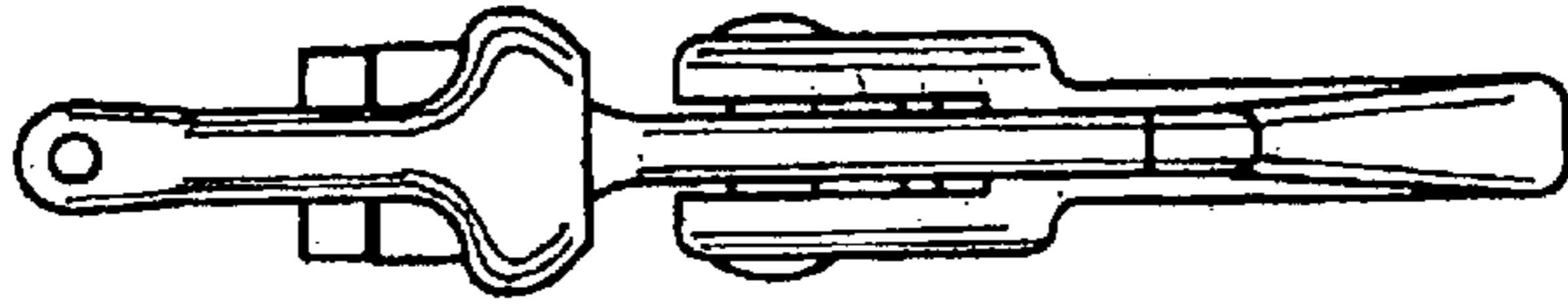

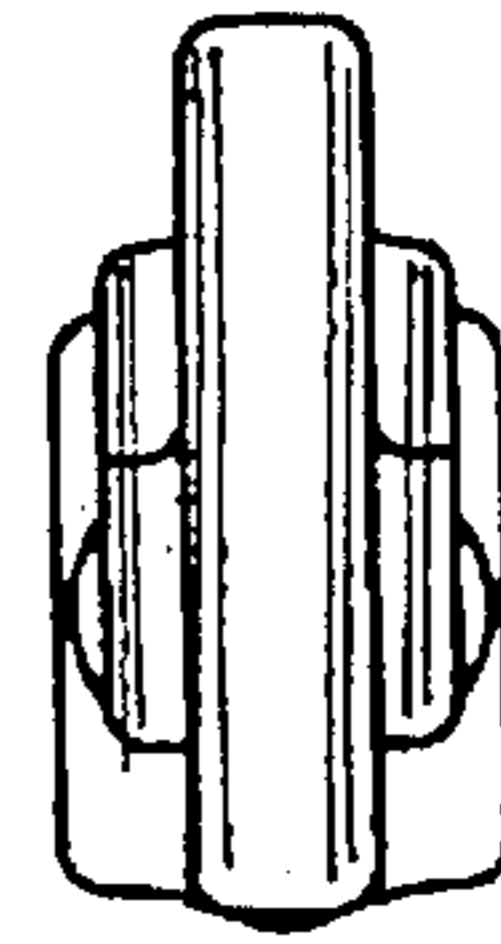

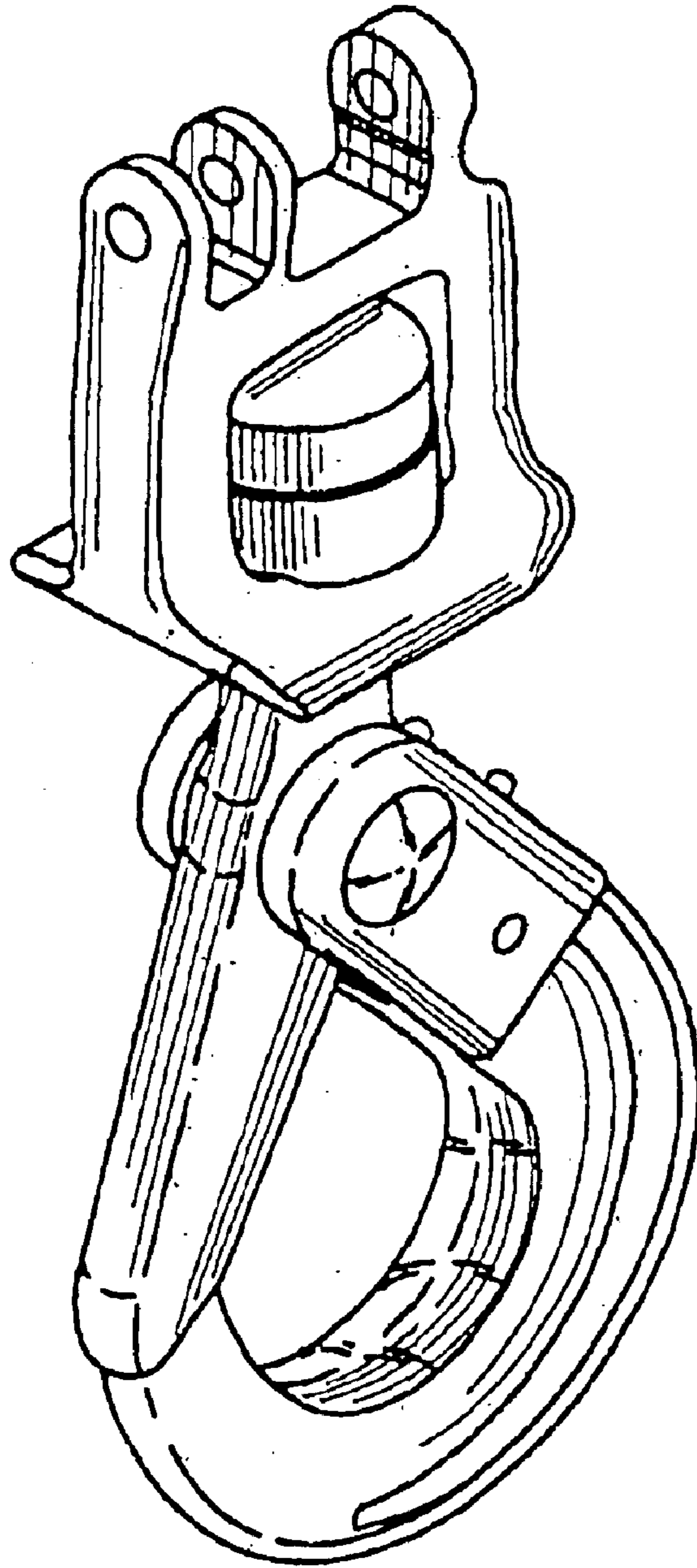

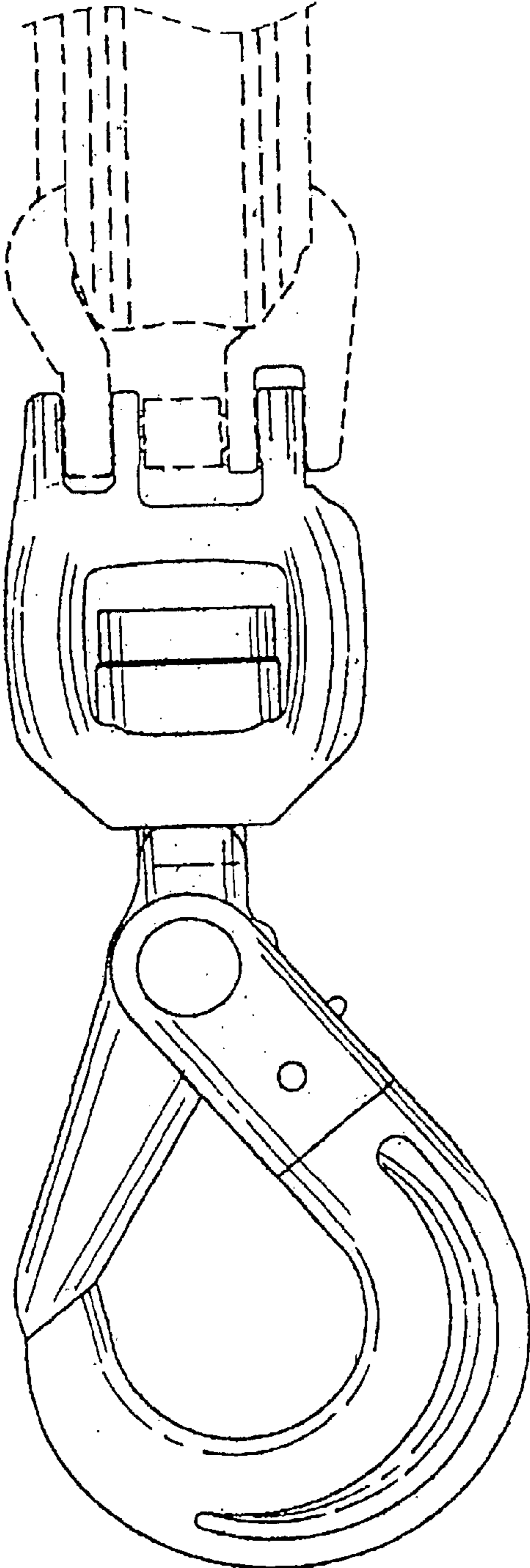

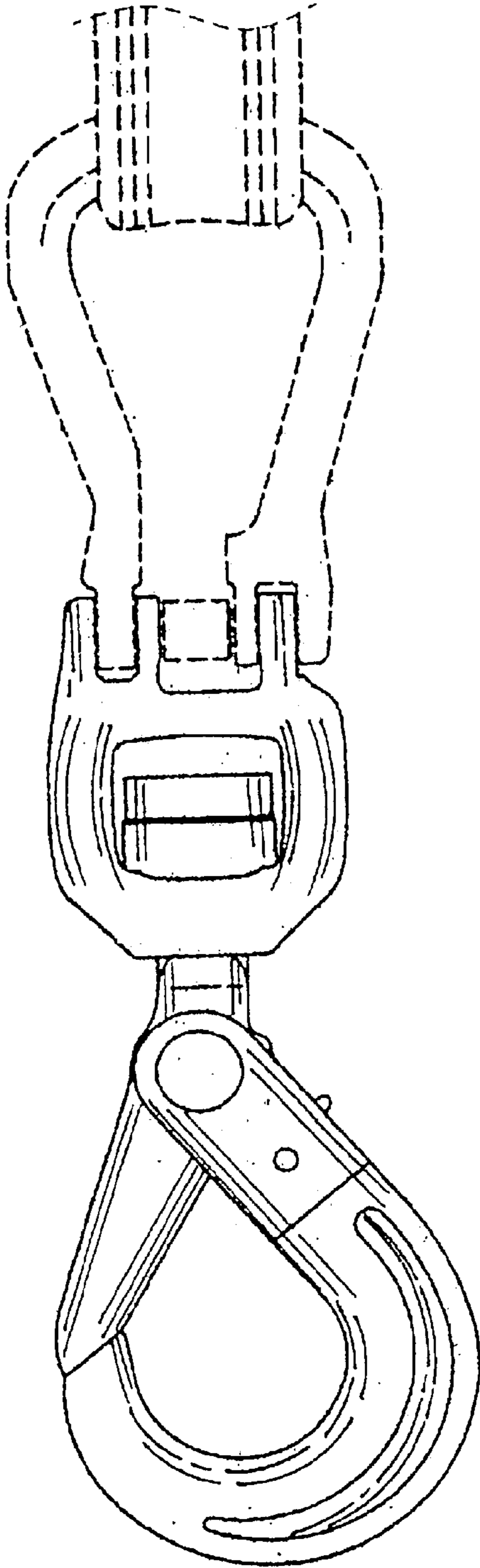

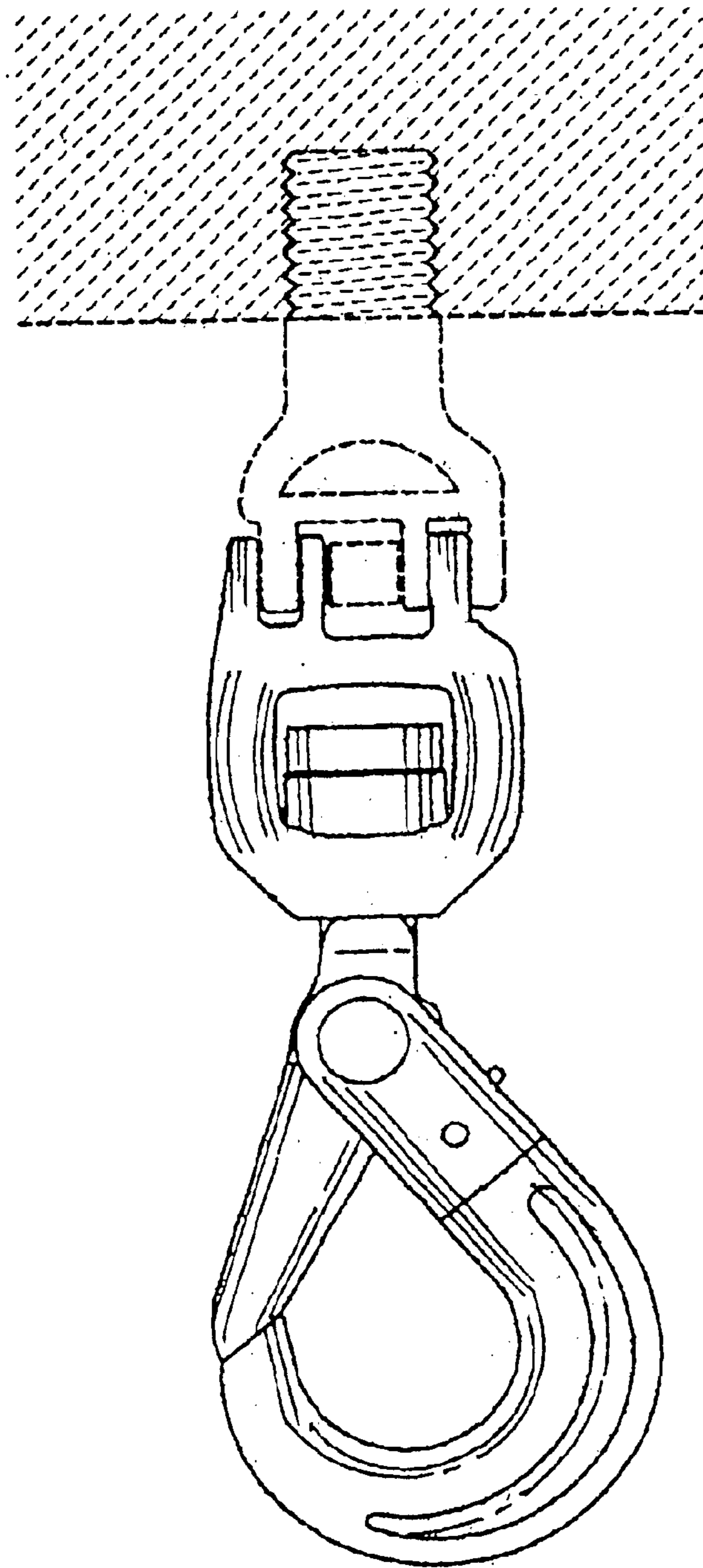

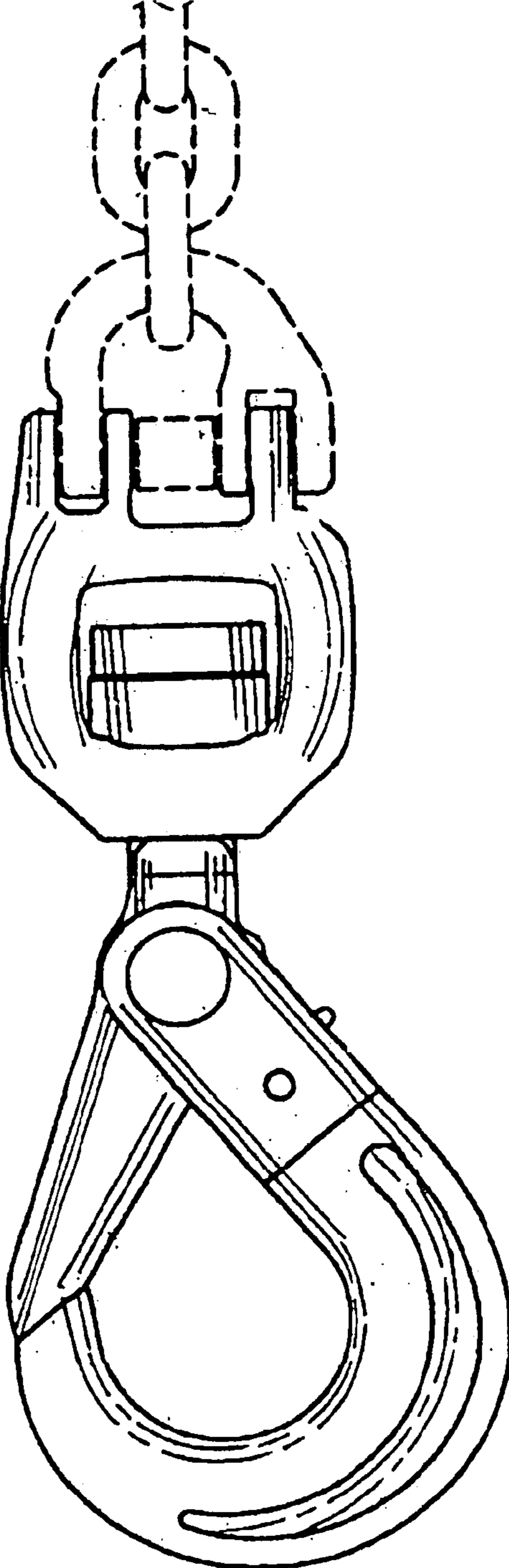

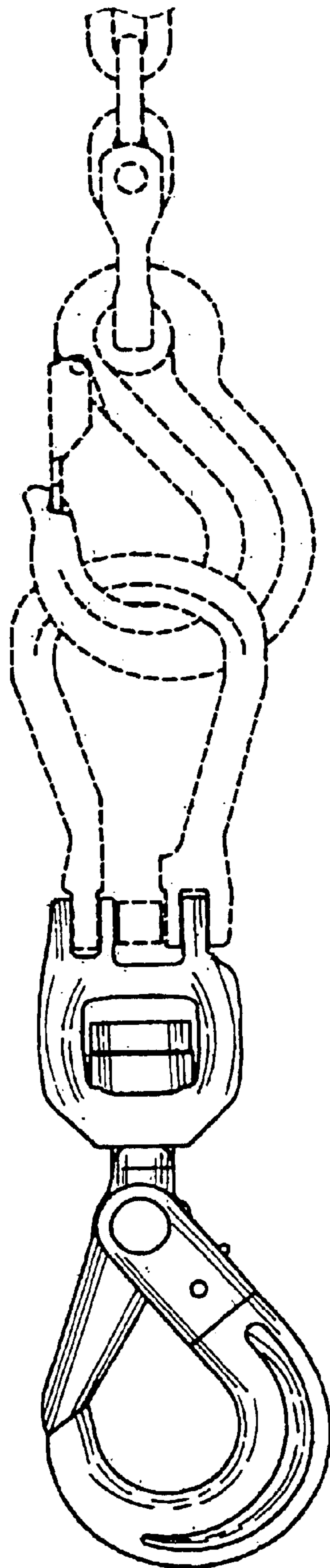
