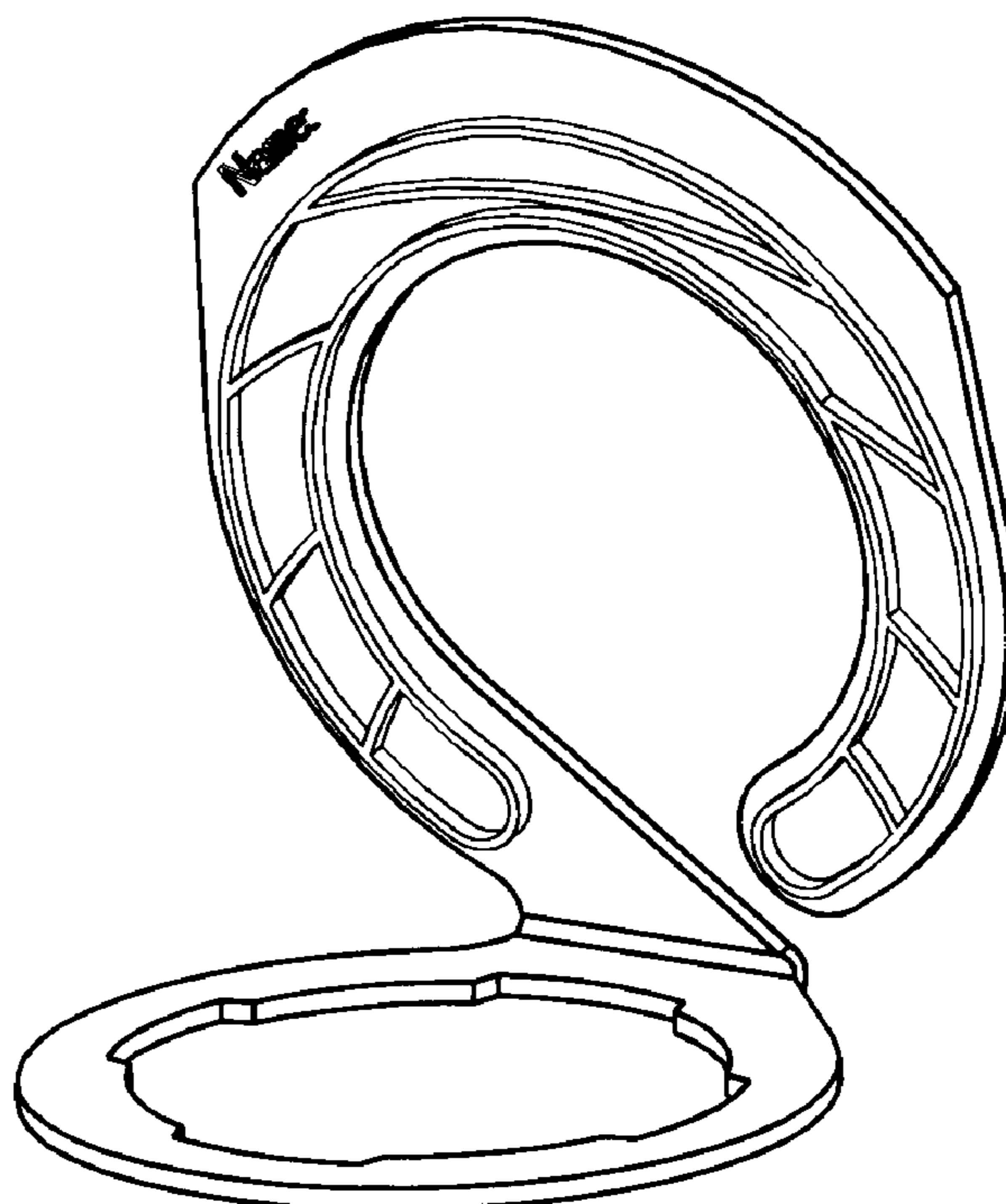
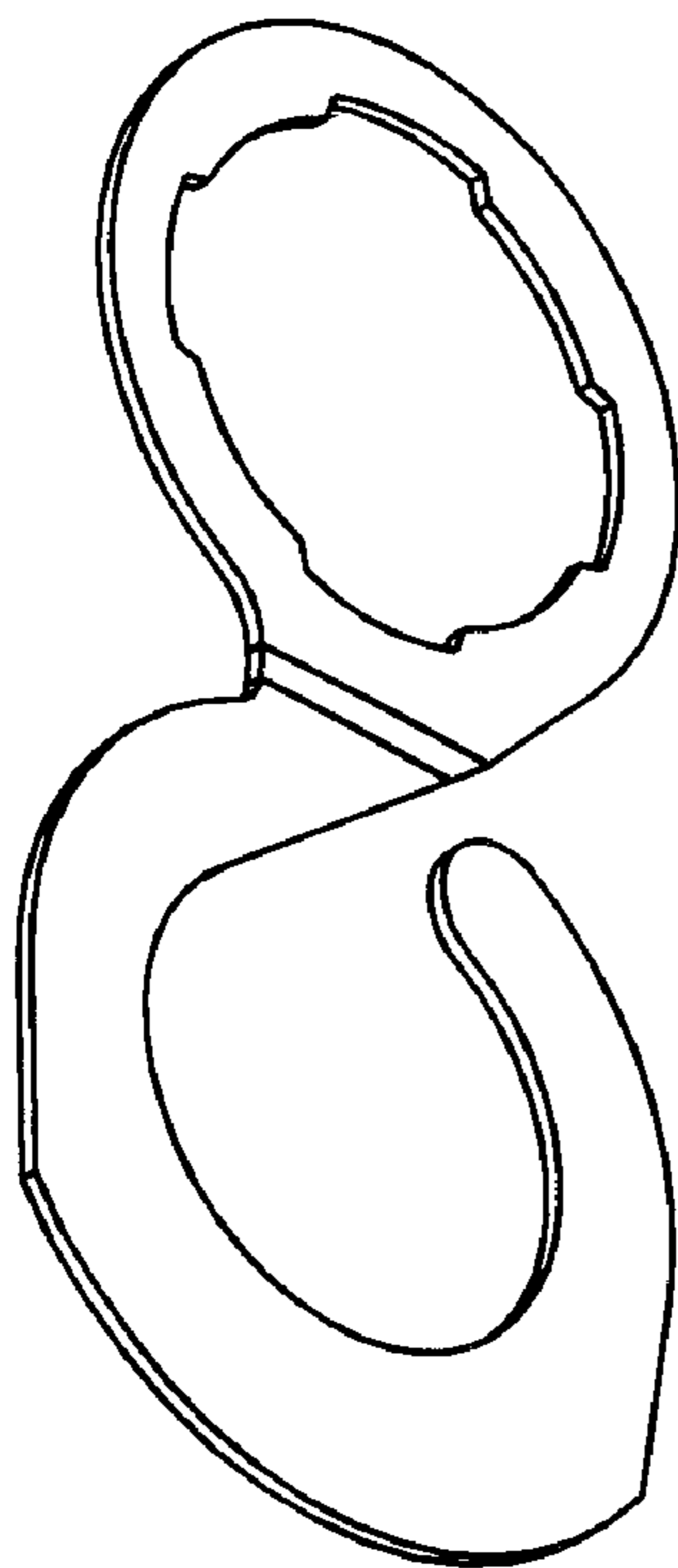
(57) **CLAIM**

The ornamental design for a carrying device for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a bottom view of a carrying device for a bottle showing an embodiment of my new design; FIG. 2 is a top view of the embodiment shown in FIG. 1; FIG. 3 is a bottom perspective view of the embodiment shown in FIG. 1; FIG. 4 is a top perspective view of the embodiment shown in FIG. 1; FIG. 5 is a bottom view of the embodiment shown in FIG. 1 in a folded condition; FIG. 6 is a top view of the embodiment shown in FIG. 1 in a folded condition; and, FIG. 7 is a perspective top view of the embodiment shown in FIG. 1 in a partially folded condition.

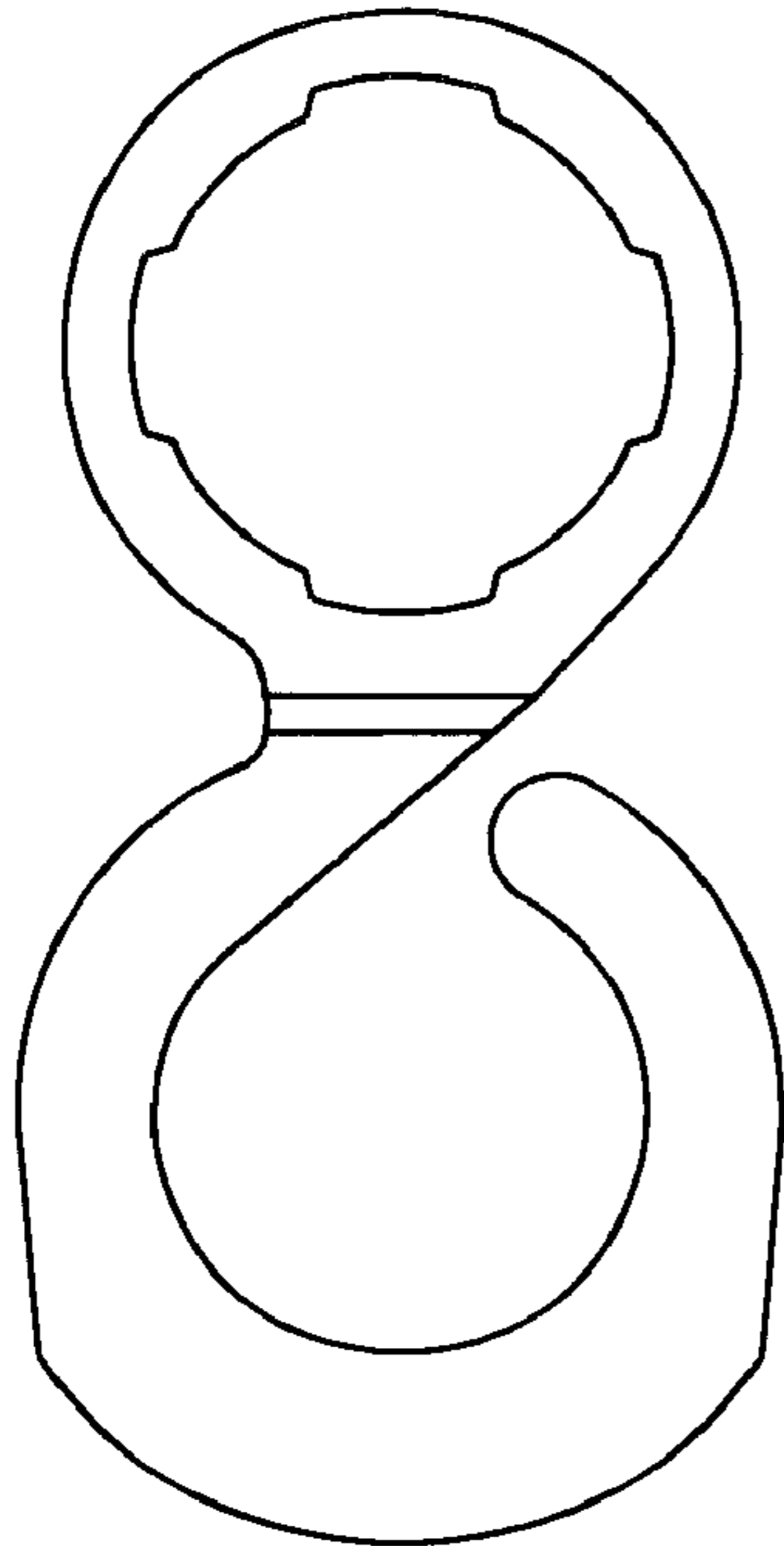

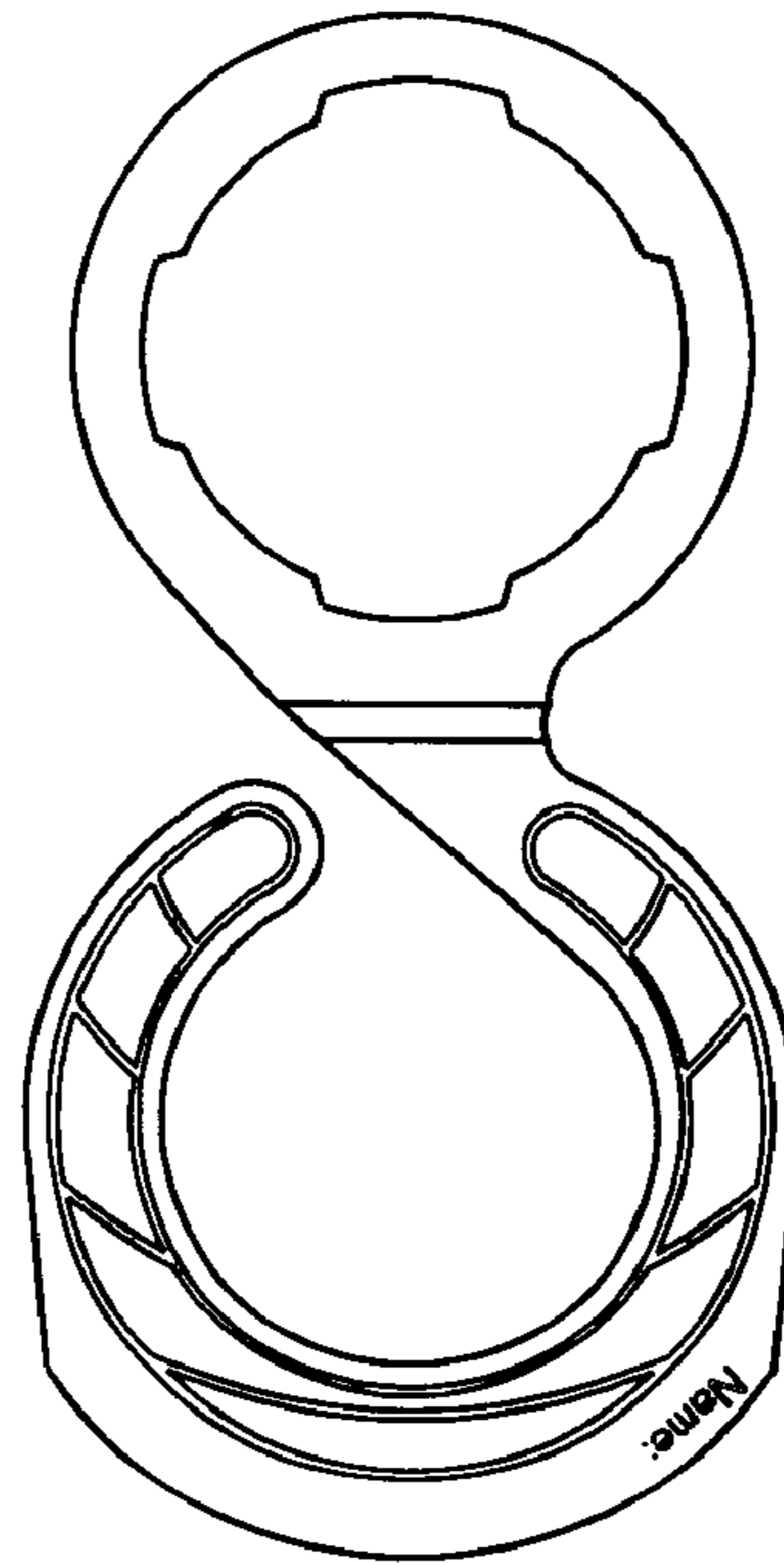

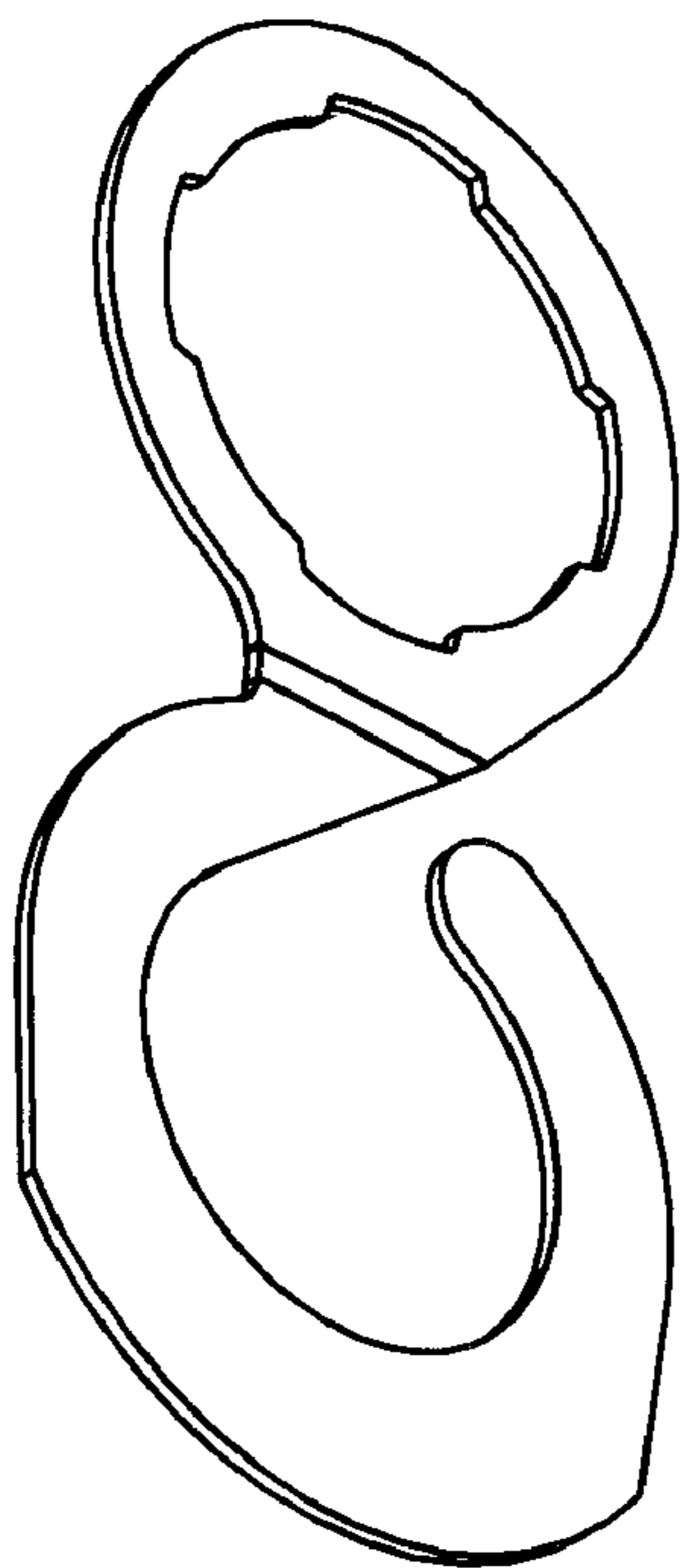

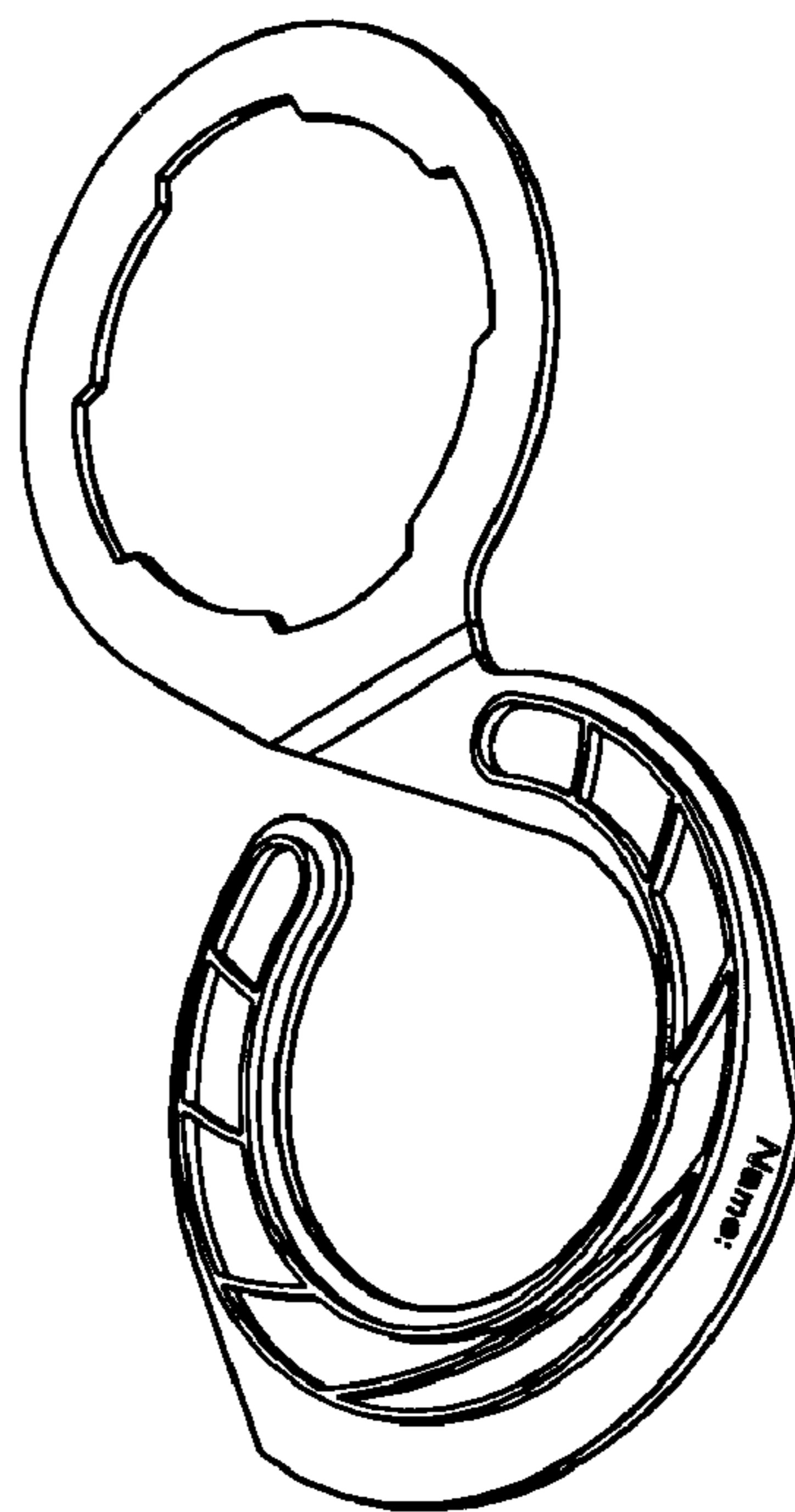

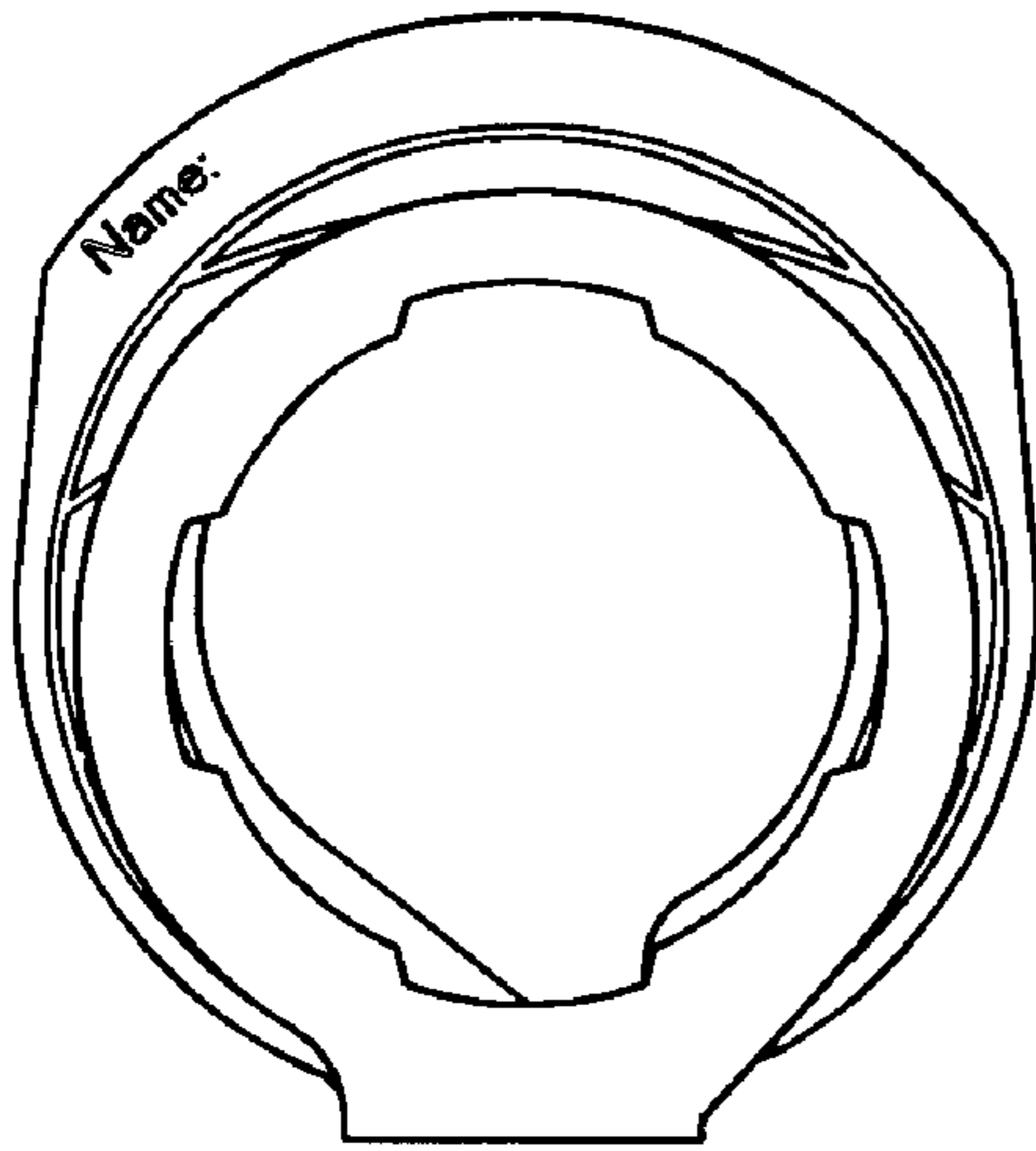

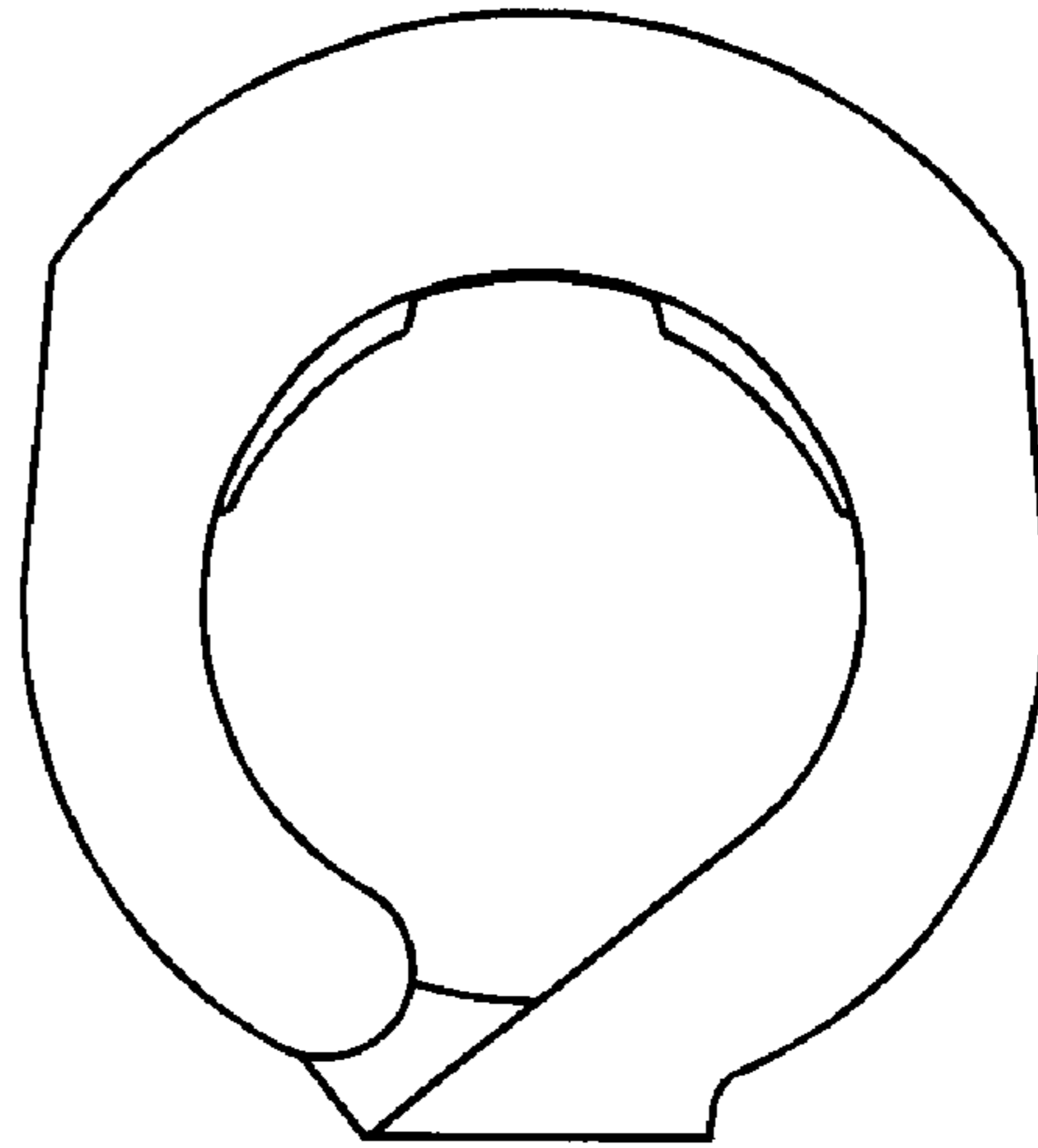

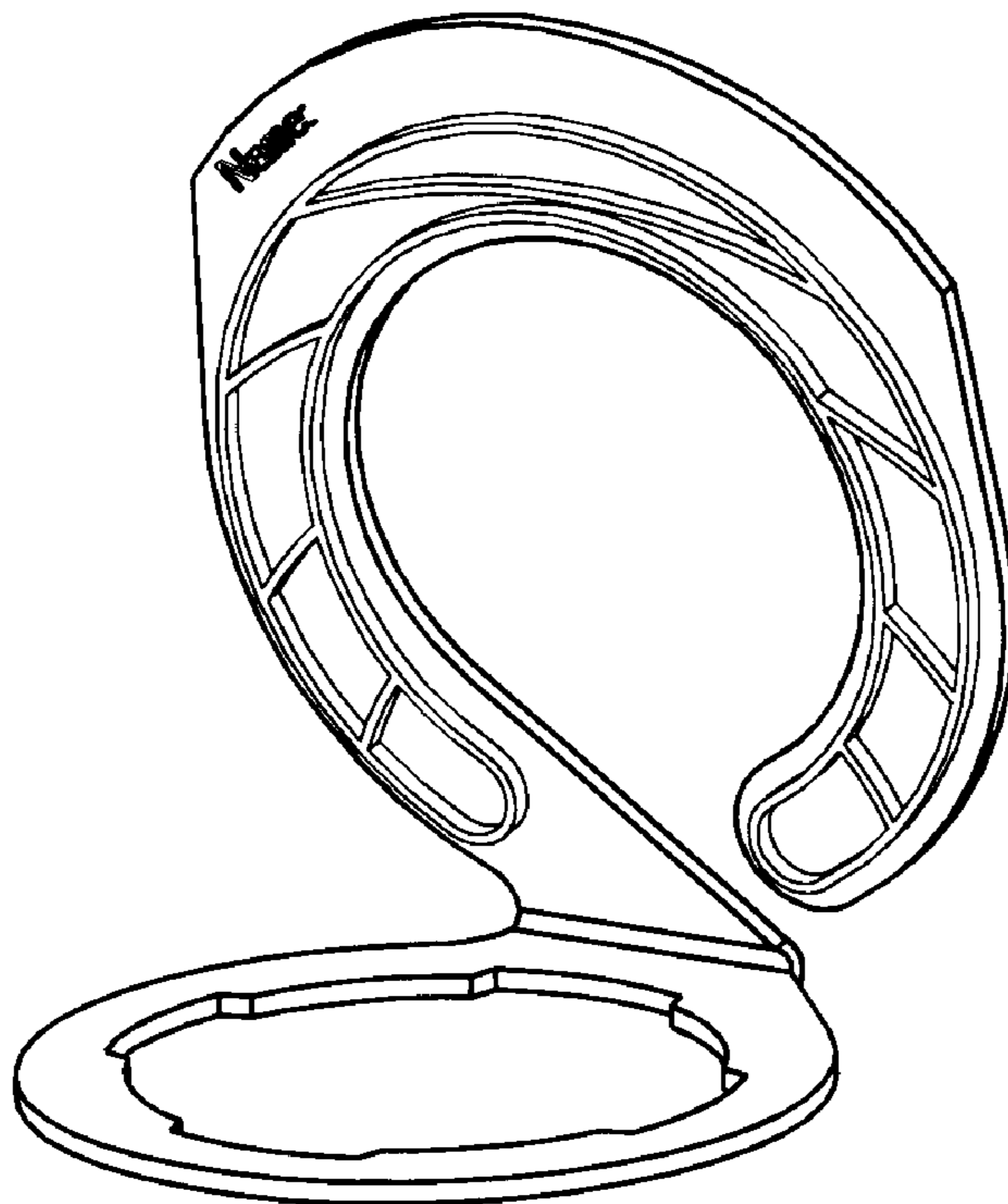
