(57) **CLAIM**

The ornamental design for an article of jewelry, substantially as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of my design for an article of jewelry shown in an extended configuration;

FIG. 2 is a lateral view thereof shown in an extended configuration and from the outside;

FIG. 3 is a lateral view of the design shown in FIG. 1 in an extended configuration and from the inside;

FIG. 4 is a top view of the design shown in FIG. 1 in a closed configuration, the bottom view being a mirror image of the top view;

FIG. 5 is a perspective view of a second embodiment of my design for an article of jewelry shown in an extended configuration;

FIG. 6 is a lateral view of the design shown in FIG. 5 shown in an extended configuration and from the outside;

FIG. 7 is a top view of the design shown in FIG. 5 shown in a closed configuration, the bottom view being a mirror image of the top view;

FIG. 8 is a lateral view of the design shown in FIG. 5 shown in an extended configuration and from the inside;

FIG. 9 is a perspective view of a third embodiment of my design for an article of jewelry;

FIG. 10 is a top view of the design of FIG. 9; and

FIG. 11 is a bottom view of the design of FIG. 9.

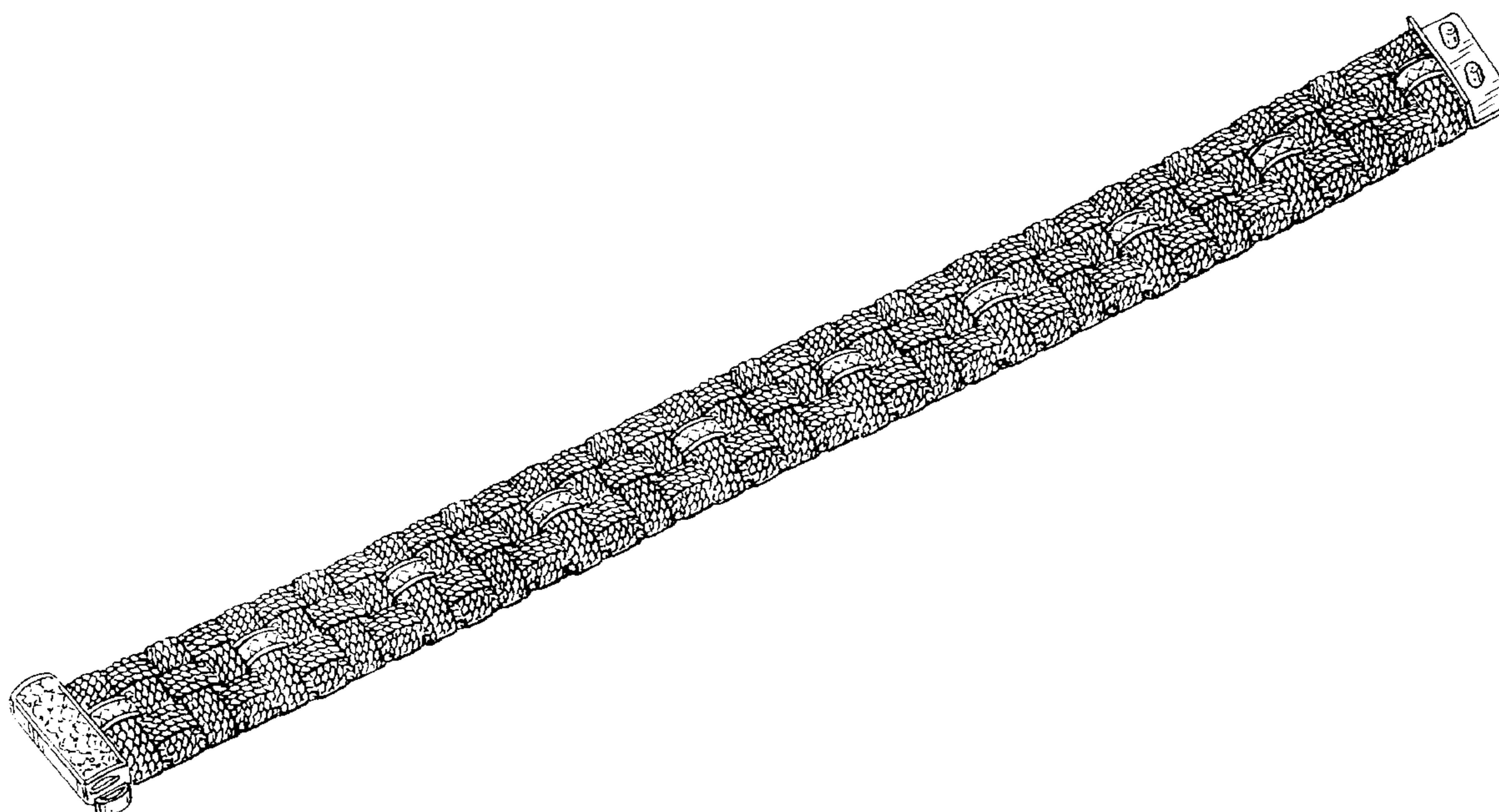
FIG. 12 shows a portion of the article of jewelry in FIG. 1 on enlarged scale.

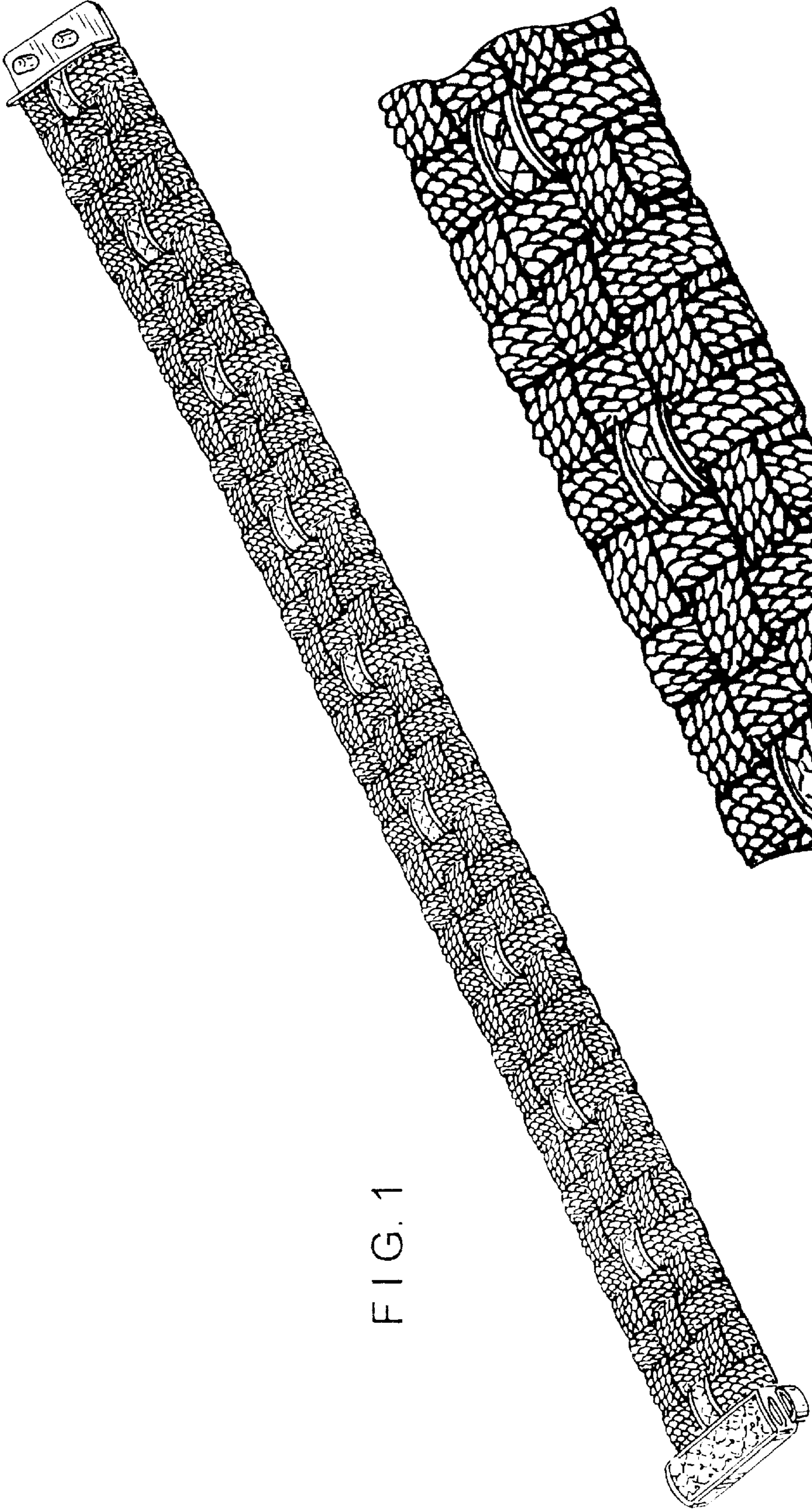

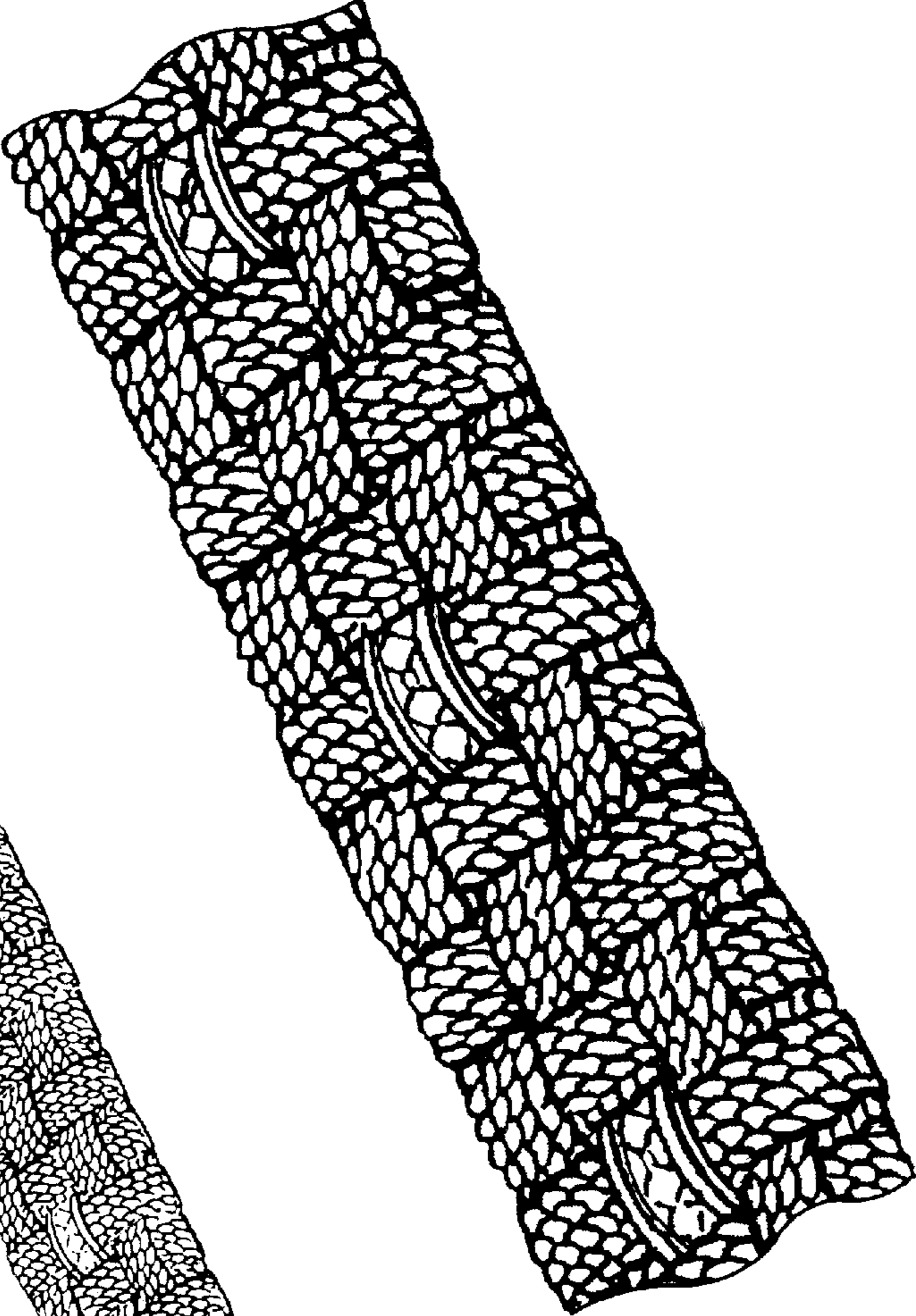

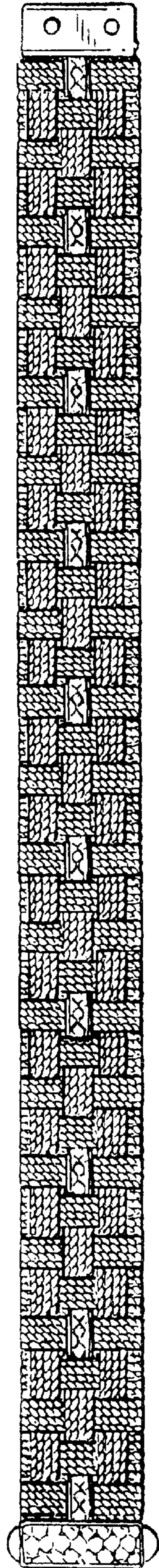

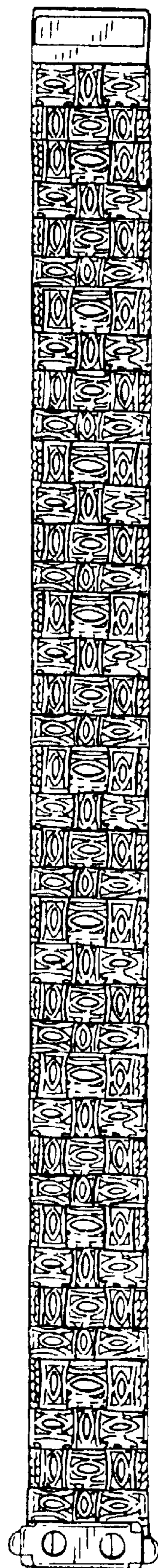

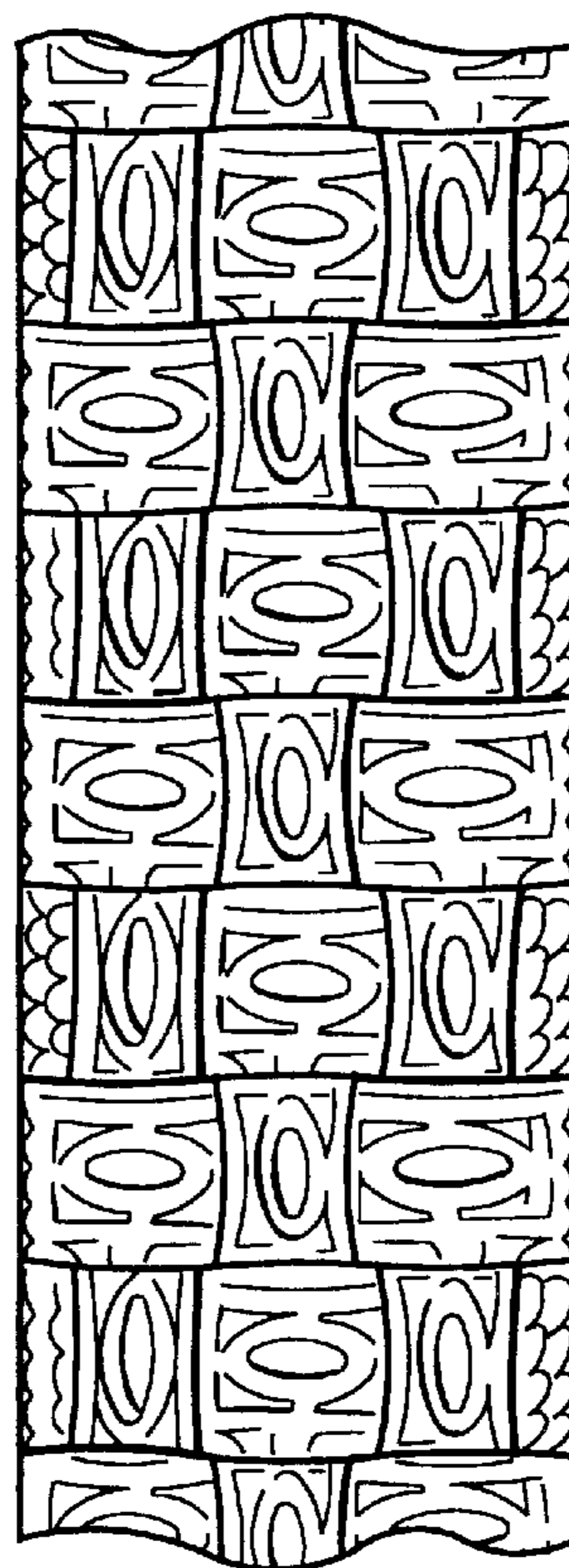

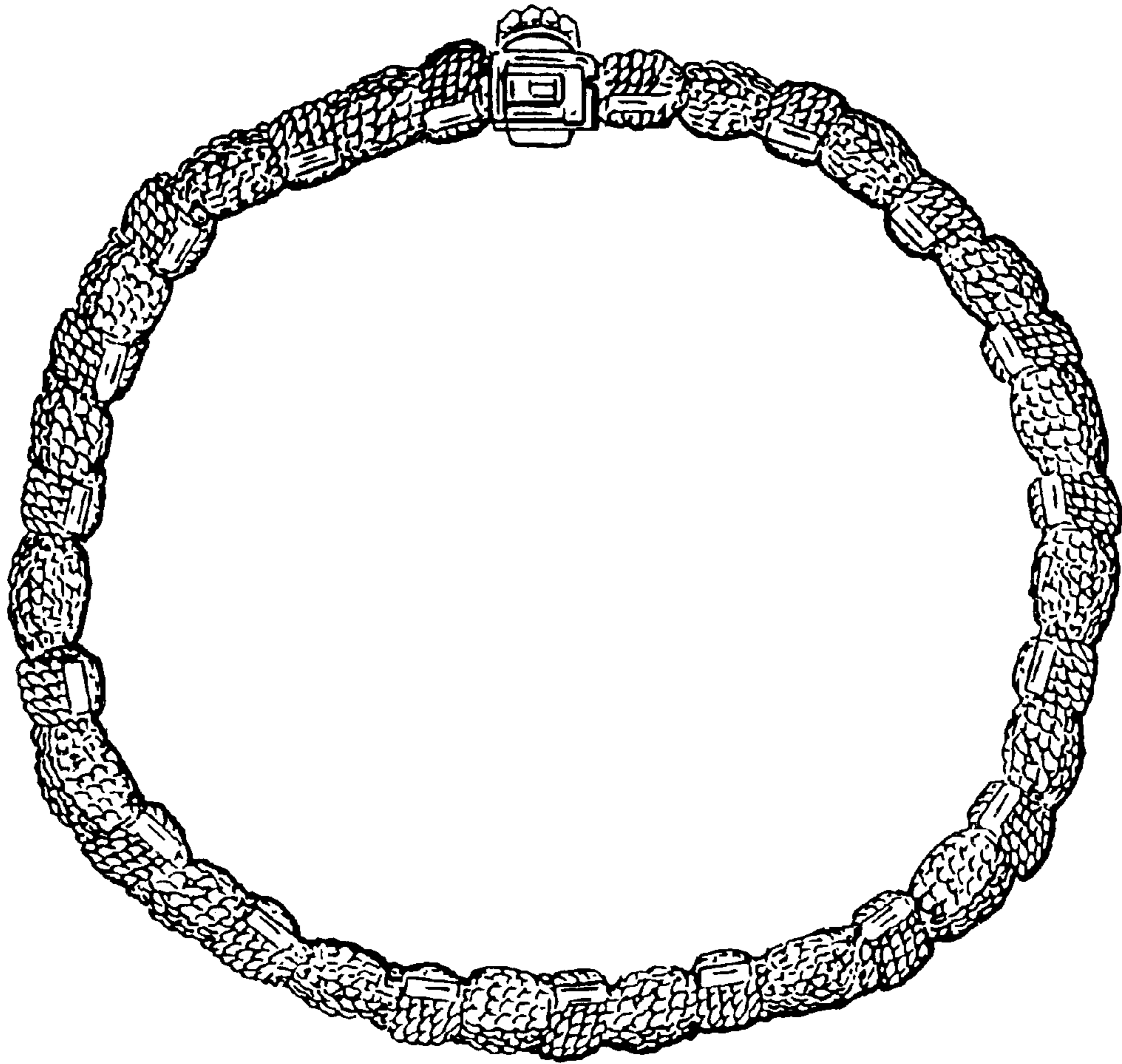

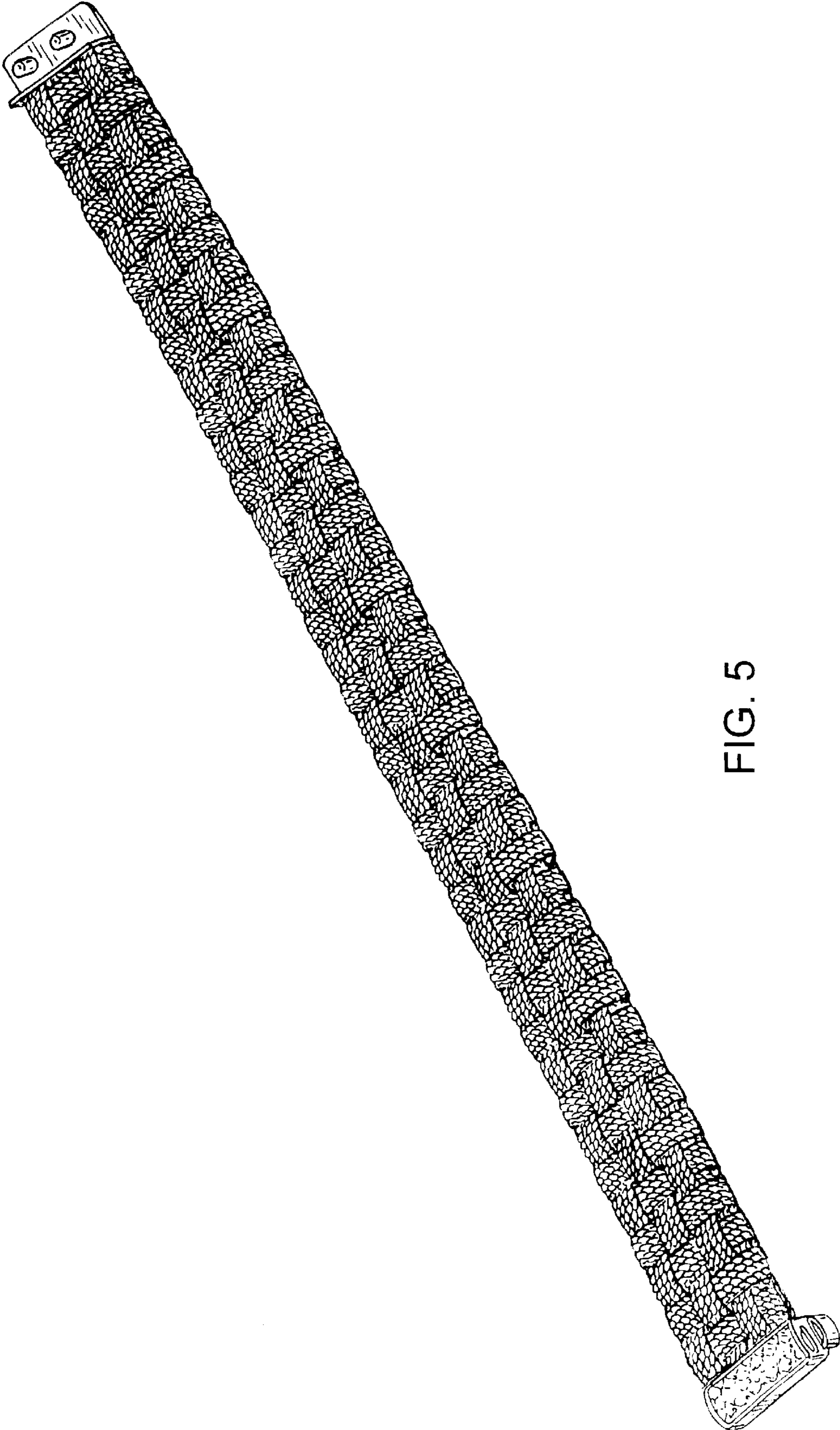

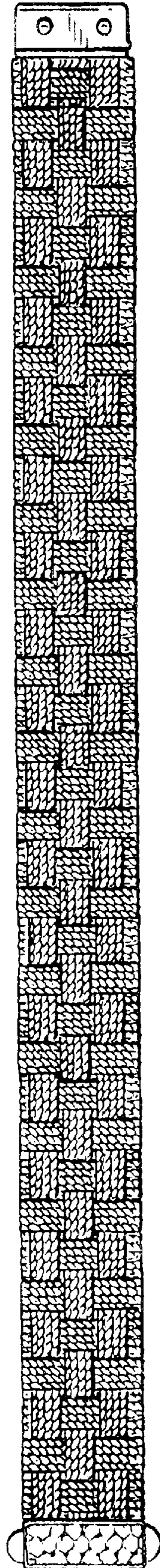

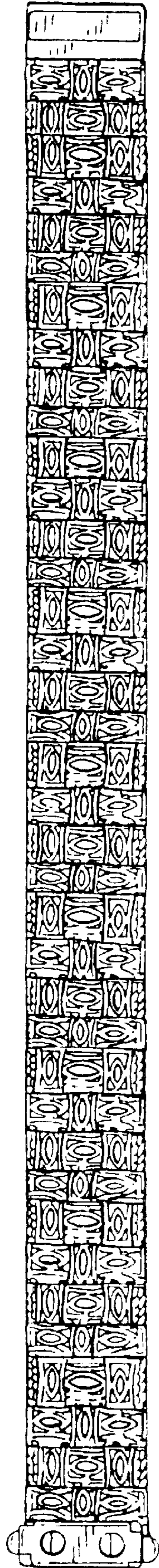

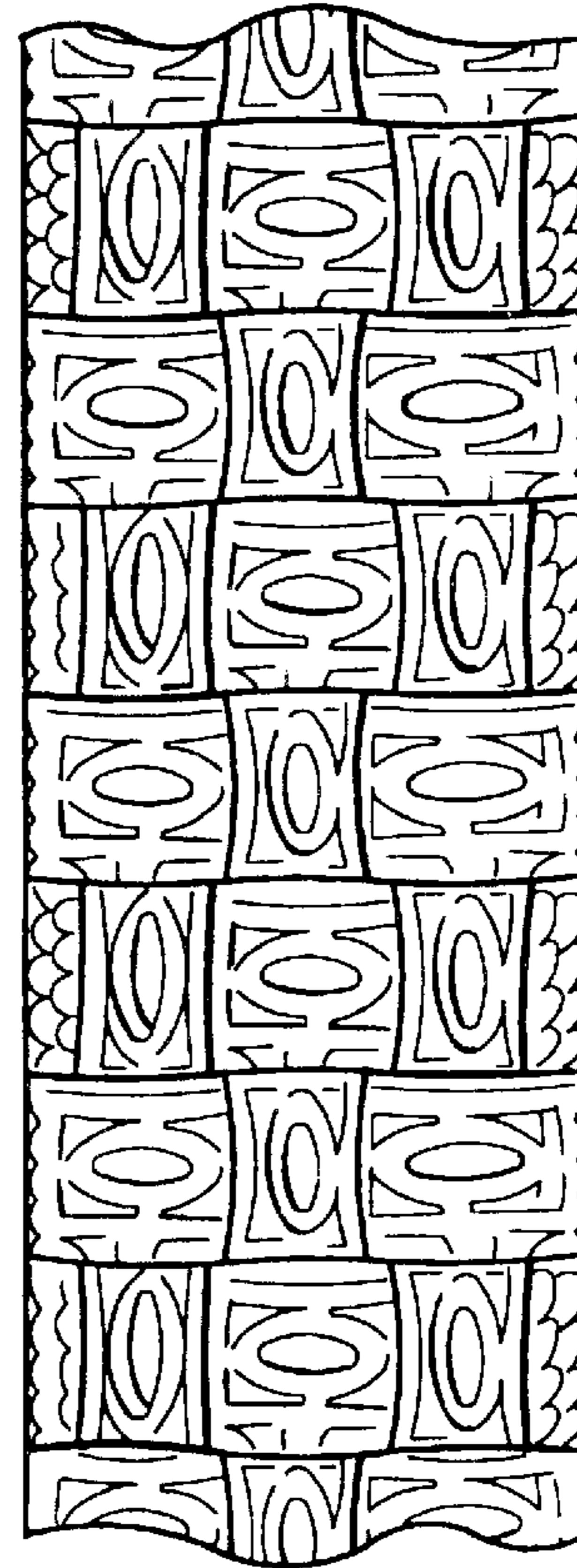

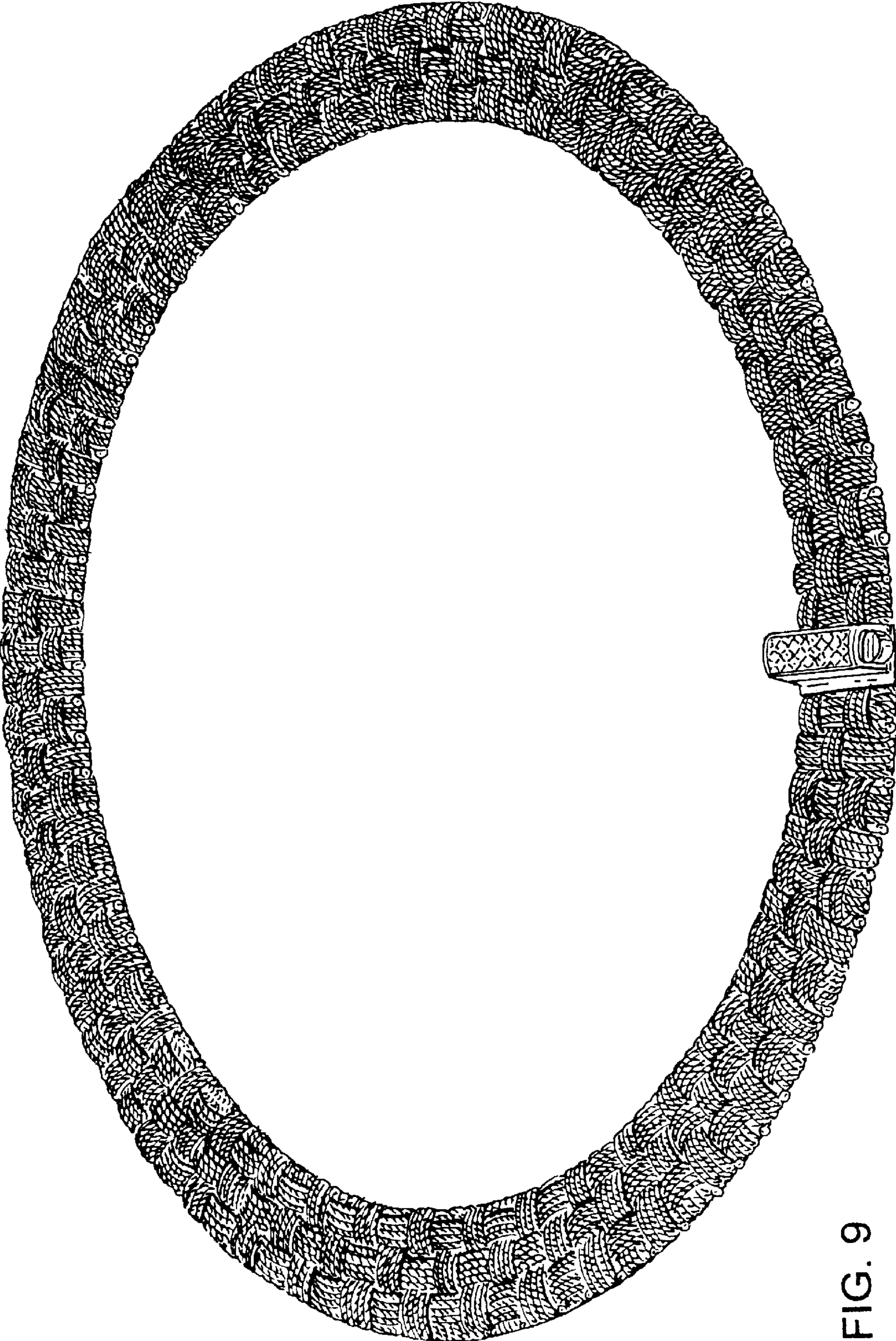

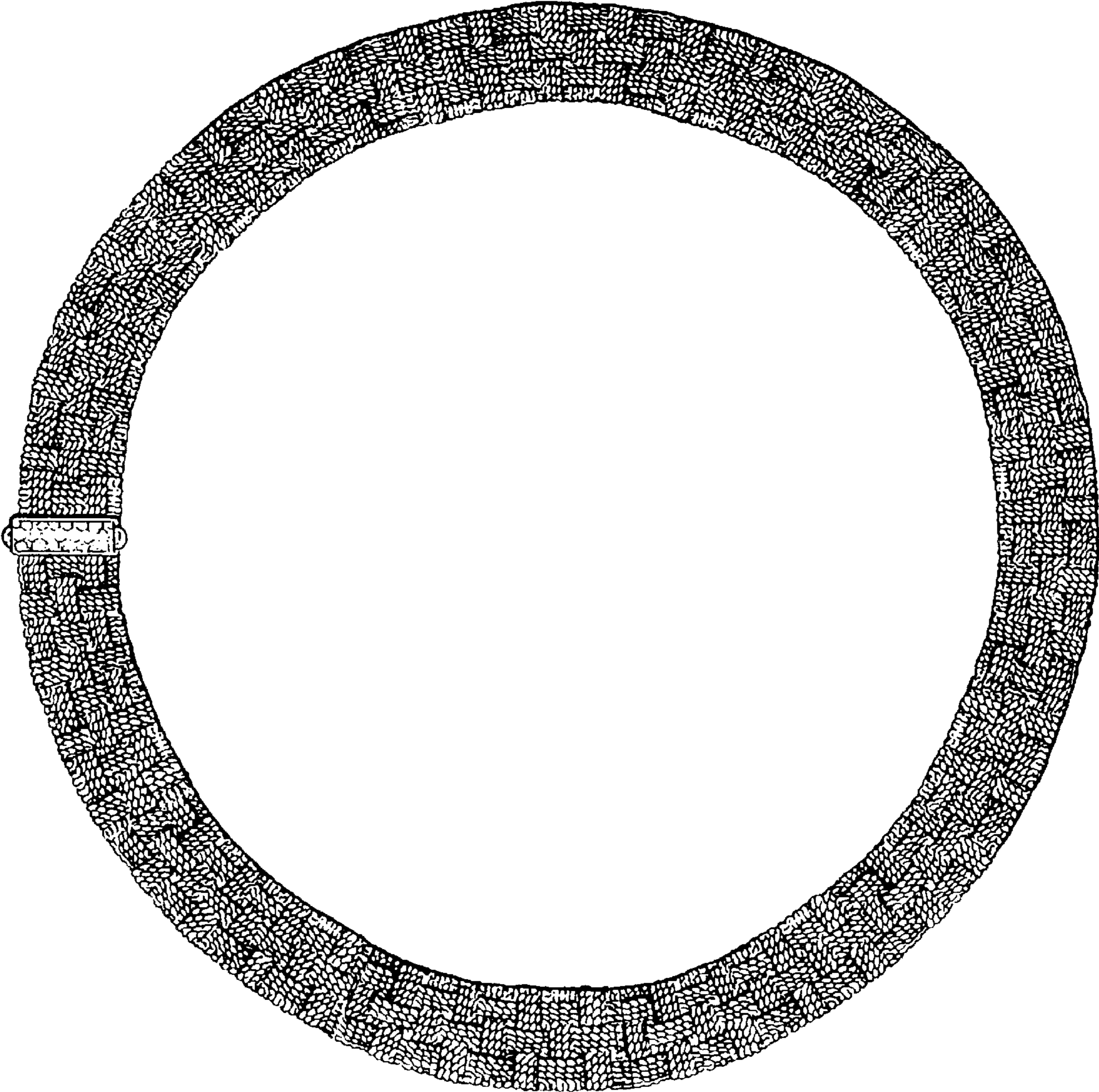

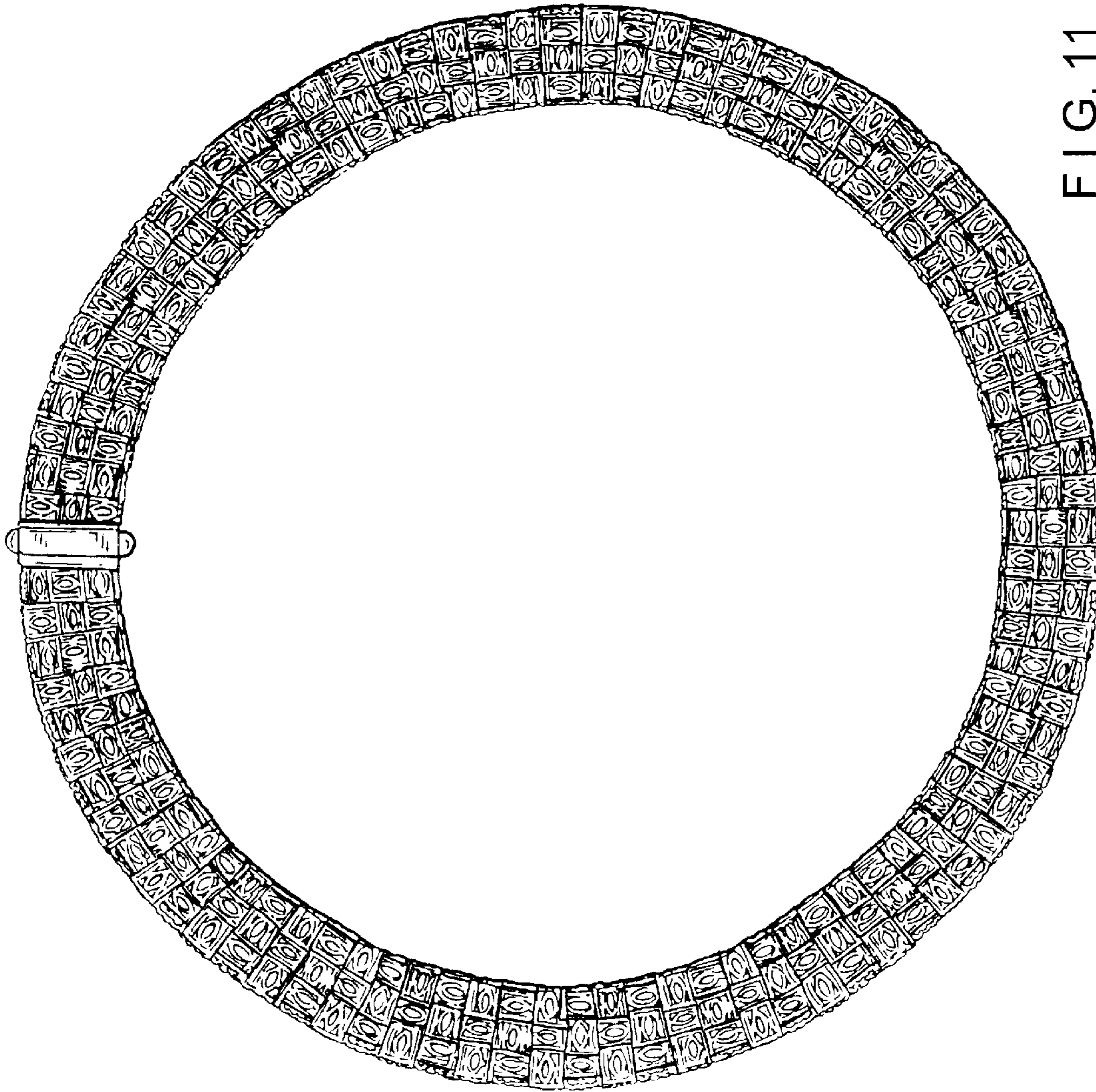

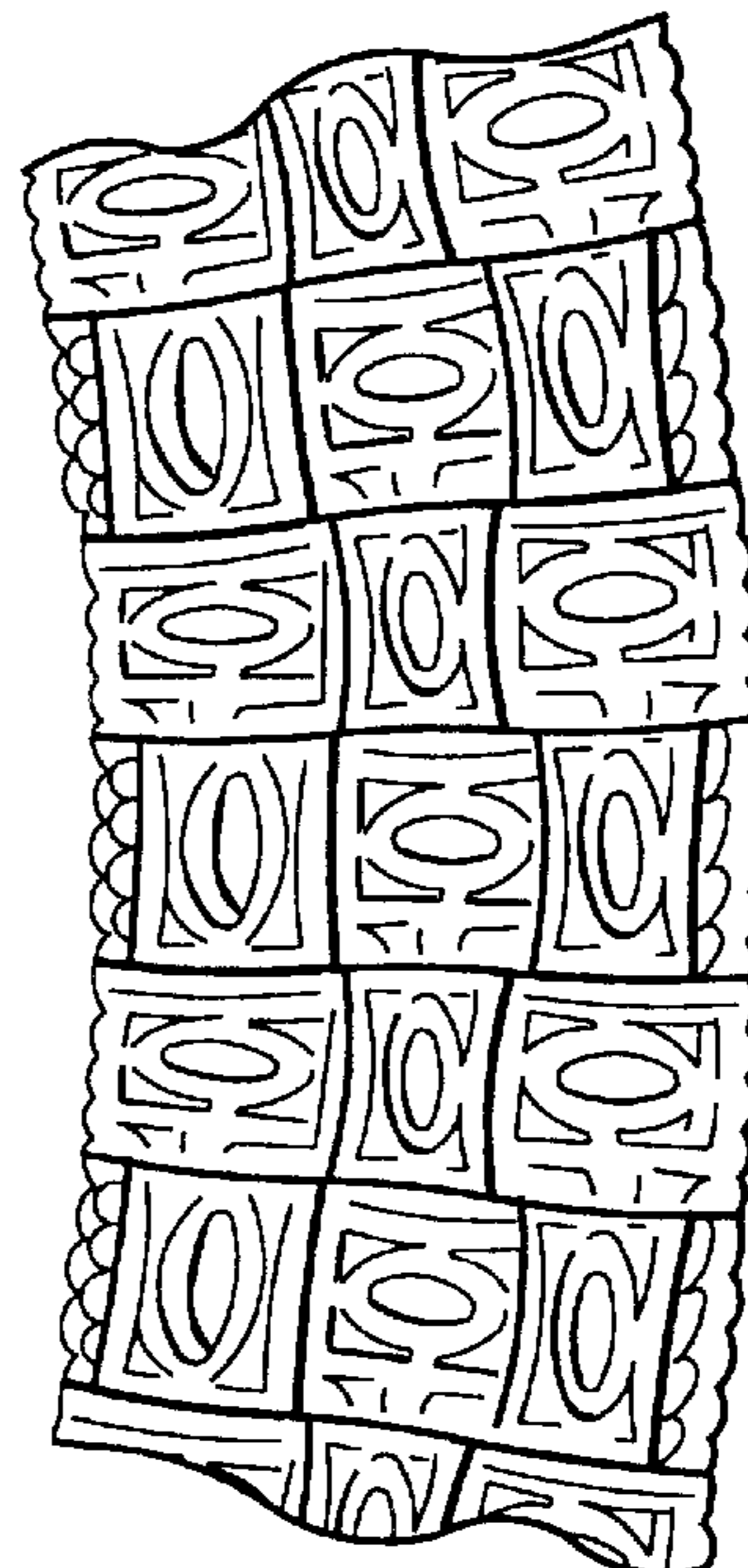
