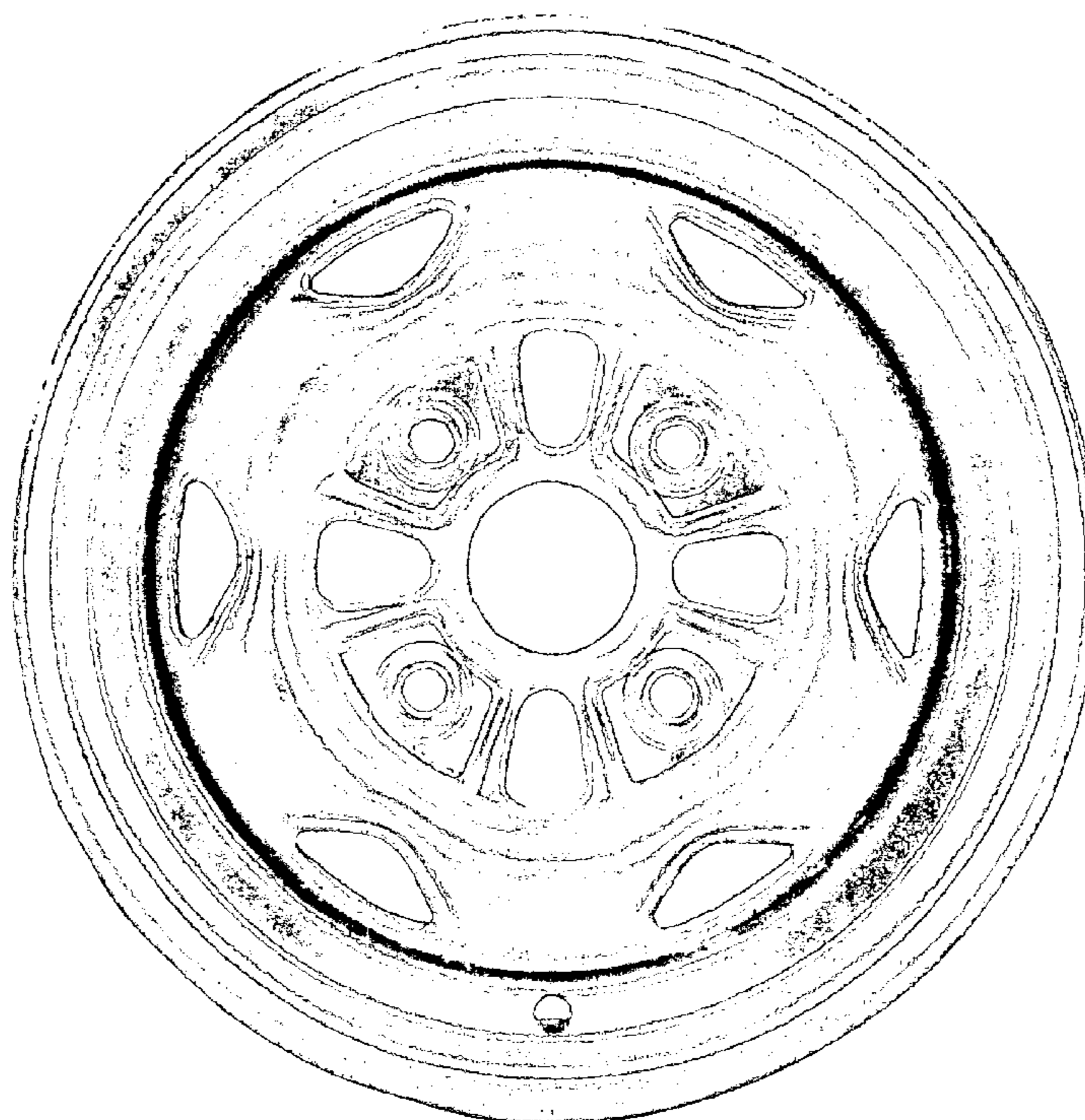
(57) **CLAIM**

The ornamental design for, wheel for a four-wheeled automobile, as shown and described.

DESCRIPTION

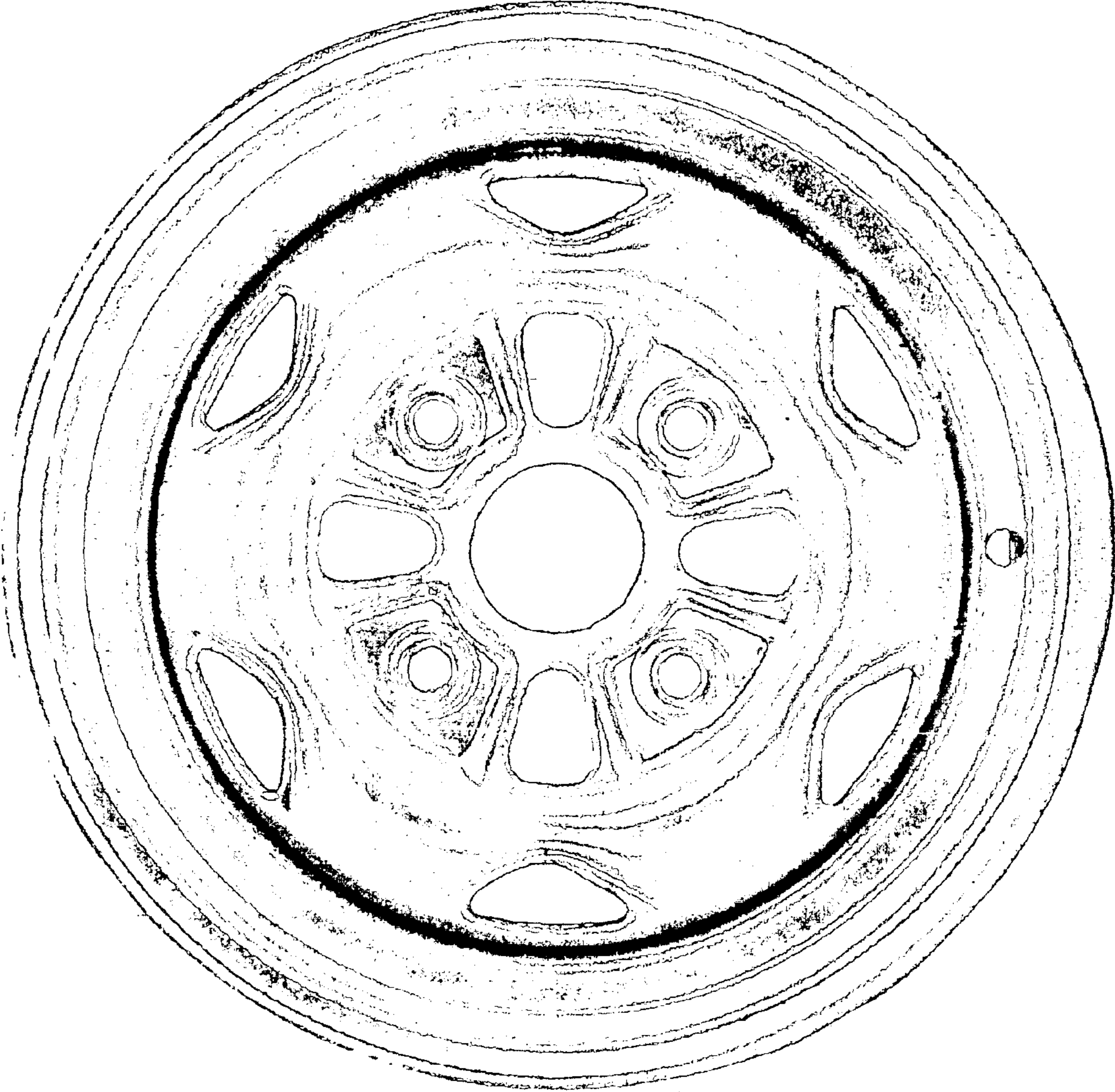


Fig.1 Front Elevation View

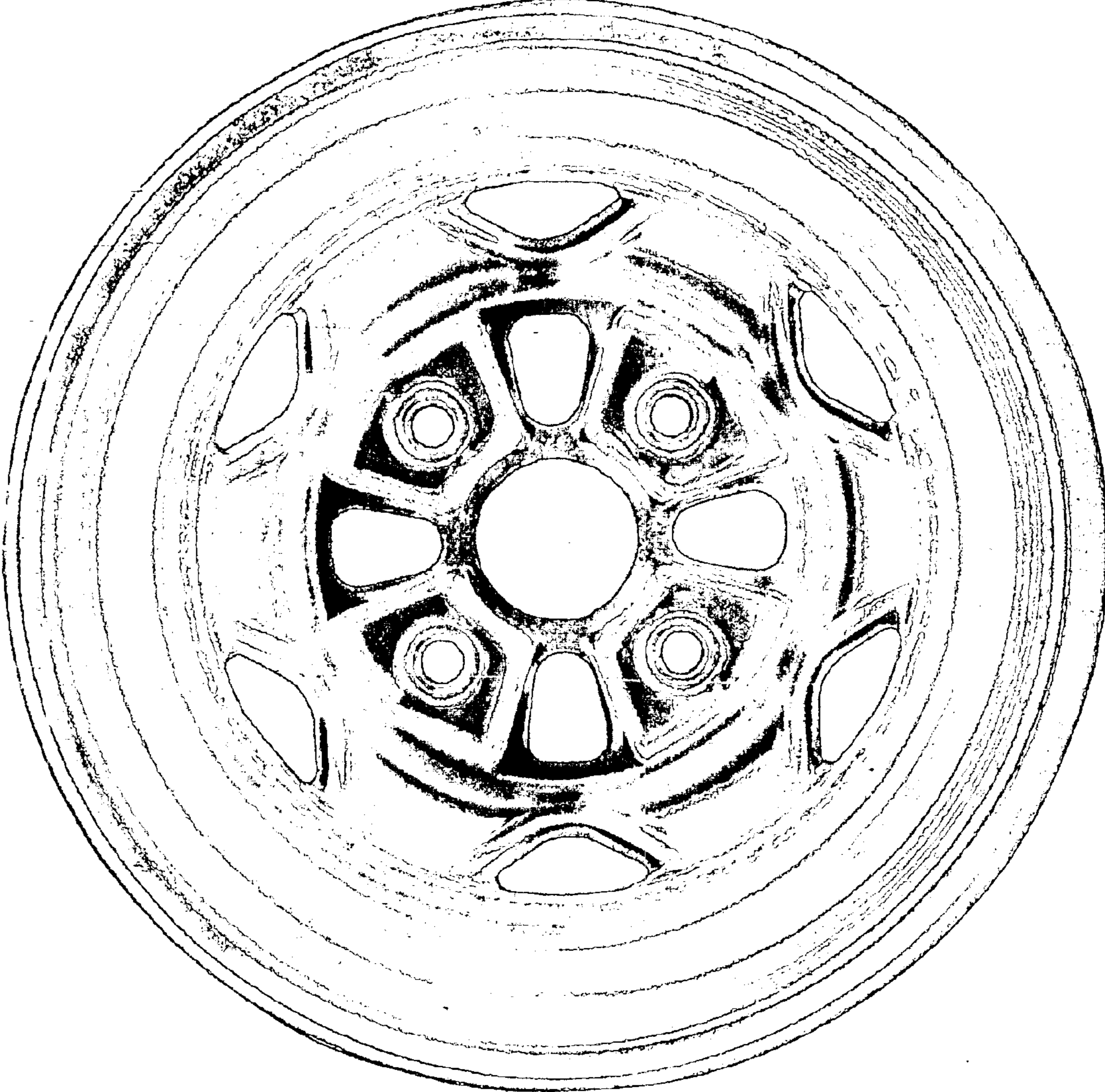


Fig.2 Rear Elevation View

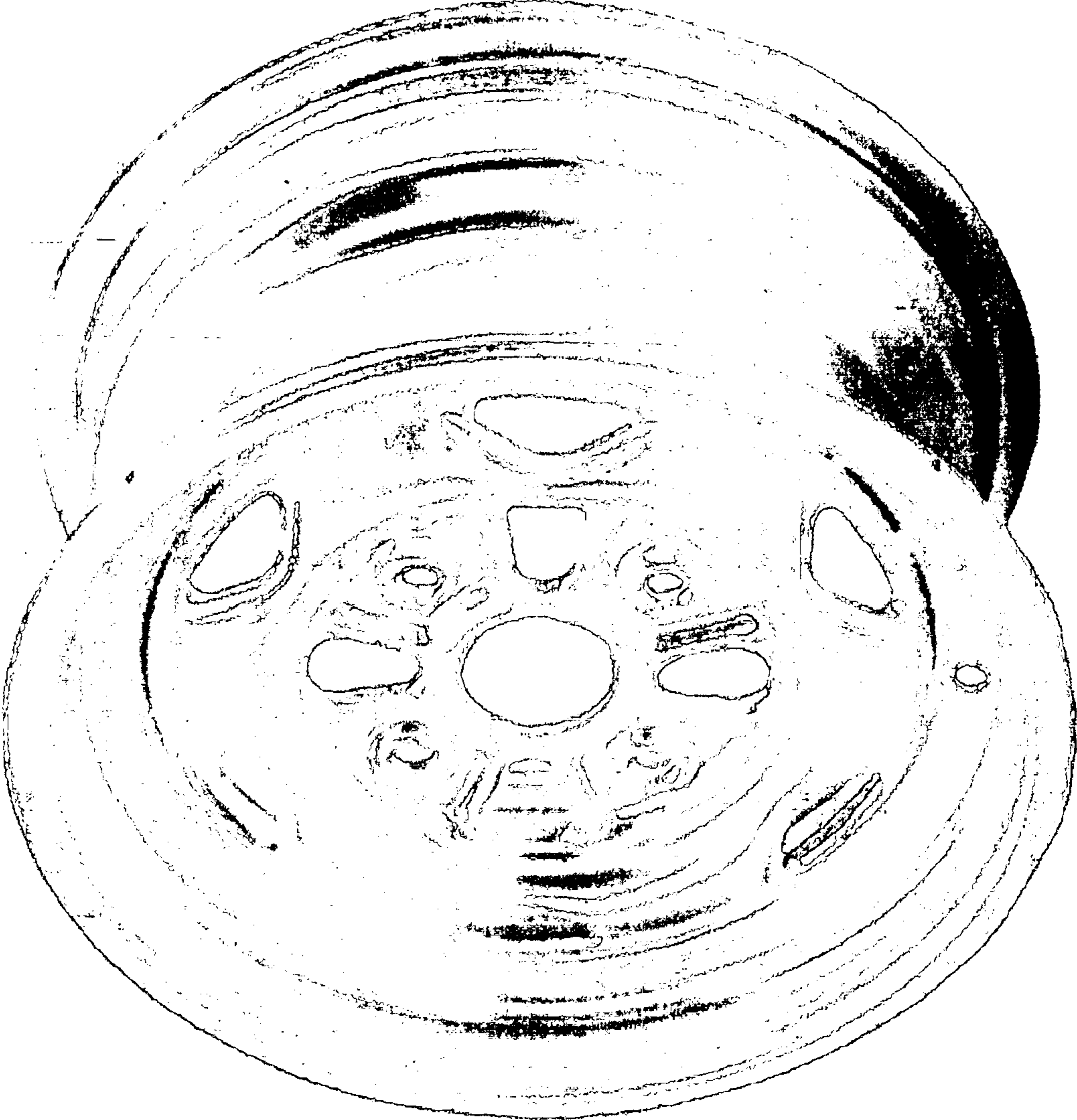


Fig.6 Right side Perspective View 1

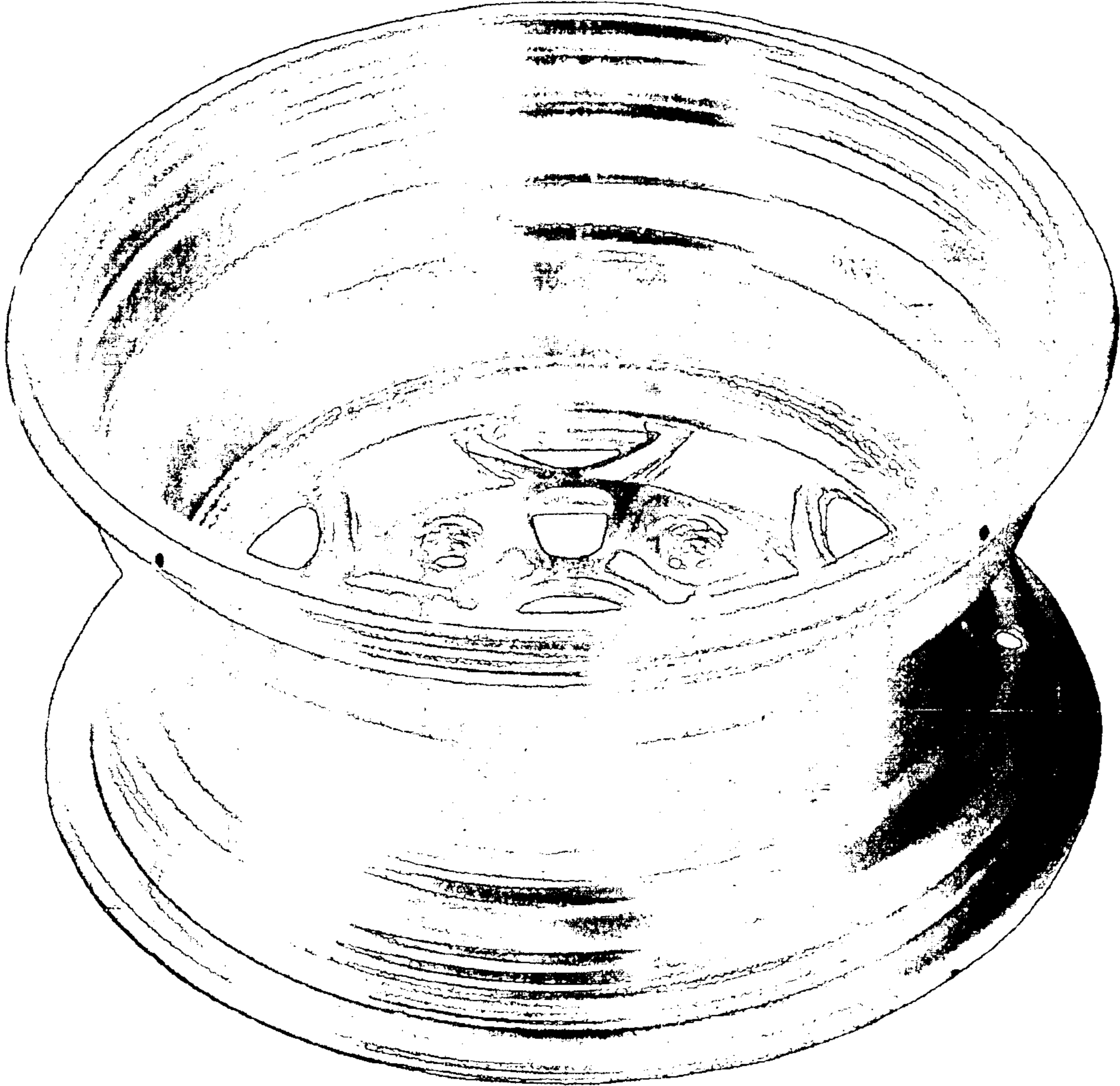


Fig.7 Right side Perspective View 2

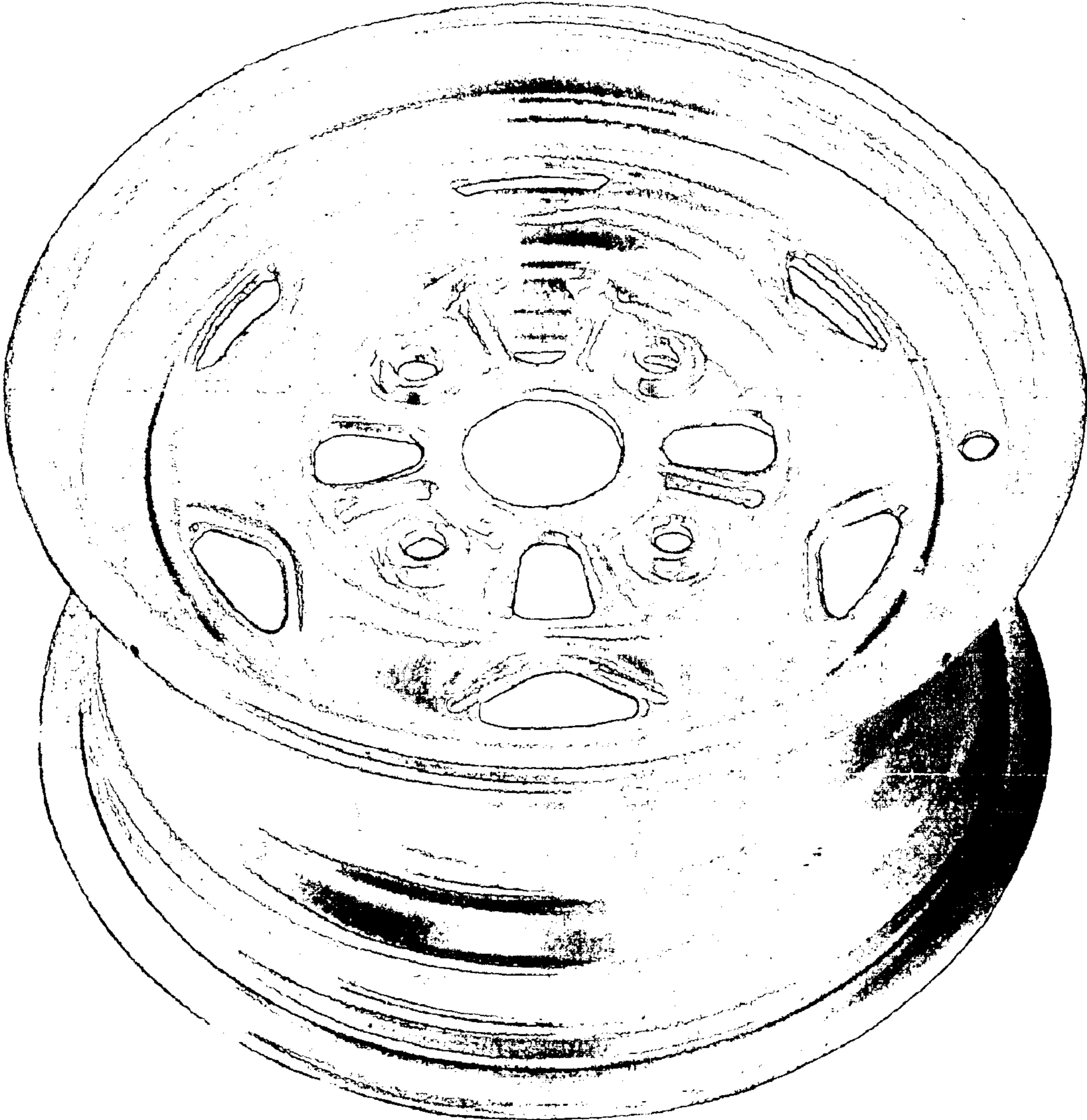


Fig.8 Left side Perspective View 1

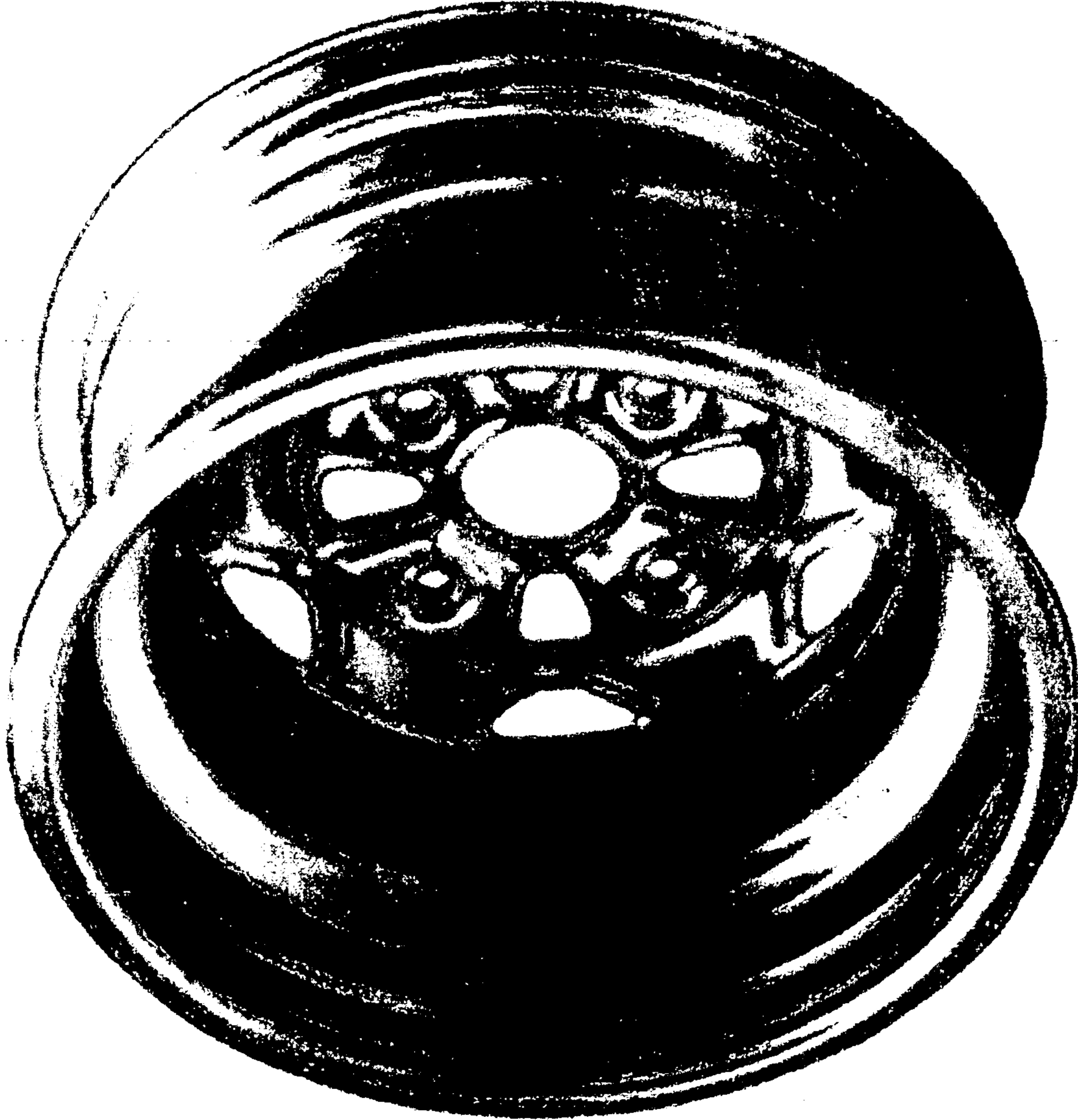


Fig.9 Left side Perspective View 2

FIG. 1 is a front elevation view thereof of wheel for a four-wheeled automobile, showing our new design; FIG. 2 is a rear elevation view thereof; FIG. 3 is a top plan view of thereof; FIG. 4 is a bottom plan view of thereof; FIG. 5 is a right side elevation view thereof, the left side elevation view is a mirror image of the right side elevation view thereof; FIG. 6 is a right side perspective view 1 of thereof; FIG. 7 is a right side perspective view 2 of thereof; FIG. 8 is a left side perspective view 1 of thereof; and, FIG. 9 is a left side perspective view 2 of thereof.
