(57) **CLAIM**

The ornamental design for a cover structure for a binder or like, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the cover structure of the present invention, shown in conjunction with a binder; FIG. 2 is a front view of the cover structure and binder of FIG. 1;

FIG. 3 is a rear view of the binder of FIG. 1;

FIG. 4 is a bottom end view of the cover structure and binder of FIG. 1;

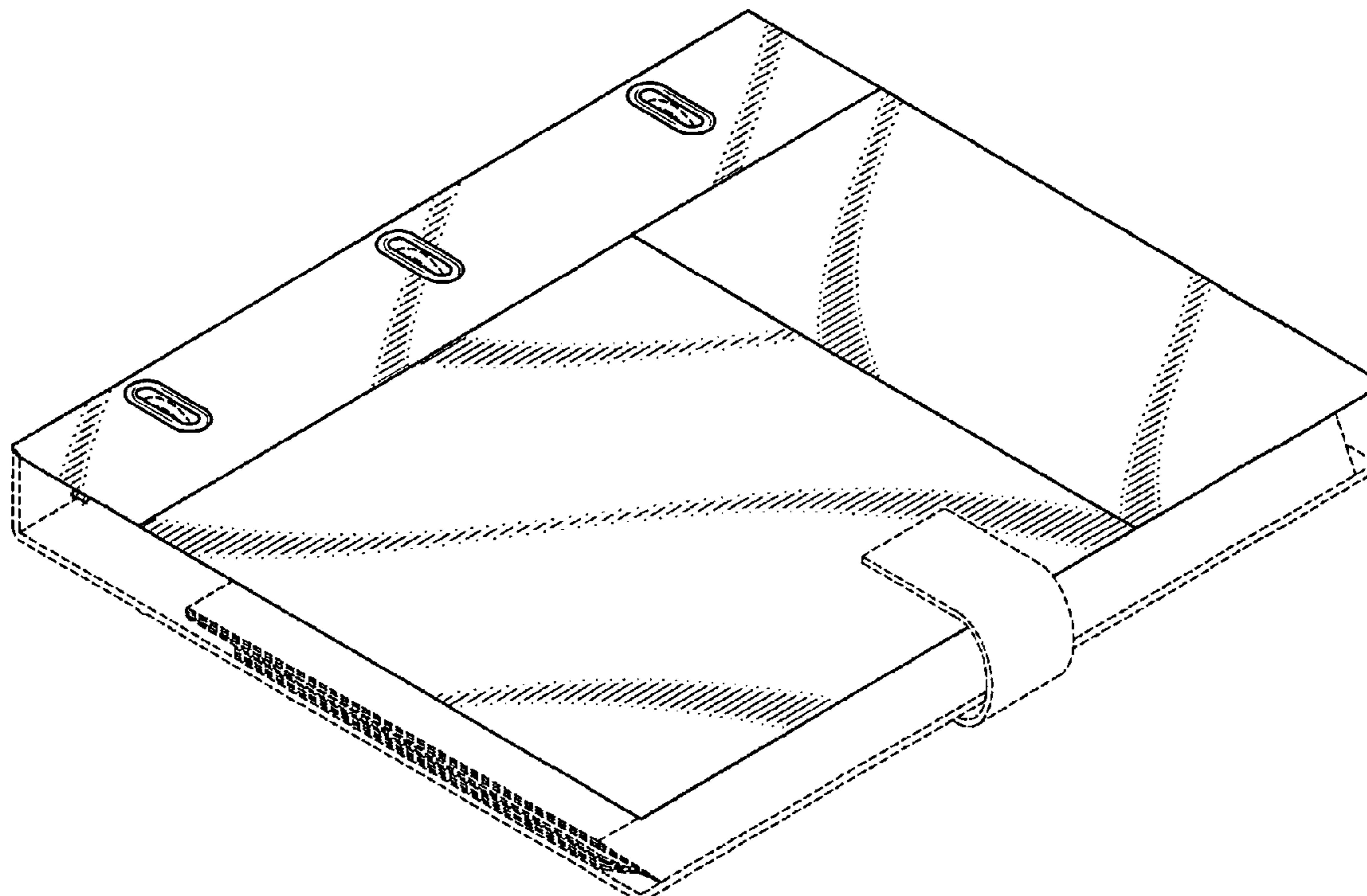
FIG. 5 is a top end view of the cover structure and binder of FIG. 1;

FIG. 6 is a left end view of the cover structure and binder of FIG. 1; and,

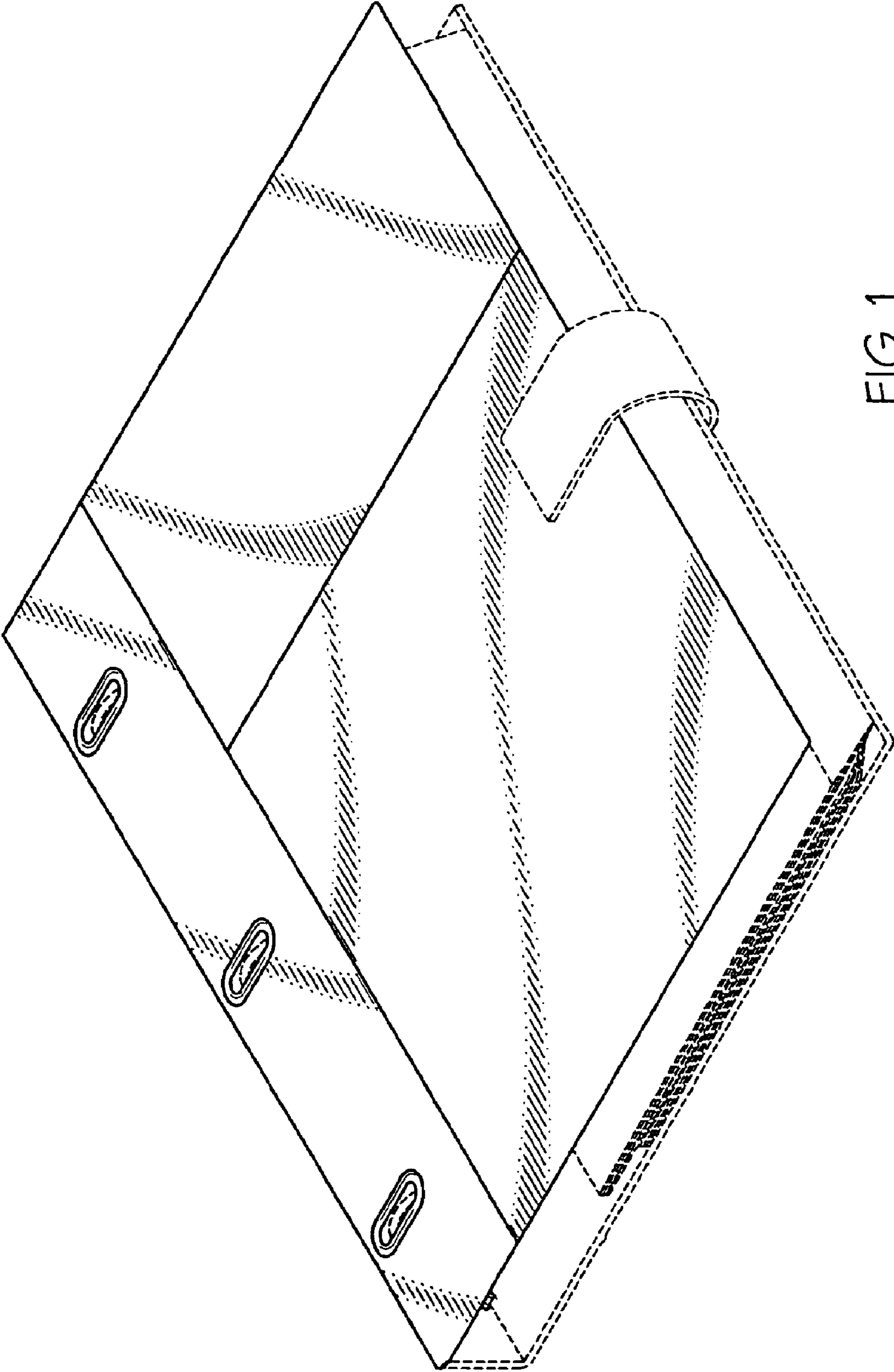

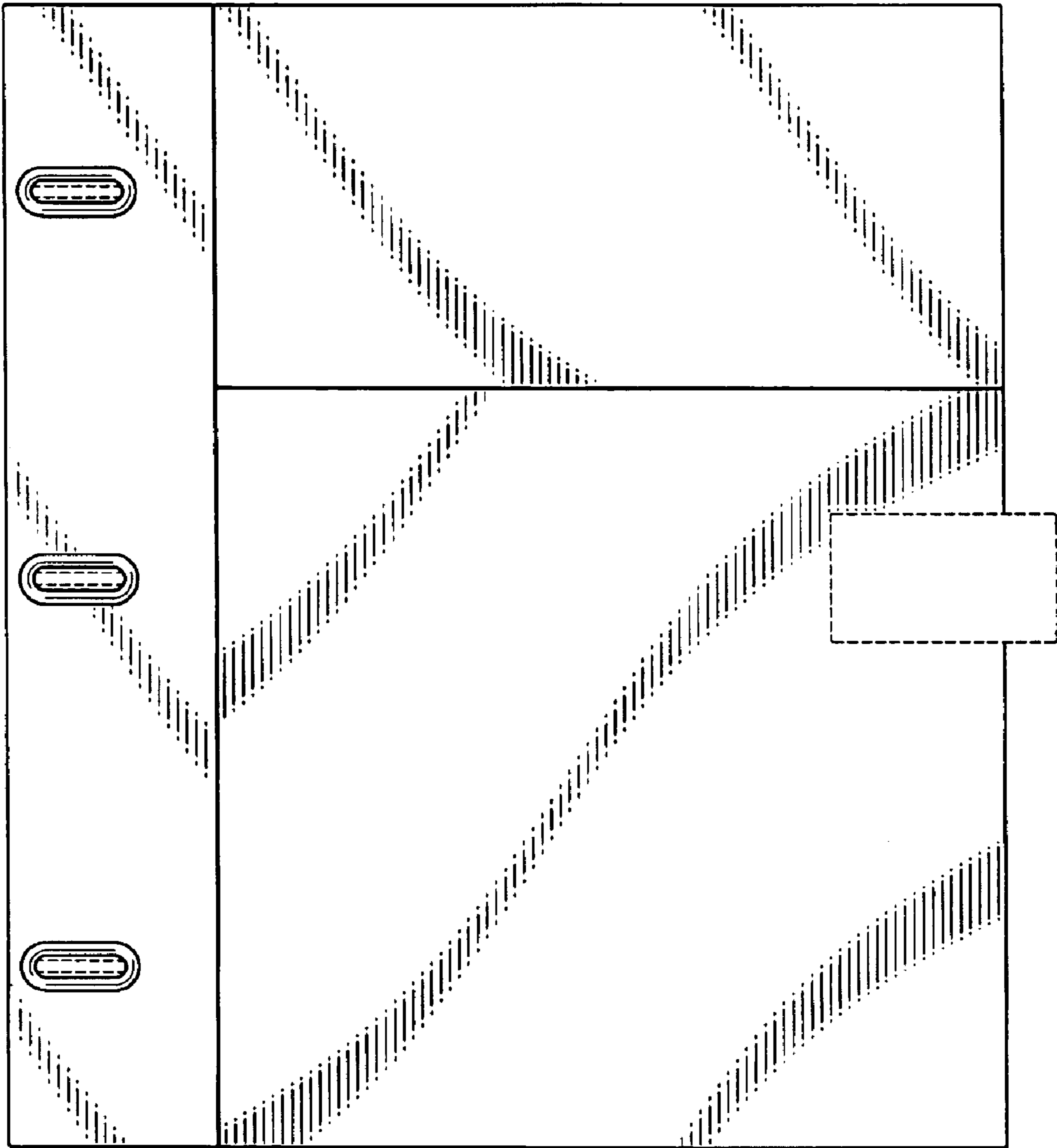

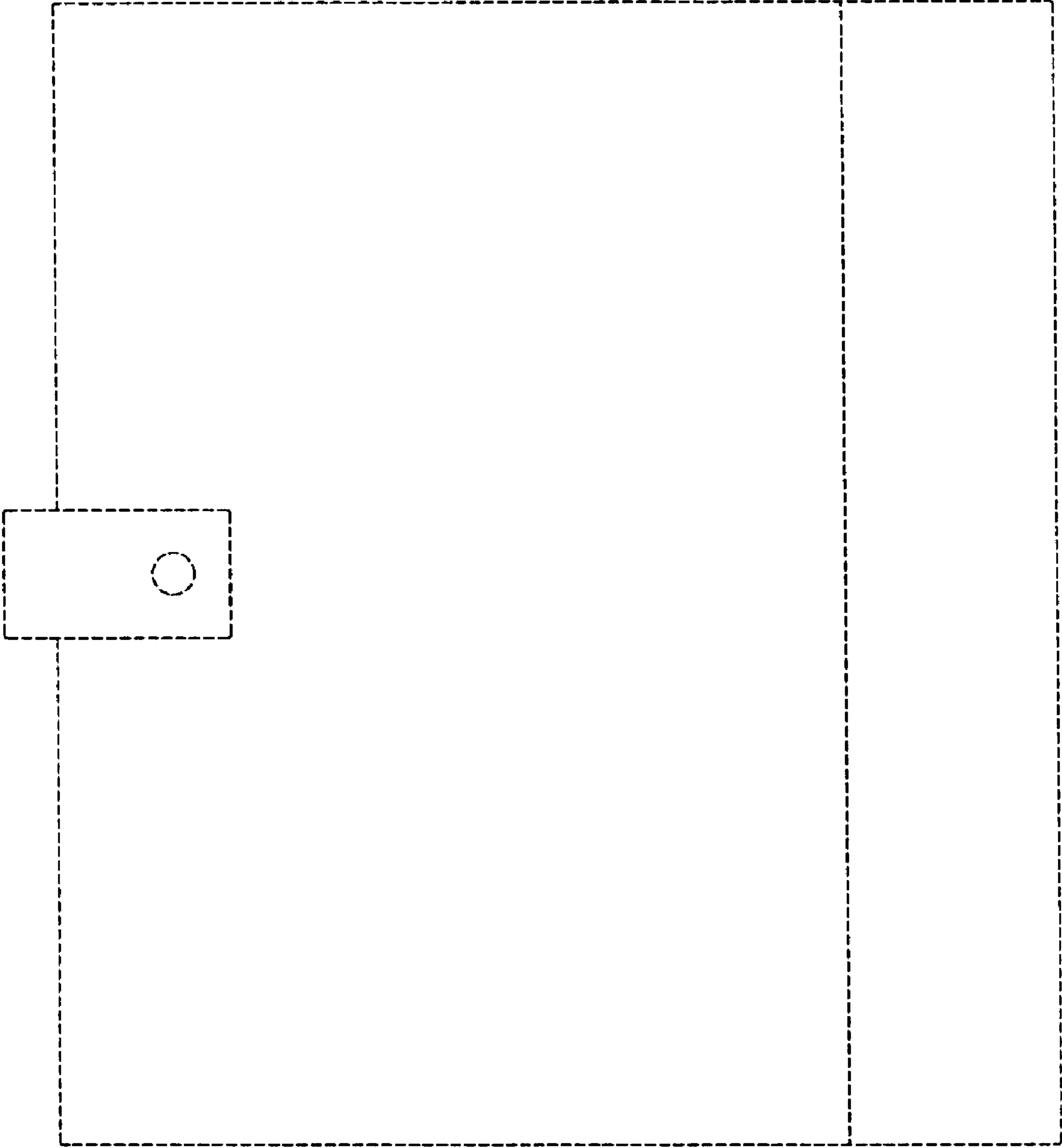

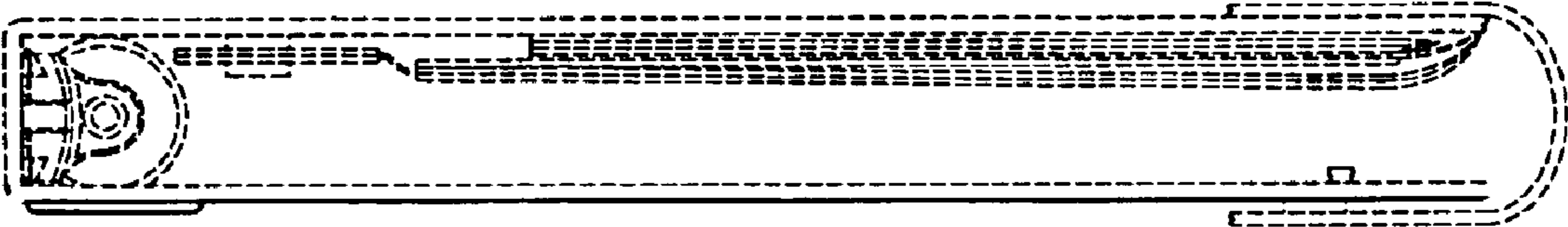

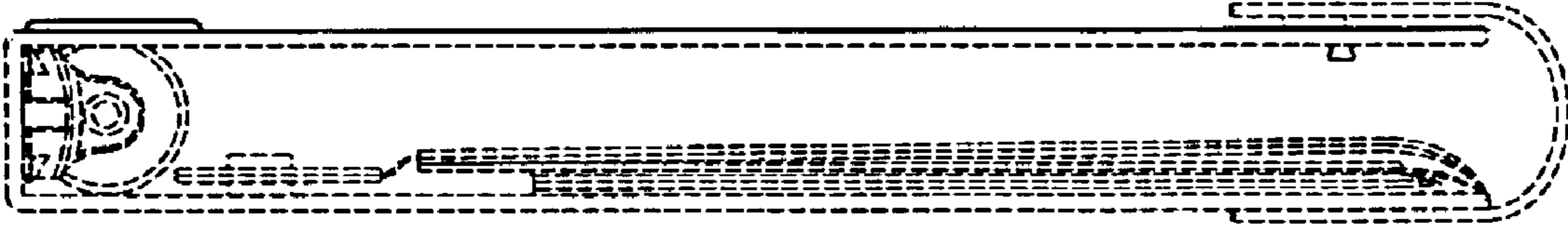

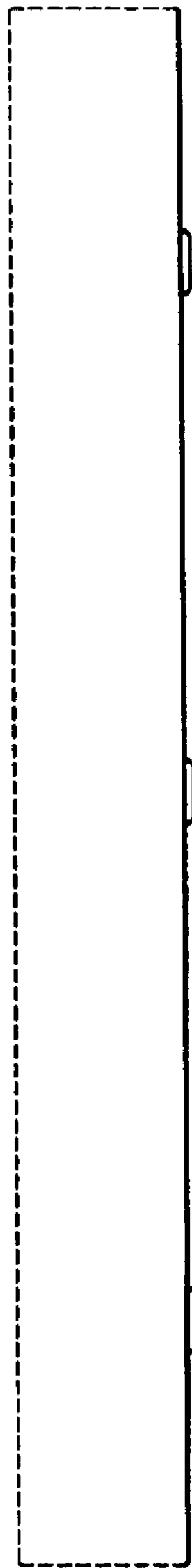

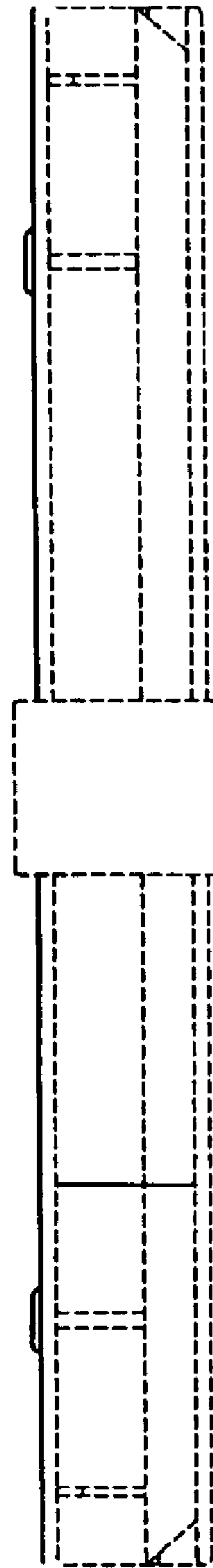
