(57) **CLAIM**

We claim the ornamental design for a head portion of a sports racquet, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a head portion of a sports racquet of the present invention.

FIG. 2 is a front perspective view of the head portion of the sports racquet shown in FIG. 1.

FIG. 3 is a side perspective view of the head portion shown in FIG. 1.

FIG. 4 is a side view of the head portion shown in FIG. 1; and,

FIG. 5 is a cross-section view of a region of the head portion of the sports racquet taken along line 5—5 of FIG. 4.

The broken line showing is for illustrative purposes only and forms no part of the claimed design.

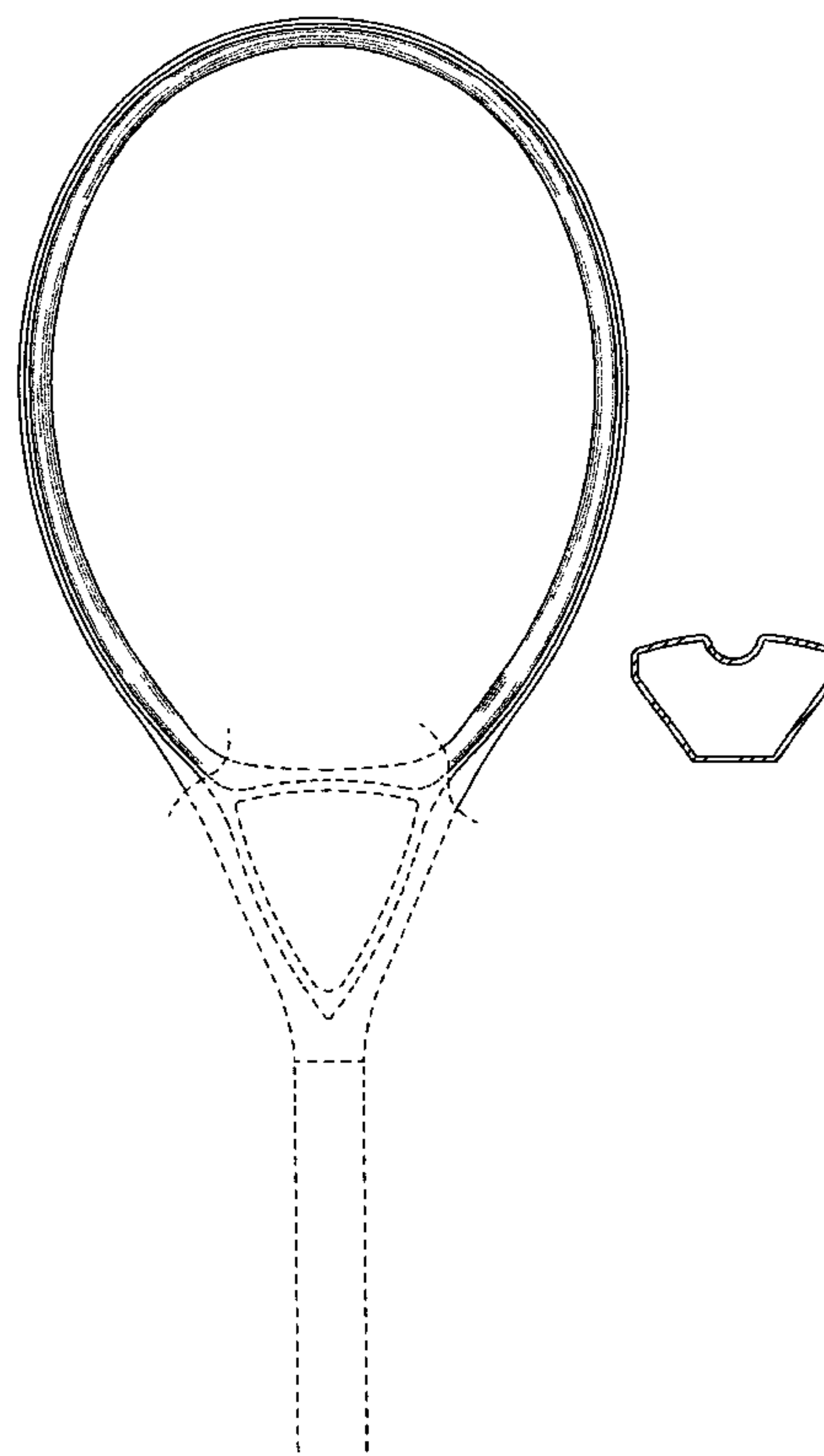
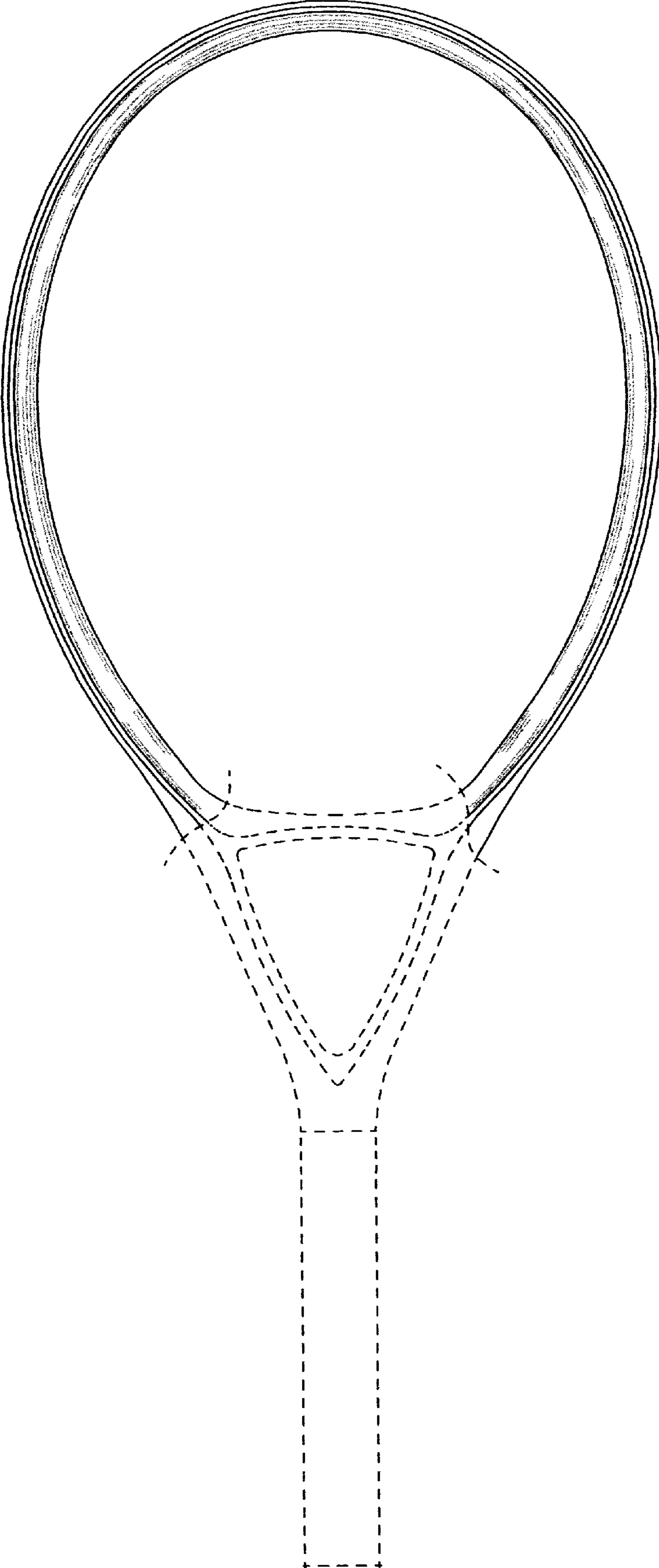

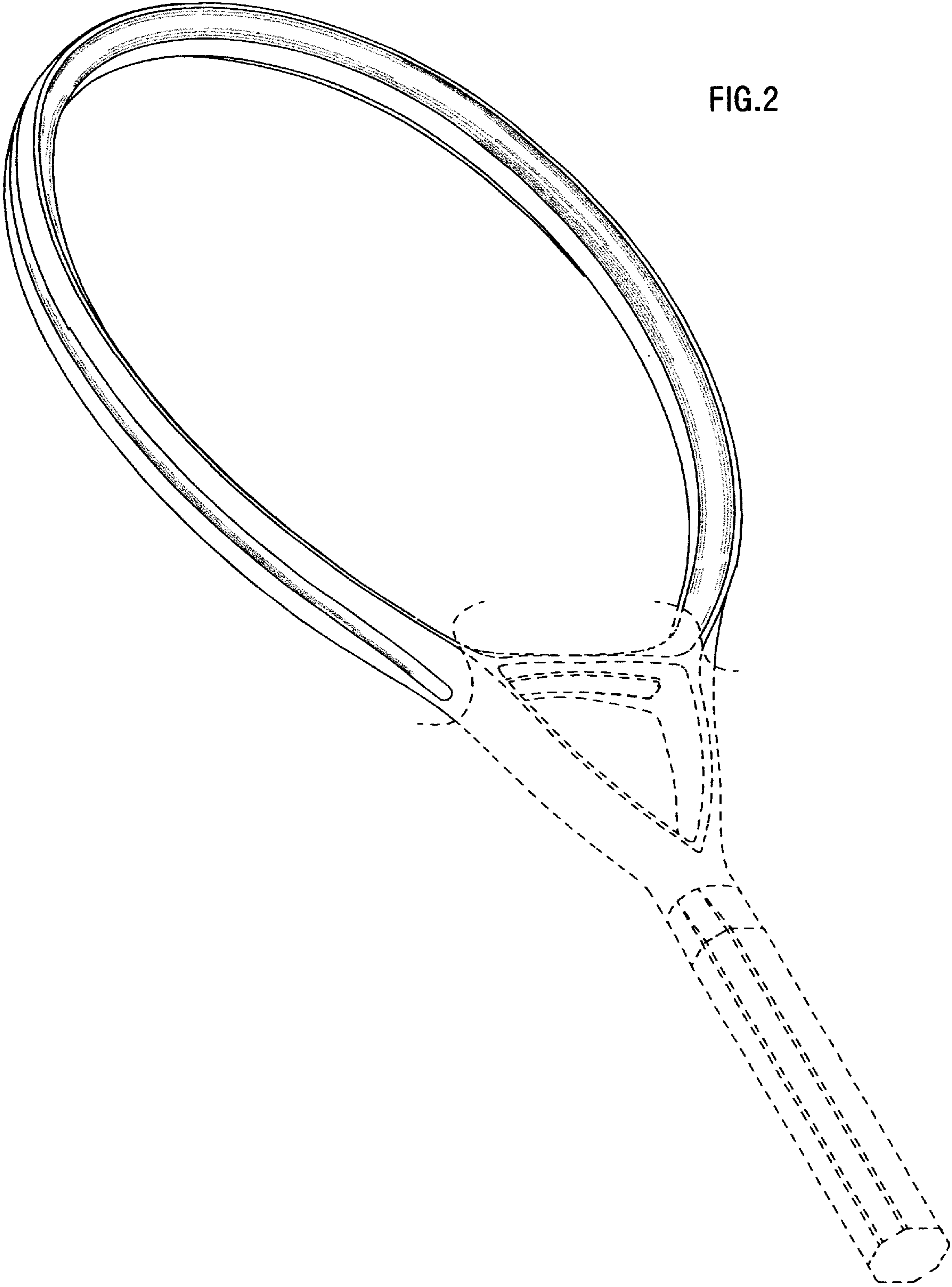

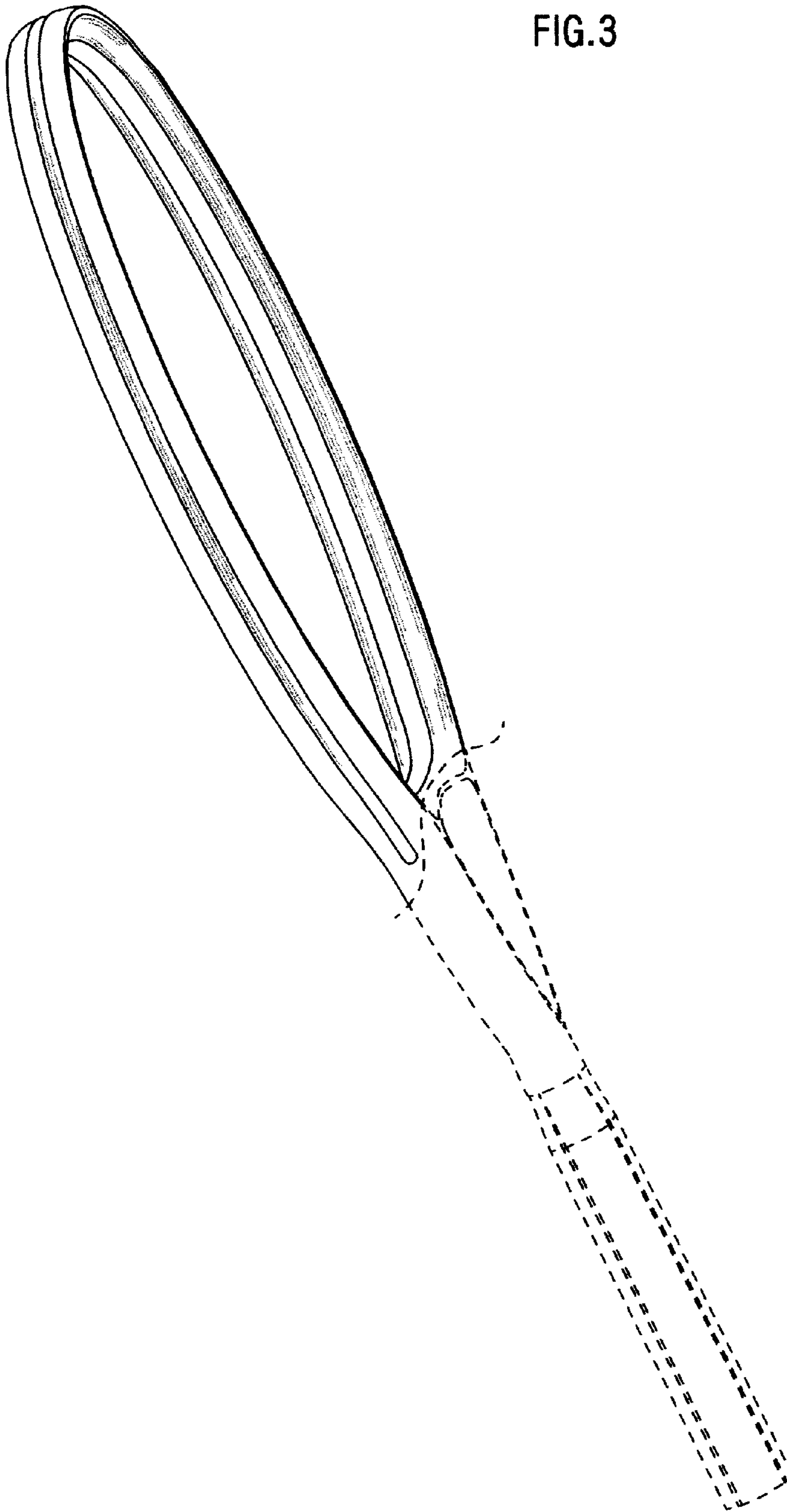

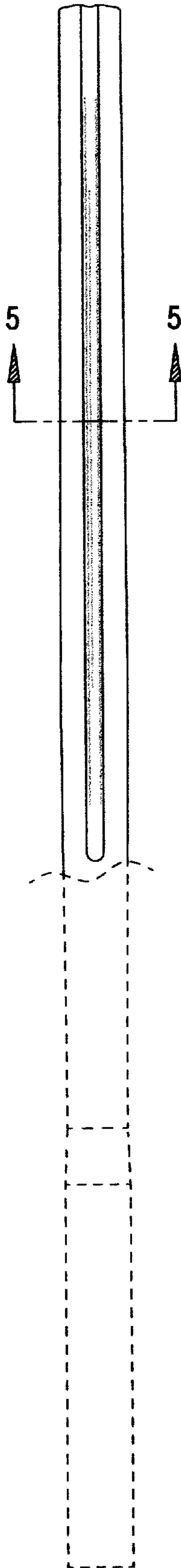
