FIG. 7 is a first side view of a second embodiment of the design.

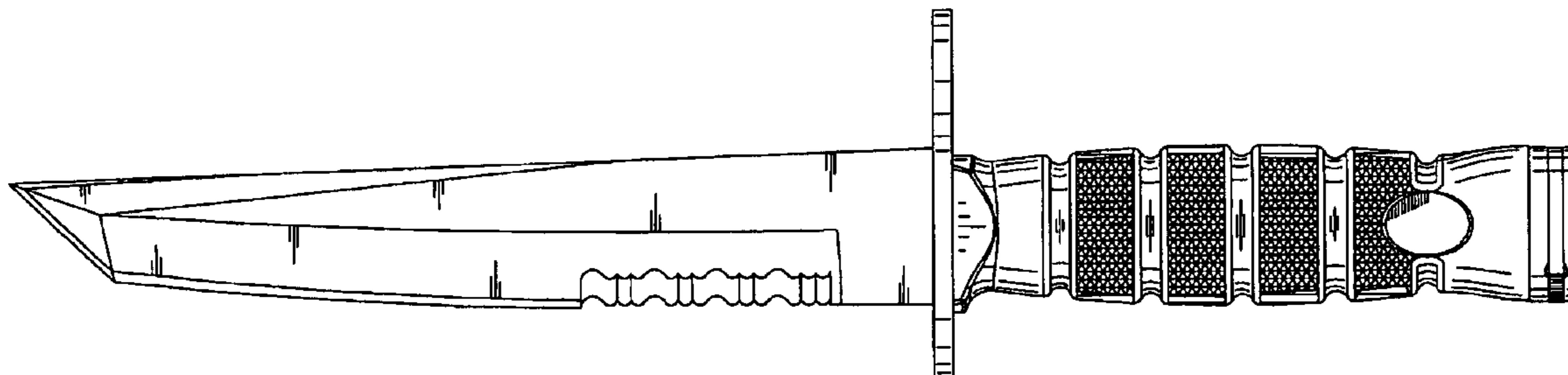
FIG. 8 is a second side view of a second embodiment of the design.

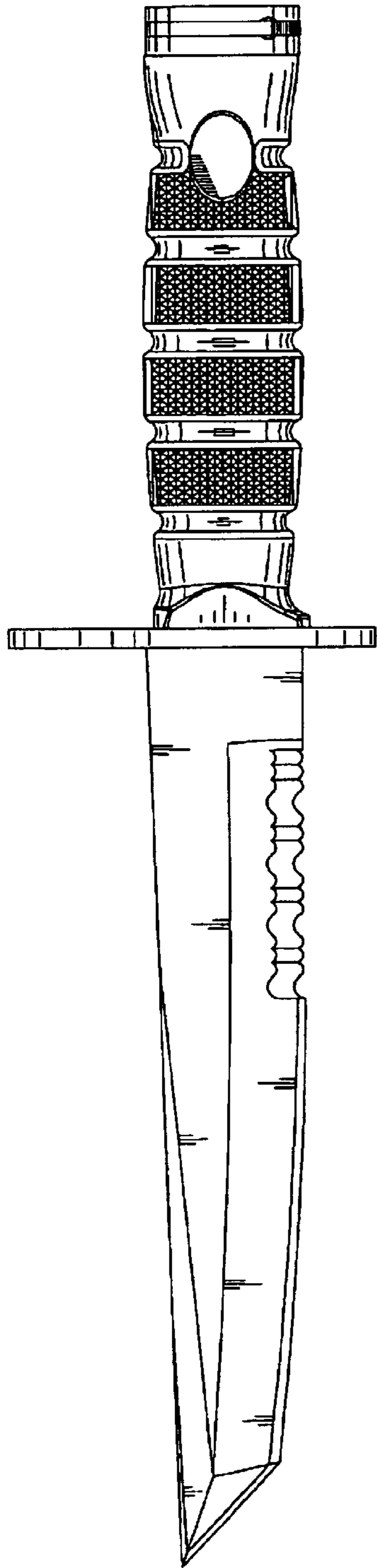
FIG. 9 is a top view of a second embodiment of the design. FIG. 10 is a bottom view of a second embodiment of the design.

FIG. 11 is a first end view of a second embodiment of the design; and,

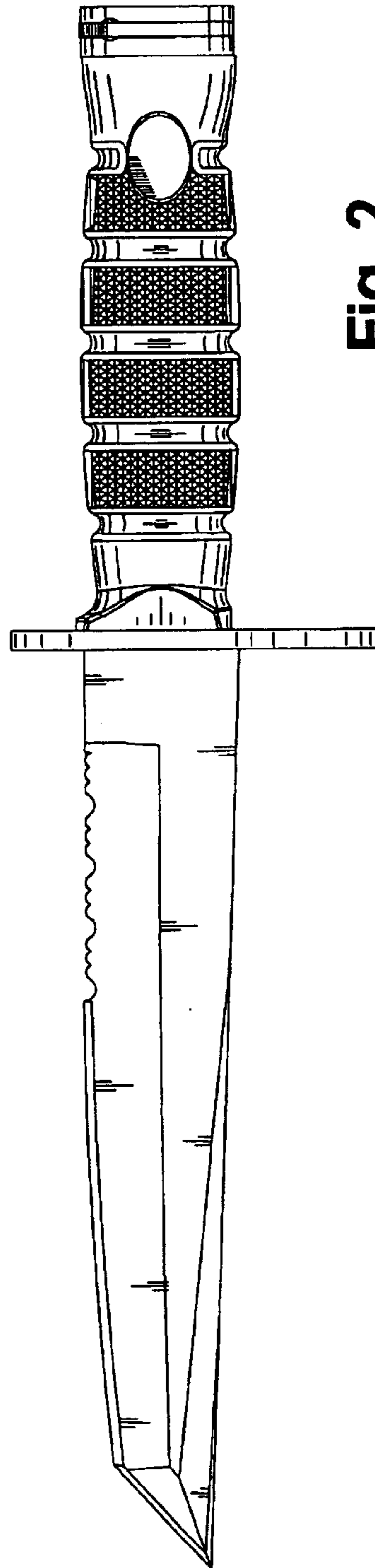
FIG. 12 is a second end view of a second embodiment of the design.

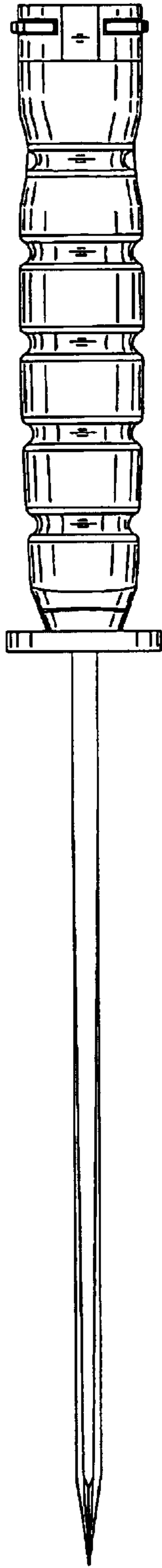




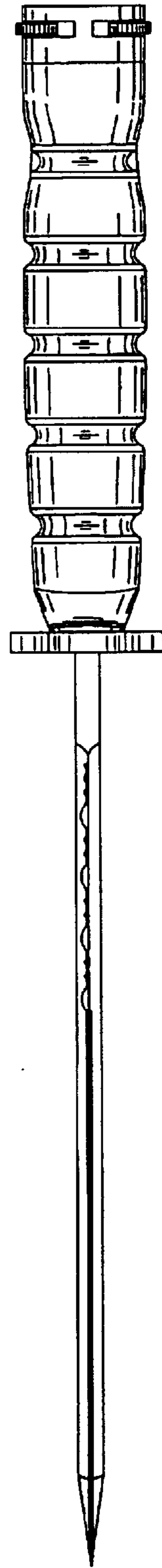

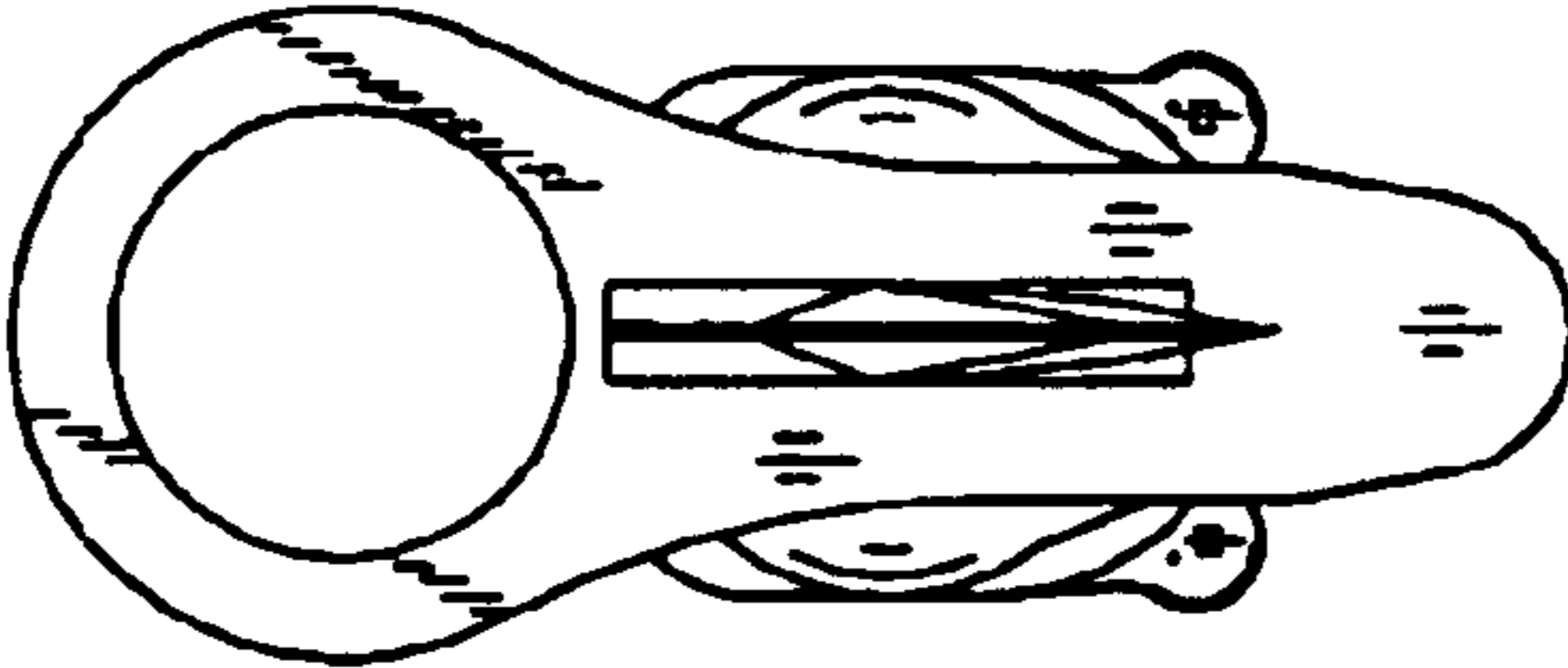

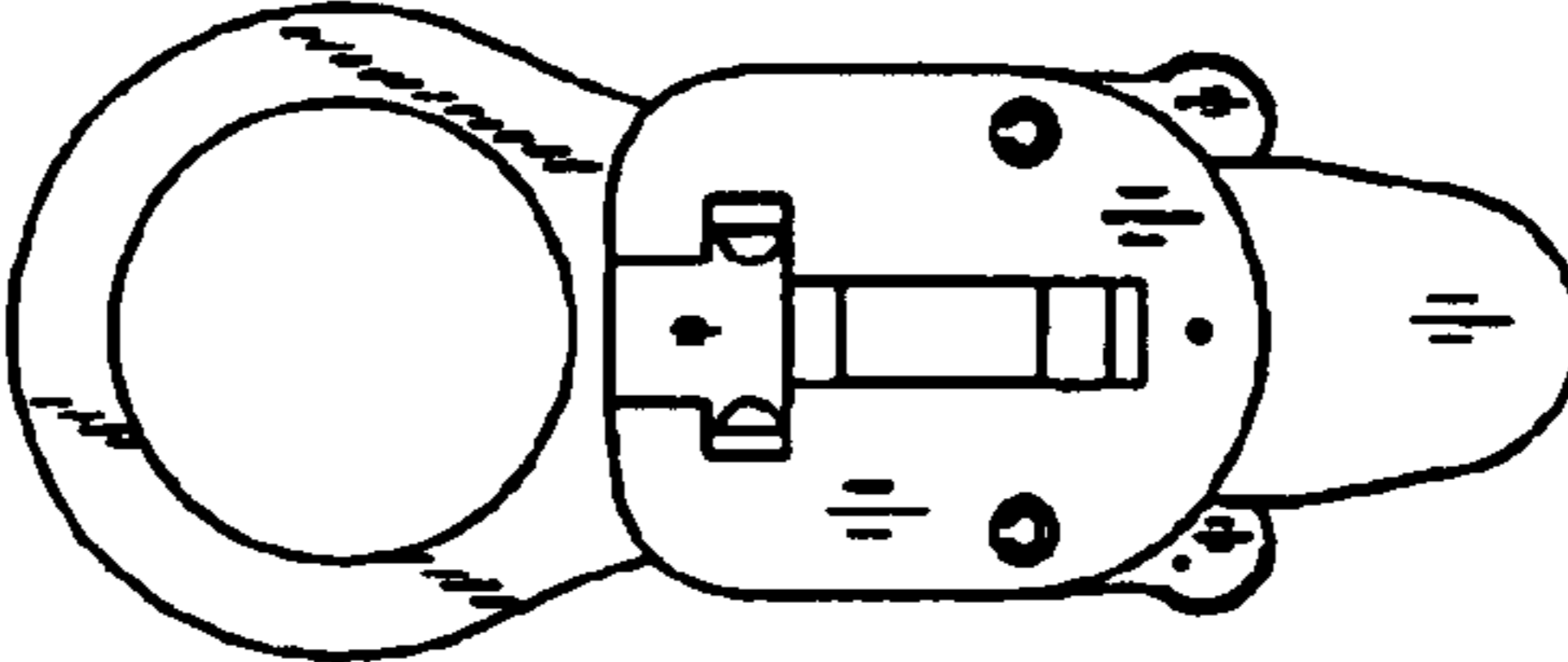

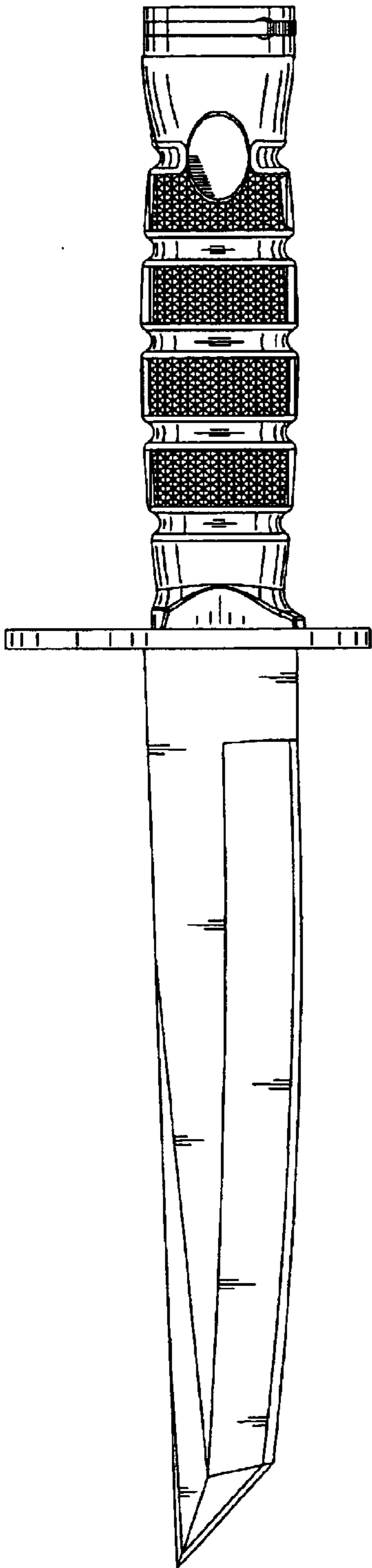

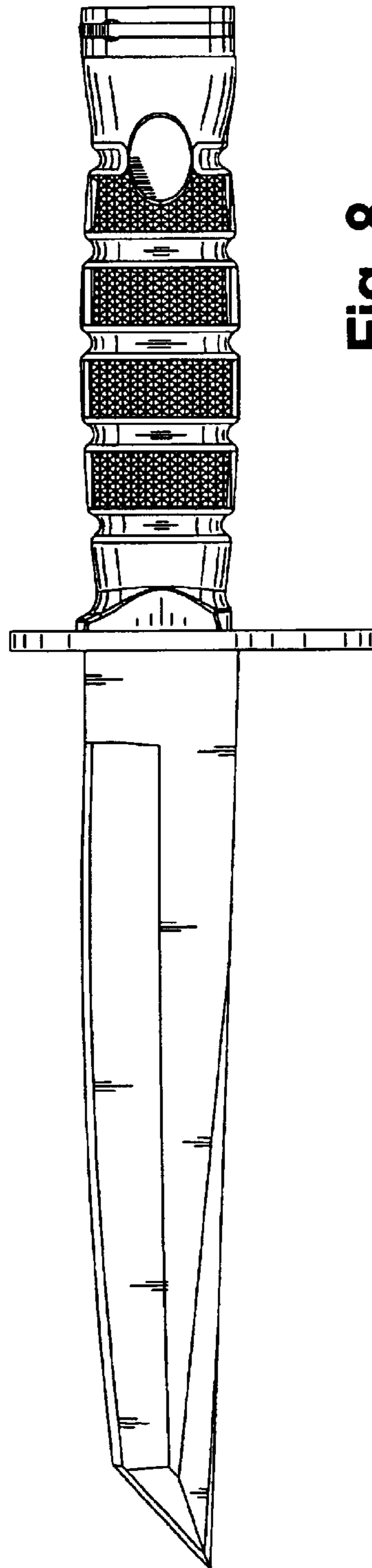
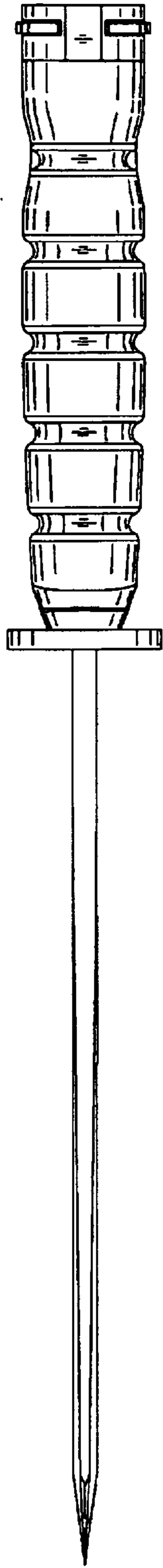
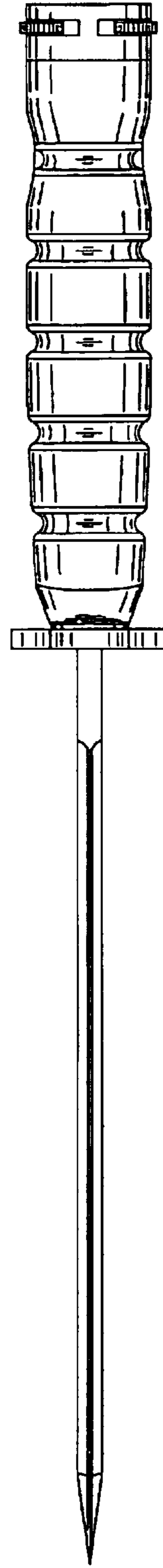


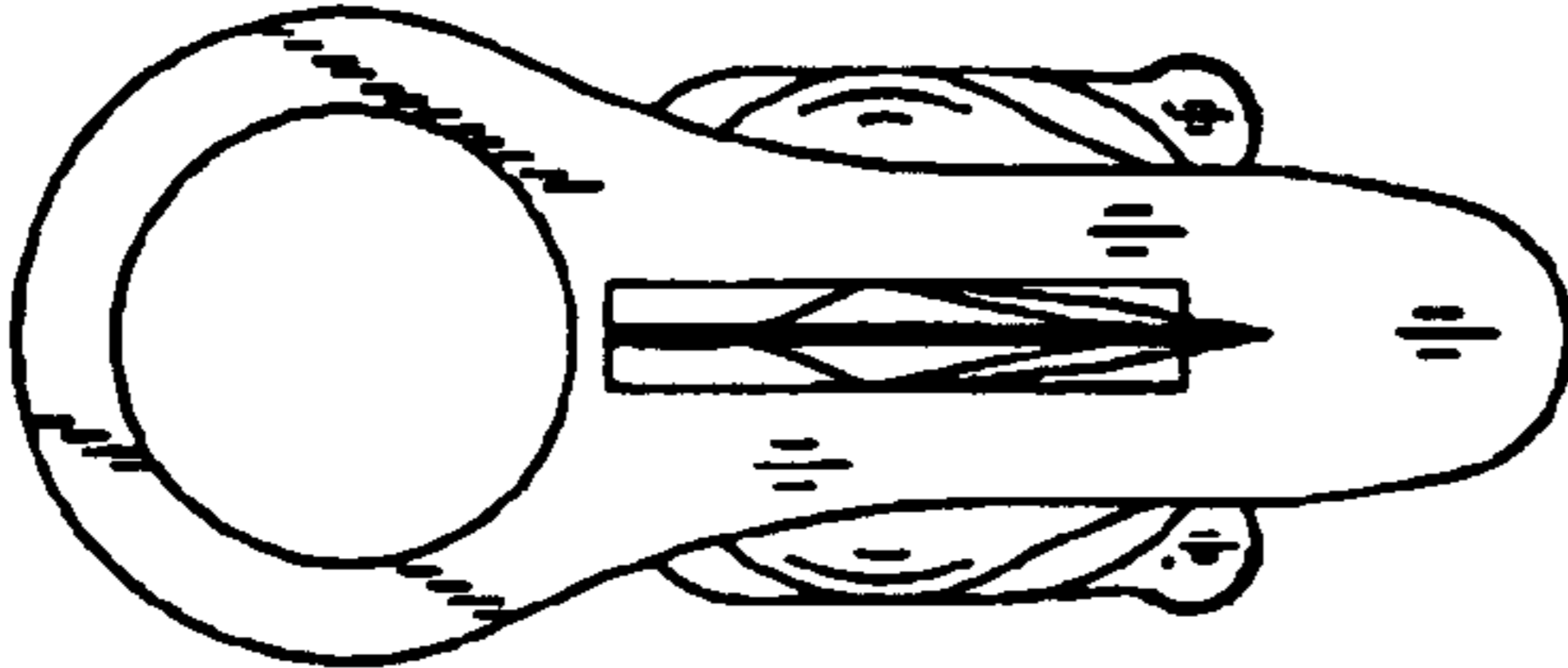

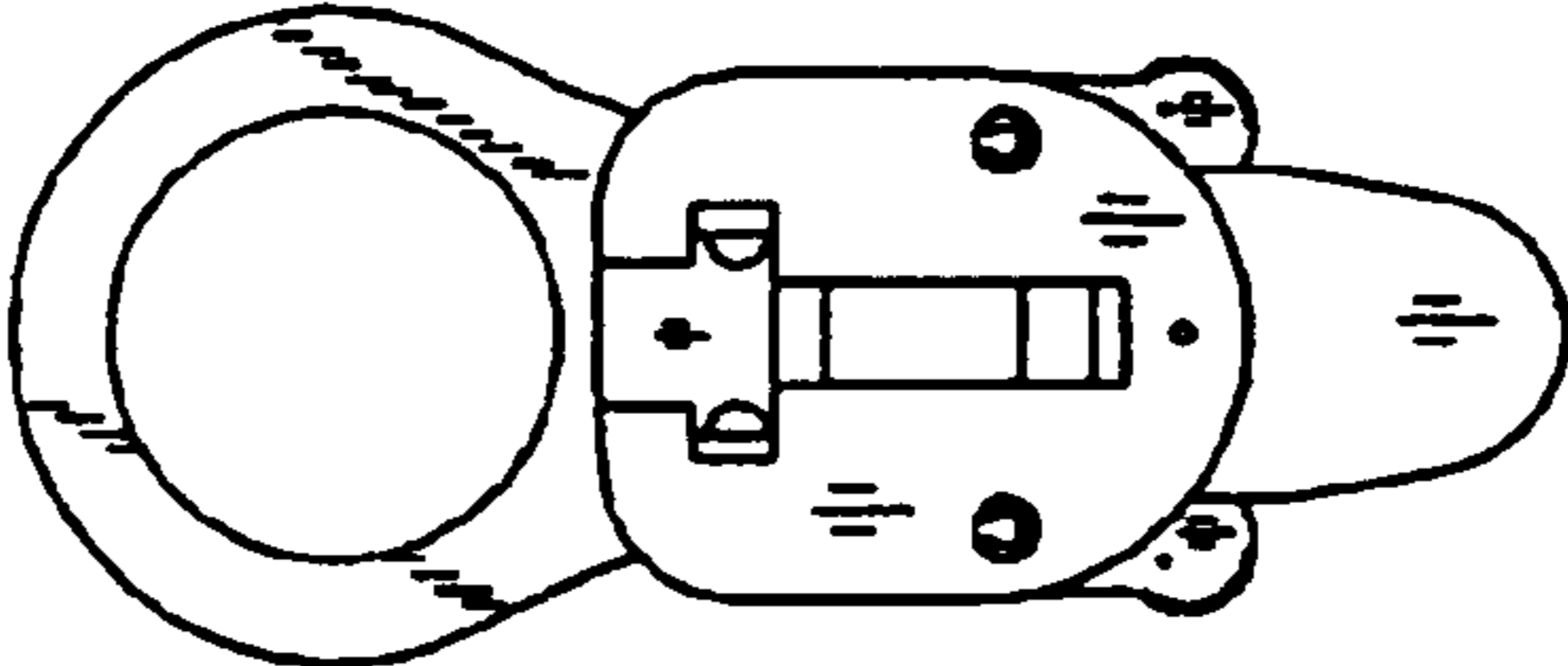
