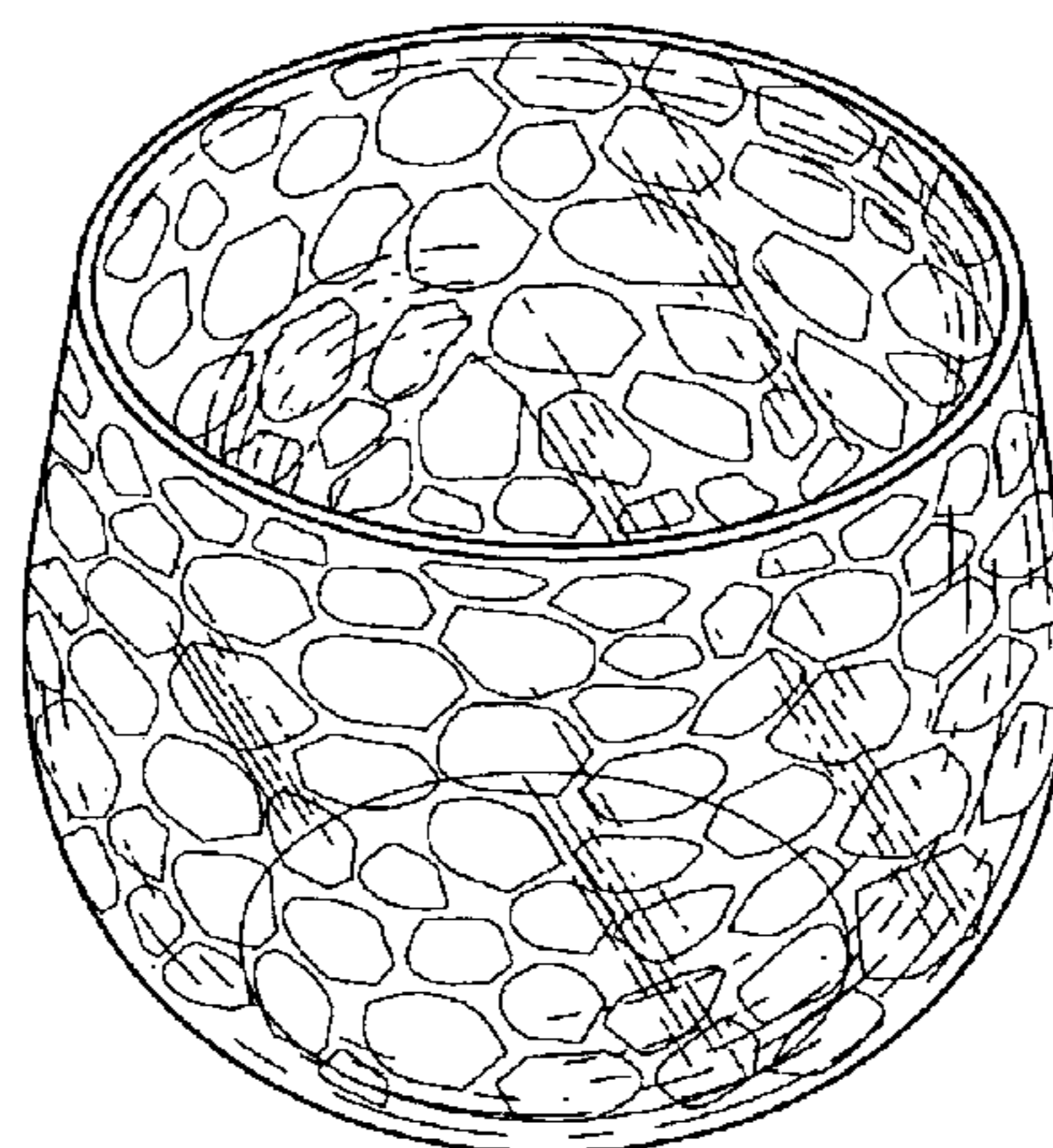

The ornamental design for a candle holder, as shown.

DESCRIPTION

FIG. 1 is a perspective view of a candle holder in accordance with the present invention as shown in the present design.

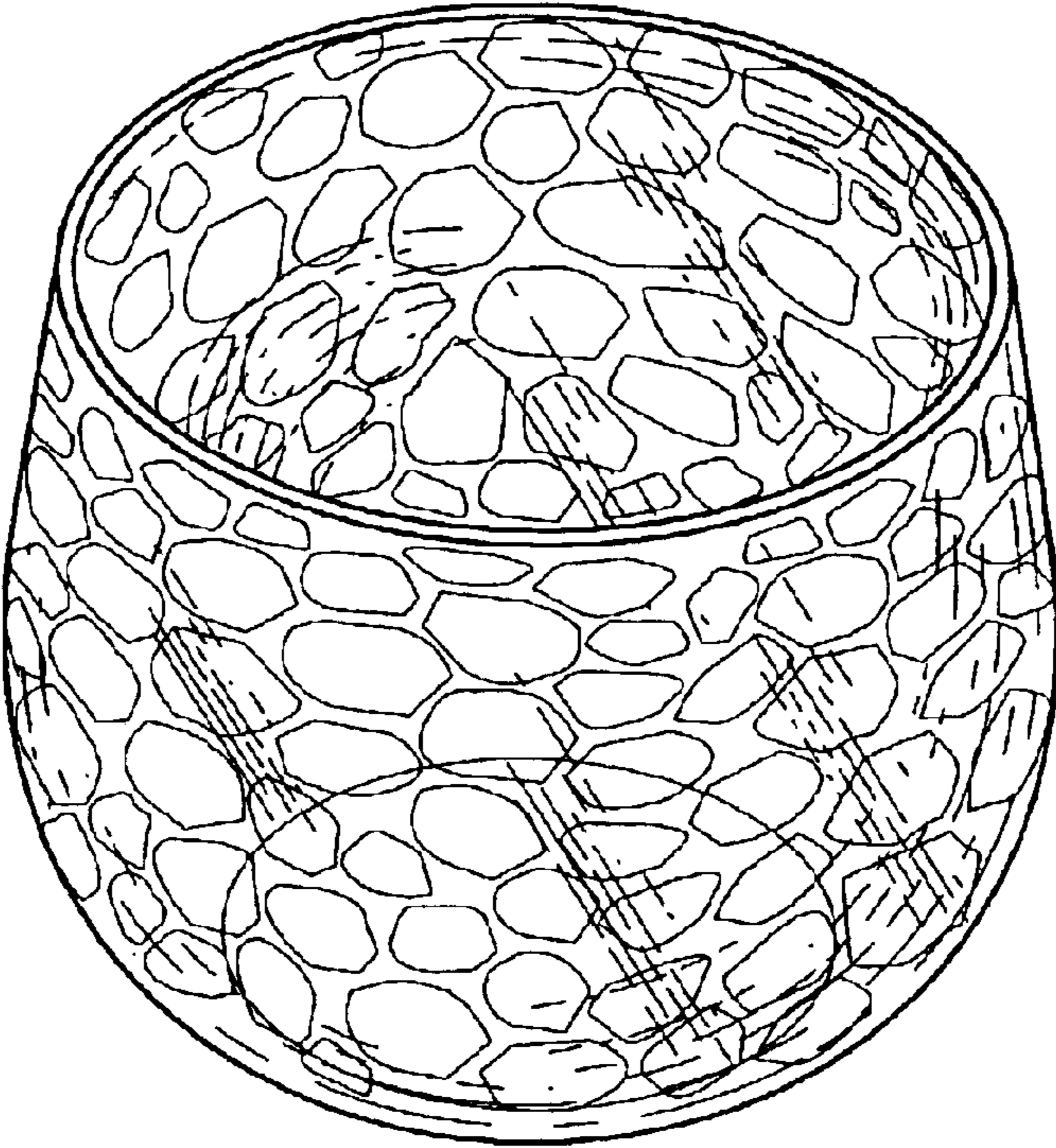

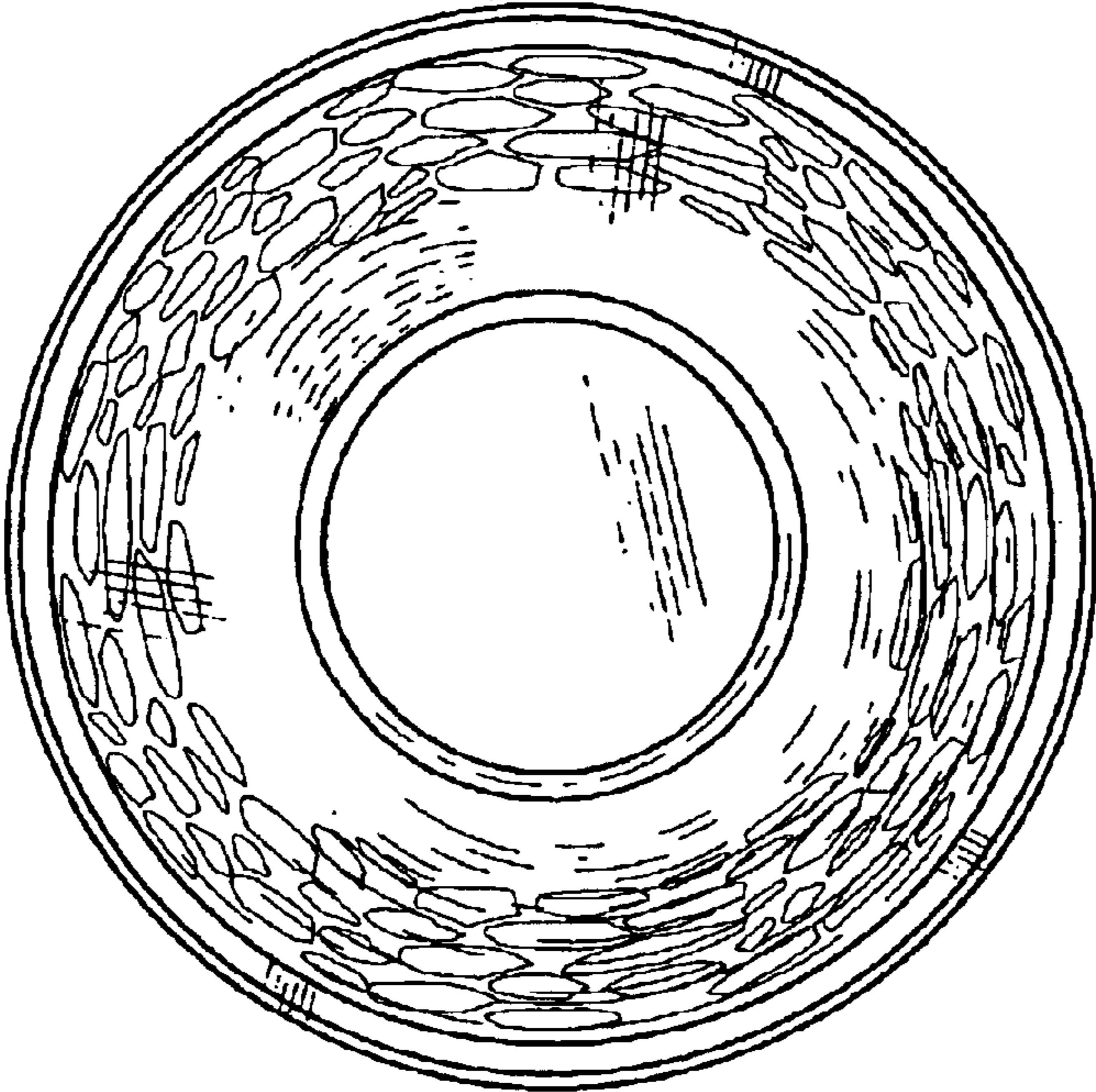

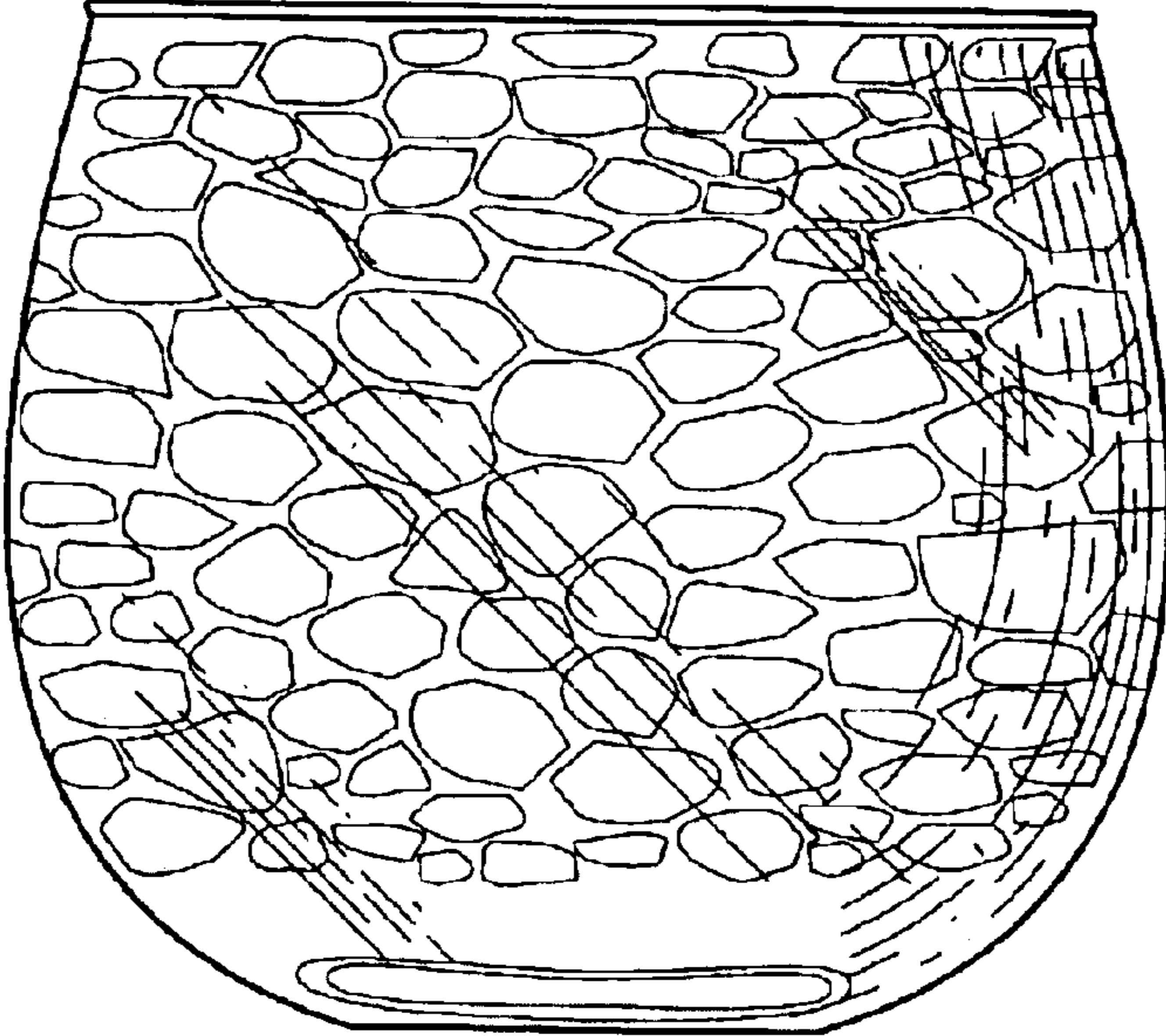

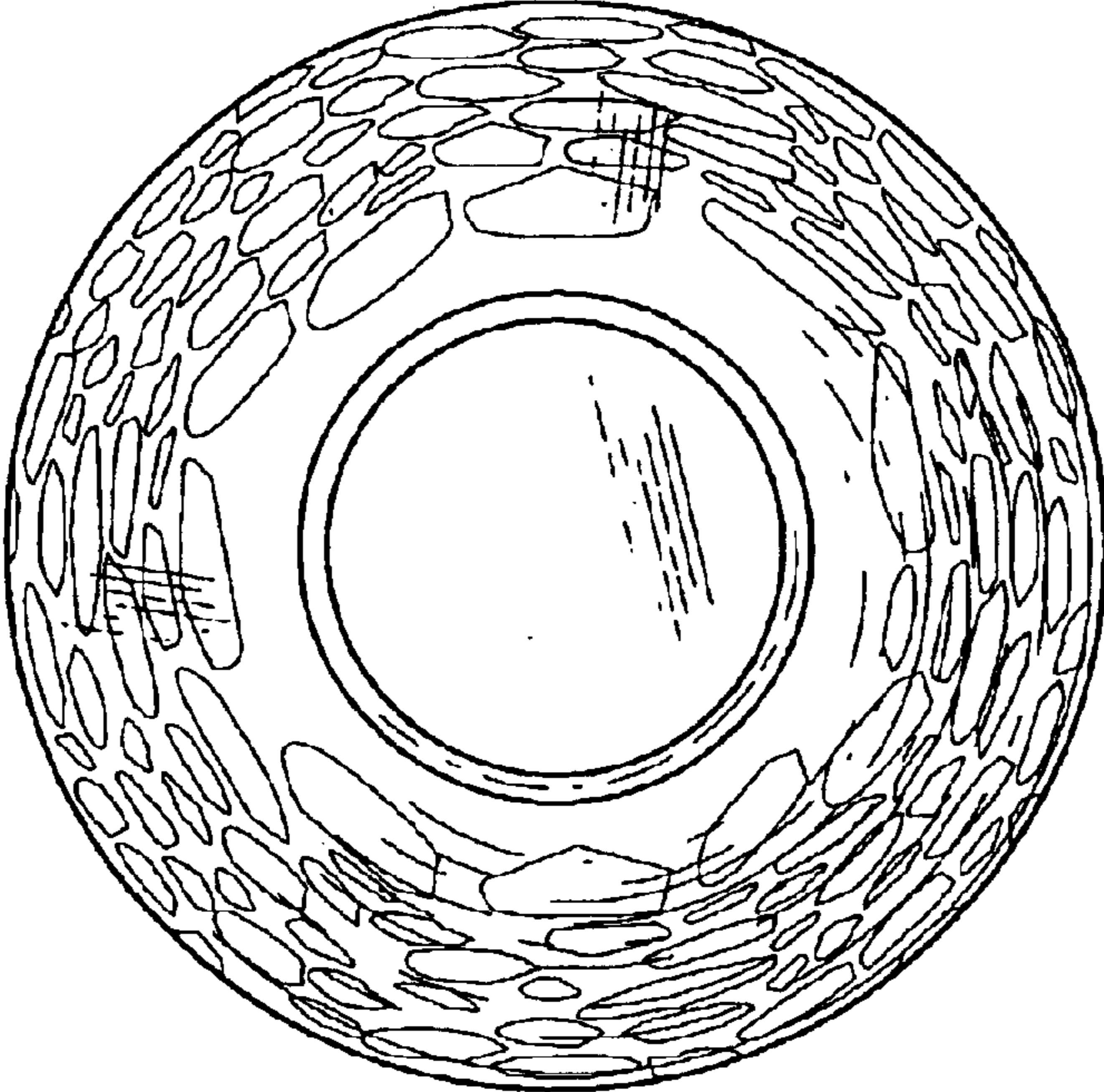
