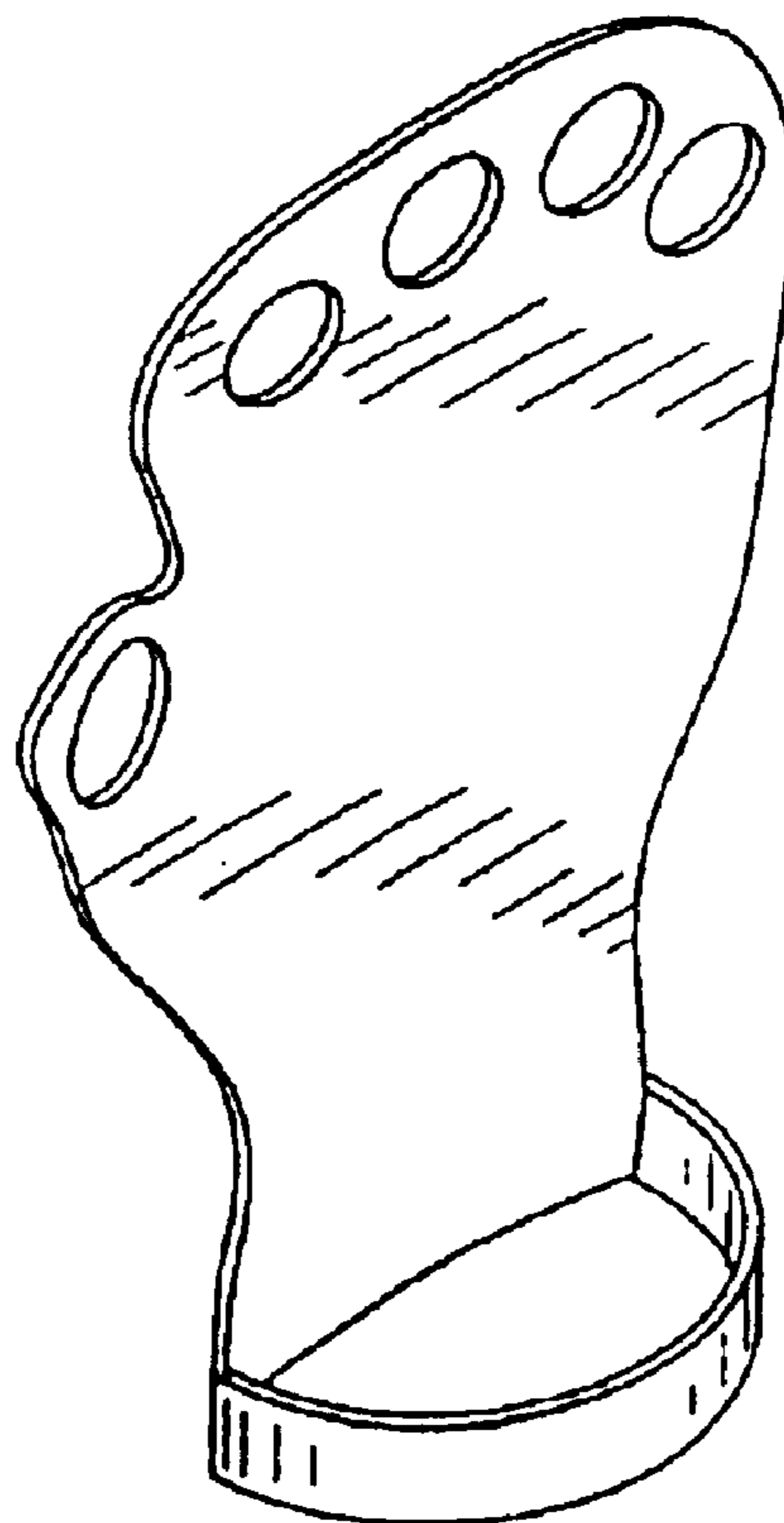
(57) **CLAIM**

What is claimed is the ornamental design for a hand protector, as shown and described herein.

**DESCRIPTION**

FIG. 1 is a rear perspective view of the invention;  
 FIG. 2 is a rear elevated view thereof;  
 FIG. 3 is a front view thereof;  
 FIG. 4 is a right side view thereof;  
 FIG. 5 is a left side view thereof;  
 FIG. 6 is a top end view thereof;  
 FIG. 7 is a bottom end view thereof;  
 FIG. 8 is a rear view of the invention engaged with a hand.  
 FIG. 9 is a front view of the invention engaged with a hand.  
 FIG. 10 is a rear perspective view of yet another alternative embodiment like that of FIG. 1, the only difference being a two-piece wrist band; and,  
 FIG. 11 is a rear perspective view of yet another alternative embodiment like that of FIG. 1, the only difference being a wrist band detached at one end.  
 The broken line showing is for illustrative purposes only and forms no part of the claimed design.

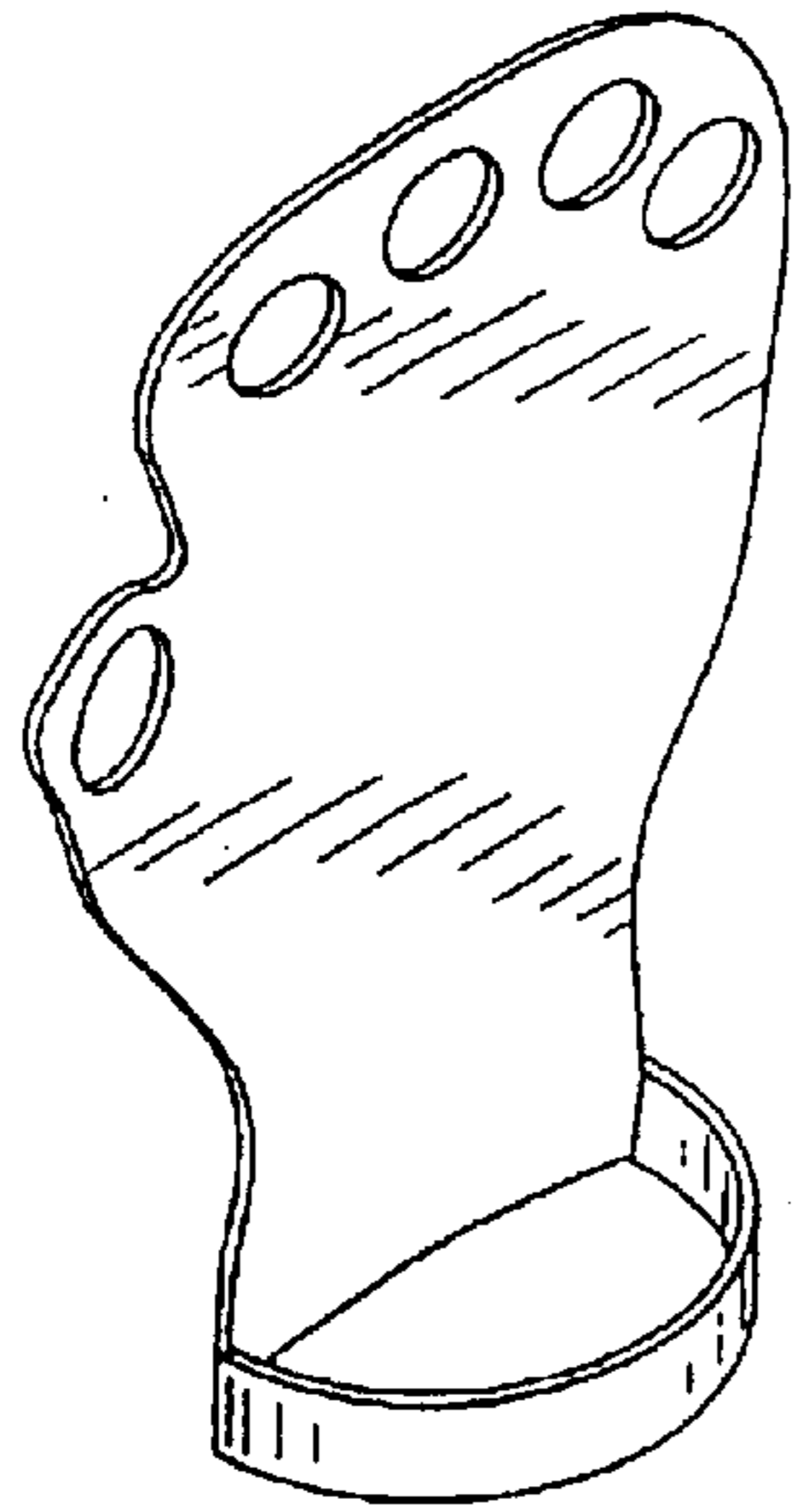

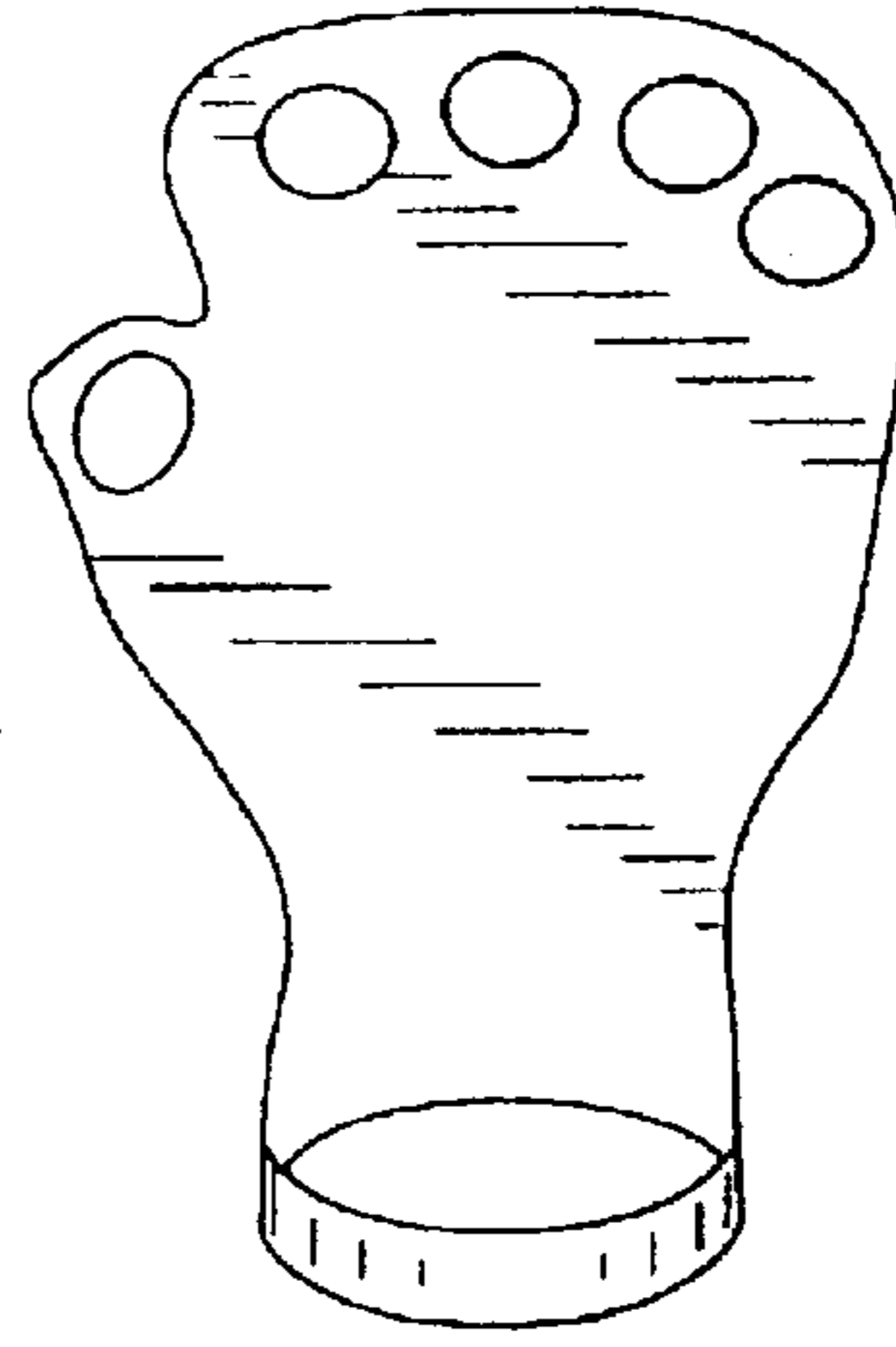

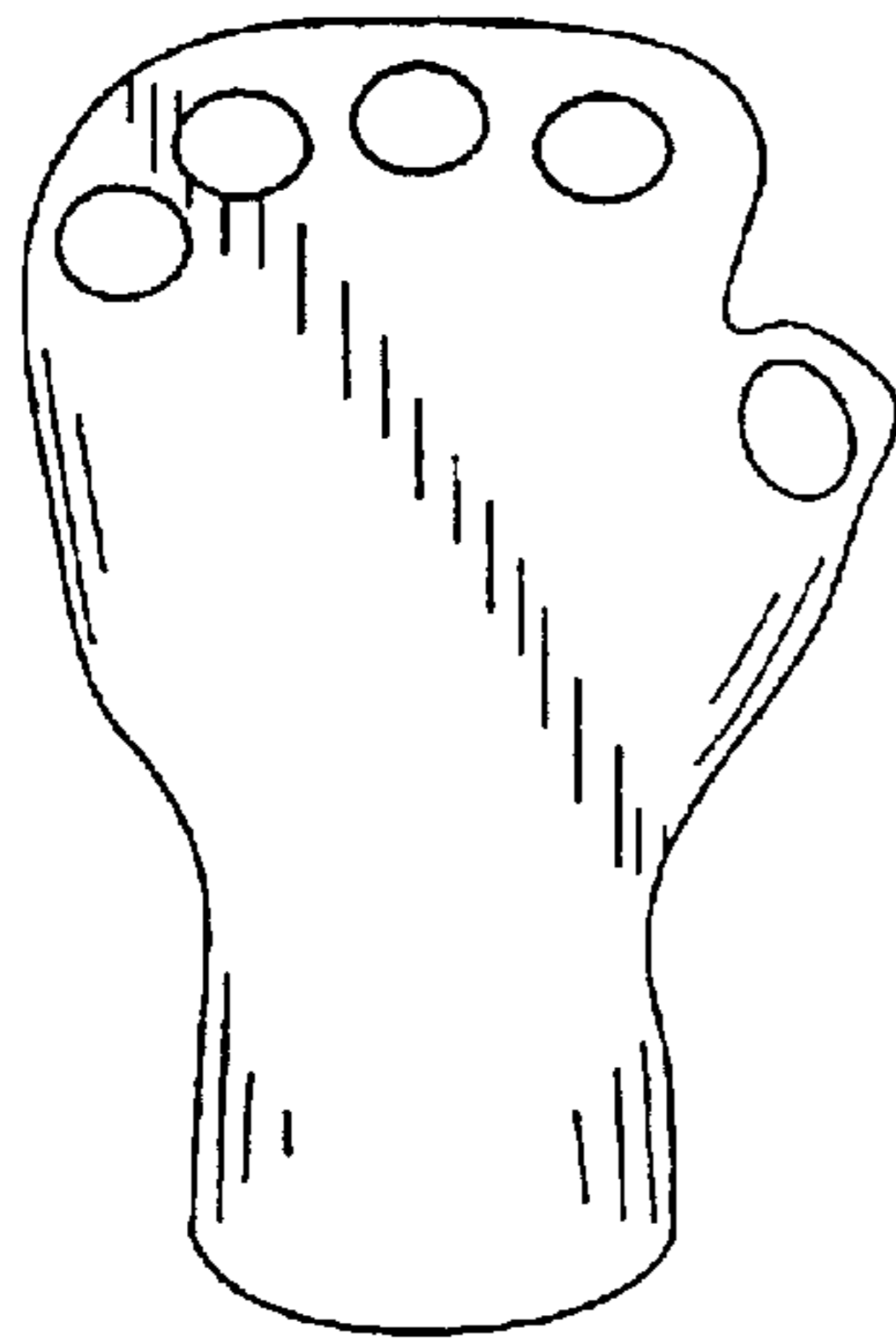

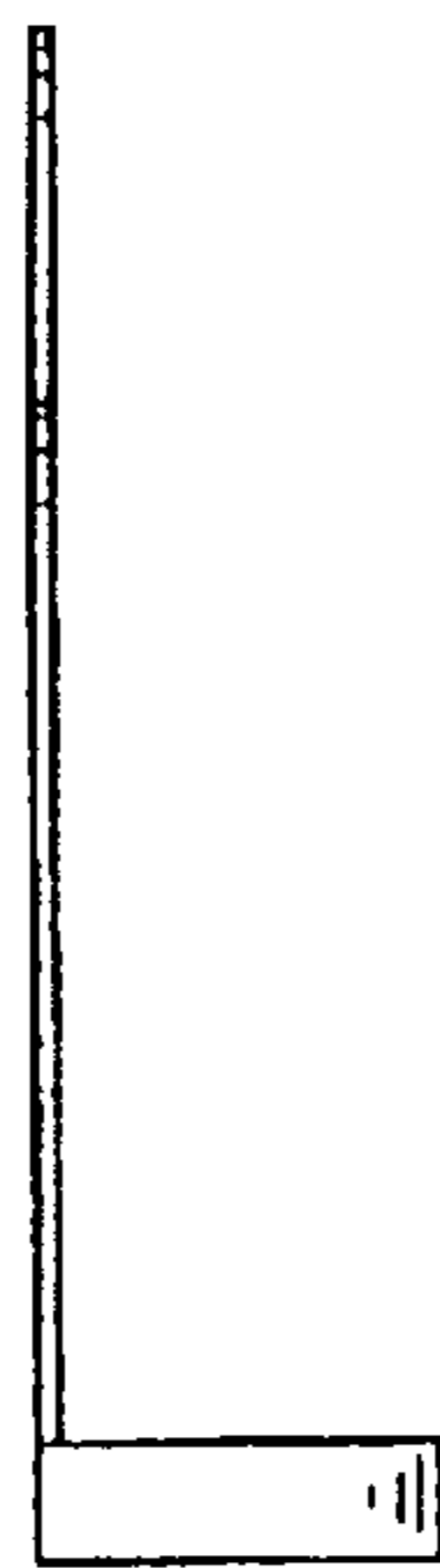

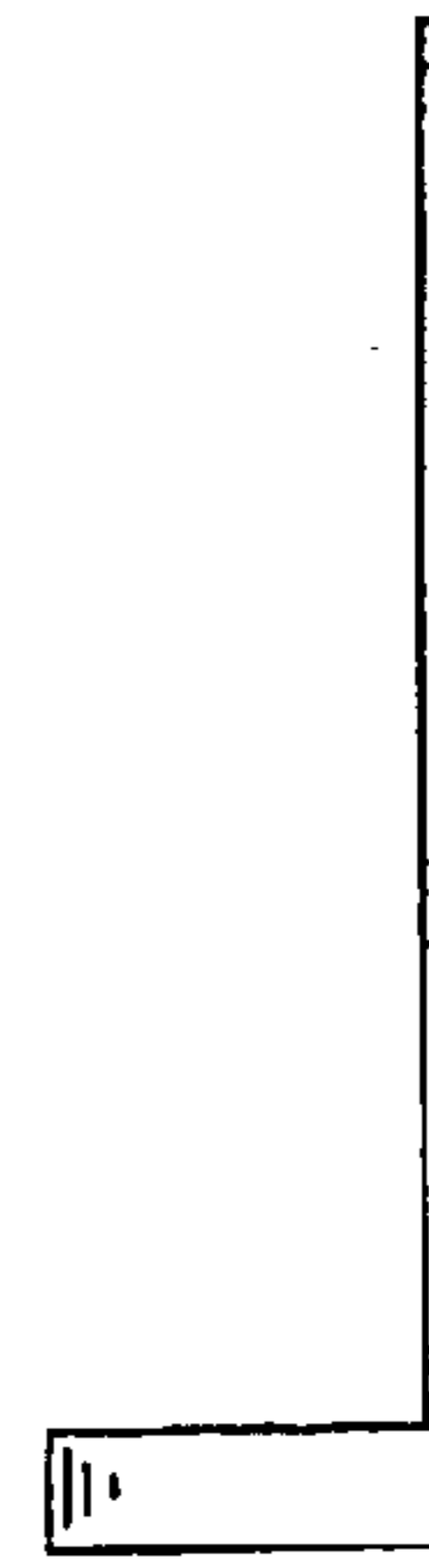

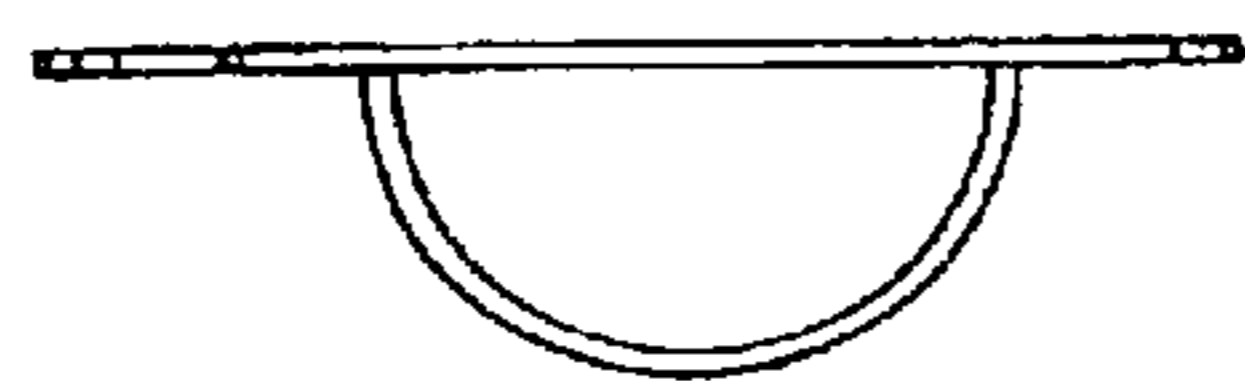
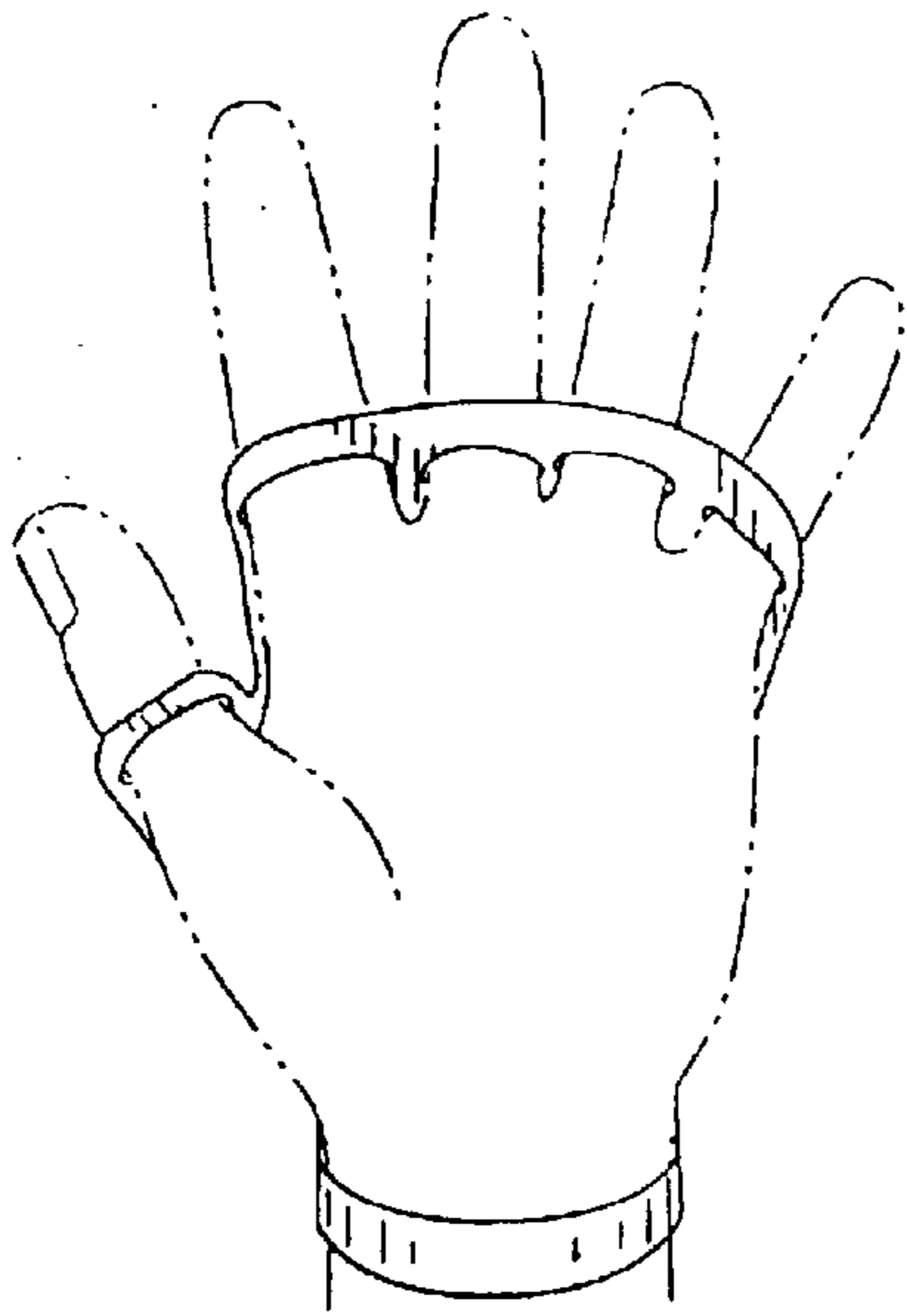


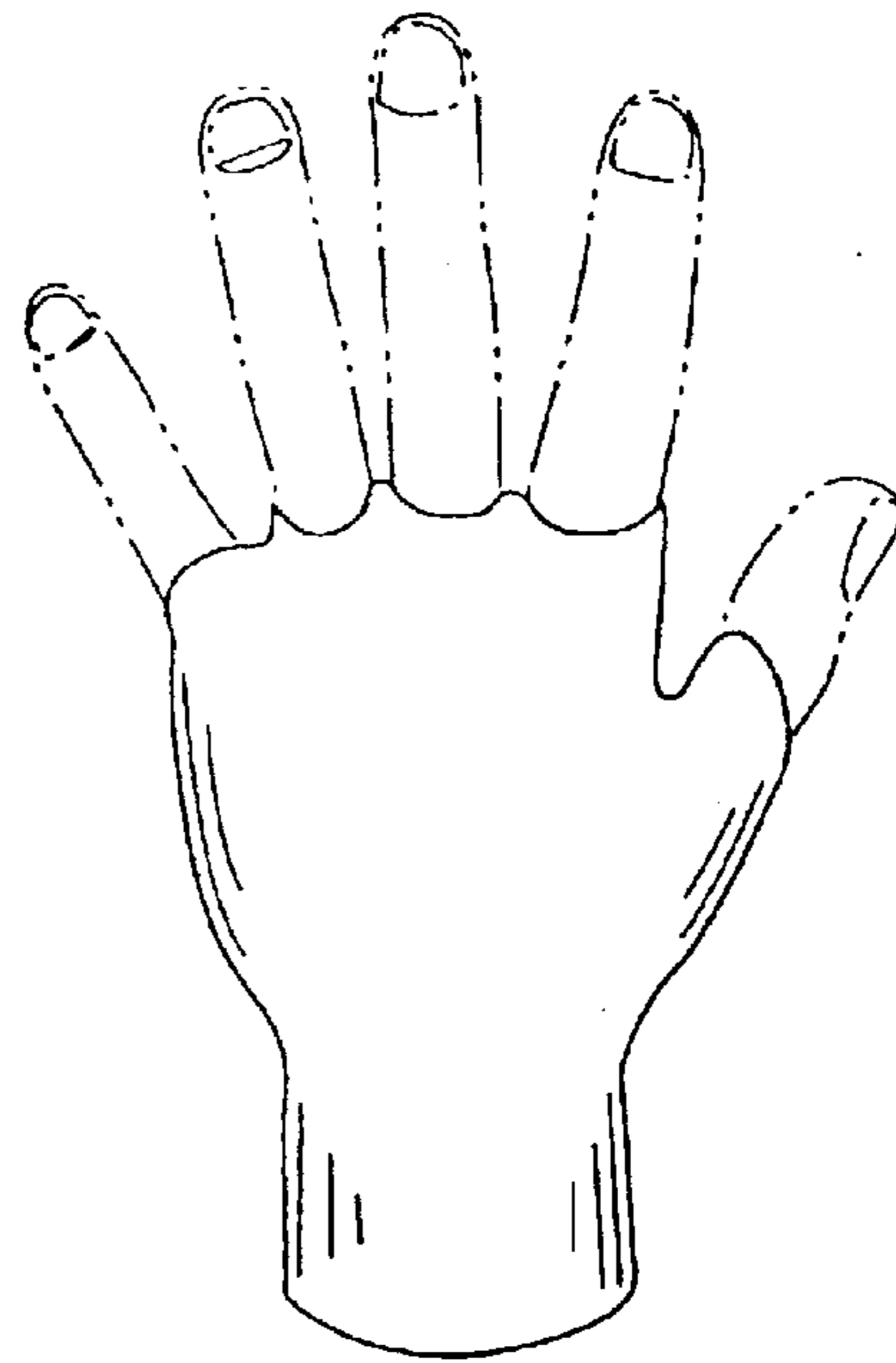

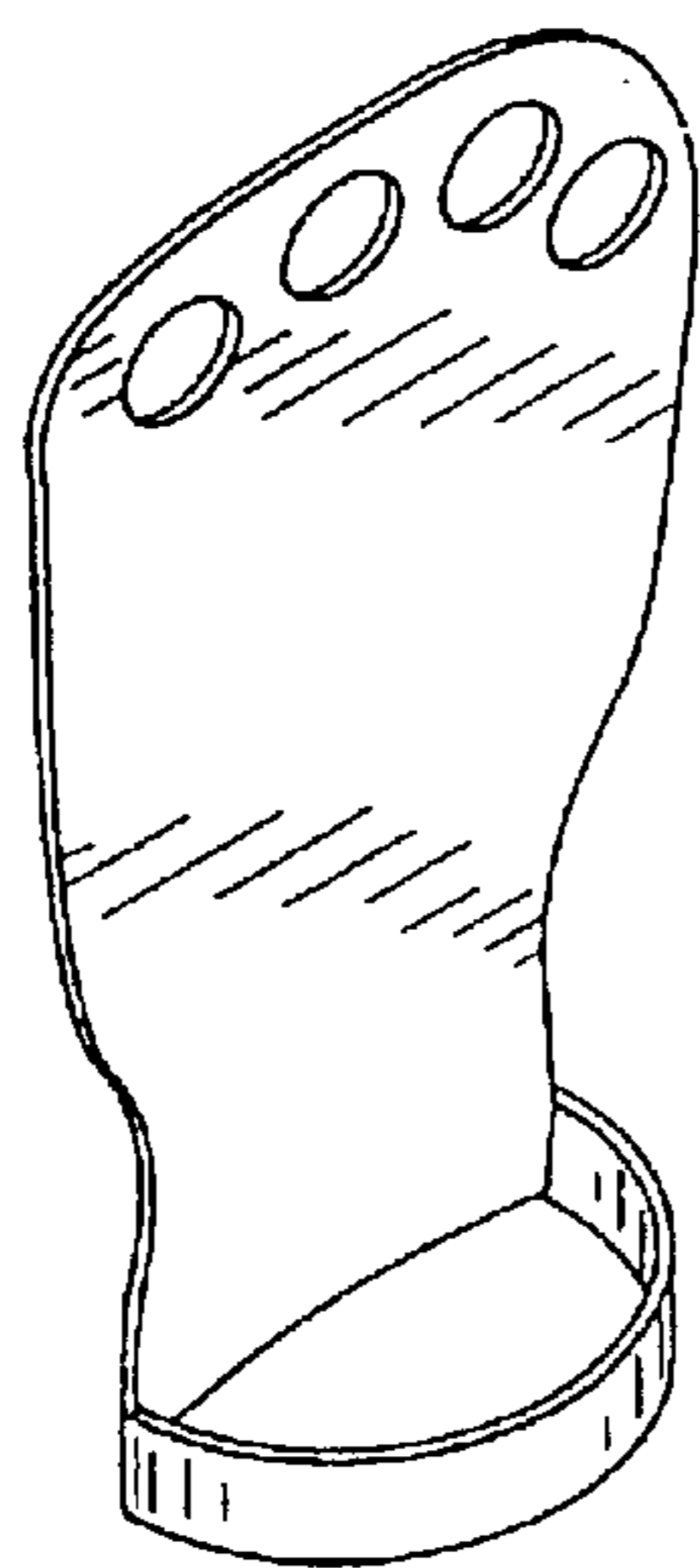

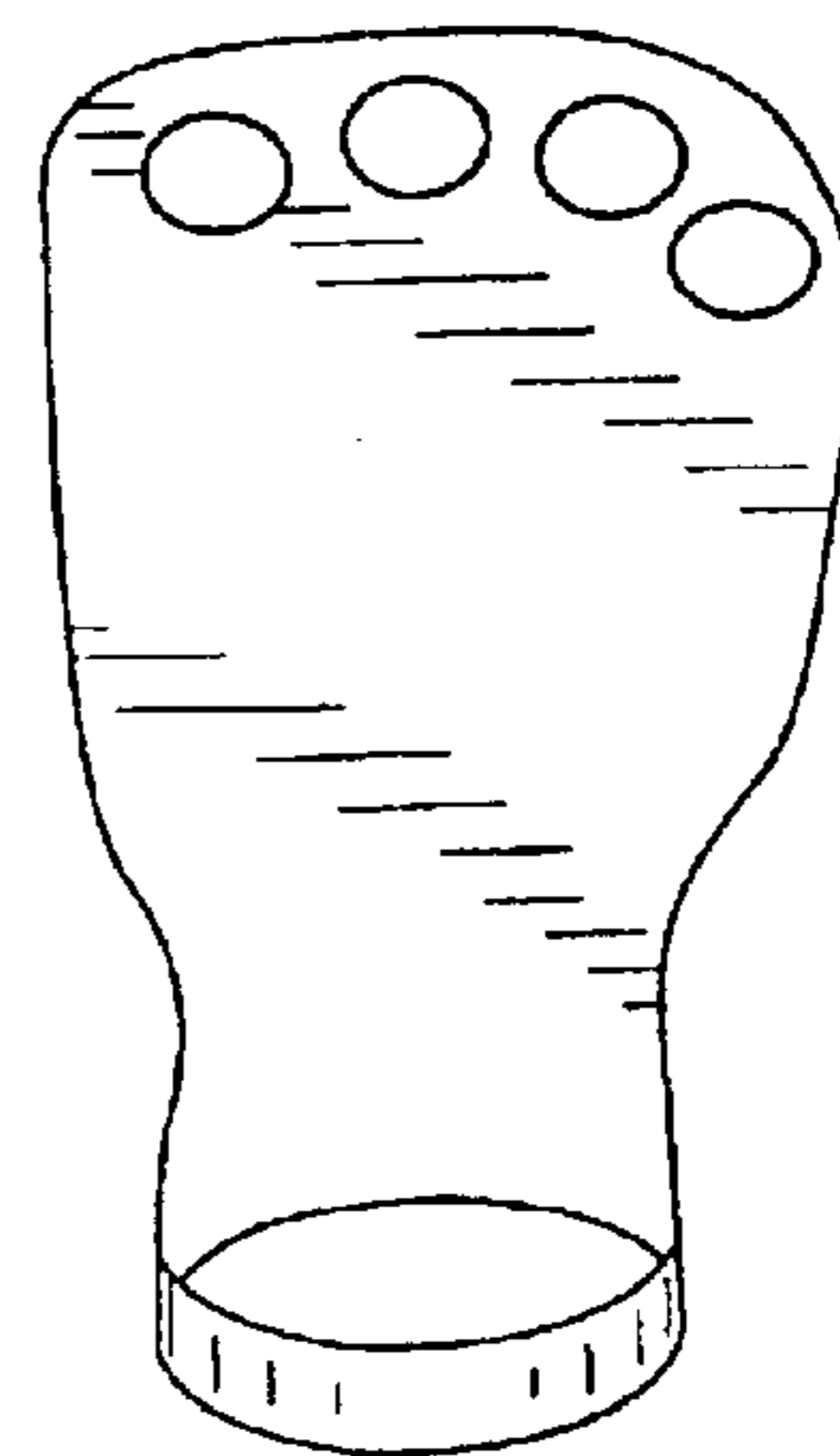
