FIG. 1 is a perspective view of the decorative bill for sports cap with a cap of the present invention;
FIG. 2 is another perspective view of the decorative bill for sports cap with a visor of the present invention shown in another environment;
FIG. 3 is a slightly reduced top view of the decorative bill for sports cap of FIG. 1;
FIG. 4 is a slightly reduced bottom view of the decorative bill for sports cap of FIG. 1;
FIG. 5 is a slightly reduced right side view of the decorative bill for sports cap of FIG. 1; and,
FIG. 6 is a front view of the decorative bill for sports cap of FIG. 1.

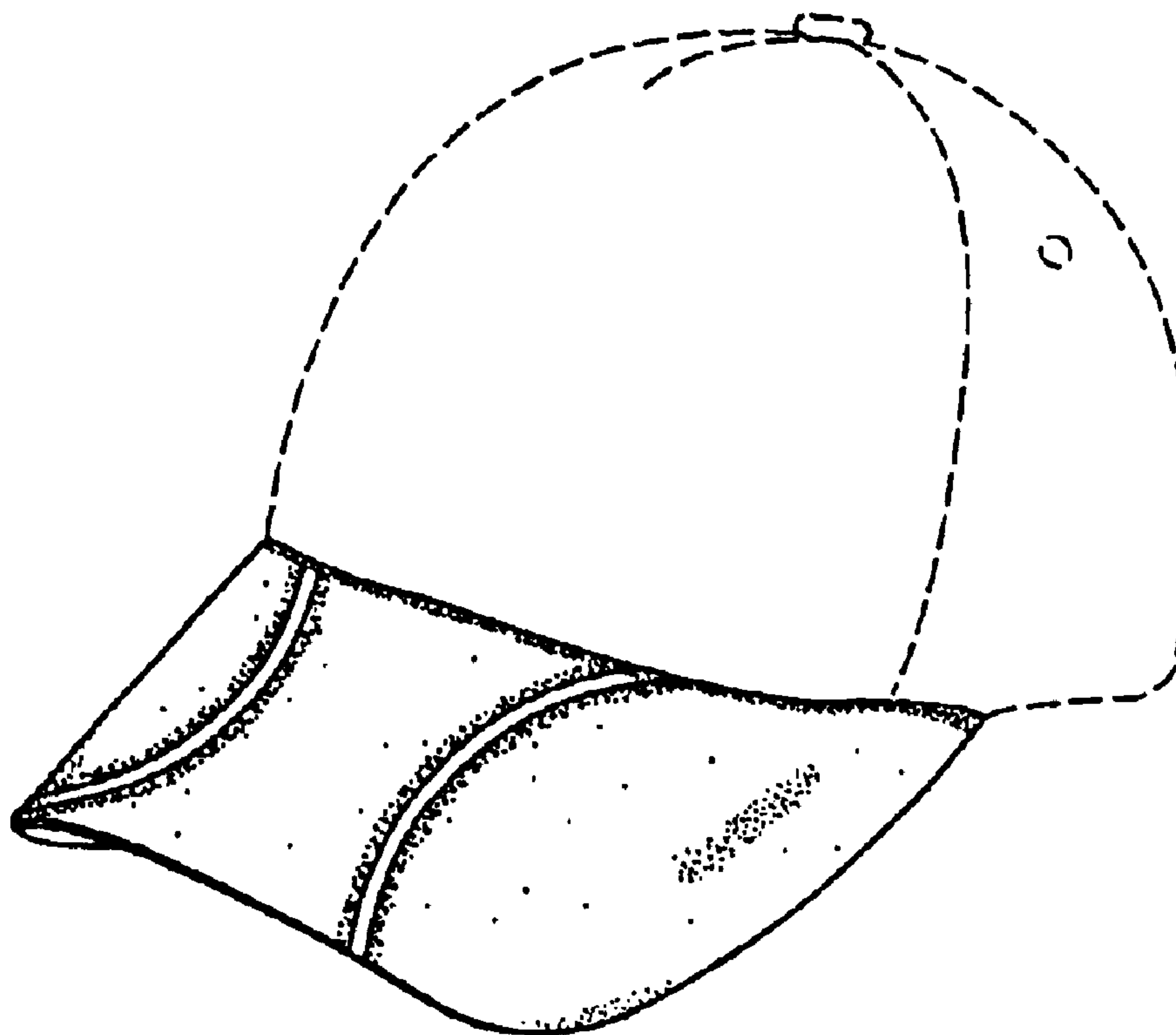

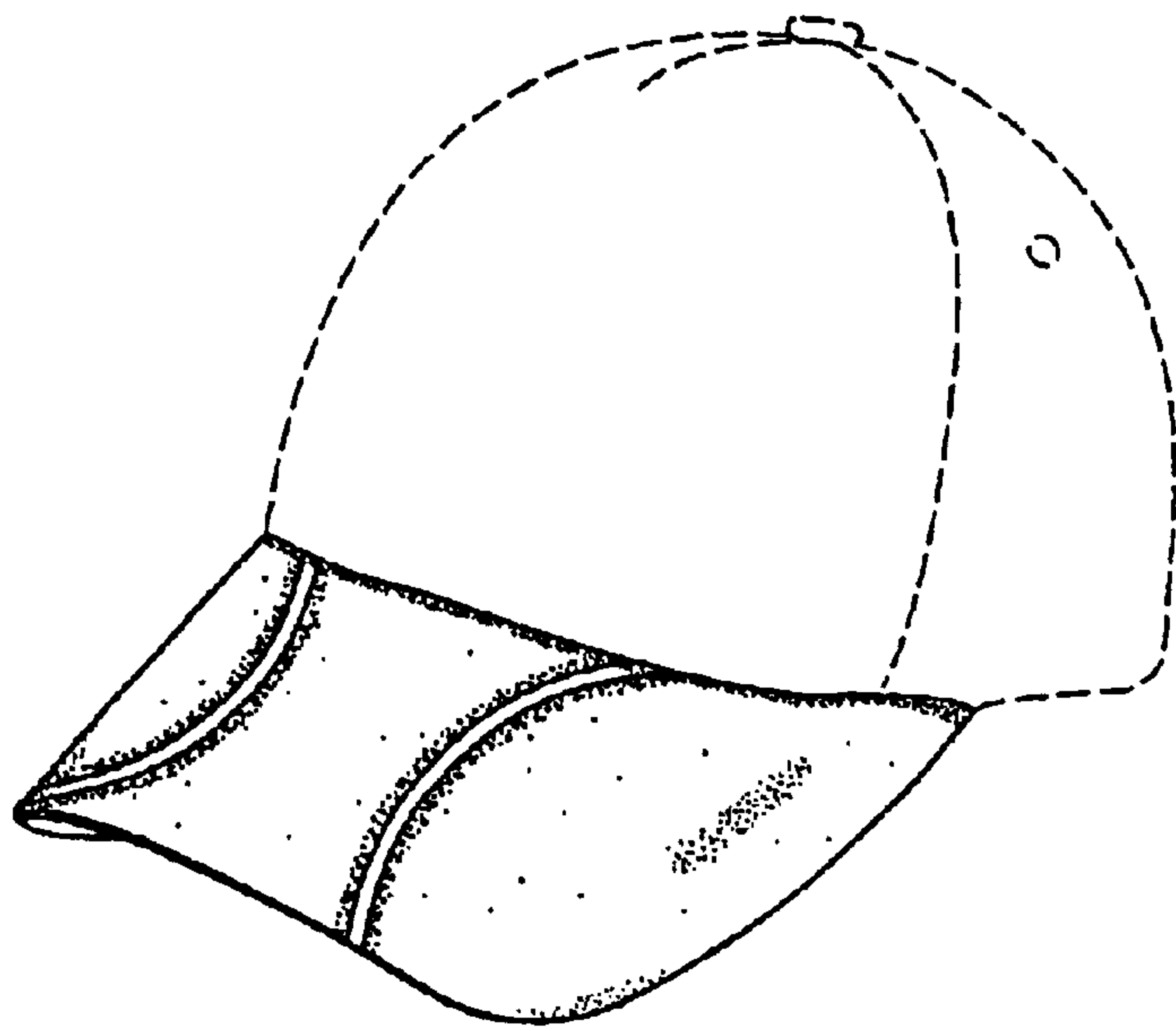

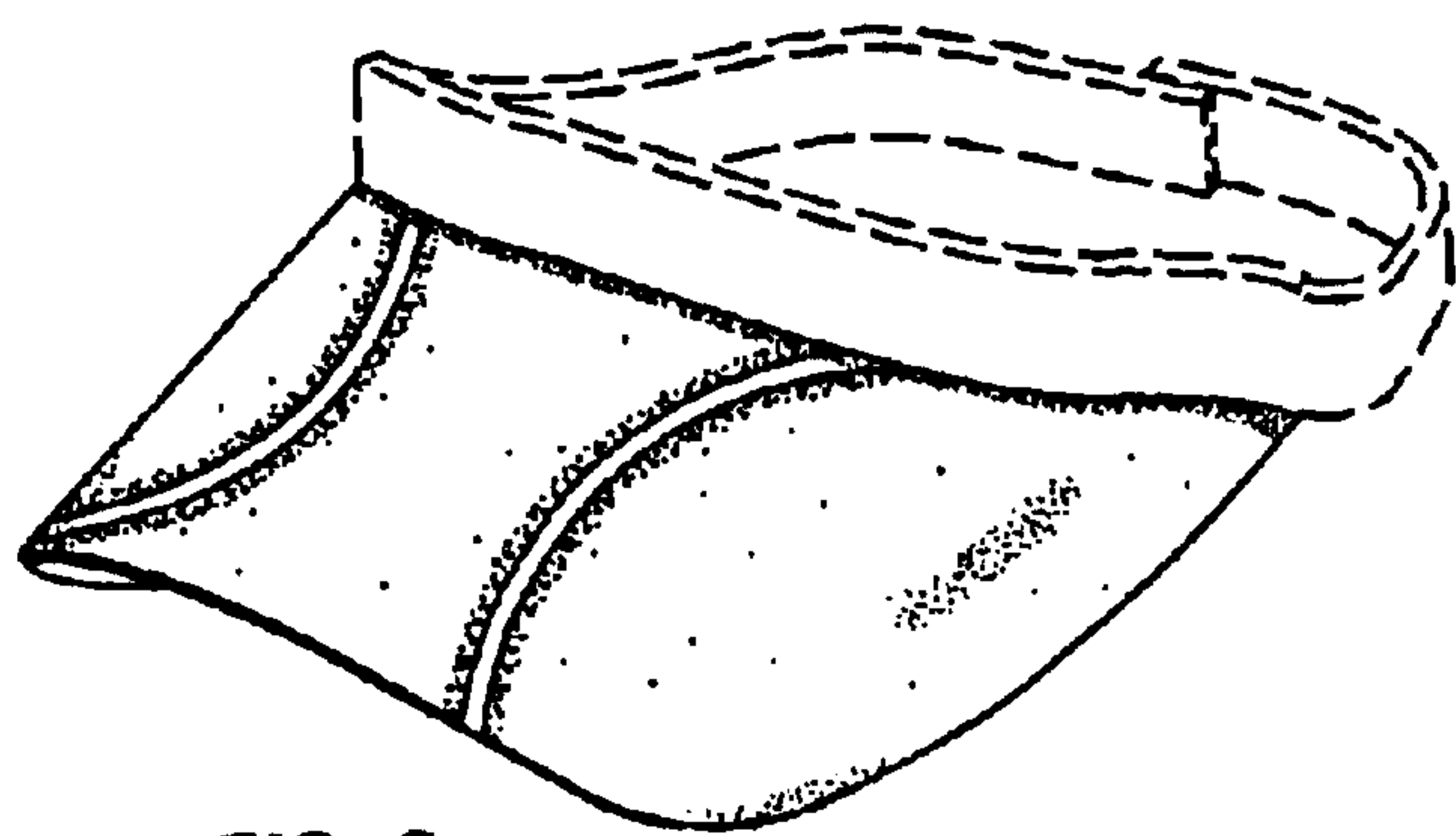

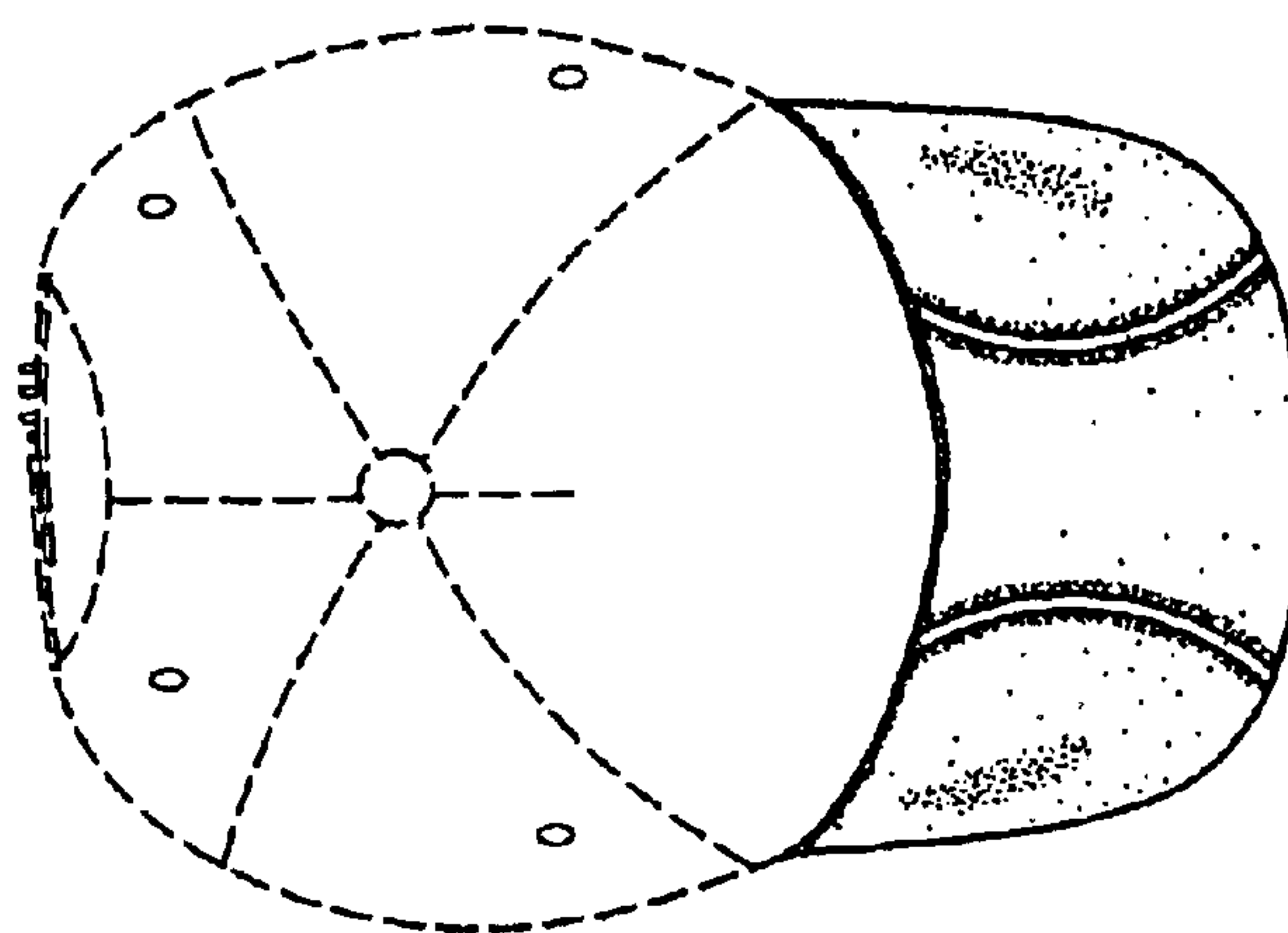

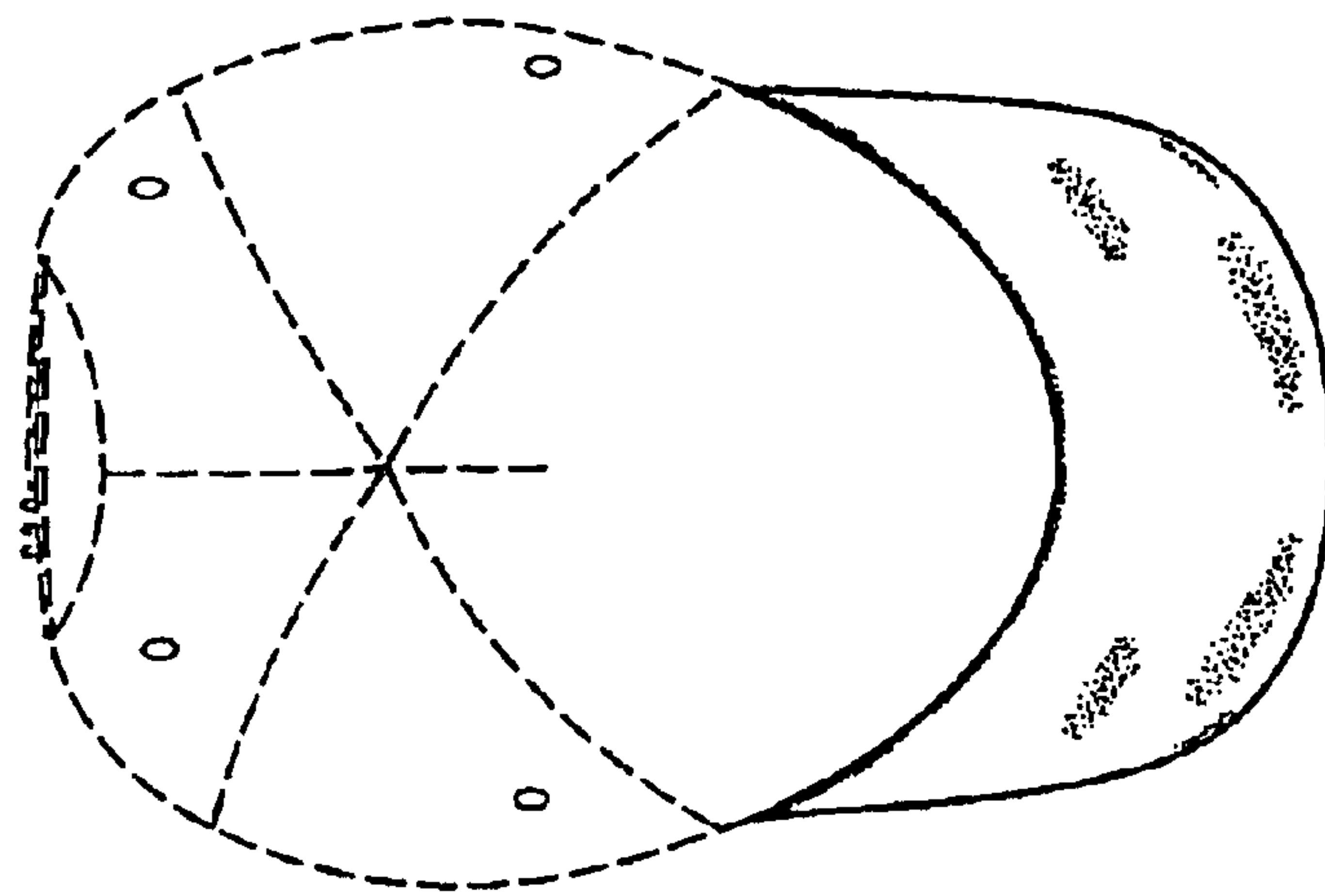

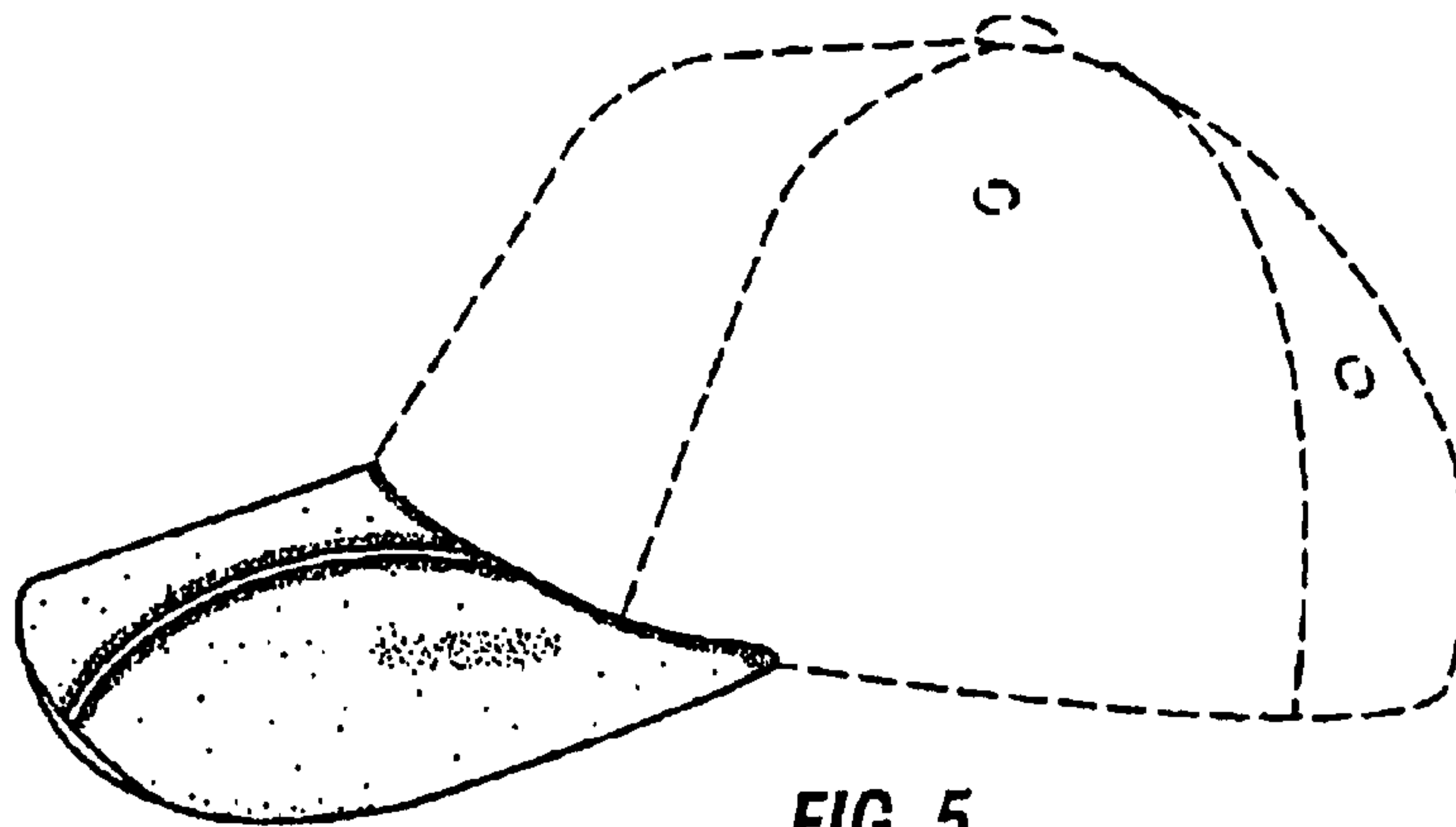

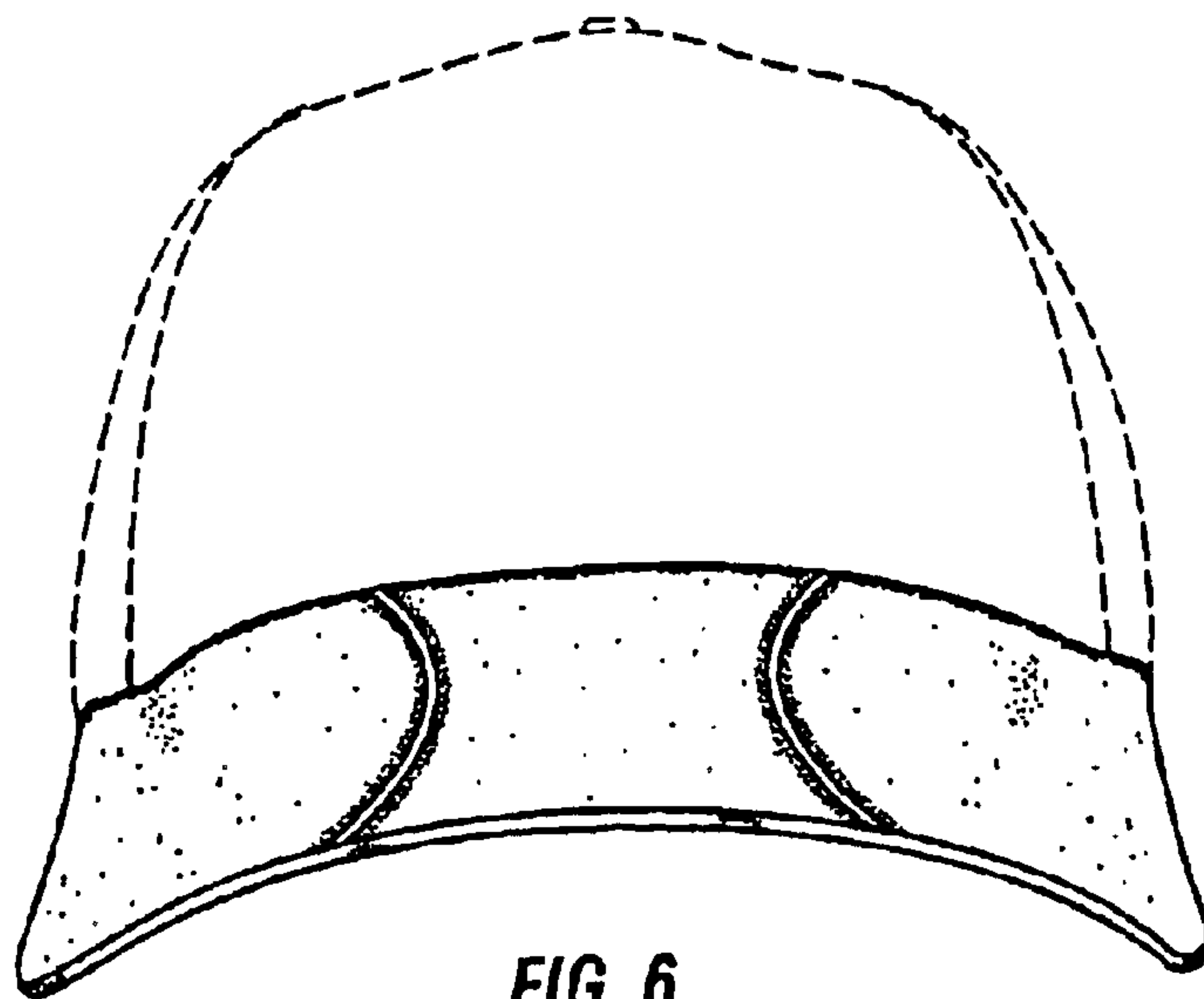
