(57) **CLAIM**

The ornamental design for a chair, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the front and right side of a chair showing my new design;

FIG. 2 is a perspective view of the rear and right side thereof;

FIG. 3 is a perspective view of the top, front and right side thereof;

FIG. 4 is a right side elevational view thereof, the left side being a mirror image thereof;

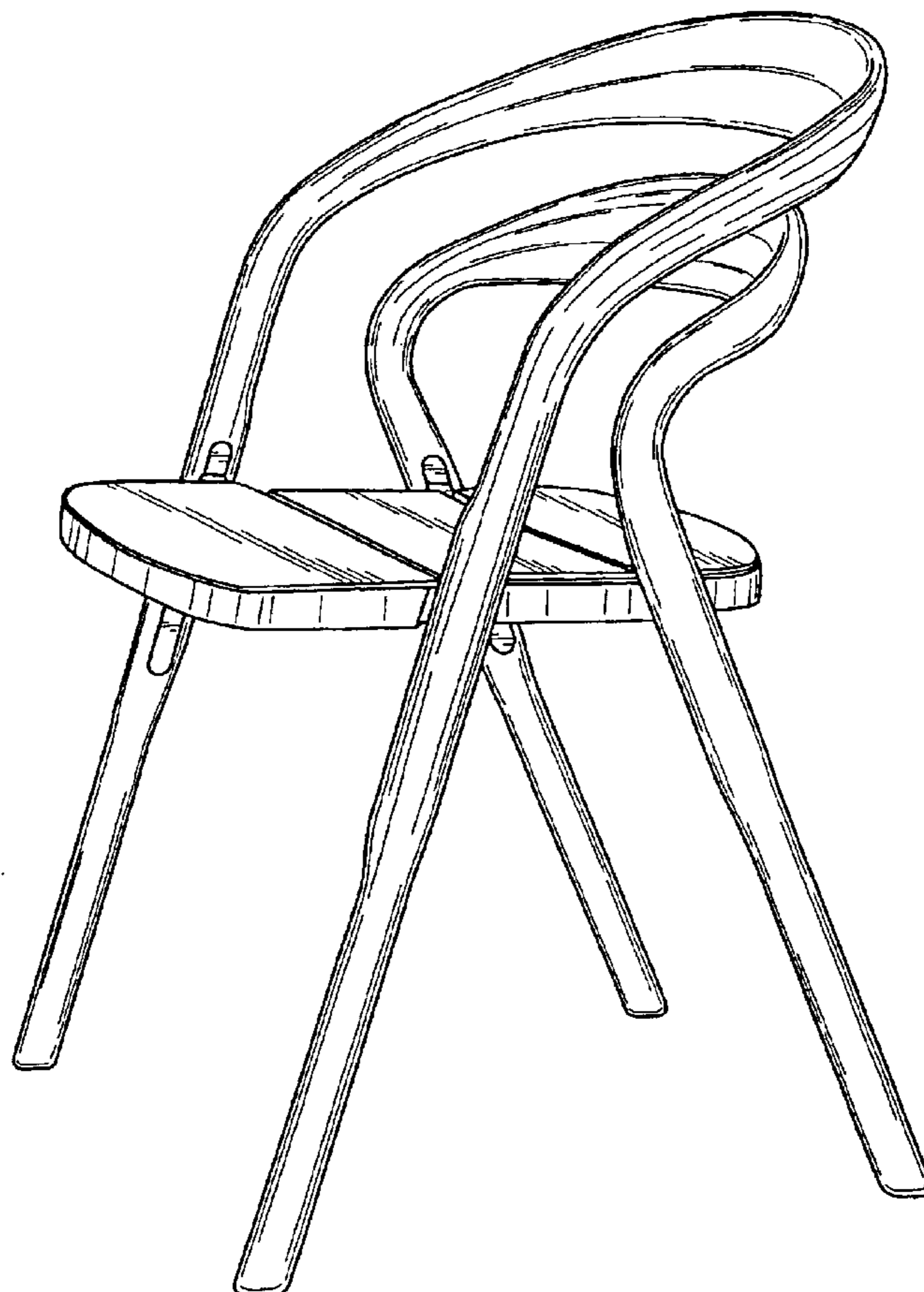
FIG. 5 is a perspective view of the top and front thereof;

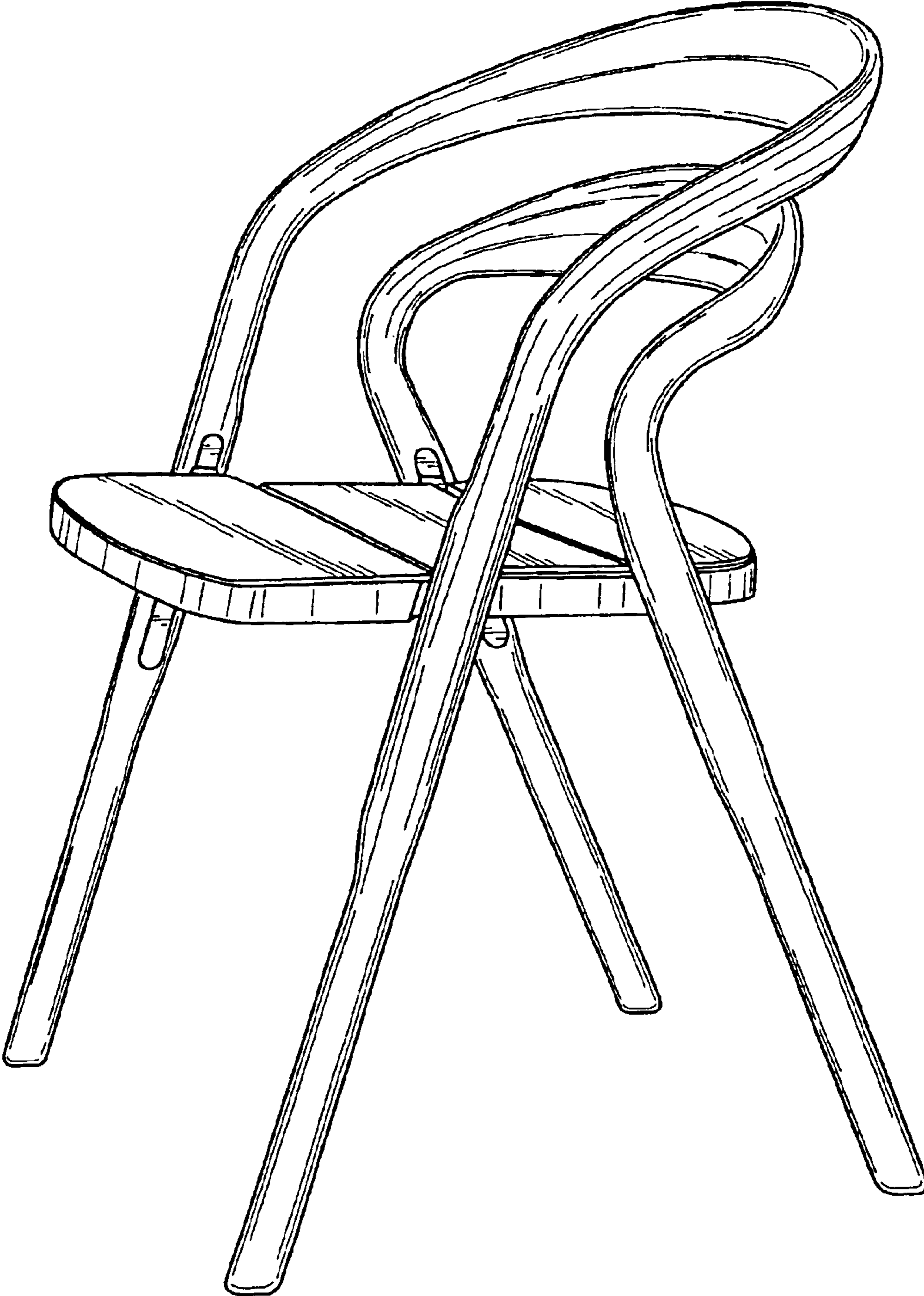
FIG. 6 is a rear elevational view thereof; and,

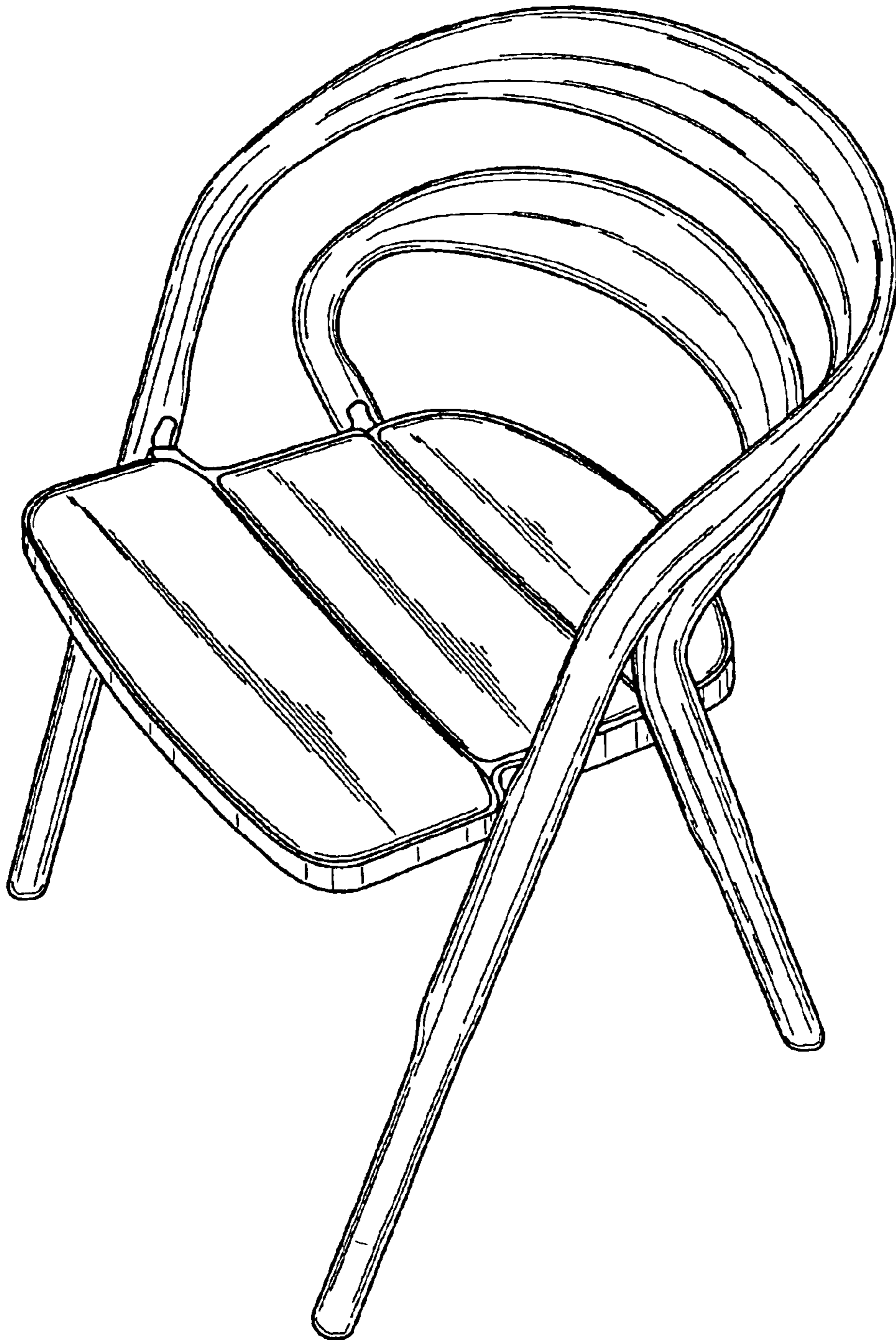




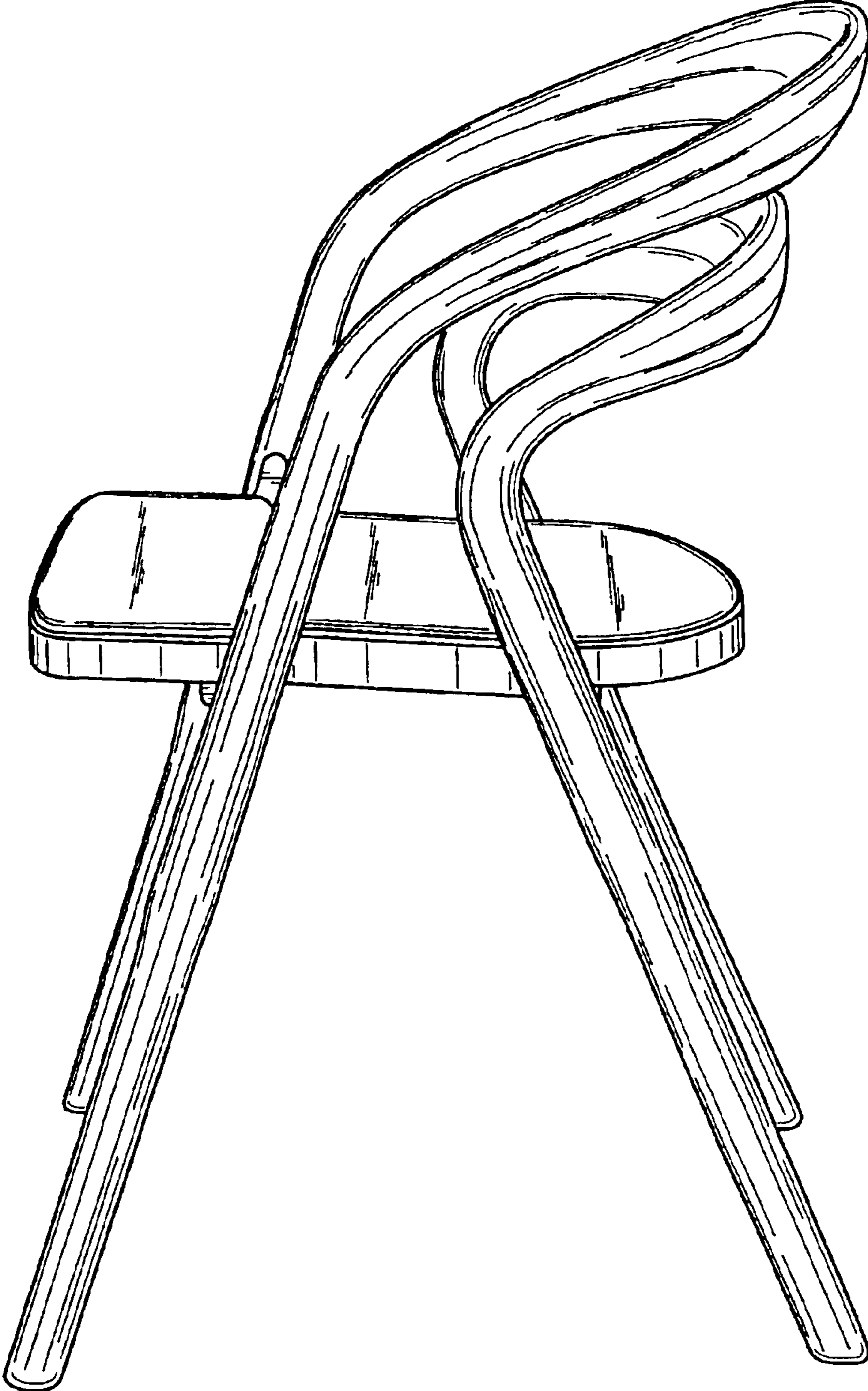

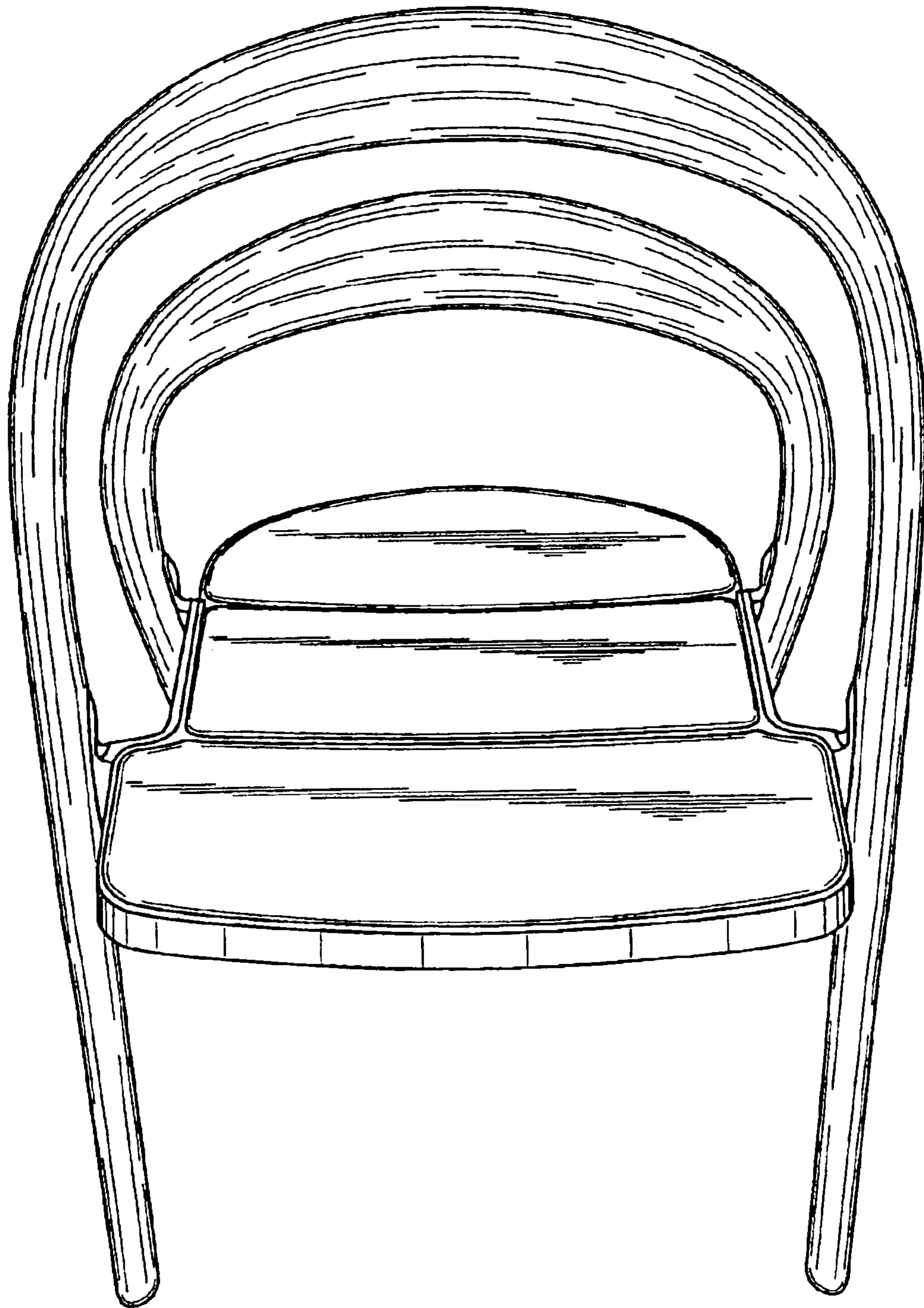

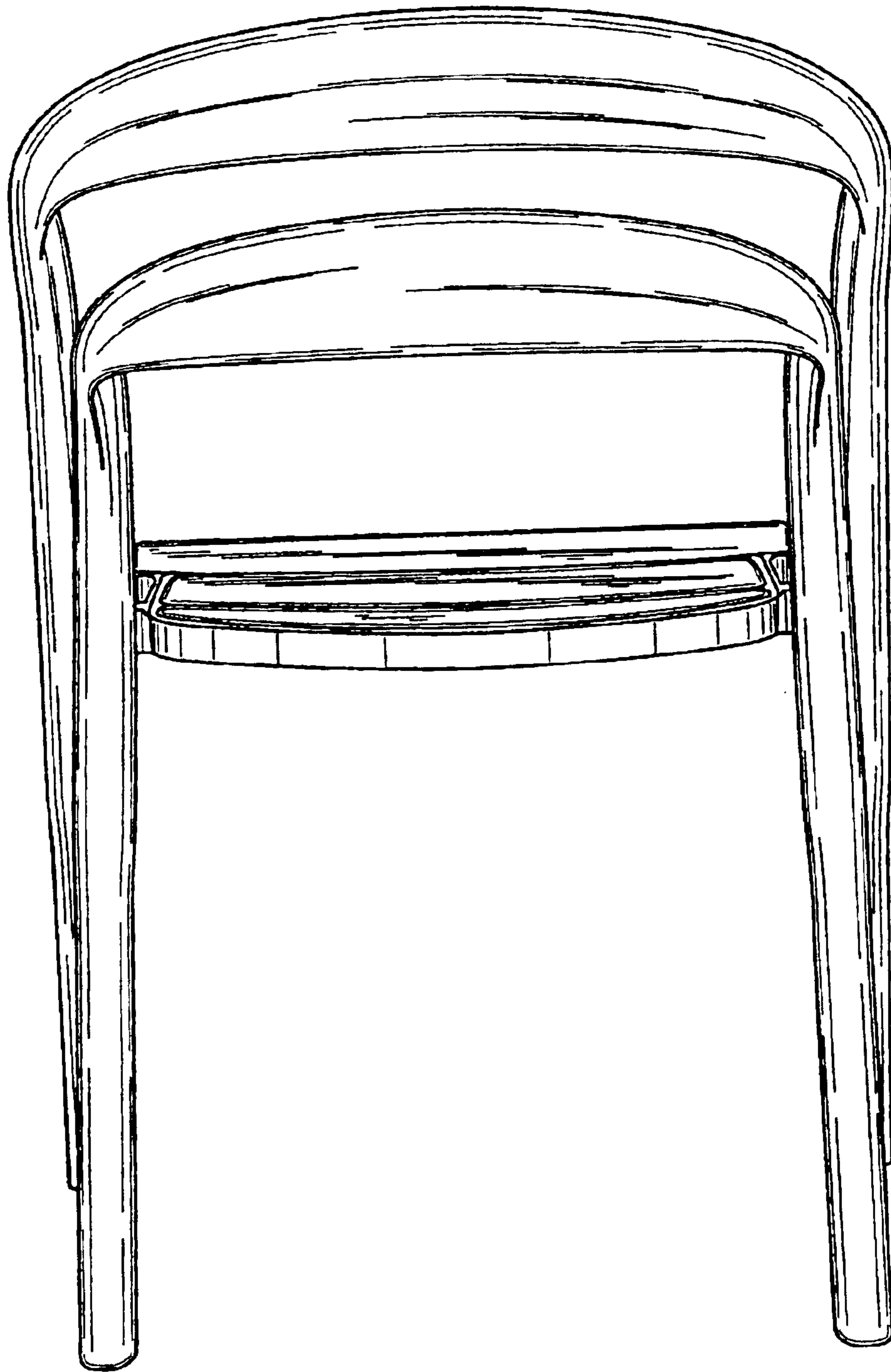

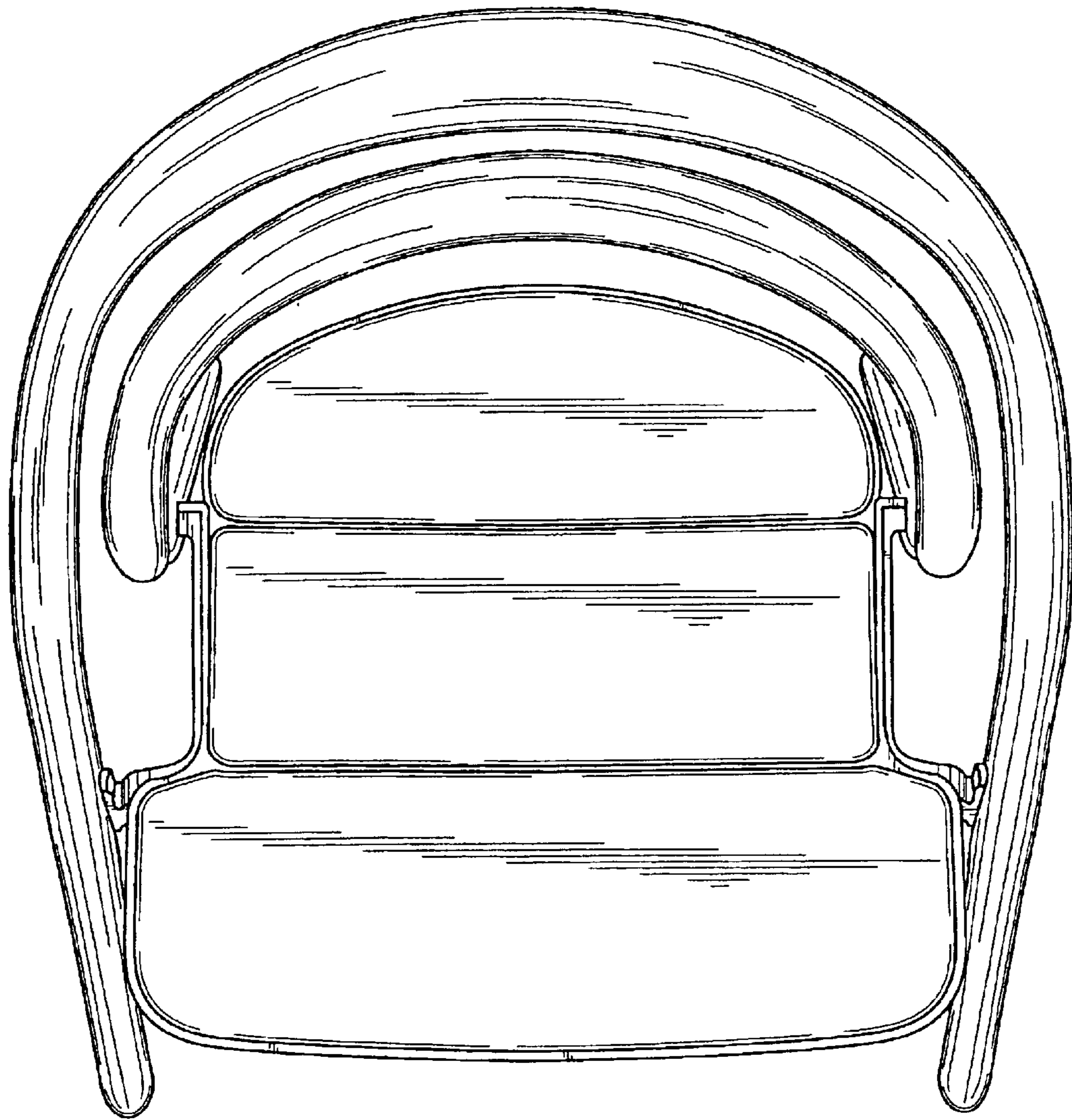
