DESCRIPTION

FIG. 1 is a perspective view of a bottle embodying an embodiment of our new design.

FIG. 2 is a front elevational view of the bottle shown in FIG. 1.

FIG. 3 is a right side elevational view of the bottle shown in FIG. 1.

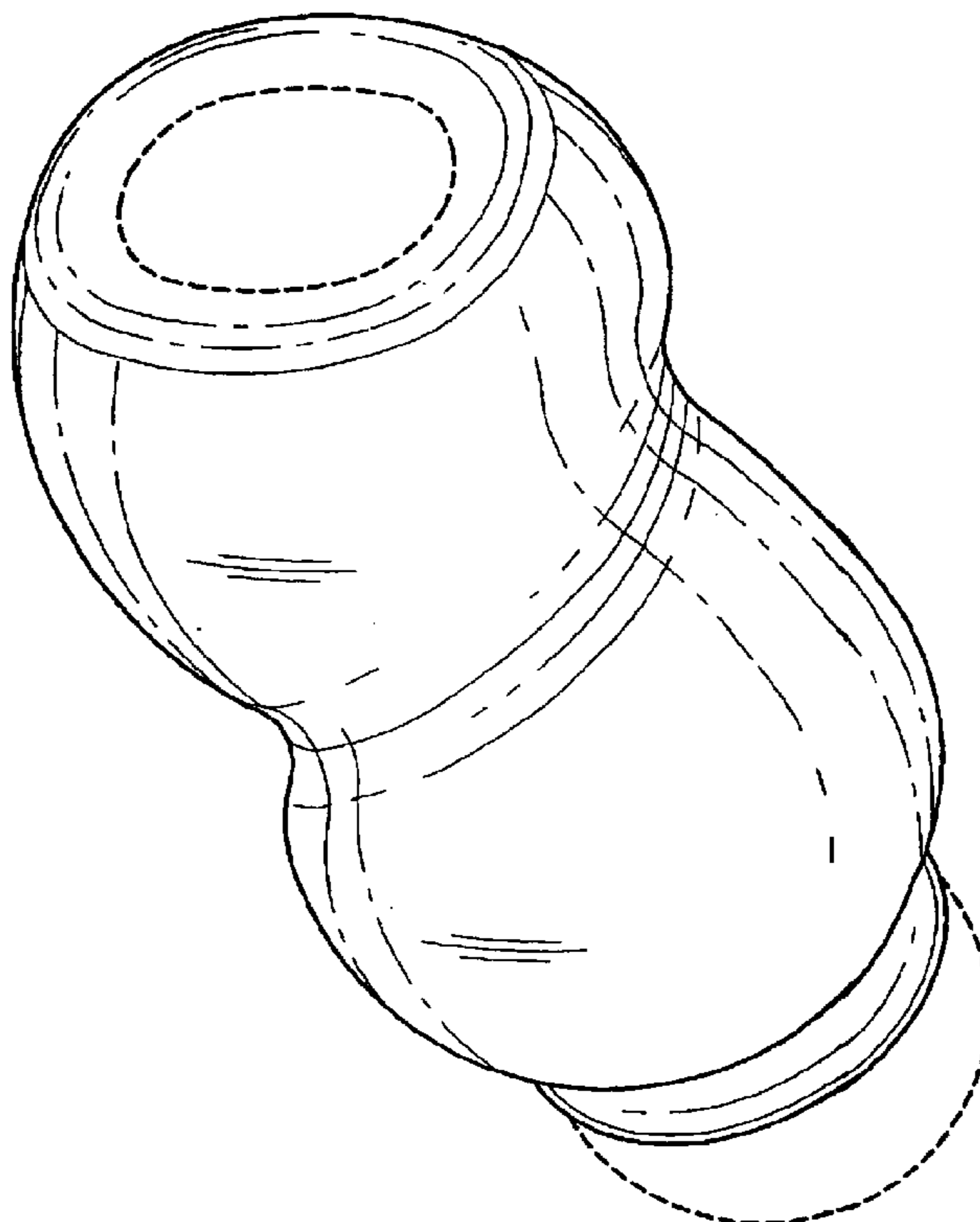
FIG. 4 is a back view elevational of the bottle shown in FIG. 1.

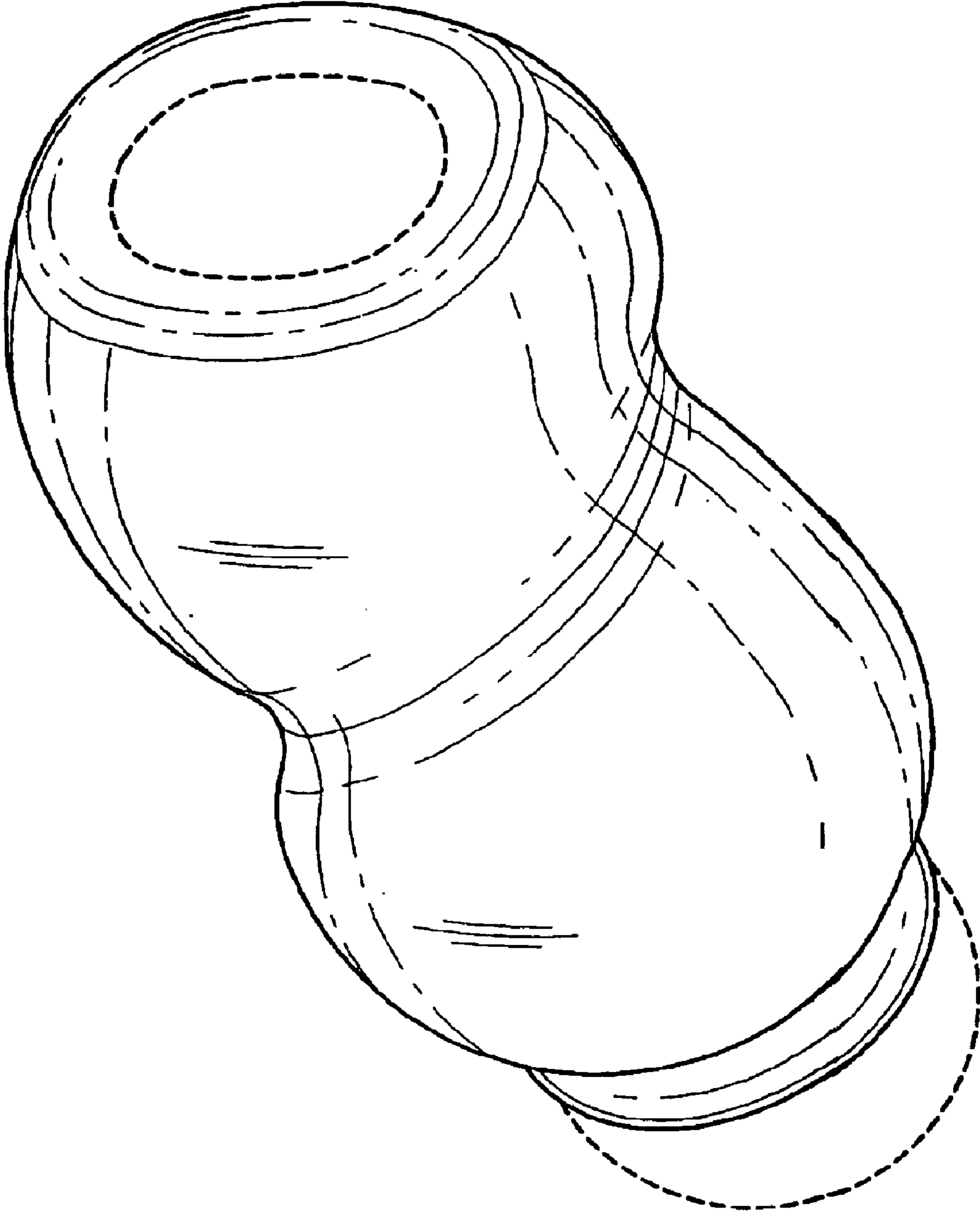

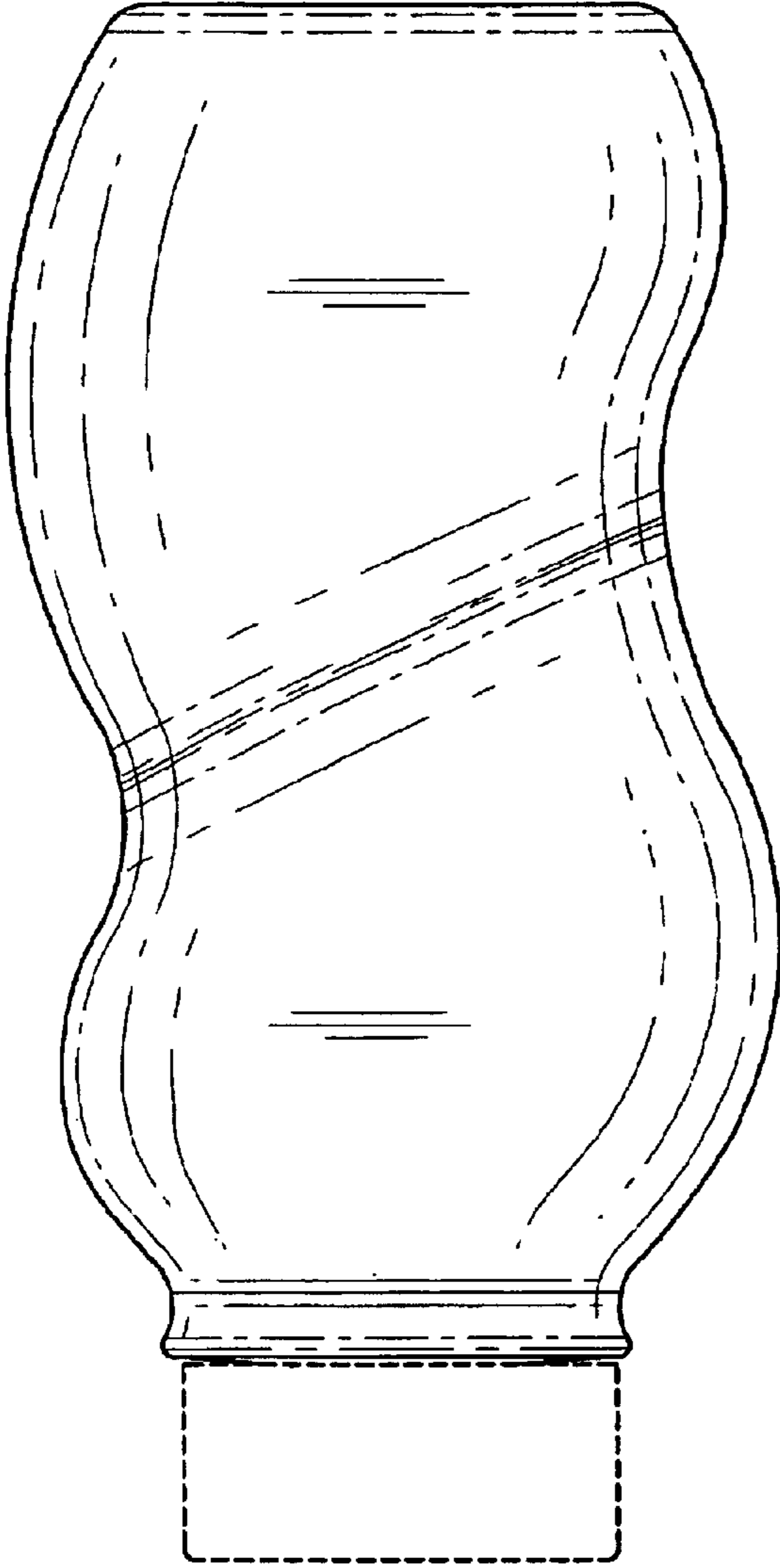

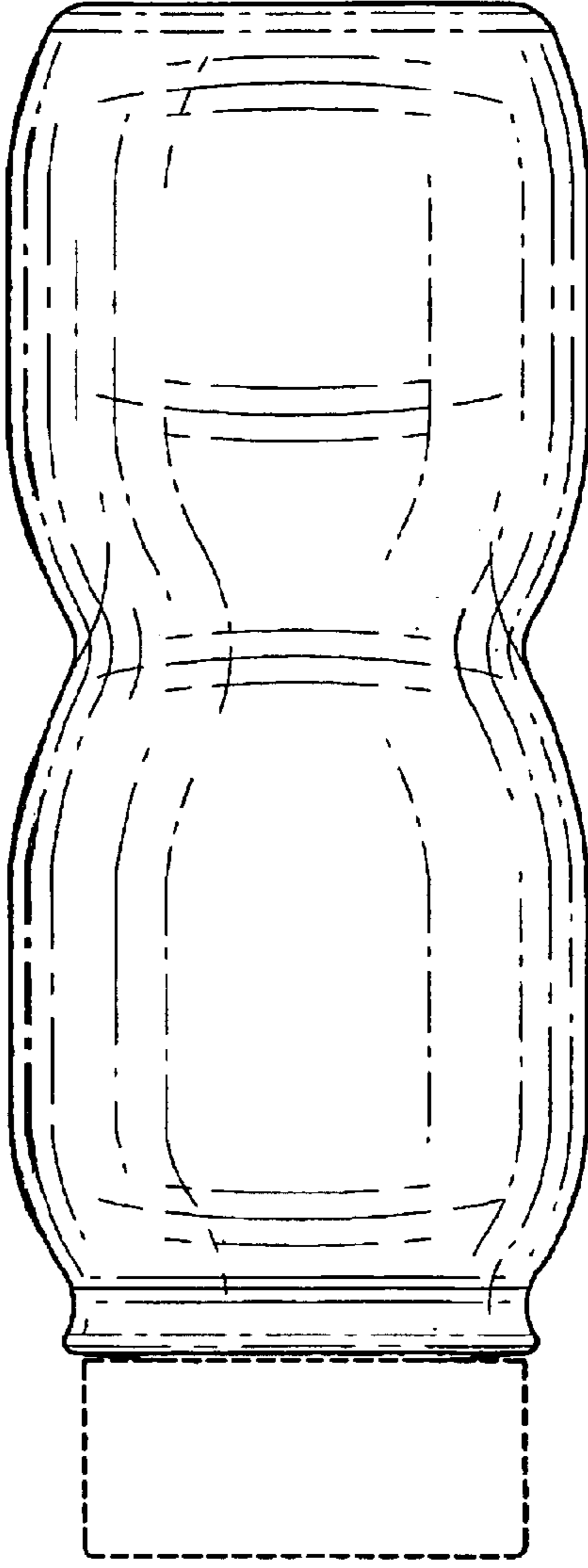

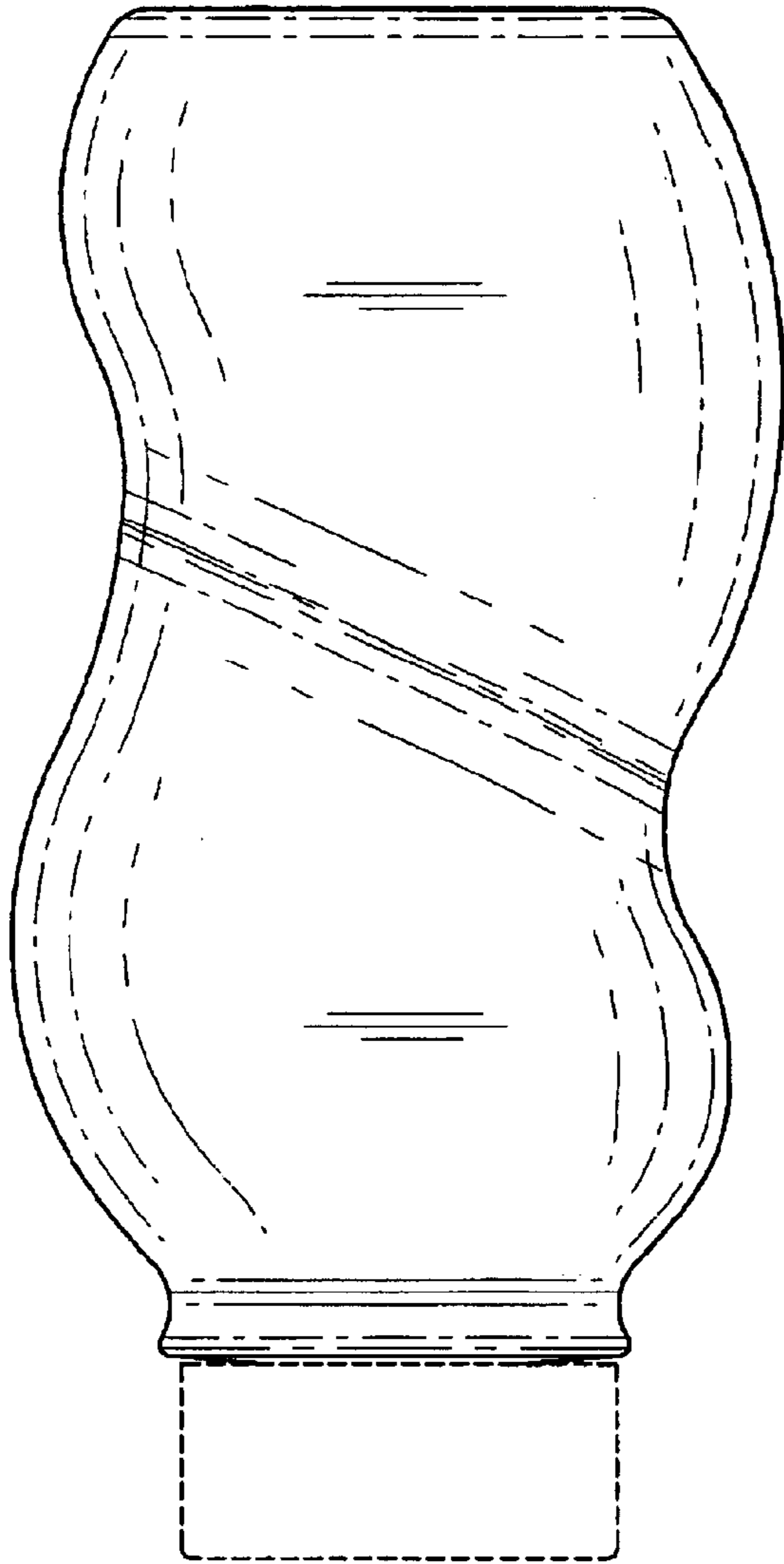

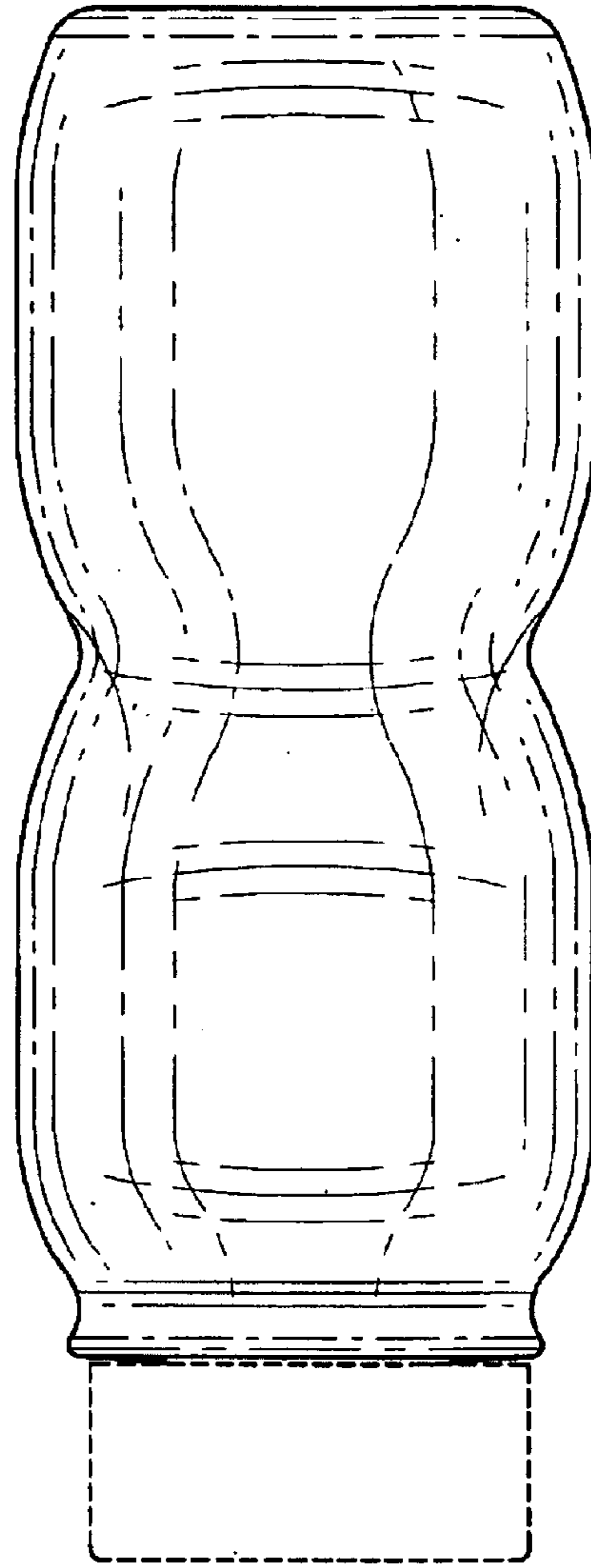

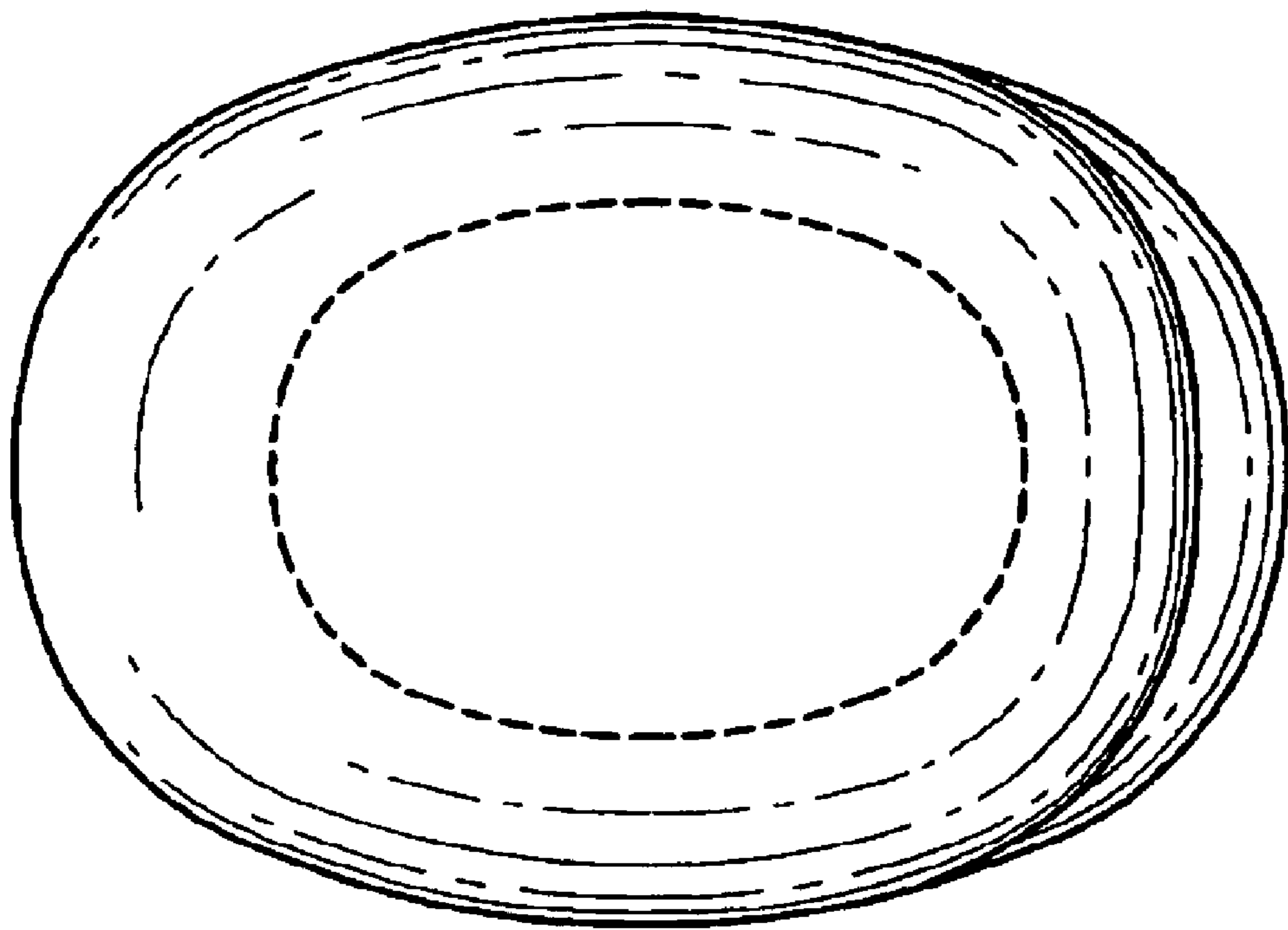
