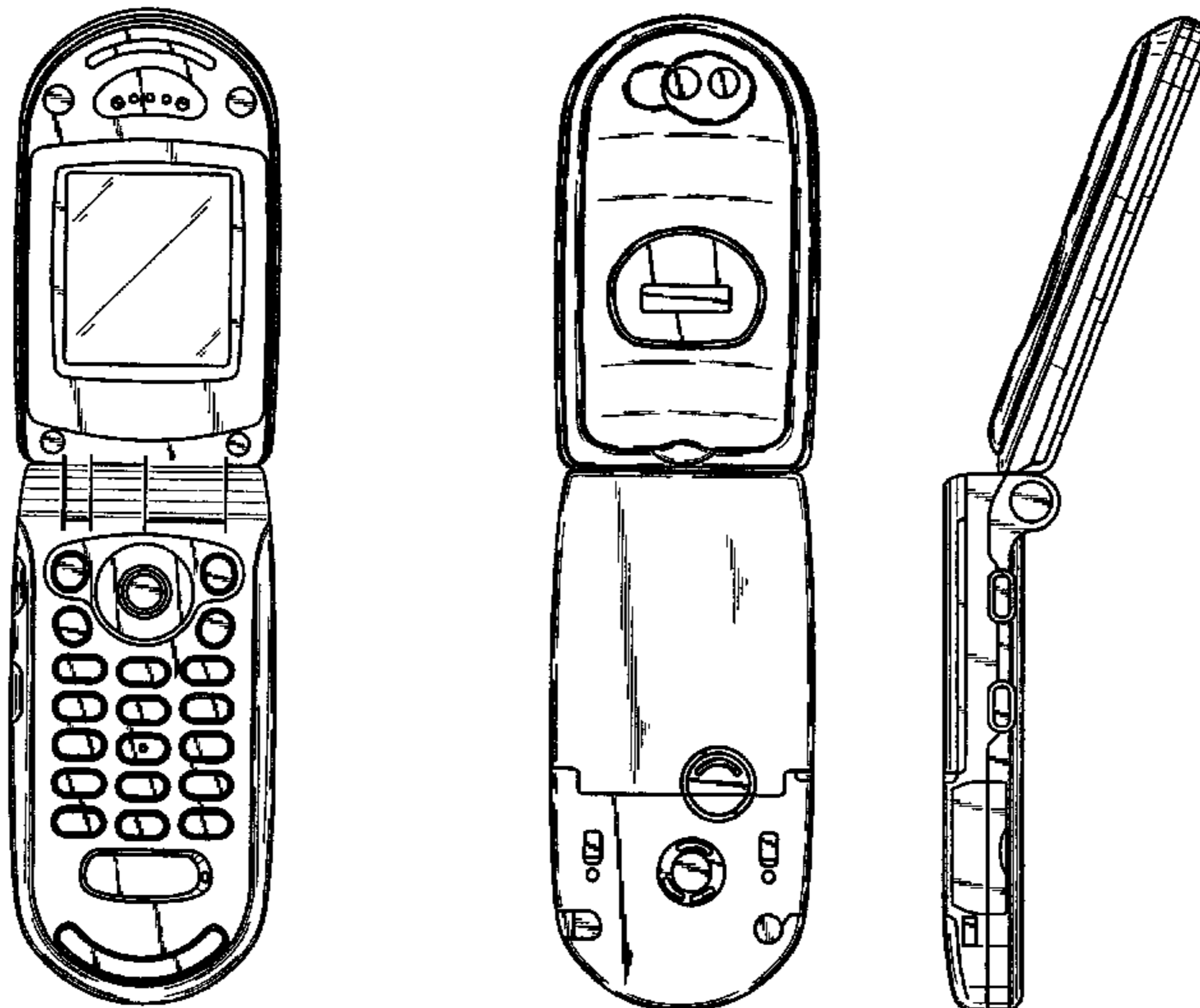

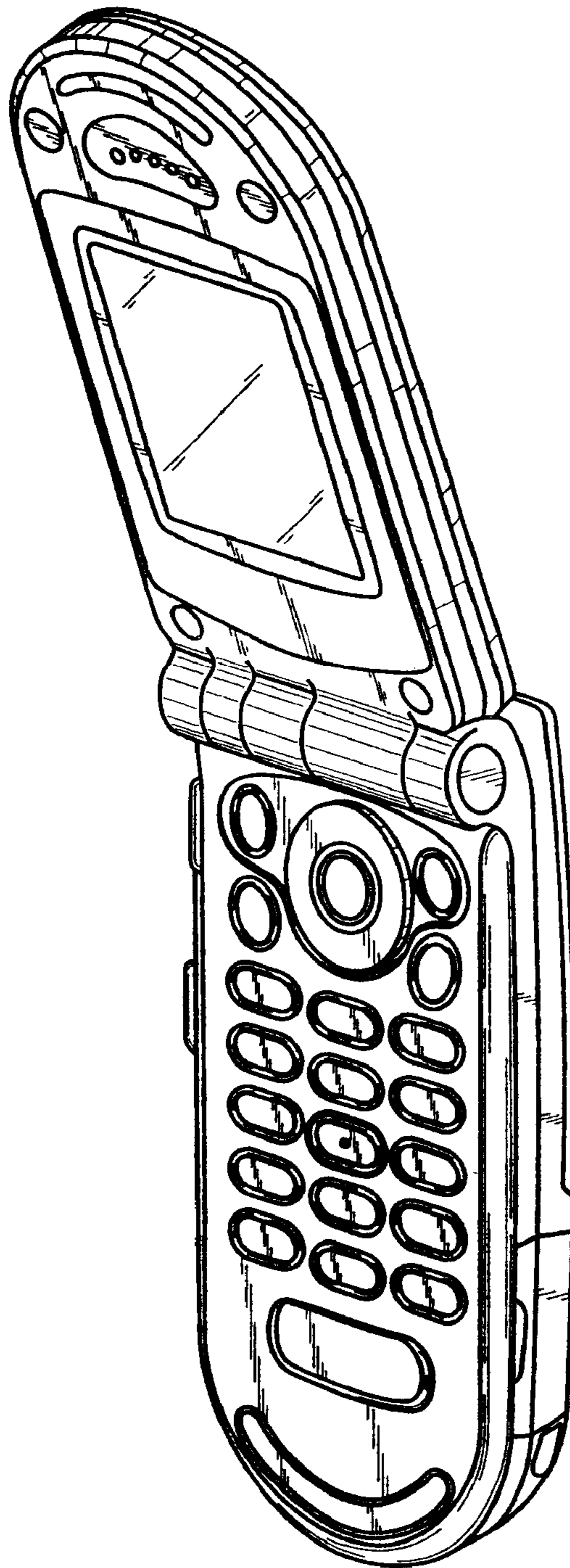
The ornamental design for a portable wireless telephone, as shown.

**DESCRIPTION**

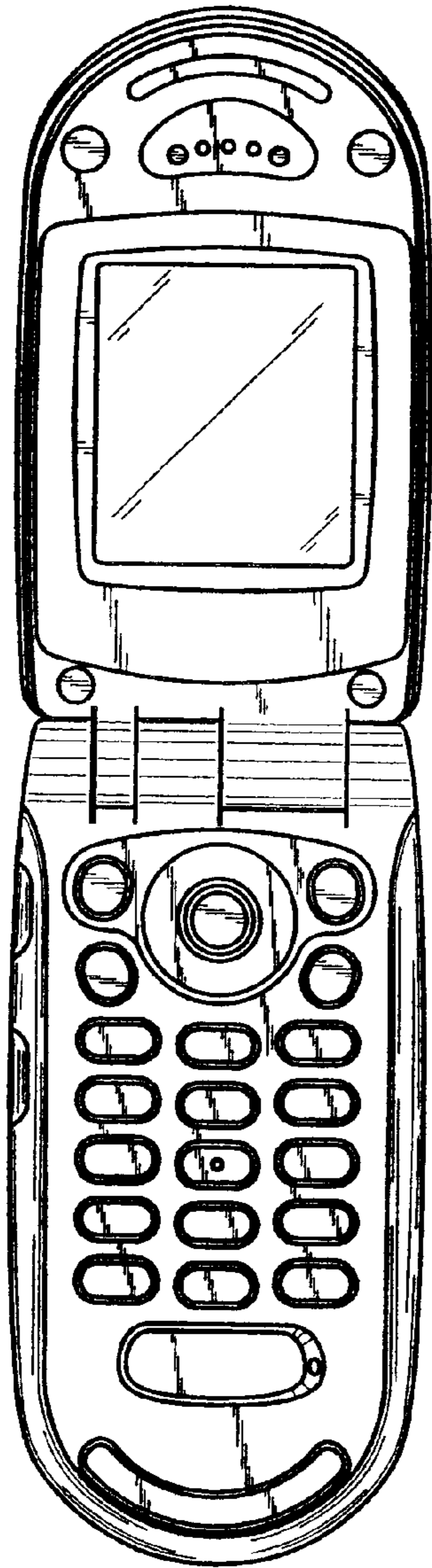

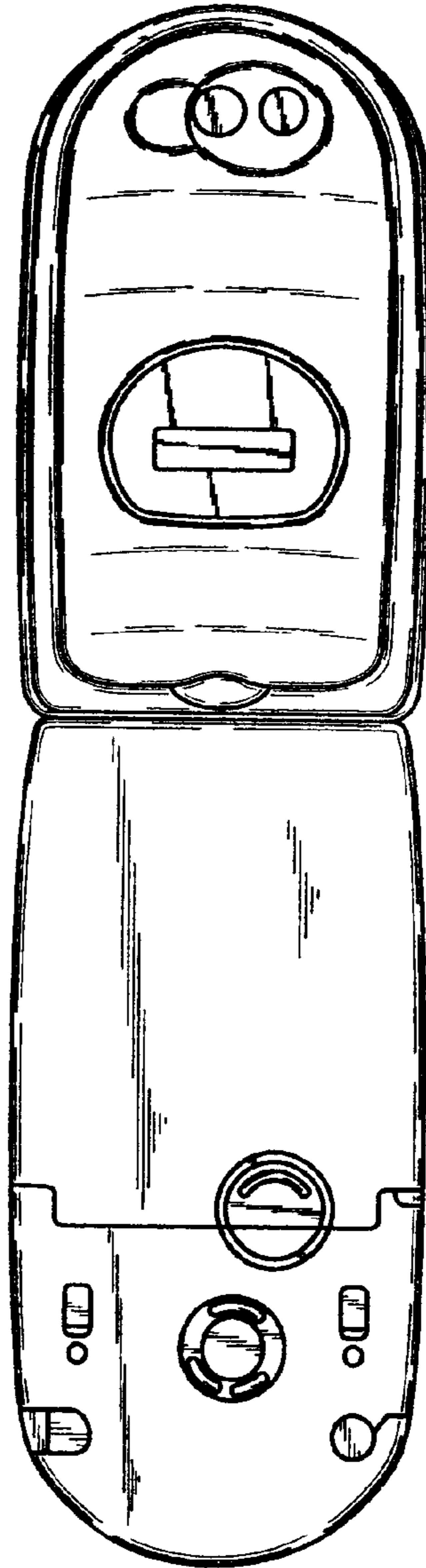




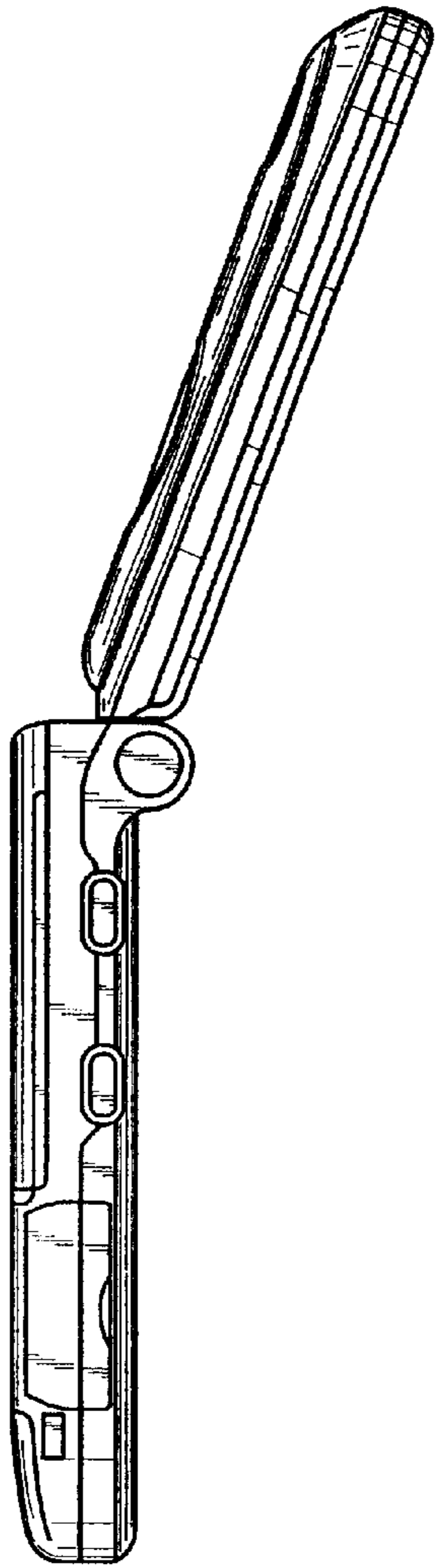

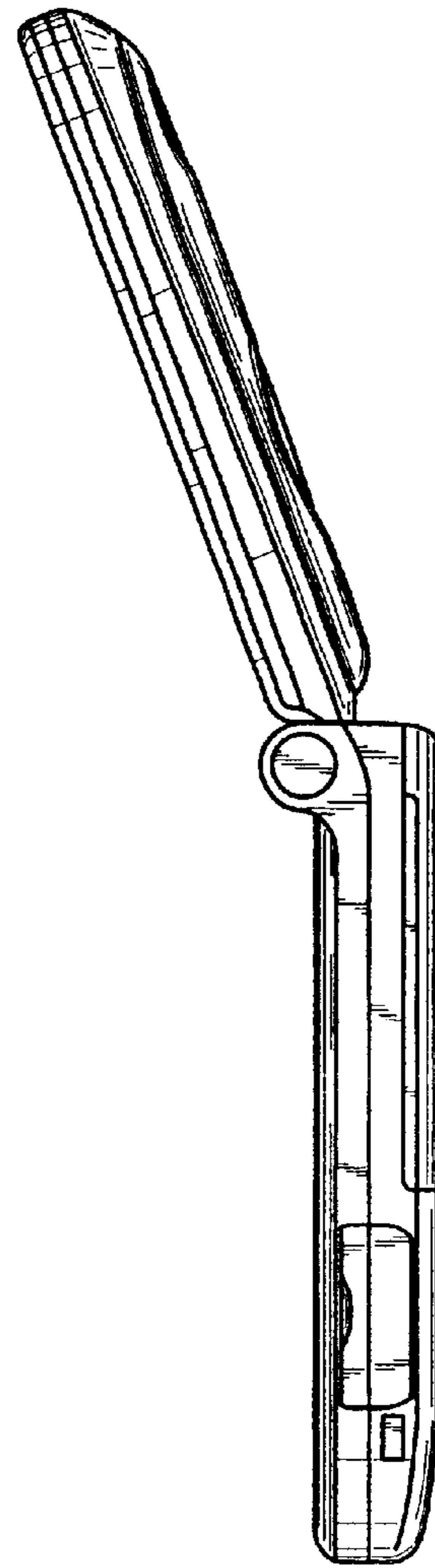

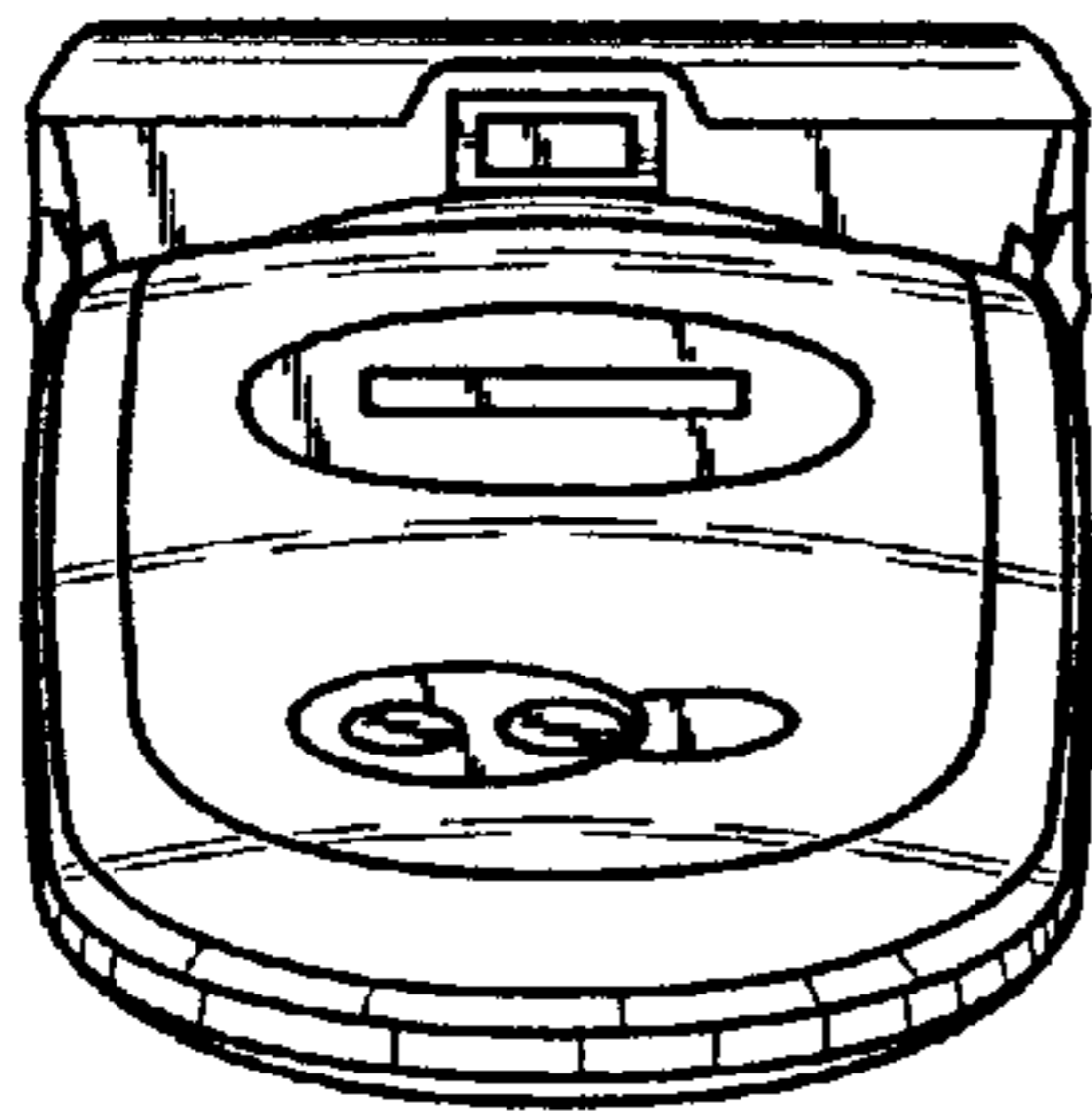

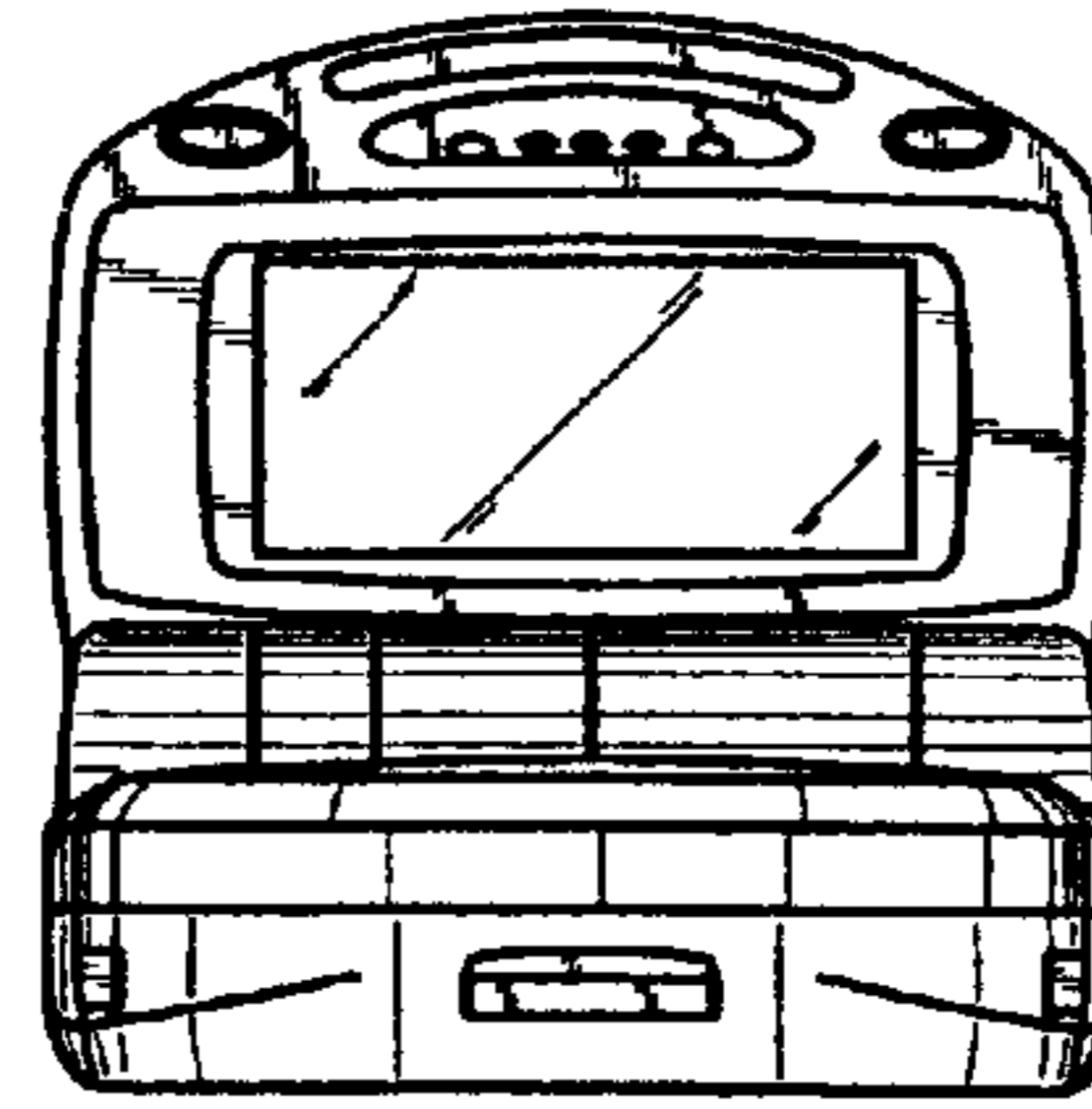
