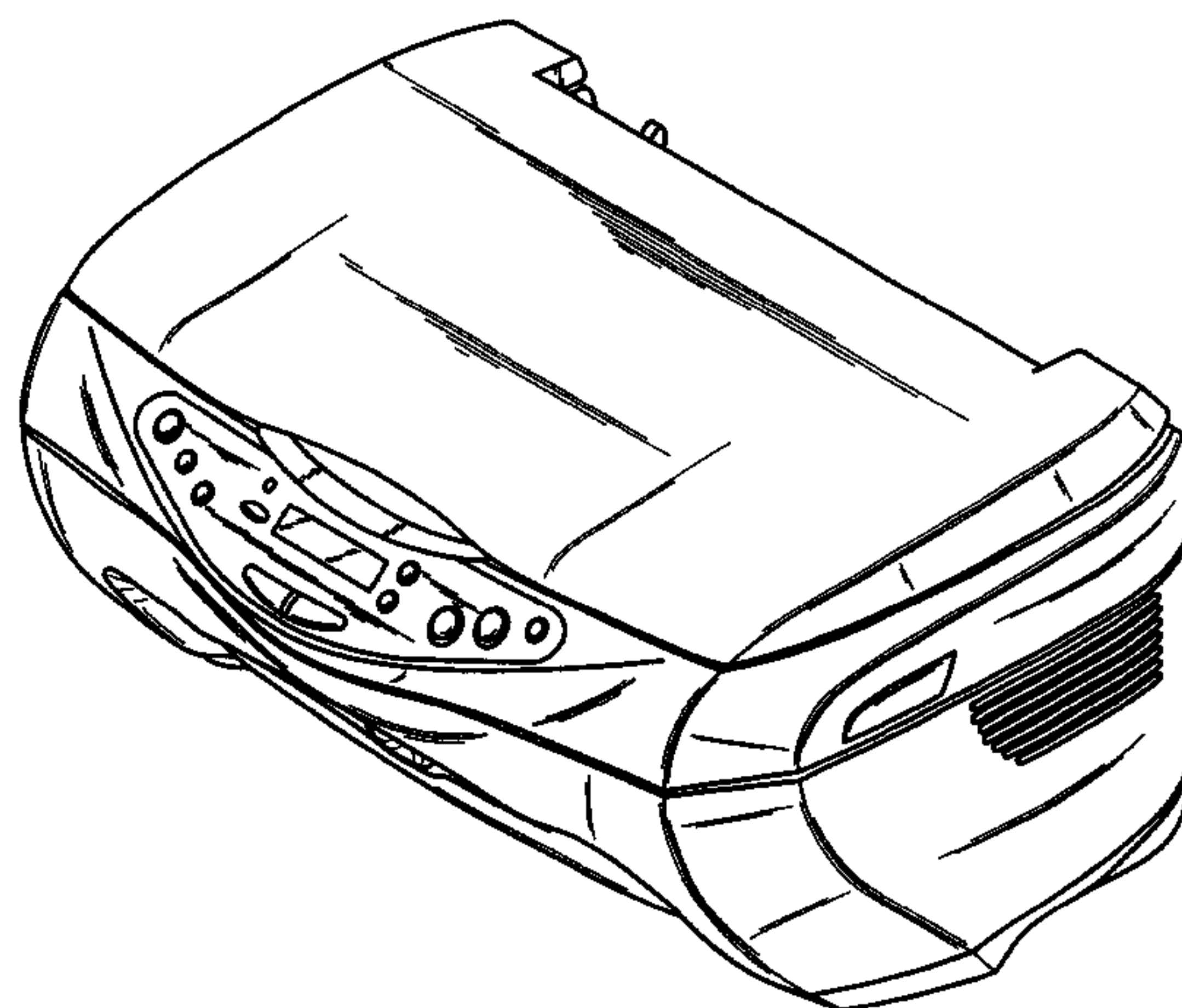
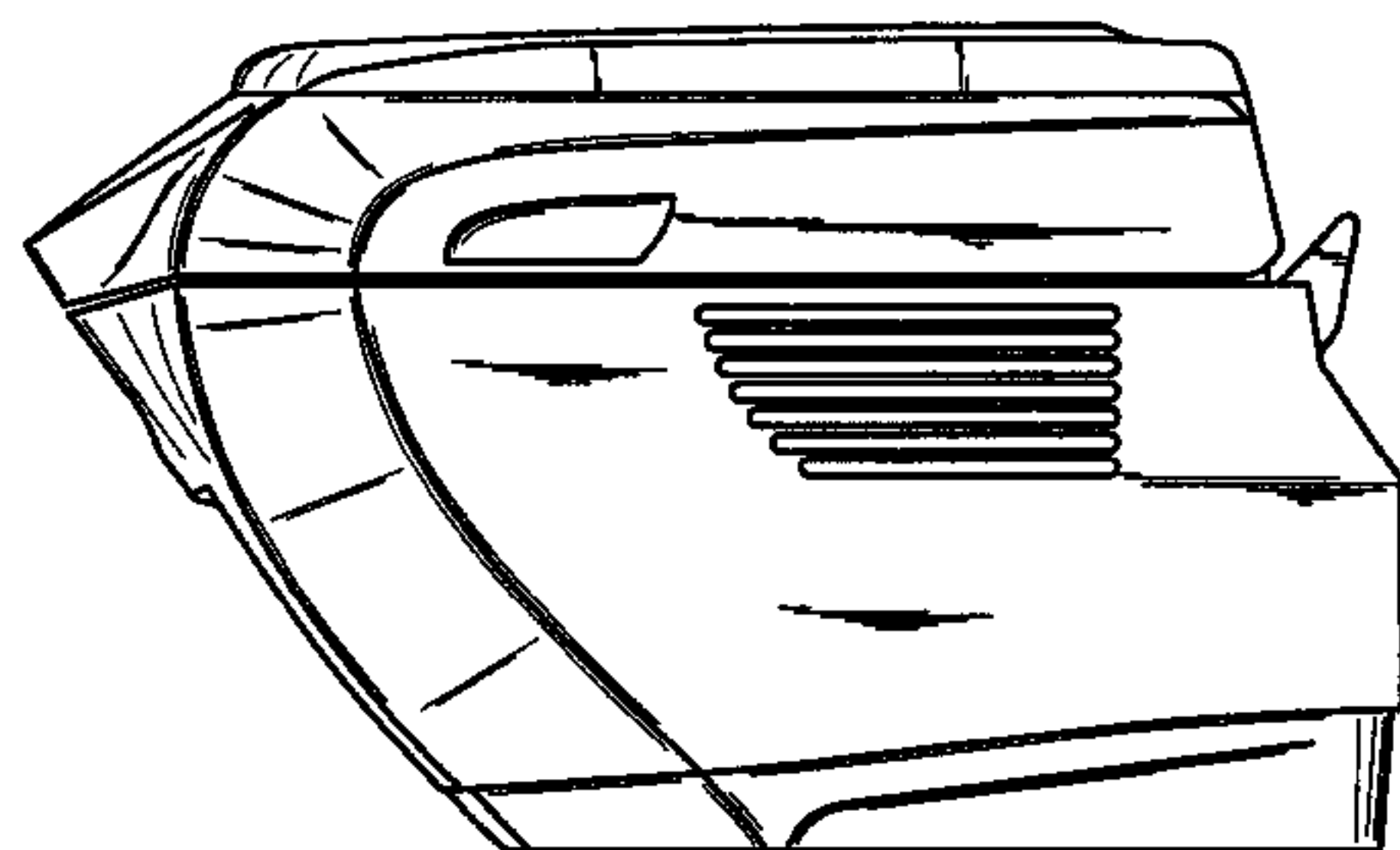
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front elevational view of a printer with scanner showing our new design;

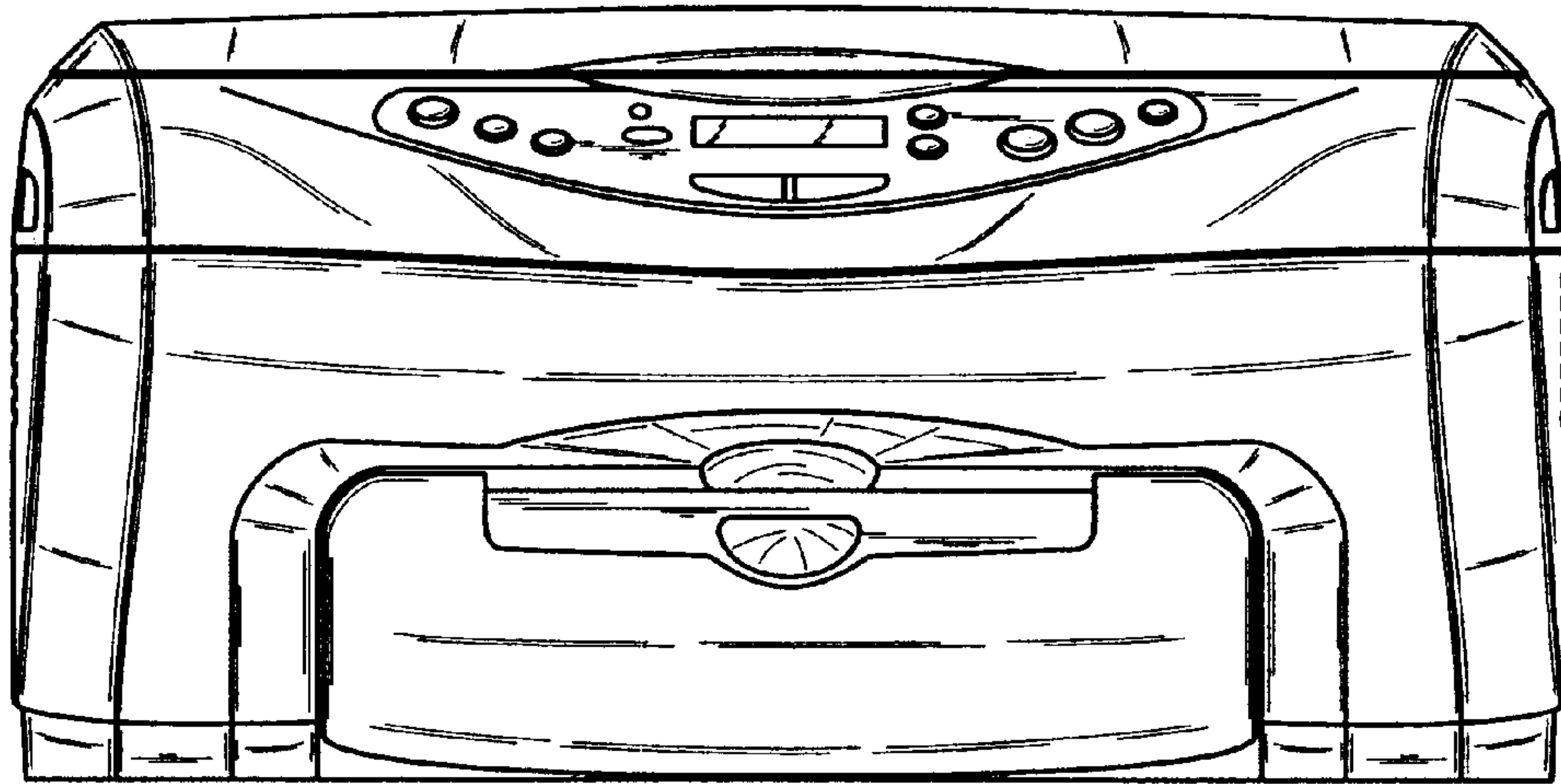

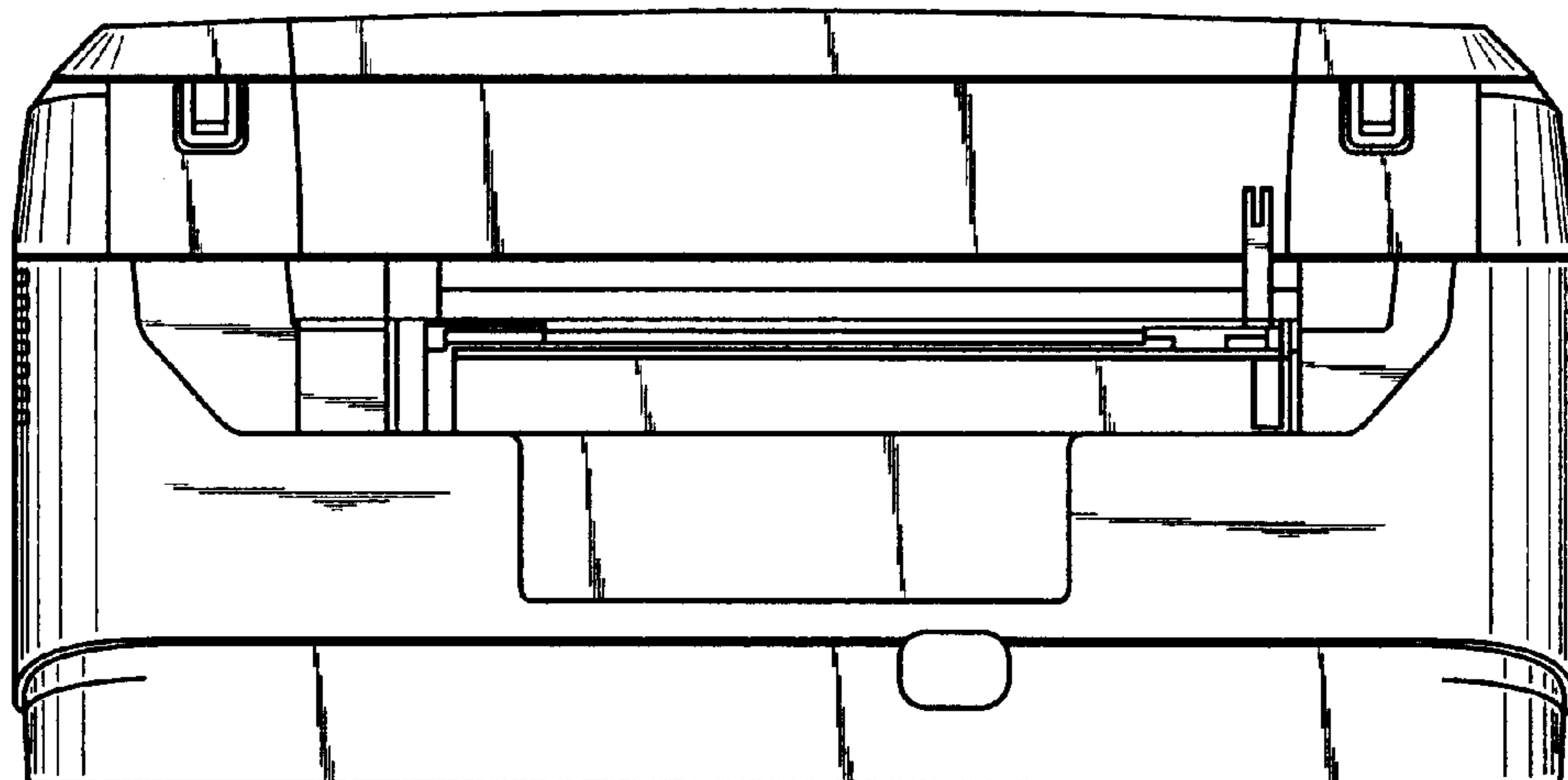

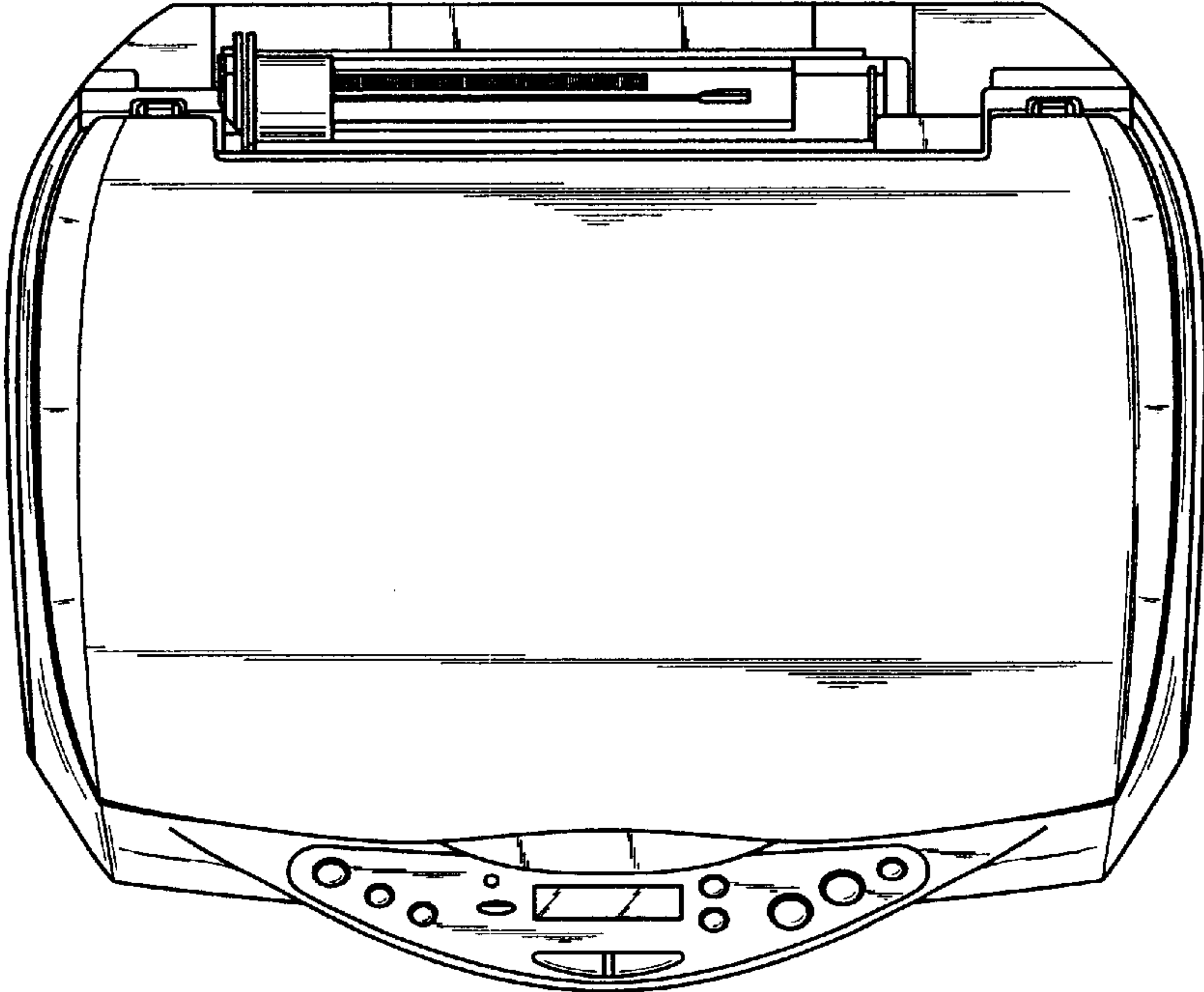

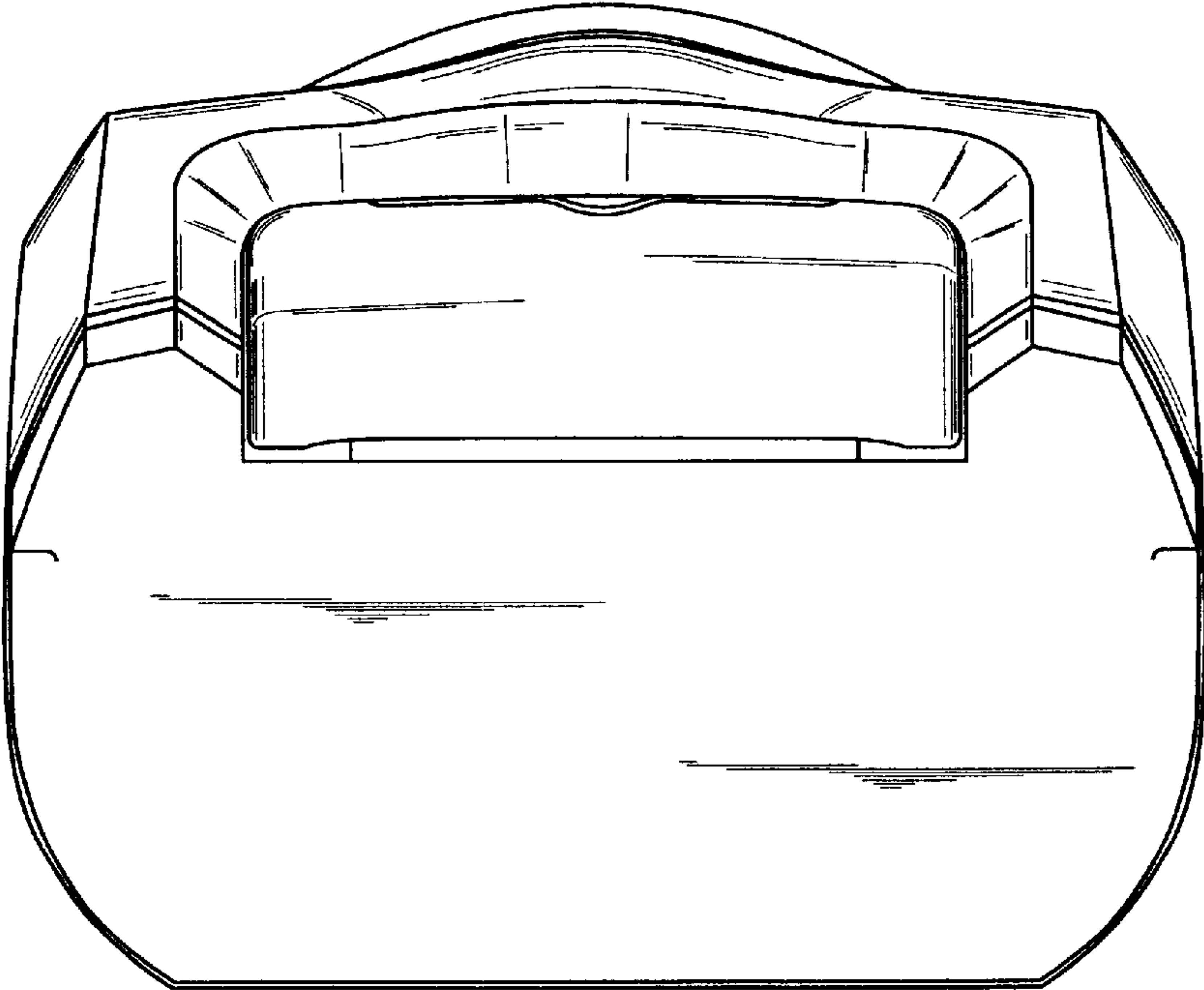

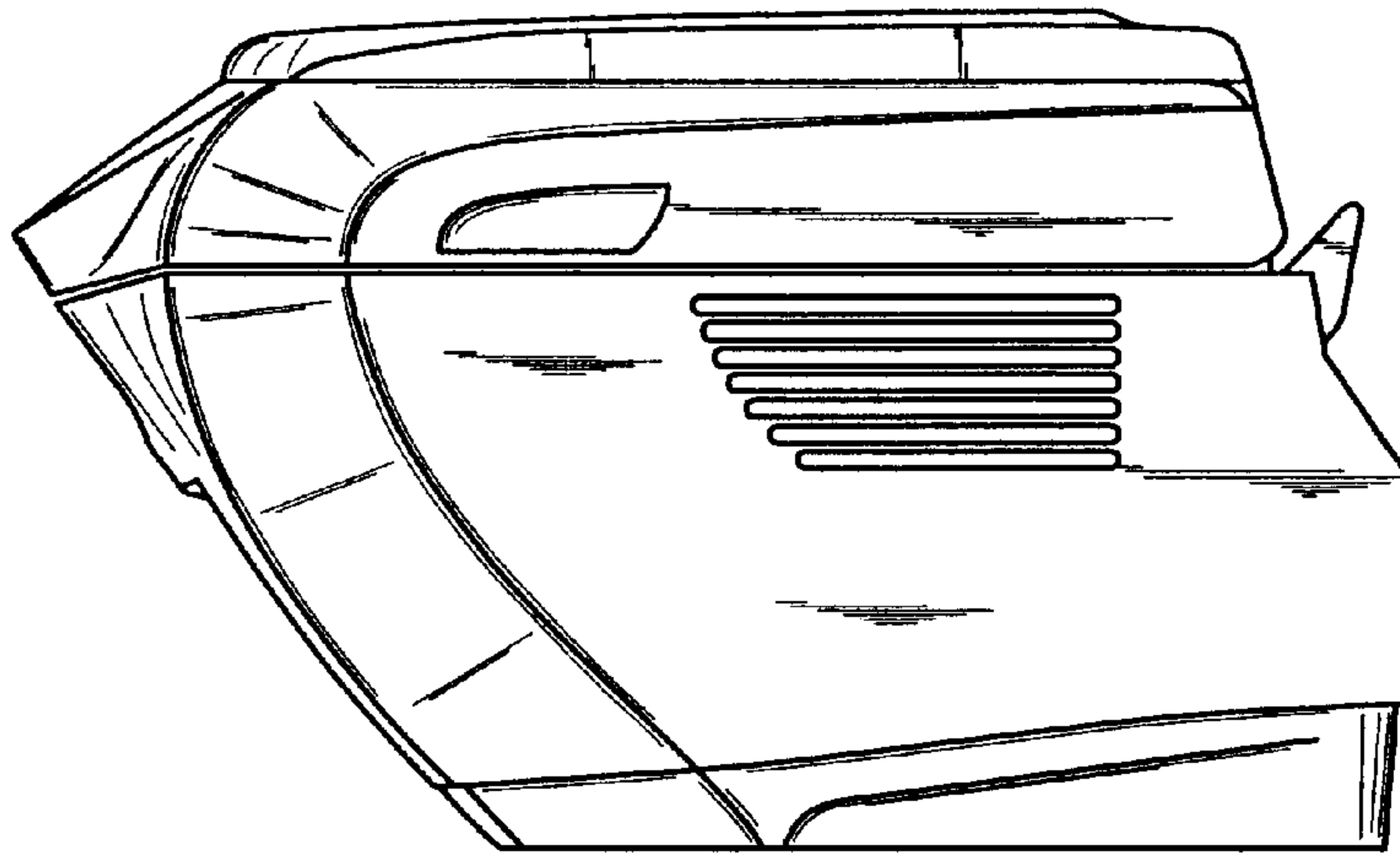

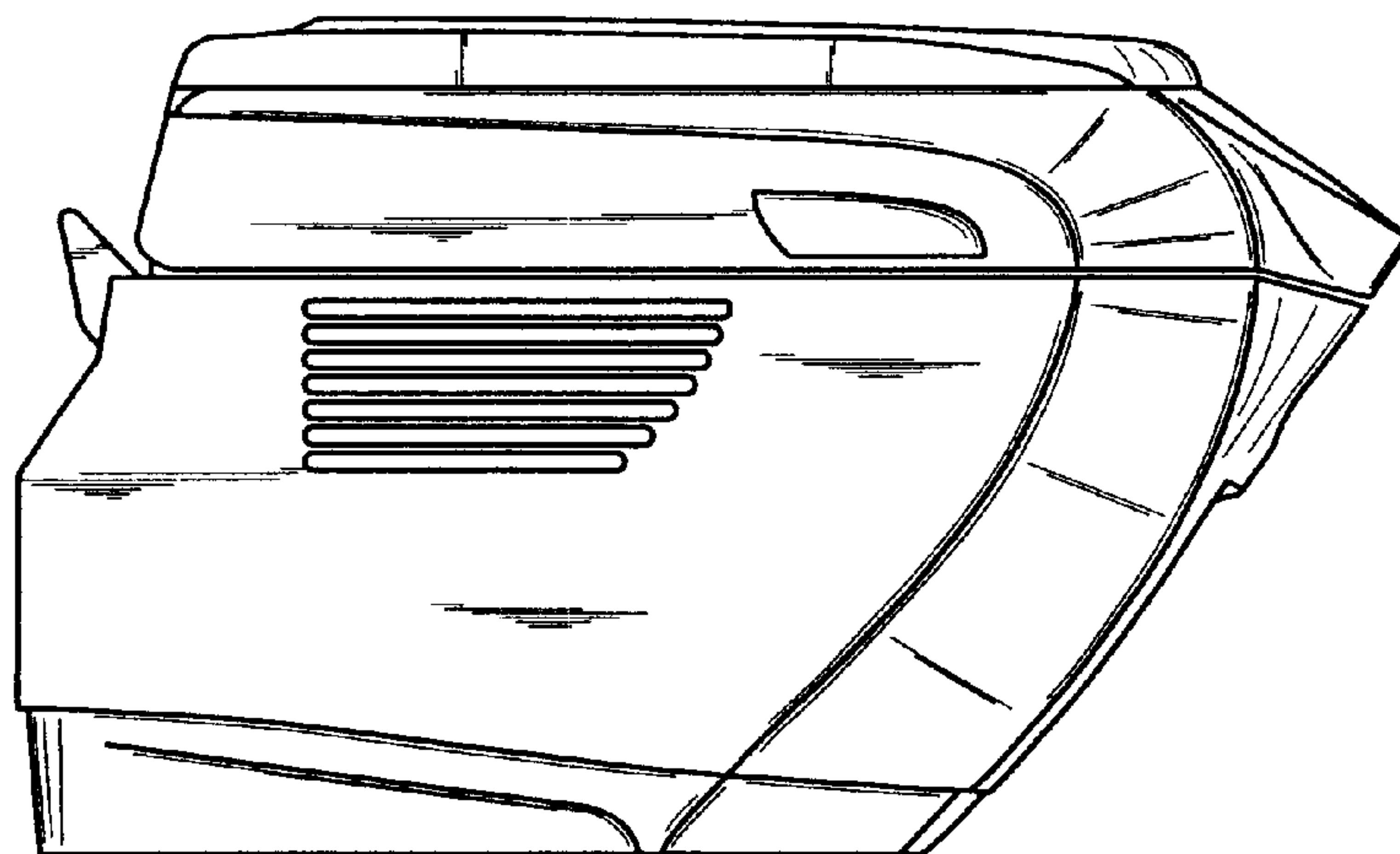

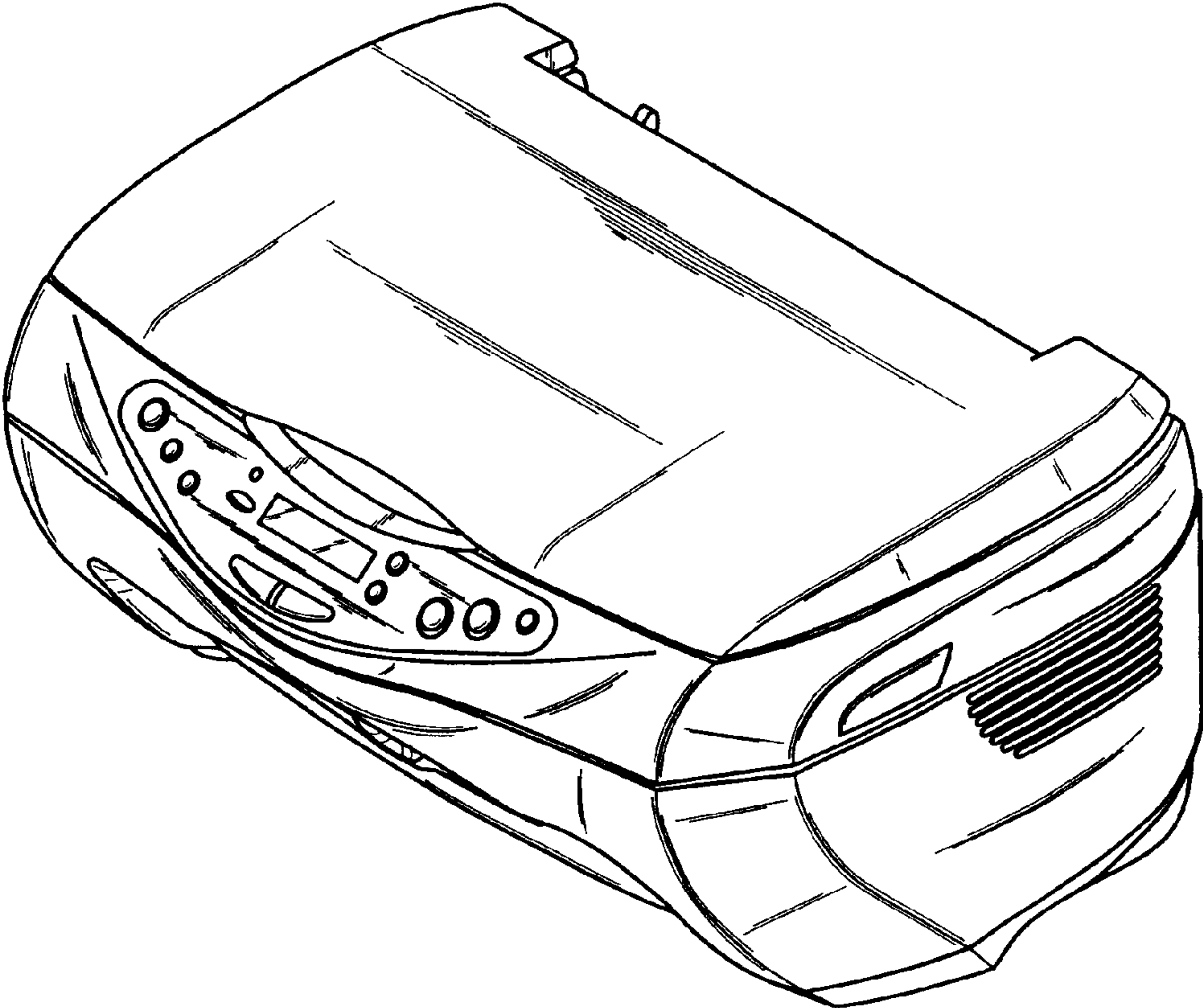
