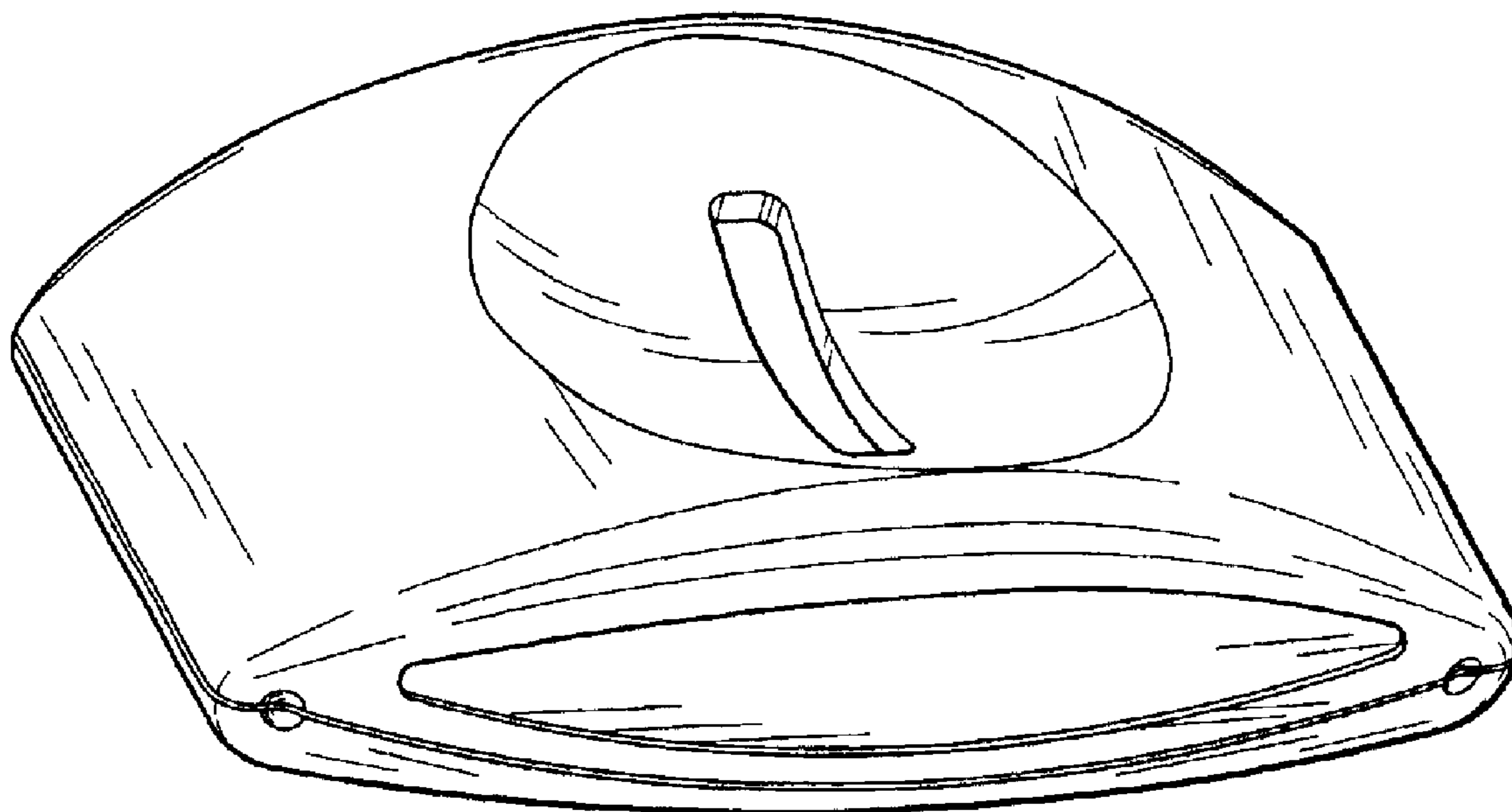
(57) **CLAIM**

The ornamental design for a flag dispenser, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the flag dispenser showing top, front, and right sides of our new design;
FIG. 2 is a top view of the flag dispenser of FIG. 1;
FIG. 3 is a right side view of the flag dispenser of FIG. 1, the left side view being a mirror image of the right side view;
FIG. 4 is a front view of the flag dispenser of FIG. 1, the rear view being a mirror image of the front view; and,
FIG. 5 is a bottom view of the flag dispenser of FIG. 1.

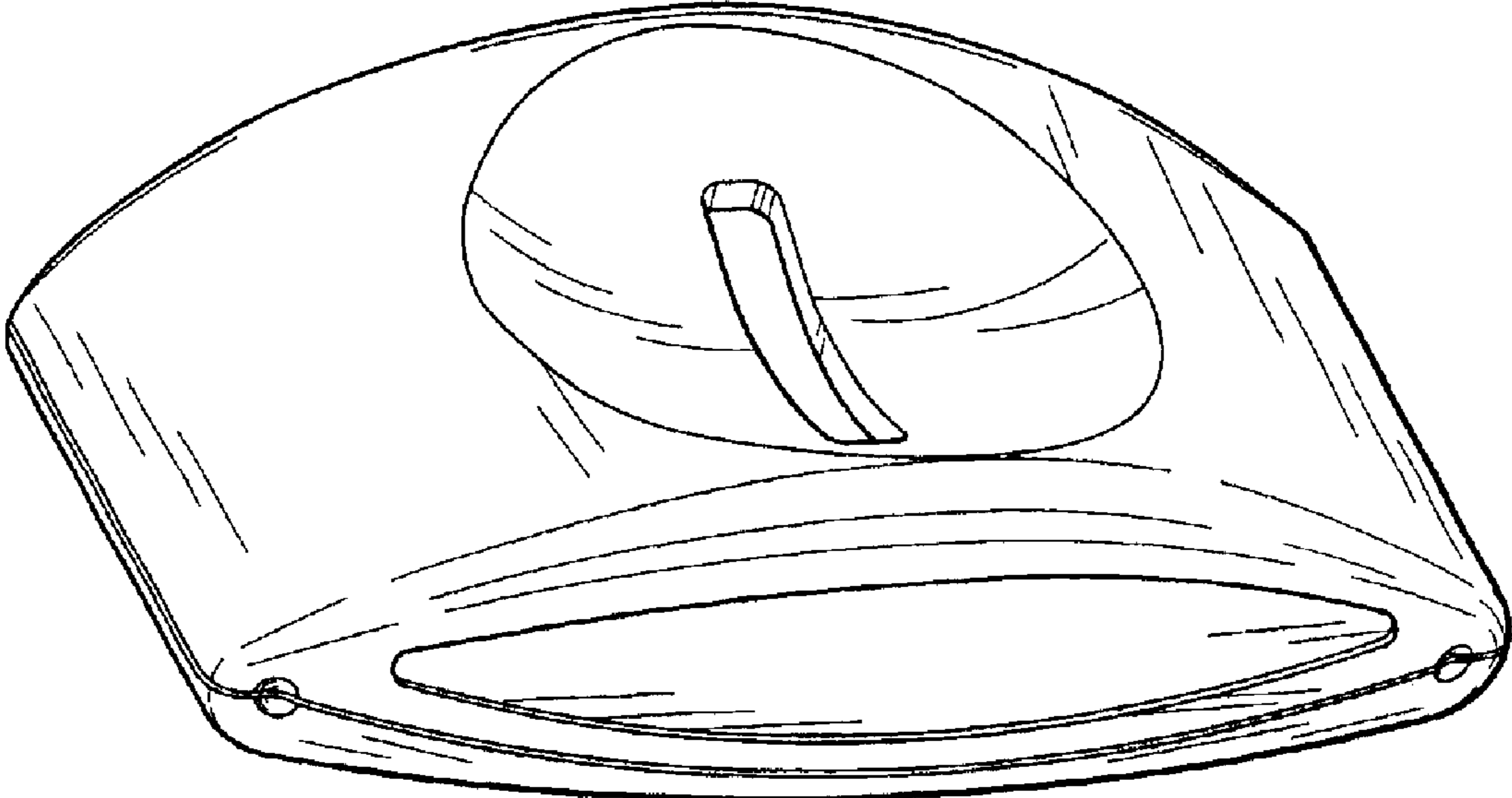

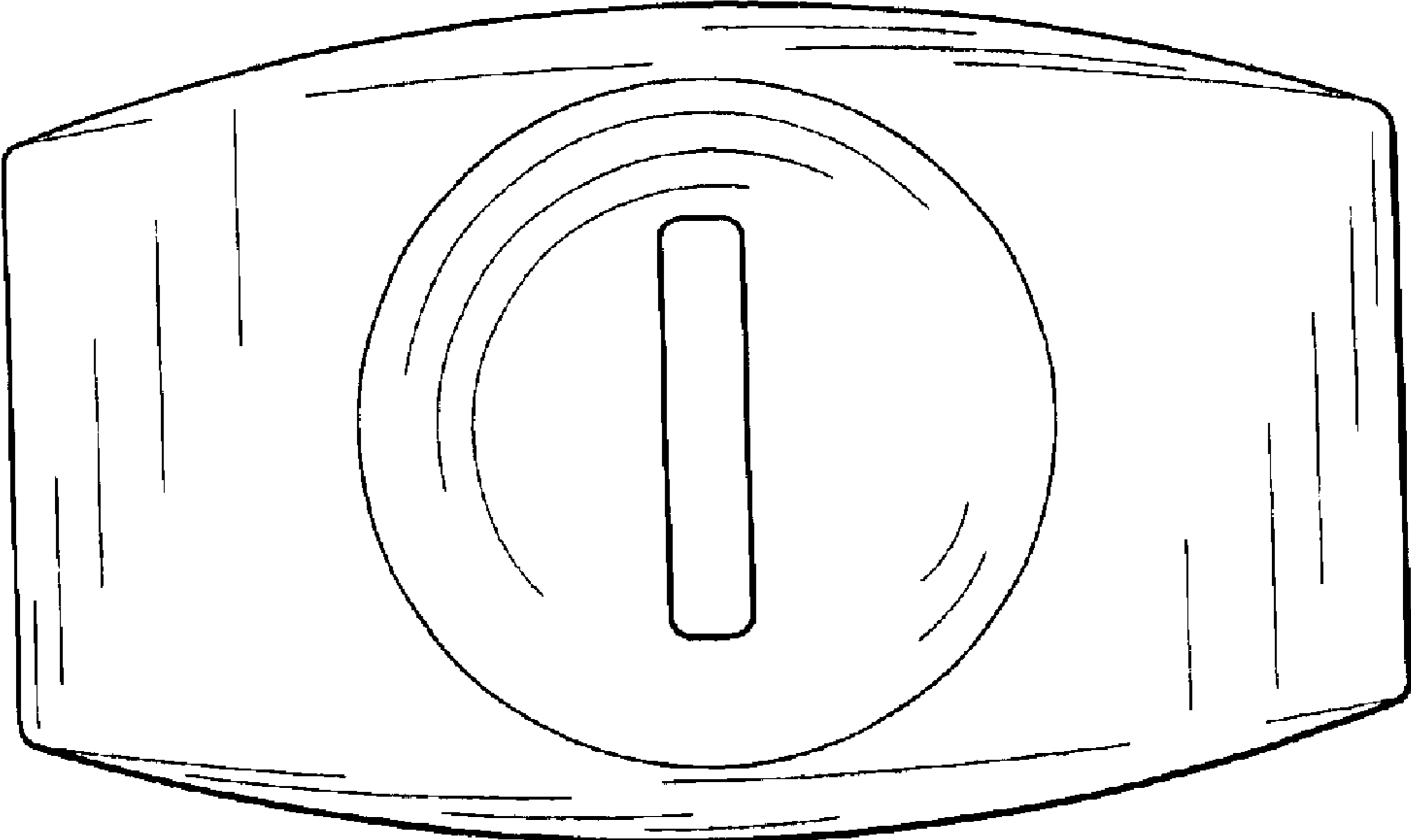

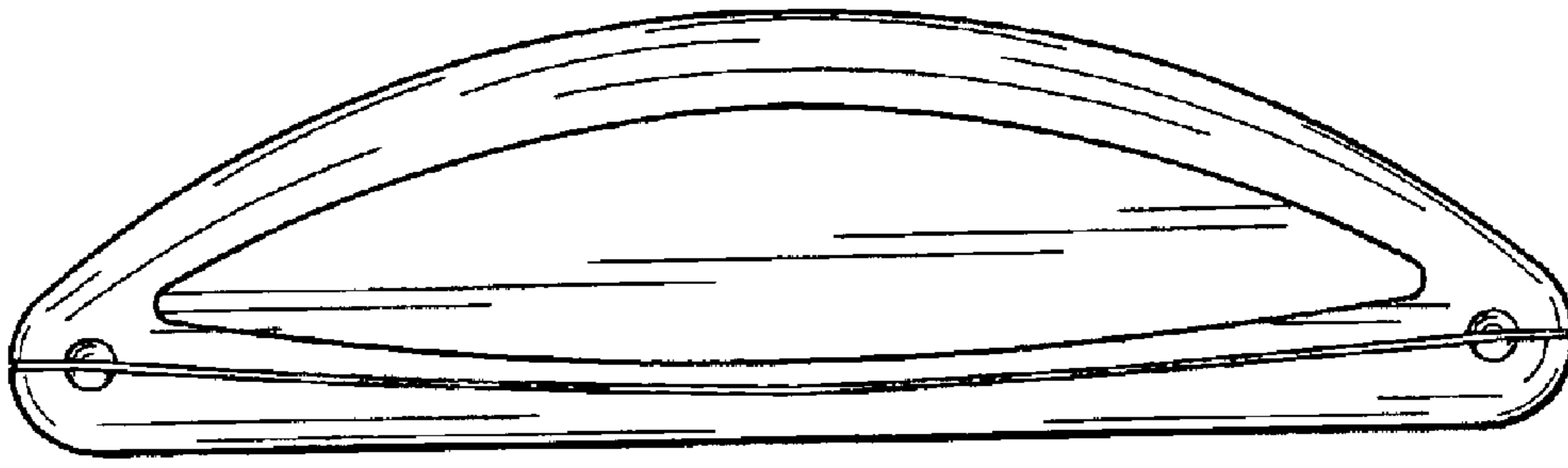

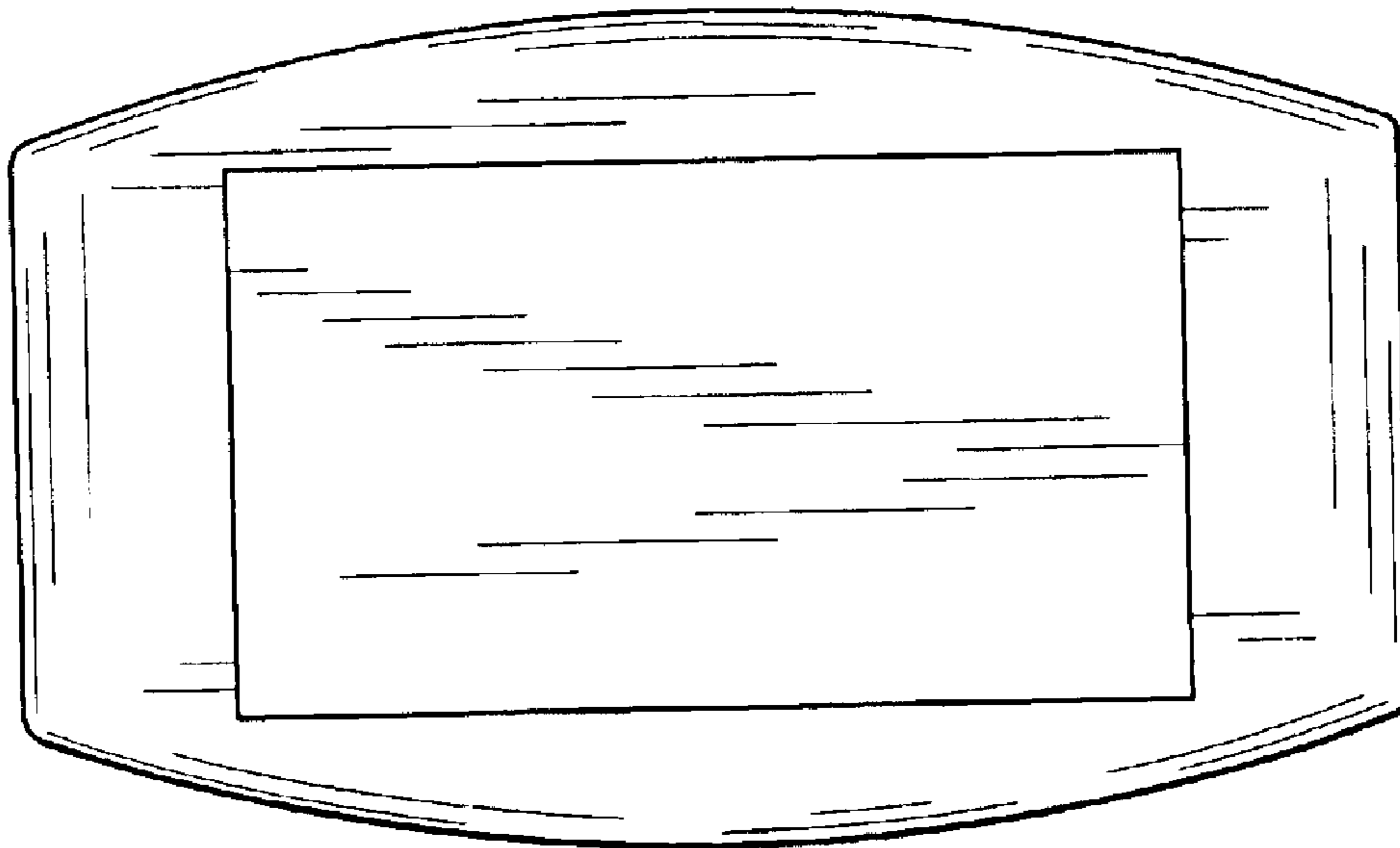
