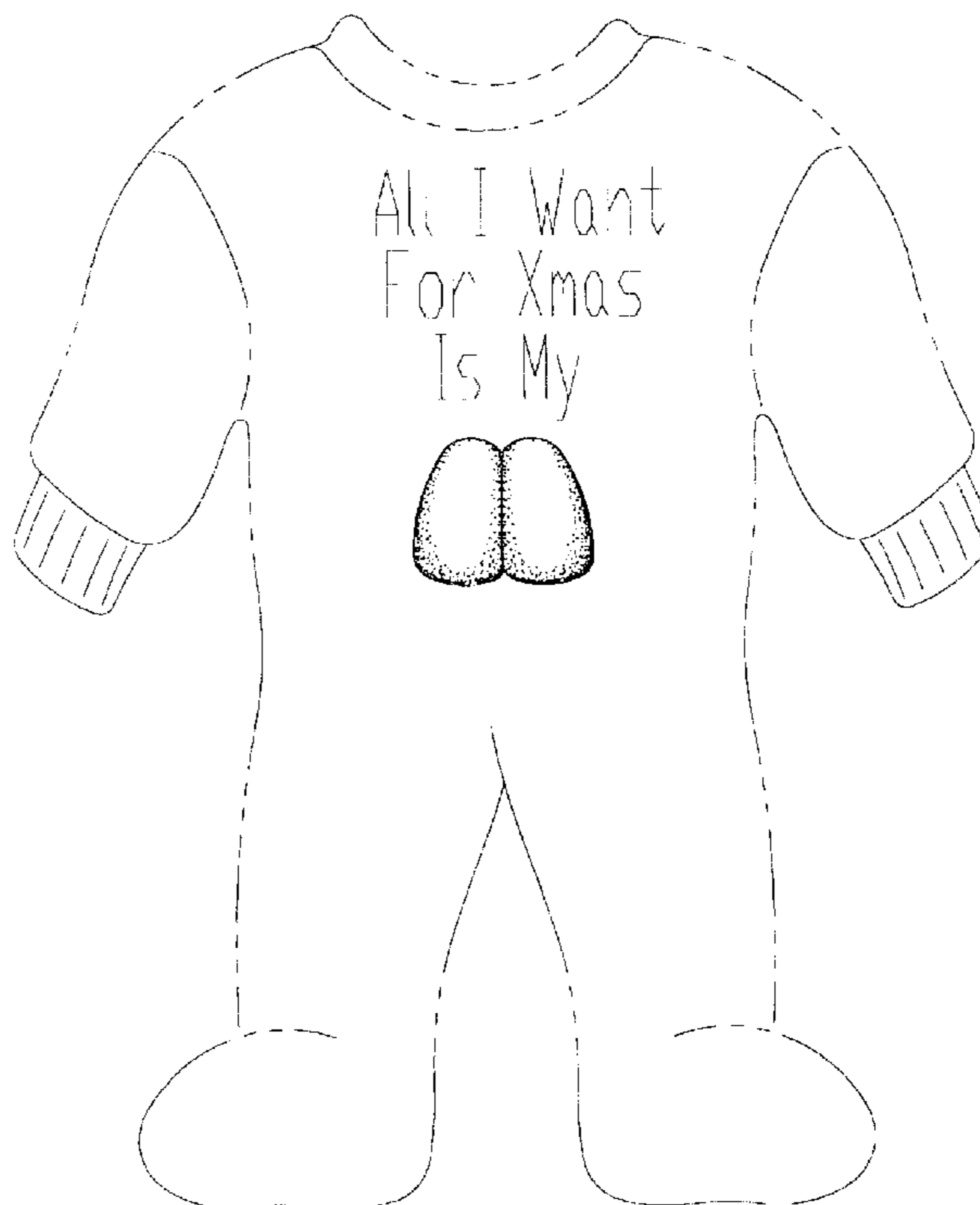
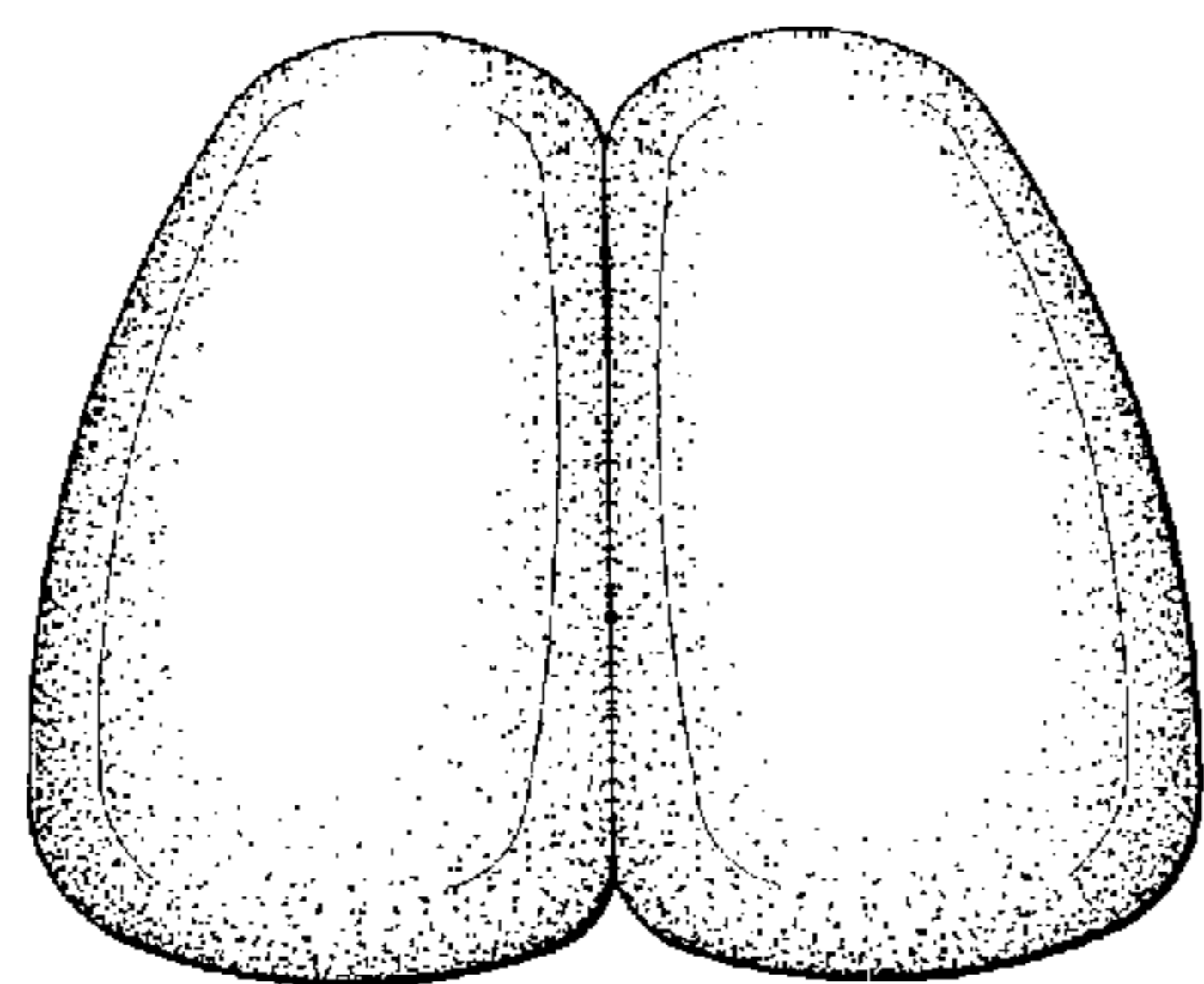
(57) **CLAIM**

We claim the ornamental design for Christmas teeth, as
shown and described.

DESCRIPTION

FIG. 1 is a perspective view of Christmas teeth showing our
new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a left side elevational view thereof, the right side
elevational view being a mirror image thereof;
FIG. 4 is a top plan view thereof;
FIG. 5 is a bottom plan view thereof;
FIG. 6 is a rear elevational view thereof; and,
FIG. 7 is a reduced perspective view showing the Christmas
teeth in use; the phantom lines depict environmental struc-
ture for illustrative purposes only and form no part of the
claimed design.

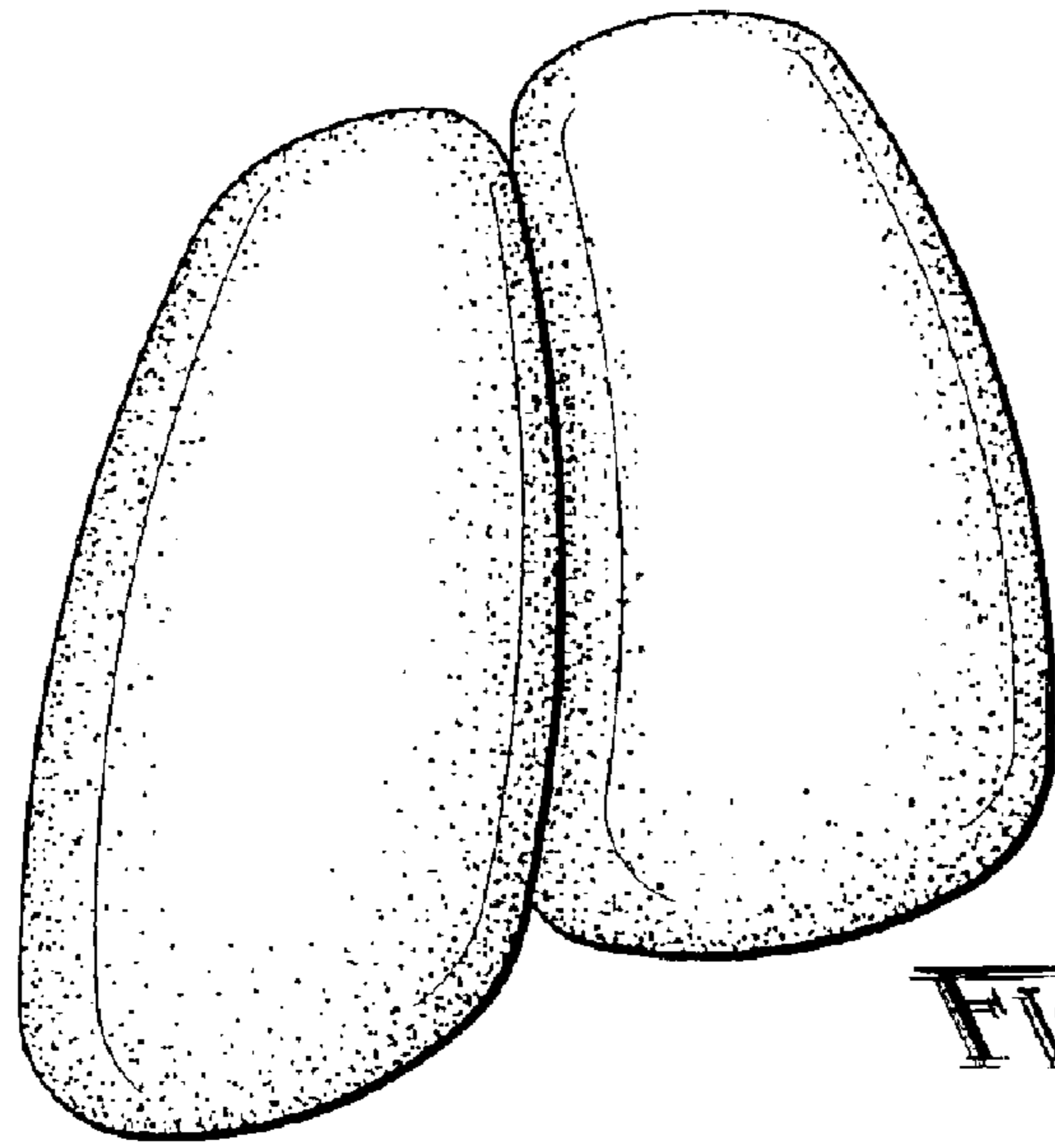

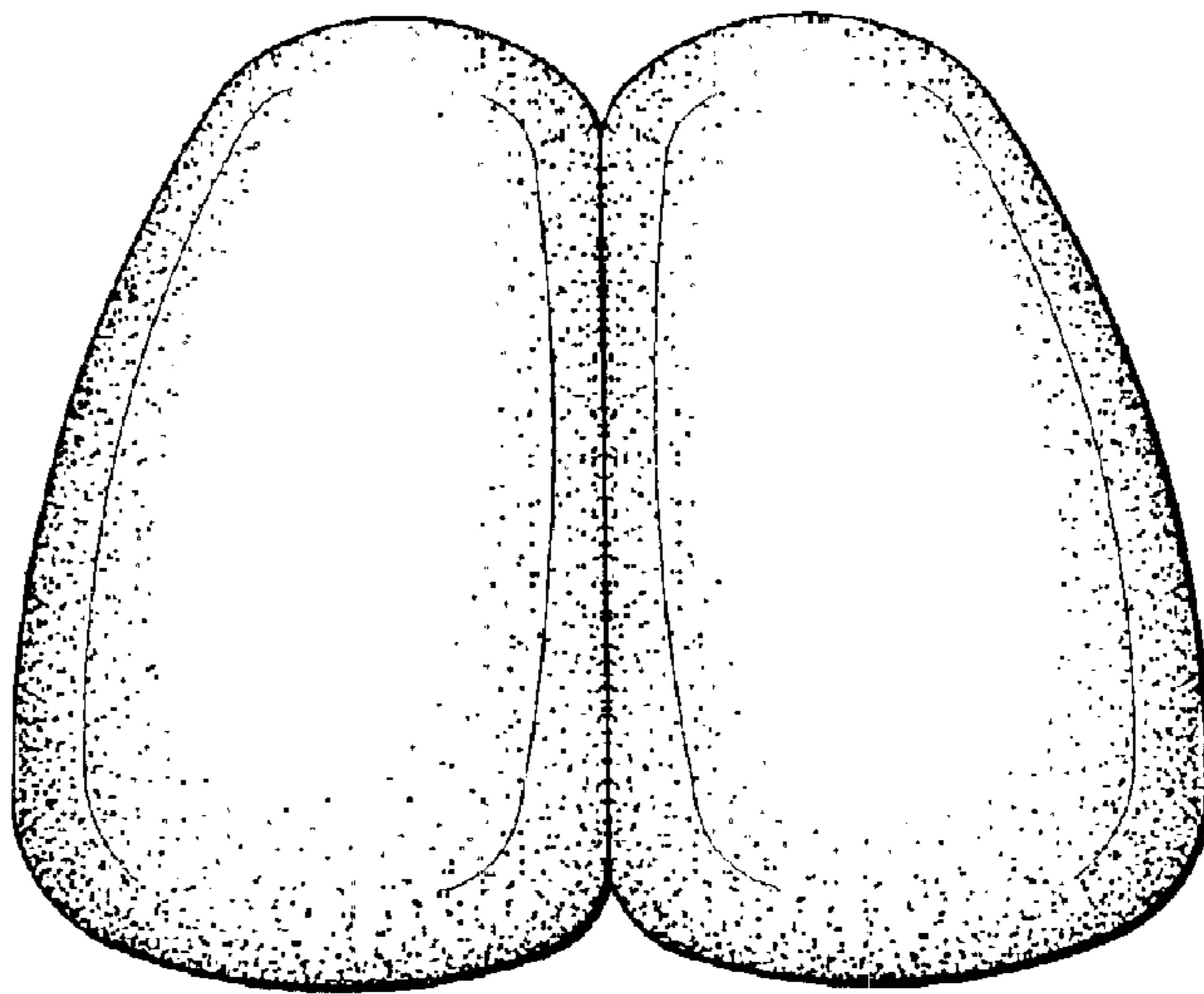

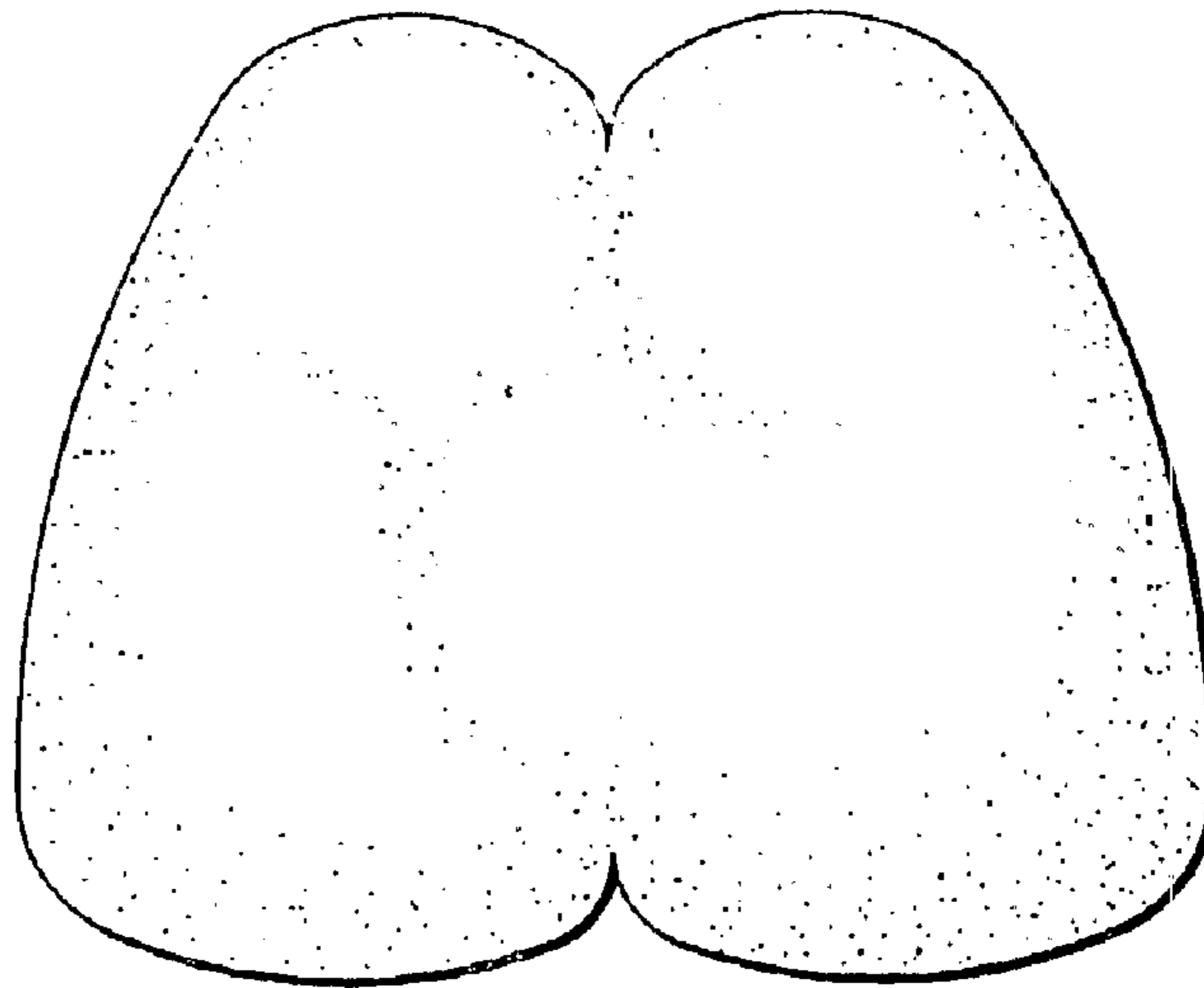
