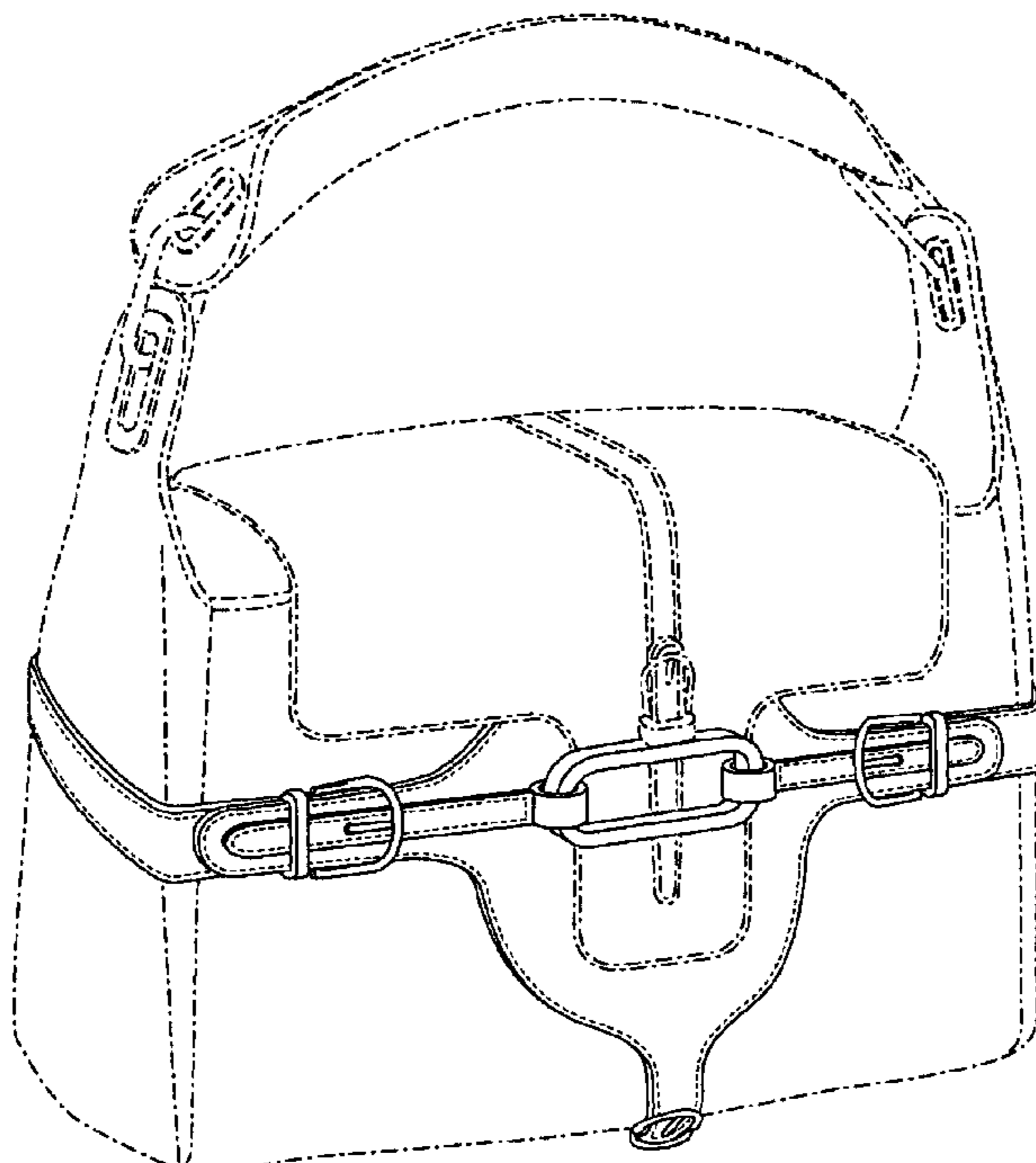
(57) **CLAIM**

The ornamental design for a handbag, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a handbag;
FIG. 2 is a front view of the handbag;
FIG. 3 is a side view of the handbag; and,
FIG. 4 is a top view of the handbag.
The broken line(s) which define the bounds of the claimed design form no part thereof.
The phantom lines showing portions of a handbag in FIGS. 1-4 are for illustrative purposes only and form no part of the claimed design. The back surface of the bag forms no part of the claimed design.

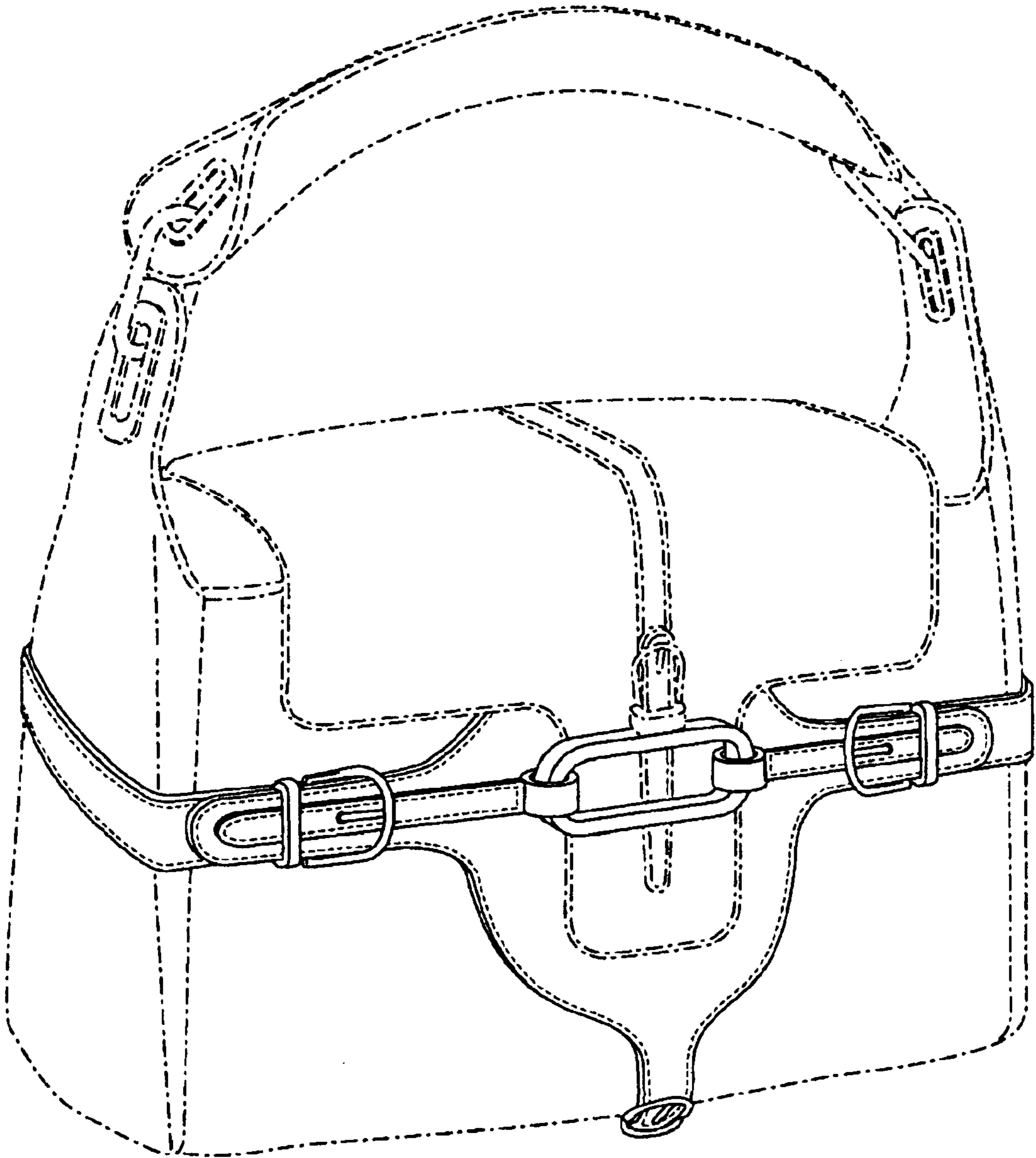

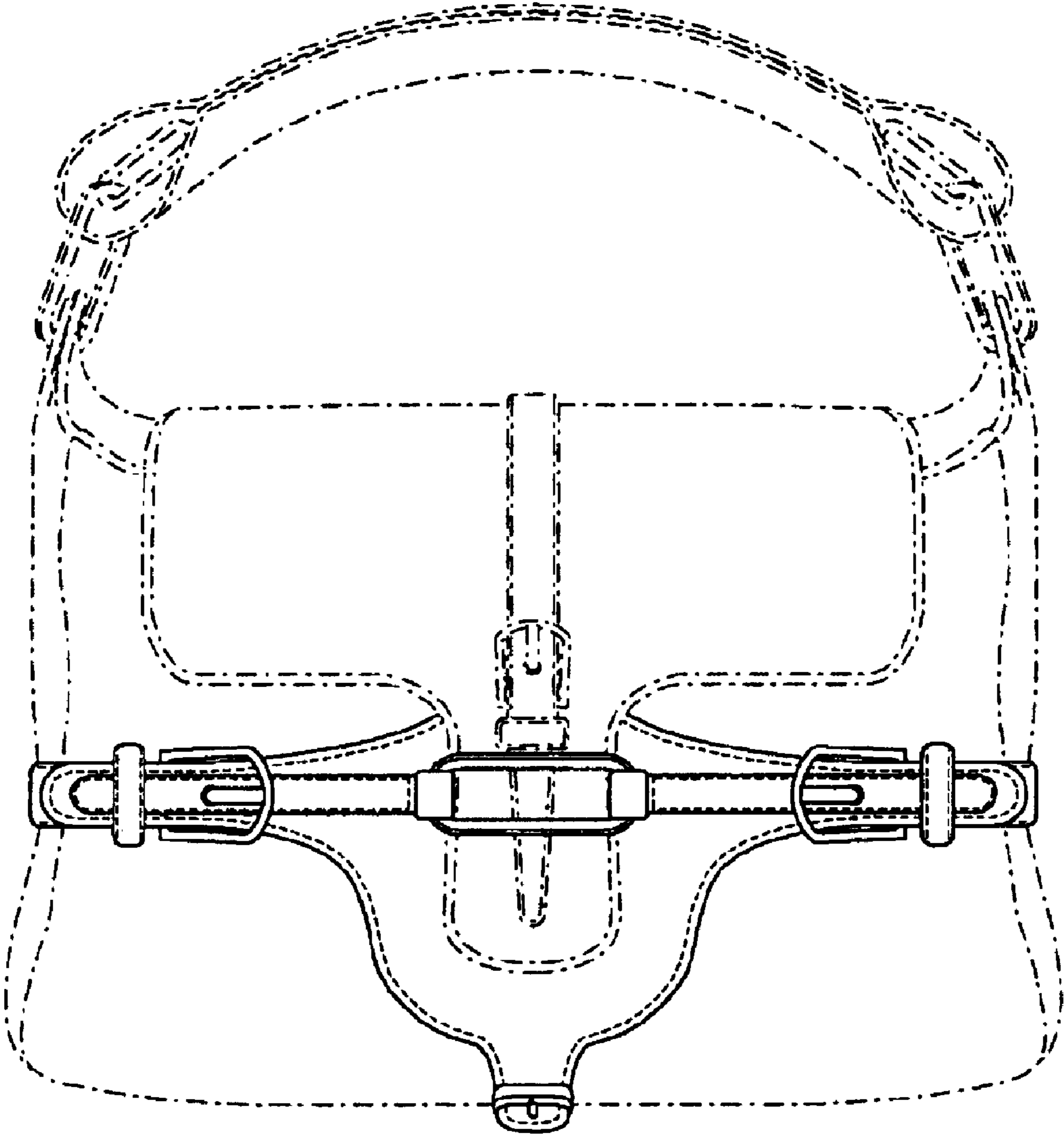

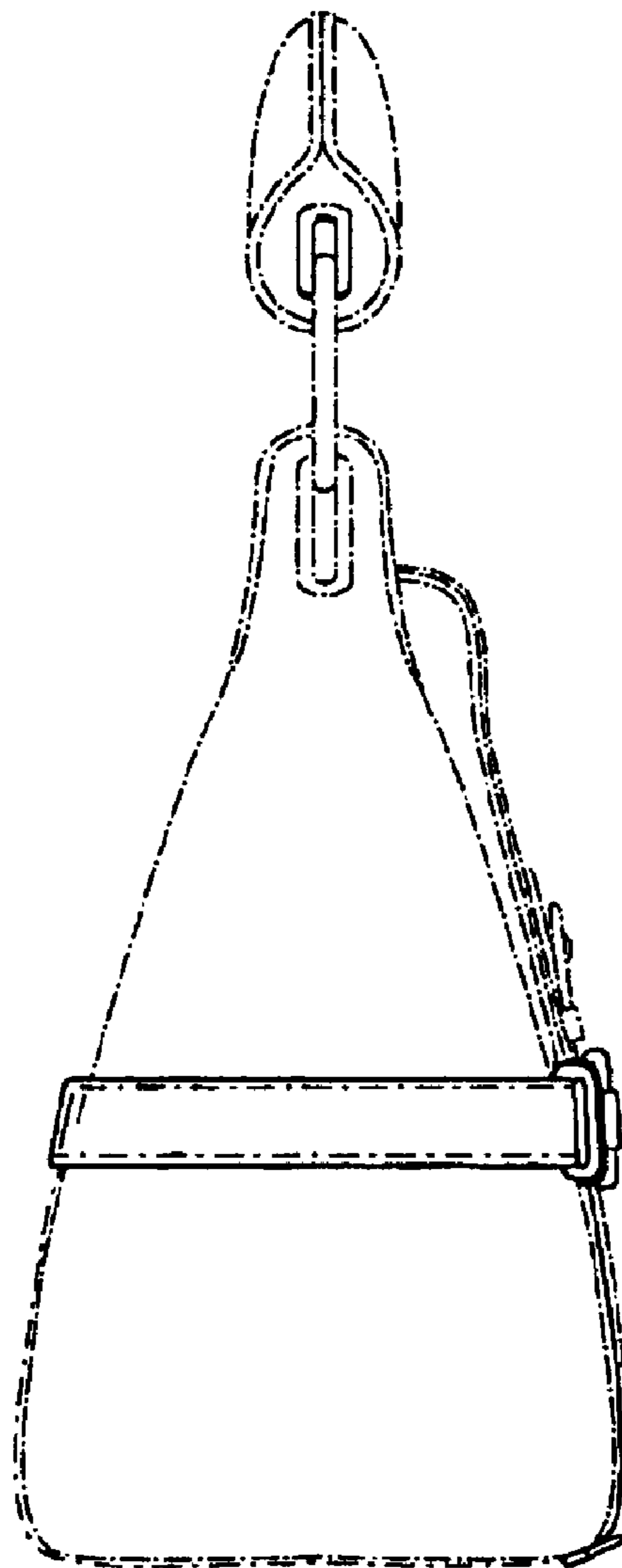

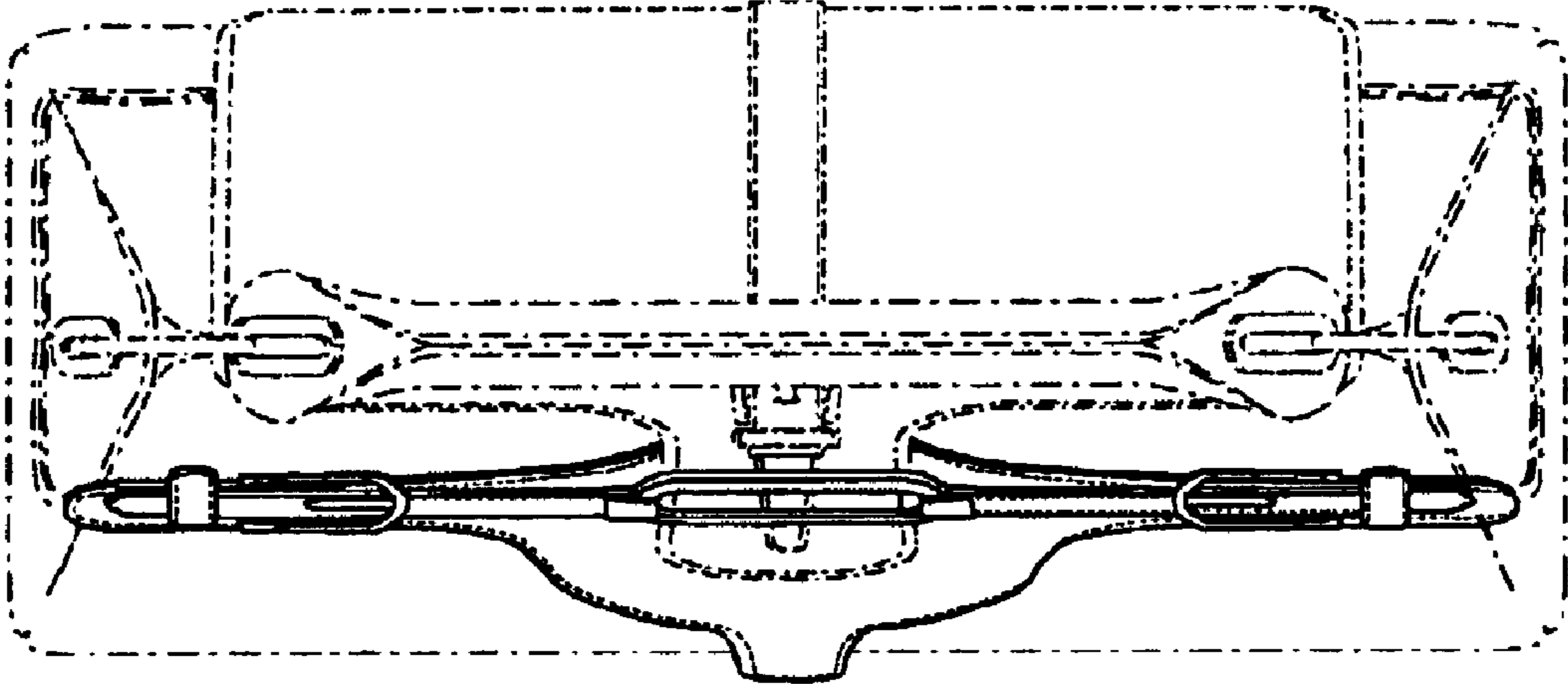
