(57)**CLAIM**

The ornamental design for a furniture post ornamentation, as shown and described.

DESCRIPTION


FIG. 1 is a perspective view of a furniture post ornamentation showing my new design;

FIG. 2 is a front elevational view thereof; and,

FIG. 3 is a front elevational view thereof and including broken lines indicating representative environmental elements.

The views of the furniture post ornamentation not shown form no part of the claimed design. The broken lines depicting a chest in FIG. 3 represent environmental elements only and form no part of the claimed design. The separation and bracket indicate, for ease of illustration, that the precise length of the furniture post ornamentation is not claimed.




