(57) **CLAIM**

The ornamental design for a child's bowl with lid and cutlery, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view as seen from the upper left rear of a child's bowl with lid and cutlery showing my new design;

FIG. 2 is a perspective view thereof as seen from the upper front right;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a rear elevational view thereof;

FIG. 5 is a top plan view thereof;

FIG. 6 is a bottom view thereof;

FIG. 7 is a perspective view thereof as seen from the upper left side;

FIG. 8 is a left side elevational view thereof;

FIG. 9 is a perspective view thereof as seen from the lower front;

FIG. 10 is a perspective view thereof as seen from the lower rear;

FIG. 11 is a perspective view thereof as seen from the upper front, showing a cutlery cover in an alternative position;

FIG. 12 is a rear perspective view thereof;

FIG. 13 is a front elevational view thereof;

FIG. 14 is a left side elevational view thereof;

FIG. 15 is a left side elevational view thereof with the lid removed for ease of illustration;

FIG. 16 is a left side perspective view thereof;

FIG. 17 is a perspective view thereof as seen from the upper front;

FIG. 18 is a front elevational view thereof;

FIG. 19 is a perspective view thereof as seen from the upper rear;

FIG. 20 is a rear elevational view thereof;

FIG. 21 is a perspective view thereof as seen from the lower front;

FIG. 22 is a perspective view thereof as seen from the lower rear;

FIG. 23 is a perspective view thereof as seen from the upper left with the lid and insert removed for ease of illustration;

FIG. 24 is a perspective view thereof as seen from the upper front;

FIG. 25 is a left side elevational view thereof, the right side being a mirror image thereof;

FIG. 26 is a front elevational view thereof;

FIG. 27 is a rear elevational view thereof;

FIG. 28 is a perspective view of the spoon portion of the child's bowl with lid and cutlery as seen from the upper right, the other portions removed for ease of illustration;

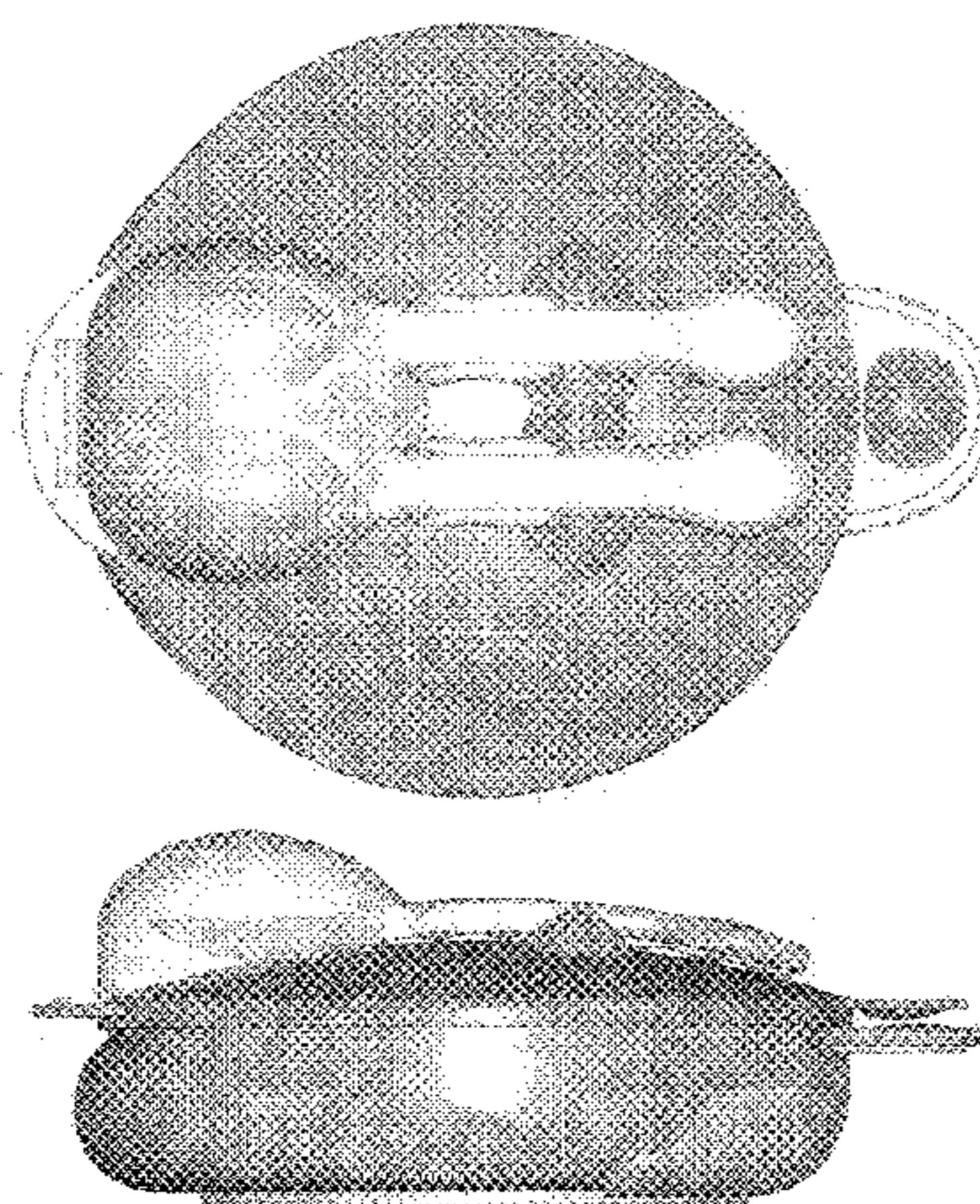
FIG. 29 is a perspective view thereof as seen from the upper left;

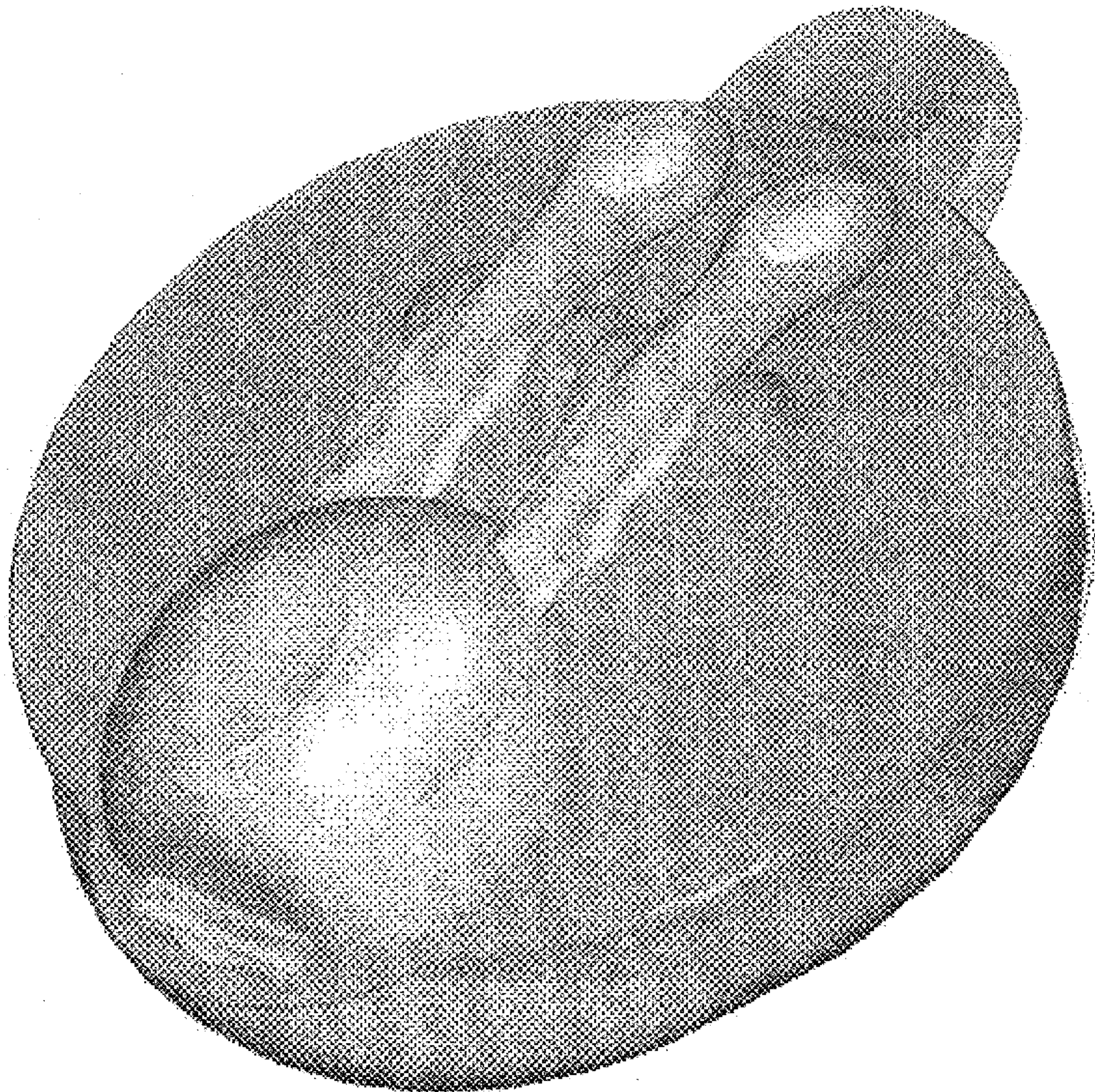

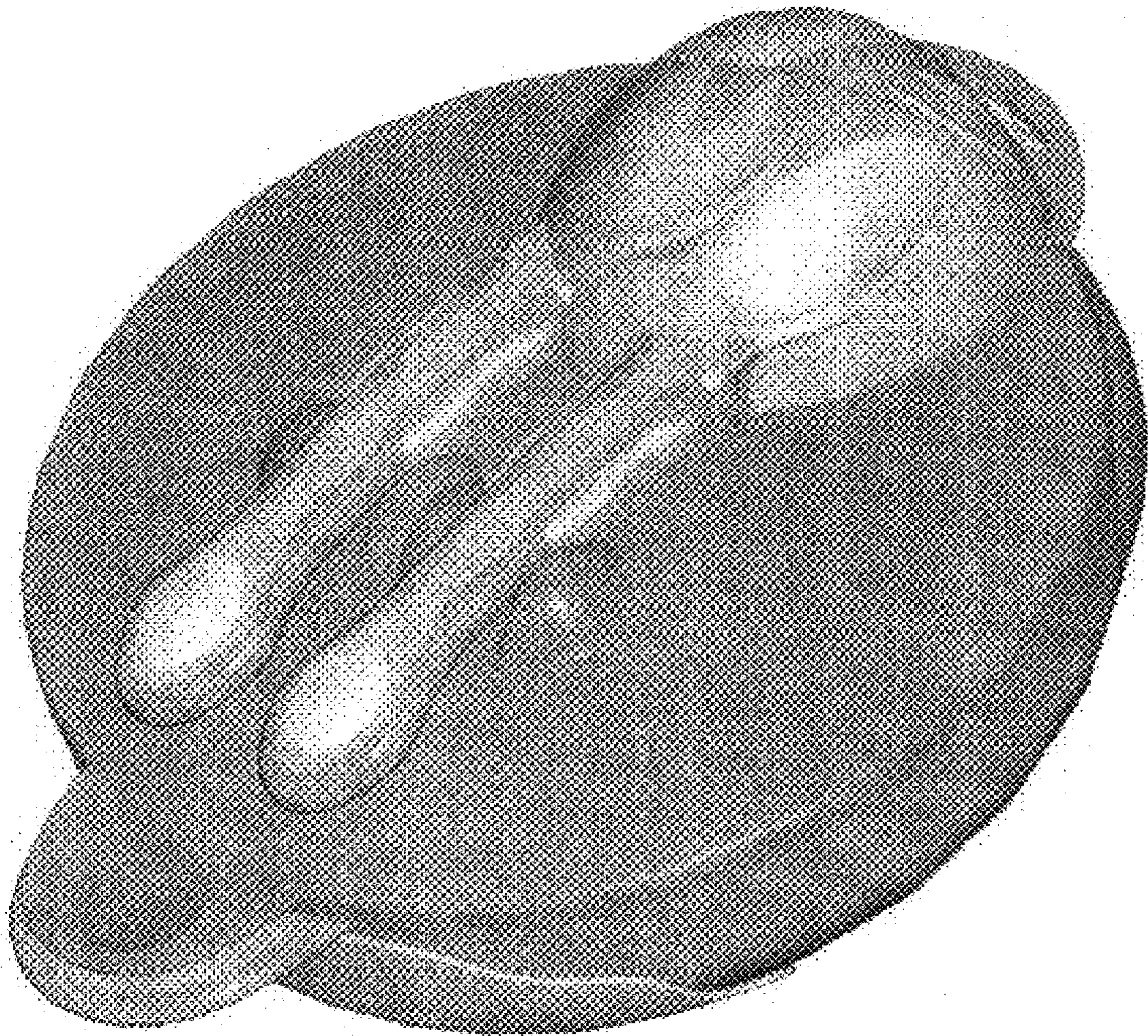

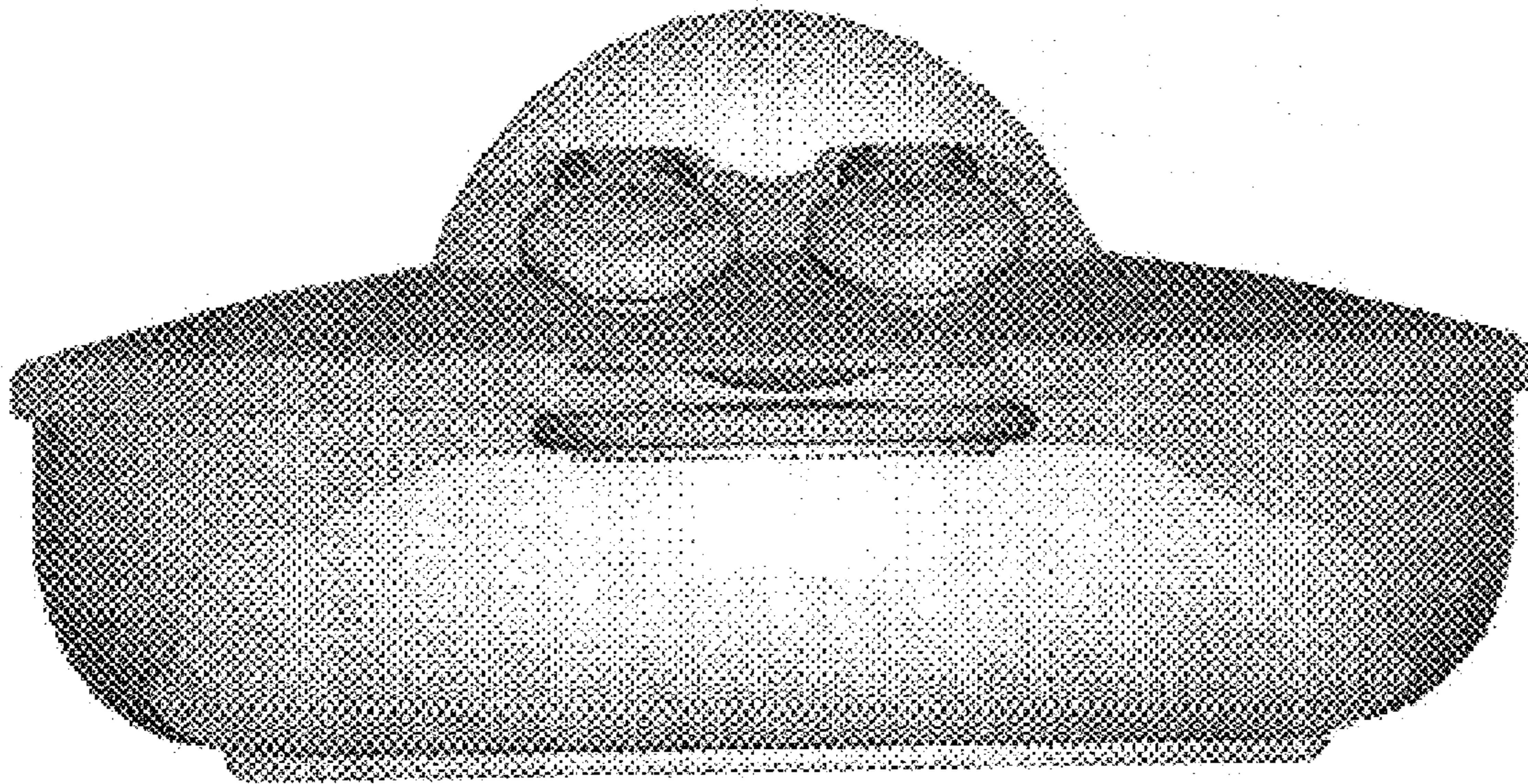

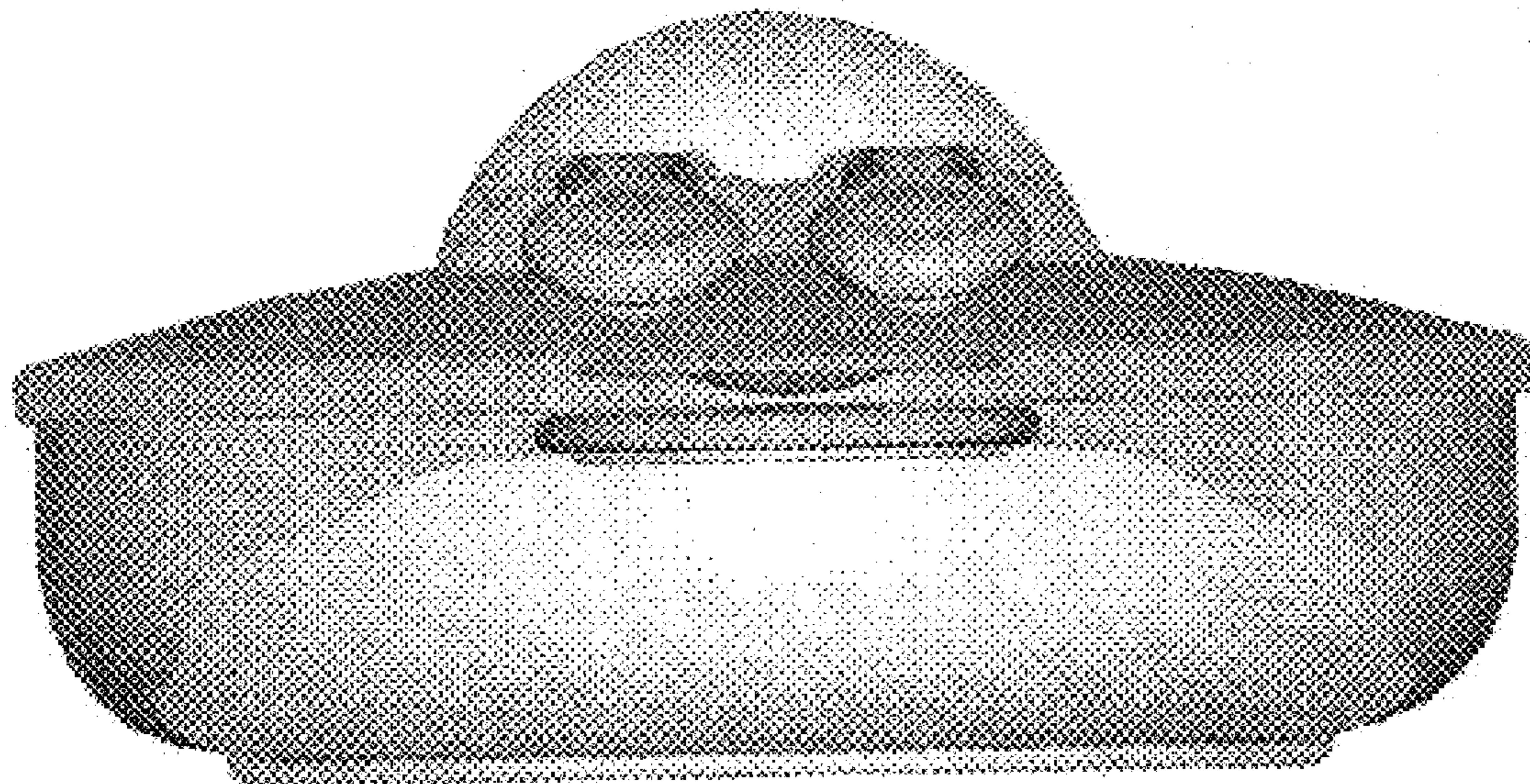

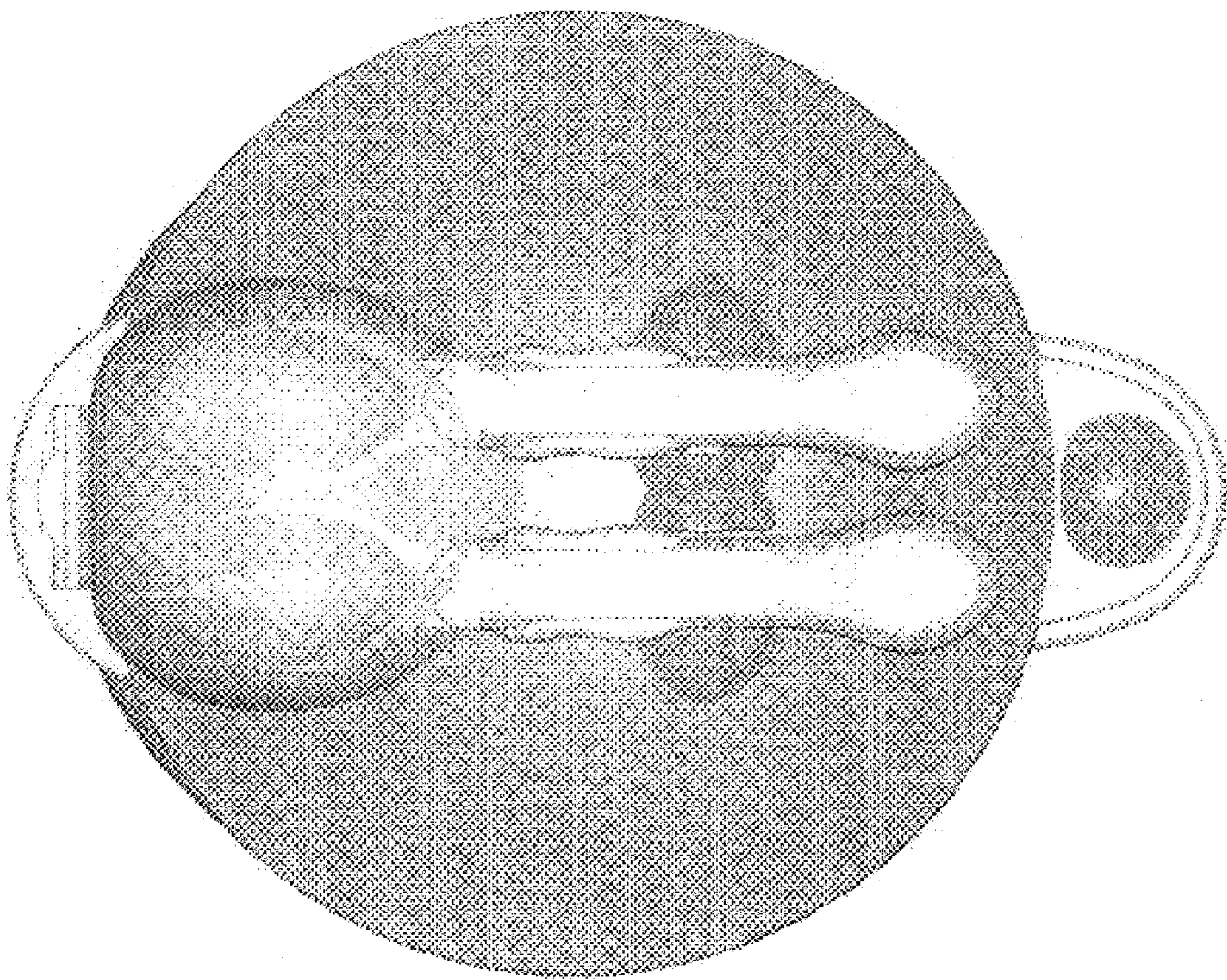

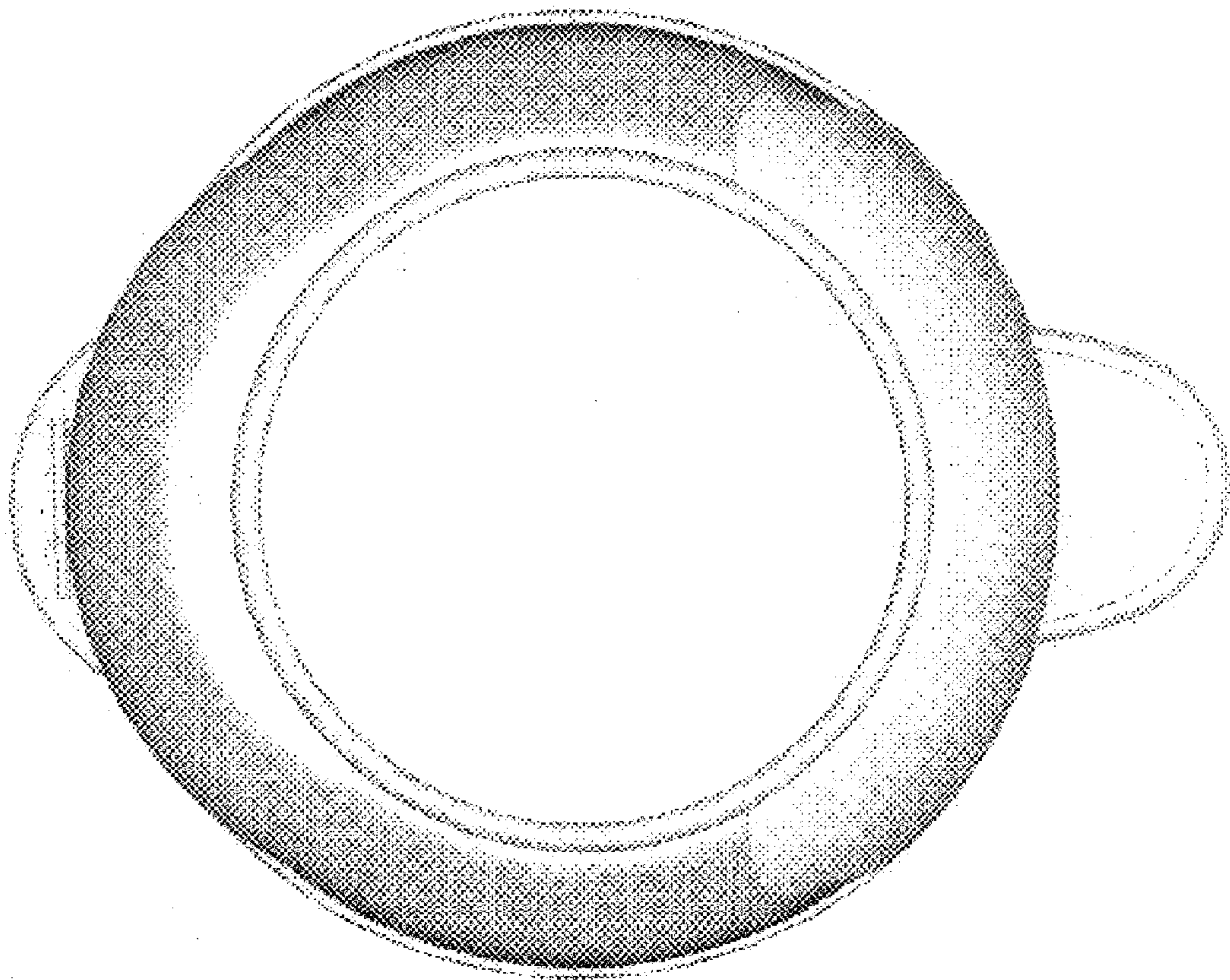

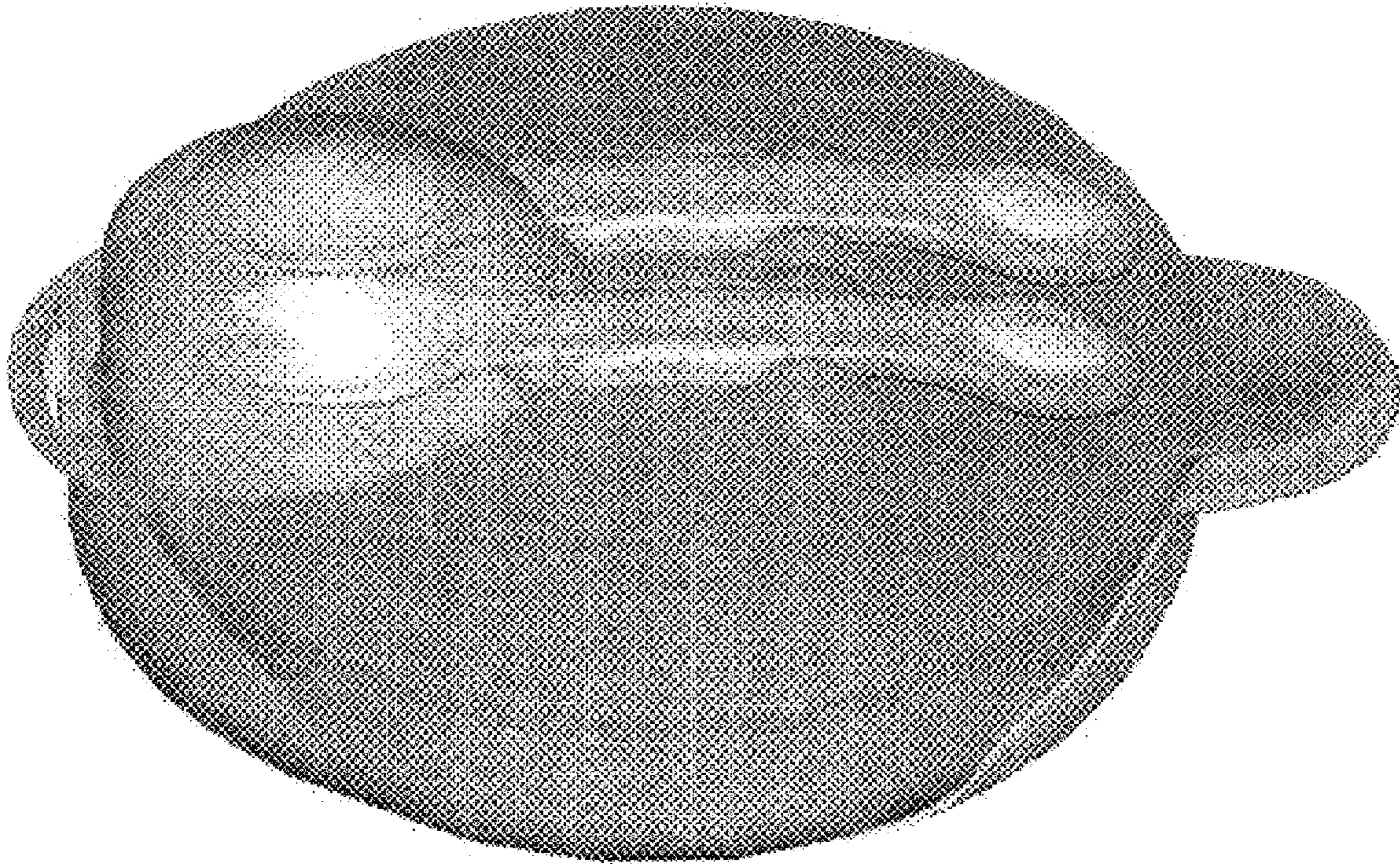

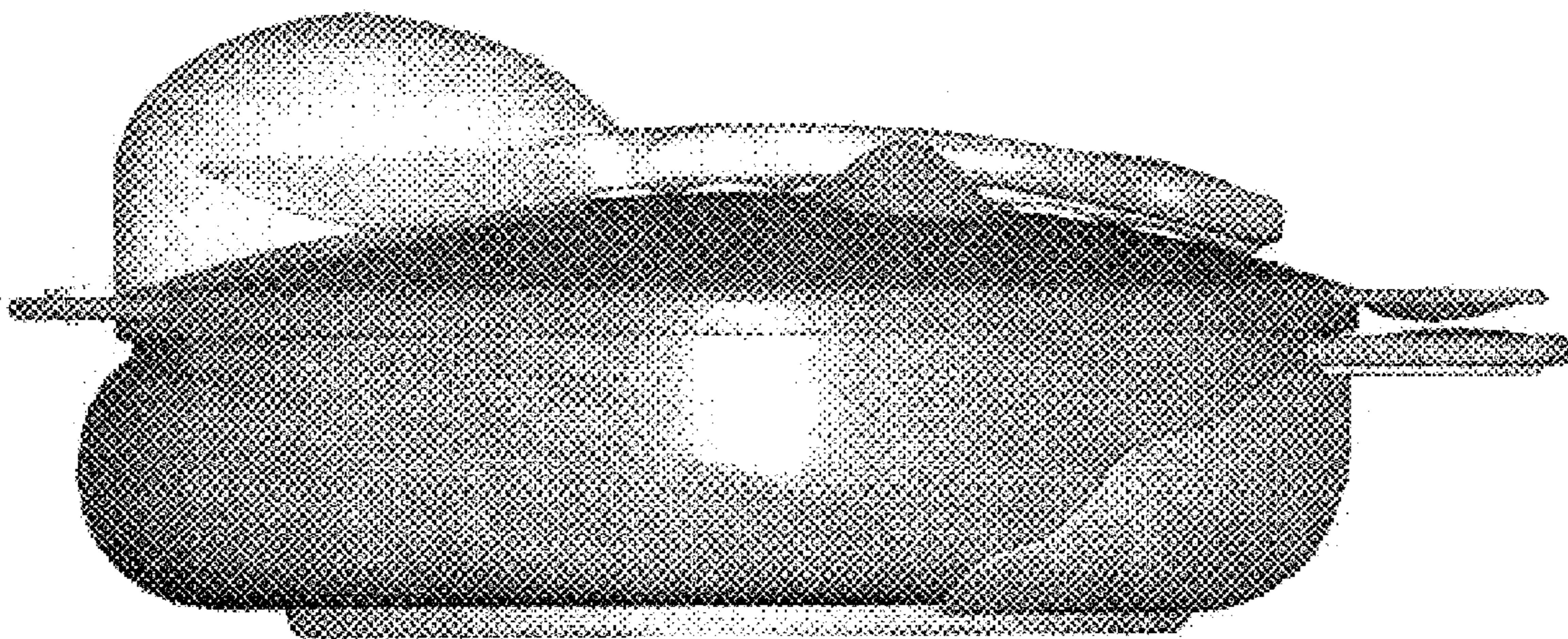

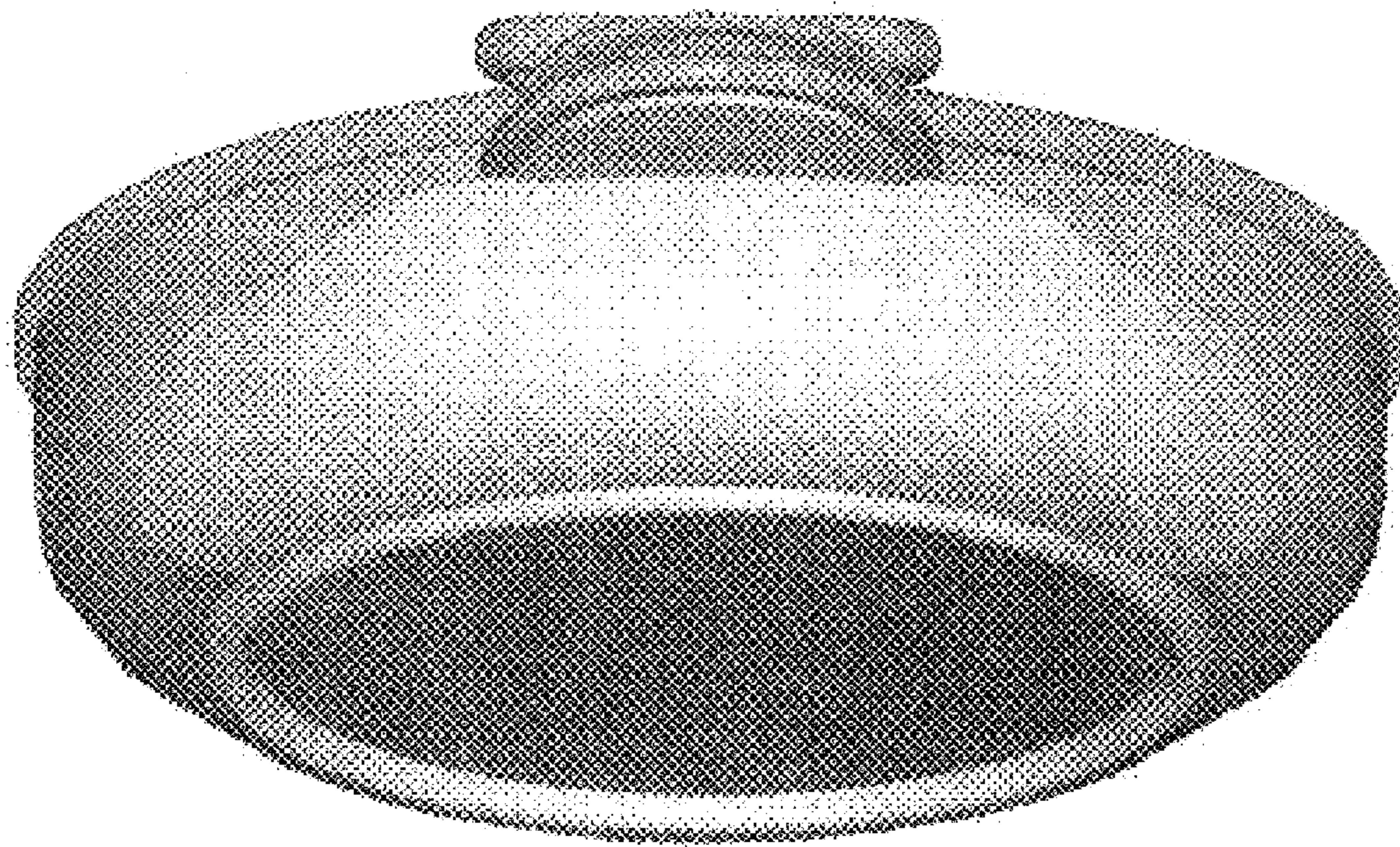

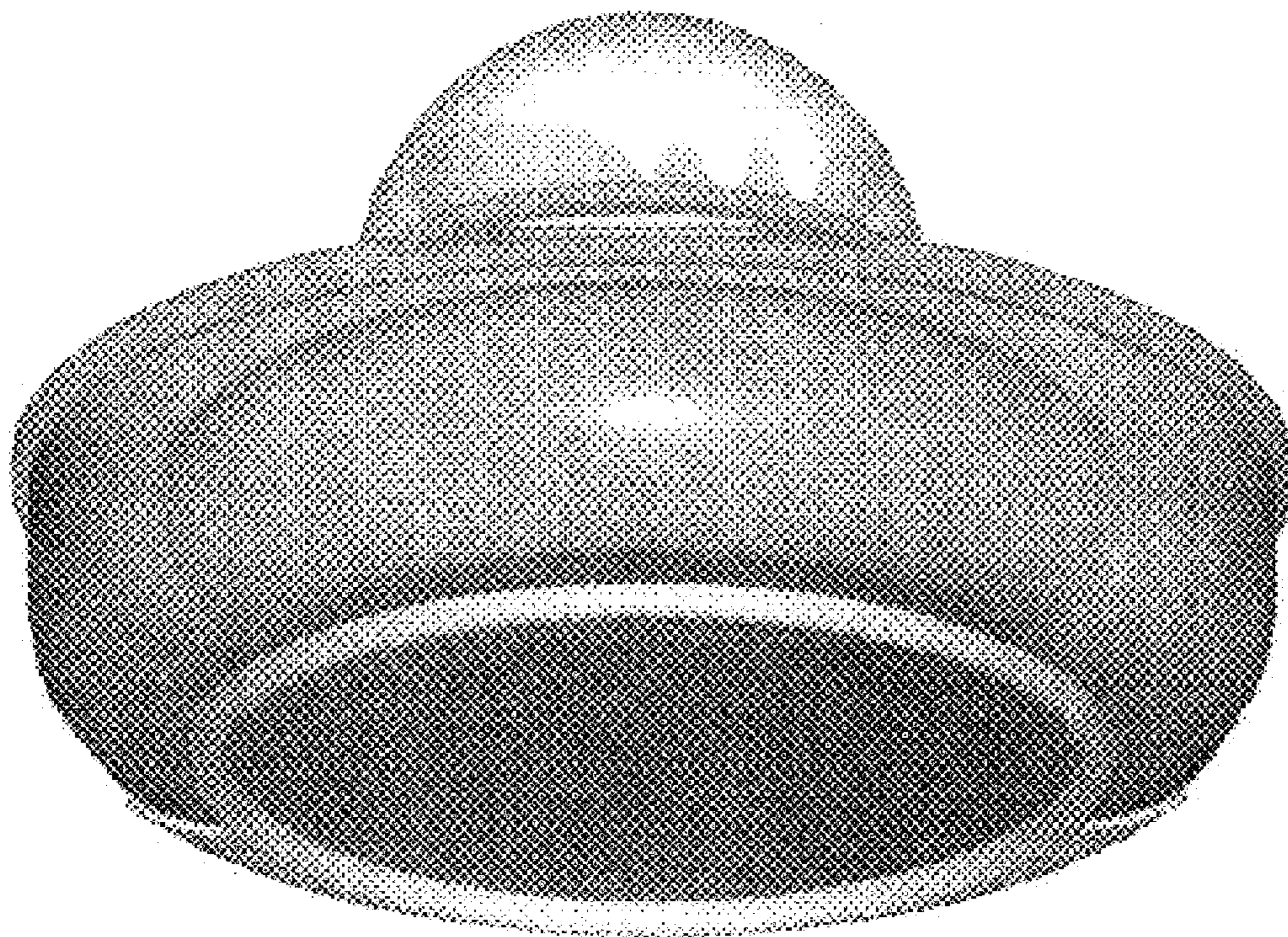

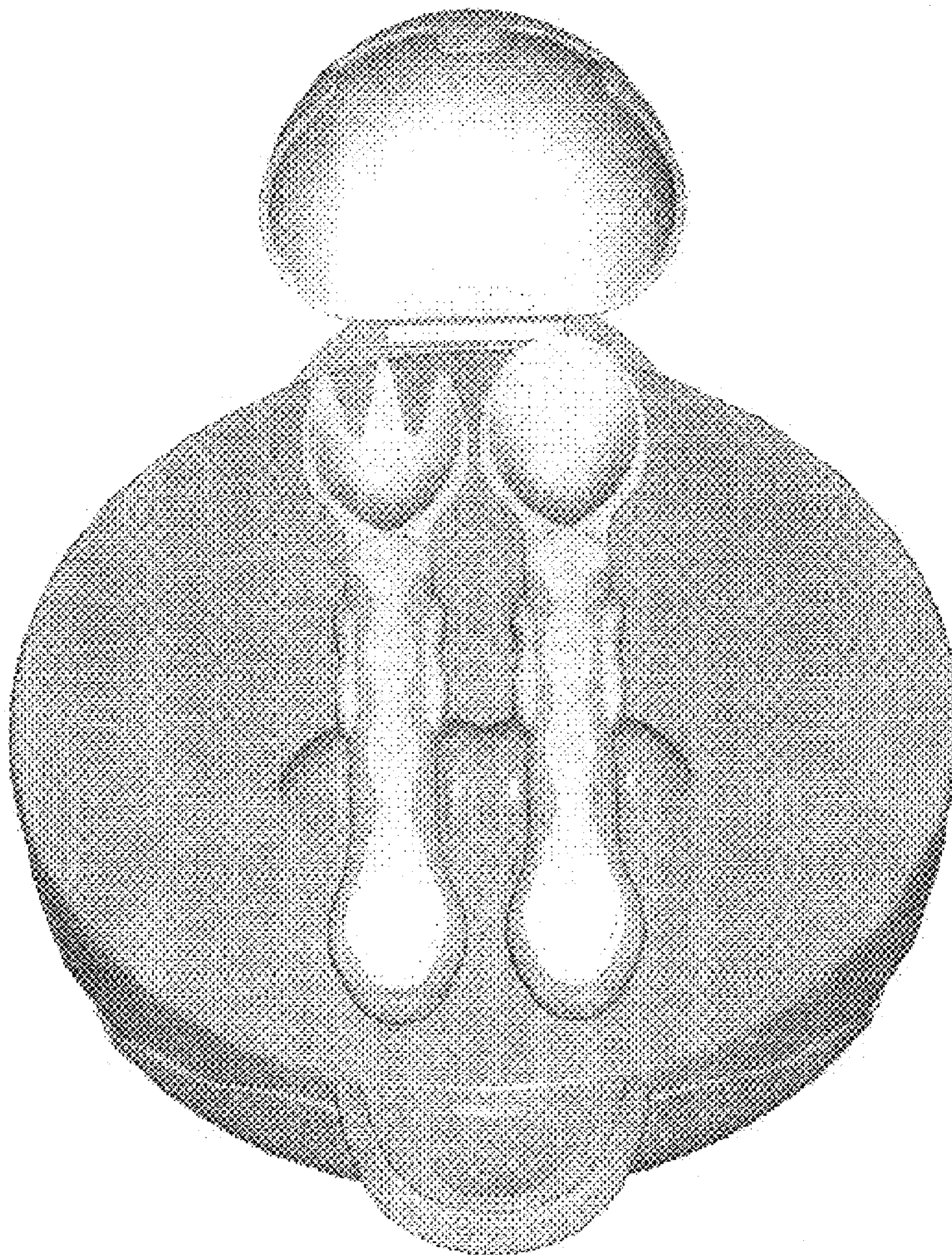

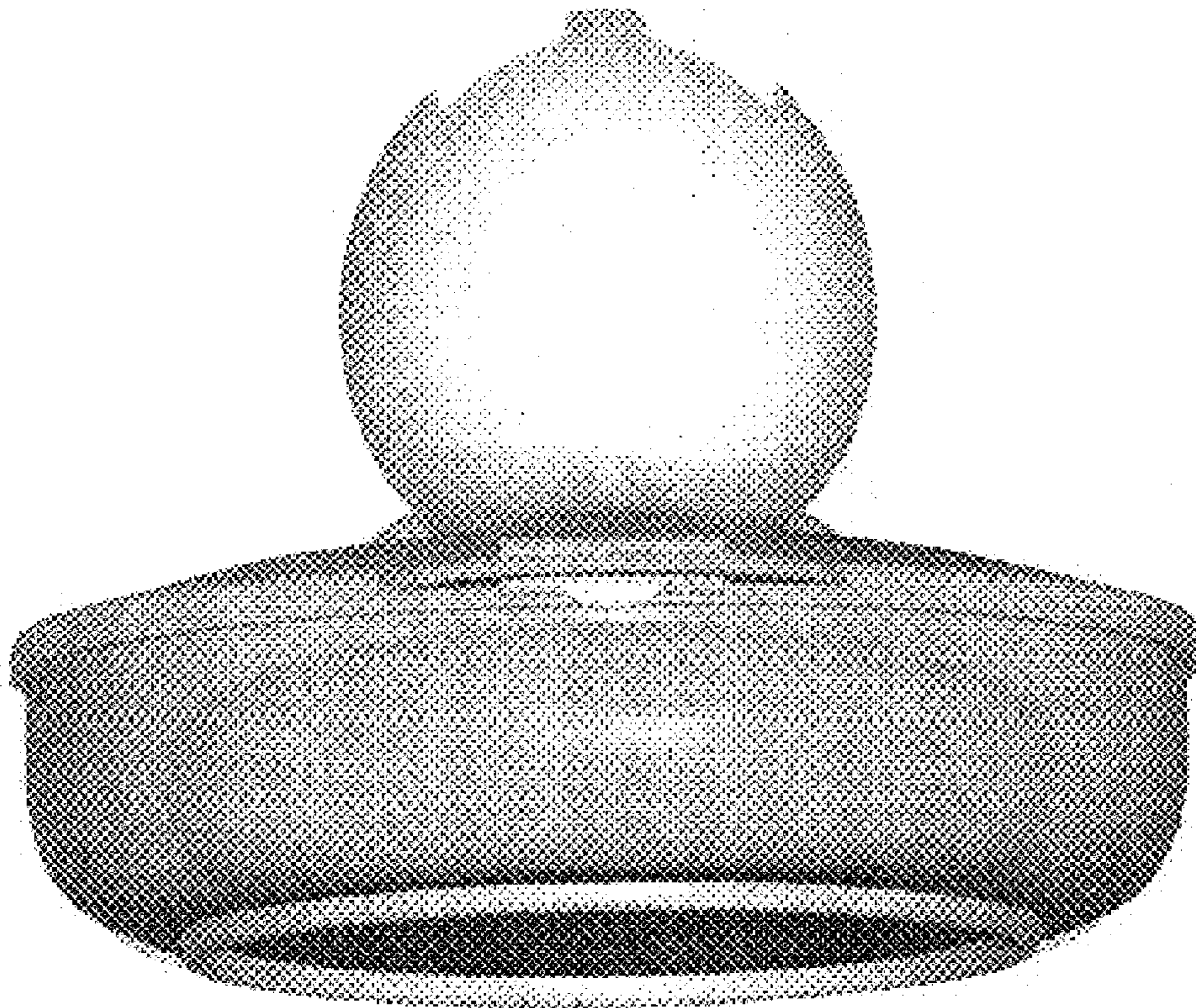

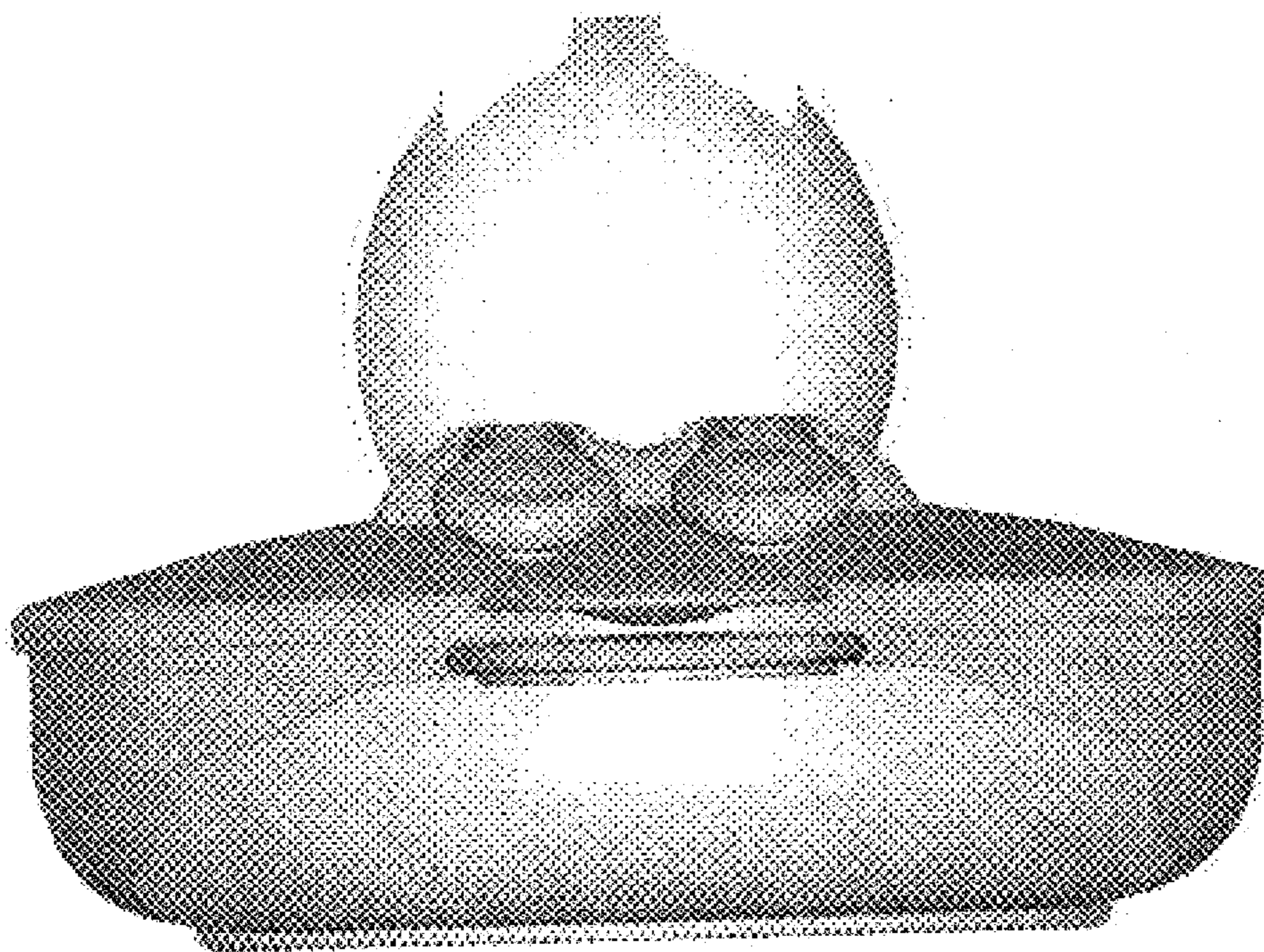

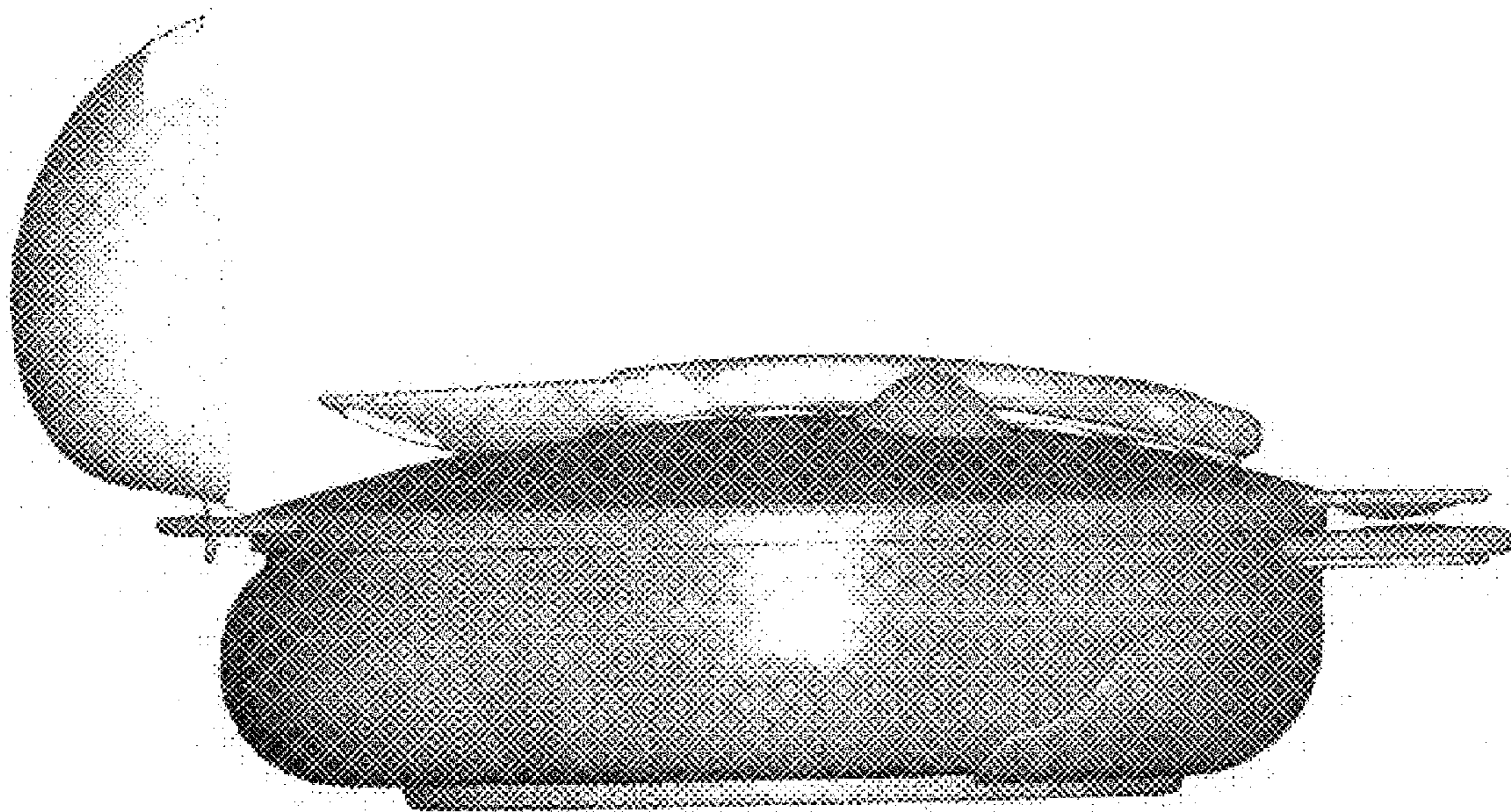

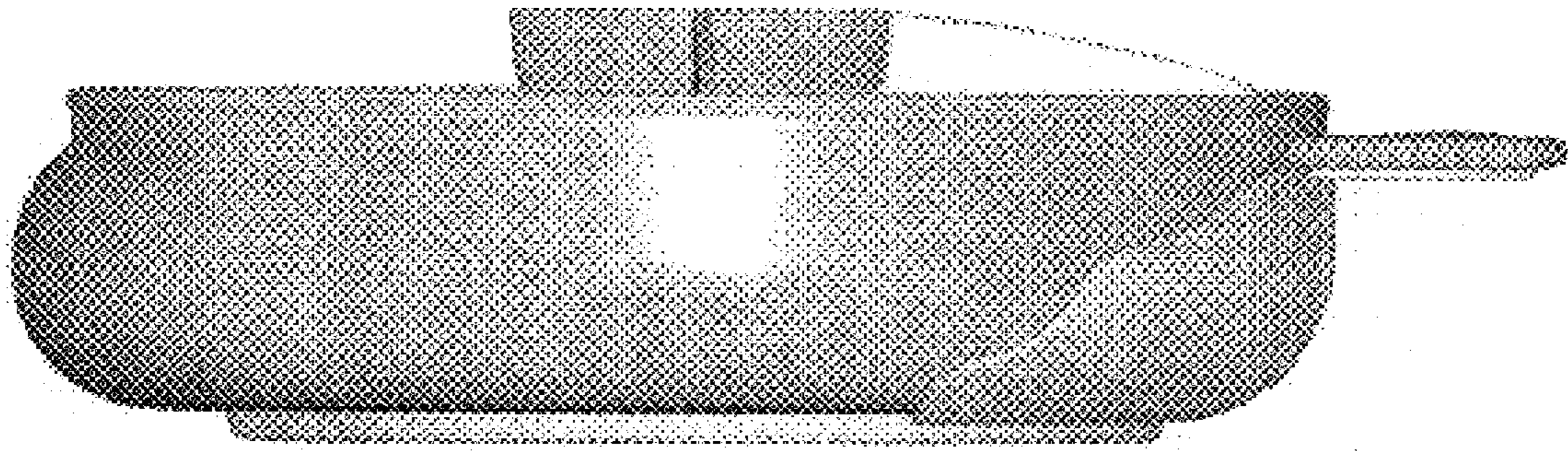

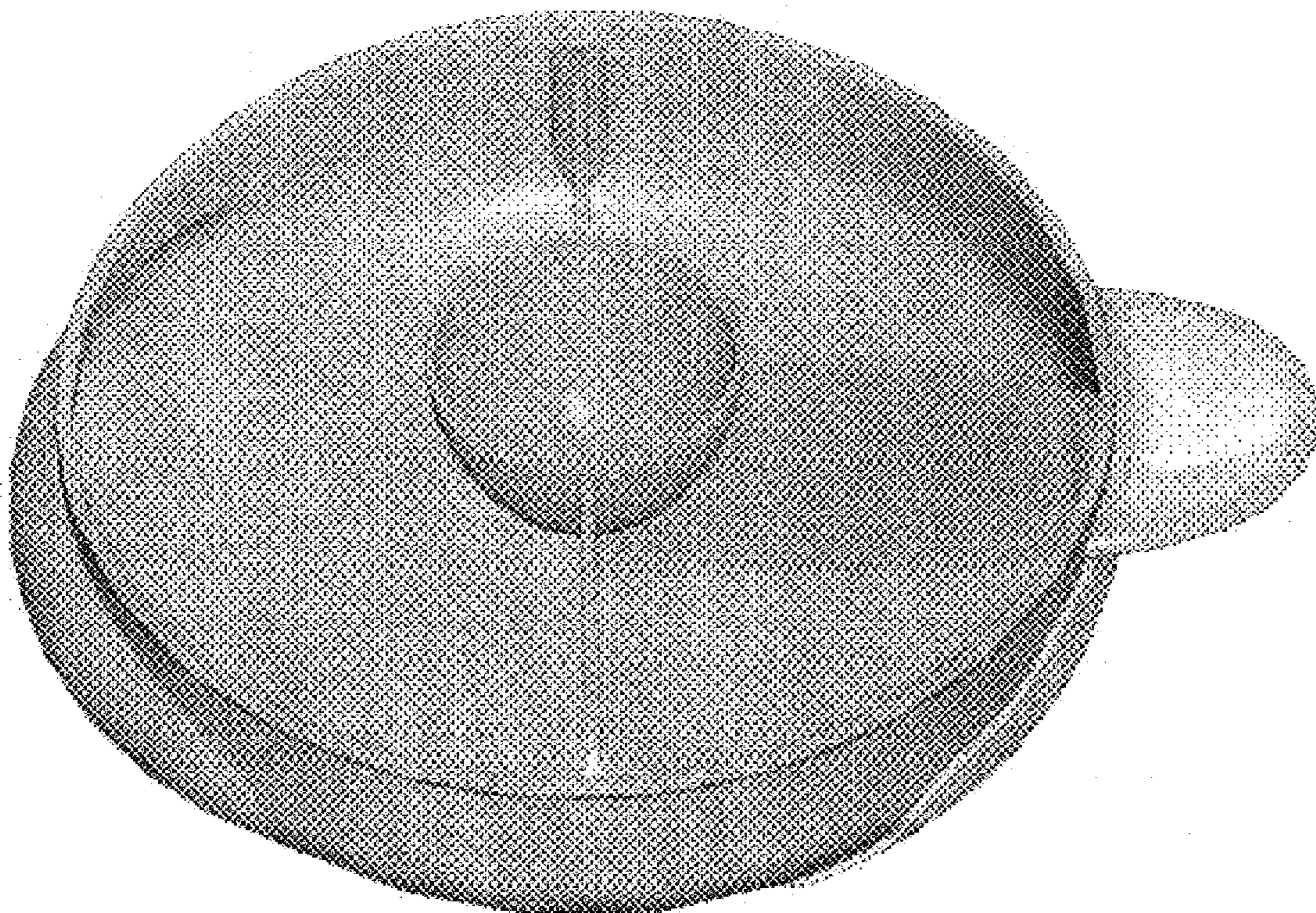

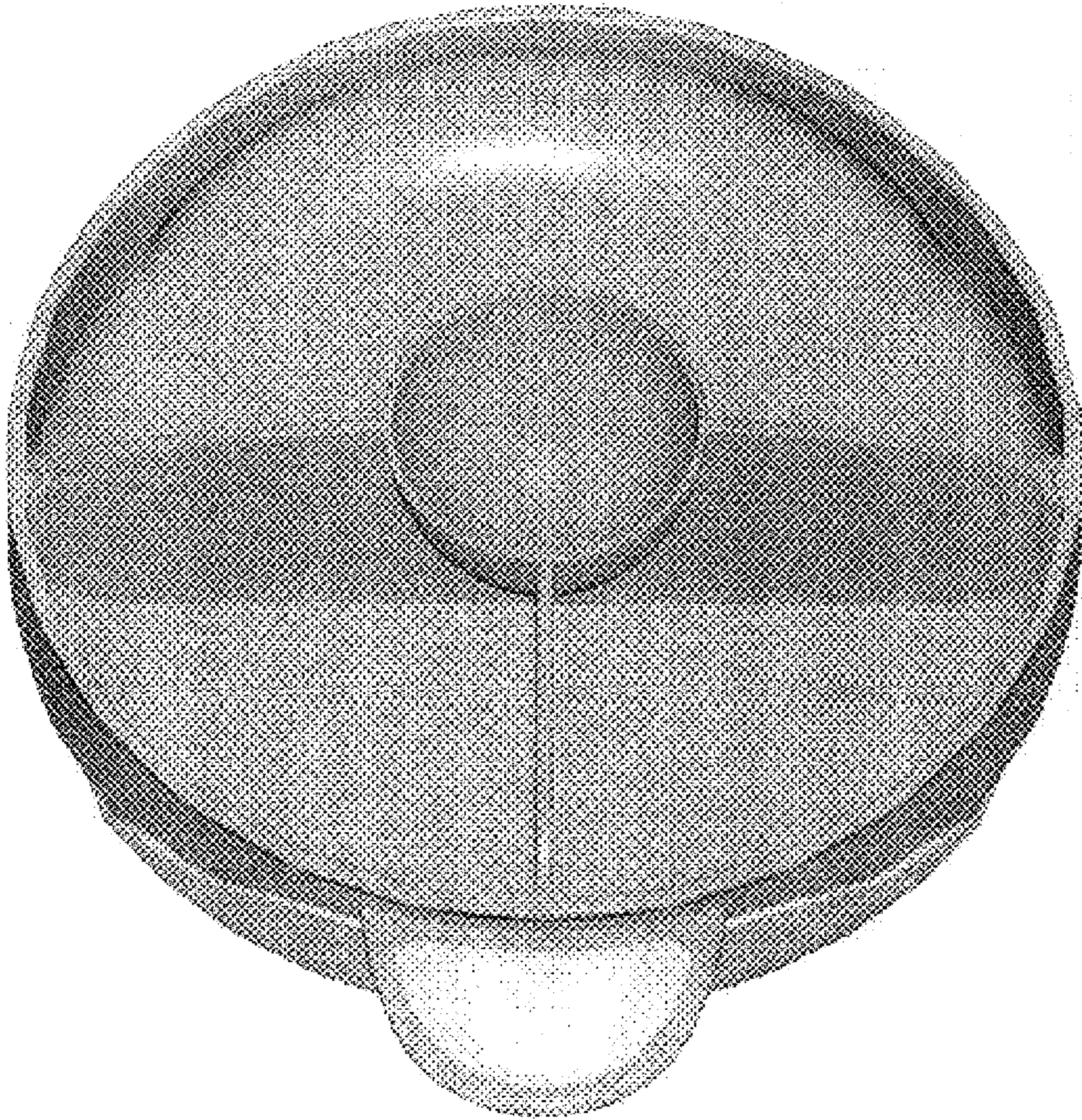

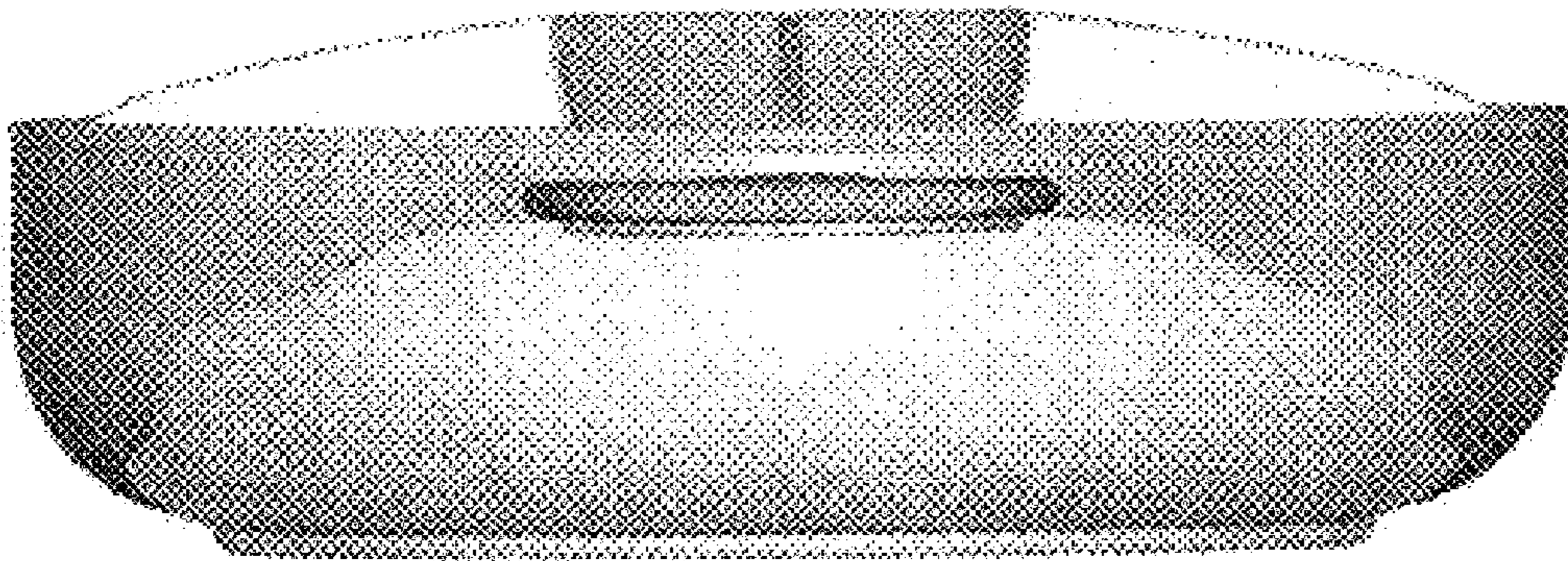

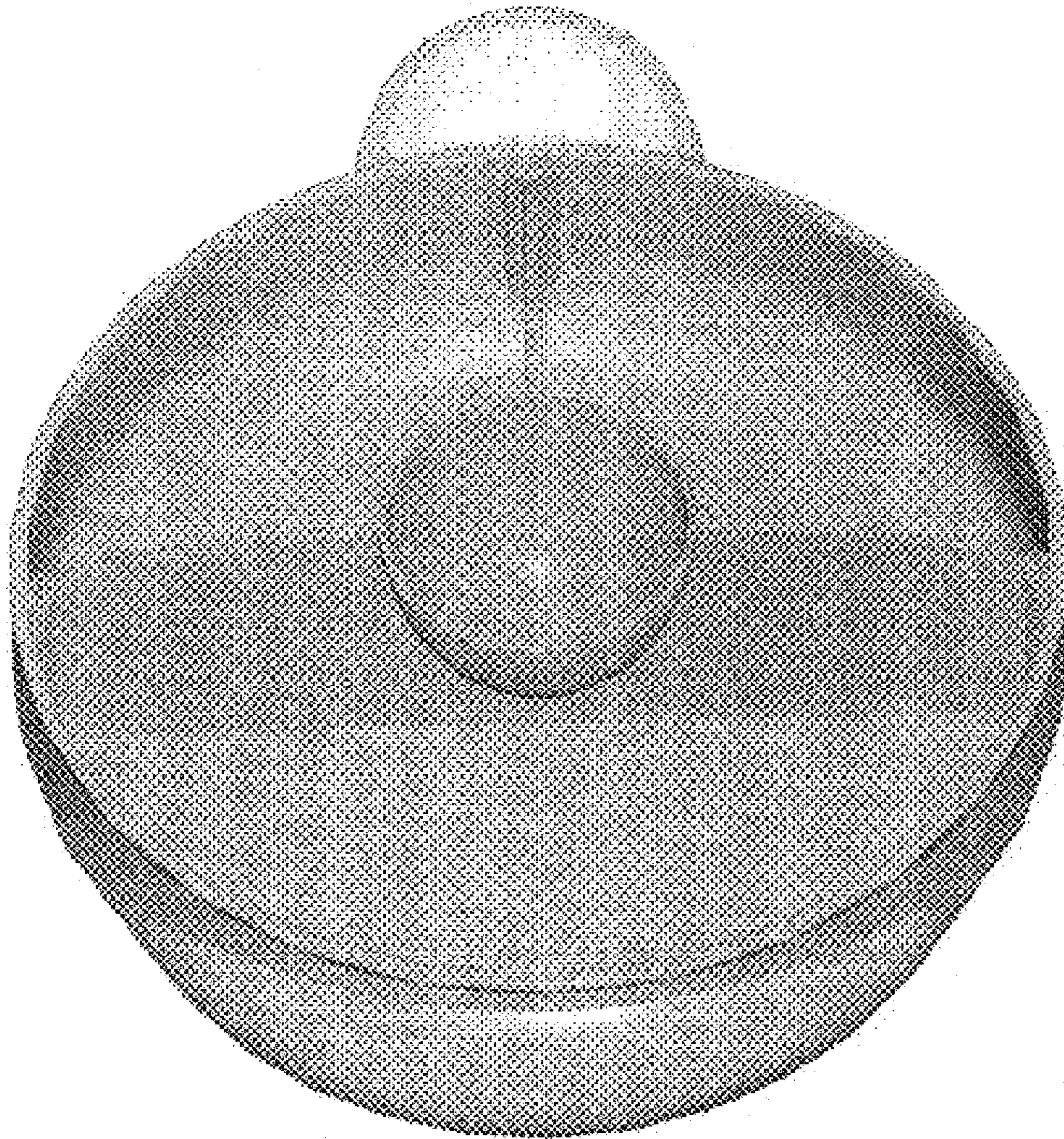

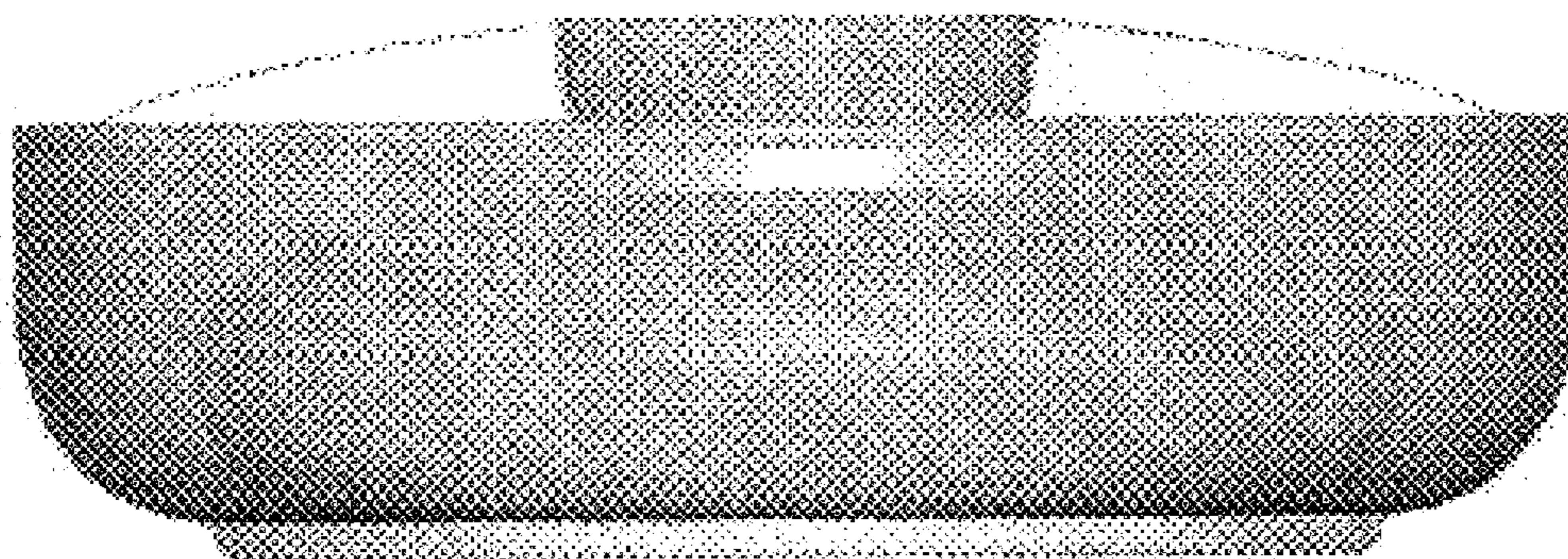

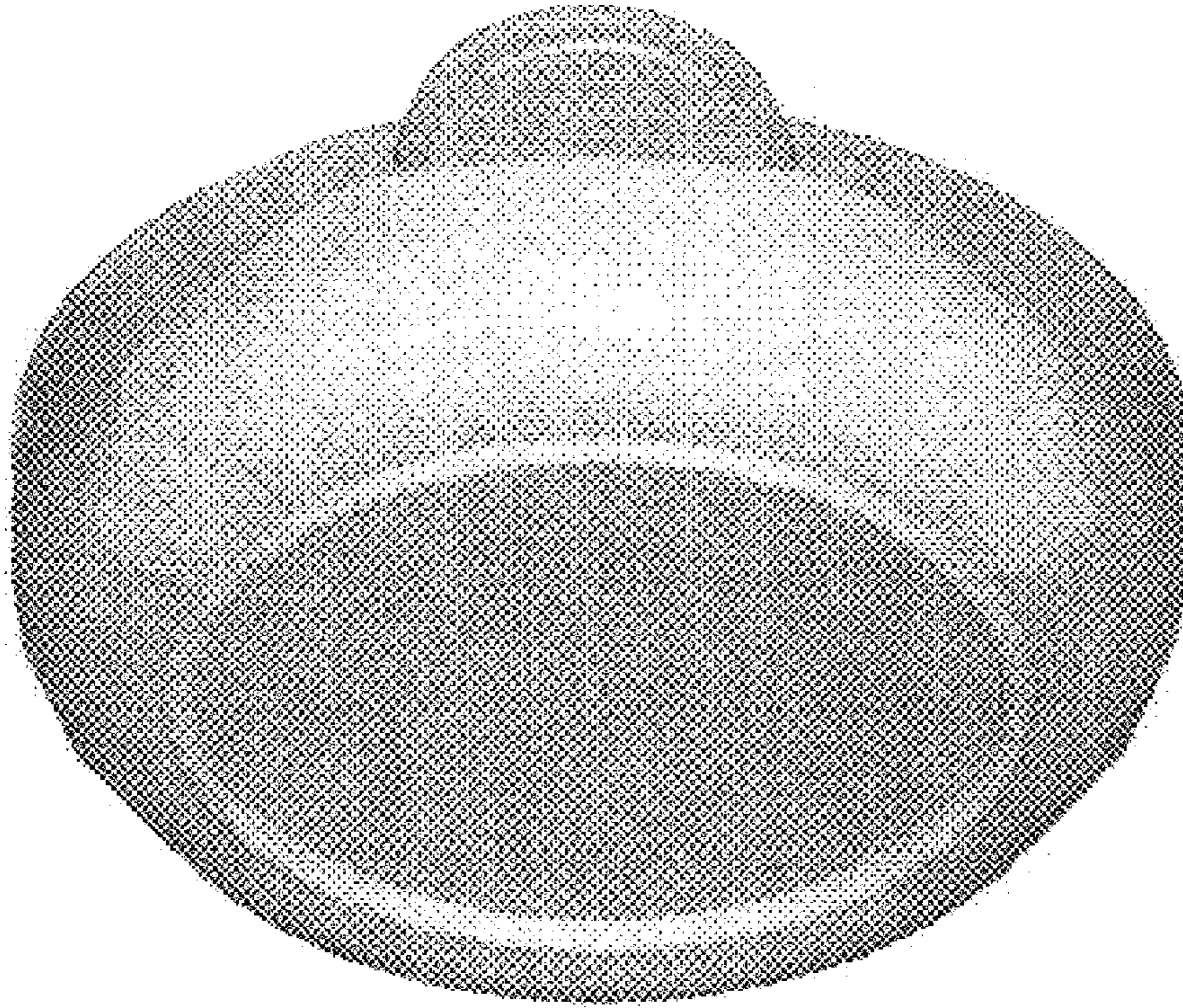

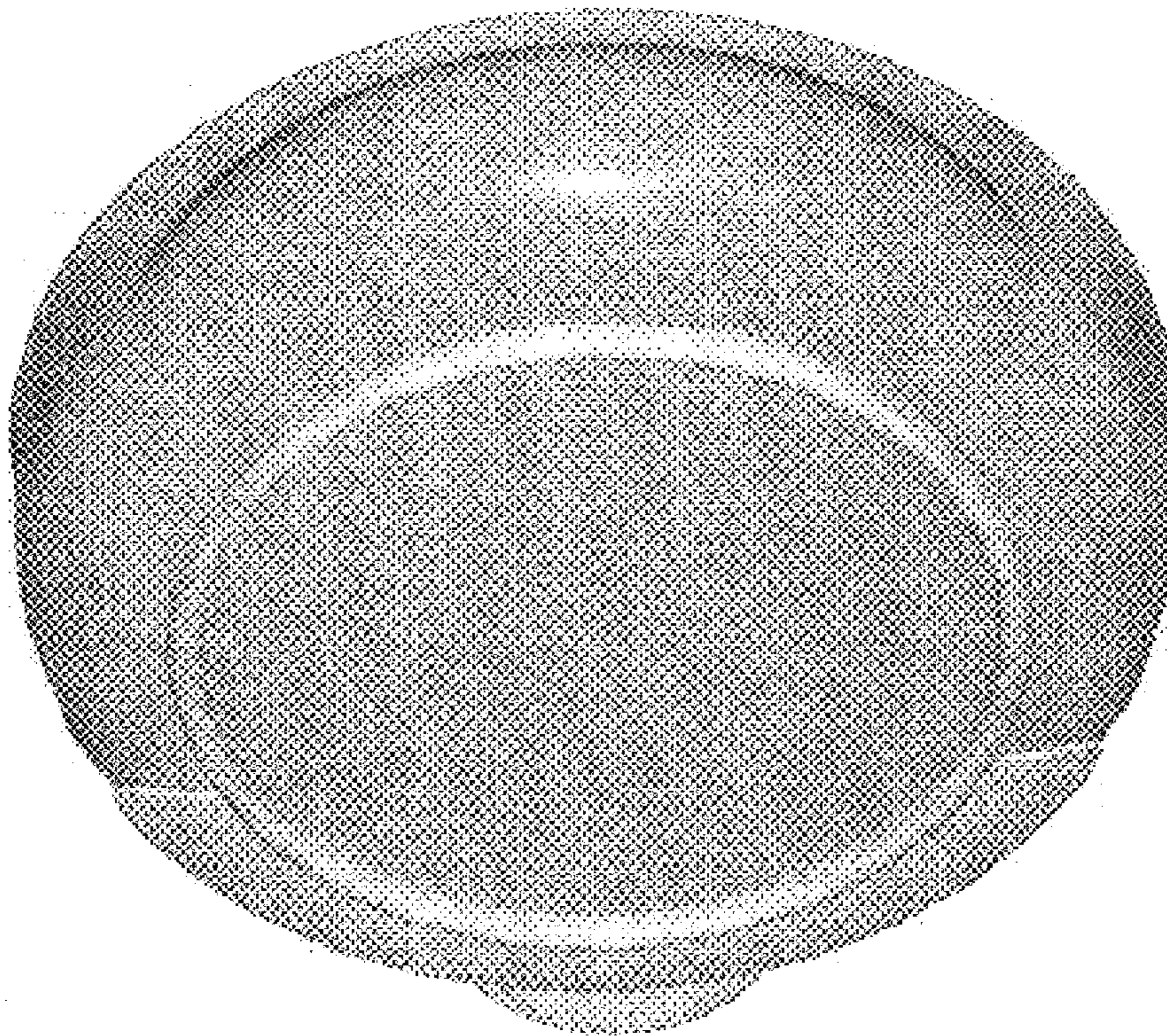

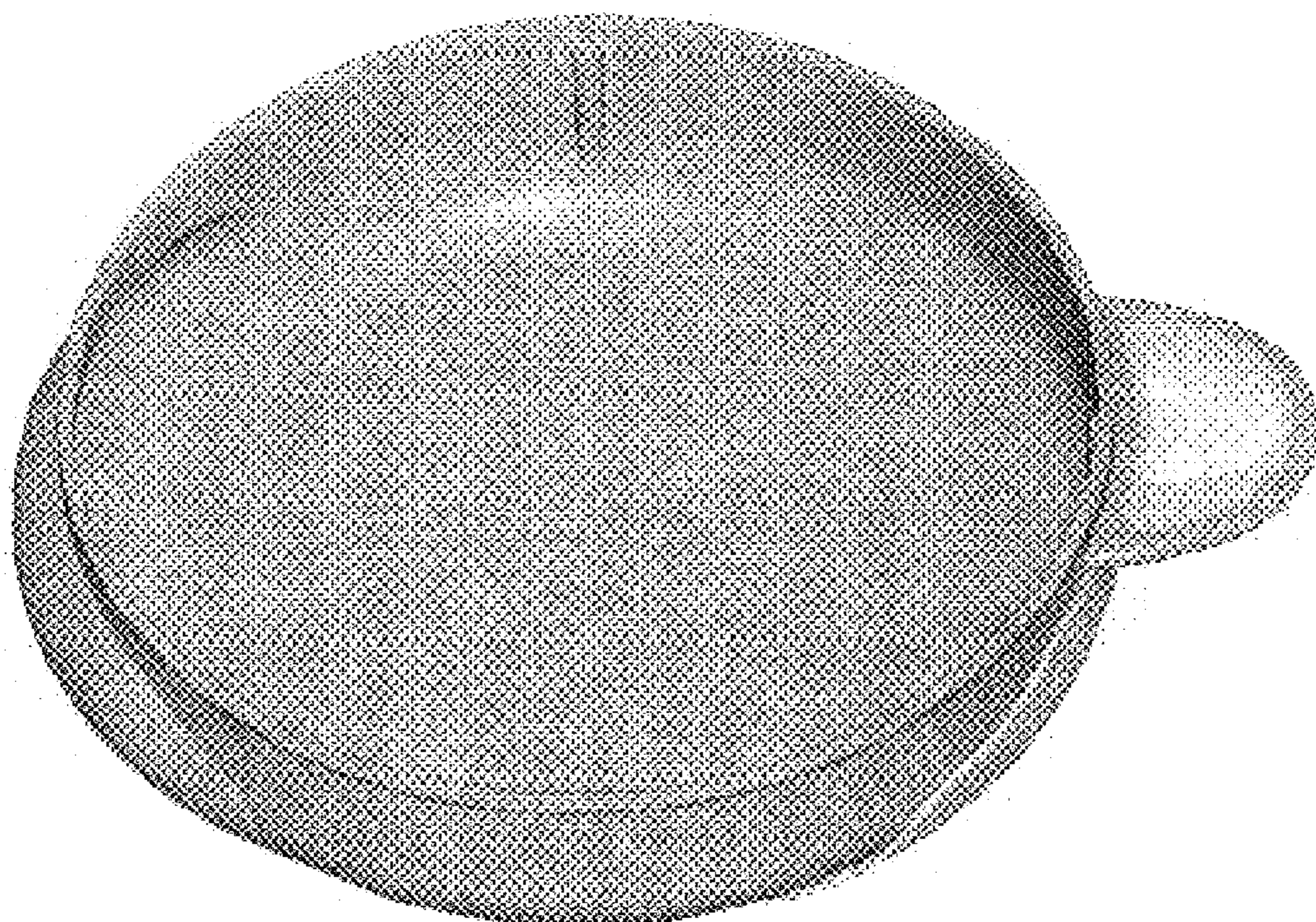

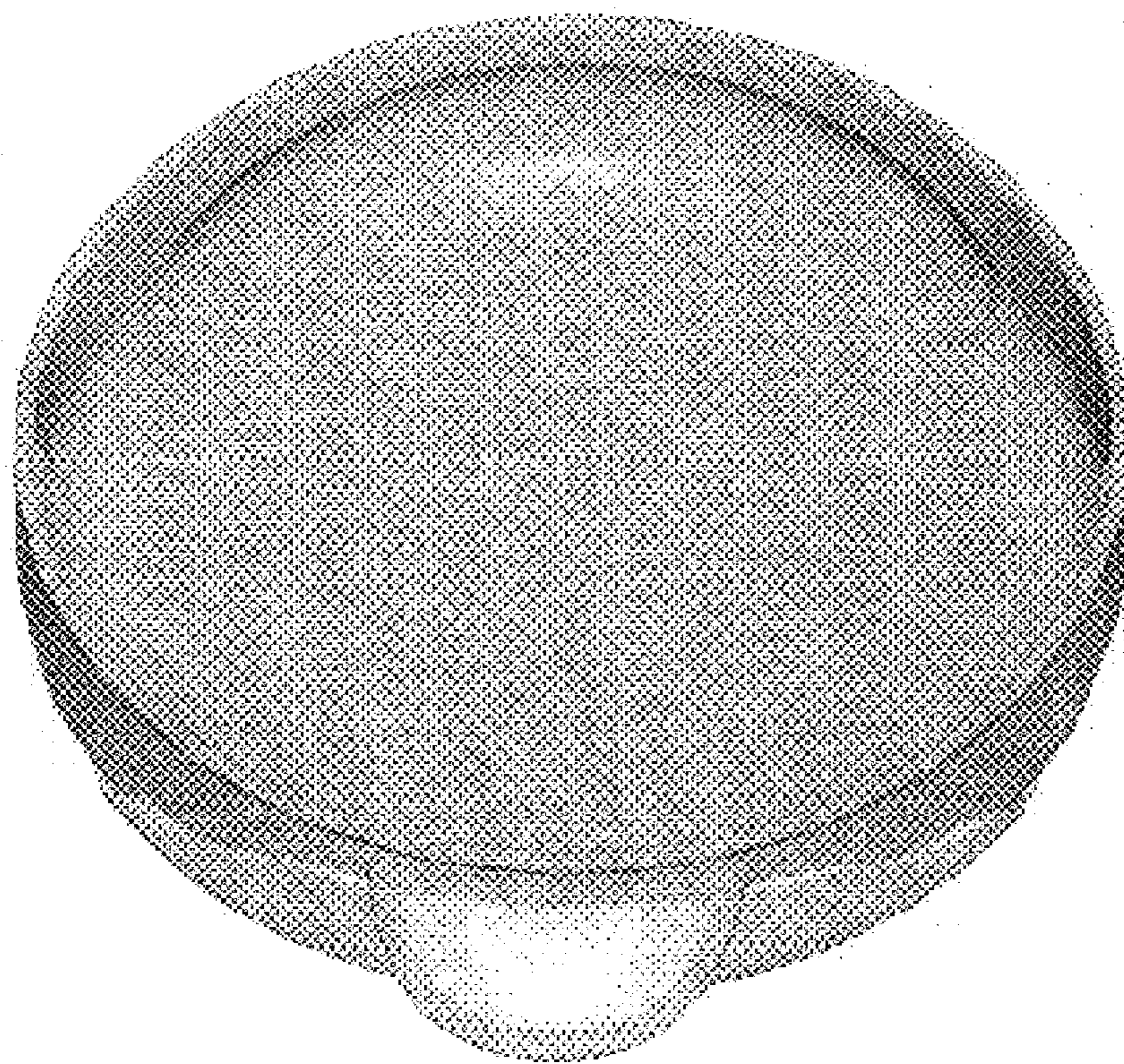

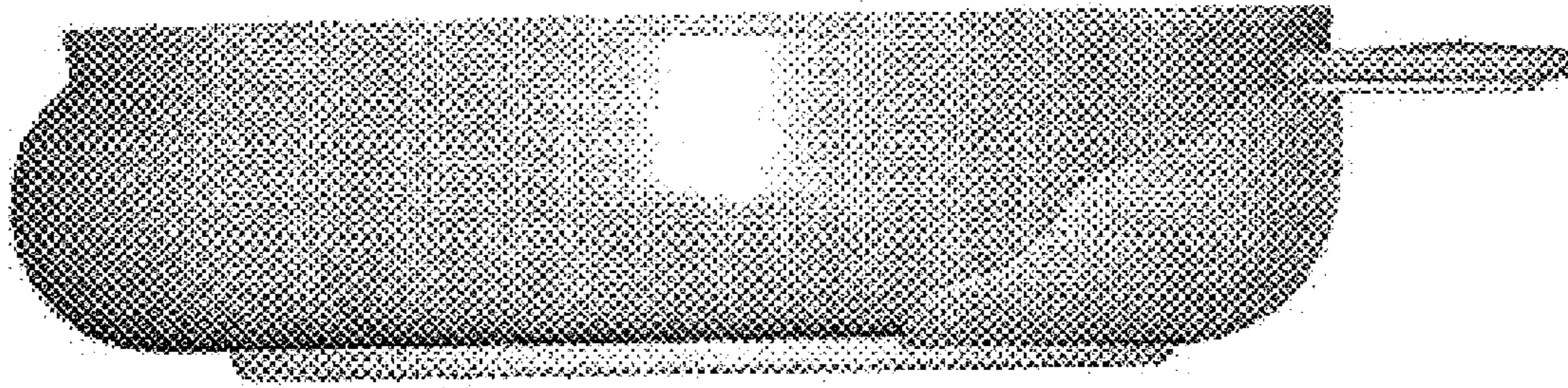

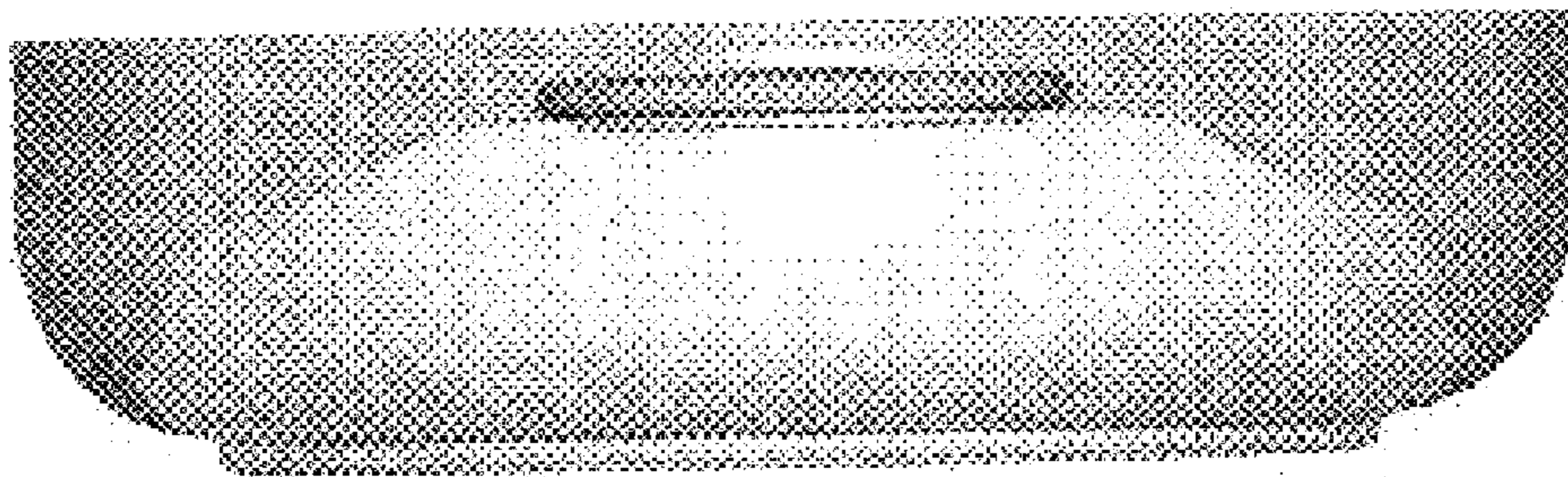

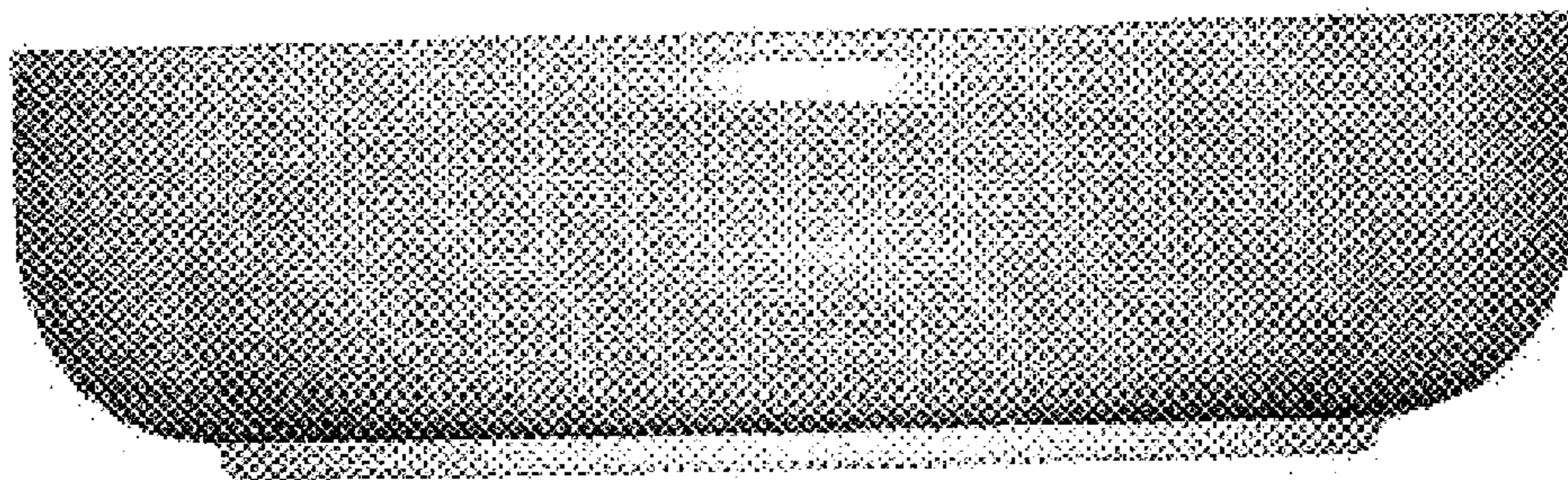

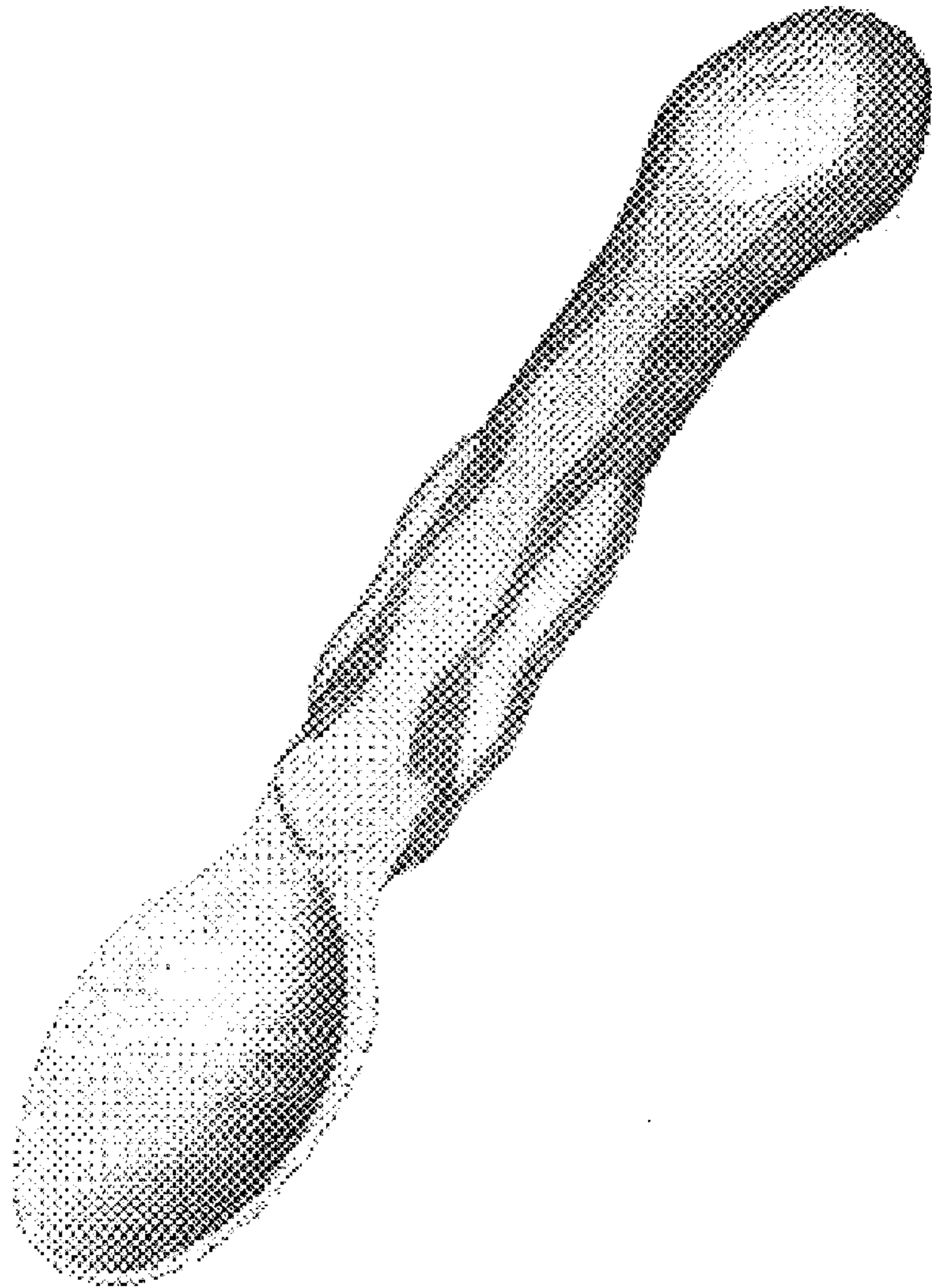

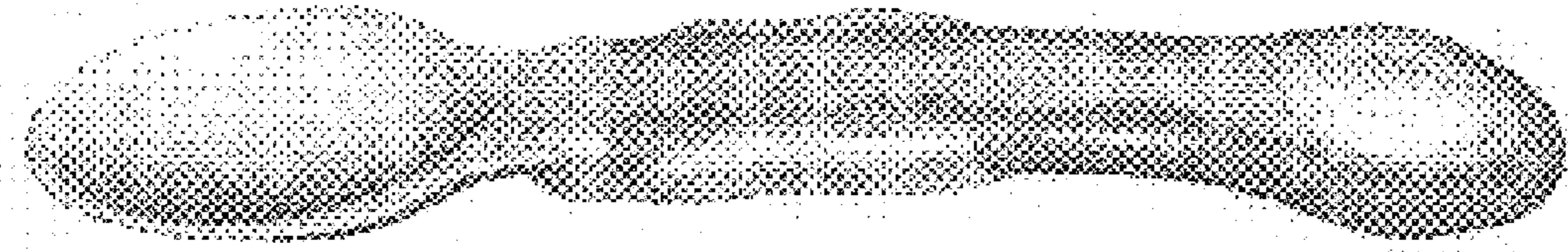

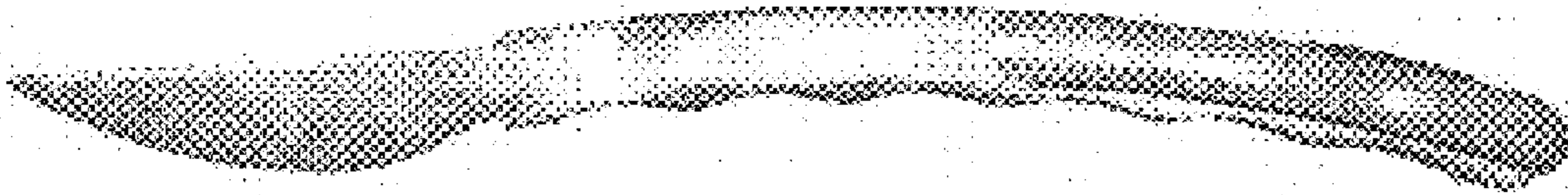

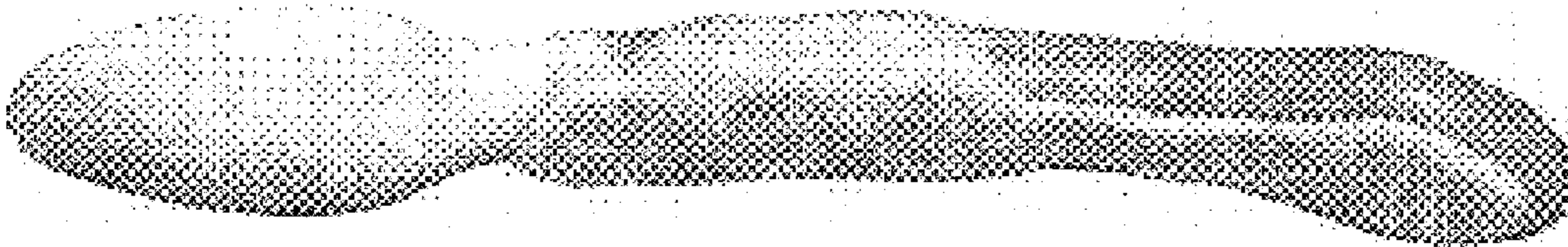

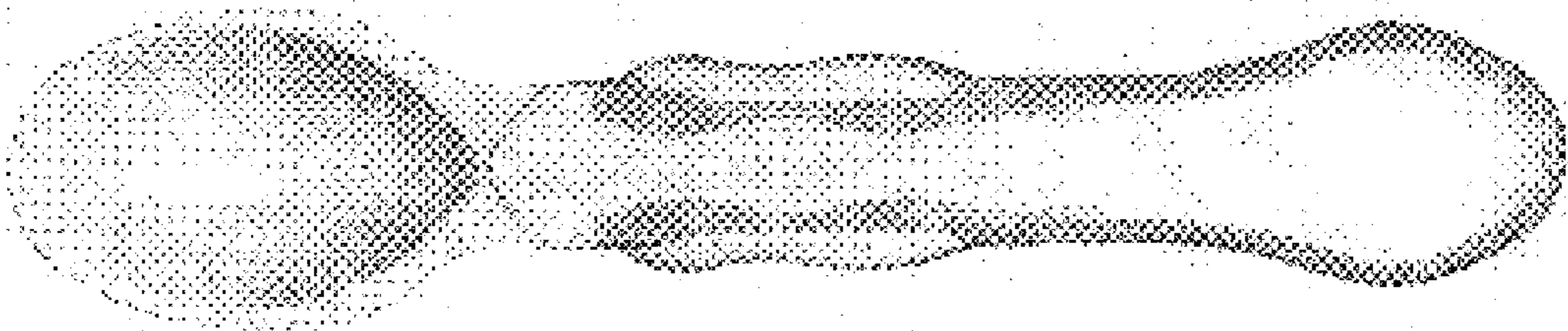
