The ornamental design for a wire management grommet, as shown and described.

**DESCRIPTION**

FIG. 1 is a downward looking isometric view of the wire management grommet showing the new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a bottom plan view thereof;

FIG. 4 is a right side elevation view thereof;

FIG. 5 is a front elevation view thereof;

FIG. 6 is a left side elevation view thereof; and,

FIG. 7 is a rear elevation view thereof.

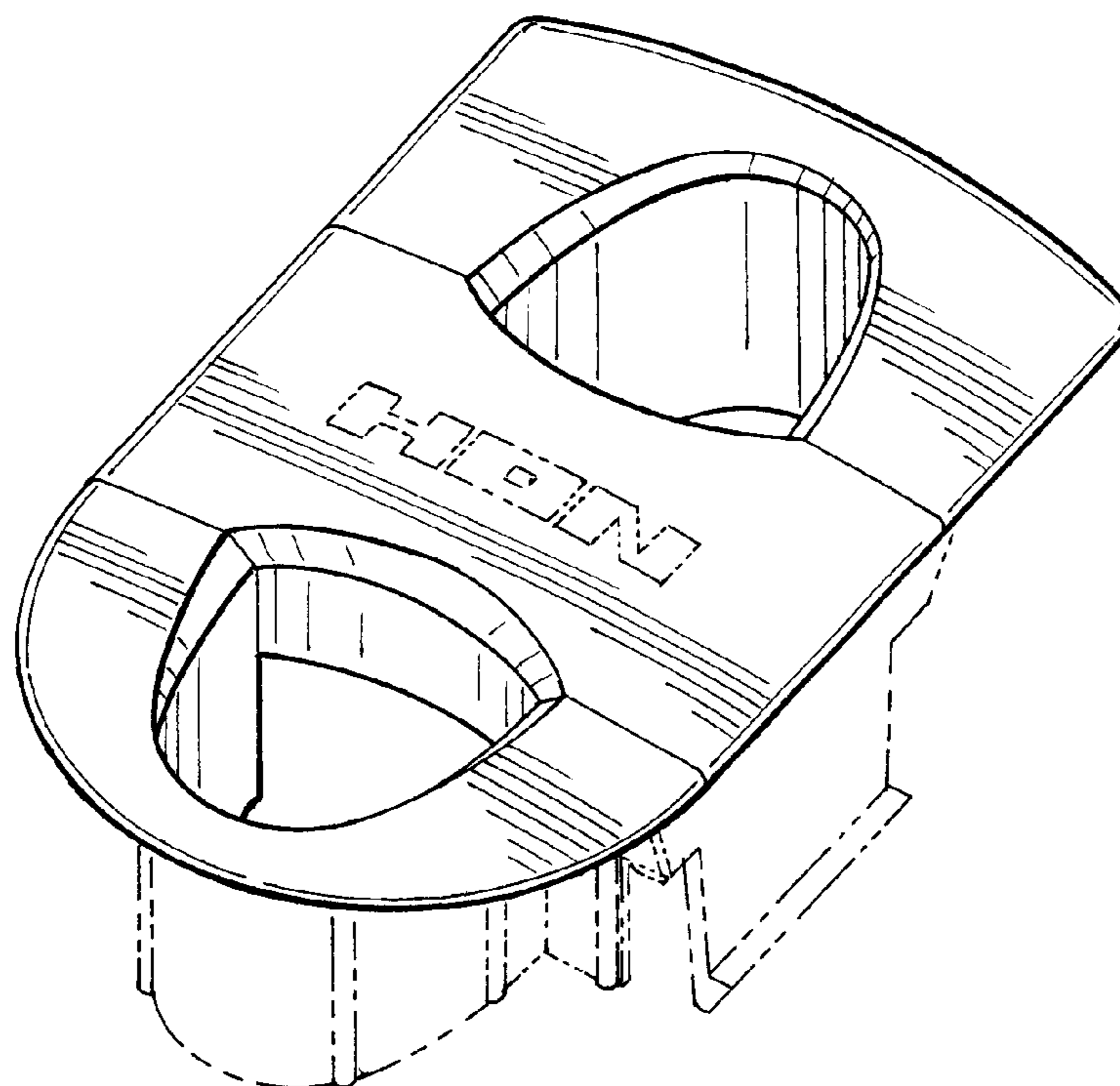

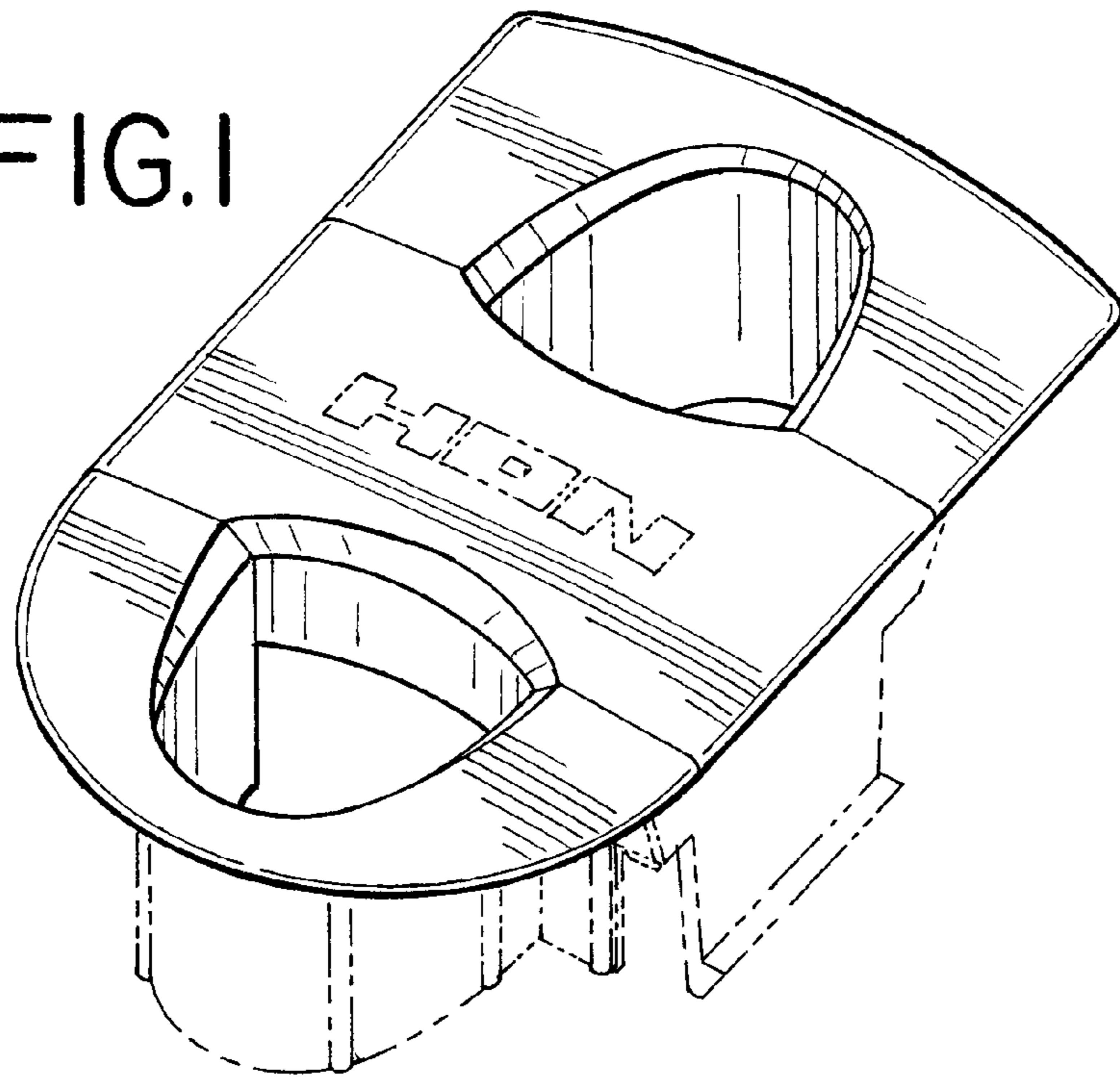

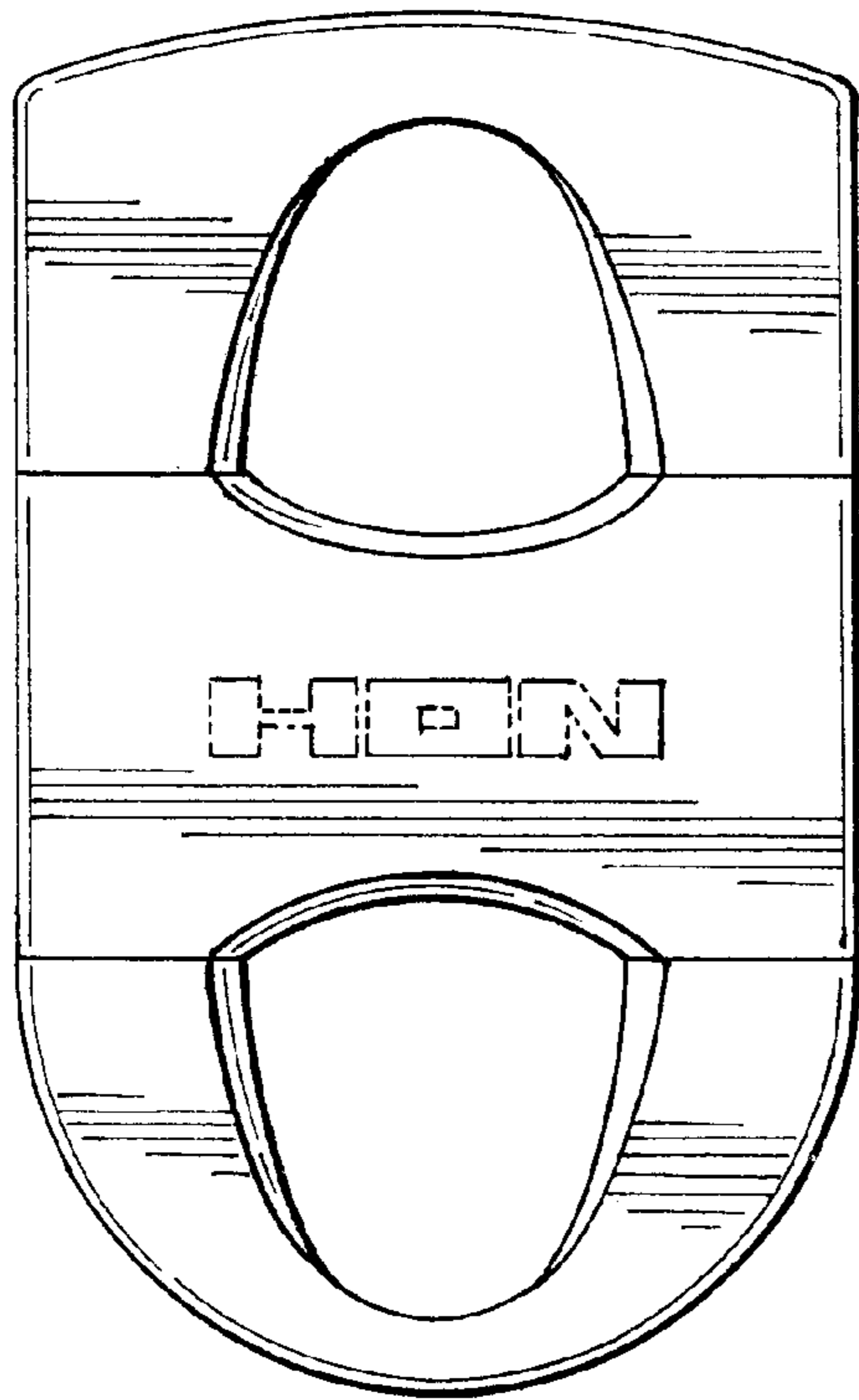

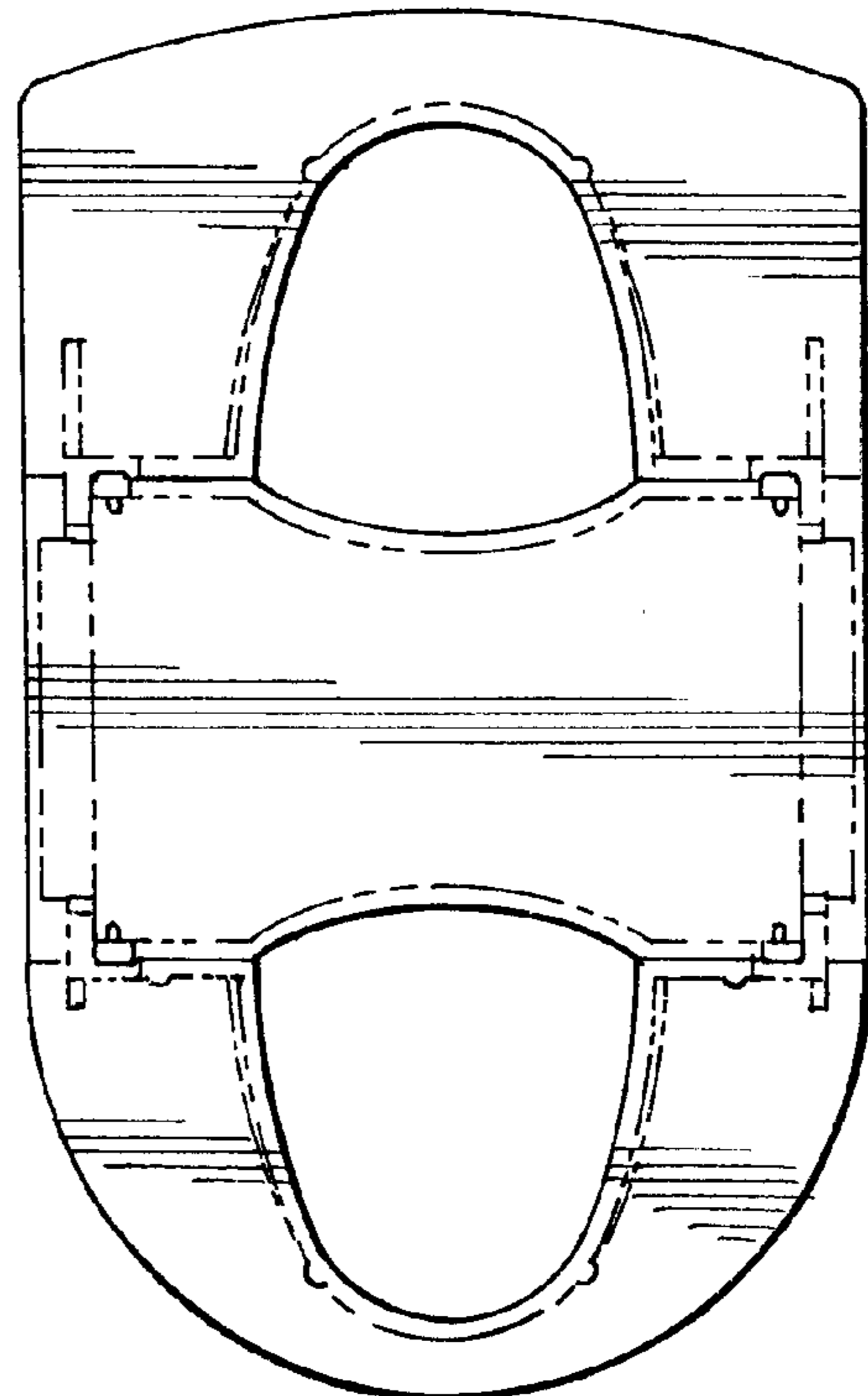

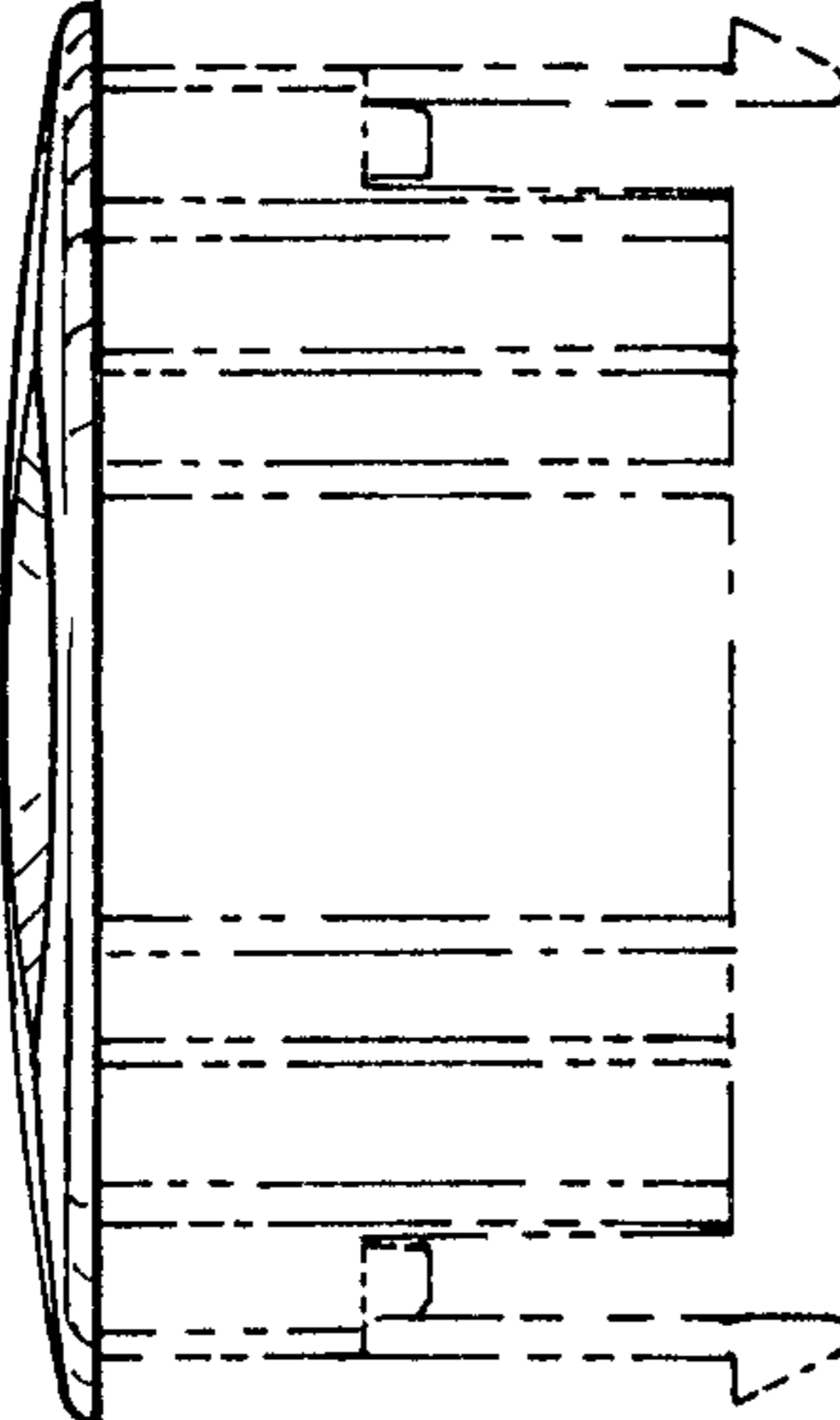

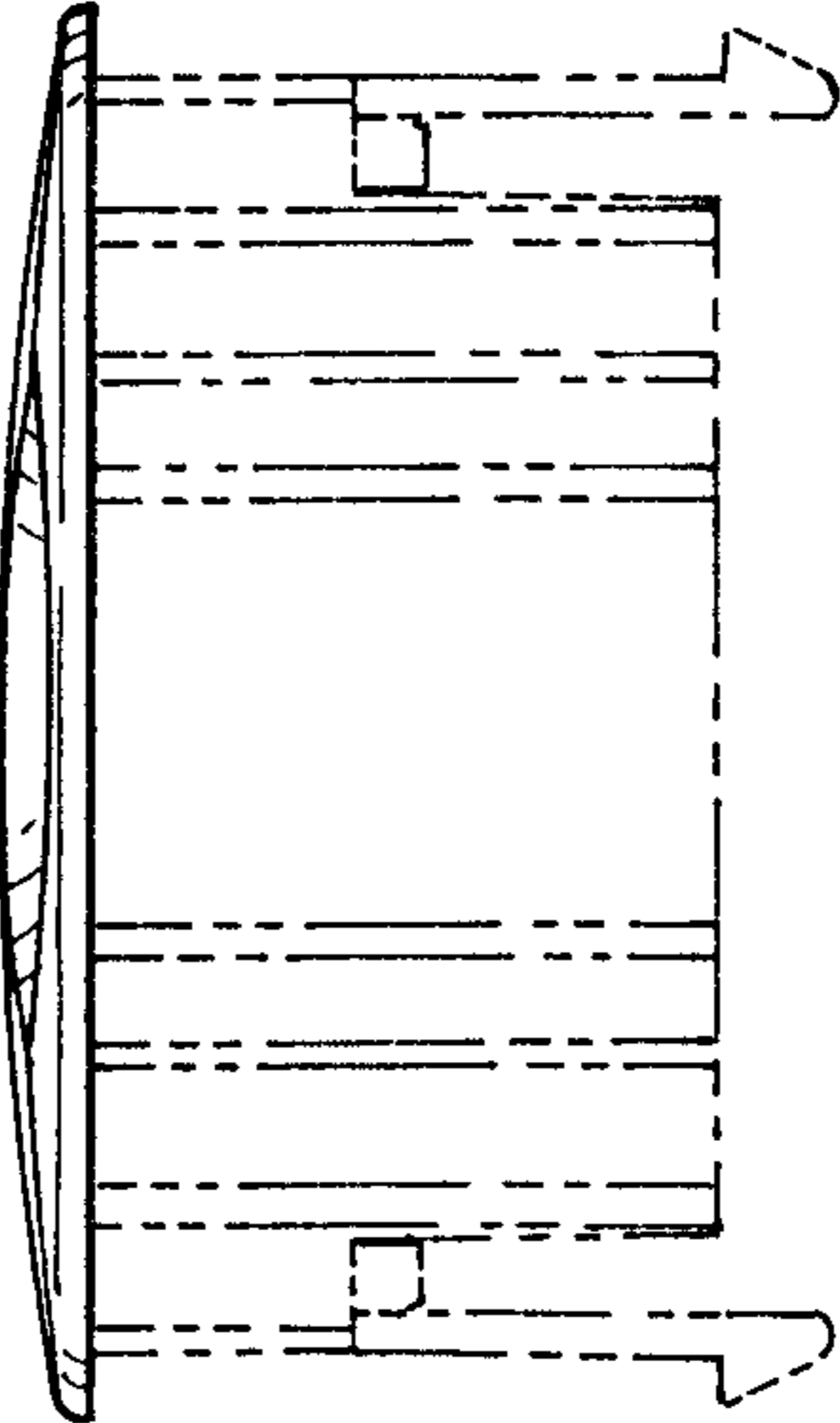

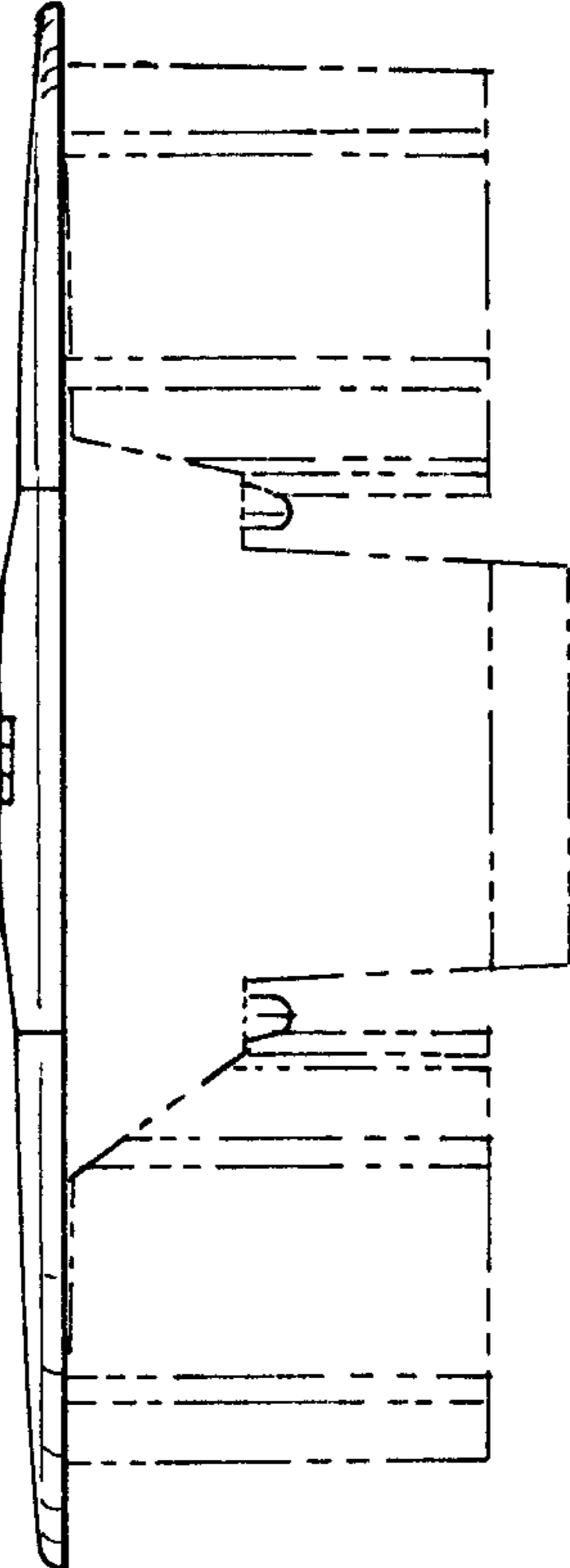
