(57) **CLAIM**

The ornamental design for a faceted diamond, as shown and
described.

DESCRIPTION

FIG. 1 is a top view of a gemstone facet configuration in
accordance with the present invention.

FIG. 2 is a side view of the faceted gemstone of FIG. 1.

FIG. 3 is a bottom view of the faceted gemstone of FIG. 1.

FIG. 4 is a top view of the gemstone as shown in FIG. 1 and
including faceting lines from the bottom view which are
reflected through the transparent gemstone to the top view.

FIG. 5 is a perspective view of the gemstone of the present
invention with the table of the gemstone tilted towards the
viewer; and,

FIG. 6 is a perspective of the gemstone of the present
invention with the table tilted slightly away from the viewer.

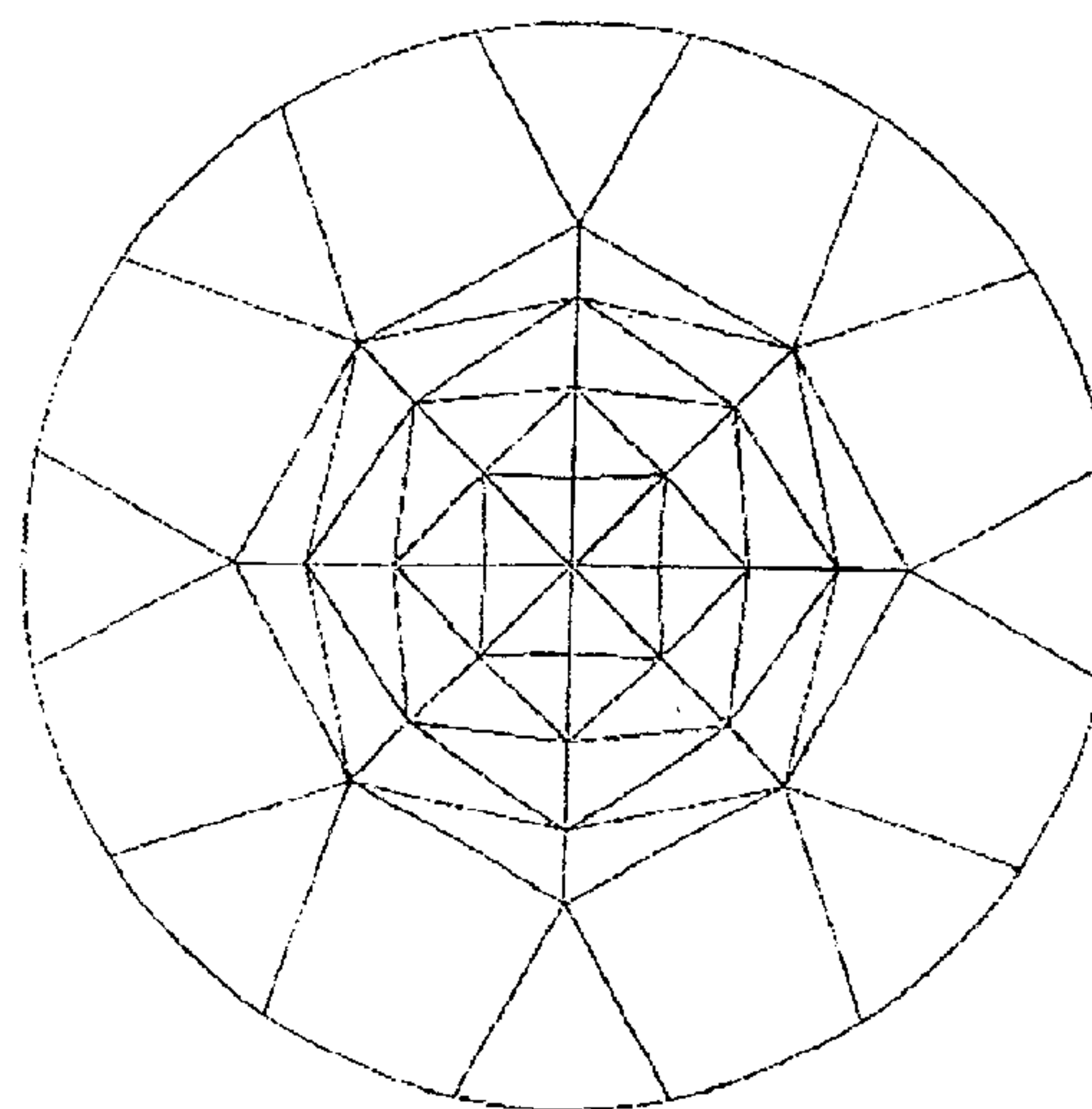
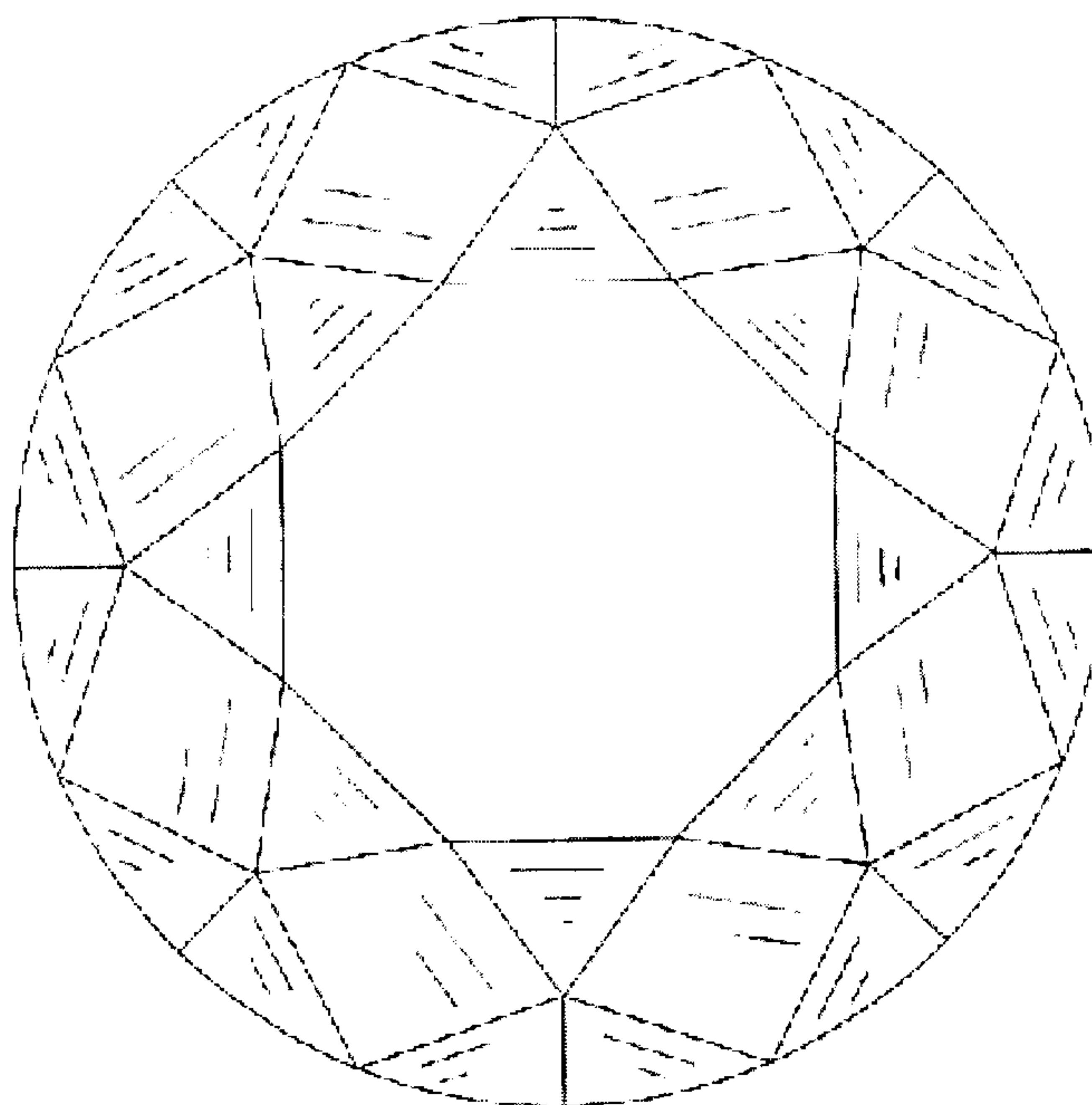

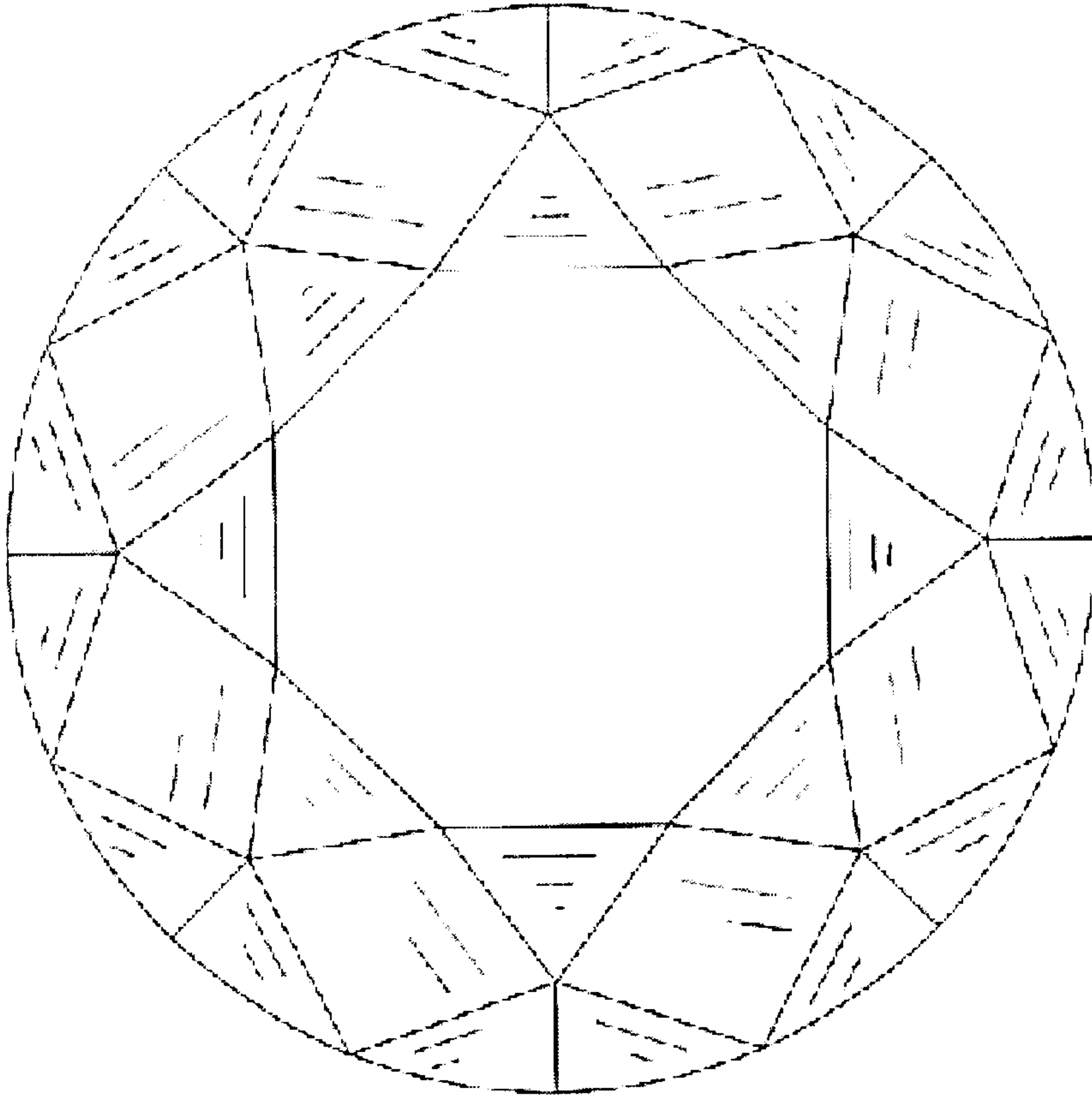

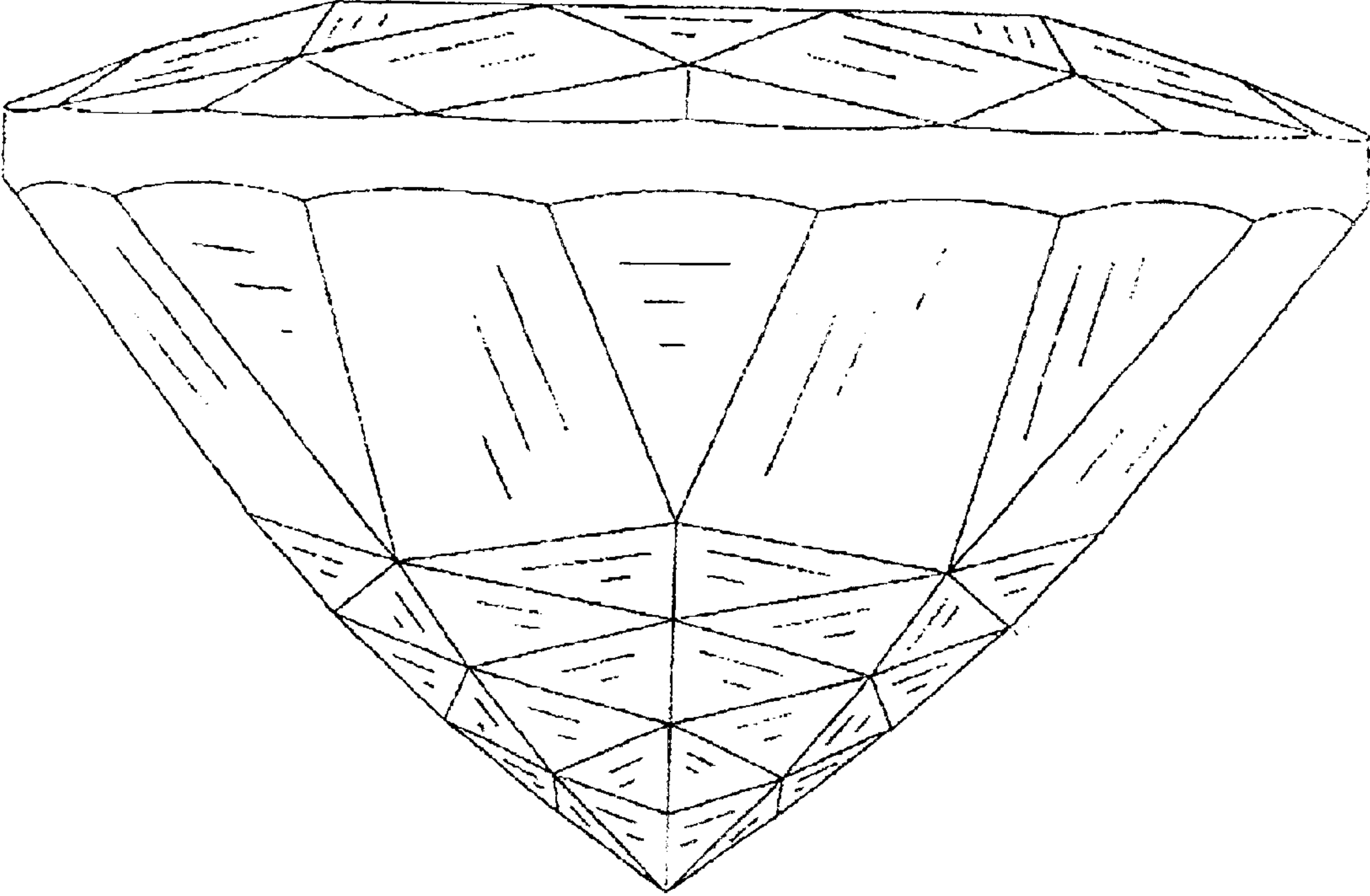

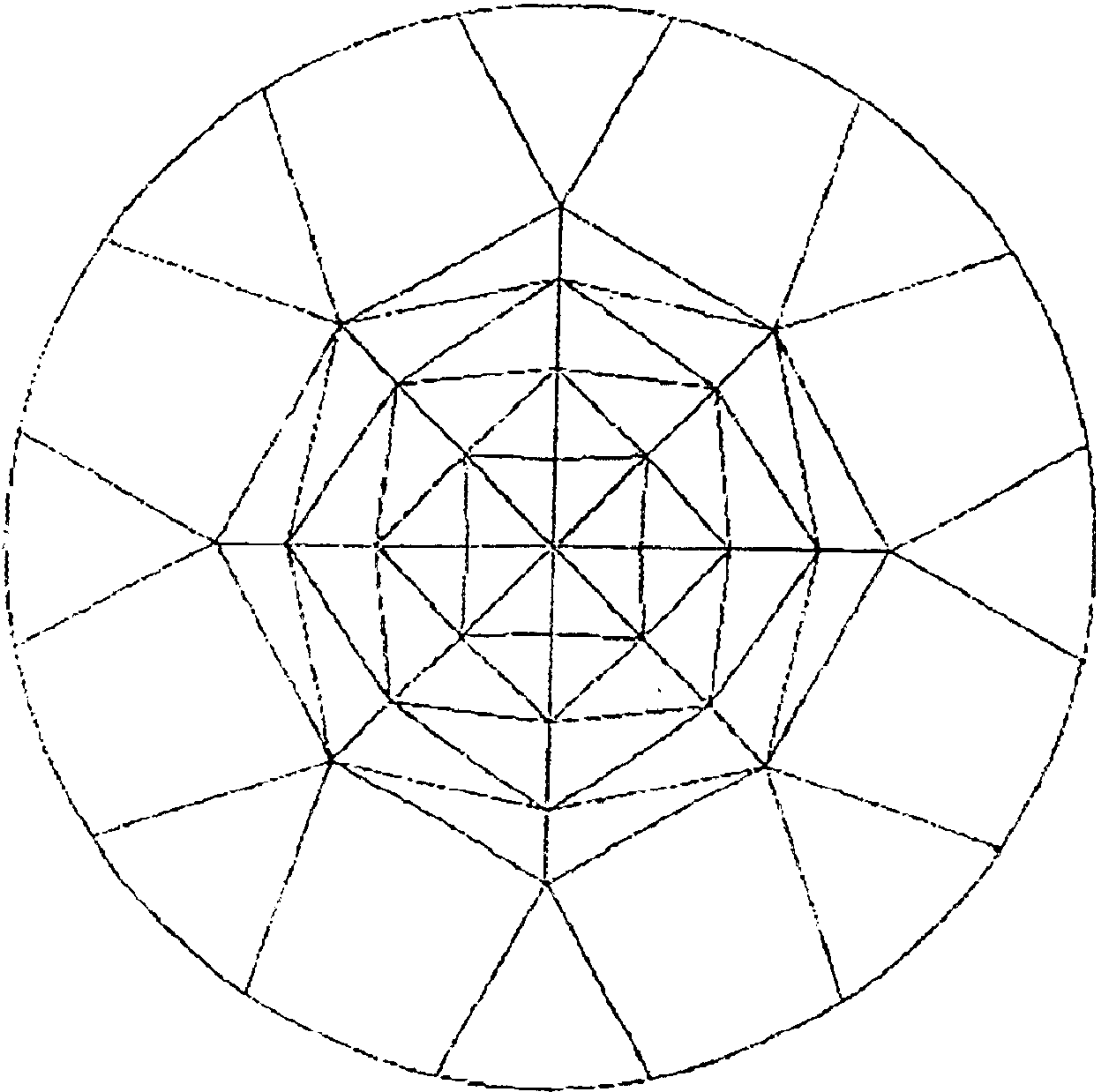

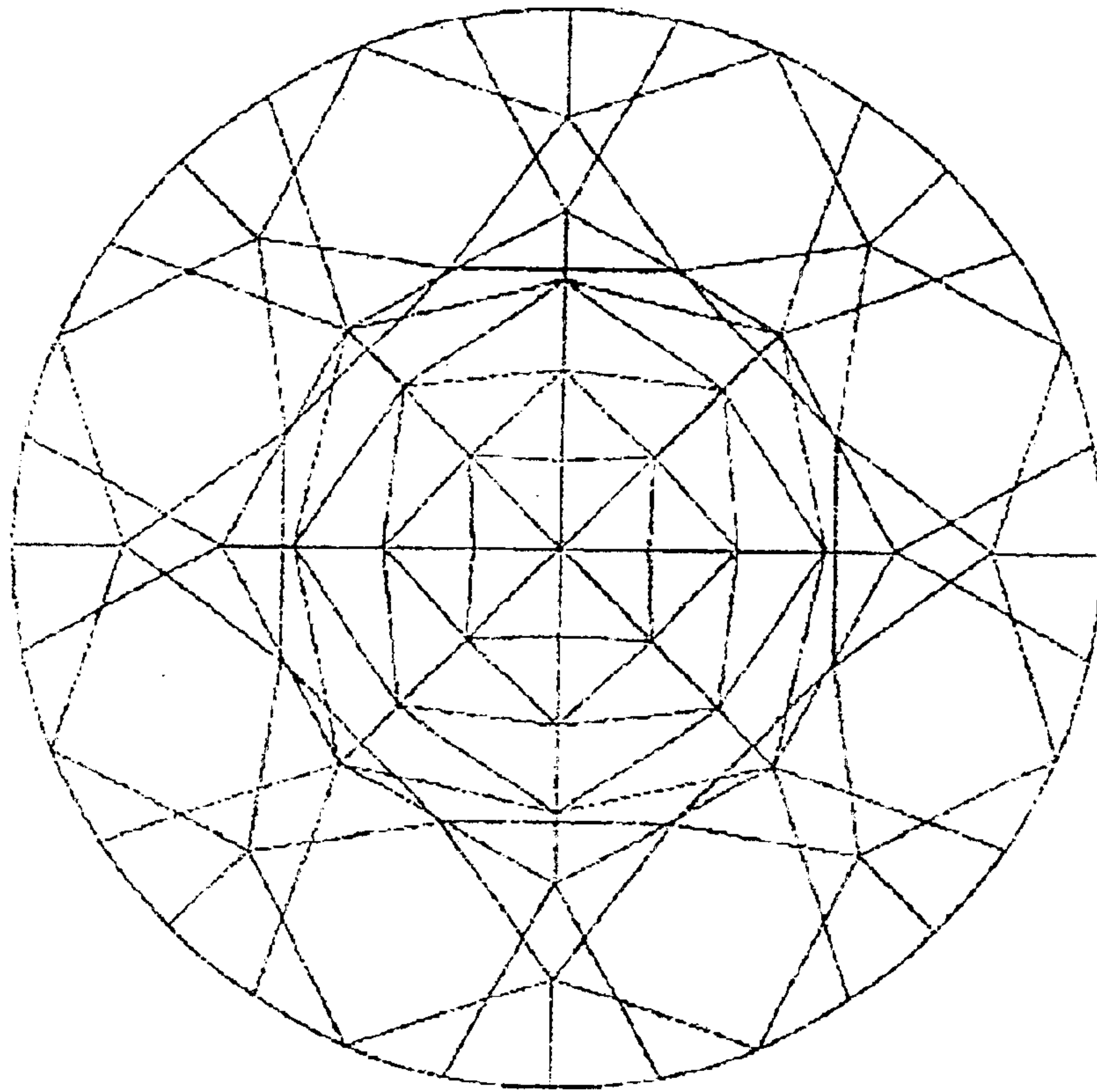

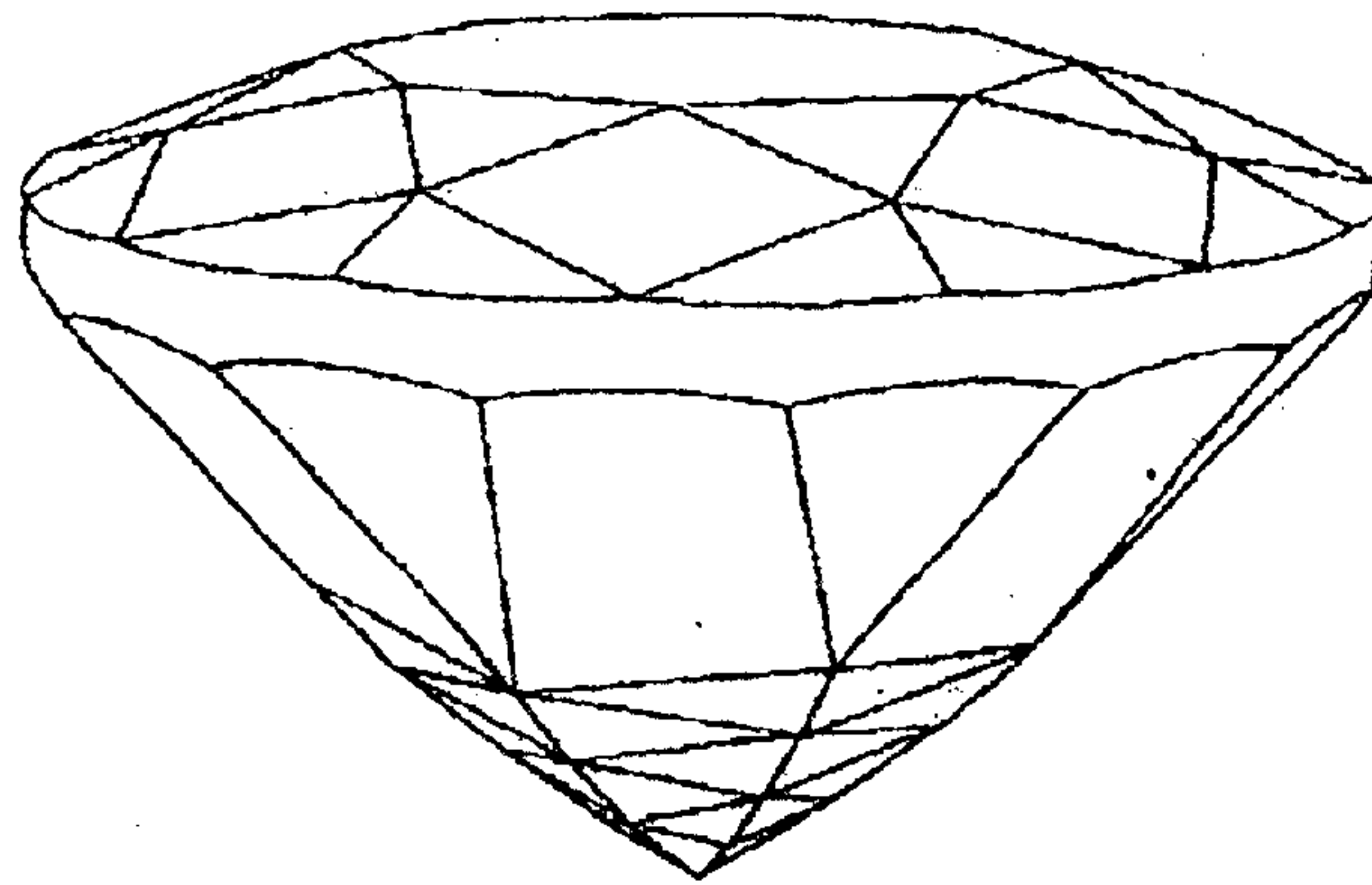
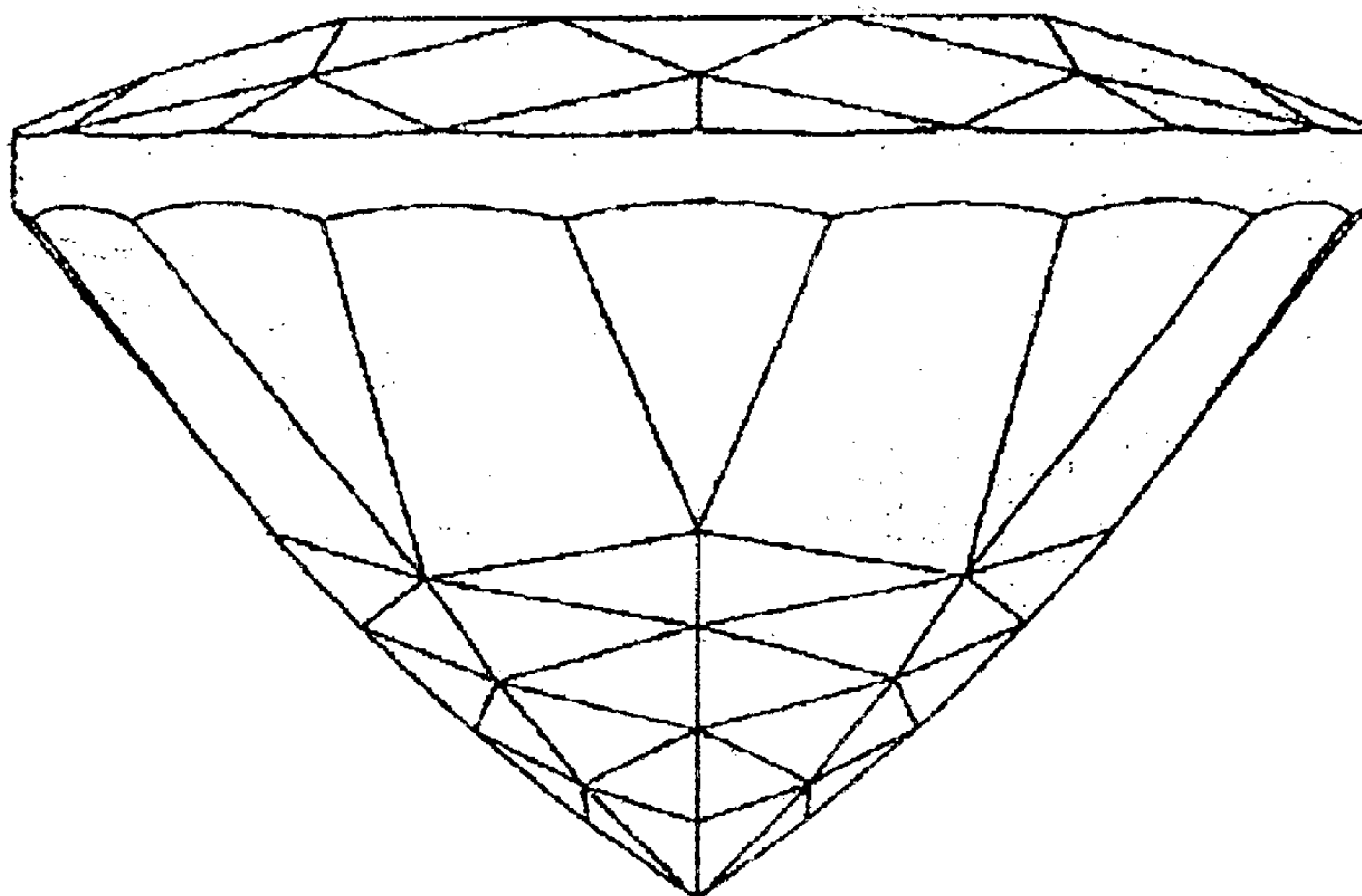
