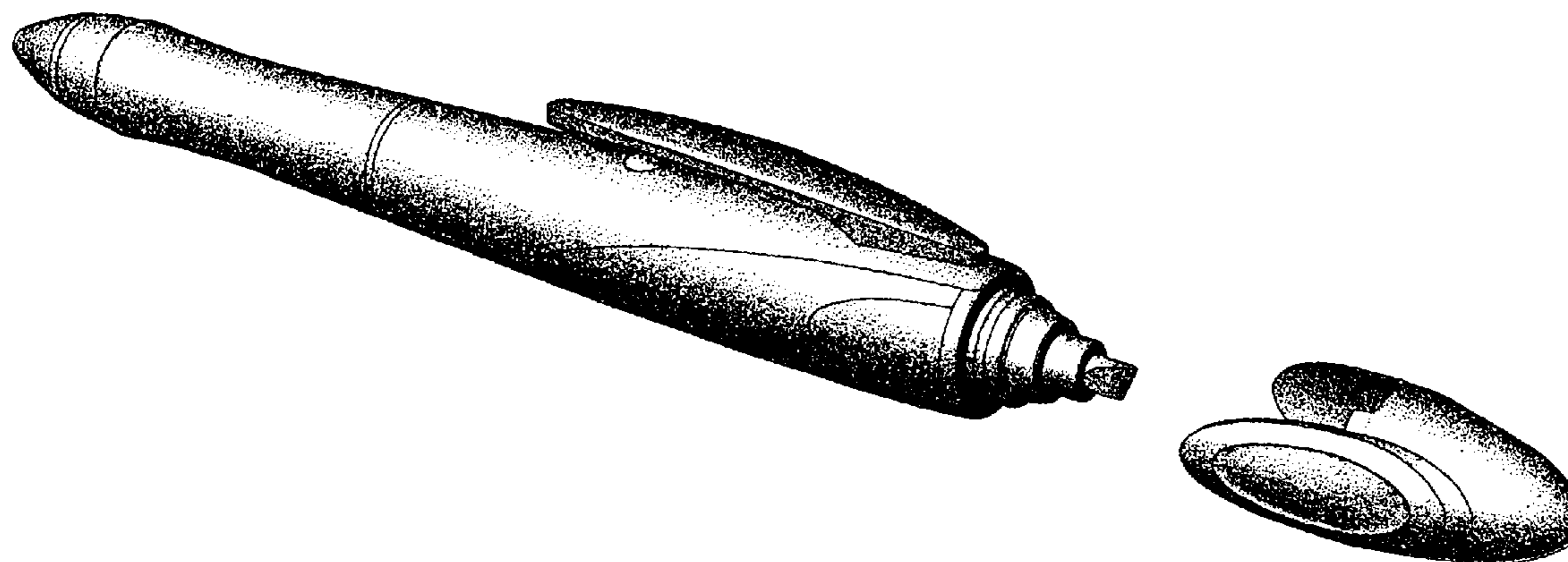
(57) **CLAIM**

The ornamental design for a “writing instrument,” as shown  
and described.

**DESCRIPTION**

FIG. 1 is a left side perspective view taken from the side and  
below showing our new design;  
FIG. 2 is a left side elevational view, the right side eleva-  
tional view being a mirror image thereof;  
FIG. 3 is a front elevational view thereof;  
FIG. 4 is a rear elevational view thereof;  
FIG. 5 is a bottom view thereof; and  
FIG. 6 is a plan view thereof; and,  
FIG. 7 is a perspective view taken from the side and below  
showing the cap removed from one end of the writing  
instrument.

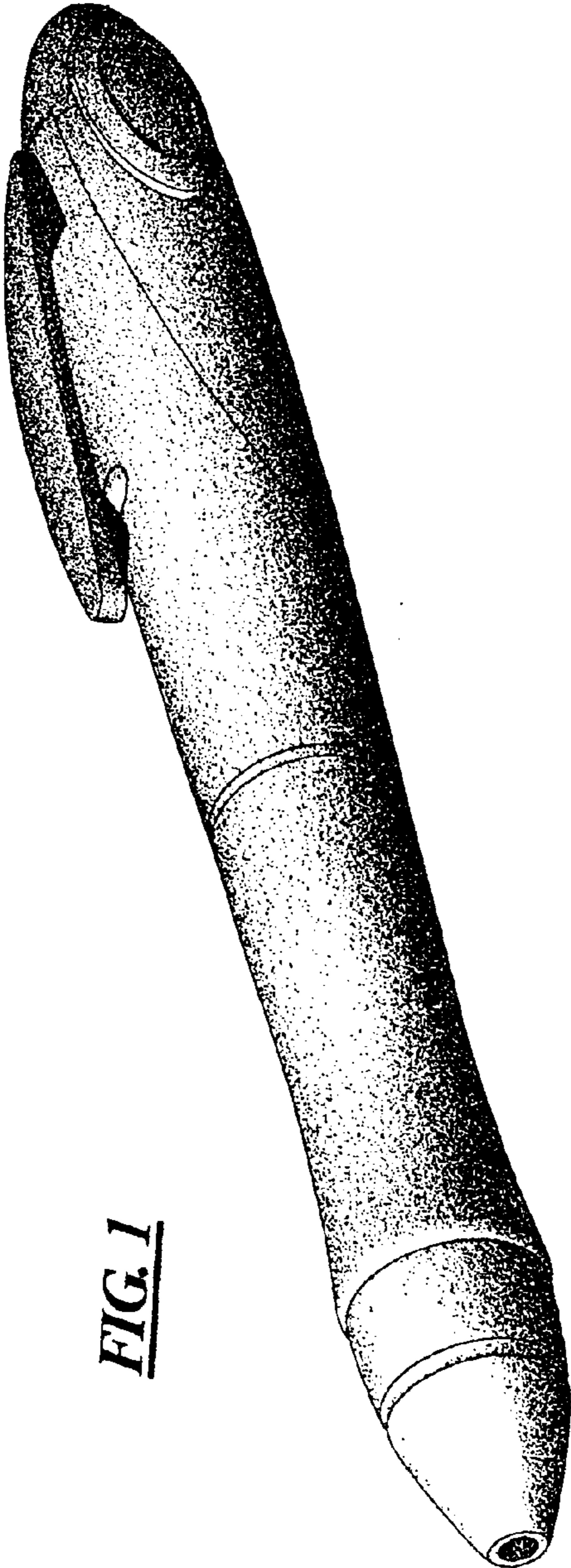

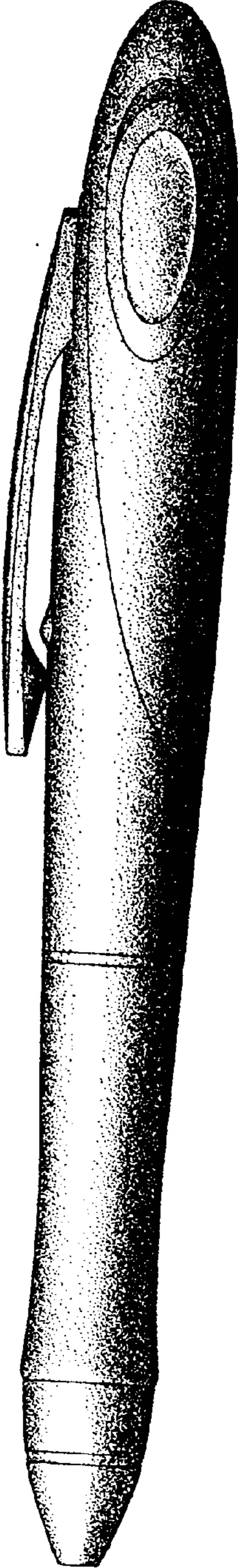

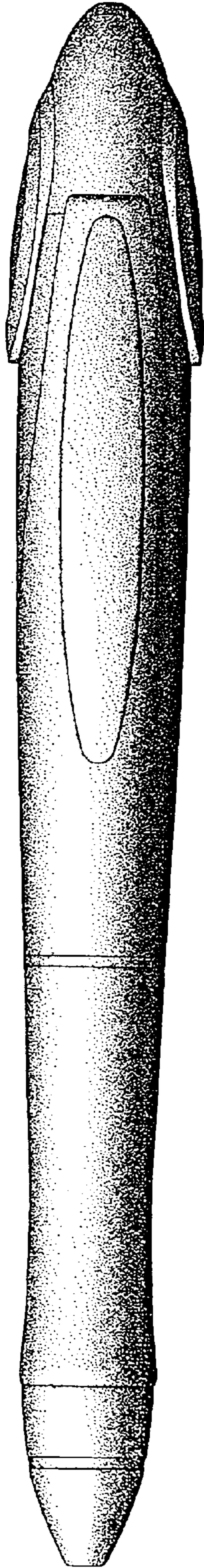

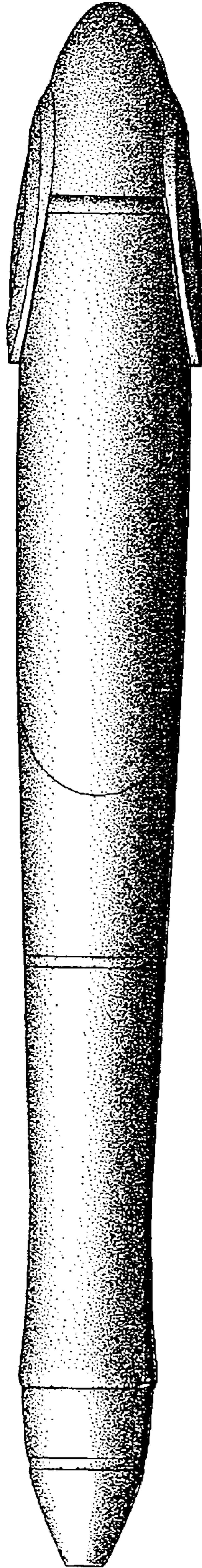

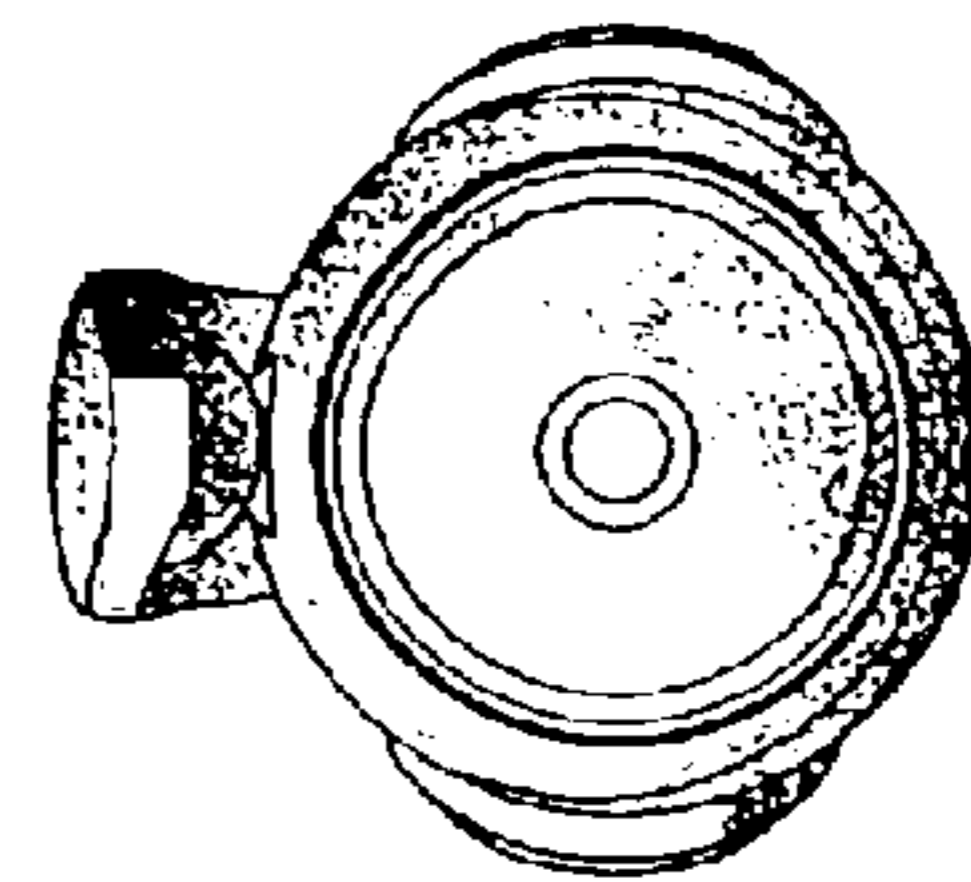
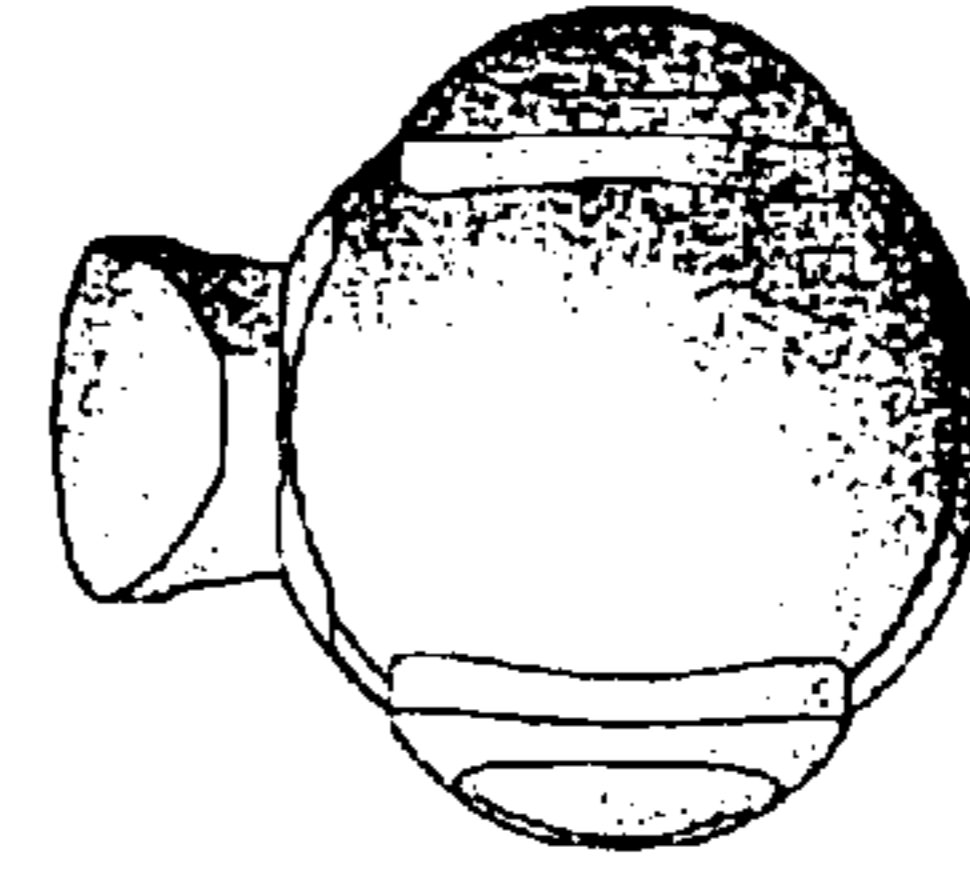
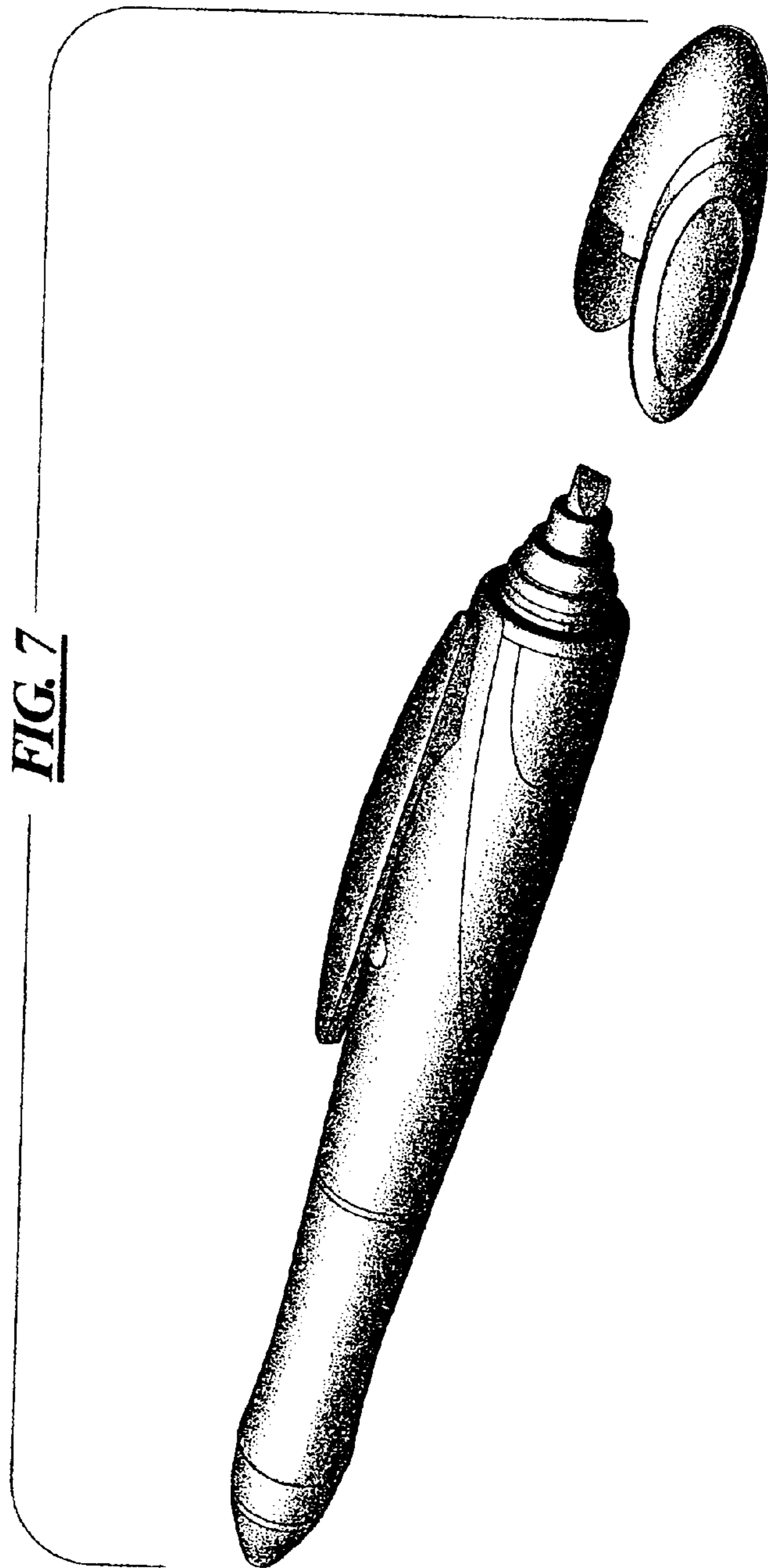
