 FIG. 7 is a left side elevational view.

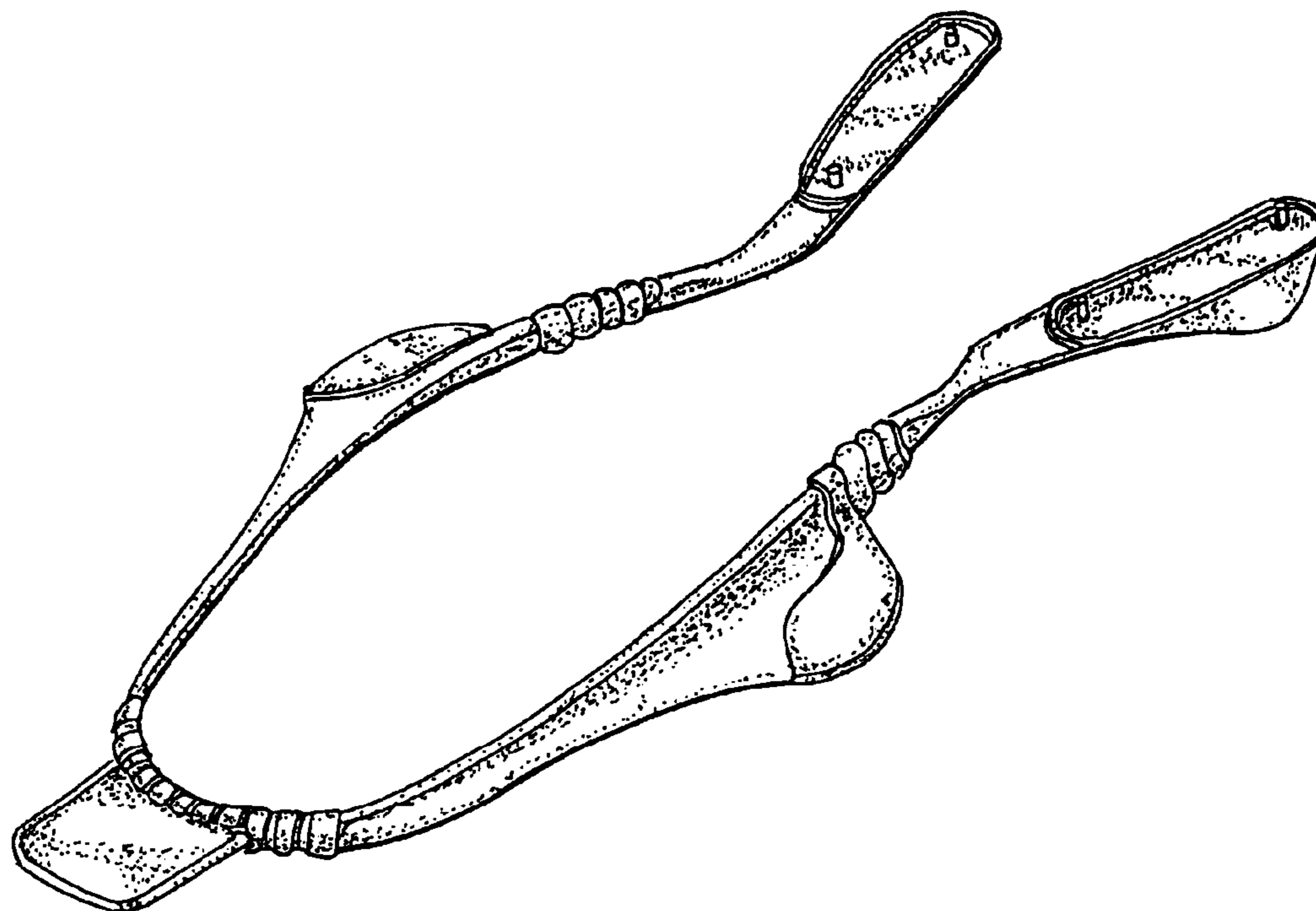
The broken line drawings of a mouthguard are for illustrative purposes only and form no part of the claimed design.

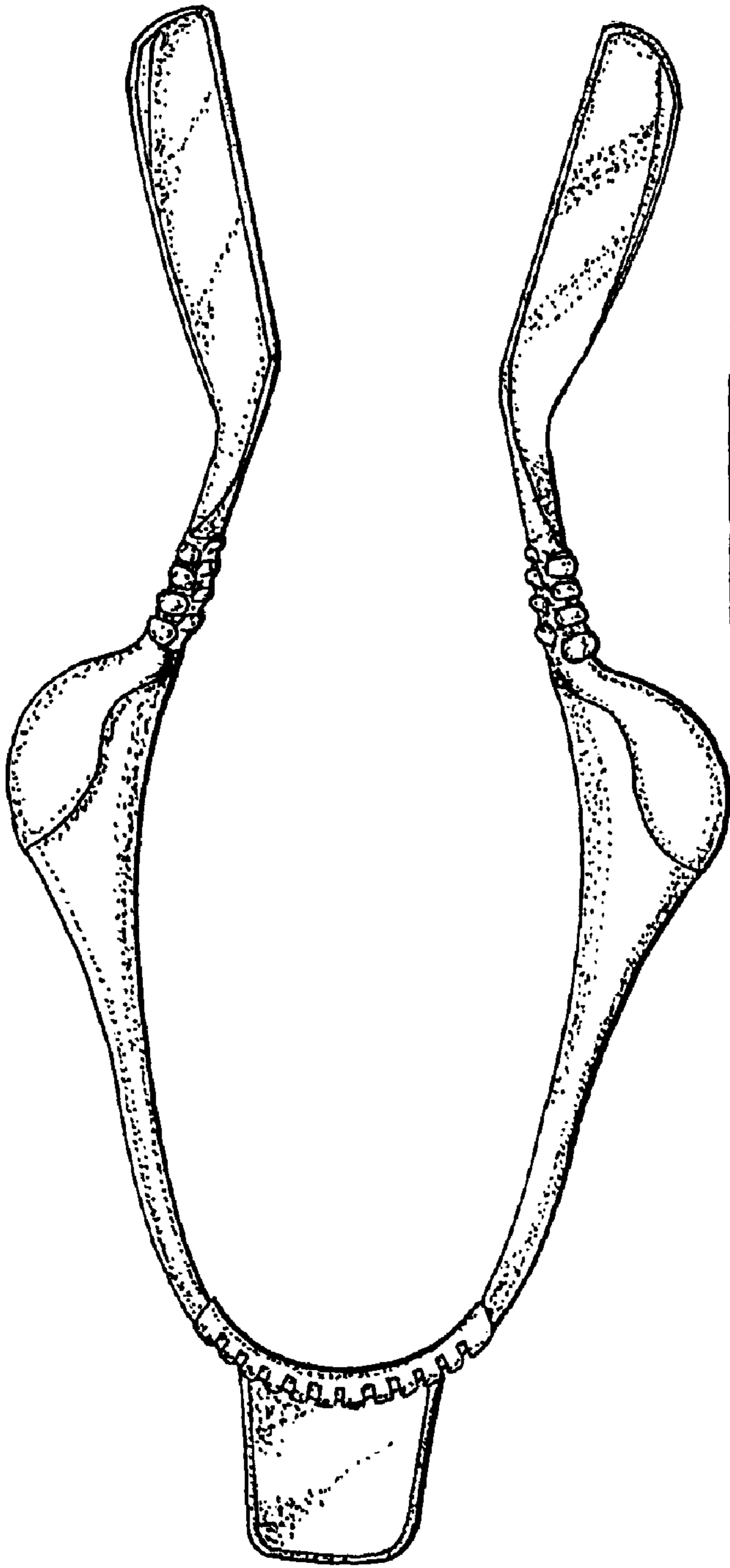

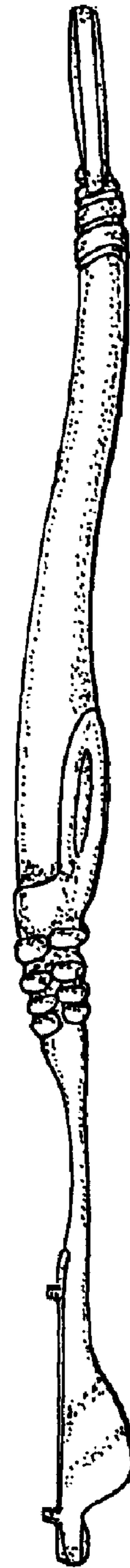

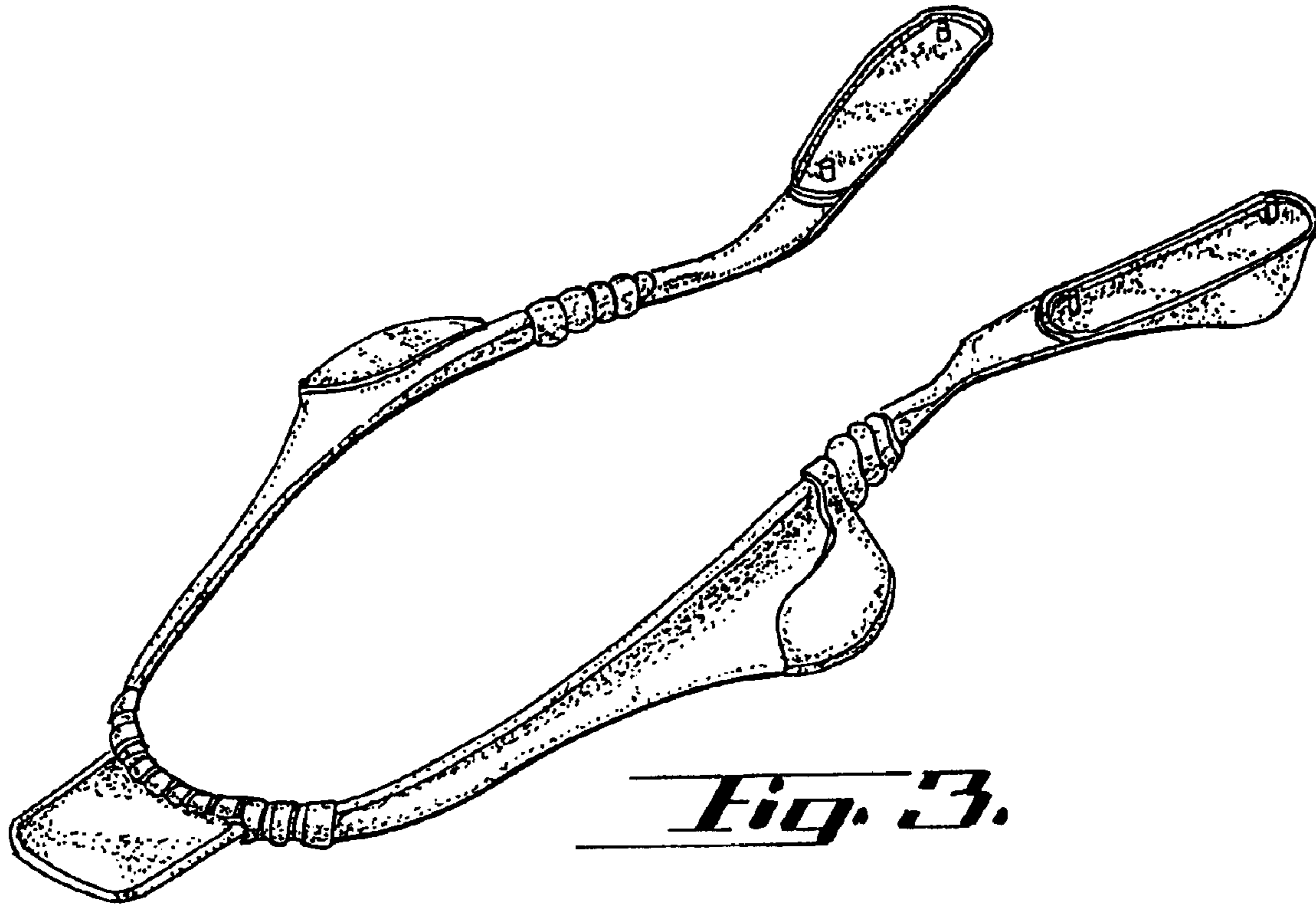

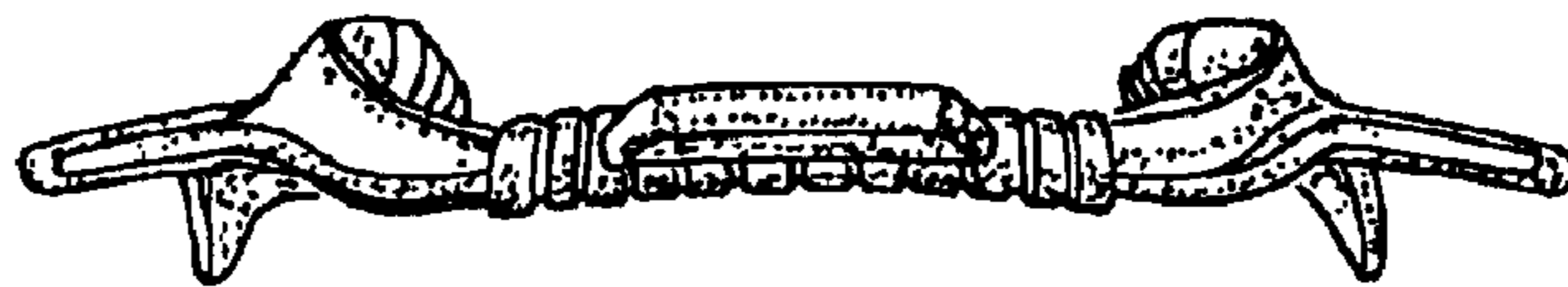

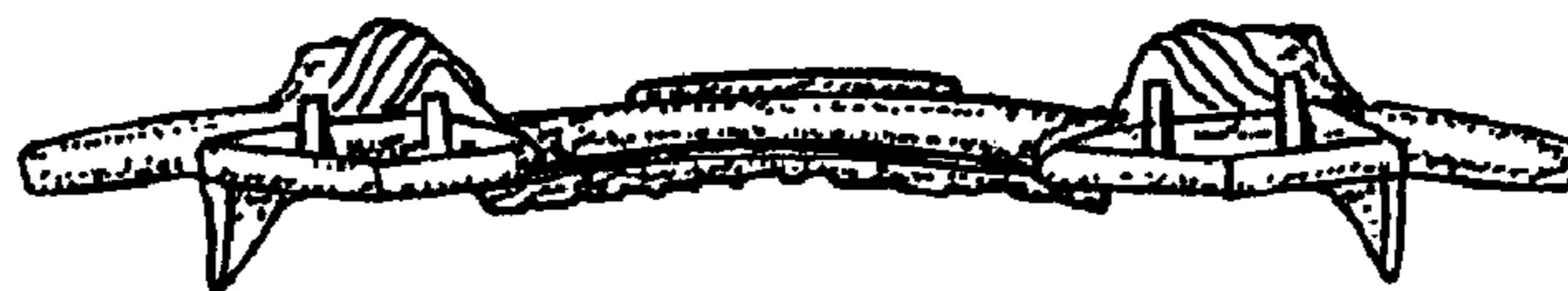

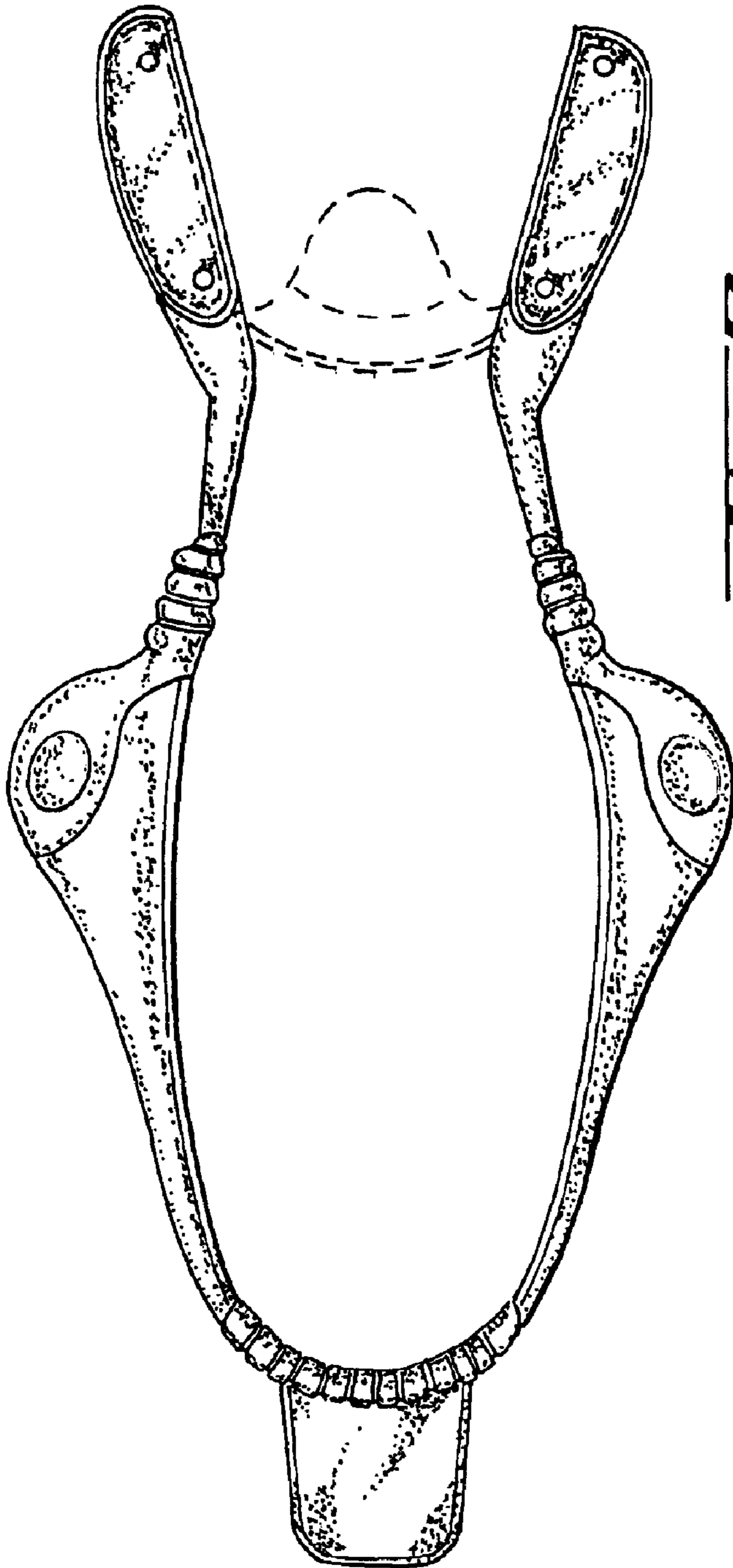

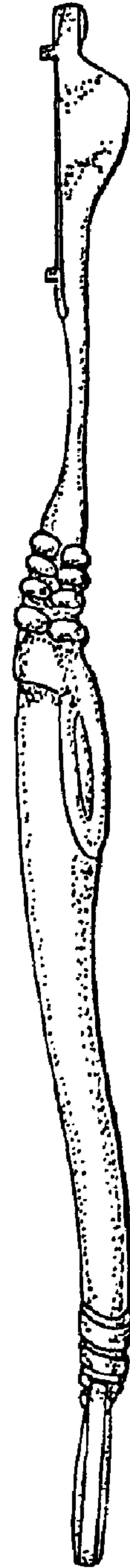
