DESCRIPTION

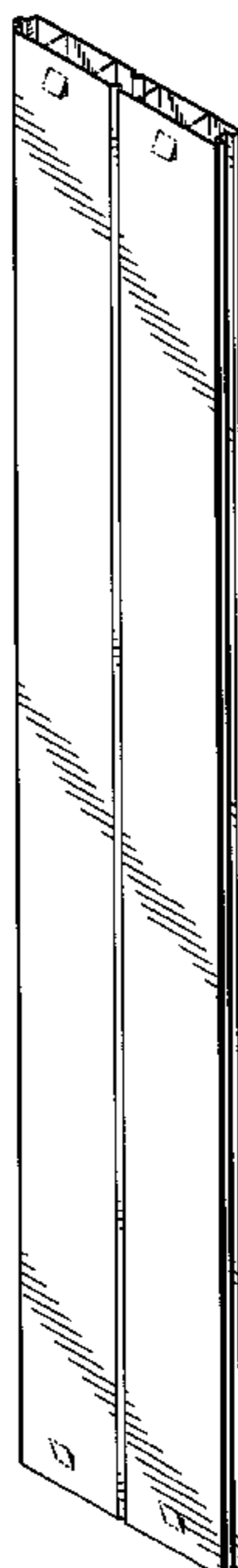
FIG. 1 is a perspective view thereof;

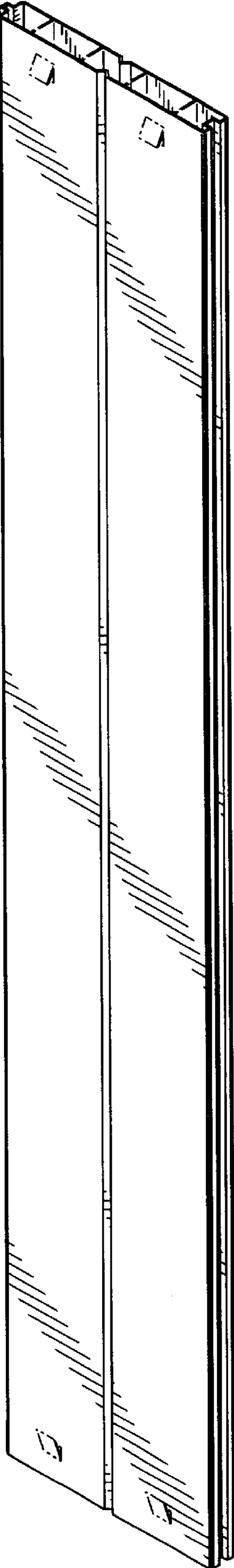

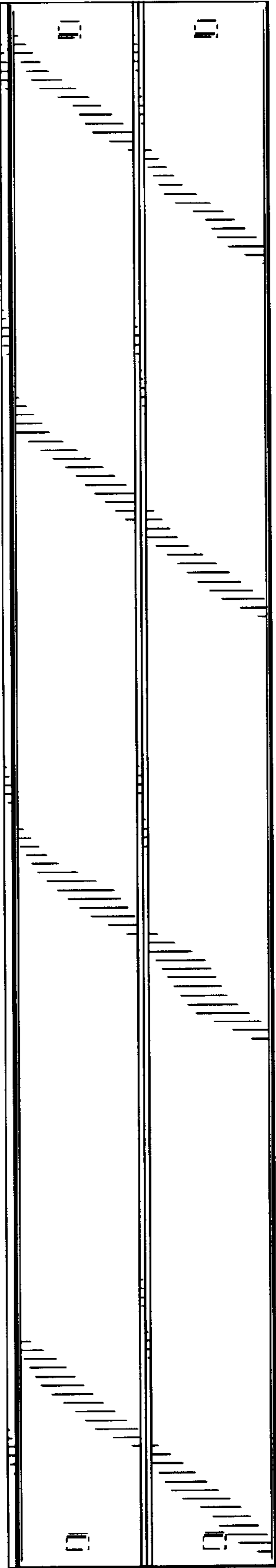

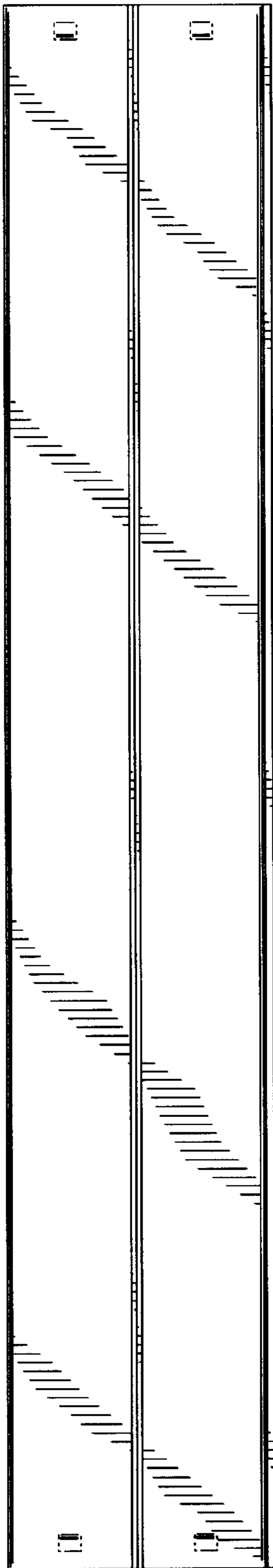

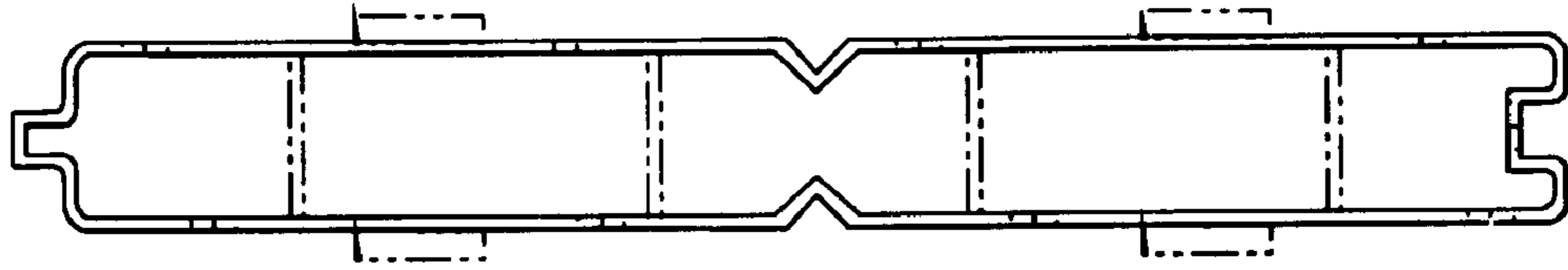

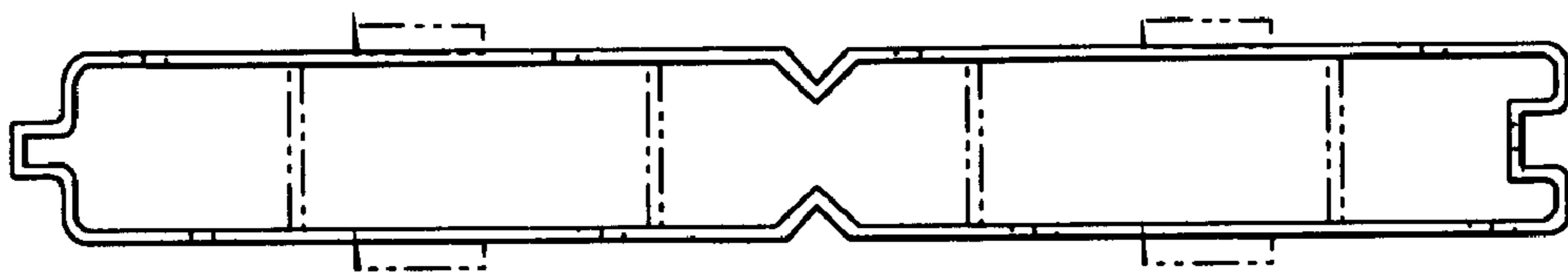
