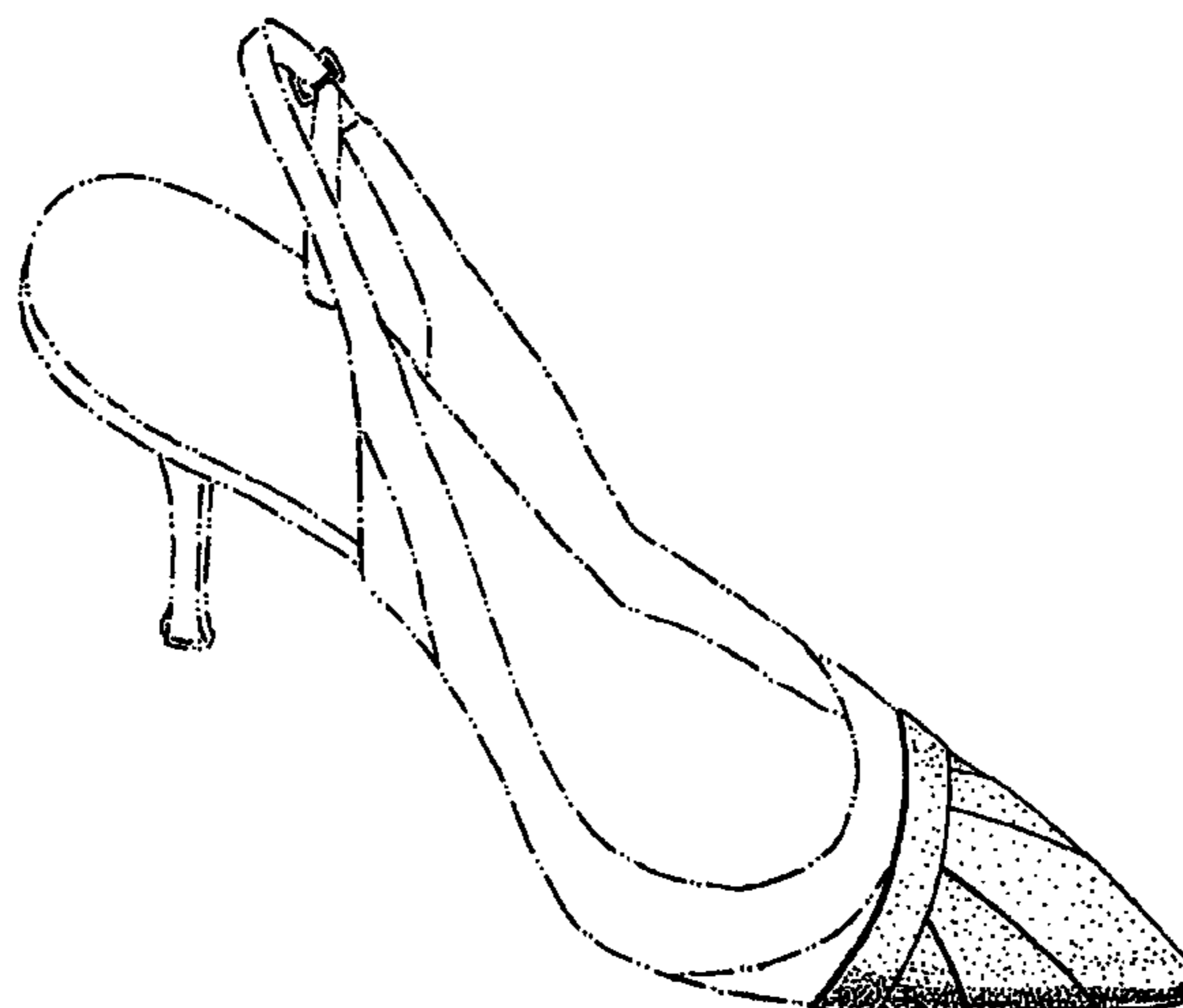
(57) **CLAIM**

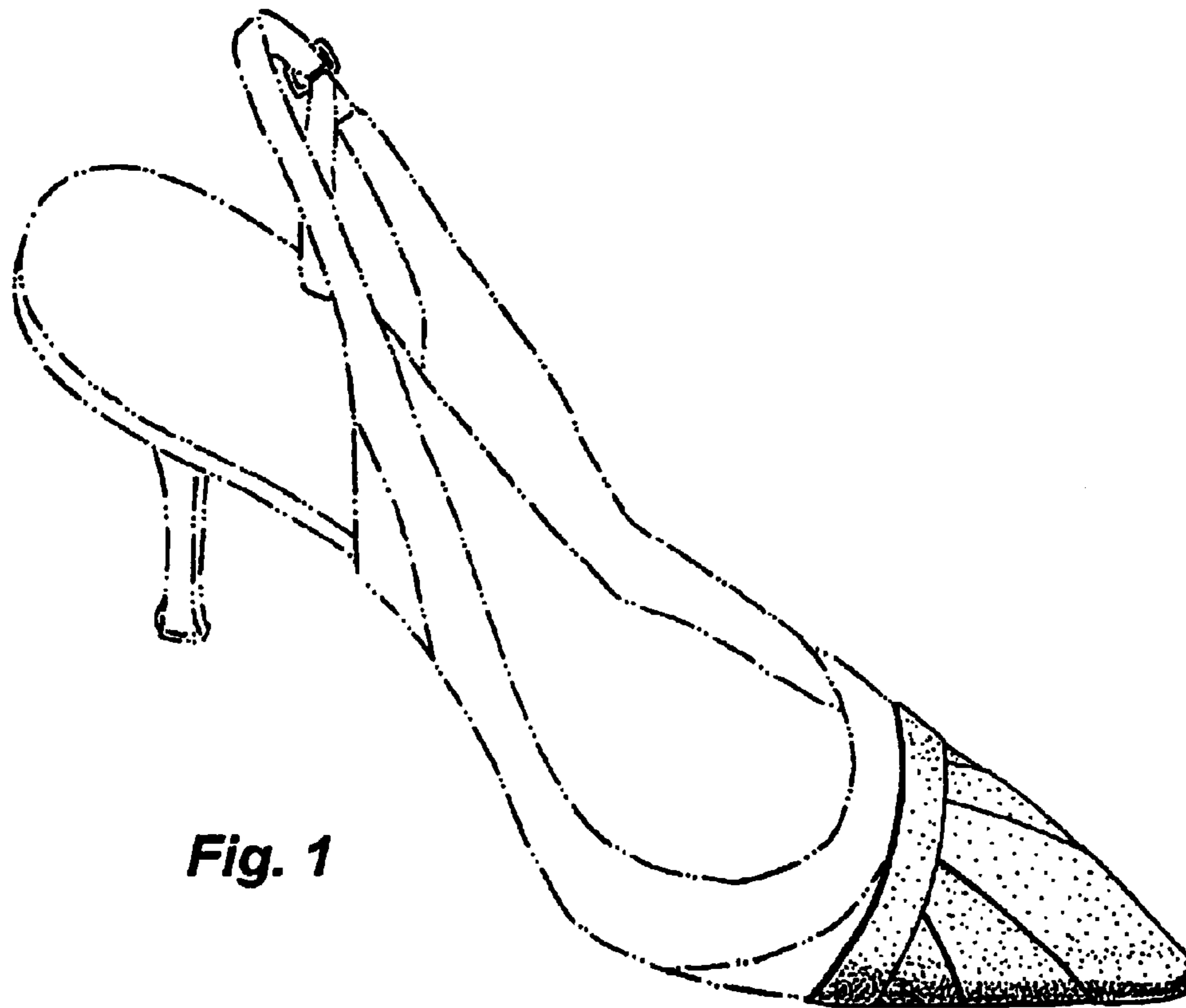
An ornamental design for a shoe, as shown and described.

**DESCRIPTION**

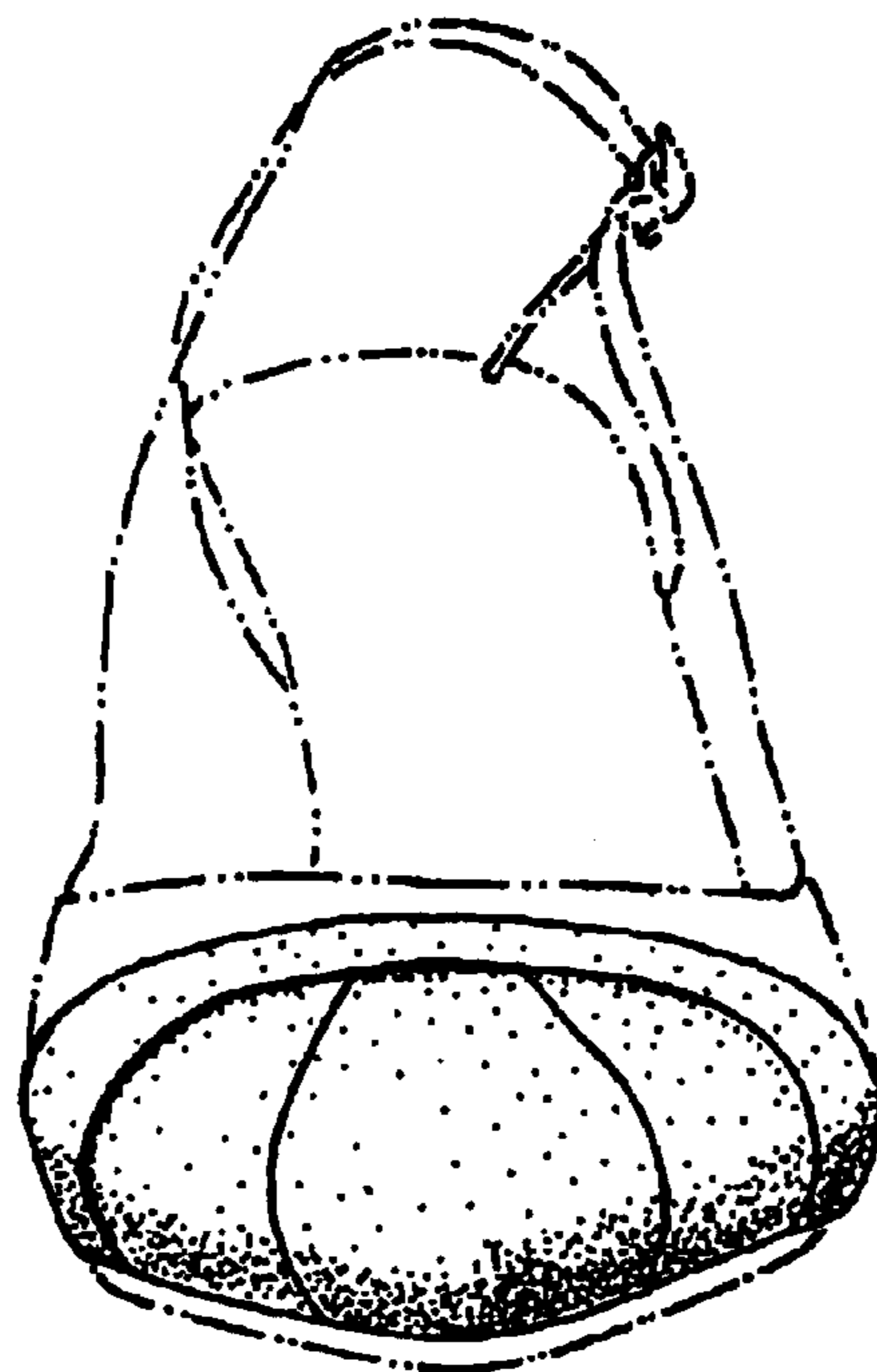
FIG. 1 is a perspective view of a shoe;  
FIG. 2 is a front view of the shoe;  
FIG. 3 is a side view of the shoe from an inside edge of the shoe;  
FIG. 4 is a side view of the shoe from an outside edge of the shoe; and,  
FIG. 5 is a top view of the shoe.

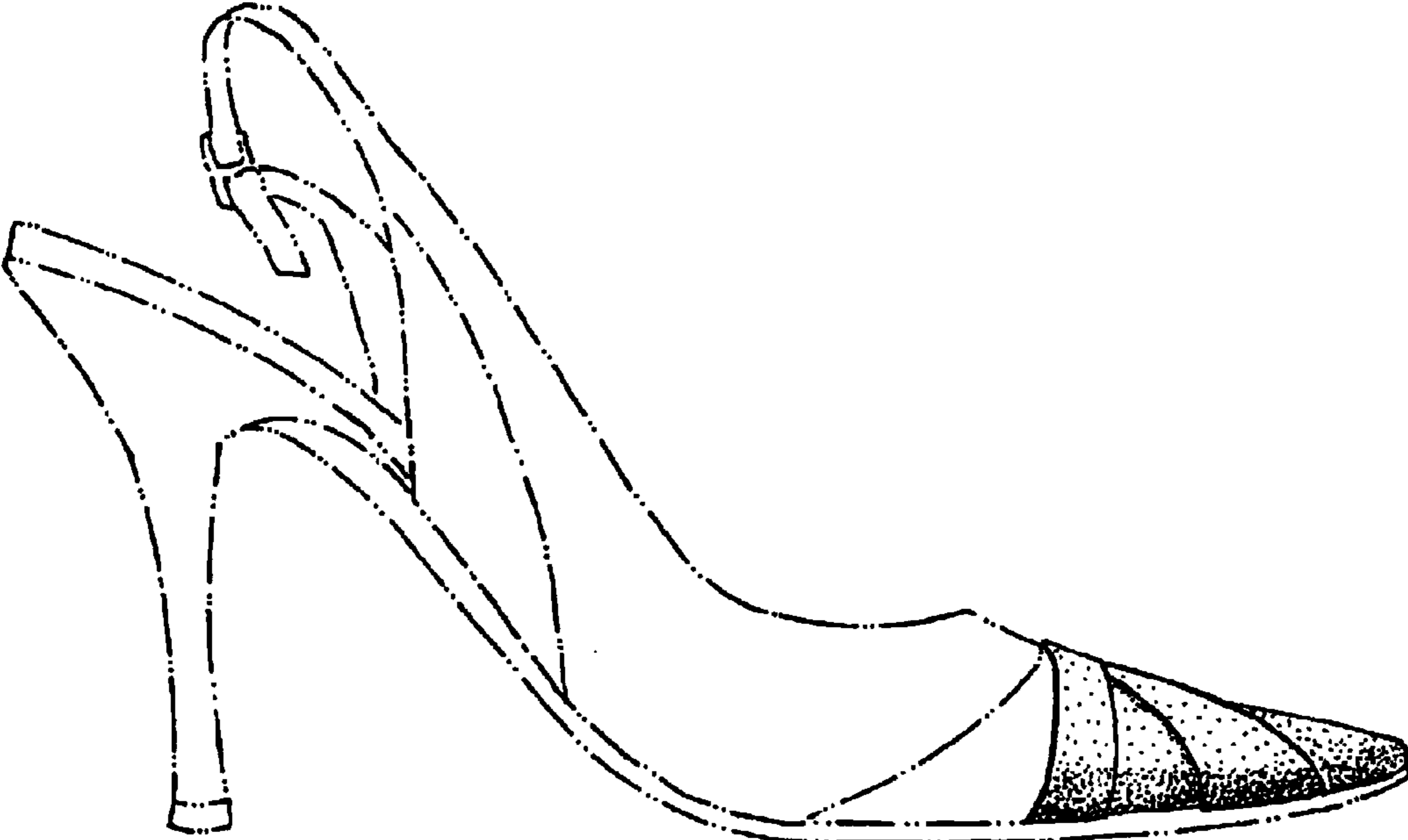




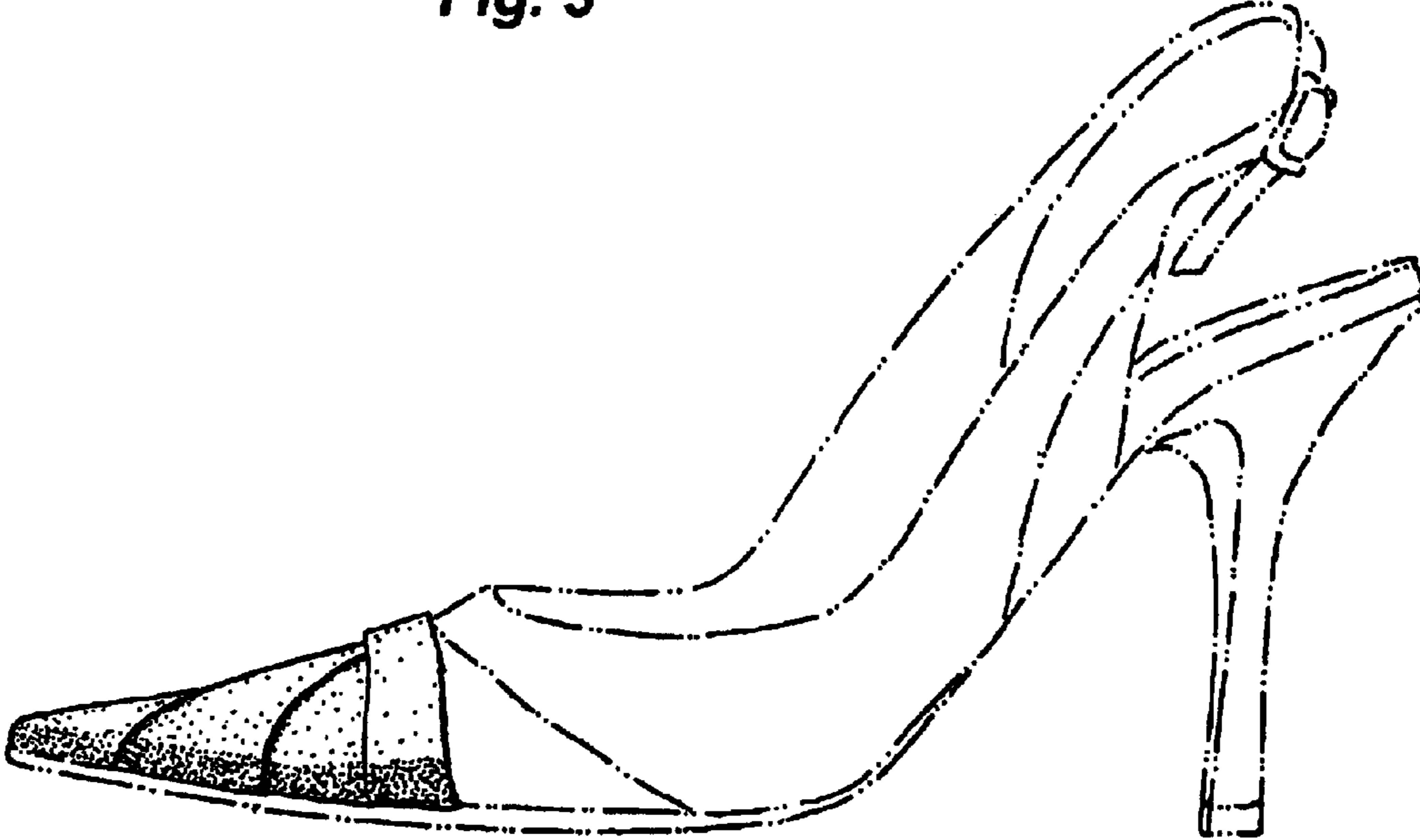

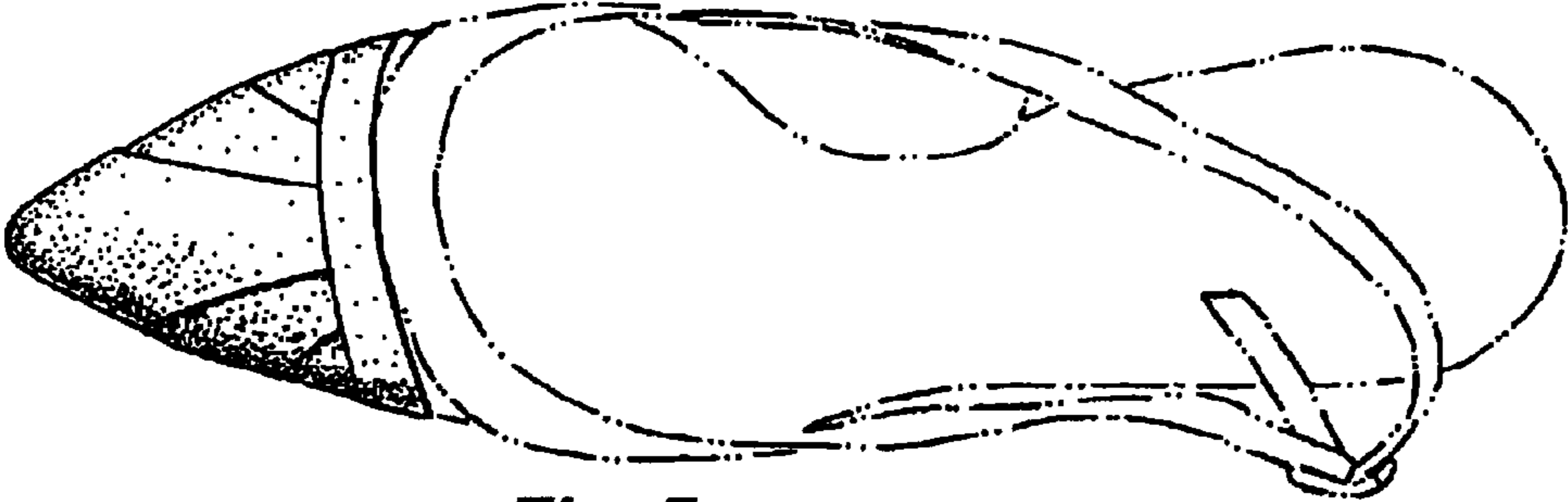
