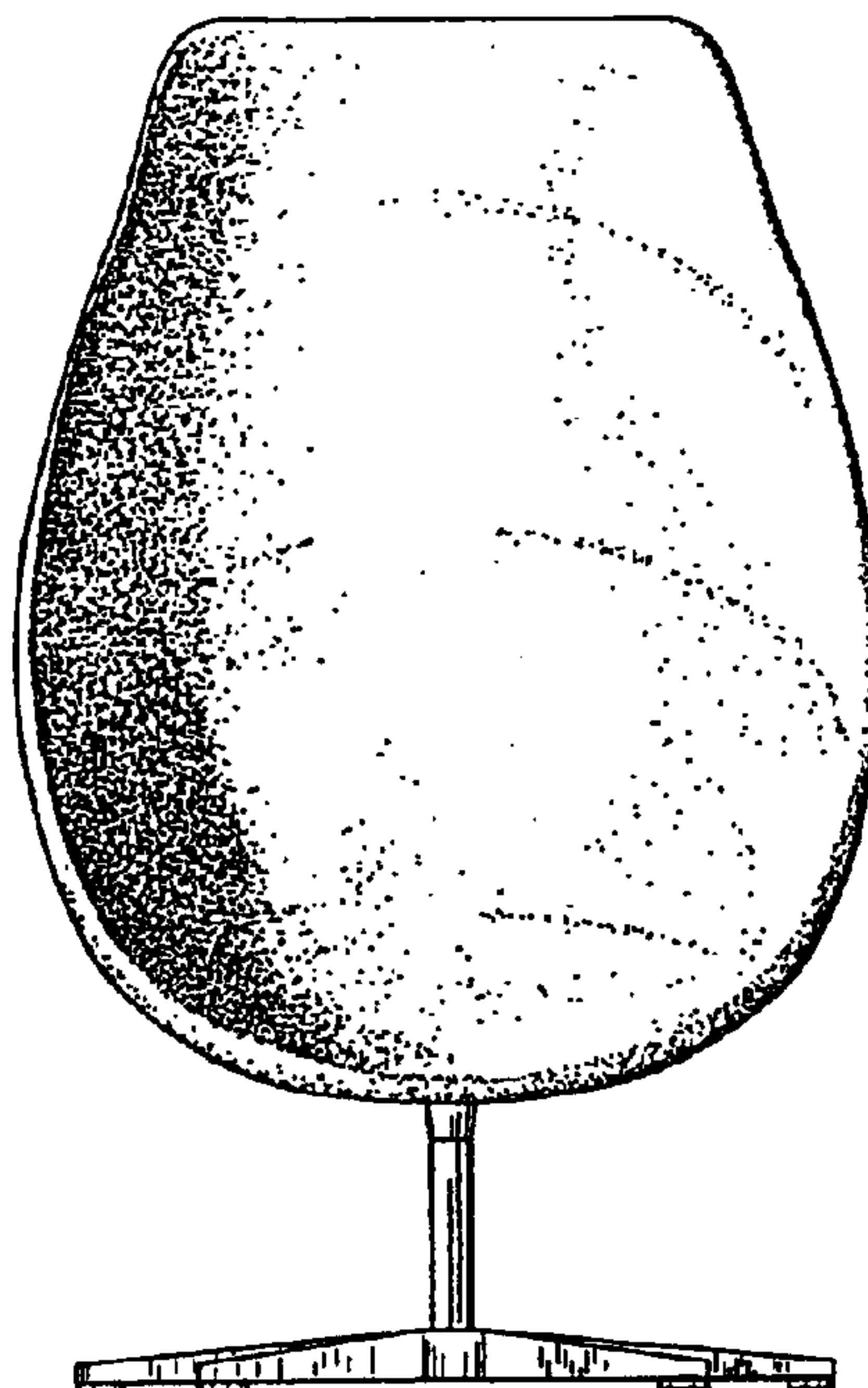
(57) **CLAIM**

I claim the ornamental design for a lounge/working chair, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a lounge/working chair showing my new design;
FIG. 2 is a left side view of FIG. 1, the right side view being a mirror image of the left side;
FIG. 3 is a rear view of FIG. 1;
FIG. 4 is a top view of FIG. 1; and,
FIG. 5 is a bottom view of FIG. 1.

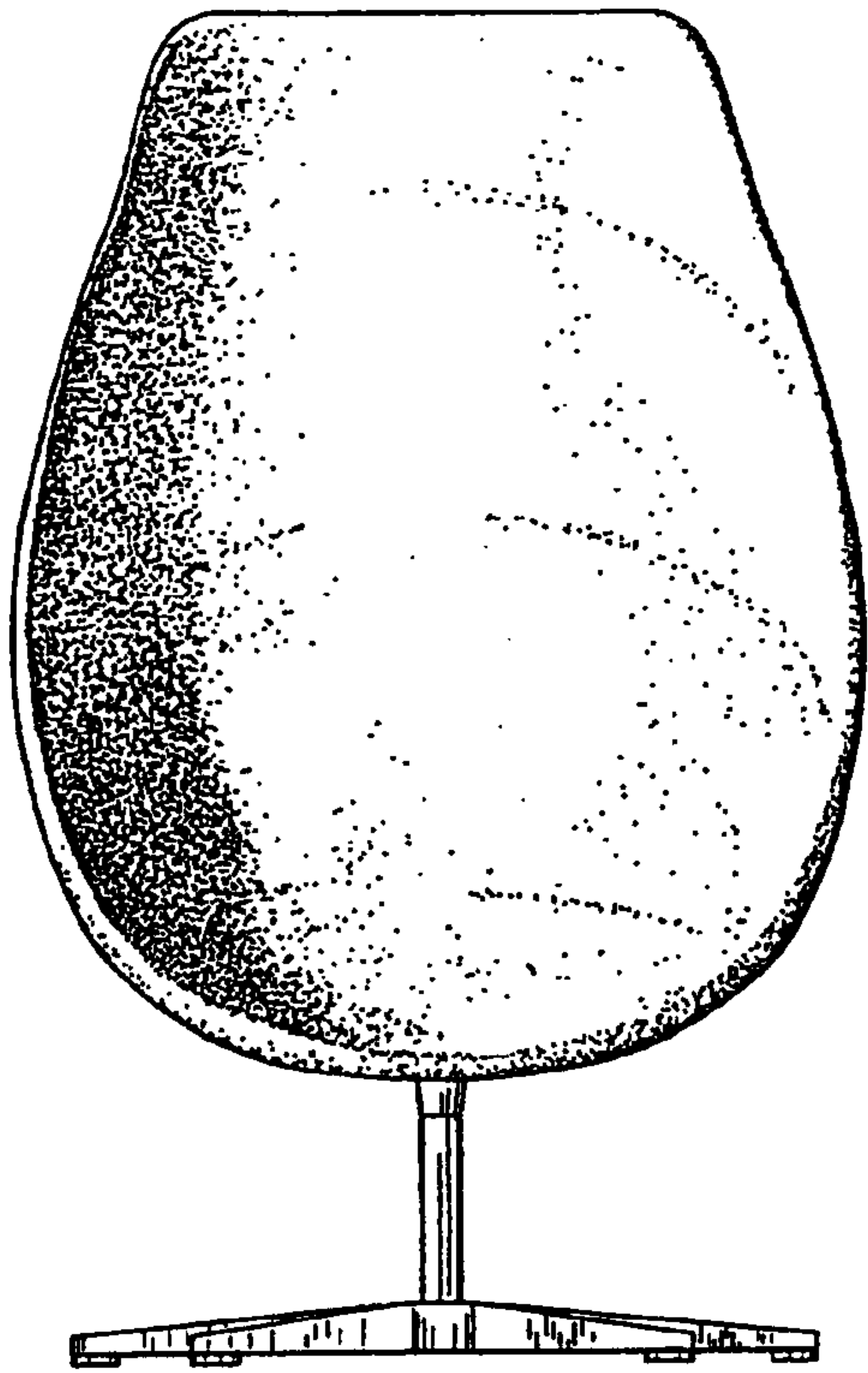

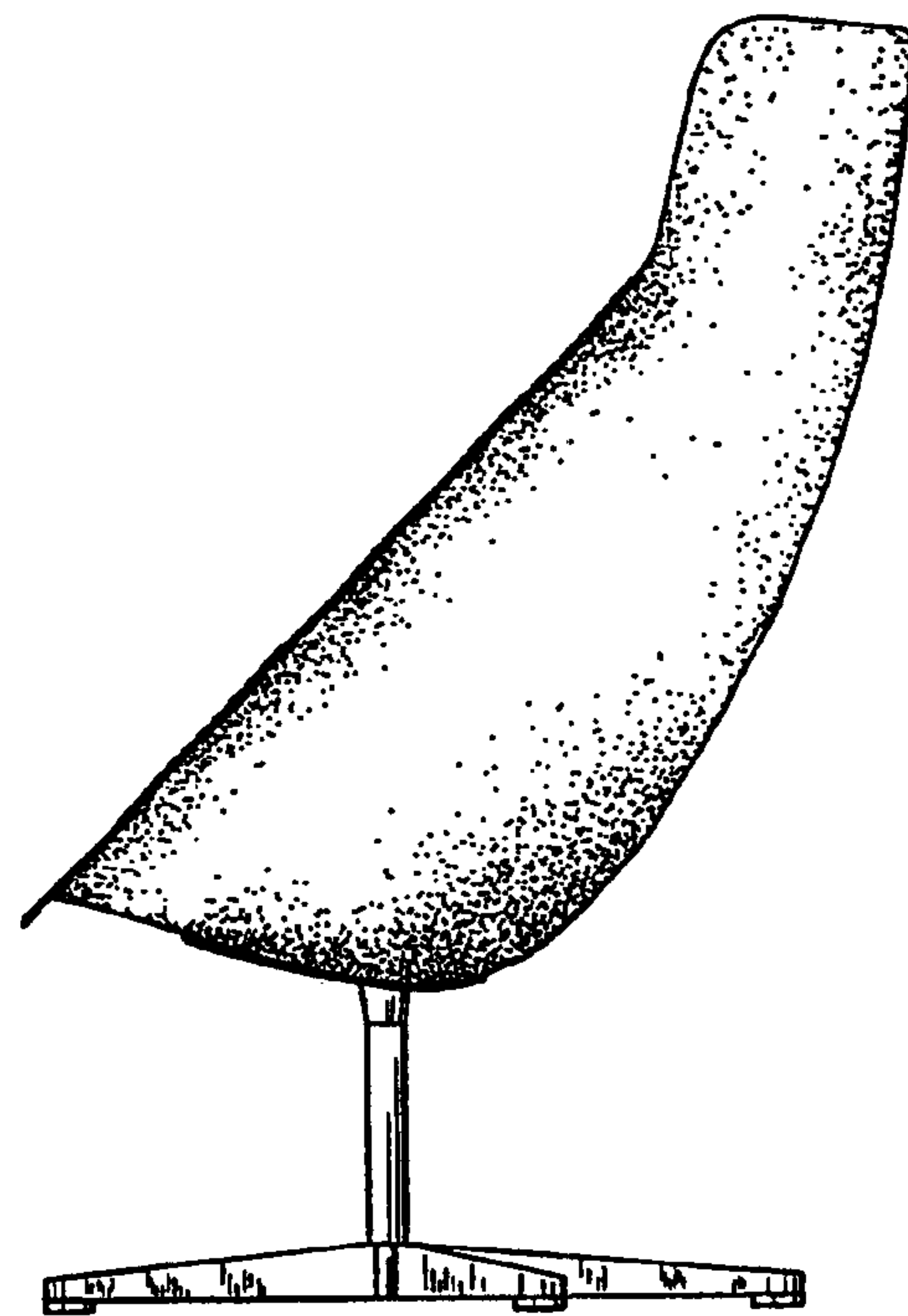

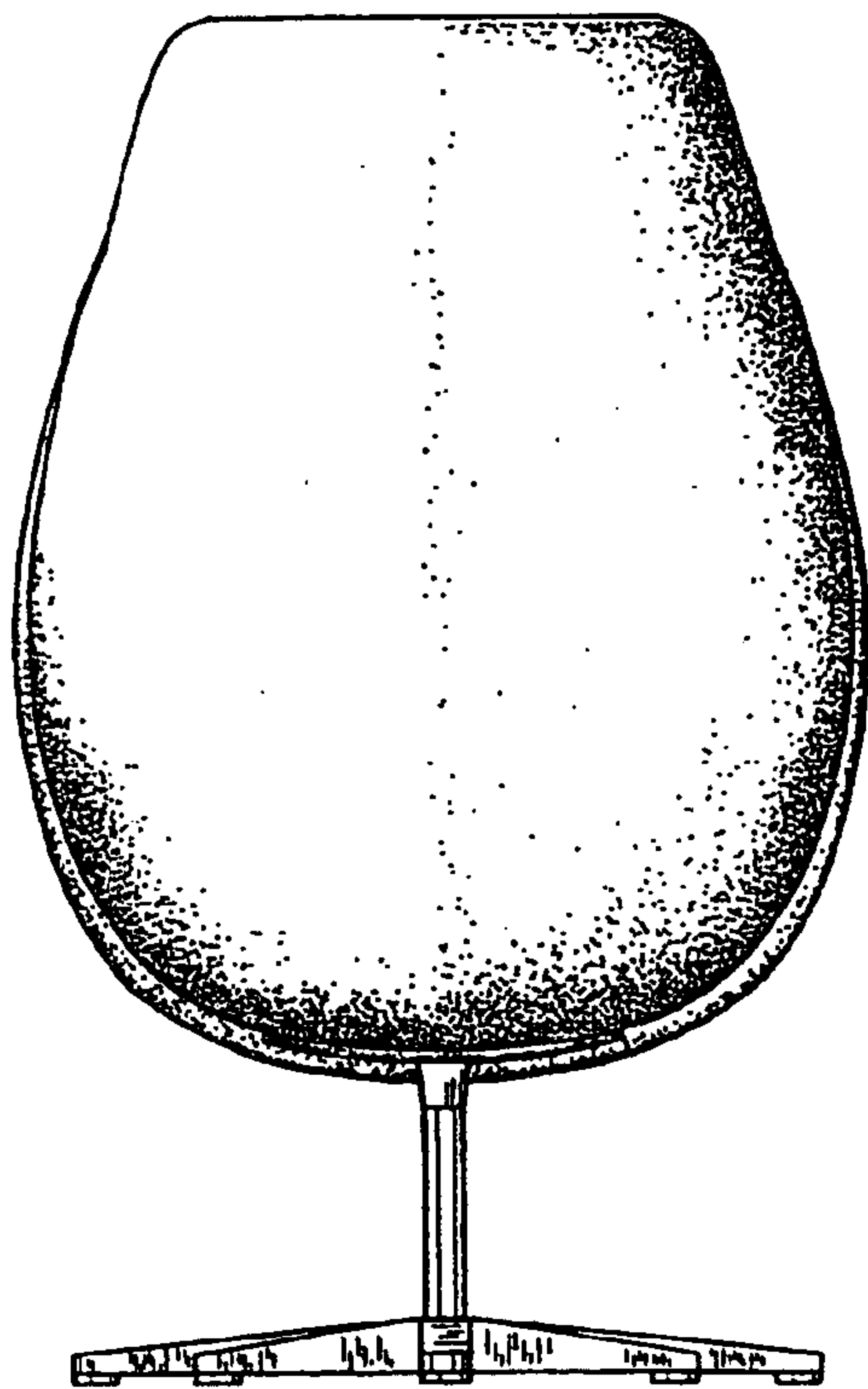

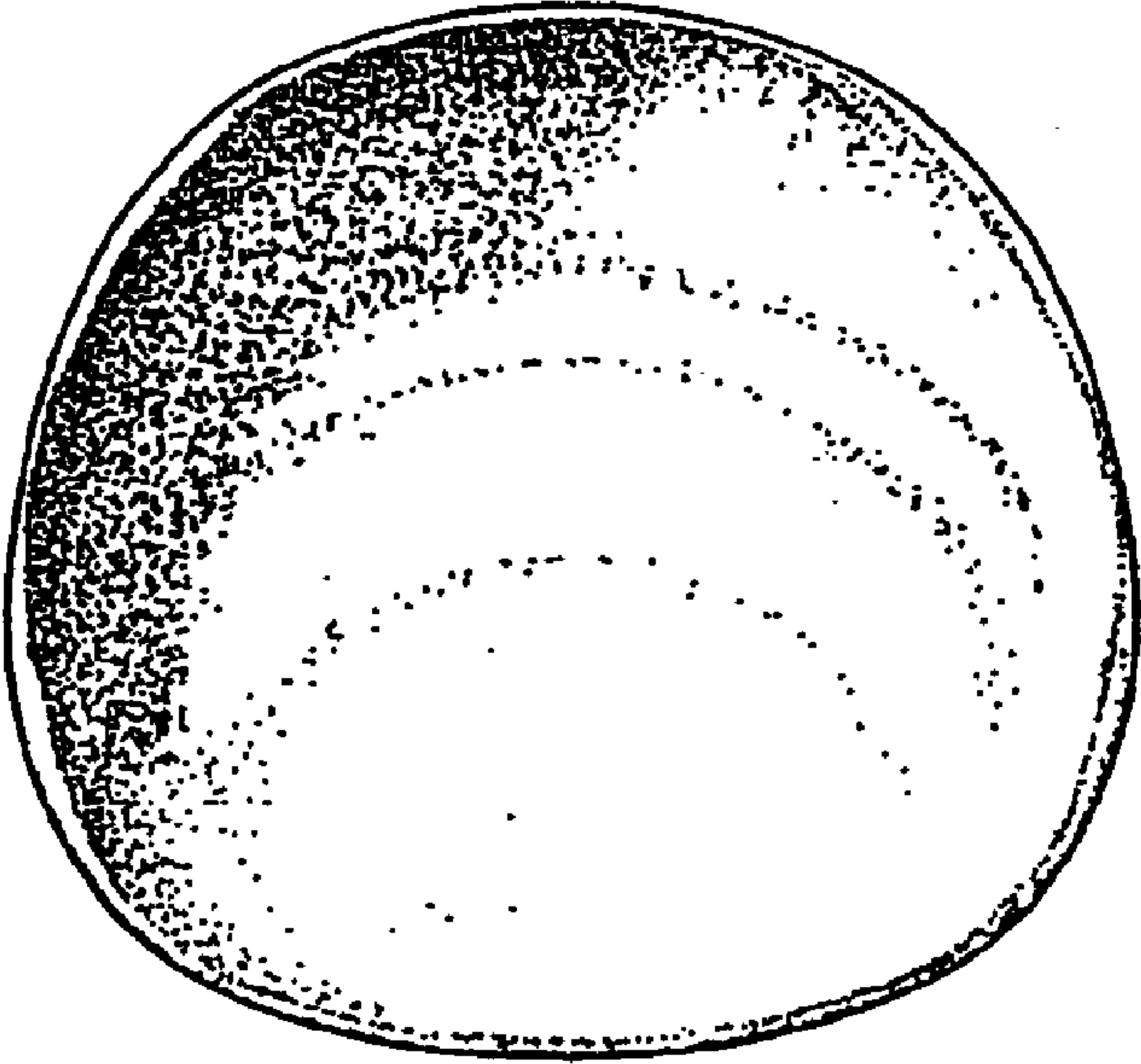

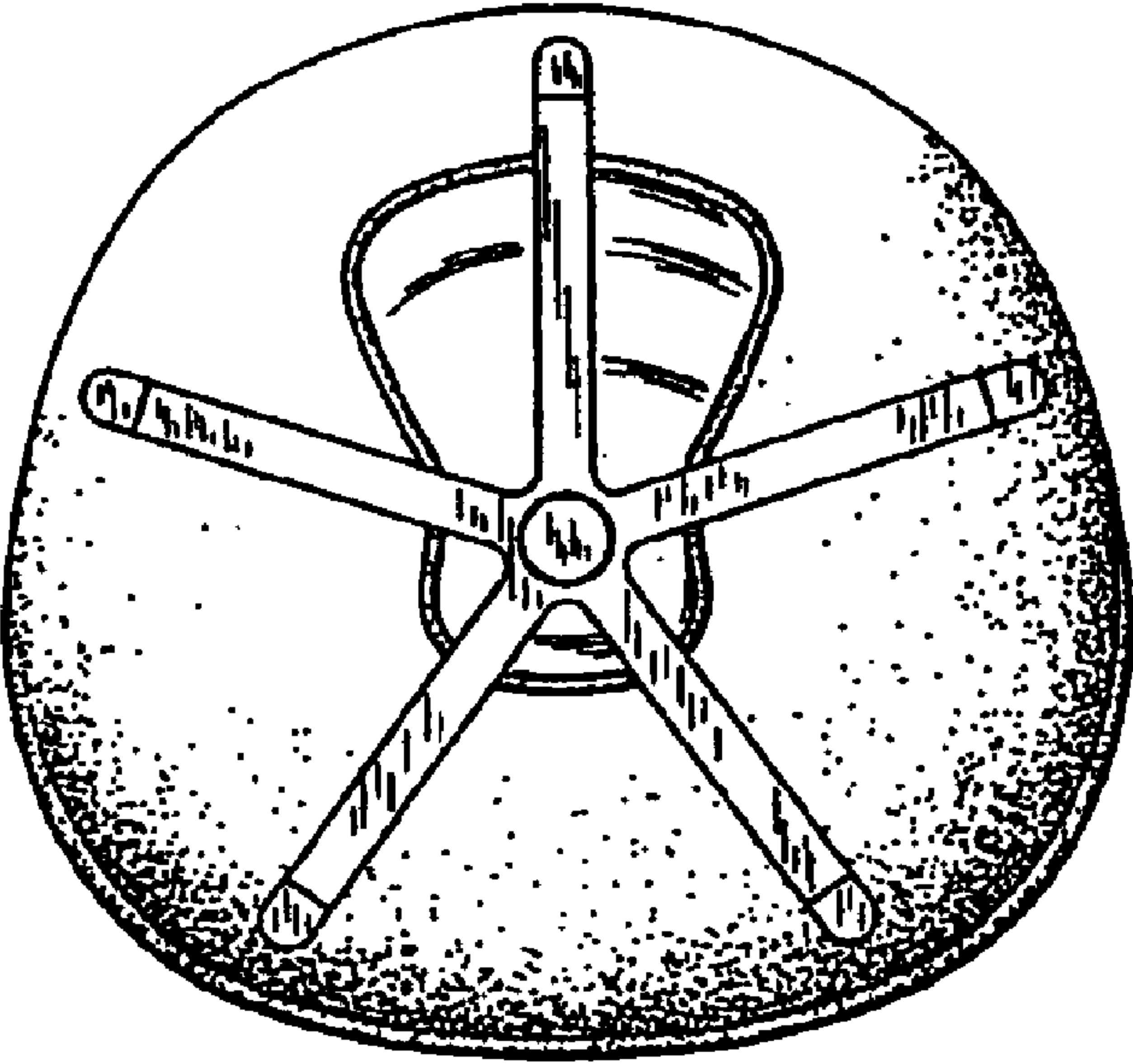
