(57) **CLAIM**

The ornamental design for a child's floor cushion, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, left side perspective view of a child's floor cushion embodying our design;
FIG. 2 is a top plan view thereof, the bottom view being identical thereto;
FIG. 3 is a cross-sectional view thereof along lines 3—3 of FIG. 2;
FIG. 4 is a left side elevational view thereof; the right side being identical thereto; and,
FIG. 5 is a front elevational view thereof; the rear view being identical thereto.

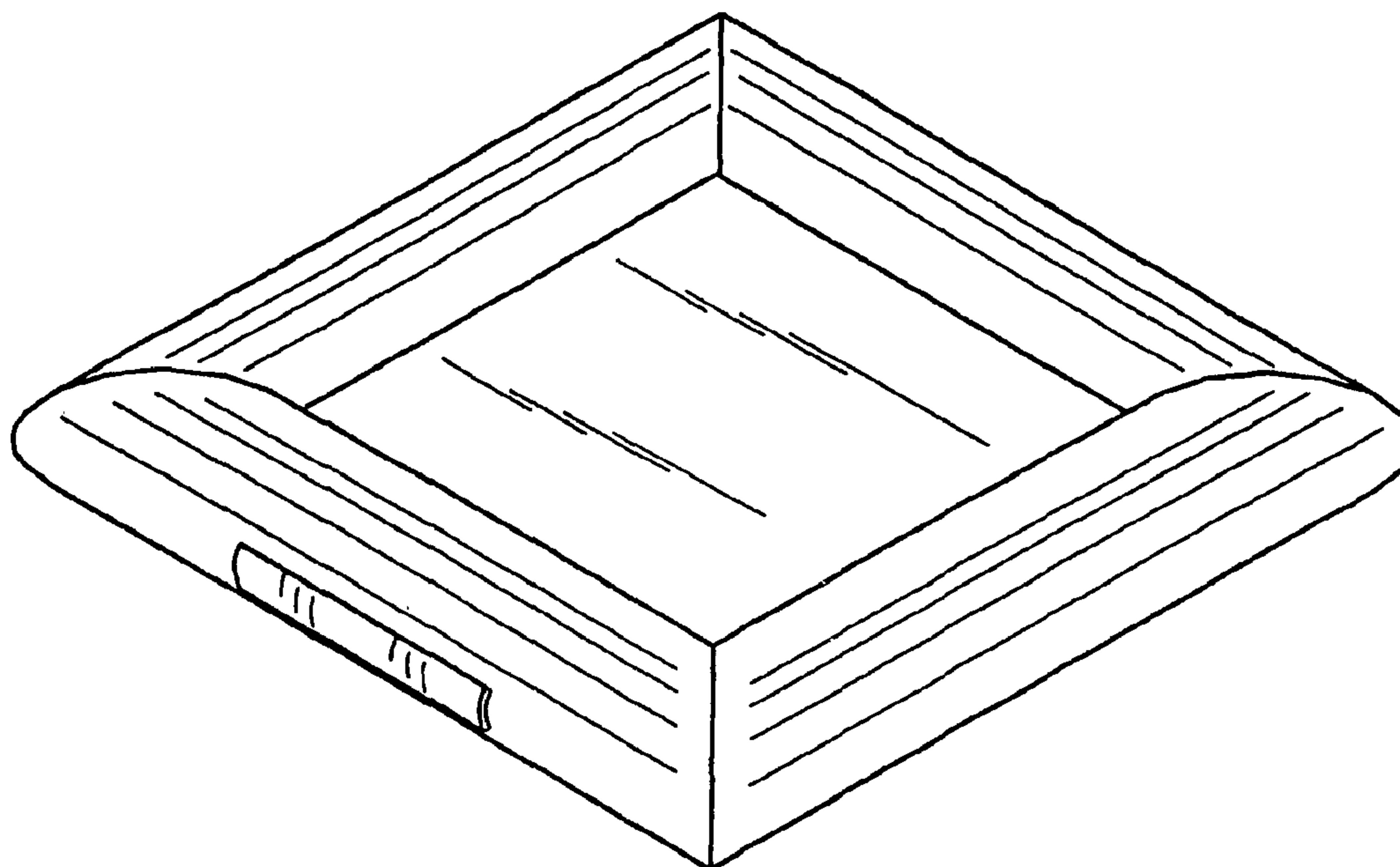

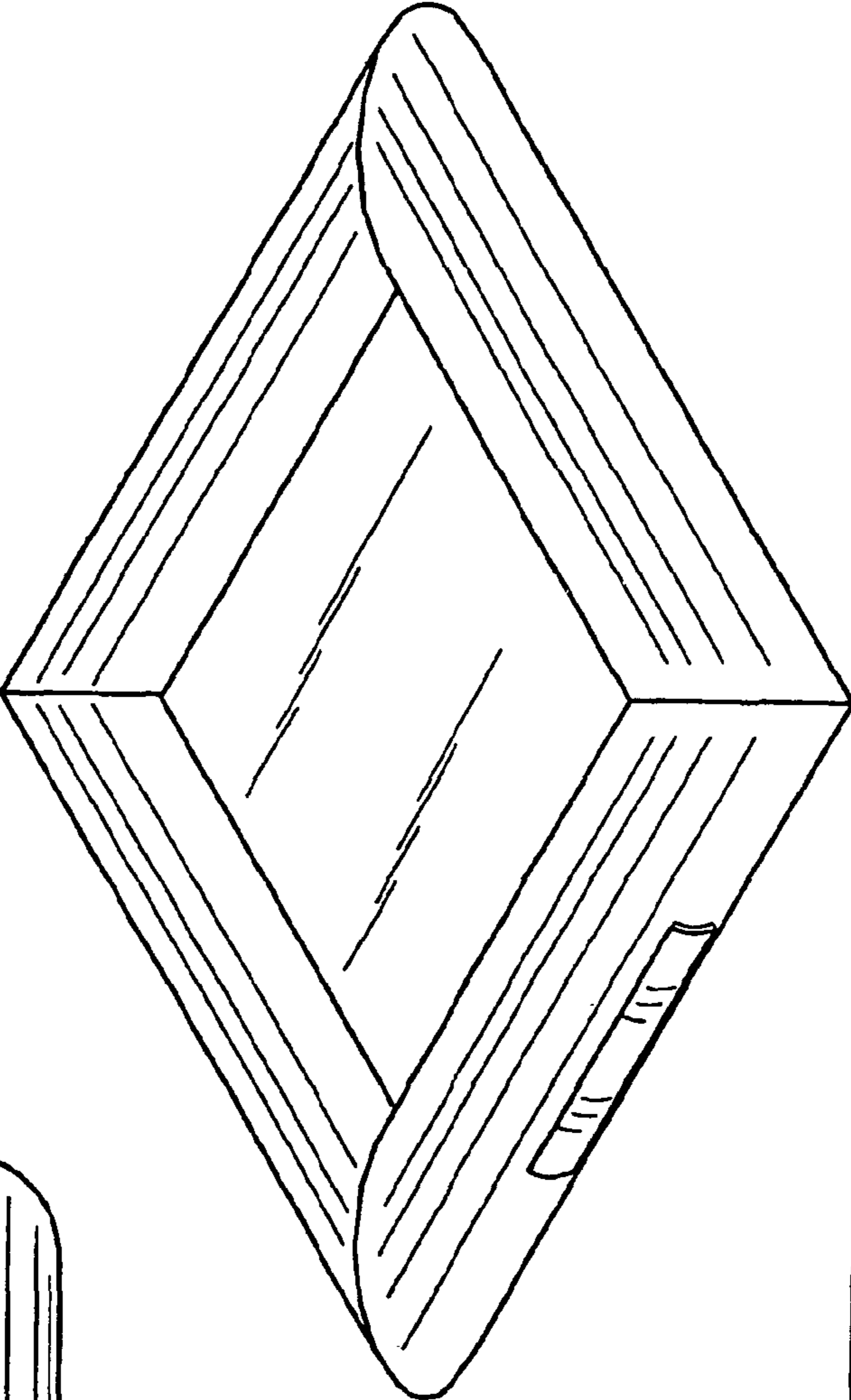

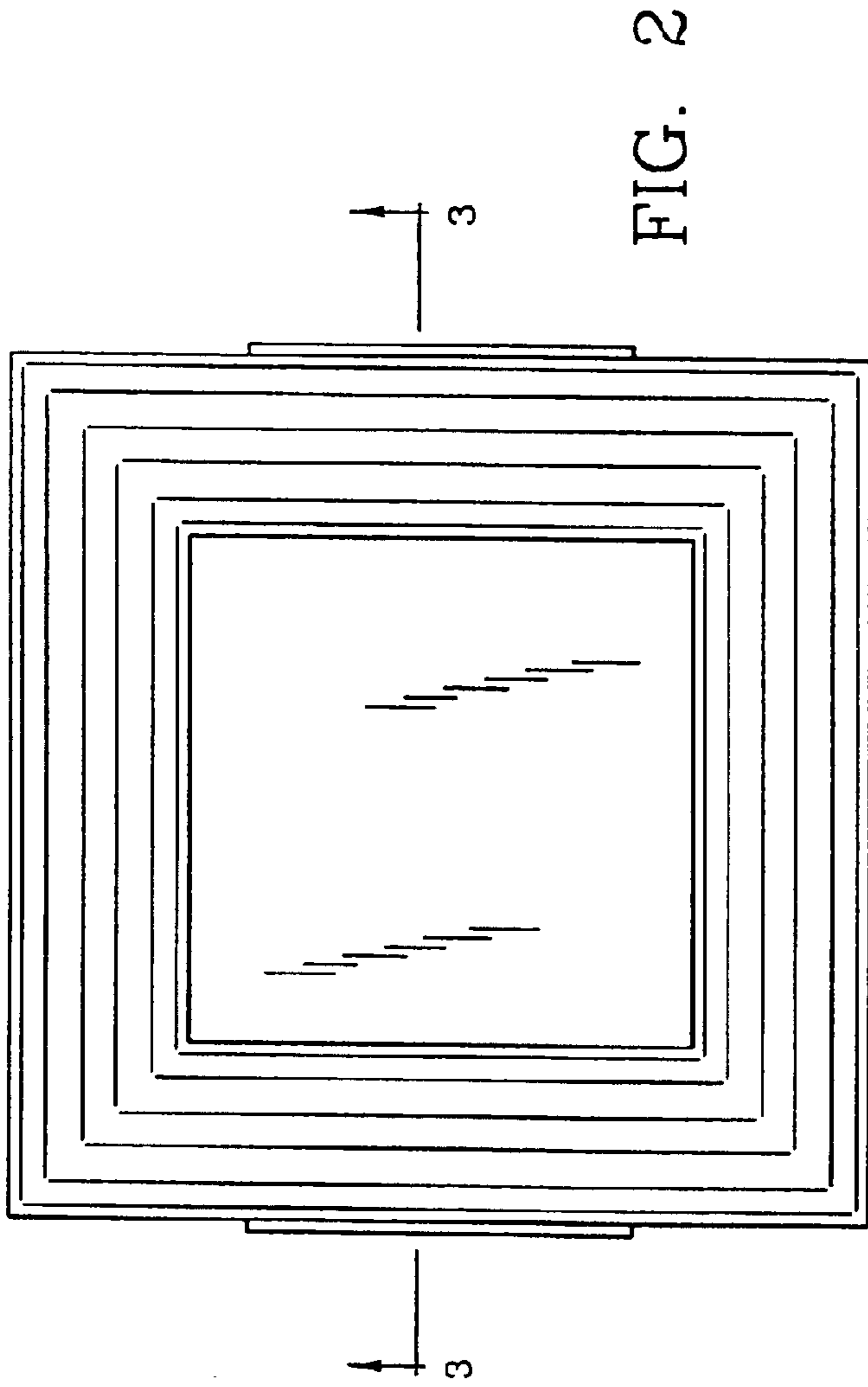

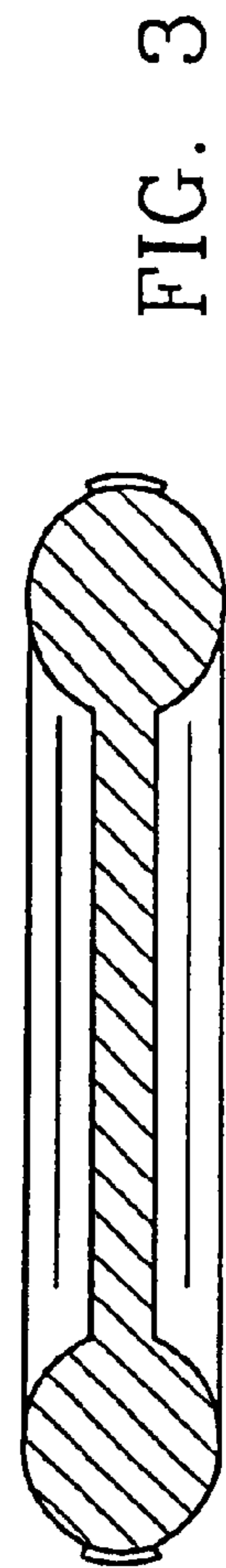
