serve coffee maker.

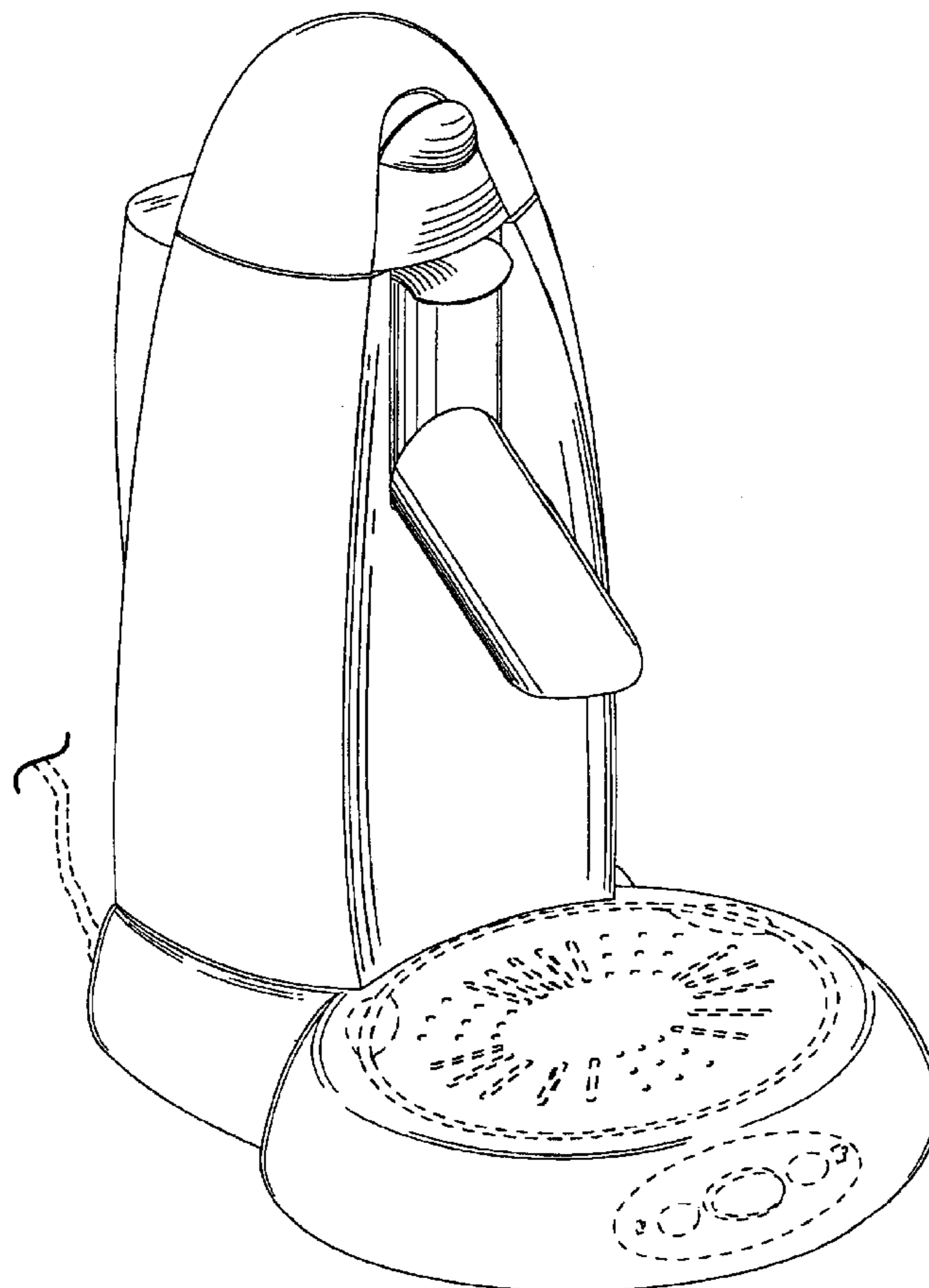

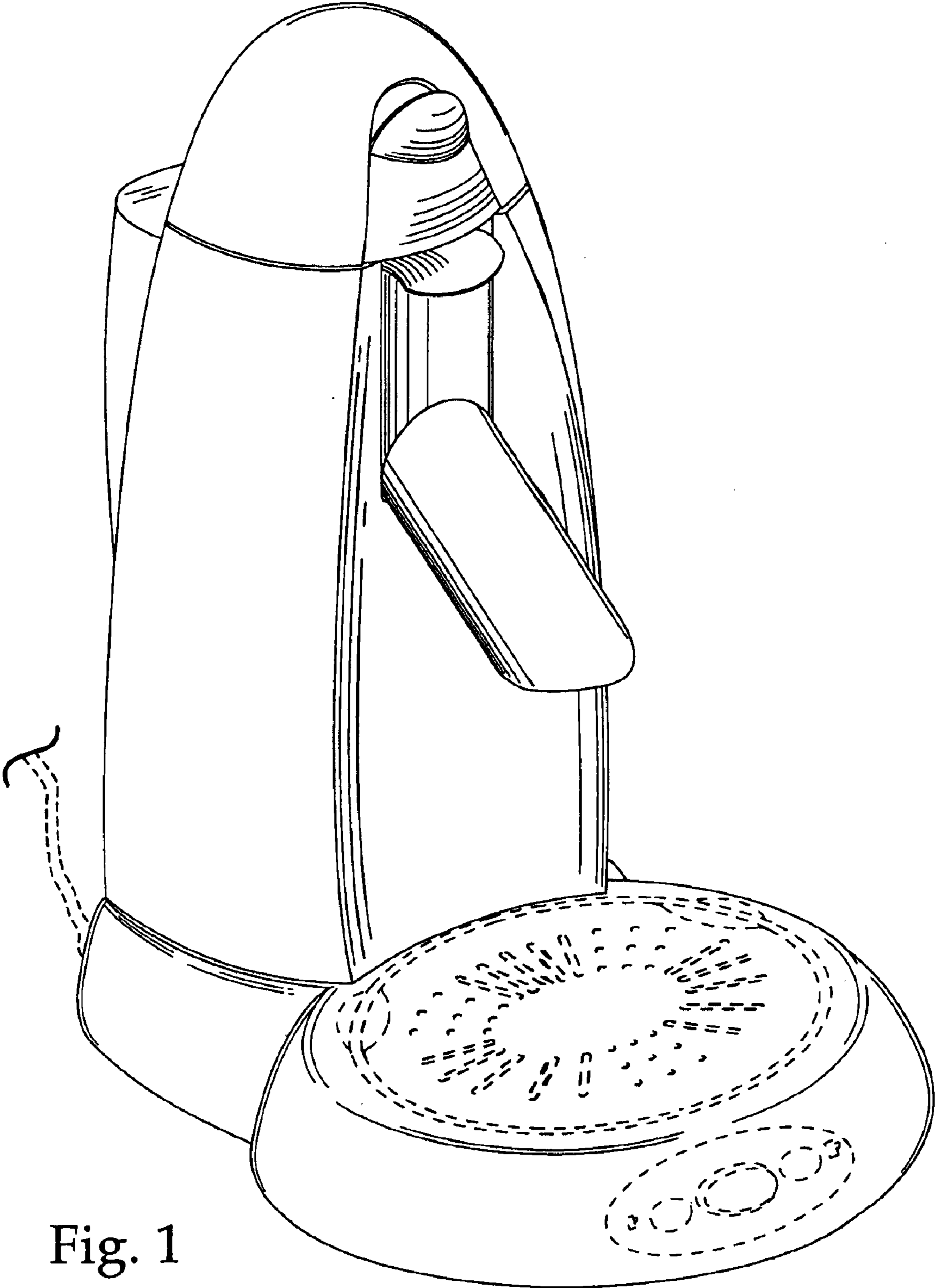

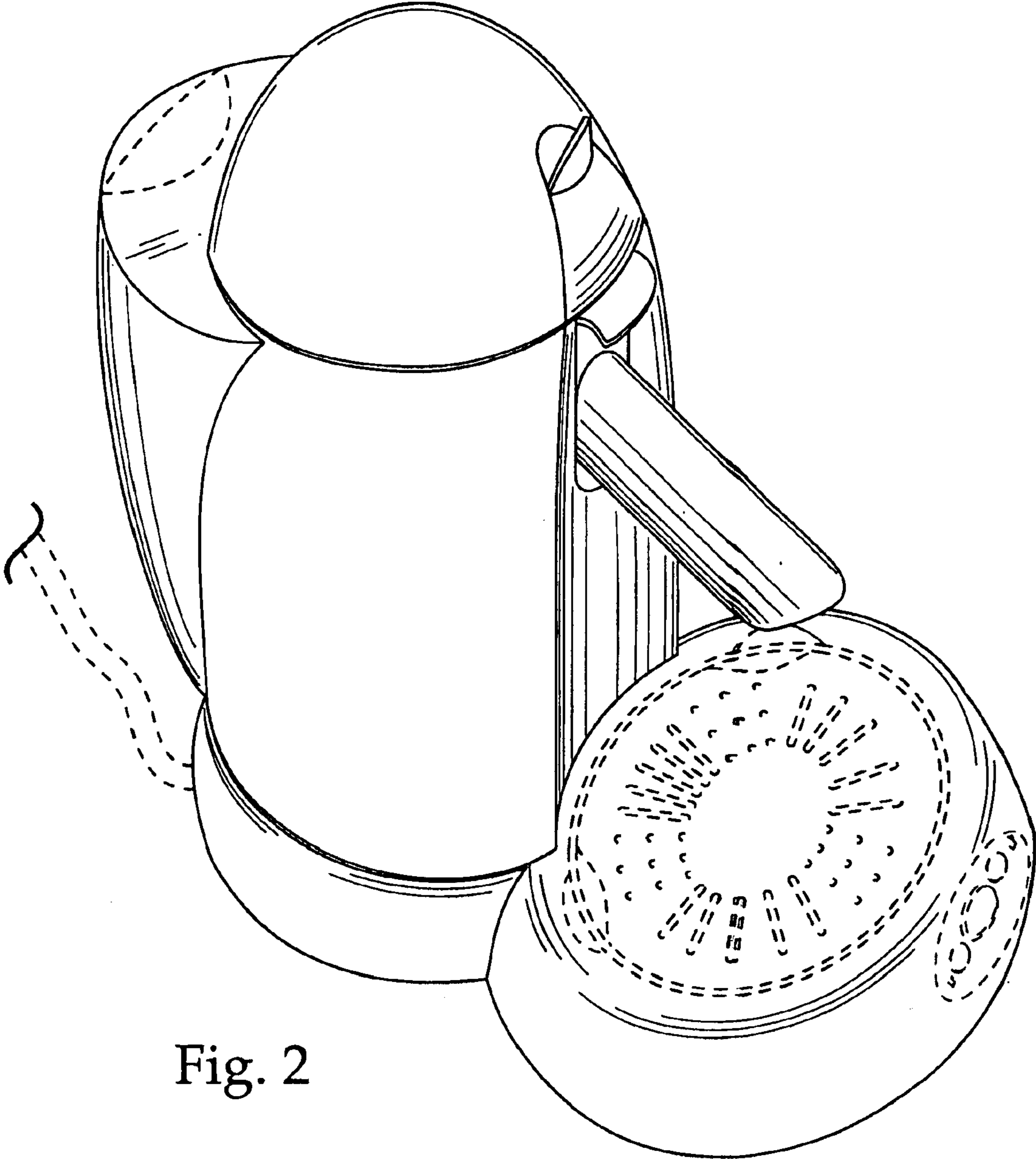

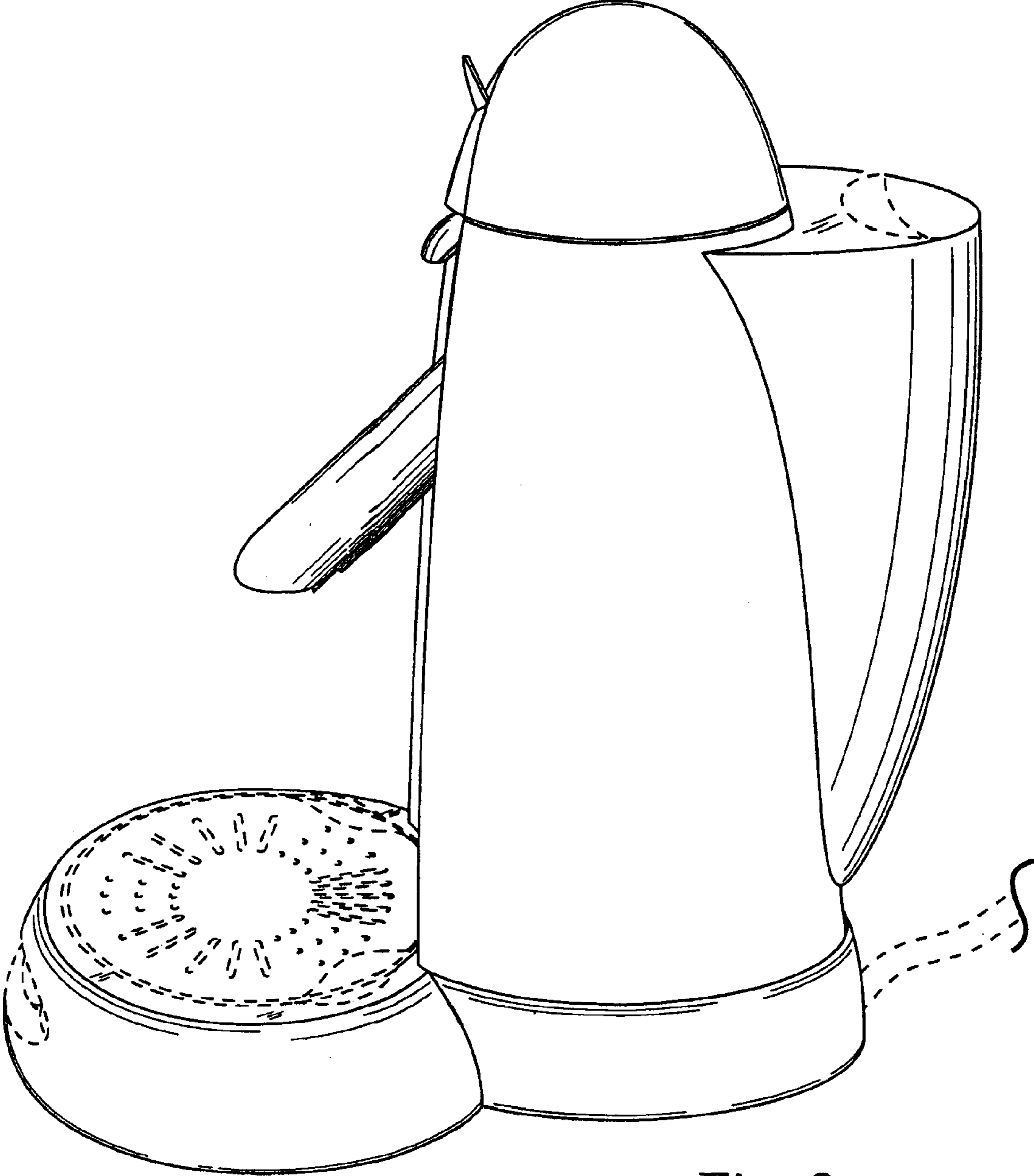

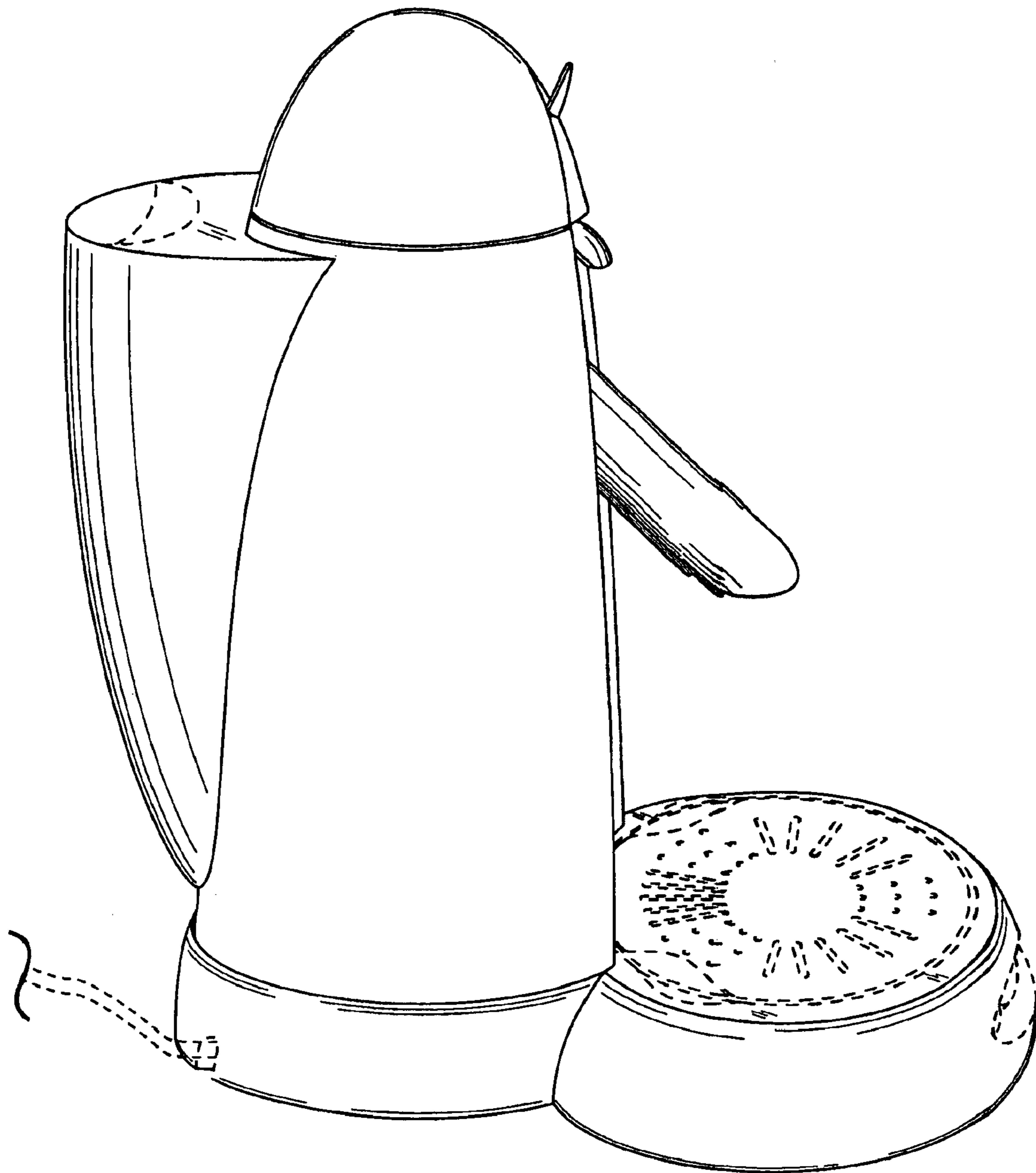

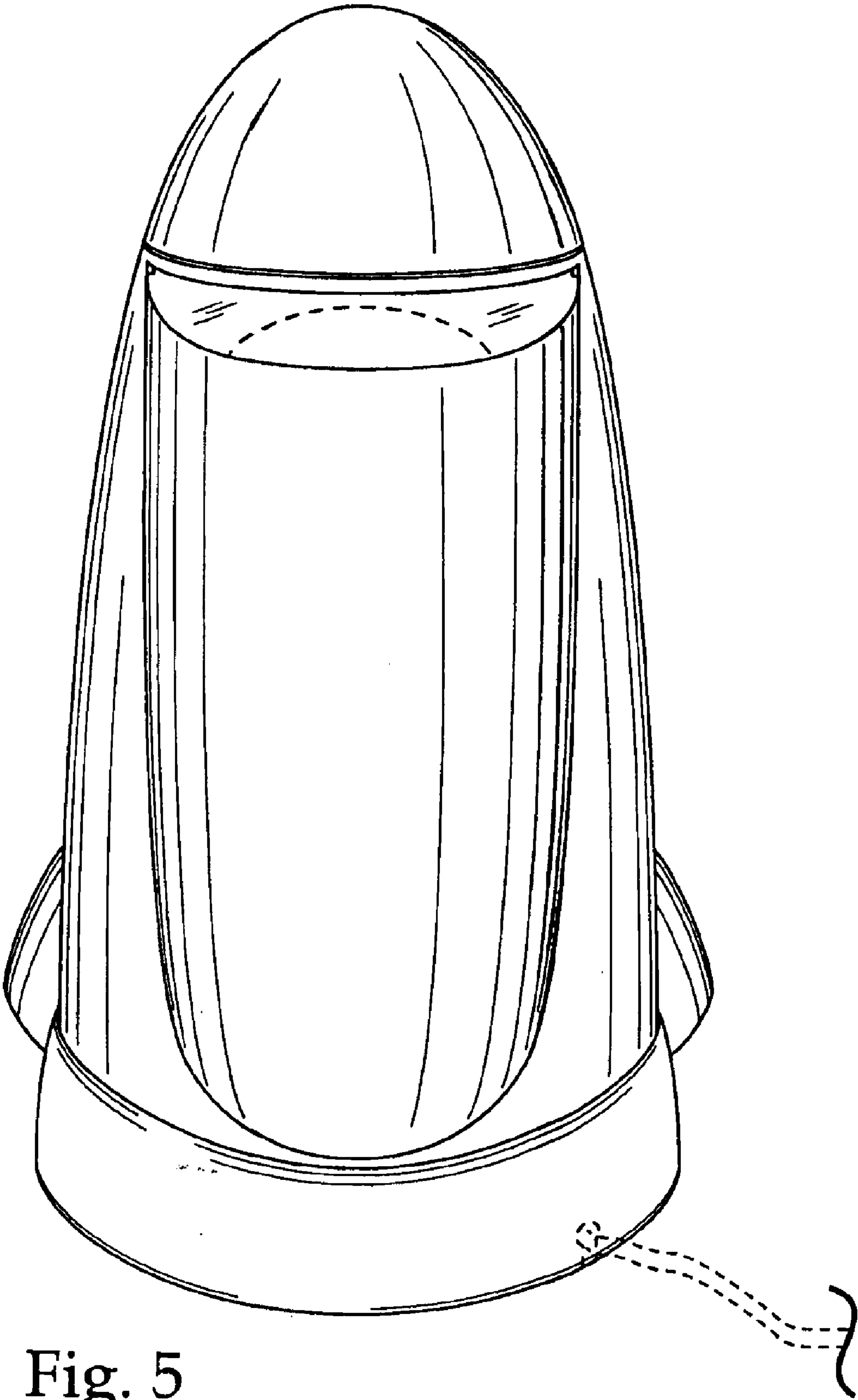

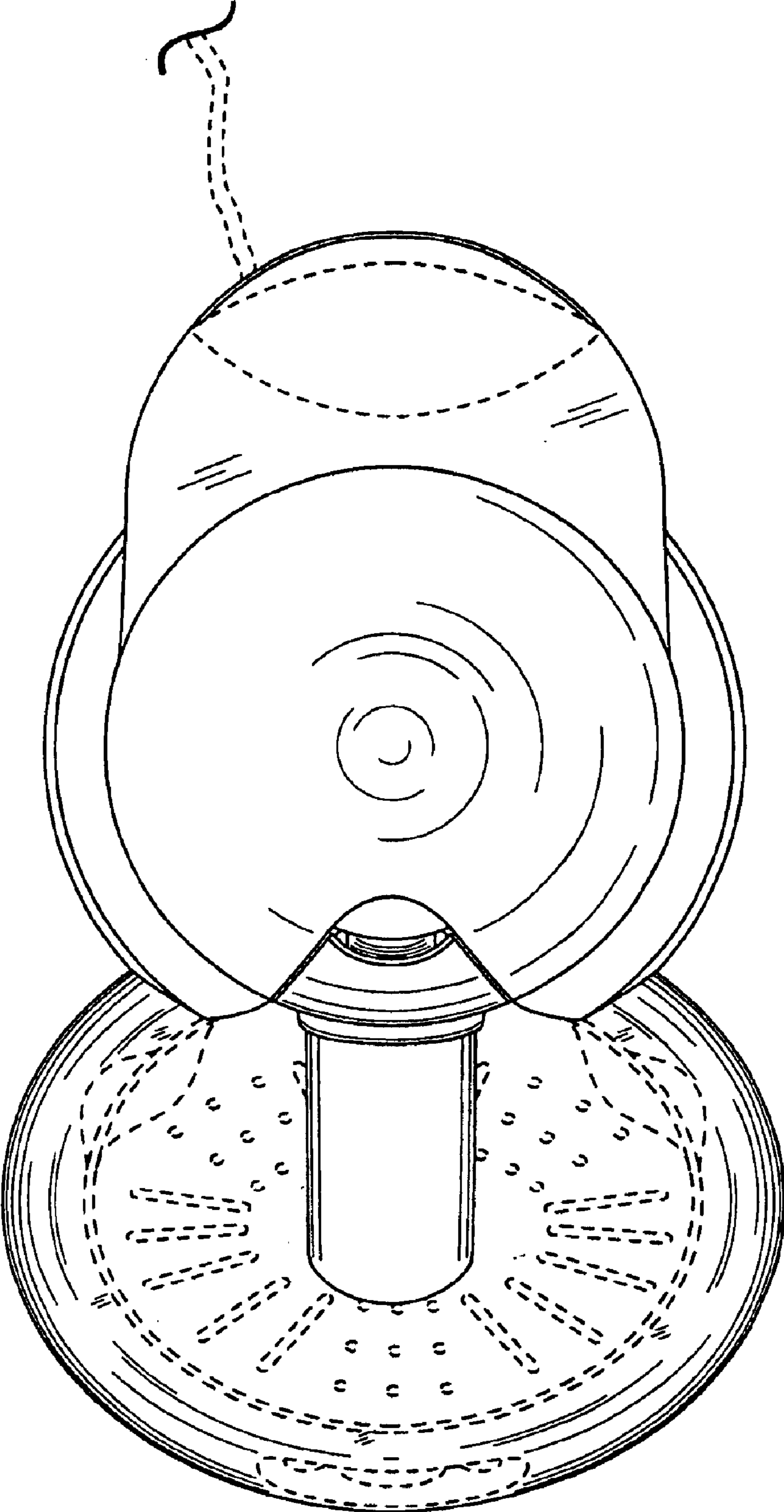

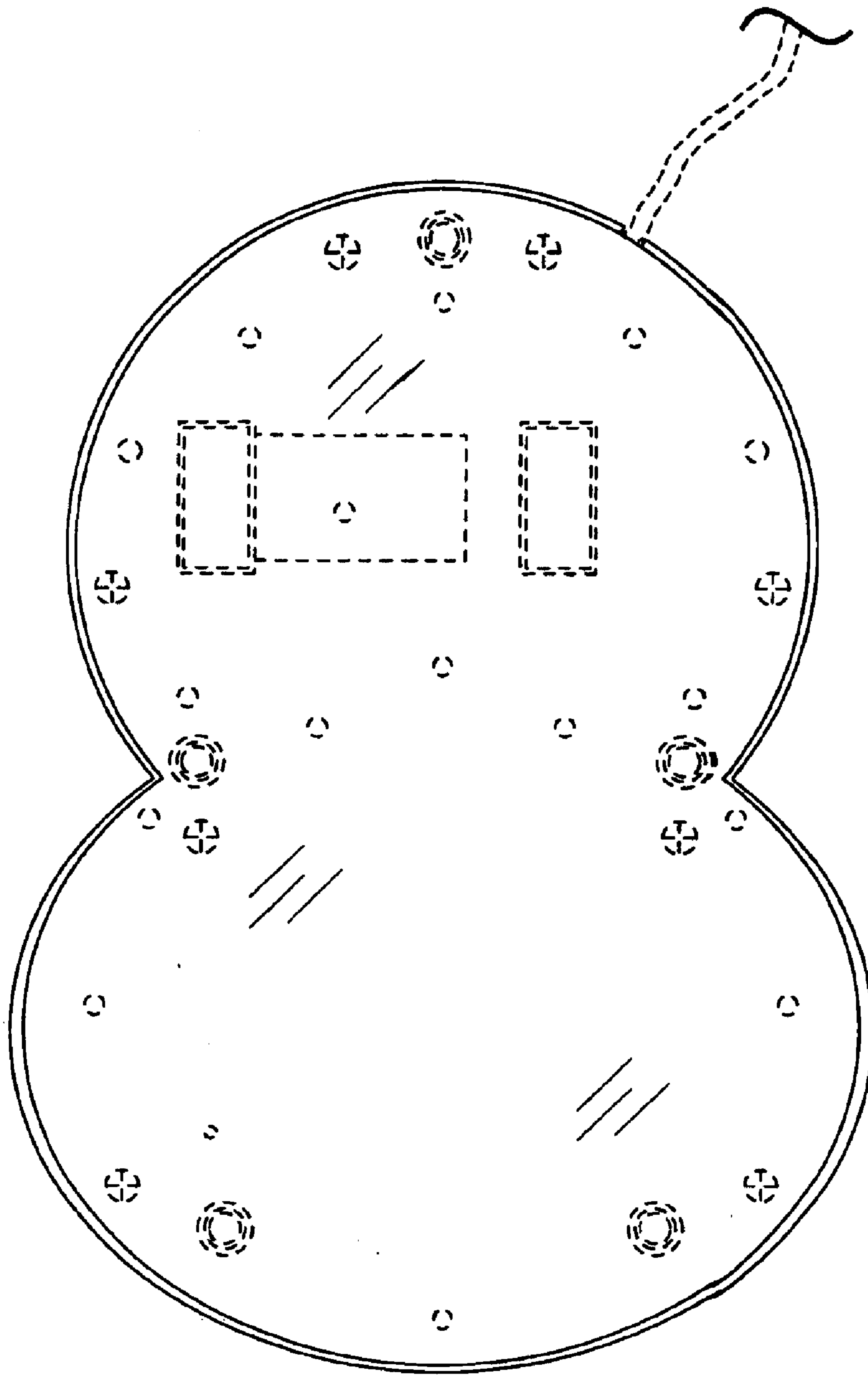

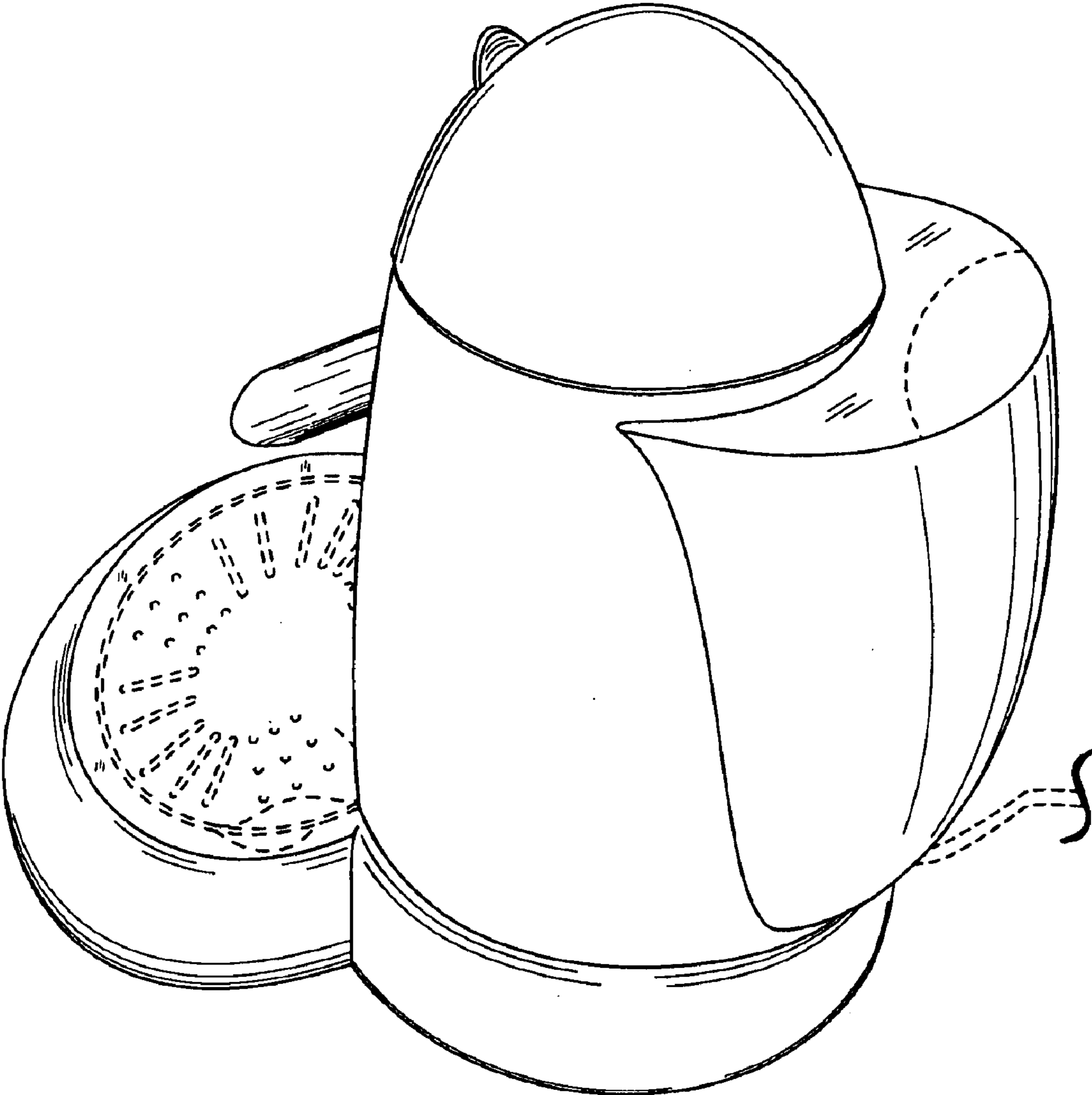
