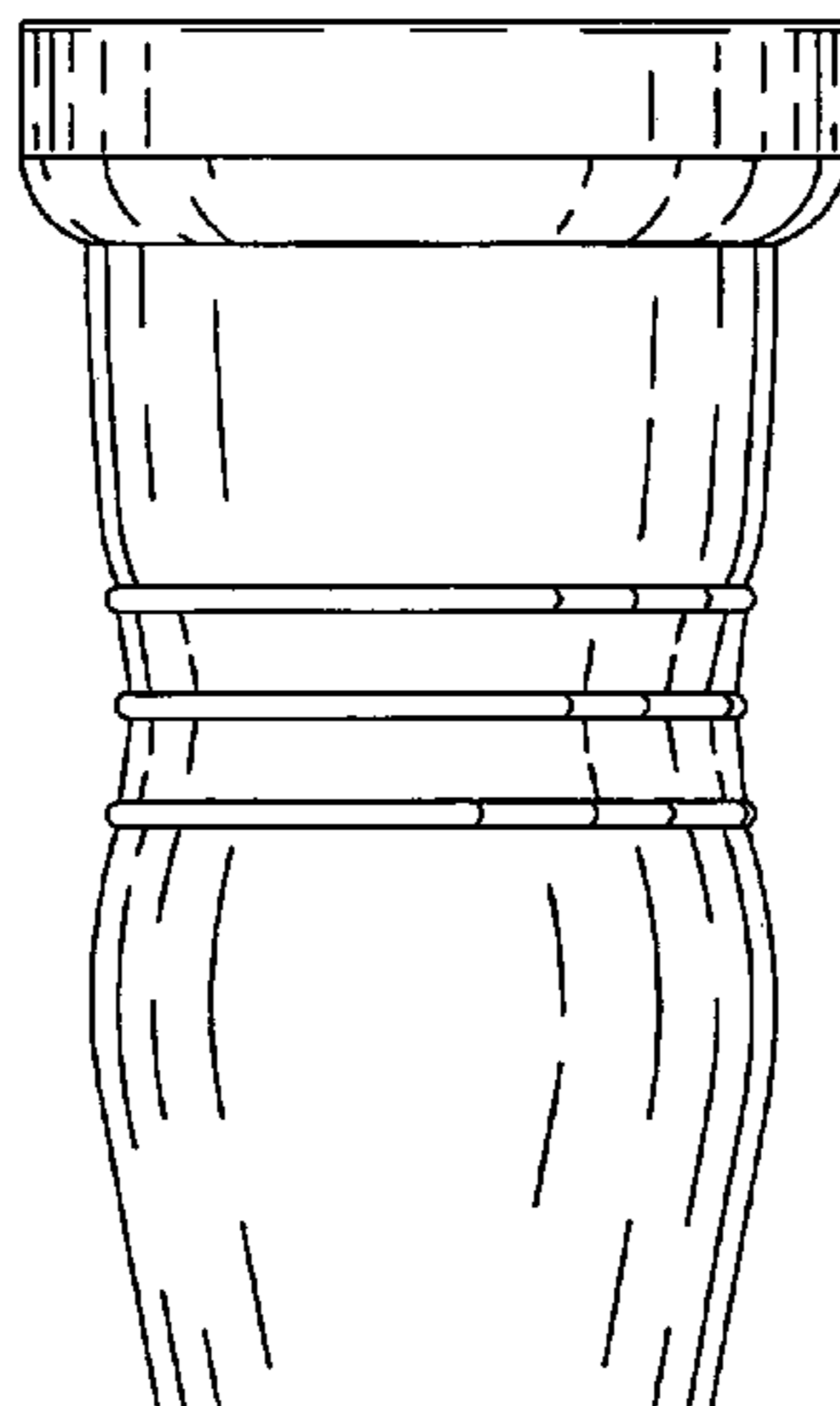
(57) **CLAIM**

The ornamental design for a beverageware, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of beverageware showing our new design;  
FIG. 2 is a front elevational view thereof, the rear, left-hand side, and right-hand side being identical to the view shown;  
FIG. 3 is a top plan view thereof; and,  
FIG. 4 is a bottom plan view thereof.  
The broken line showing of a lid in FIG. 1 is for illustrative purposes only and forms no part of the claimed design.

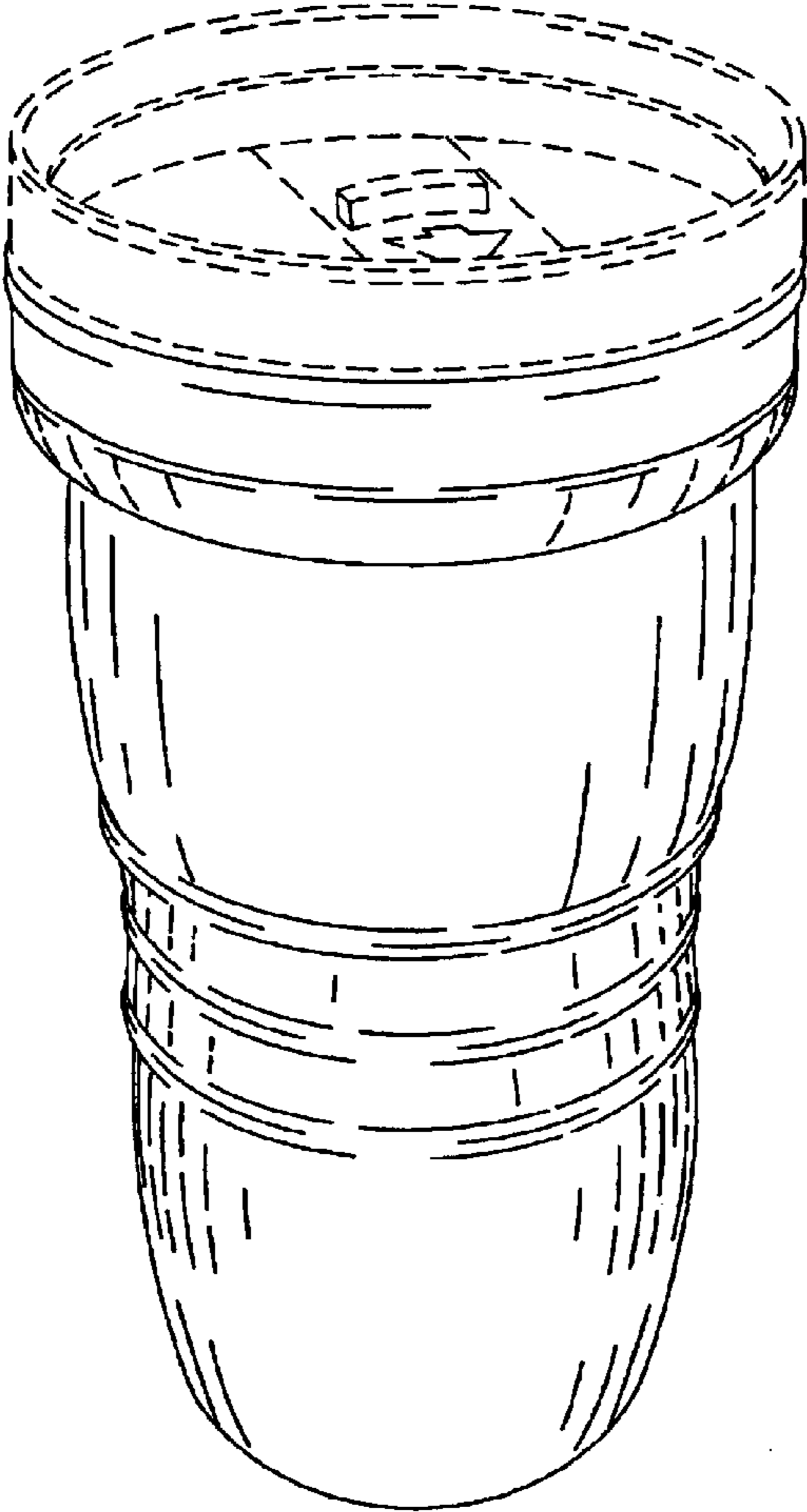

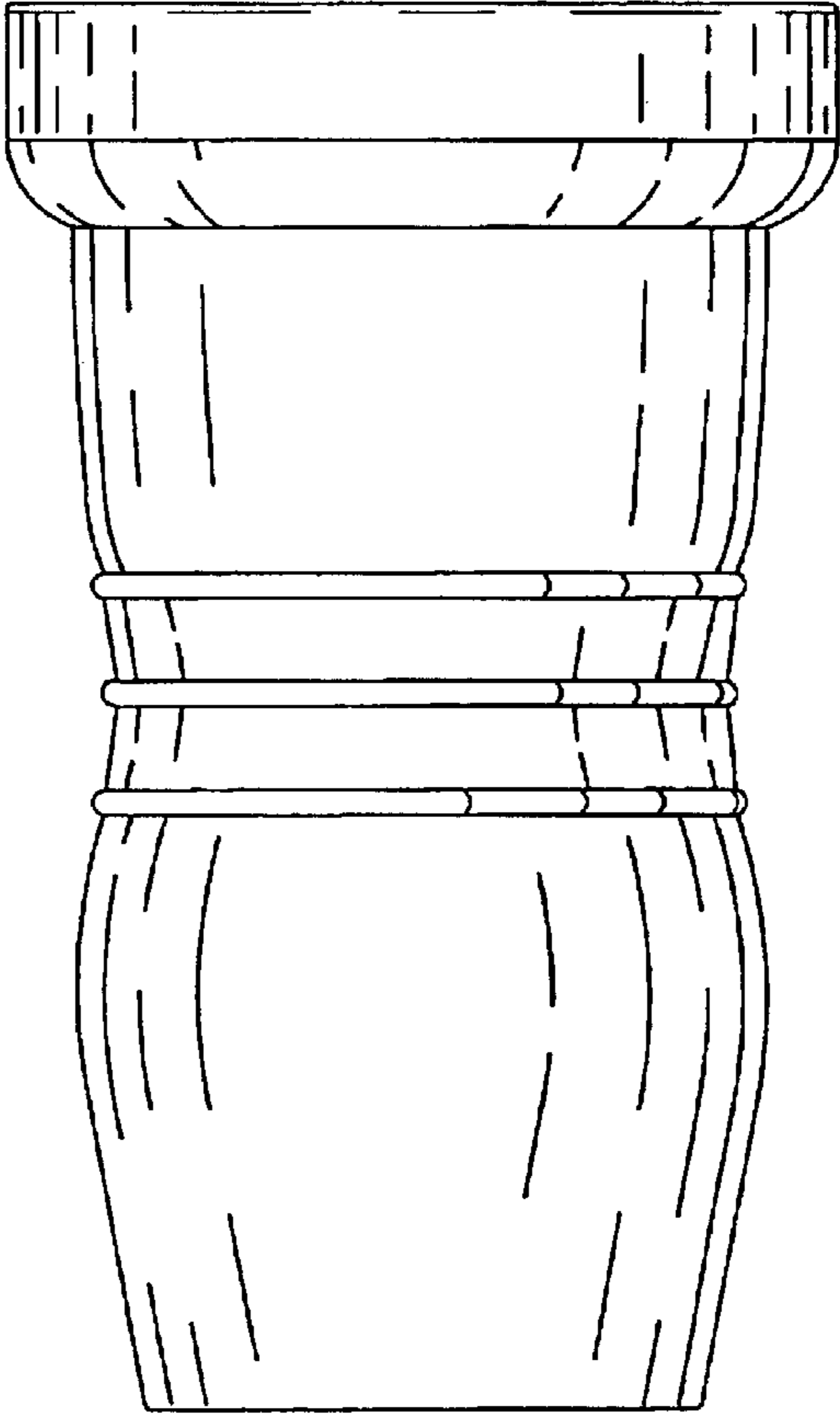

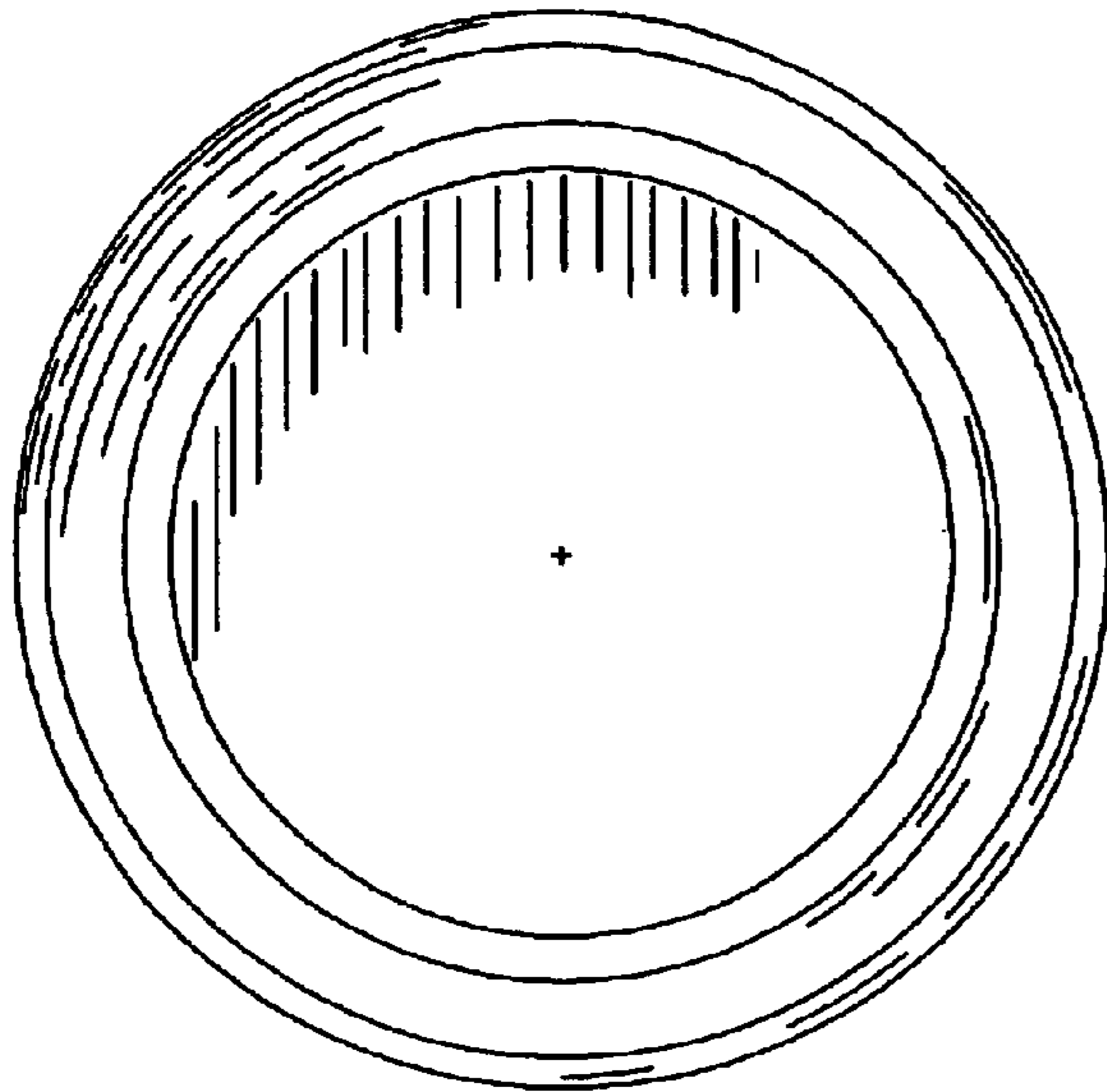

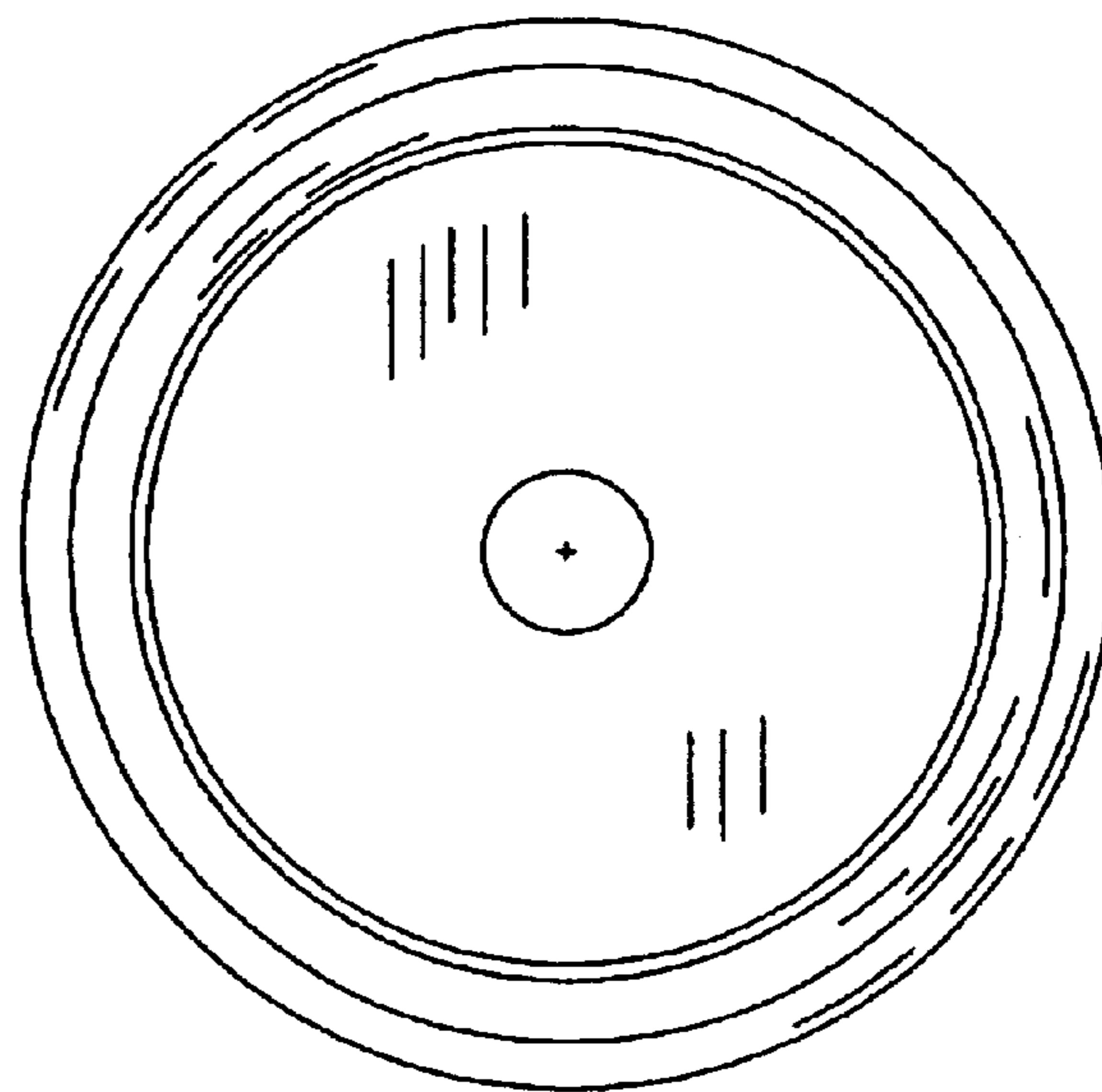
