FIG. 8 is a perspective view of the first embodiment showing the jewelry hanger use.

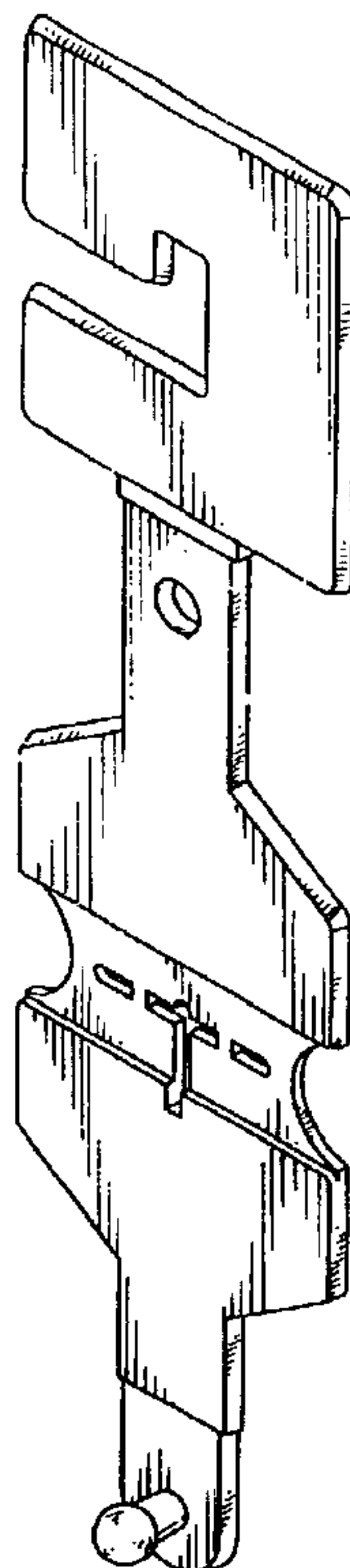

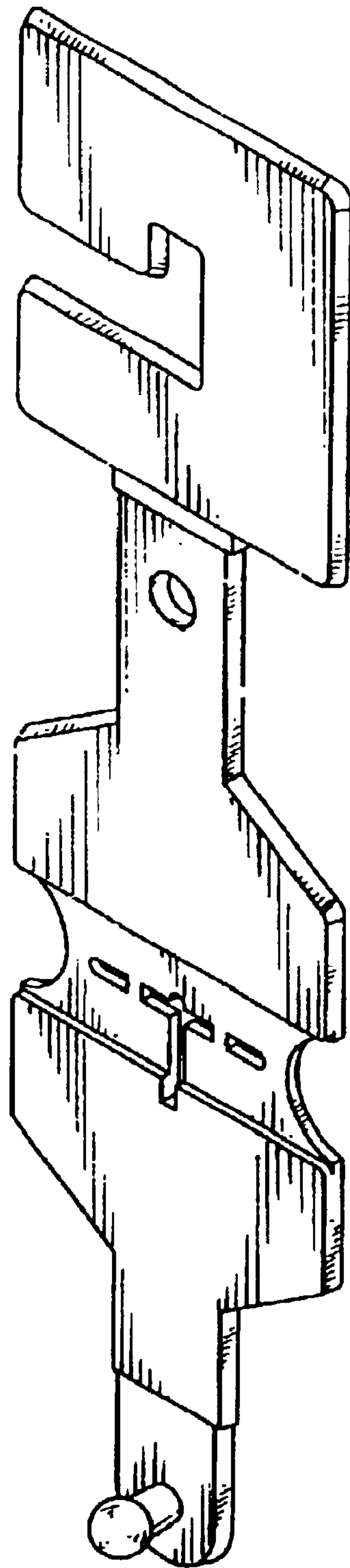

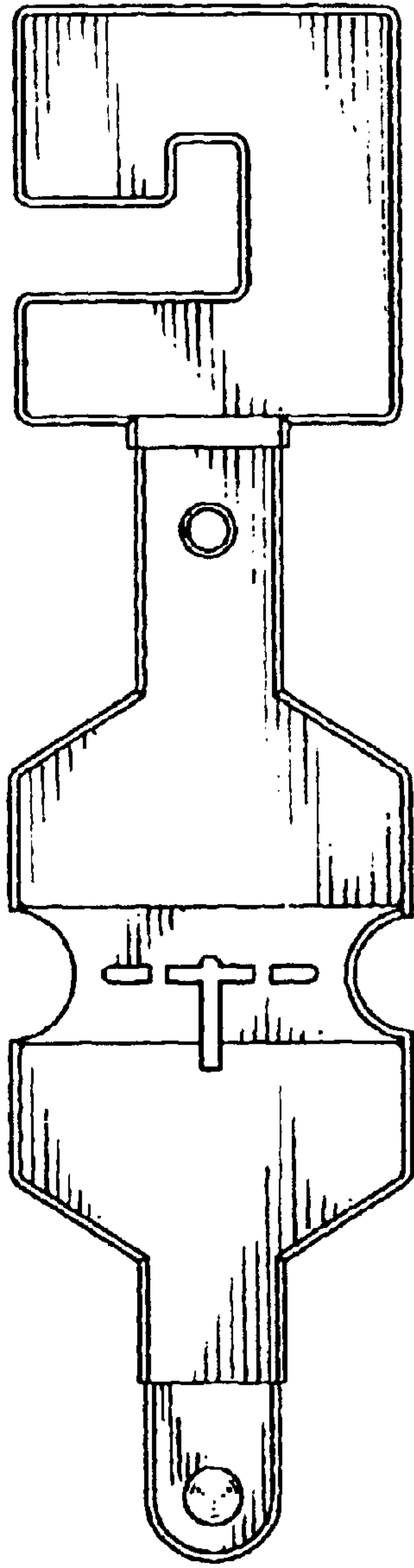

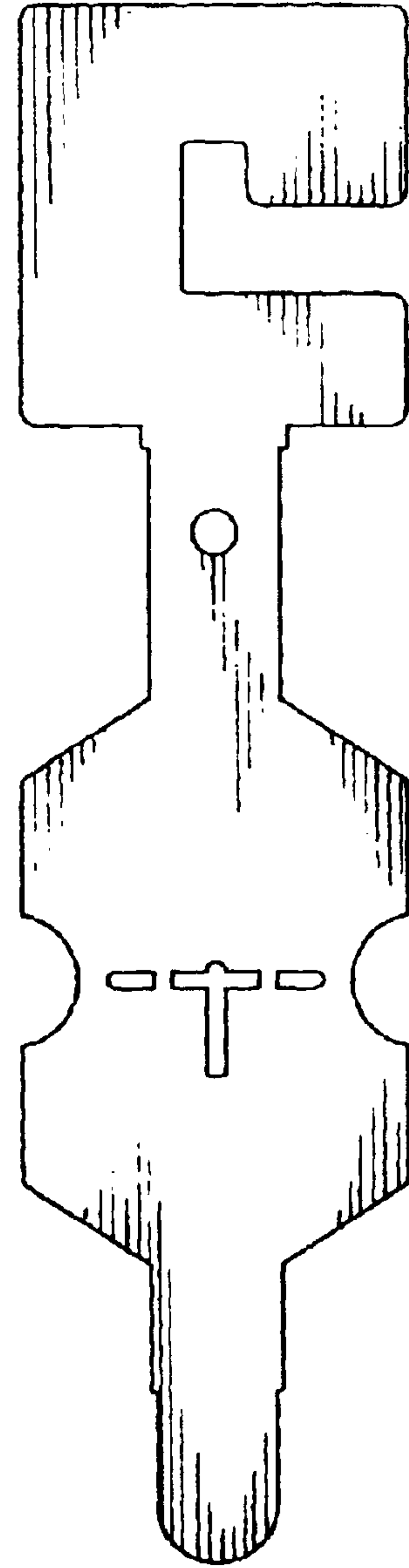

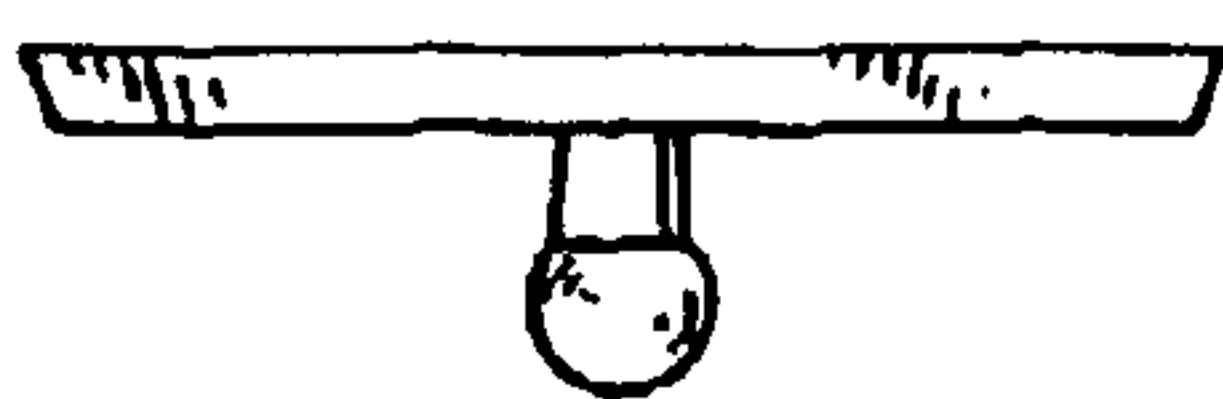

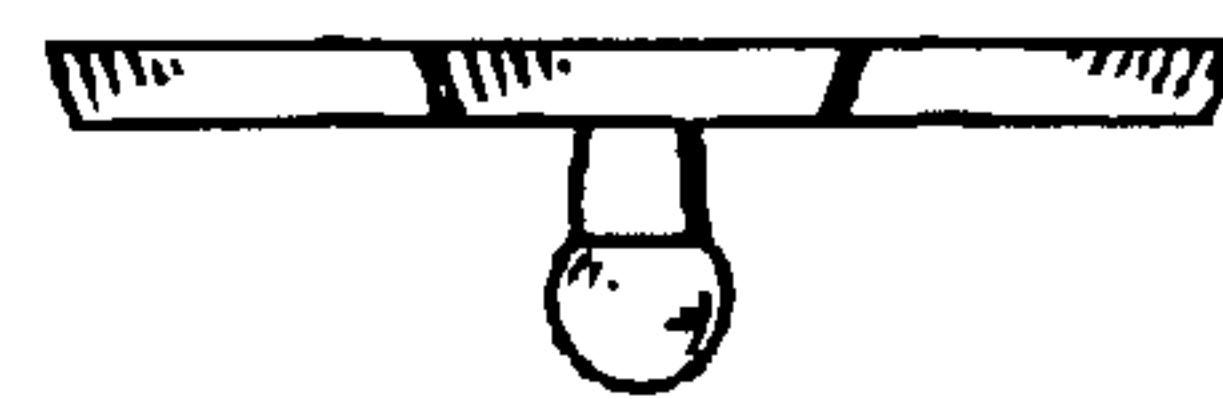
